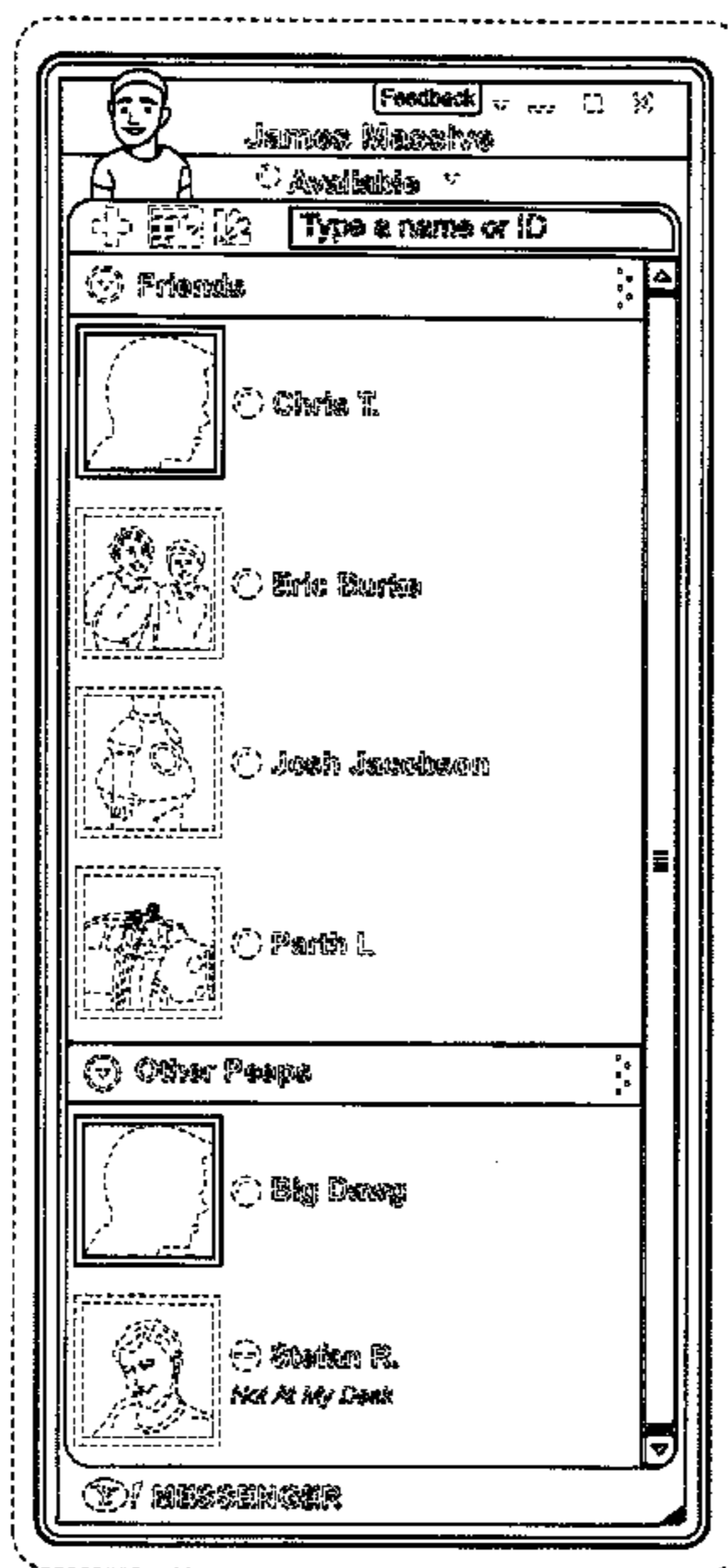
The ornamental design for a graphical user interface for a display panel, as shown and described.

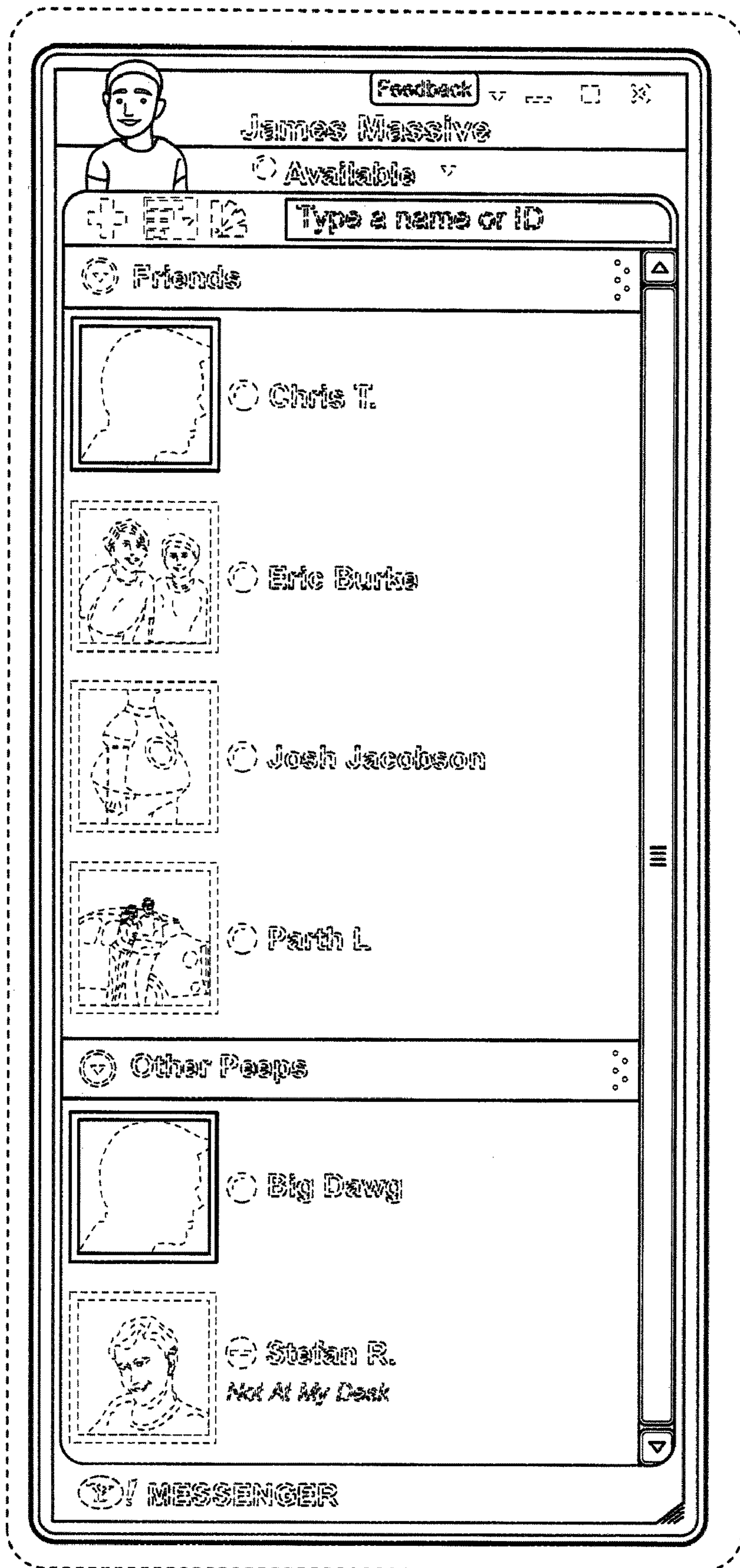
**DESCRIPTION**
