described.

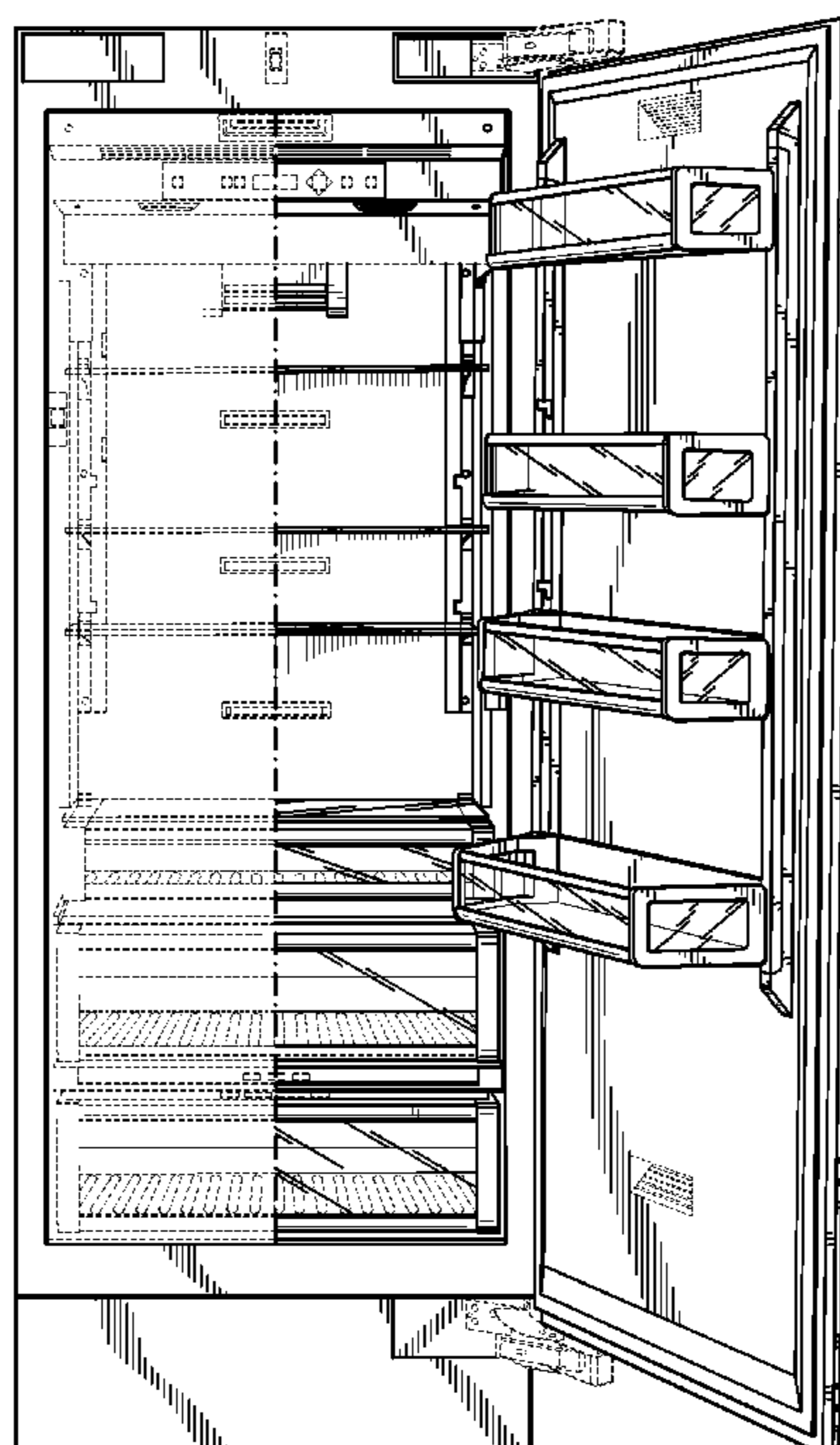
DESCRIPTION

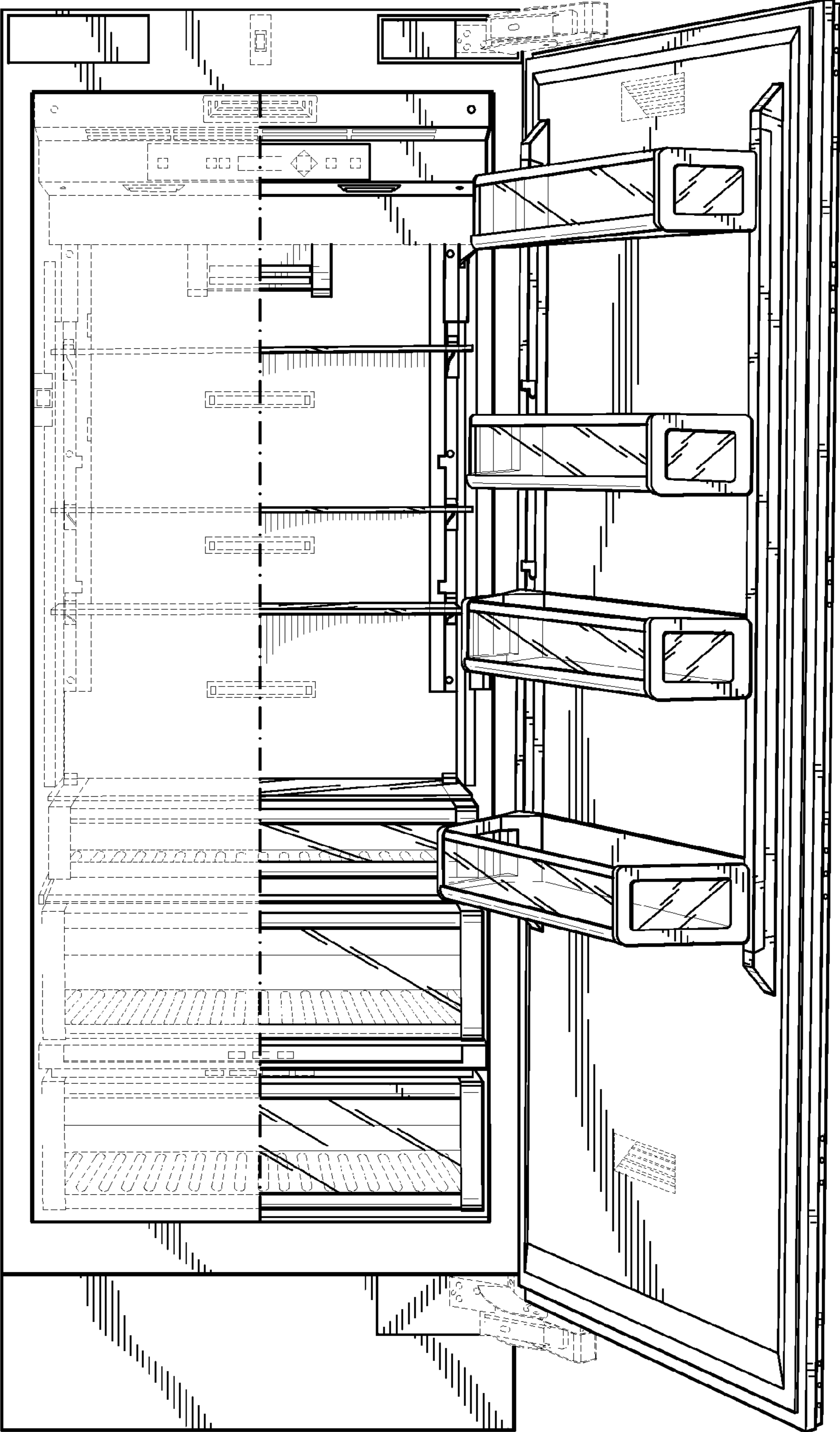

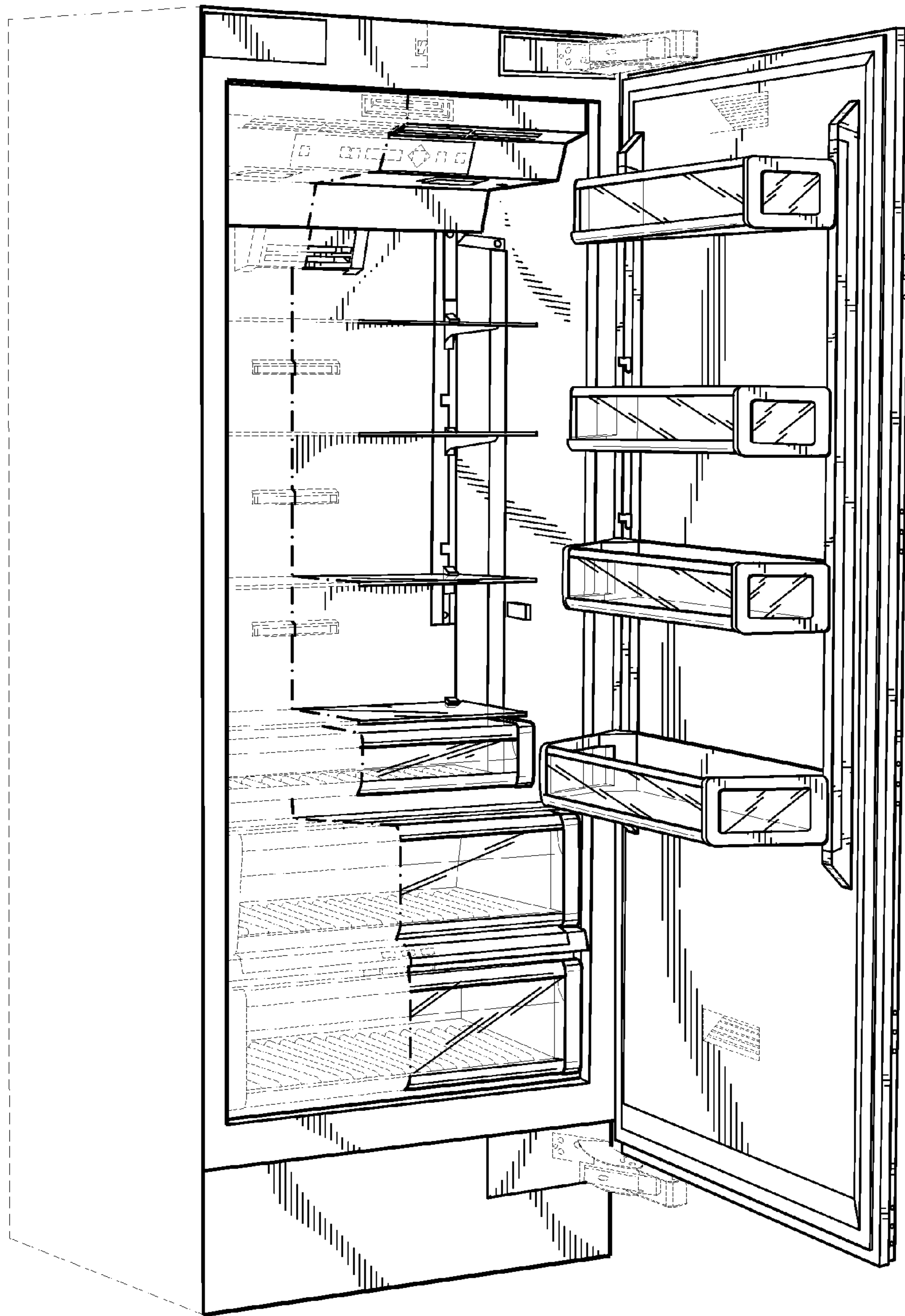

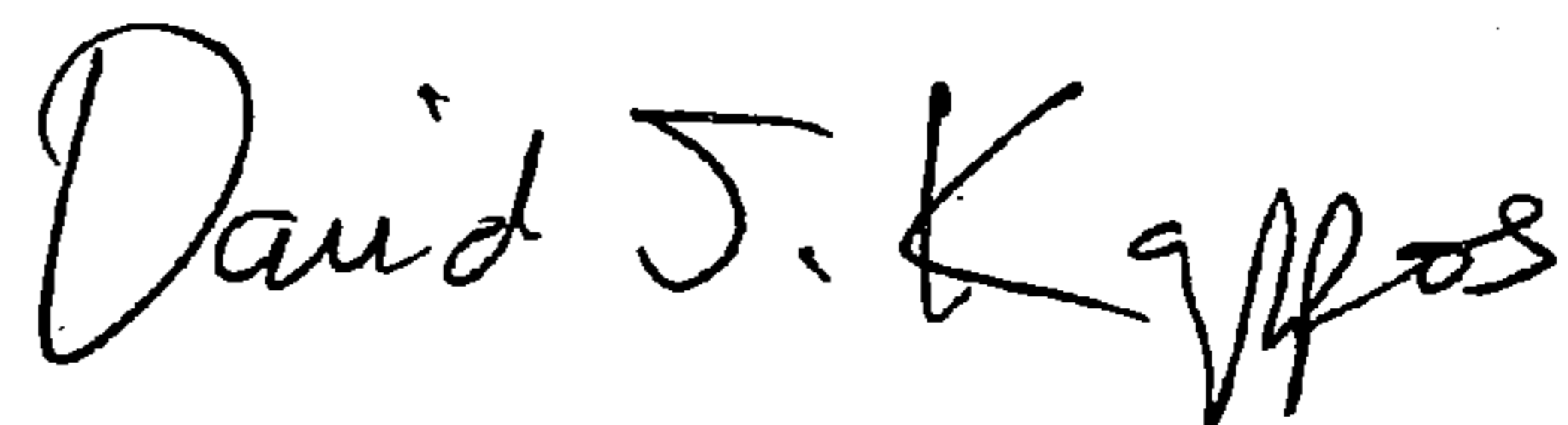
