FIG. 8 is bottom view of FIG. 5.

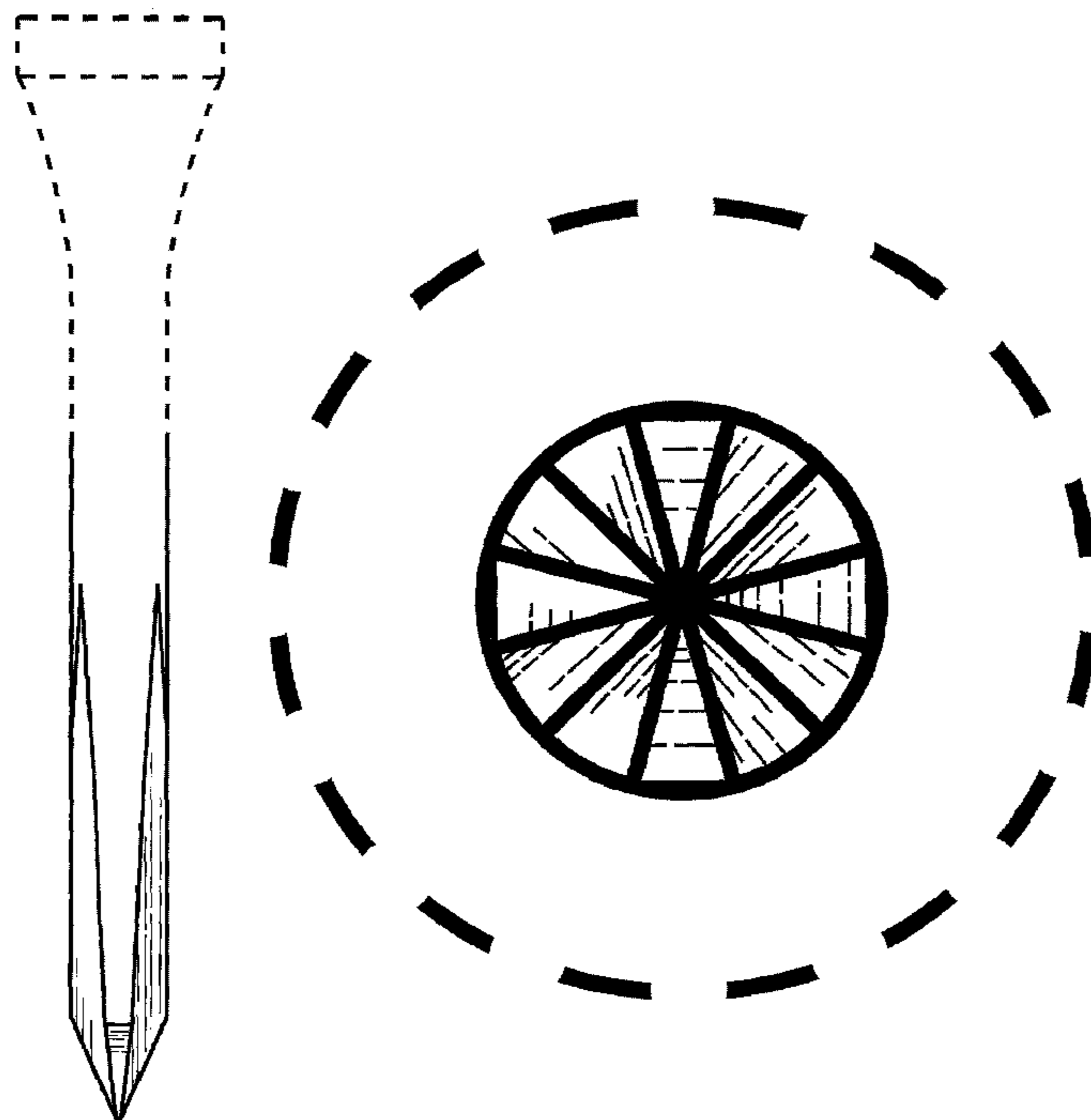
The broken lines are included for the purpose of illustrating portions of the golf tee that form no part of the claimed design.

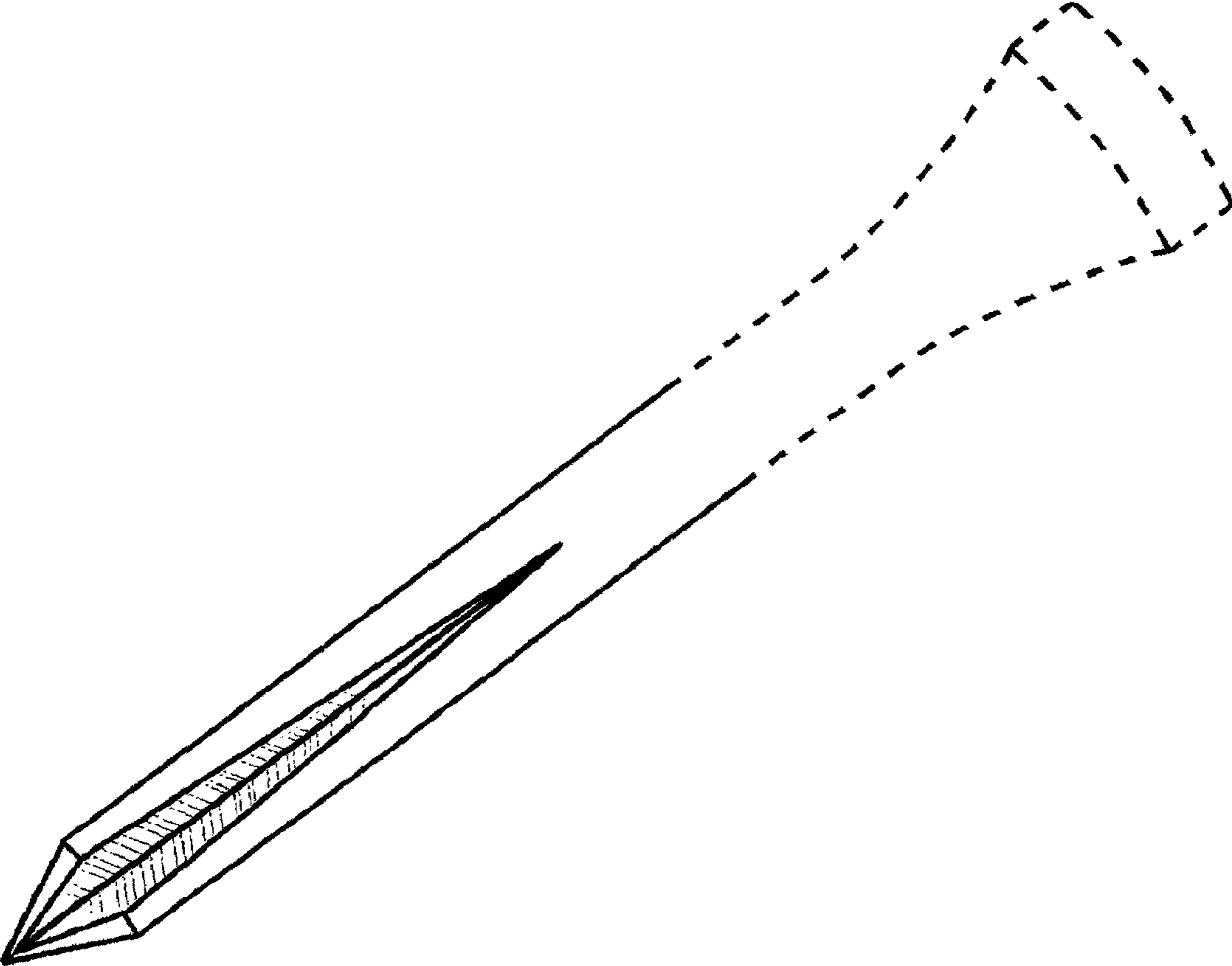

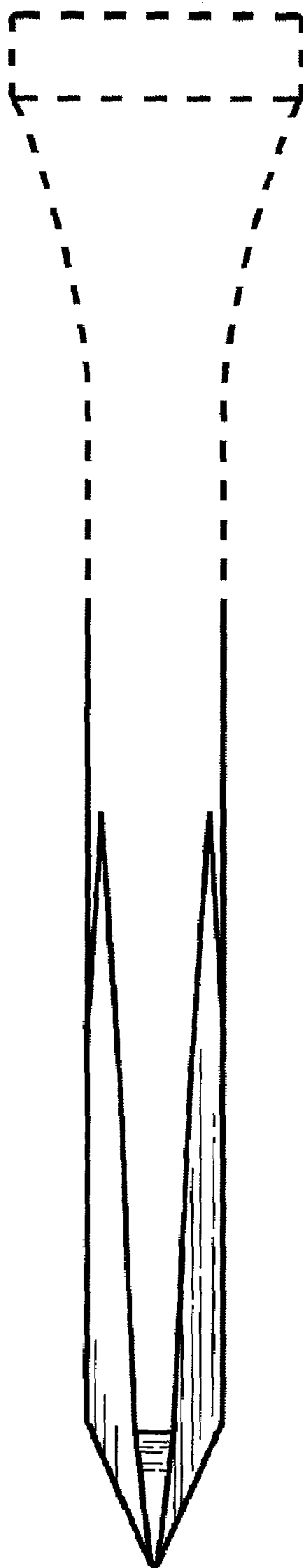

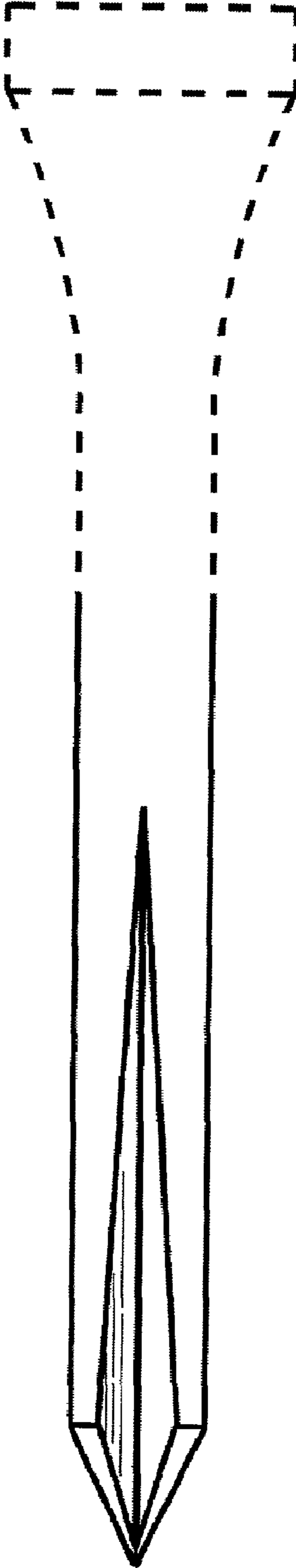

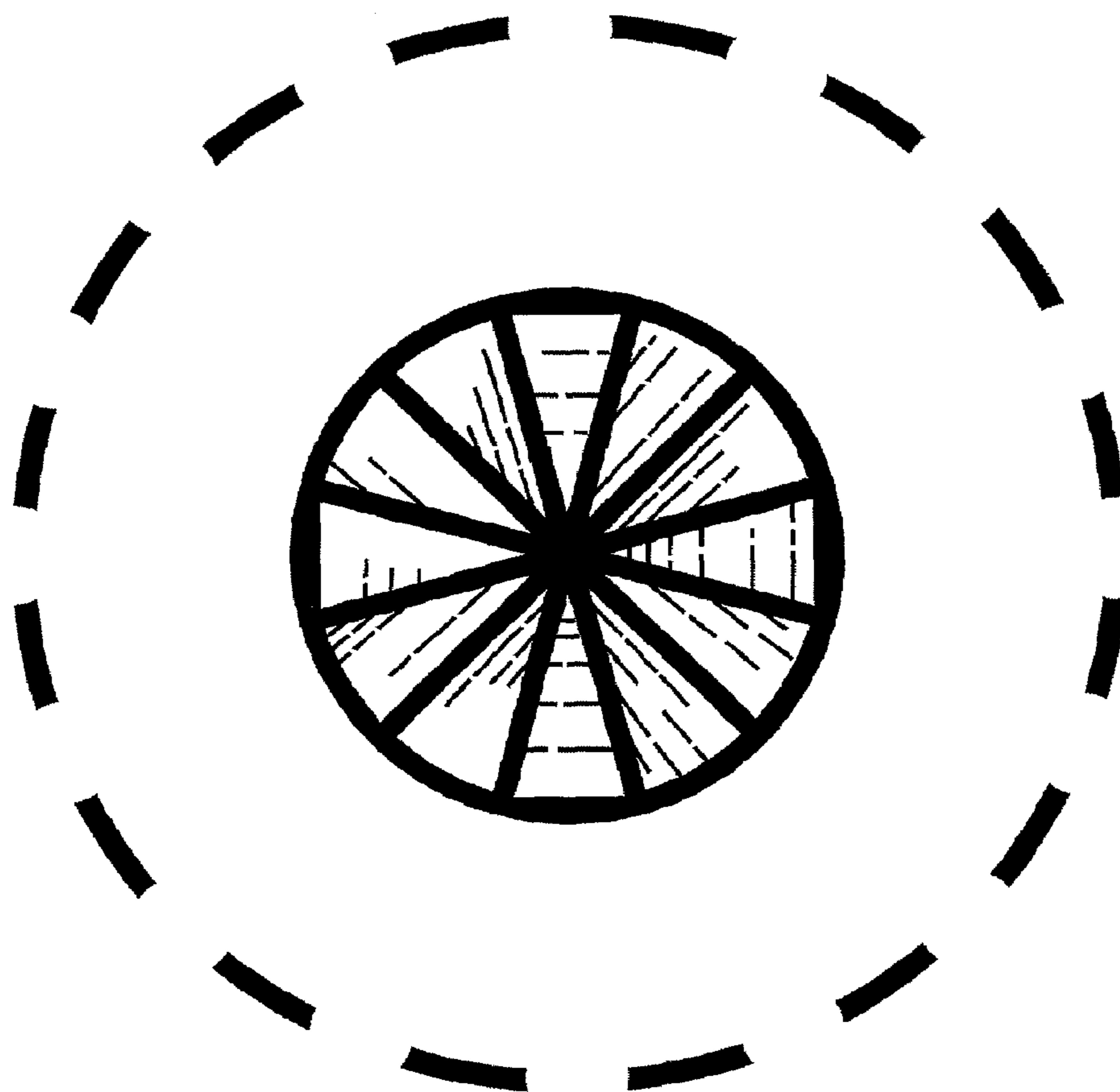

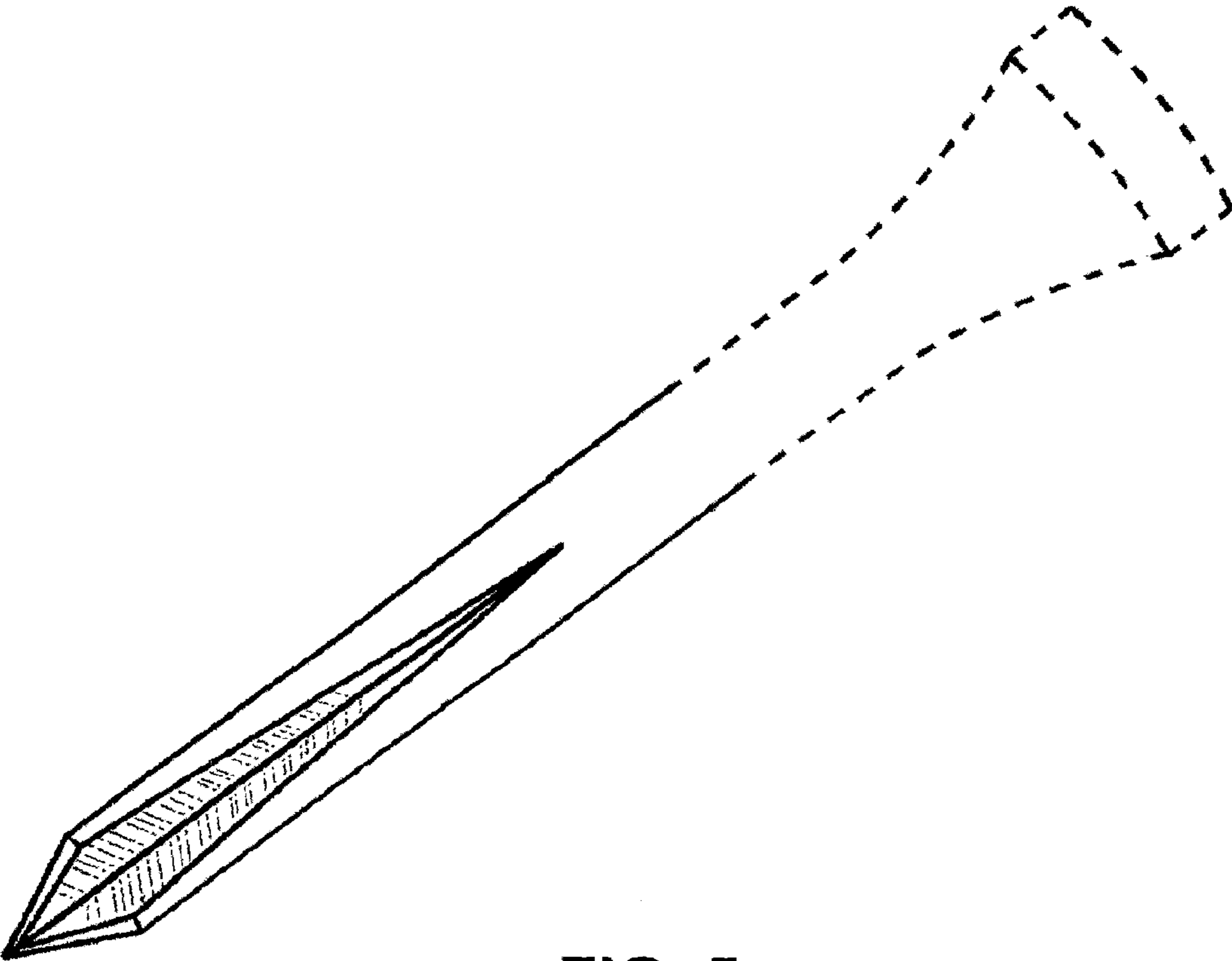

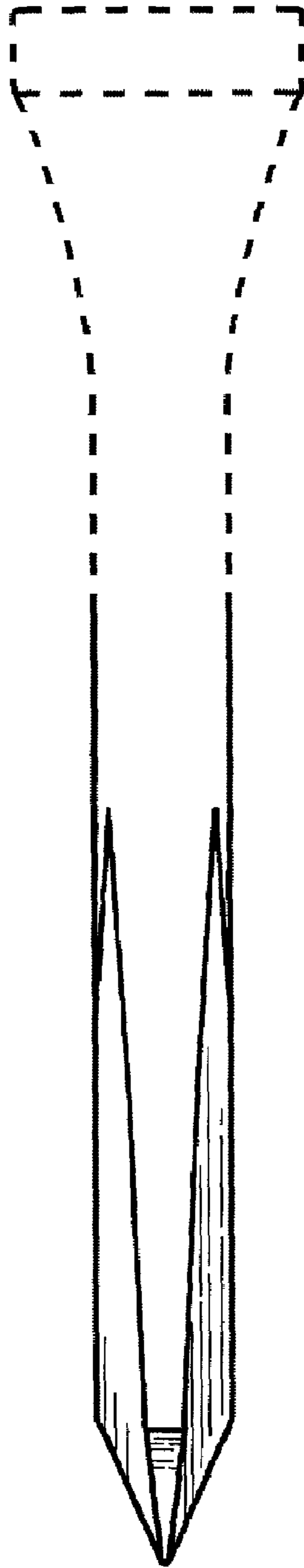

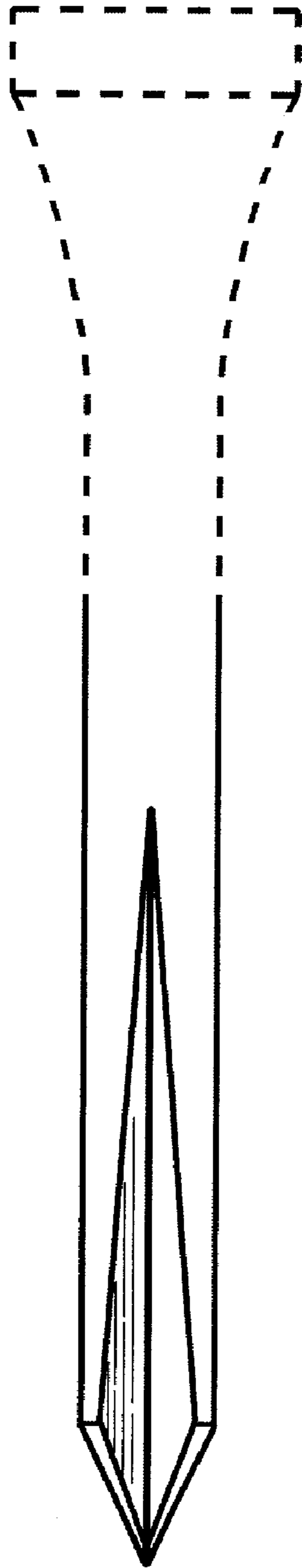

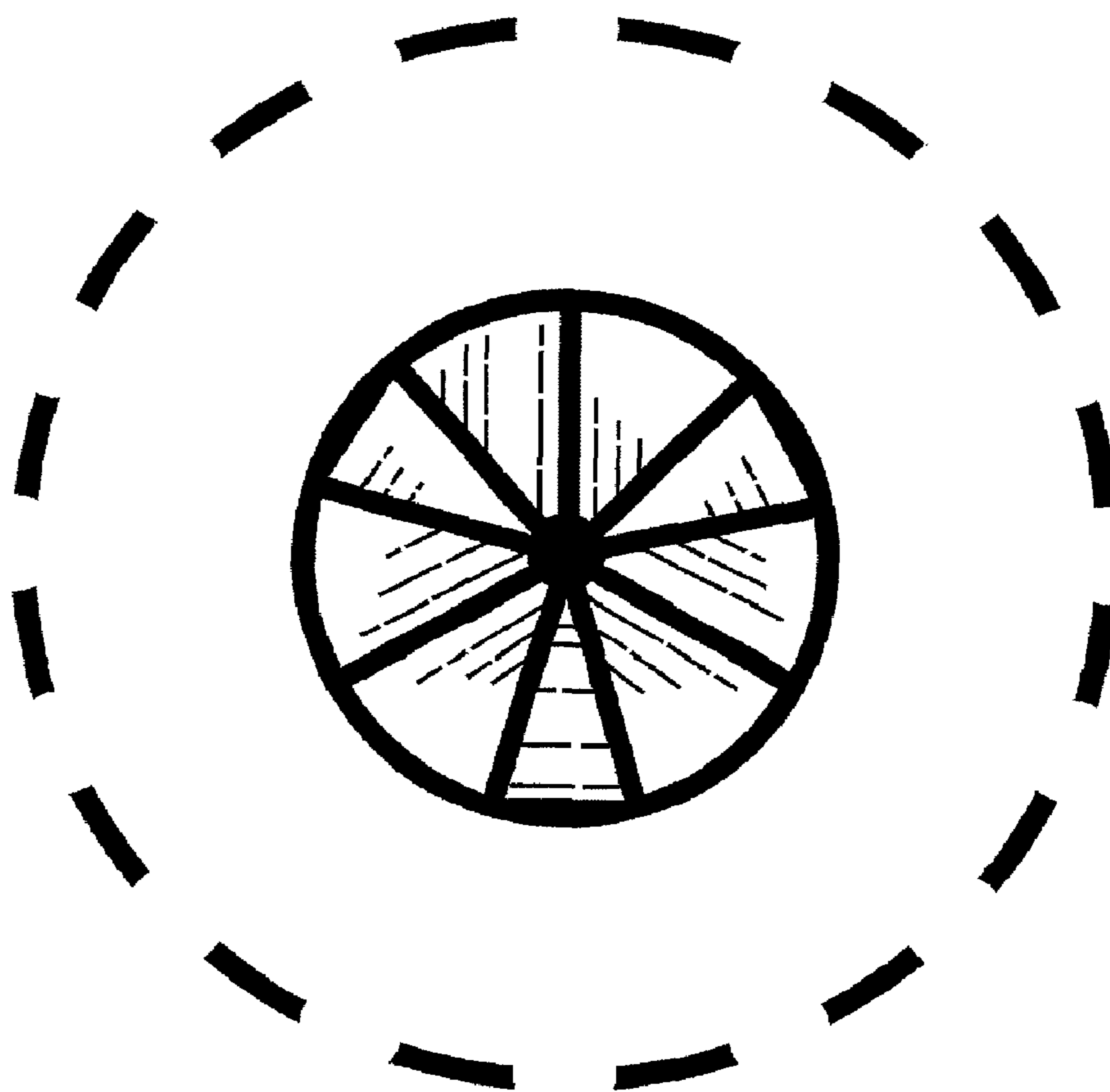
