We claim the ornamental design for the sacral wound dressing, as shown and described.

**DESCRIPTION**

FIG. 4 is a front side view thereof;

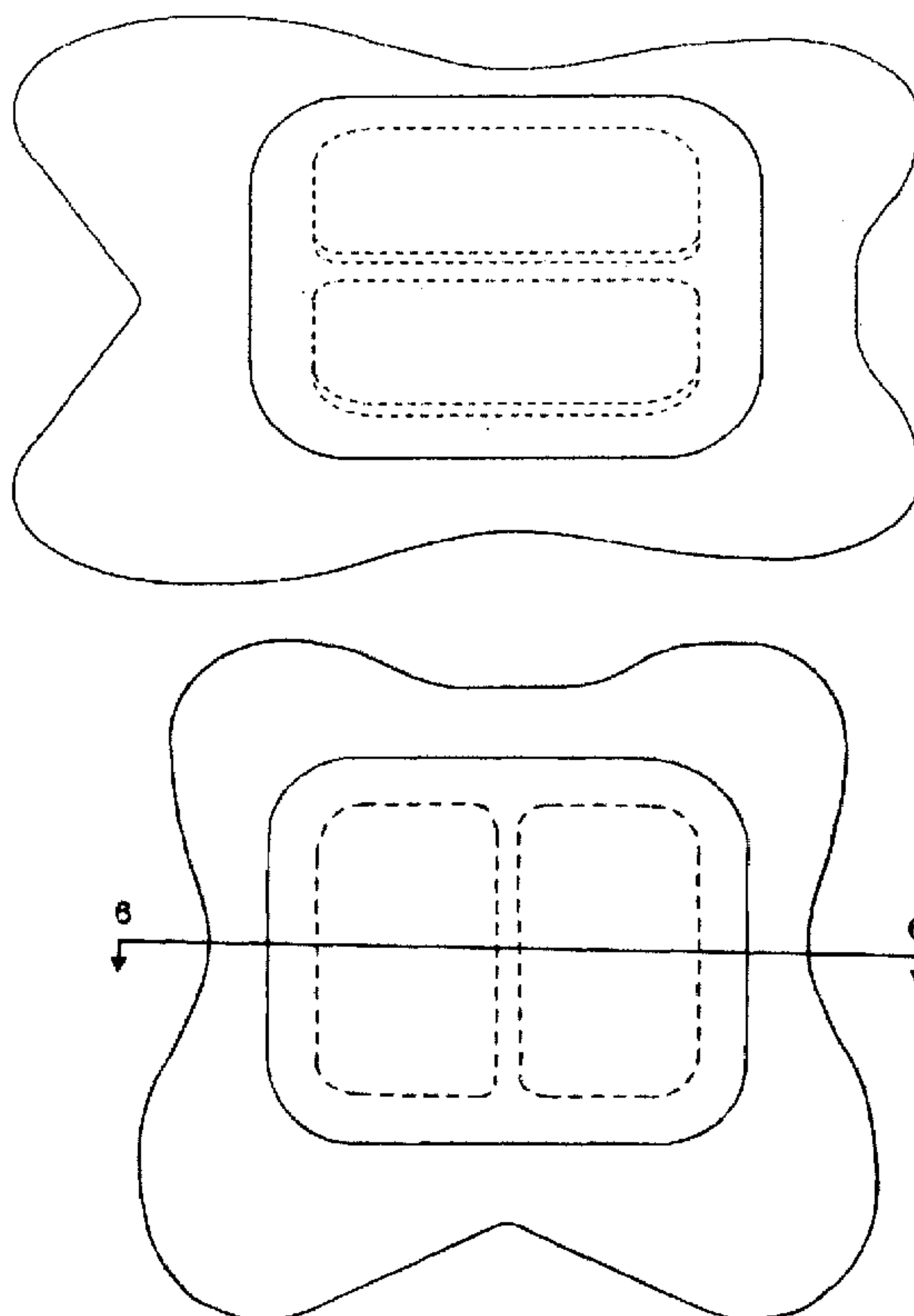
FIG. 5 is a top view thereof;

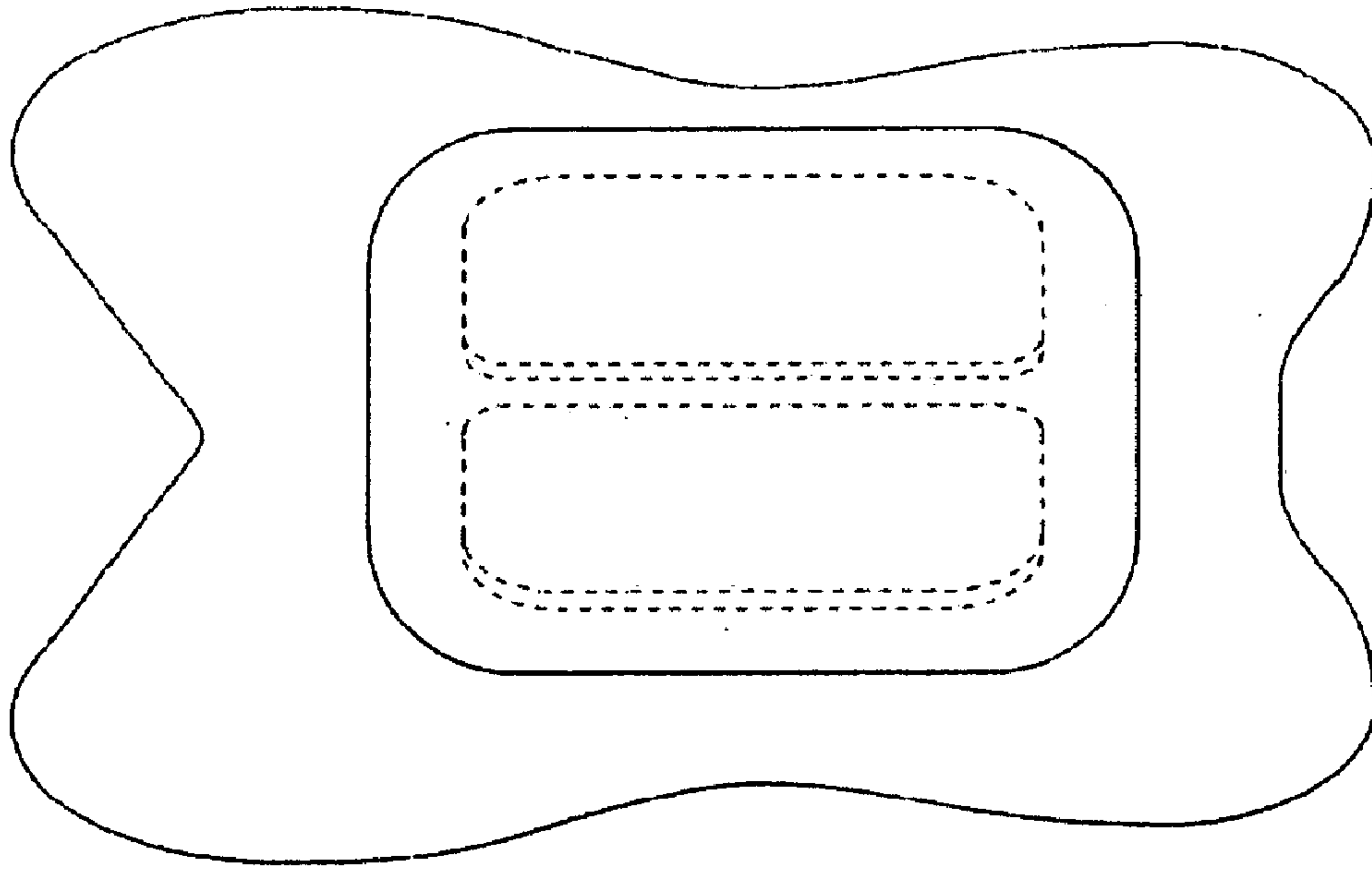
FIG. 6 is a cross-sectional view of the sacral wound dressing taken from line 6—6' of FIG. 5 thereof; and,

FIG. 7 is an outline view thereof.

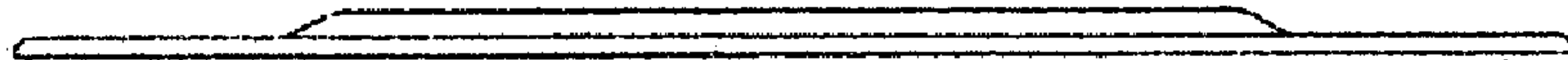
The broken line showing of sacral wound dressing is included for the purpose of illustrating stitching and forms a part of the claimed design.

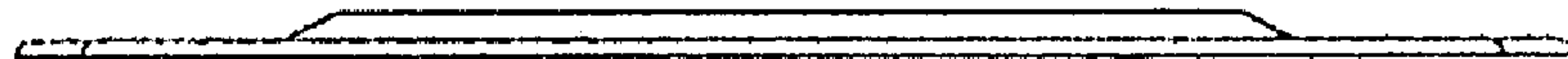




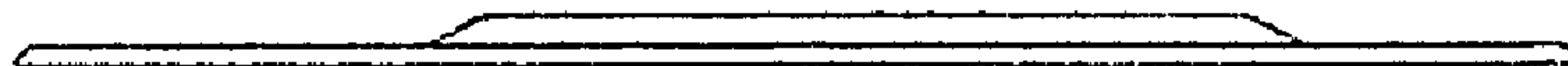

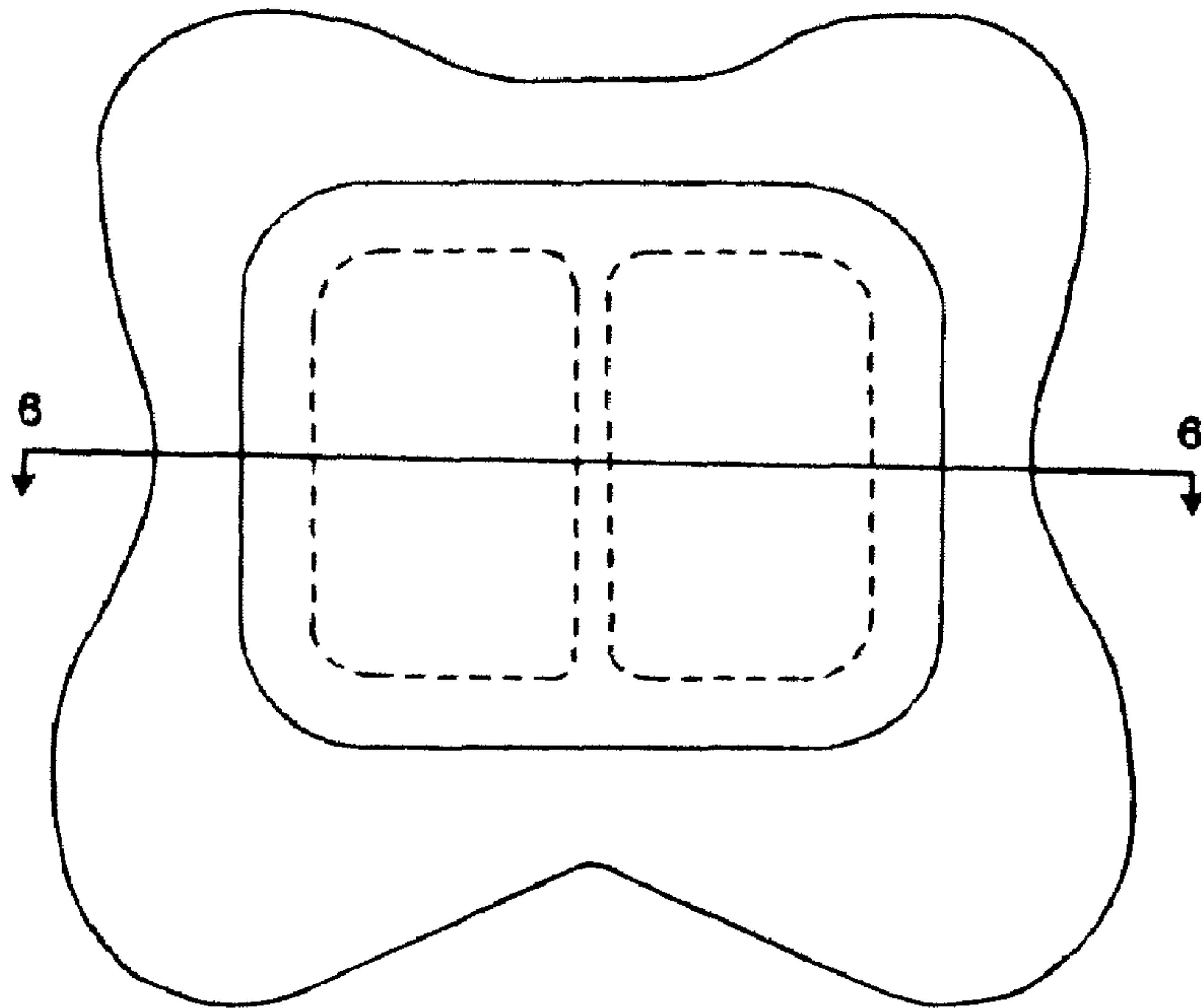

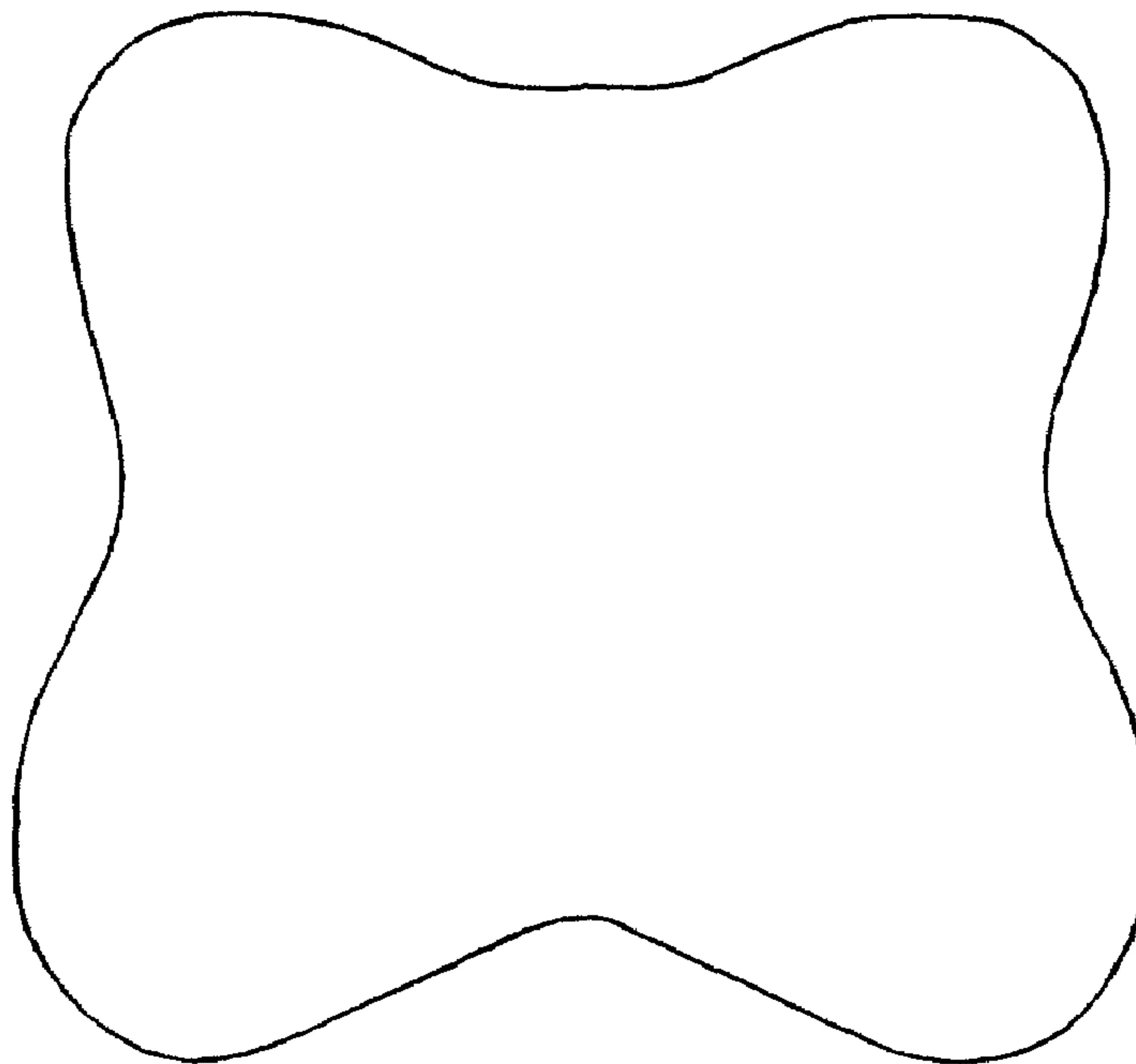
