(57) **CLAIM**

I claim the ornamental design for a “strap,” as shown and described herein.

DESCRIPTION

FIG. 1 is a perspective view of the strap design of this invention.

FIG. 2 is a top plan view of the strap of this invention shown in FIG. 1.

FIG. 3 is a bottom plan view of the strap of this invention shown in FIG. 1.

FIG. 4 is a front elevational view of the strap of this invention shown in FIG. 1.

FIG. 5 is a rear elevational view of the strap of this invention shown in FIG. 1.

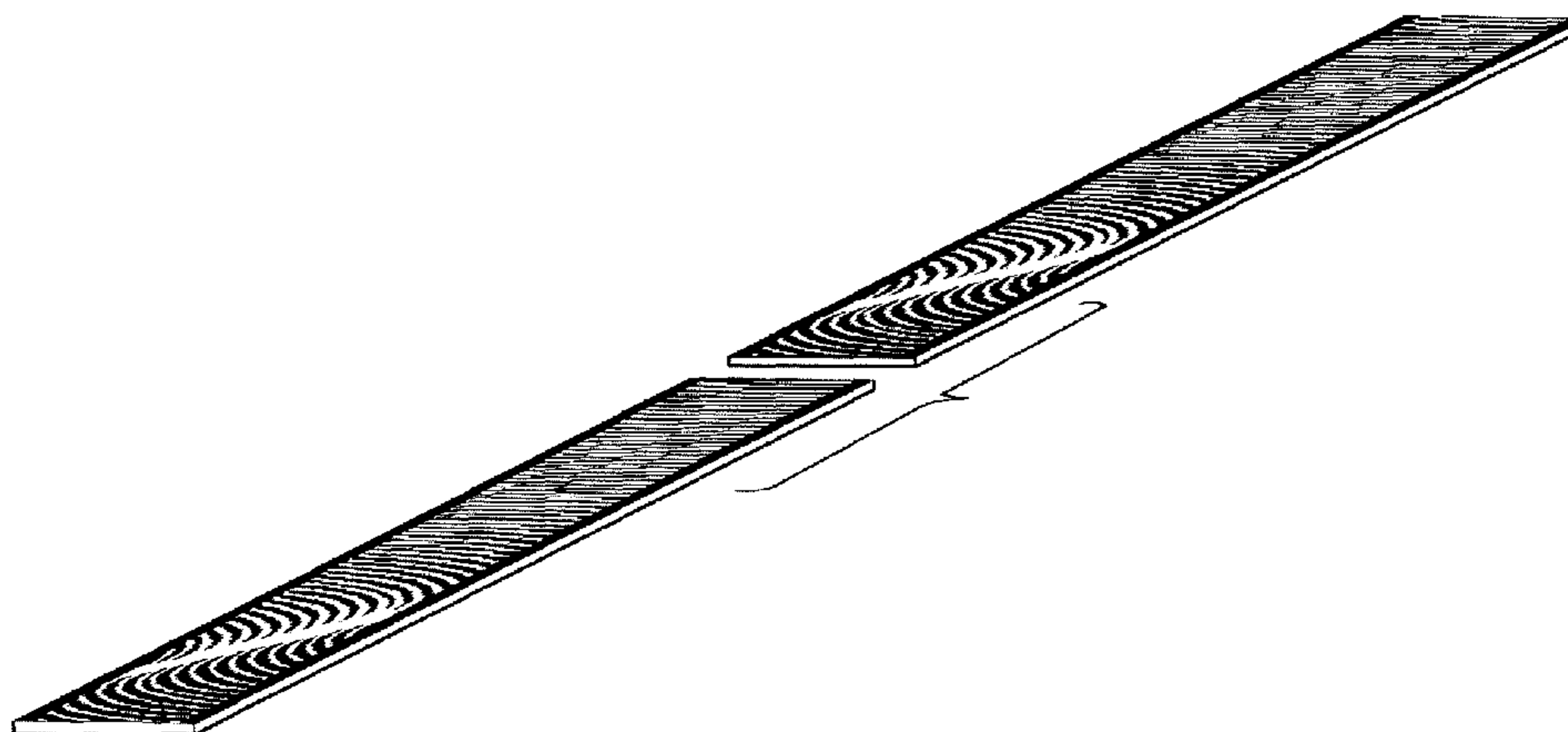
FIG. 6 is a left side elevational view of the strap of this invention shown in FIG. 1.

FIG. 7 is a right side elevational view of the strap of this invention shown in FIG. 1; and,

FIG. 8 is an enlarged detailed view of a portion of the strap shown in the rectangle in FIG. 2.

The claimed design is broken away to indicate indeterminate length.

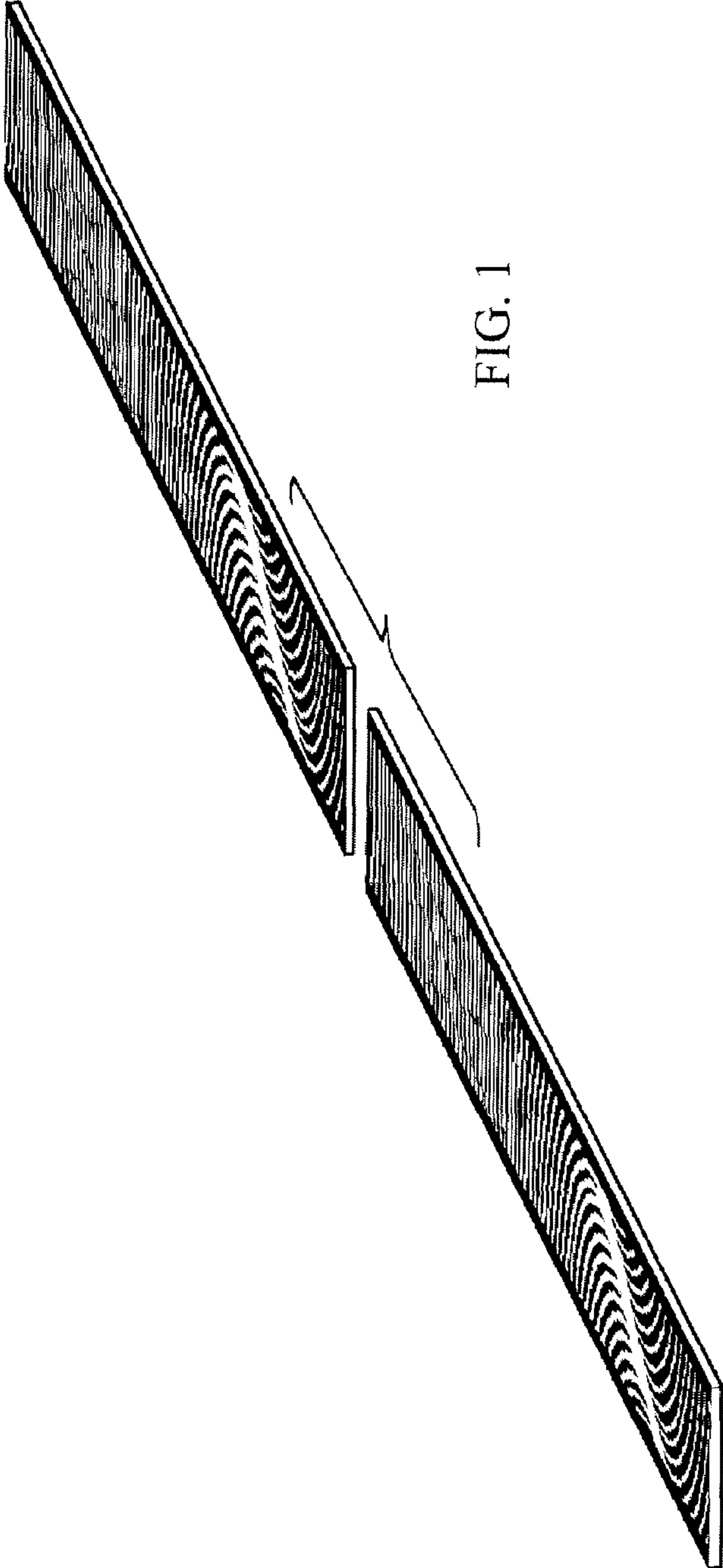

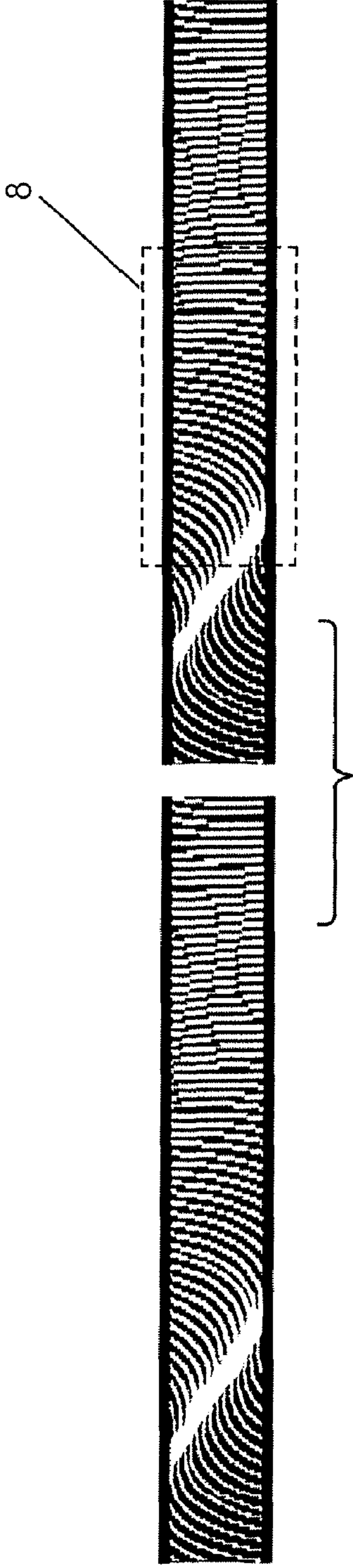

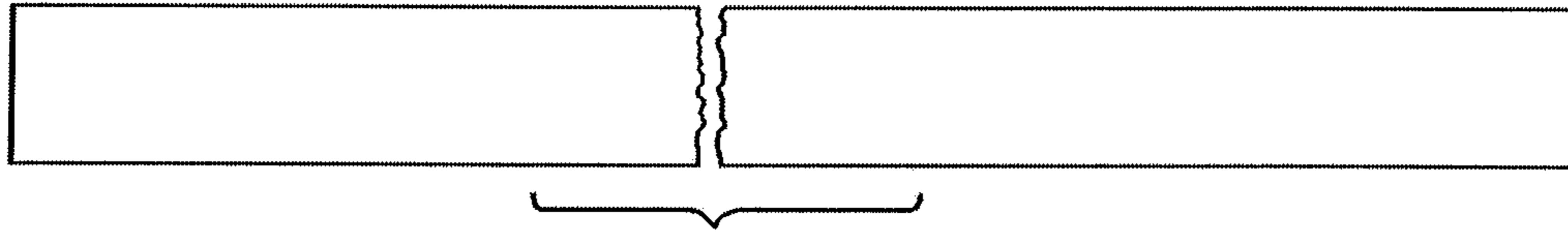

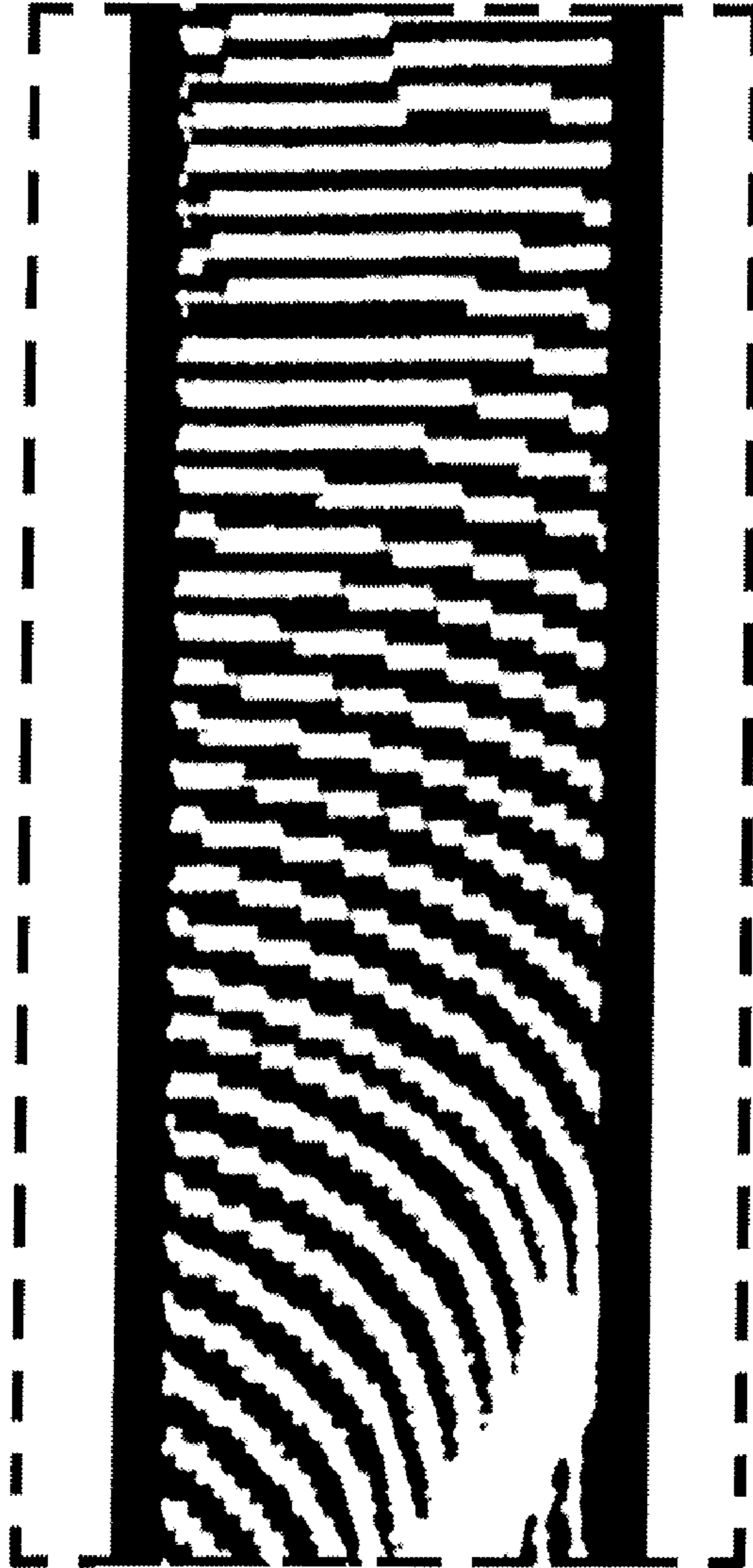
