The ornamental design for a mop housing, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of a mop housing showing our new design, the broken lines shown are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is an enlarged front, top perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a side elevational view thereof, the opposite side elevational view being a mirror image;

FIG. 5 is a top plan view thereof;

FIG. 6 is a rear elevational view thereof; and,

FIG. 7 is a bottom plan view thereof.

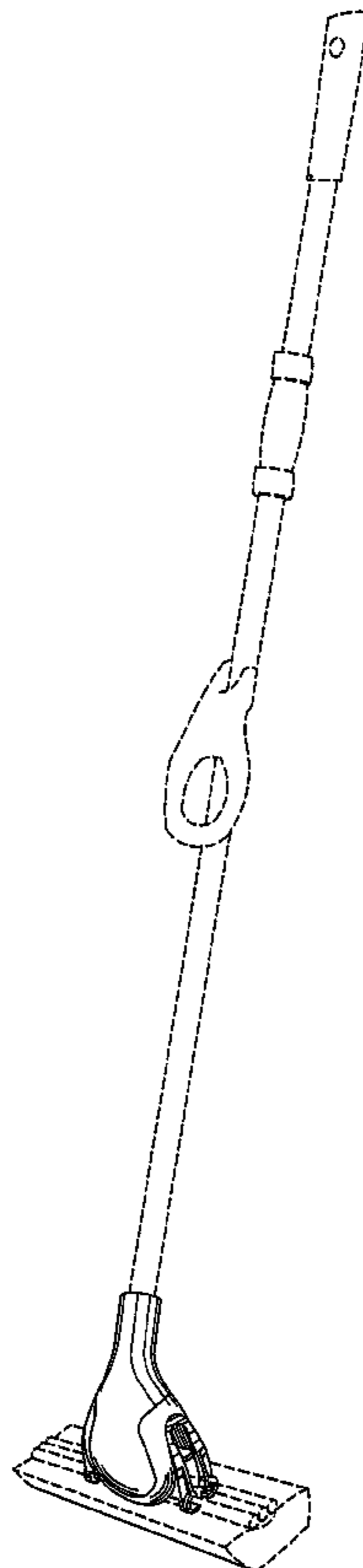

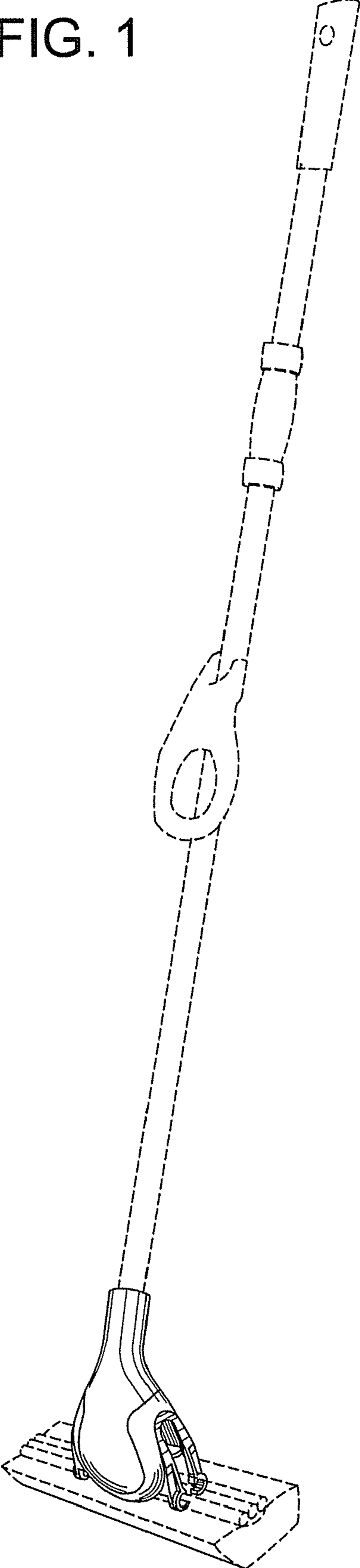

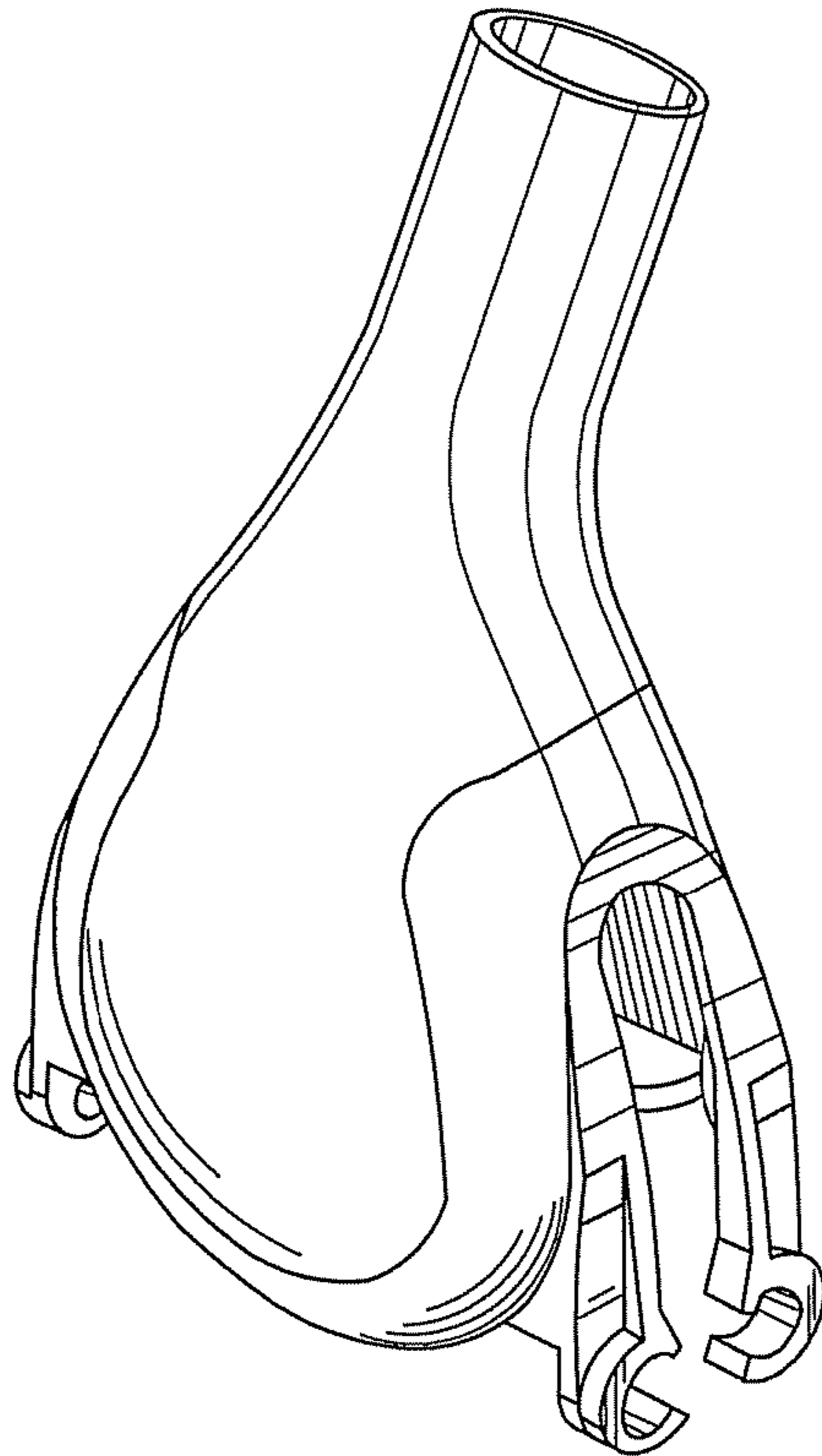

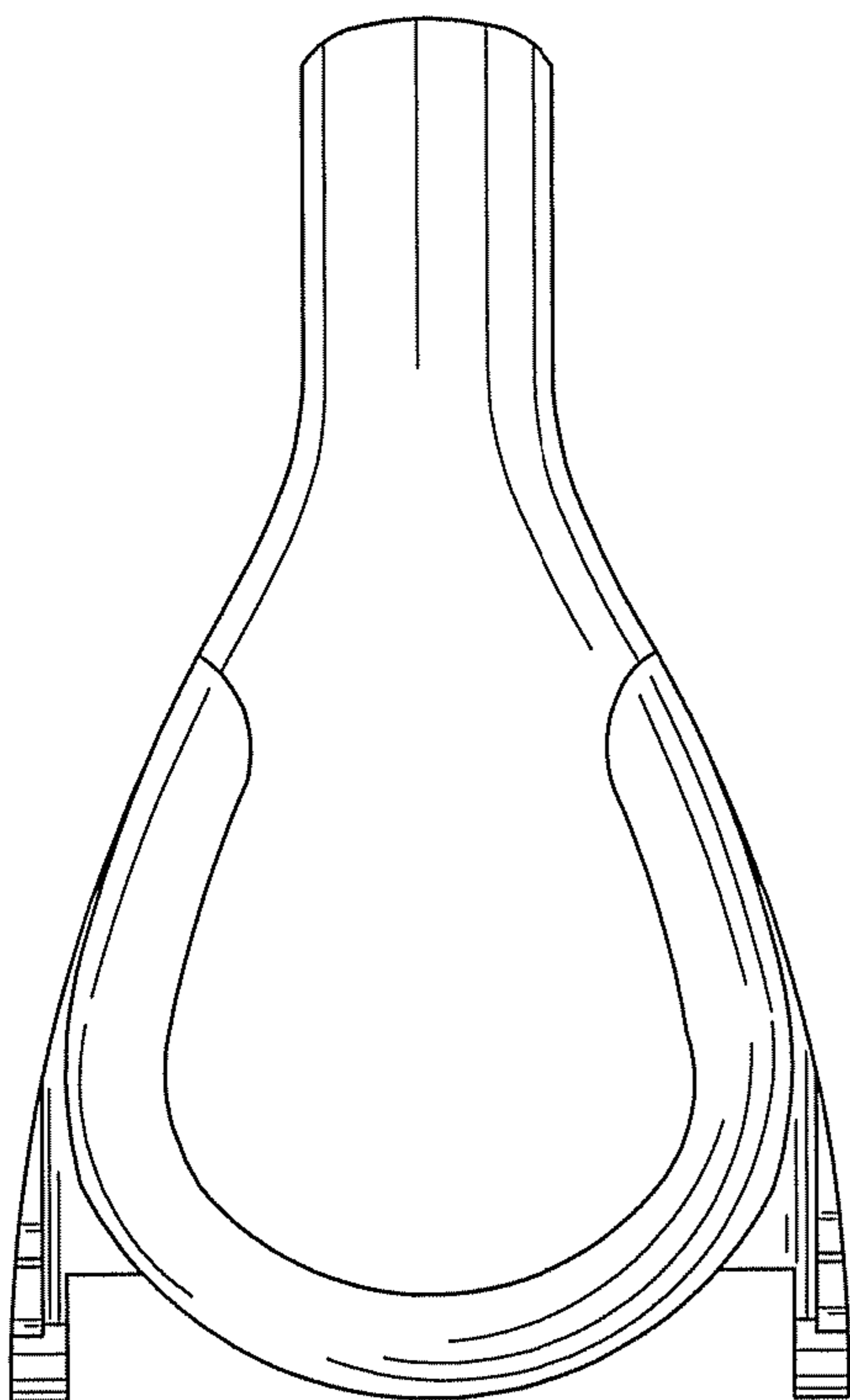

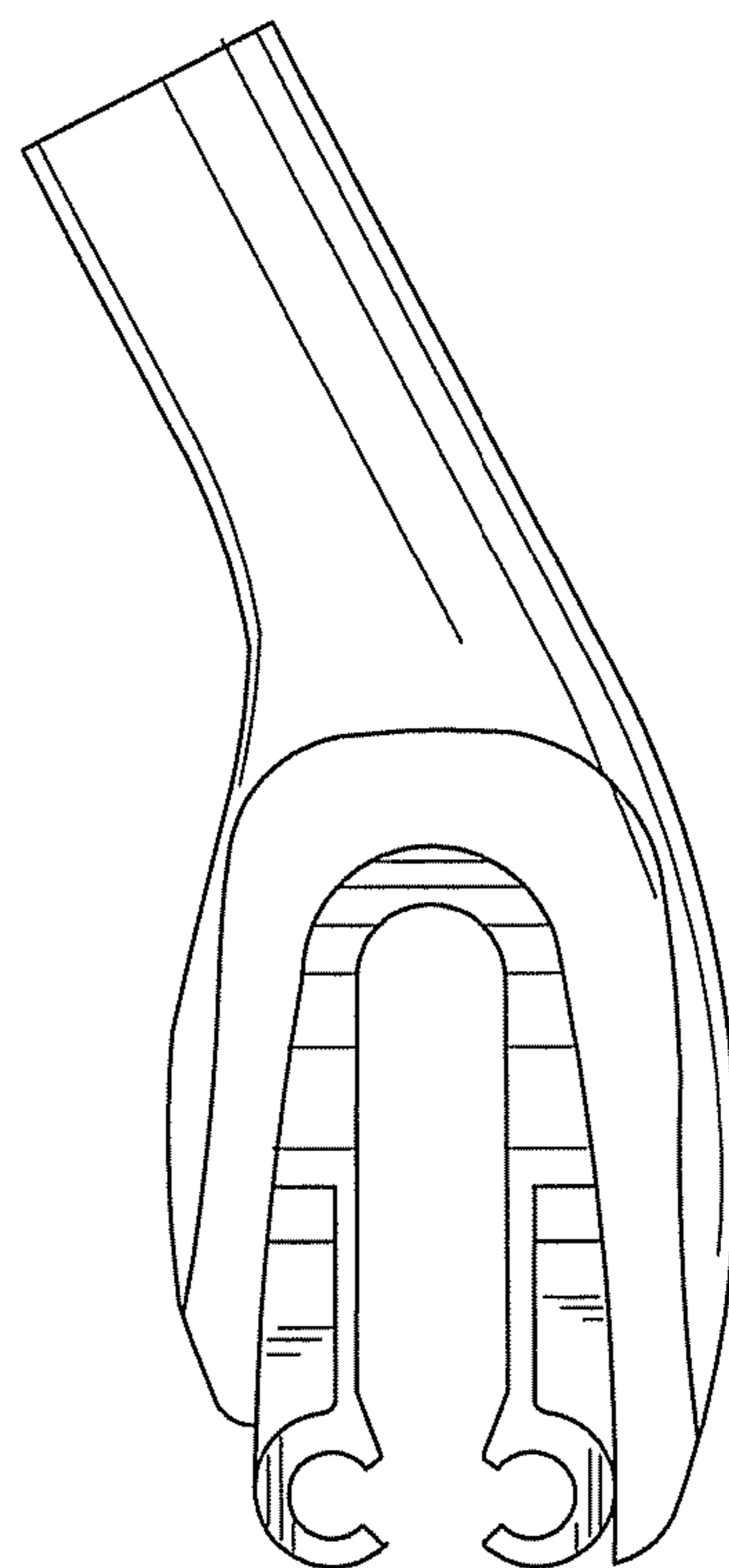

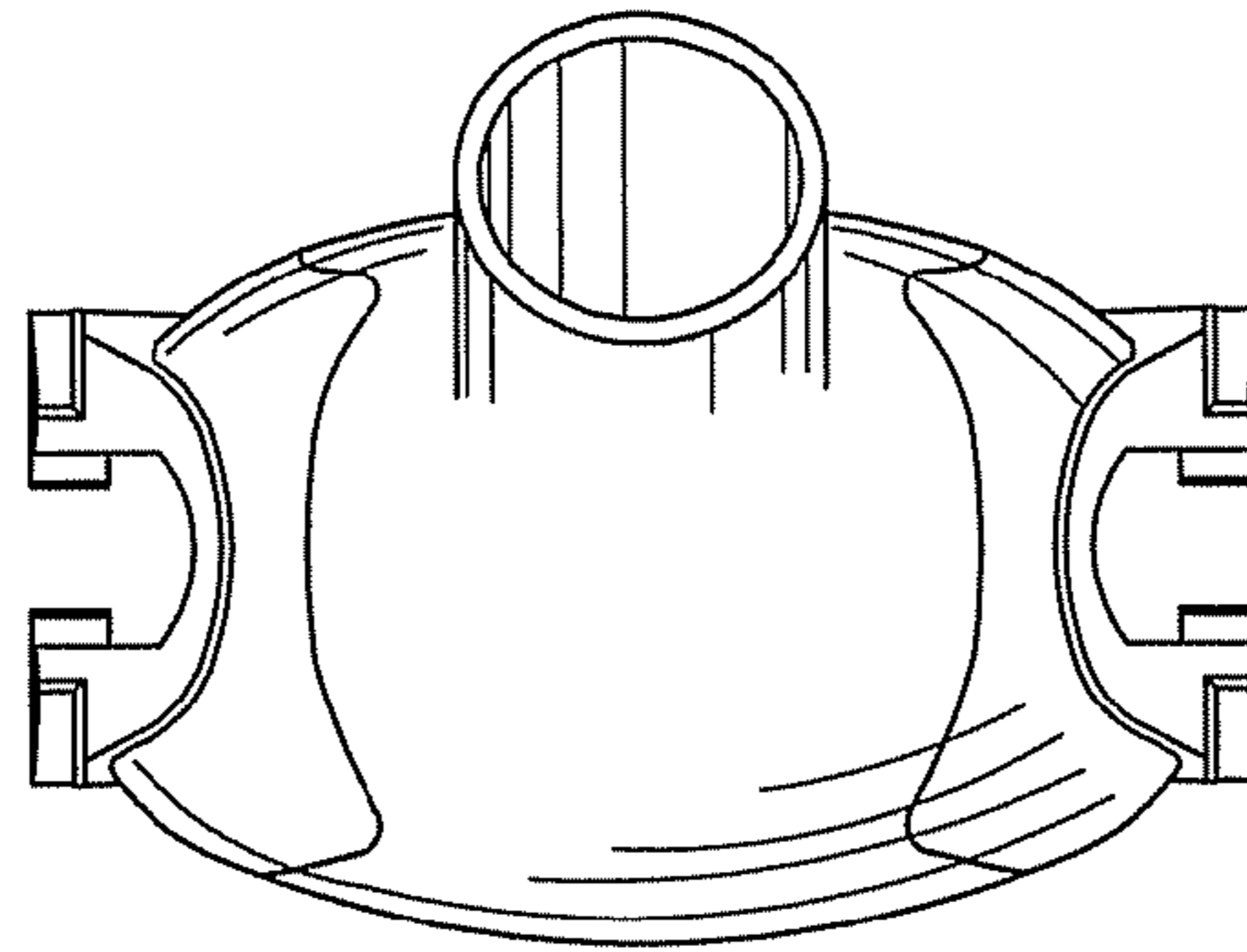

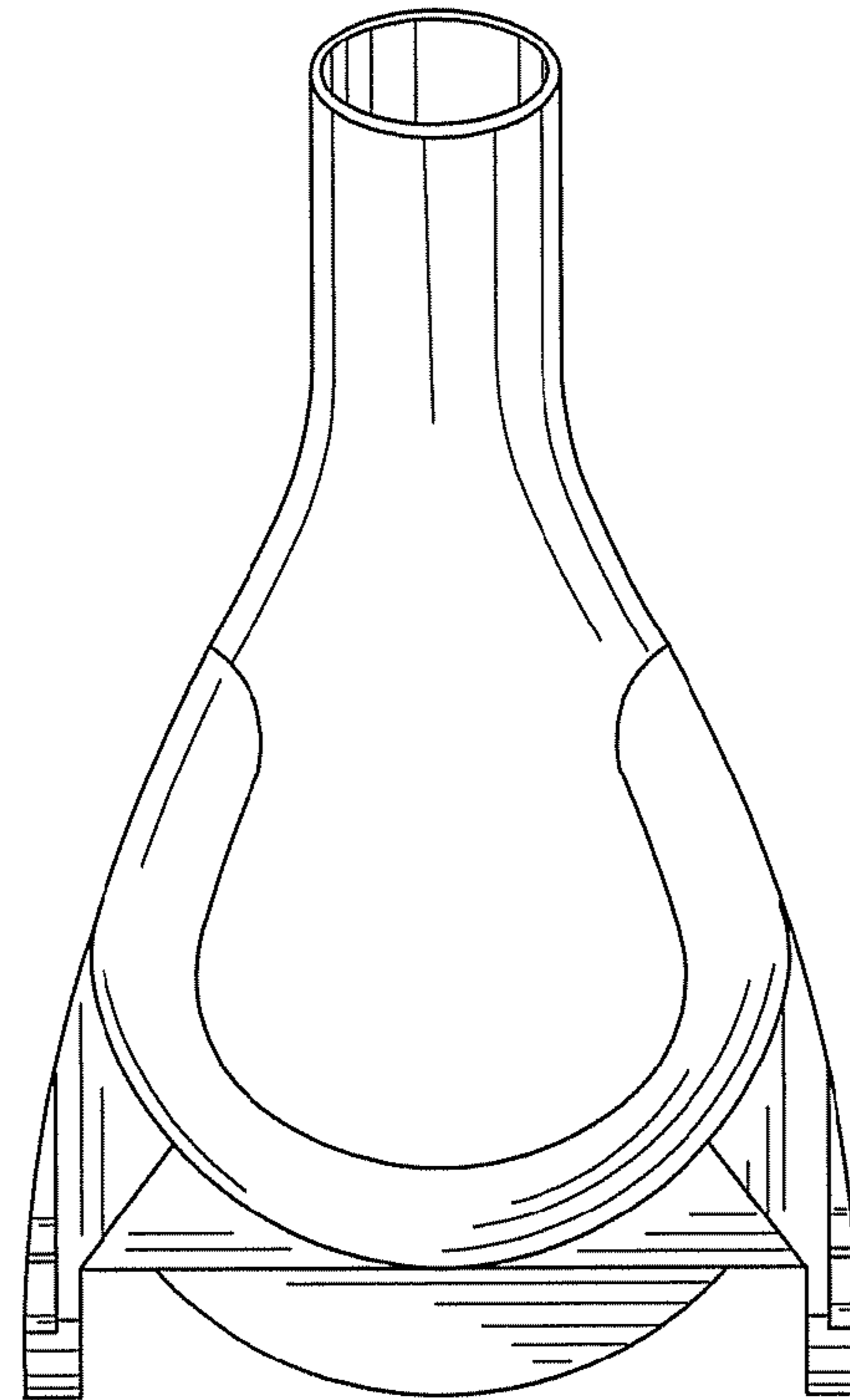
