The ornamental design for a pallet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pallet showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a side view which is a mirror image of the opposite side view thereof;

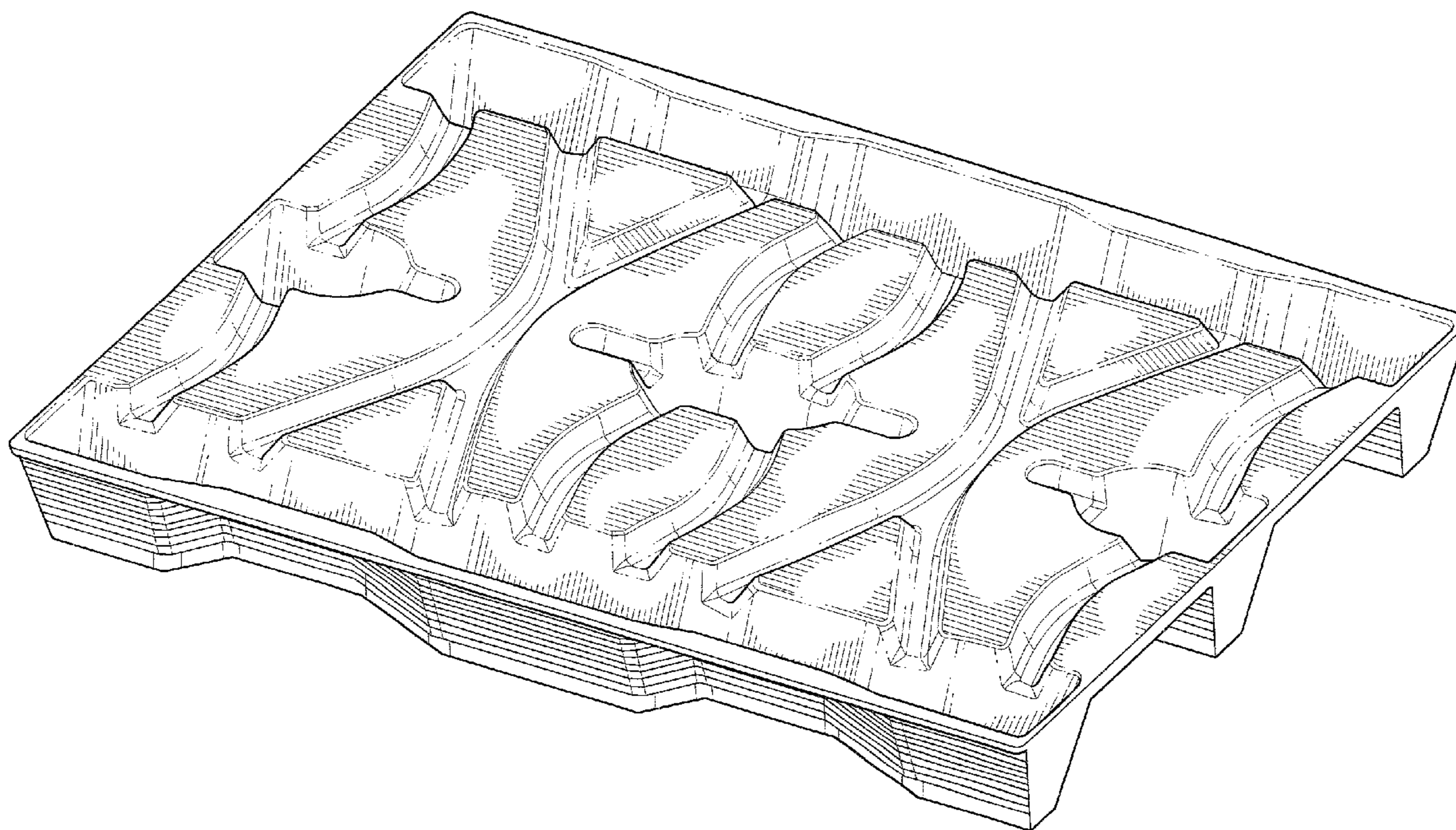
FIG. 4 is a front view thereof which is a mirror image of the opposite rear view thereof;

FIG. 5 is a sectional view taken at area 5—5 in FIG. 2;

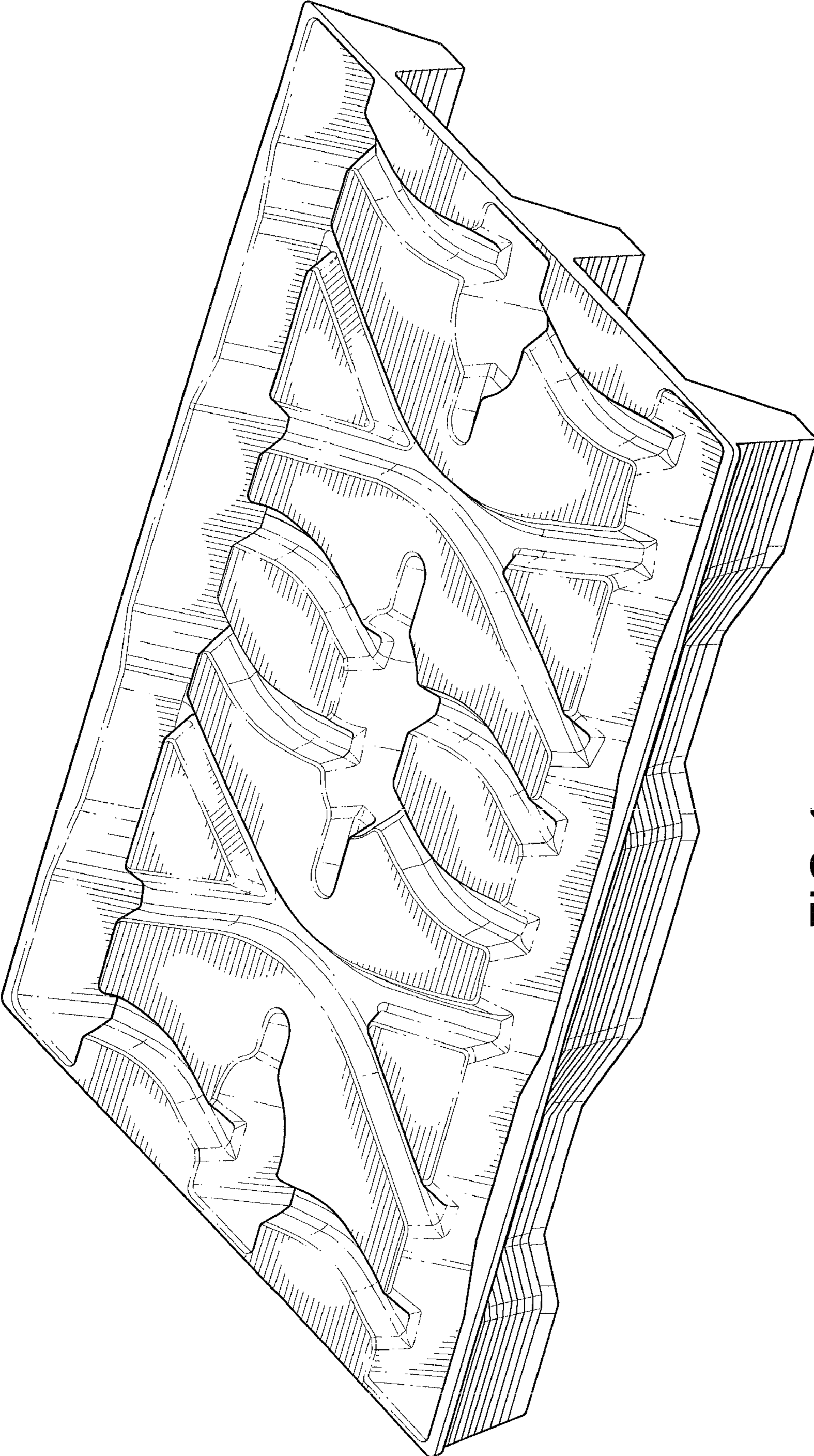

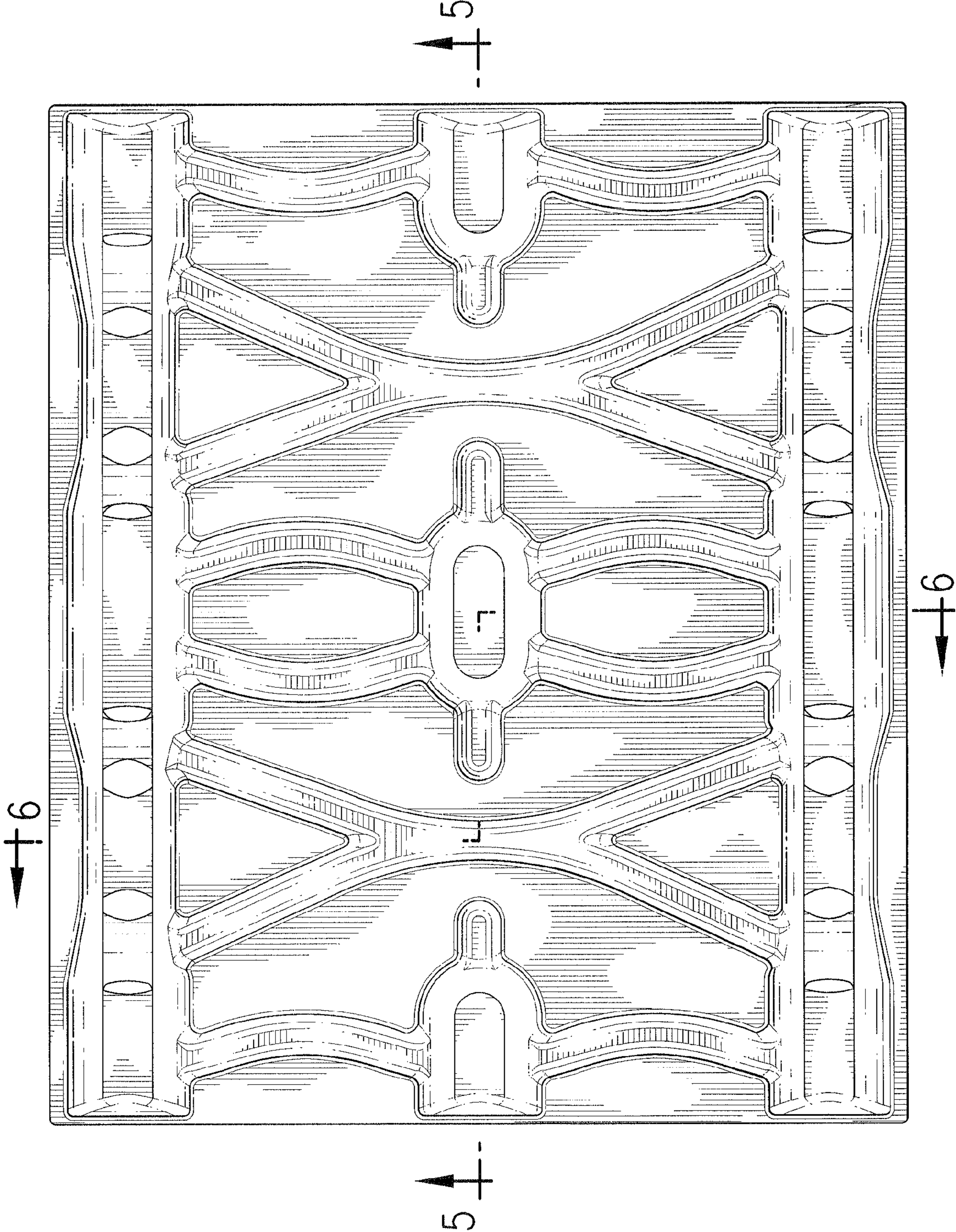

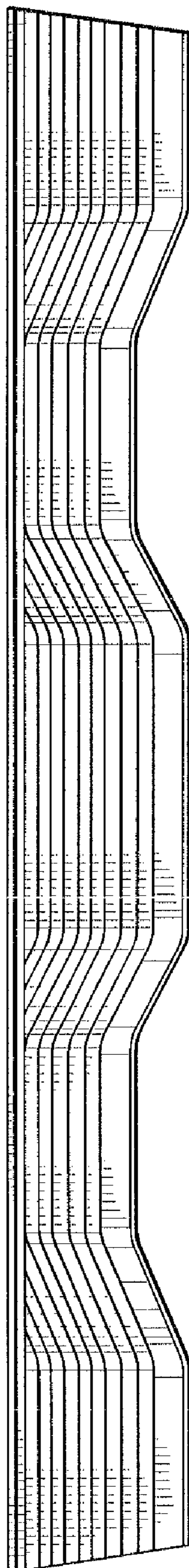

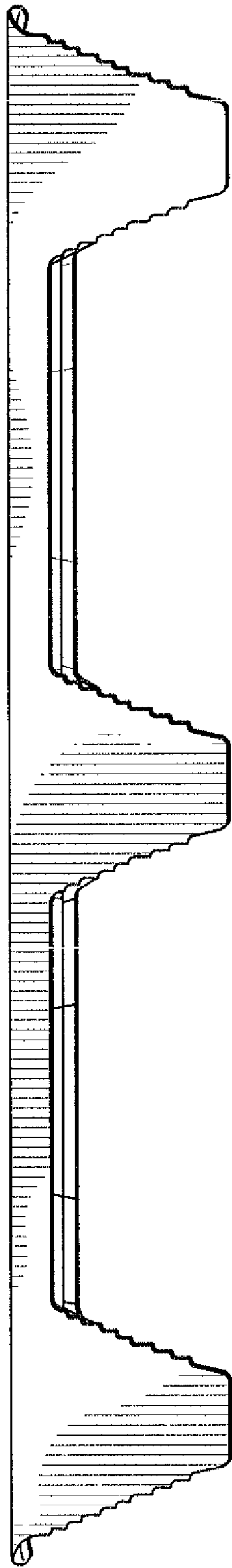

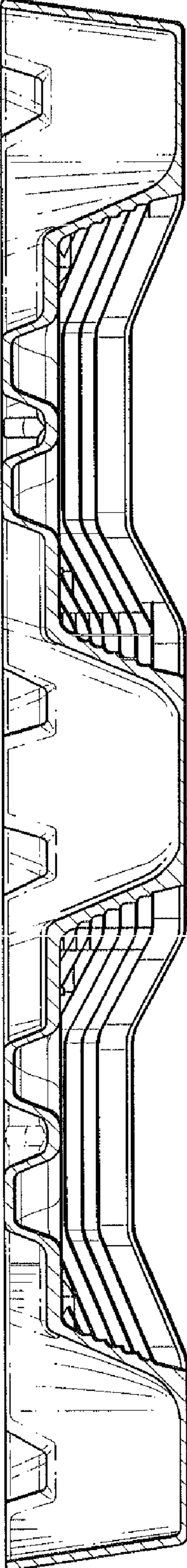

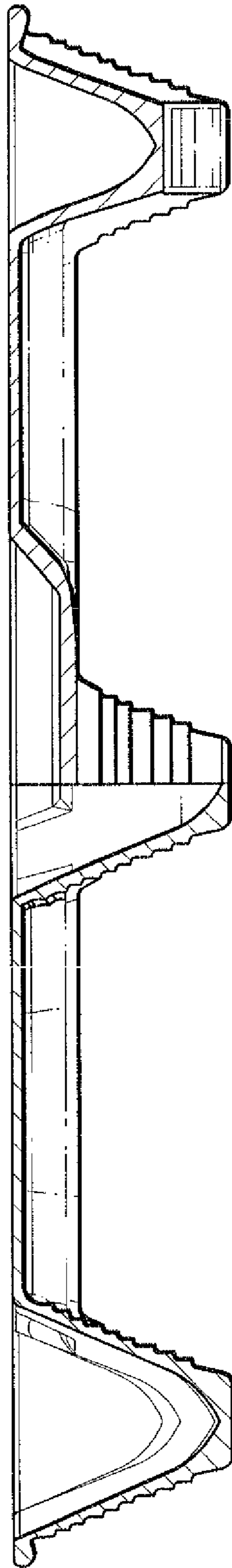
