FIG. 2 is a front view of a pair of sleeves with attached streamers.

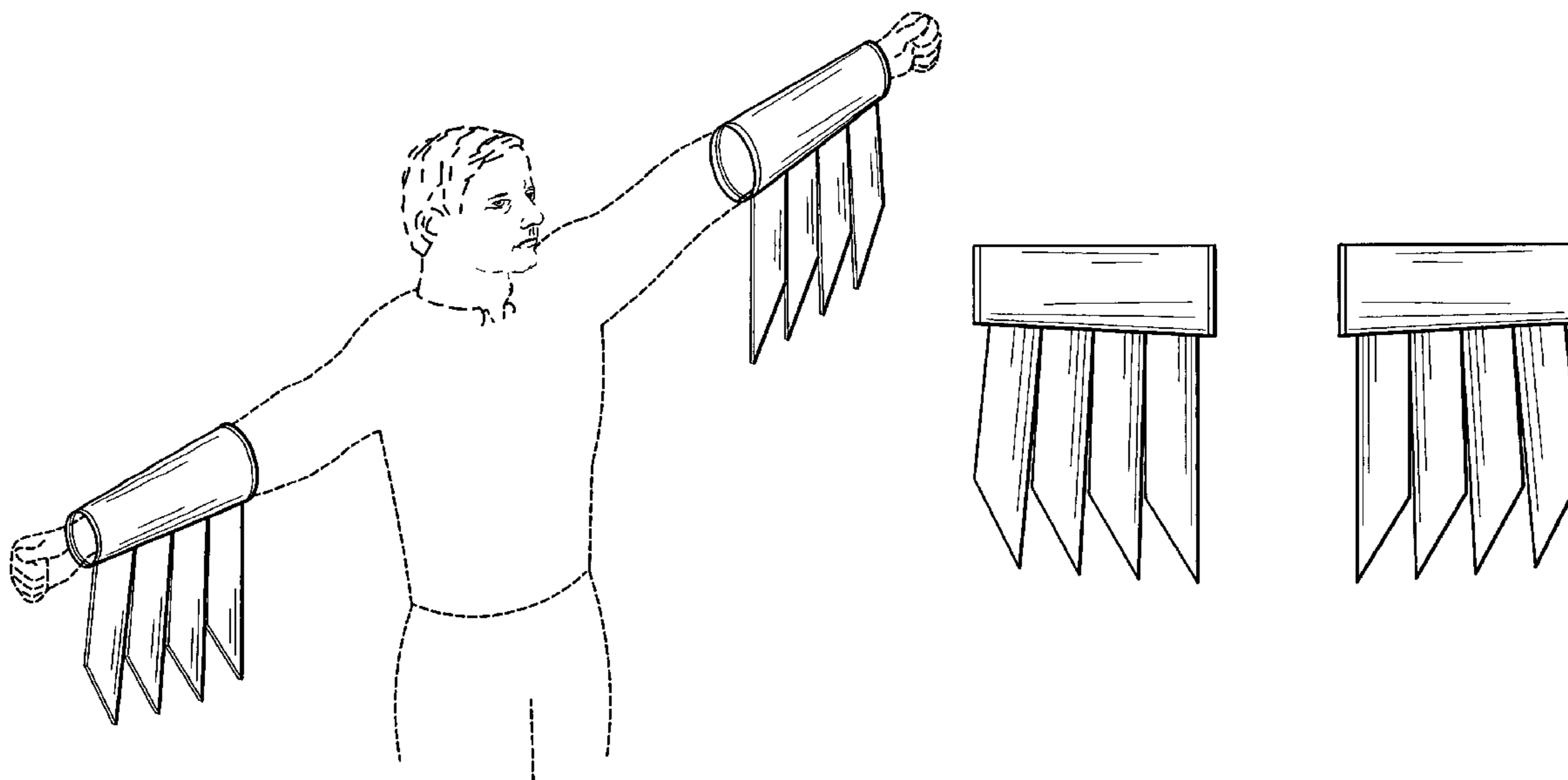
FIG. 3 is an end view of a sleeve with attached streamers.

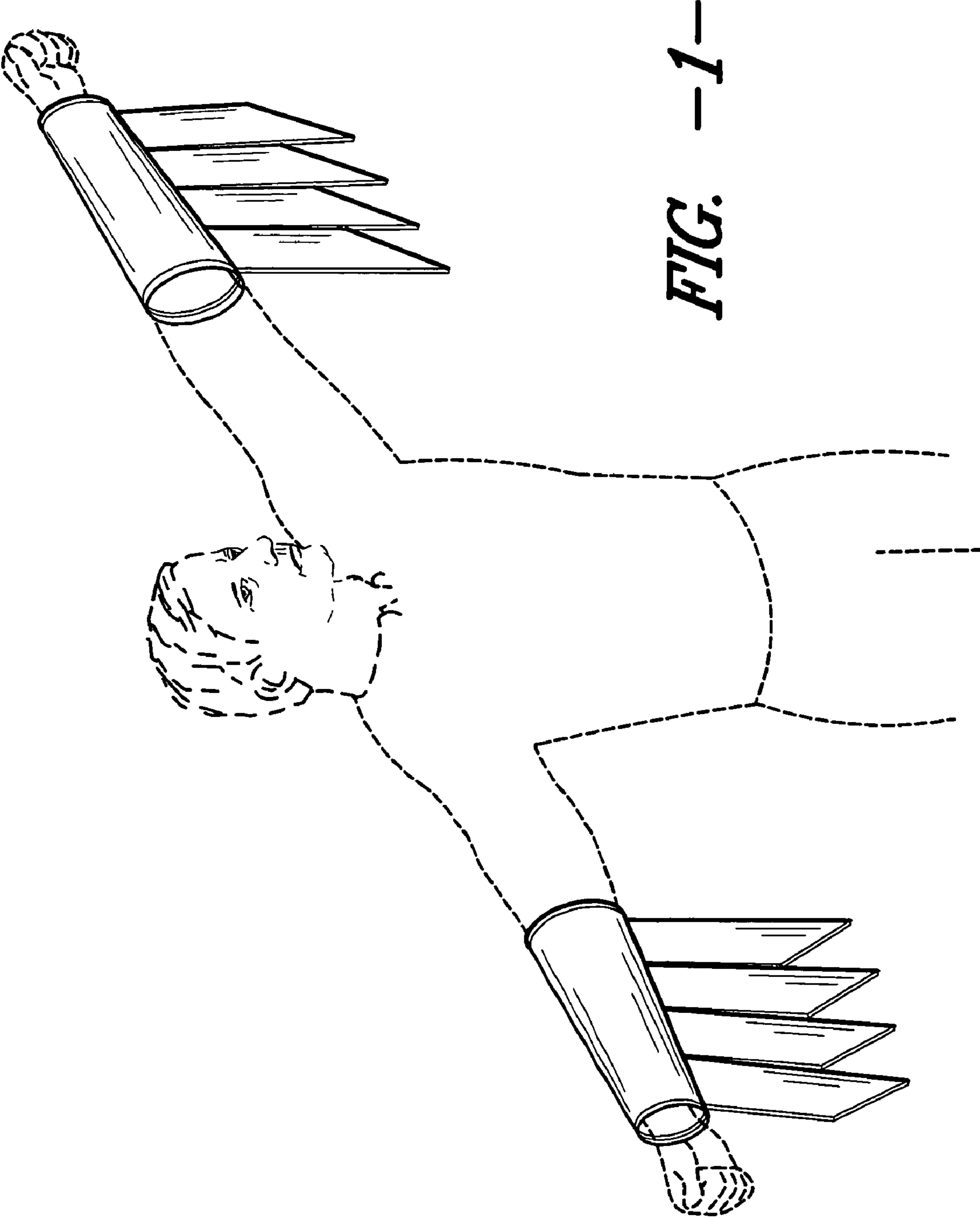
FIG. 4 is a top view of a pair of sleeves with attached streamers; and,

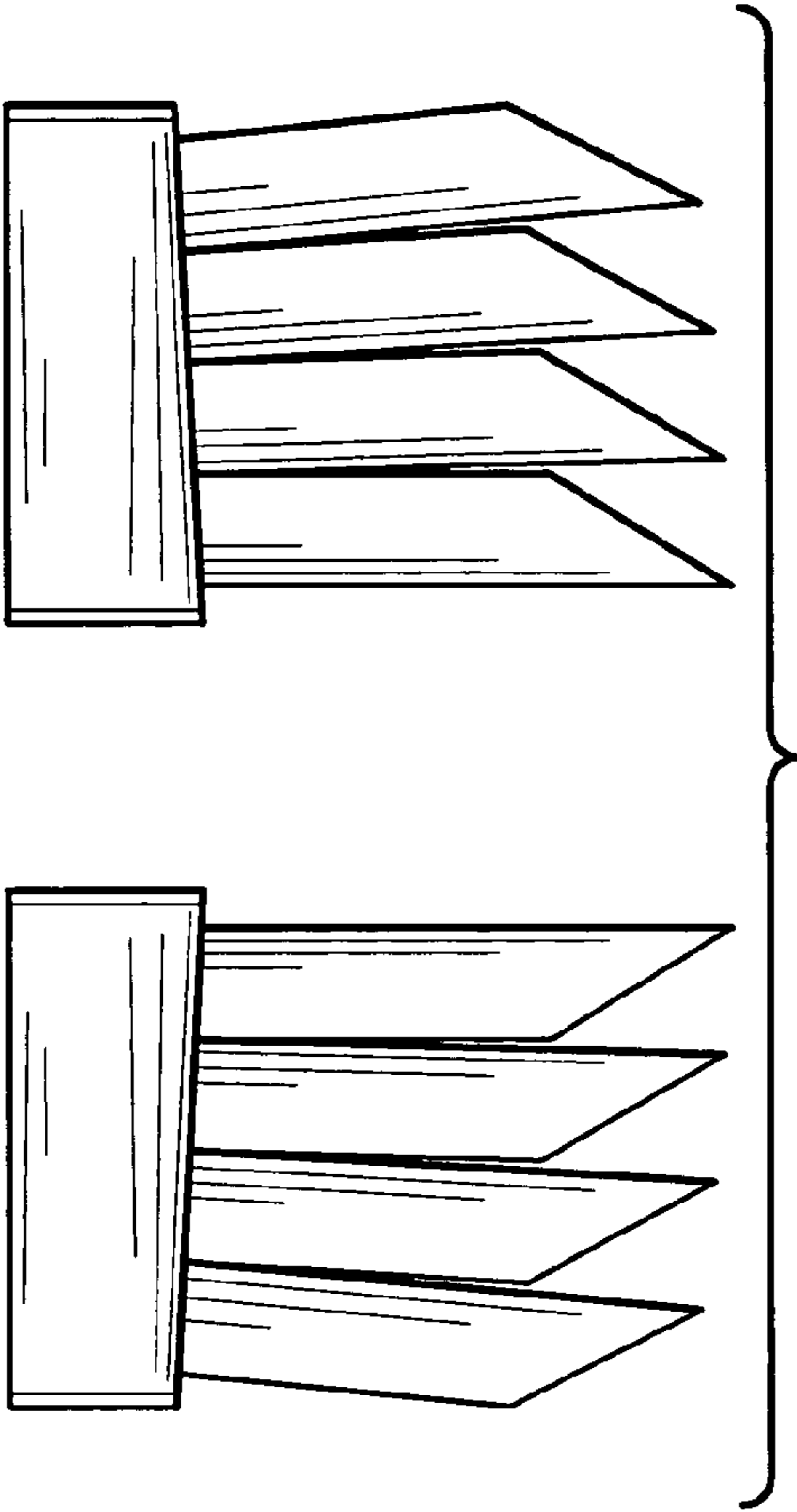
FIG. 5 is a bottom view of a pair of sleeves with attached streamers.

The broken lines showing a partial human form in FIG. 1 is for illustrative purpose only and does not form part of the claimed design.

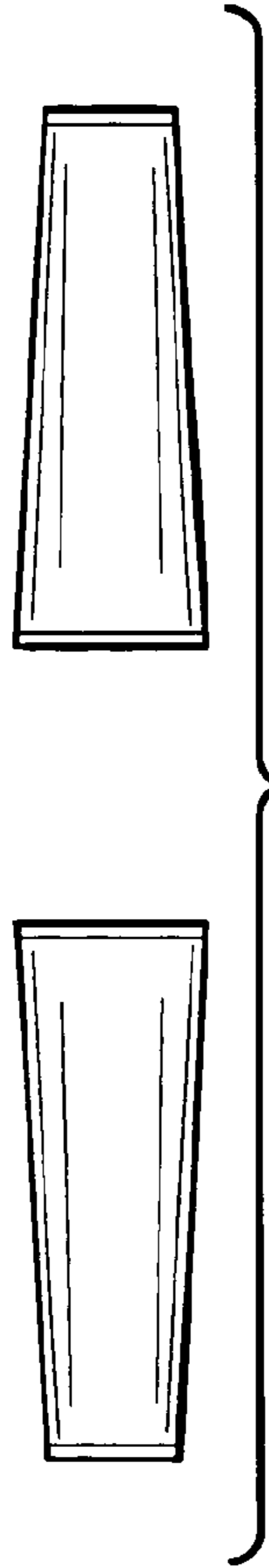

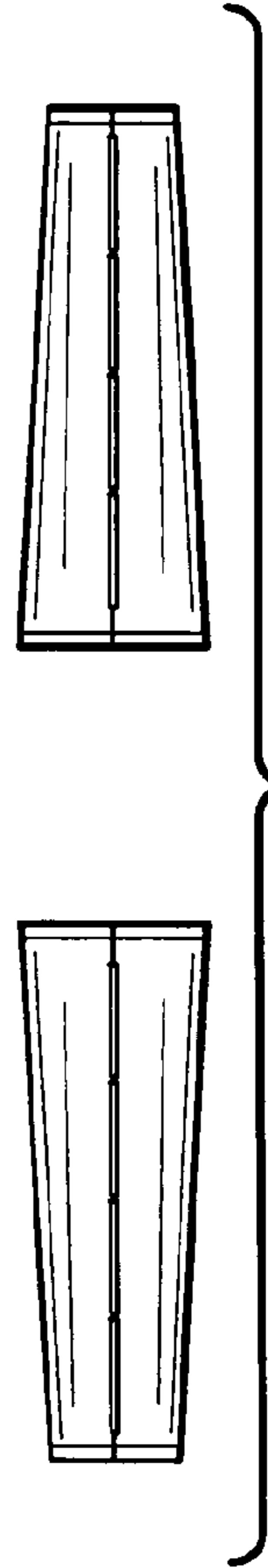
