(57) **CLAIM**

The ornamental design for an side element of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an side element of a shoe upper showing the new design;

FIG. 2 is a perspective view of an alternate embodiment of the shoe upper showing the new design;

FIG. 3 is a side elevational view of the first embodiment of the shoe upper of the new design; and,

FIG. 4 is a side elevational of the alternative embodiment.

The even broken lines in FIGS. 2 and 4 represent design elements. The uneven broken lines in all figures showing the remainder of the shoe are for illustrative purposes only and form no part of the claimed design.

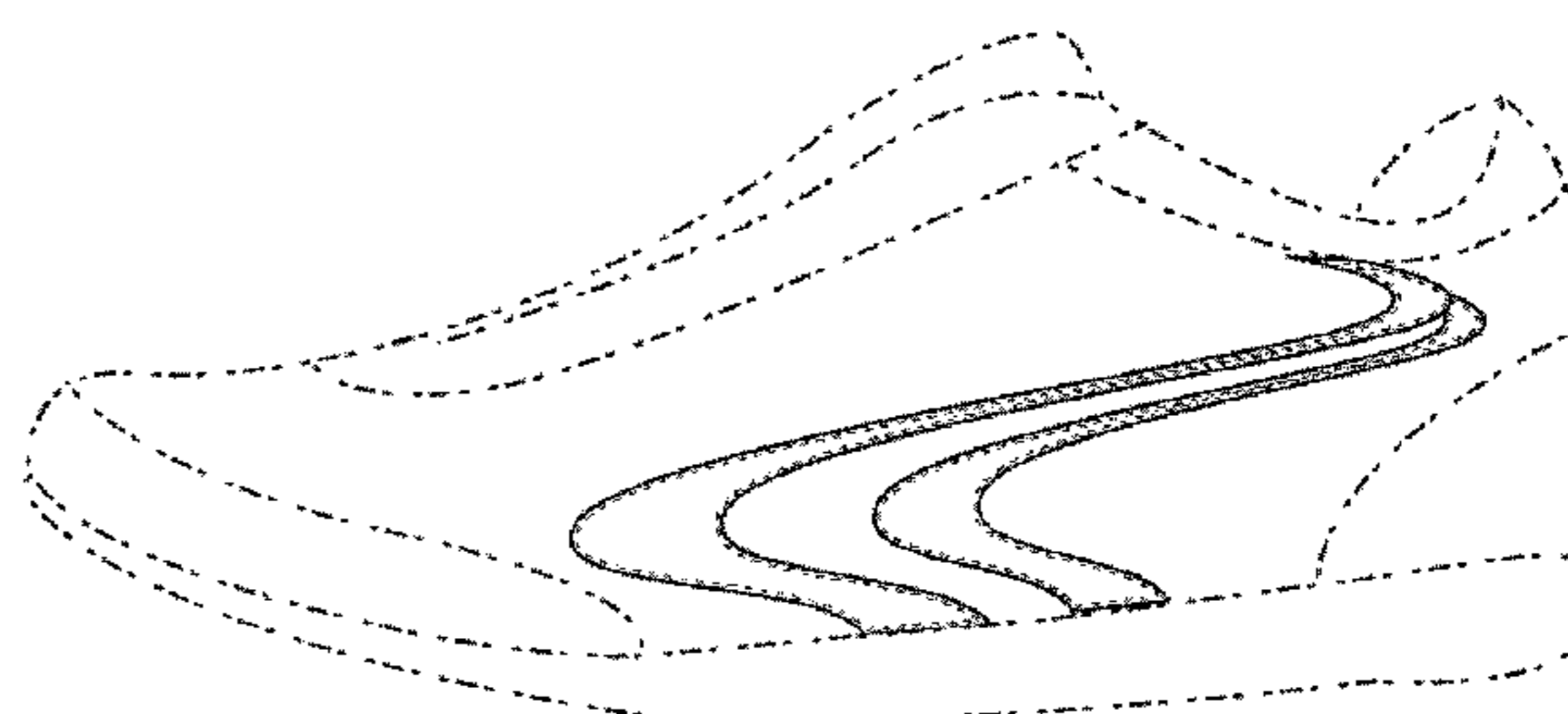
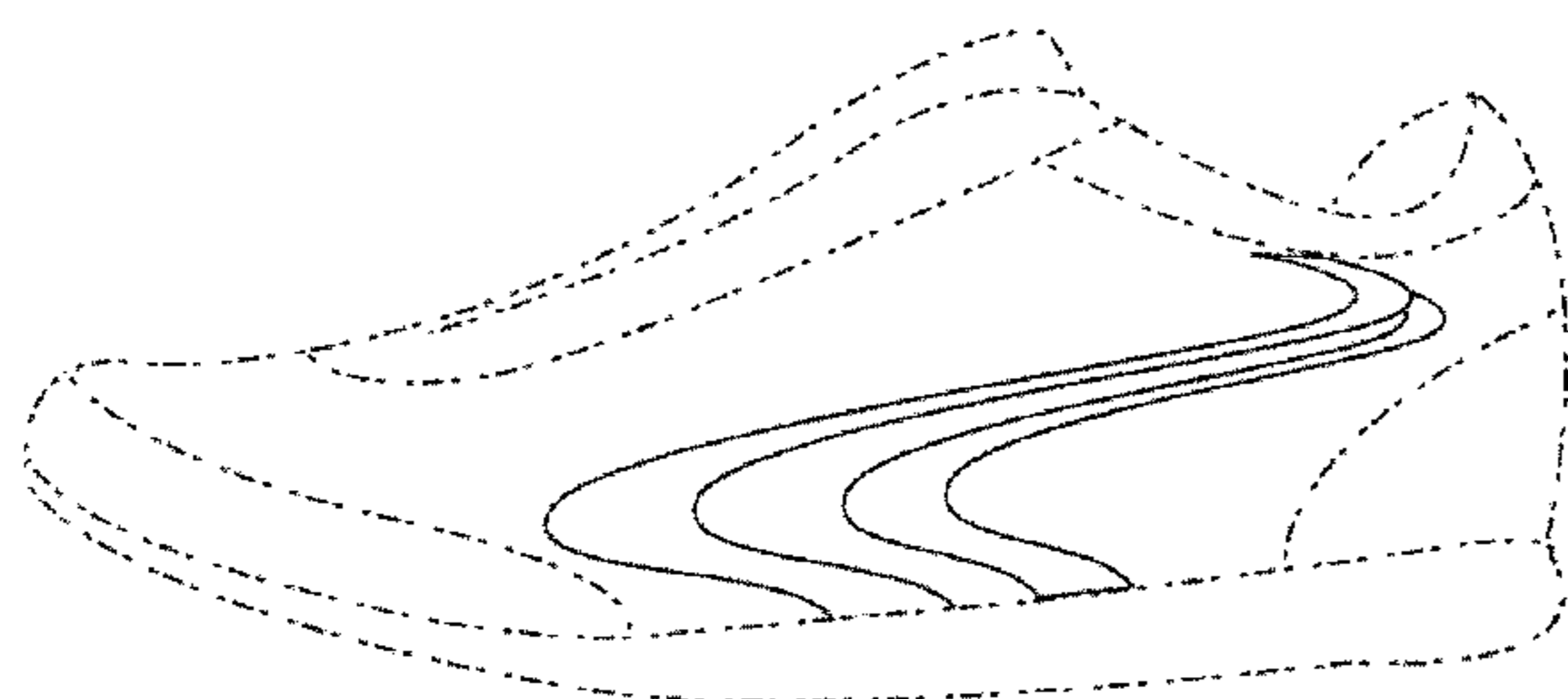

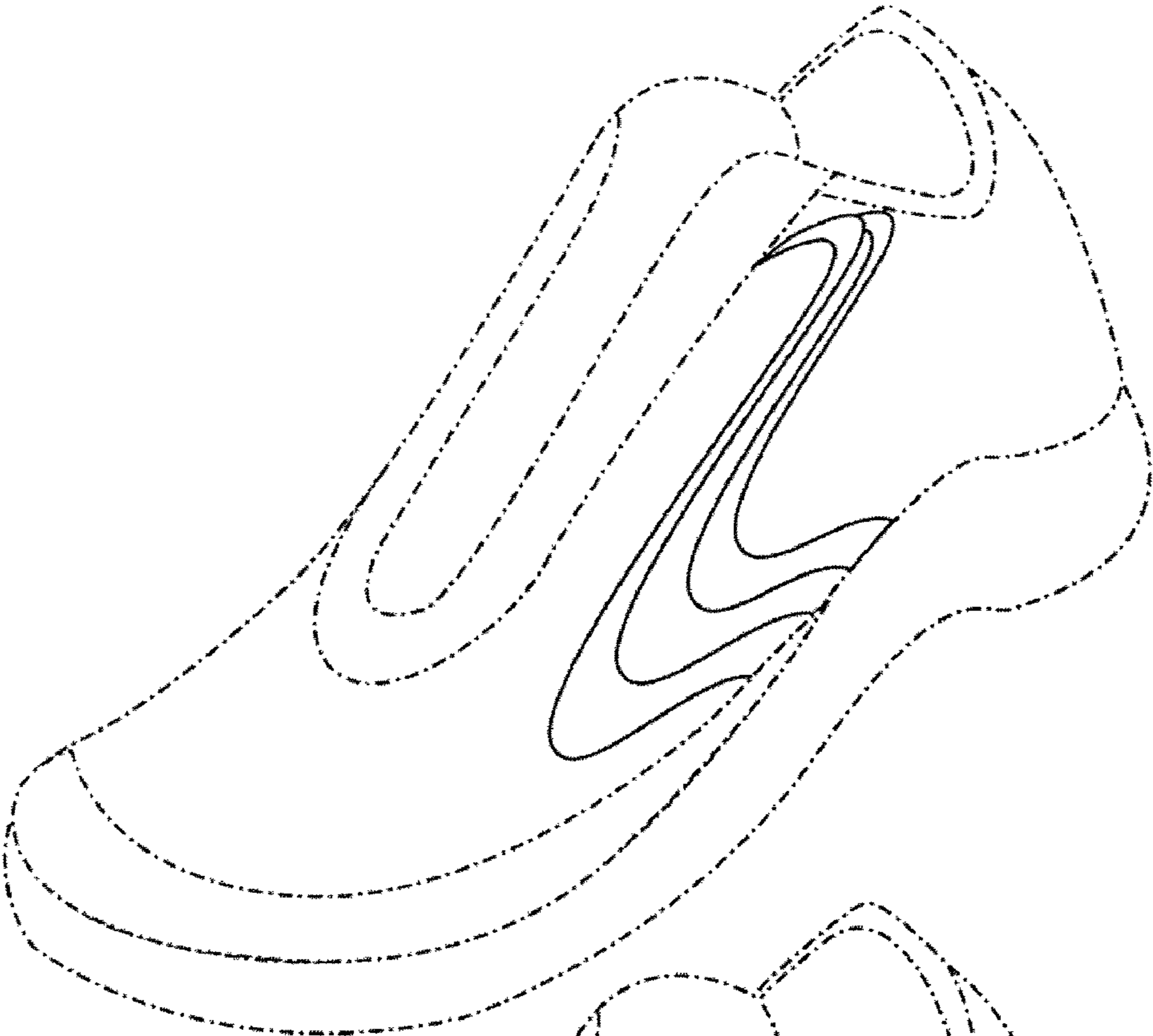

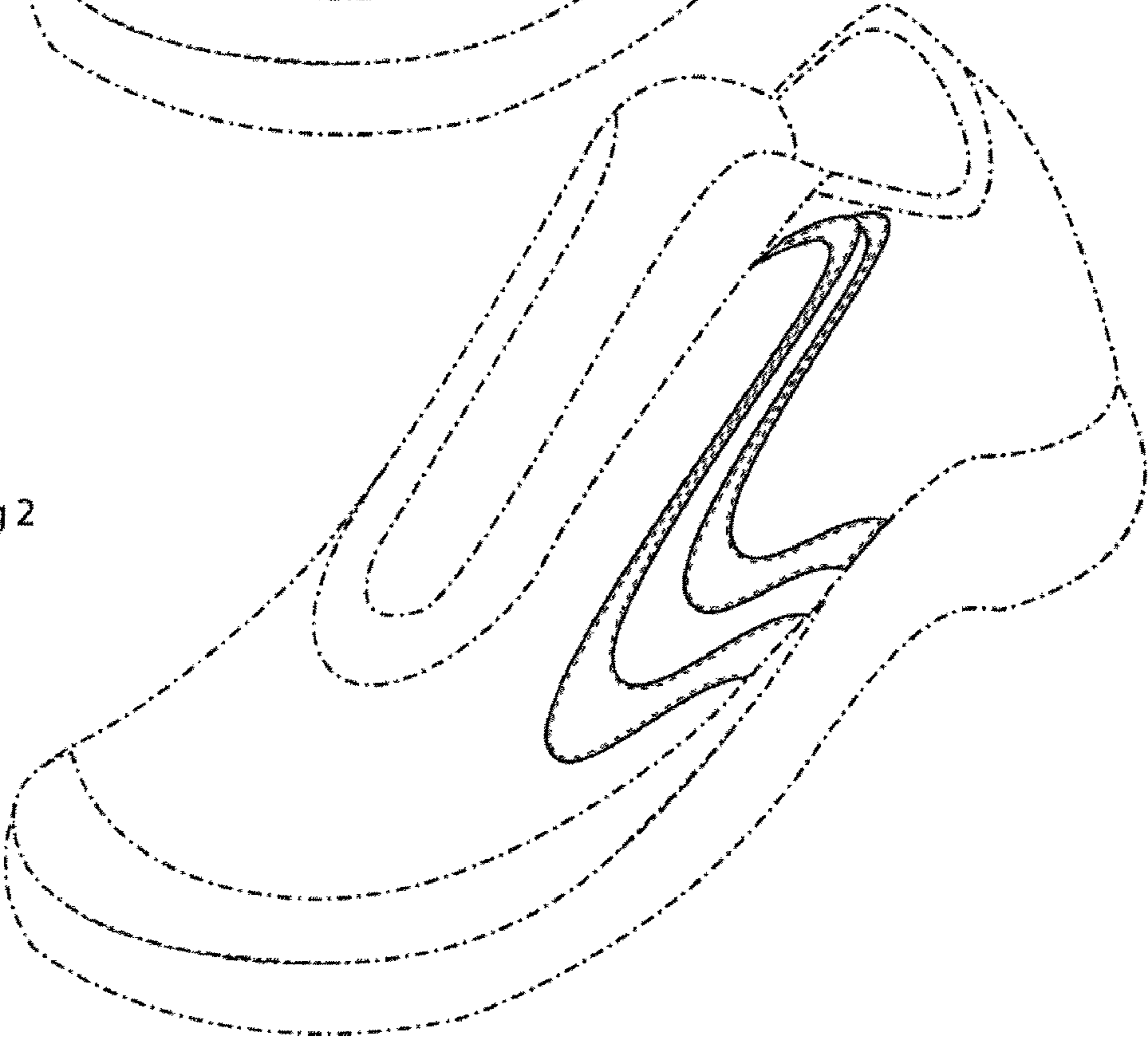

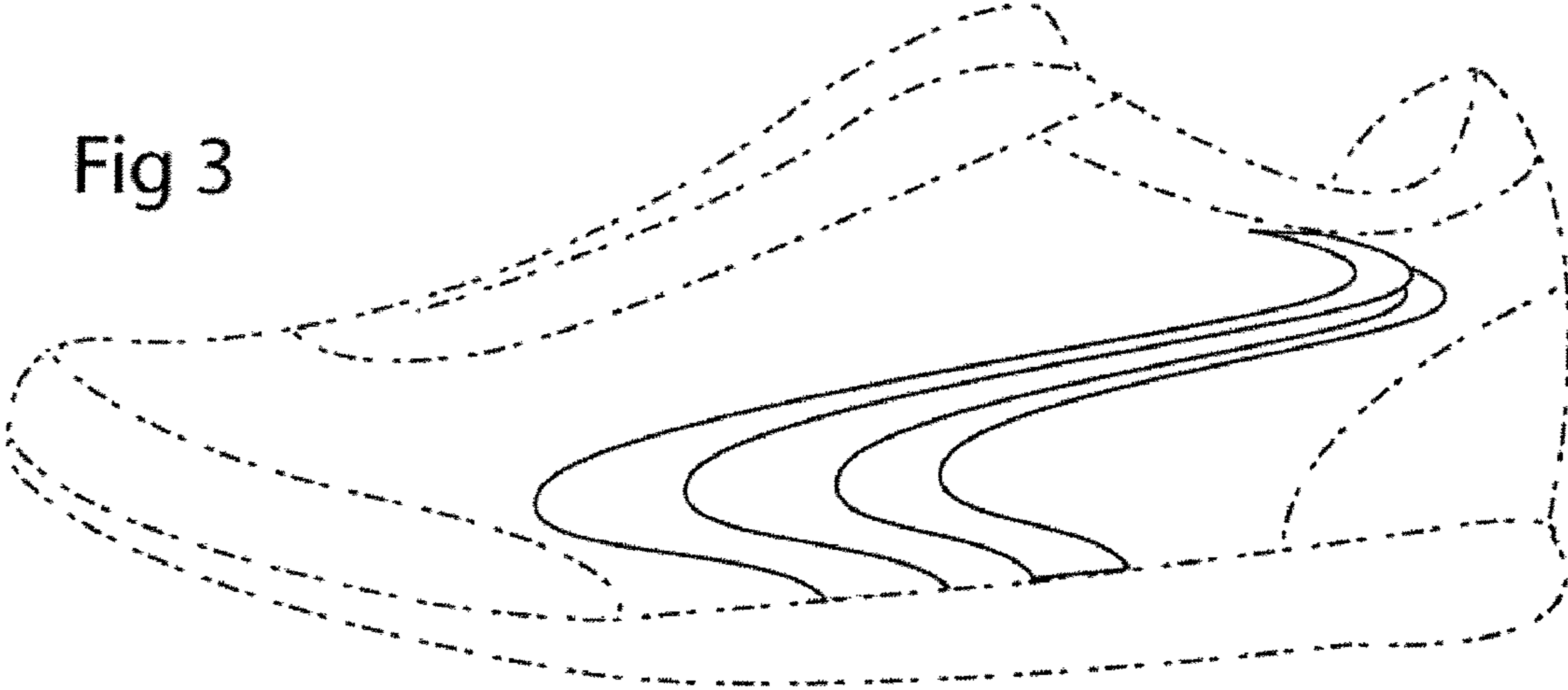
