FIG. 4 is a left side view of the handbag;

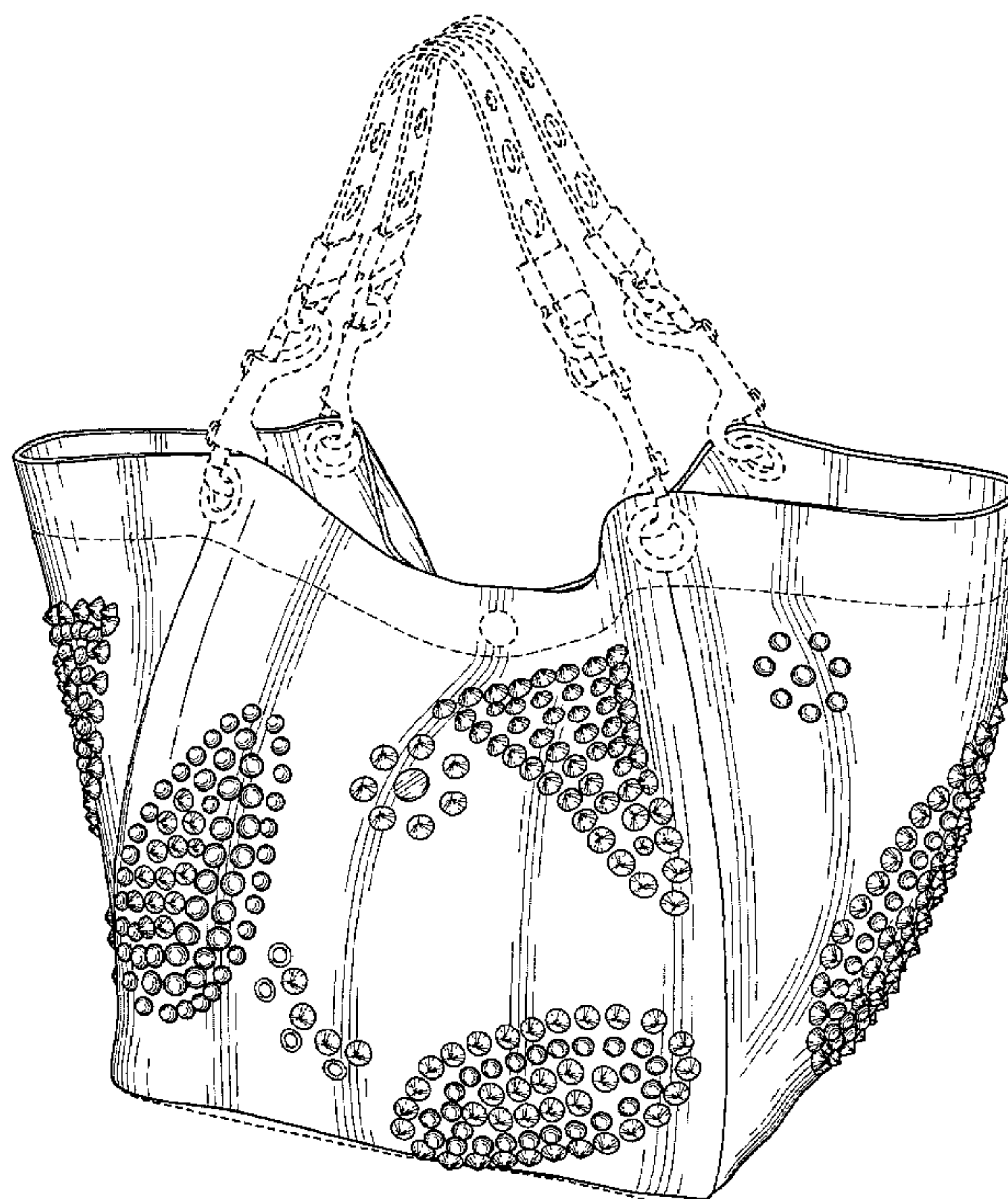
FIG. 5 is a right side view of the handbag;

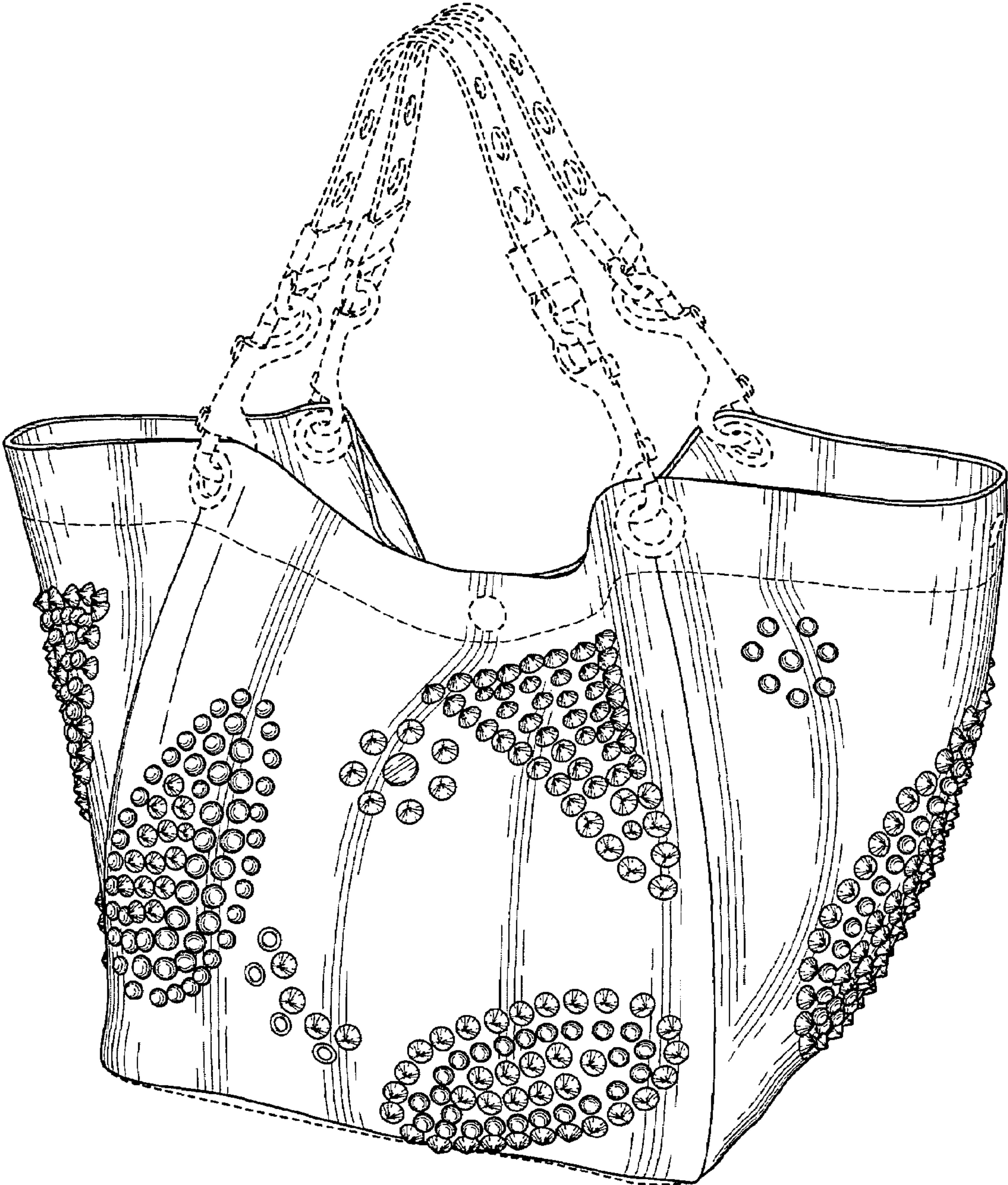

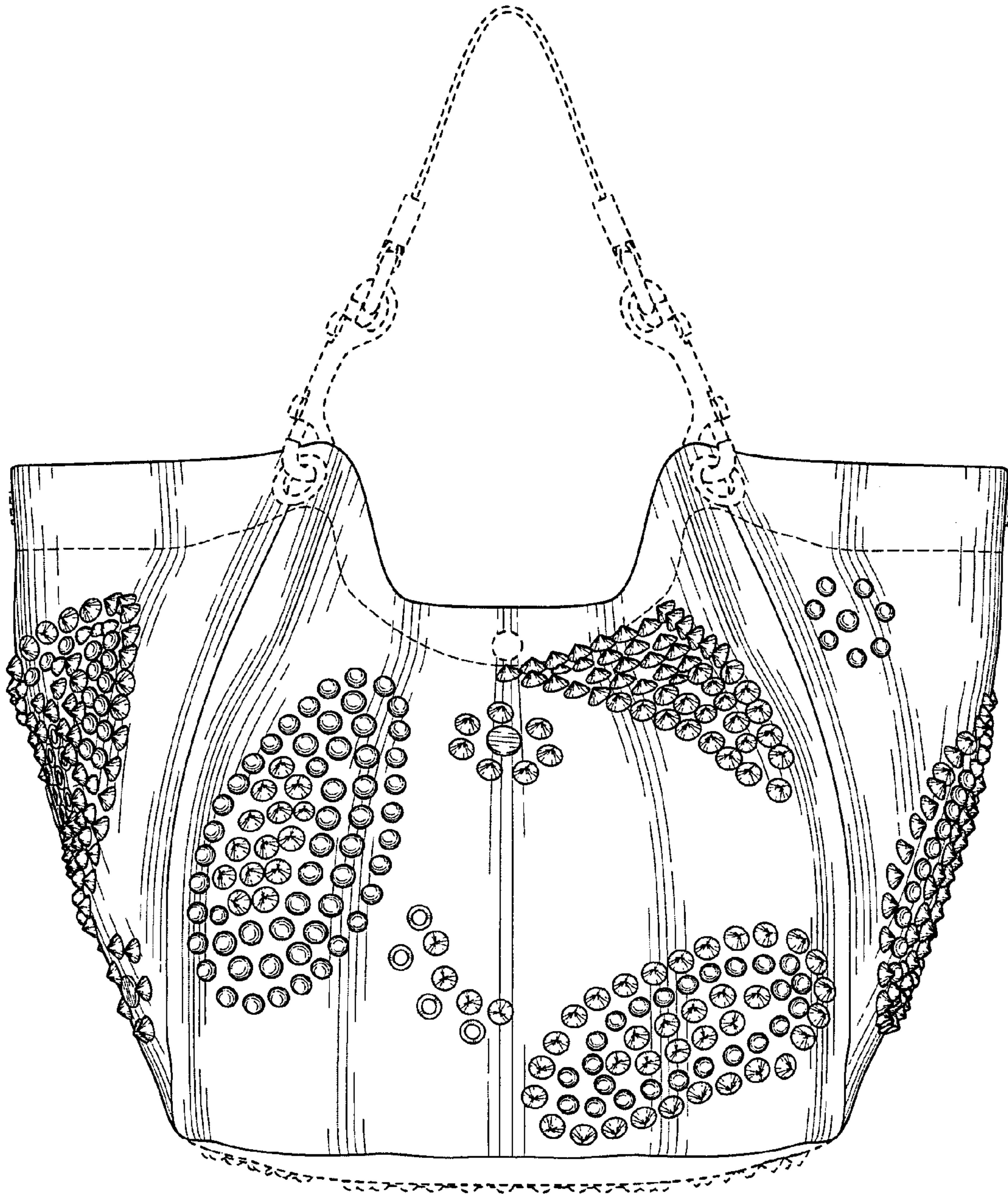

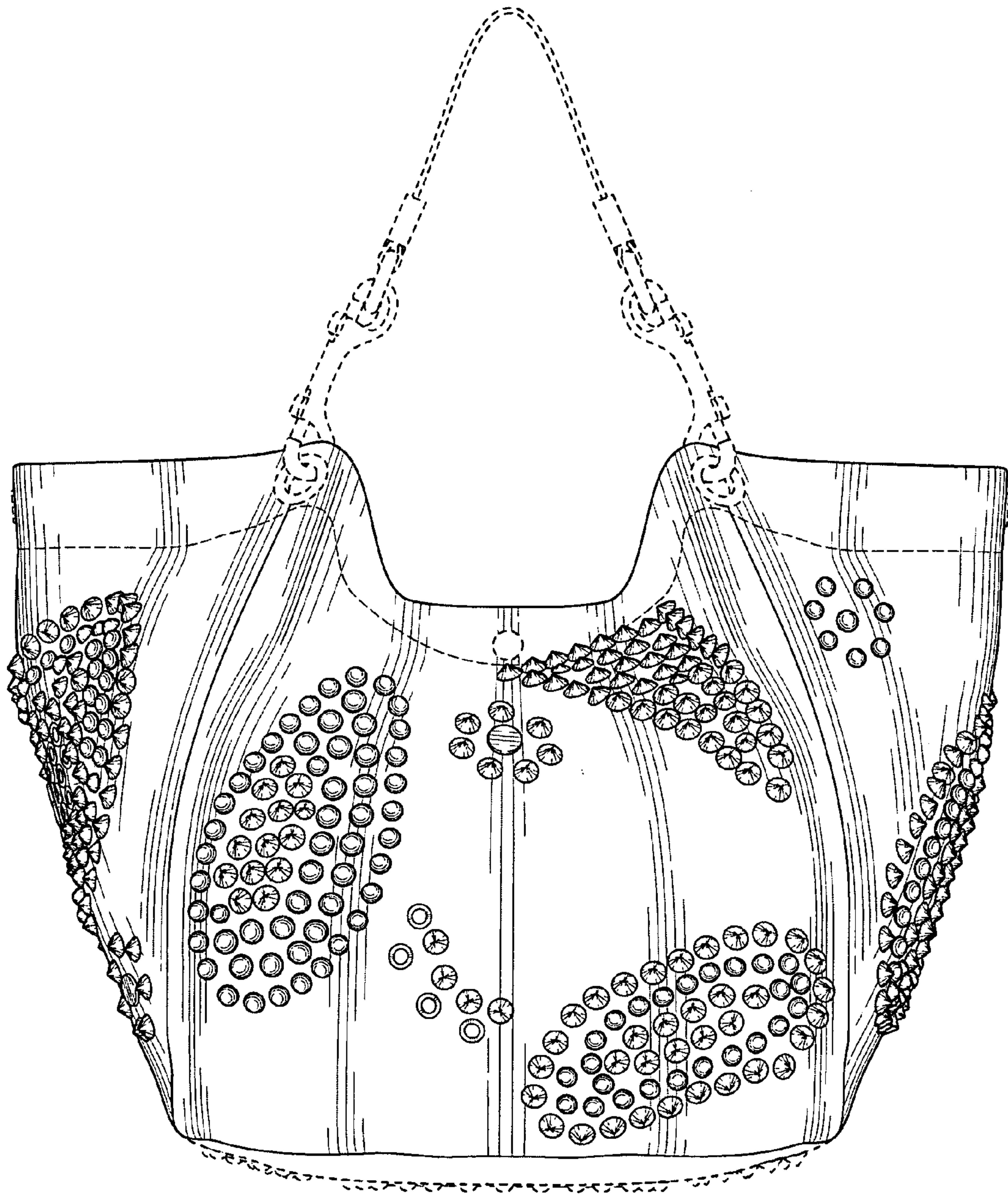

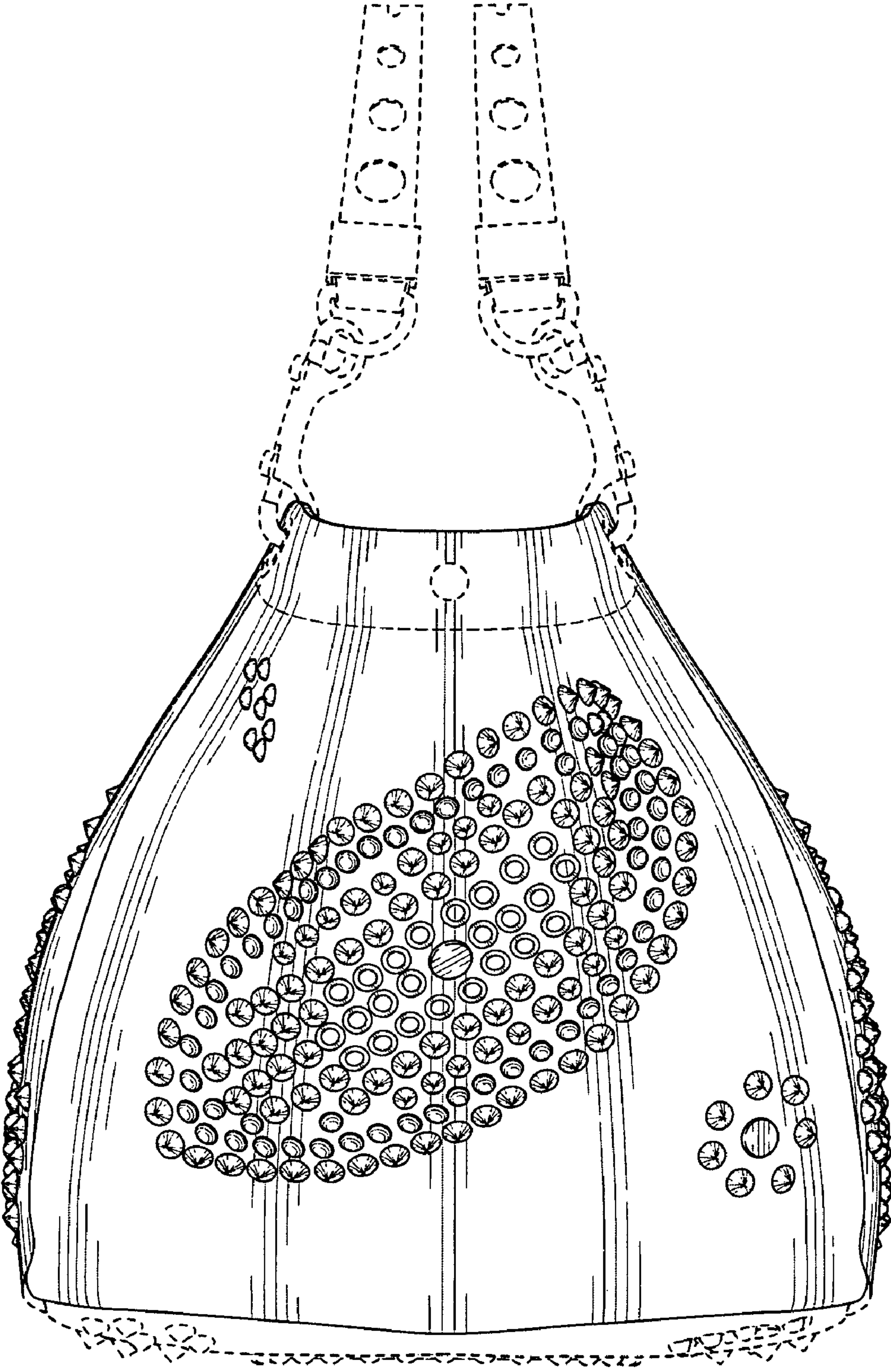

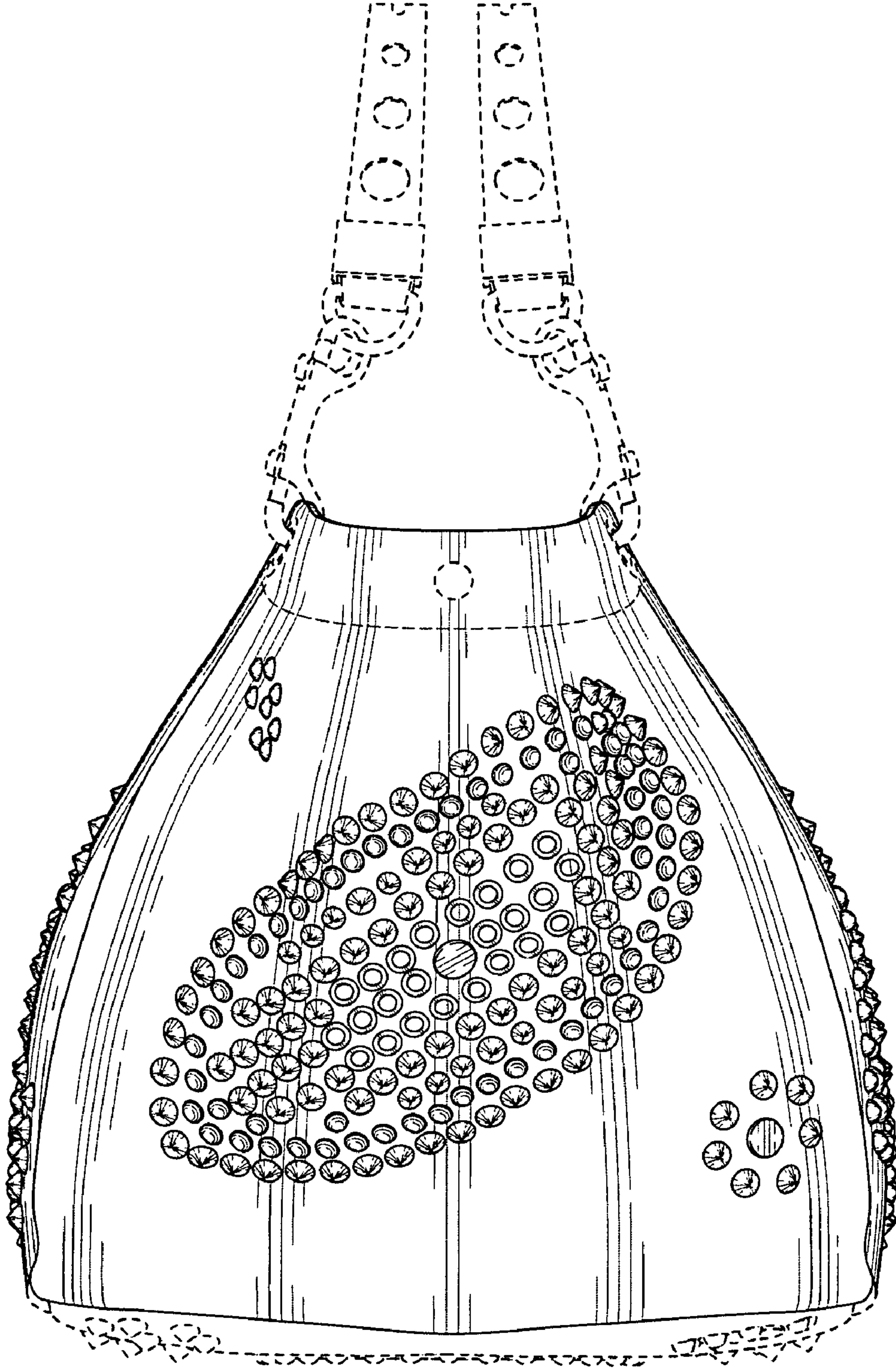

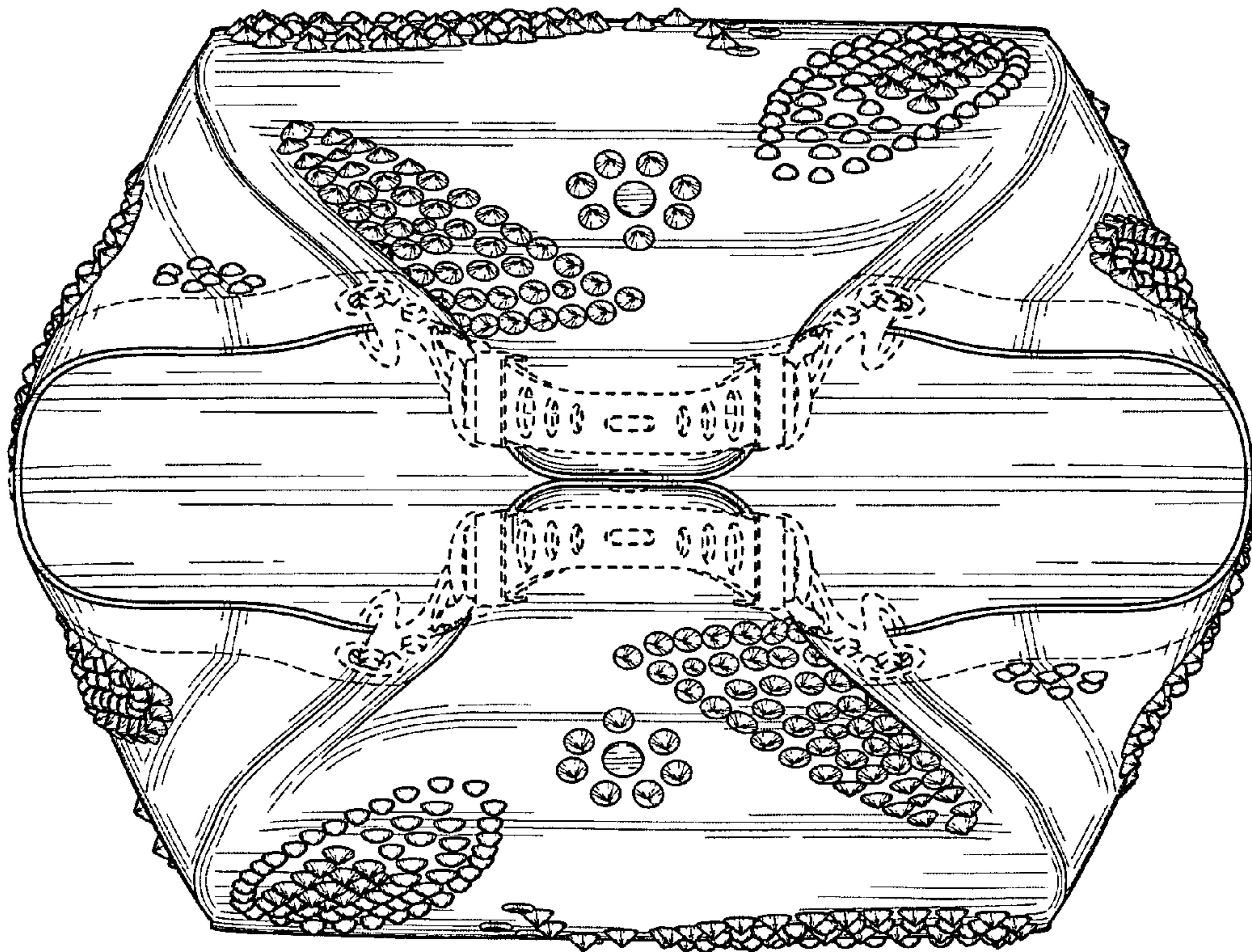

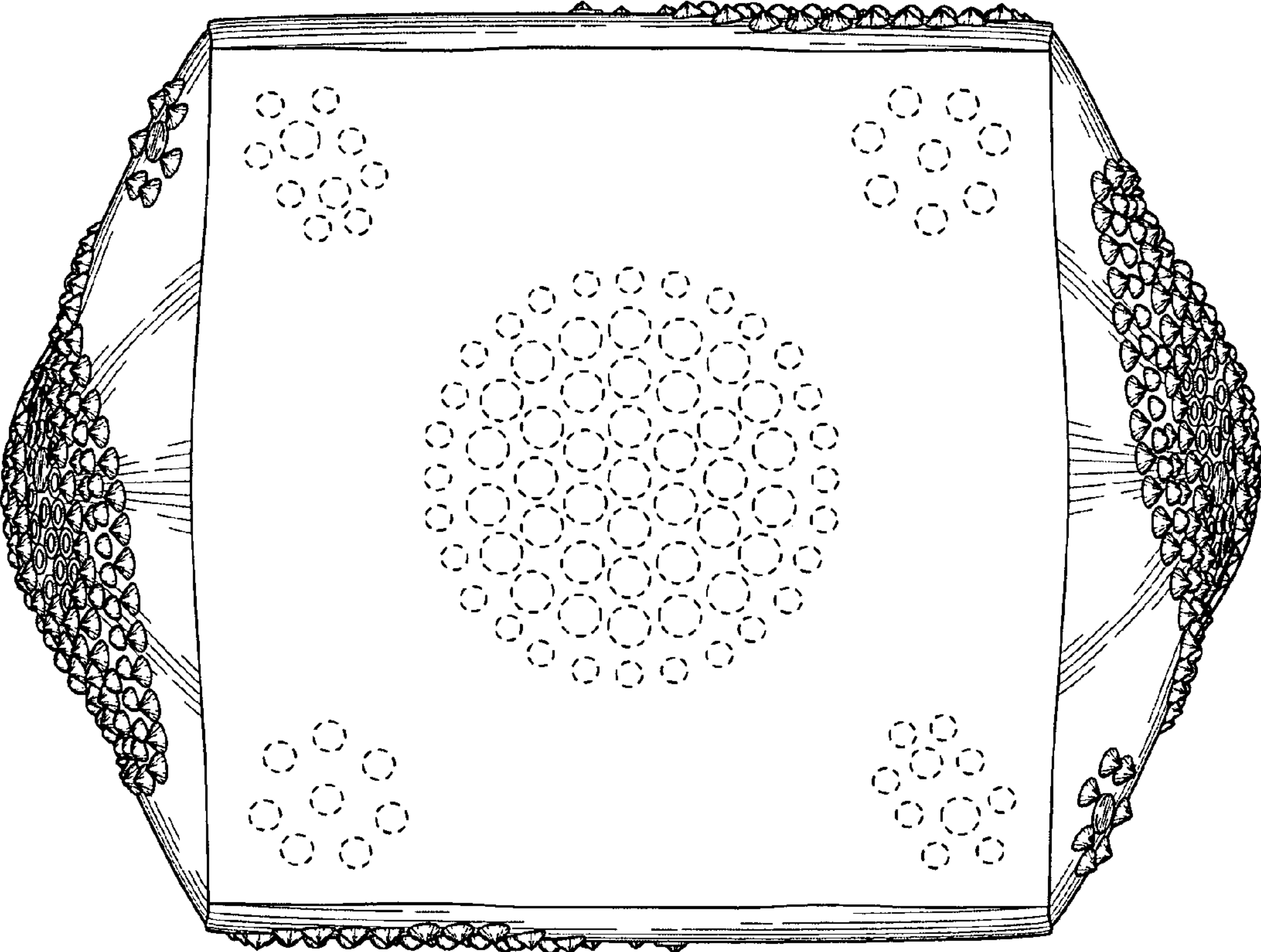
