(57) **CLAIM**

I, claim the ornamental design for a twin-flap double opening shoulder bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the twin-flap double opening shoulder bag of the present invention;

FIG. 2 is a front elevational view of the bag of FIG. 1;

FIG. 3 is a first side elevational view of the bag of FIG. 1;

FIG. 4 is a rear elevational view of the bag of FIG. 1;

FIG. 5 is a second side elevational view of the bag of FIG. 1, showing the opposite side from that of FIG. 3;

FIG. 6 is a top plan view of the bag of FIG. 1;

FIG. 7 is a bottom plan view of the bag of FIG. 1;

FIG. 8 is a perspective view of an alternative version of the twin-flap double opening shoulder bag of the present invention;

FIG. 9 is a front elevational view of the bag of FIG. 8;

FIG. 10 is a first side elevational view of the bag of FIG. 8;

FIG. 11 is a rear elevational view of the bag of FIG. 8;

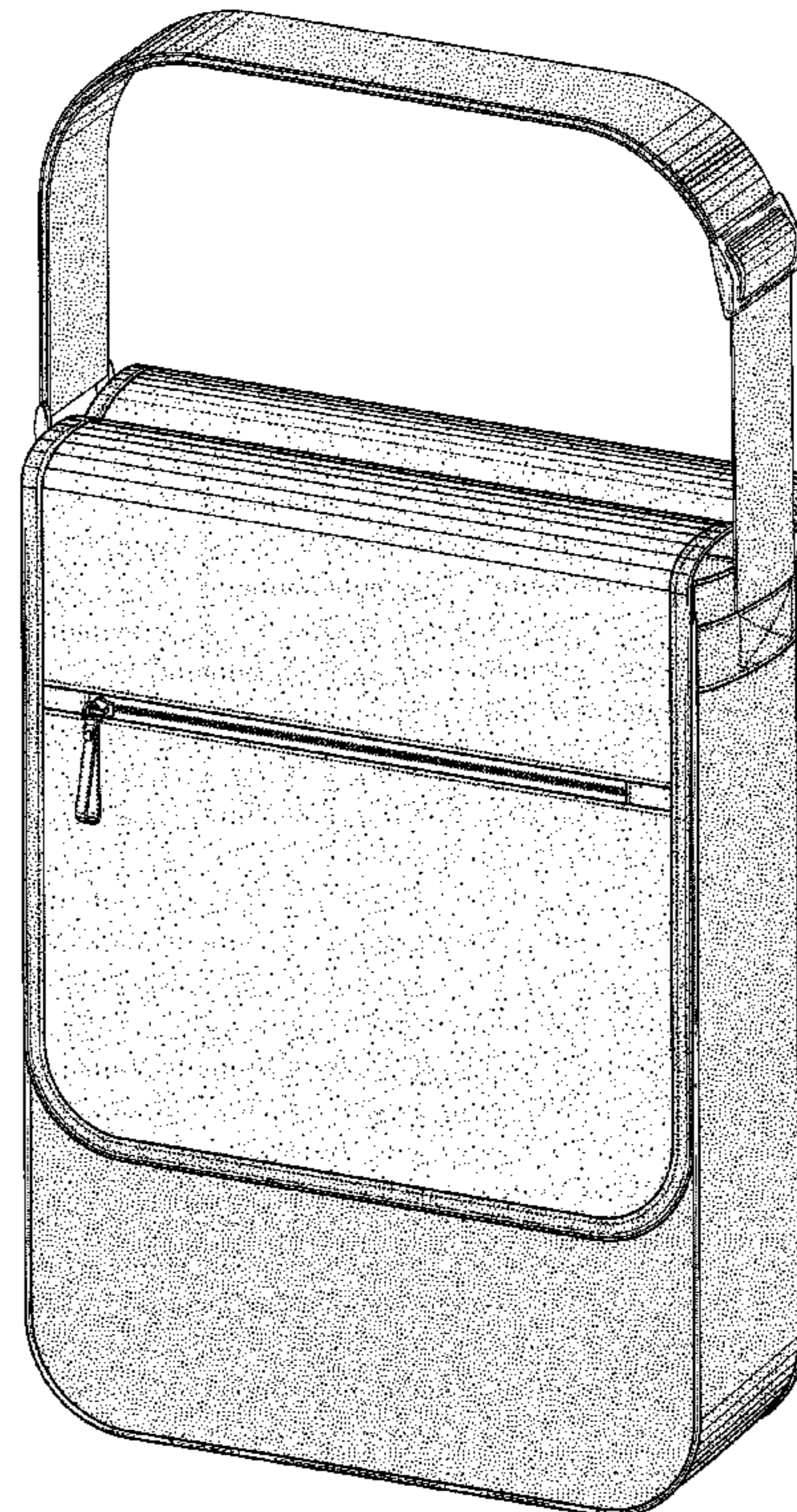
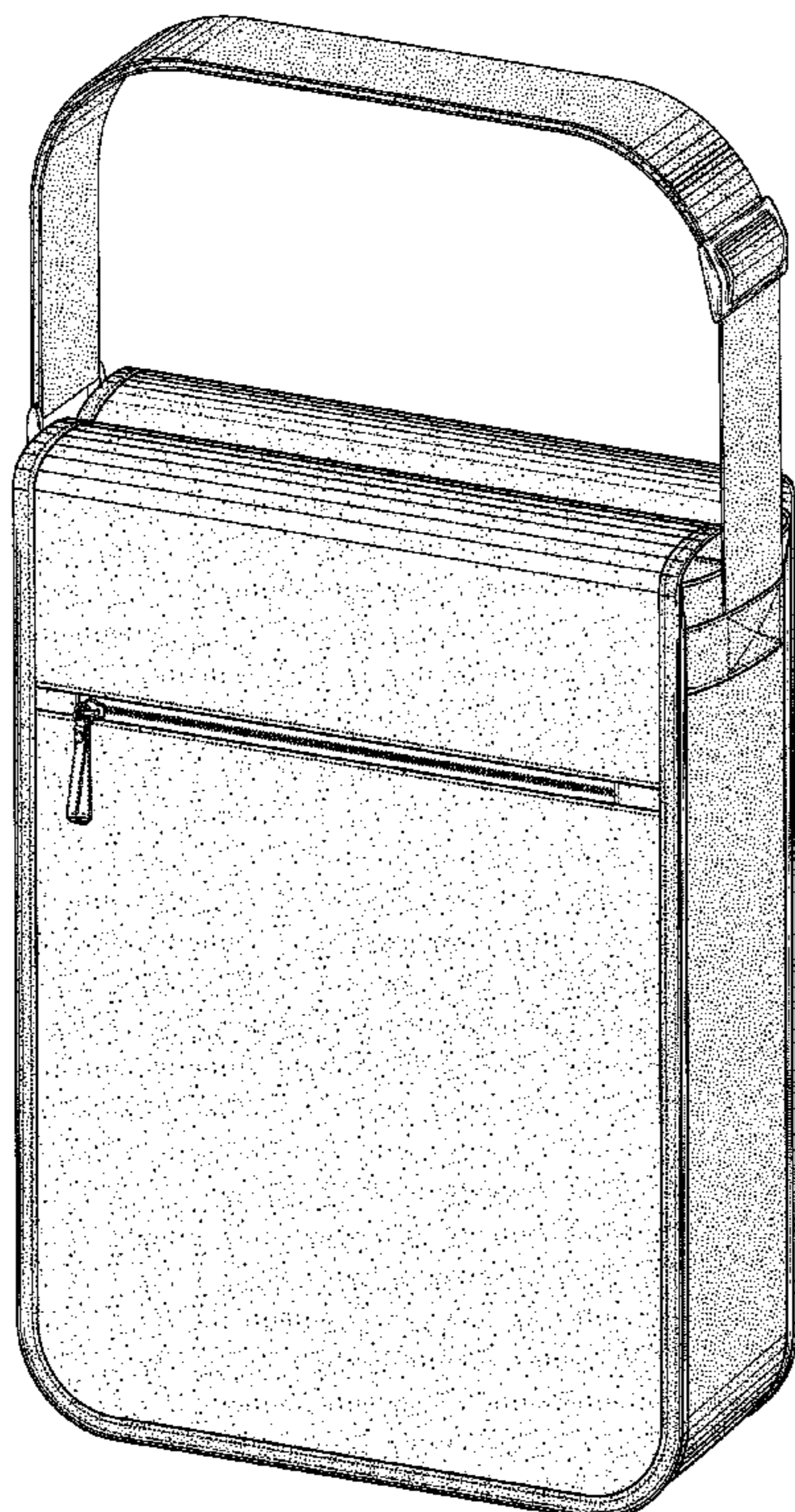
FIG. 12 is a second side elevational view of the bag of FIG. 8, showing the opposite side from that of FIG. 10;

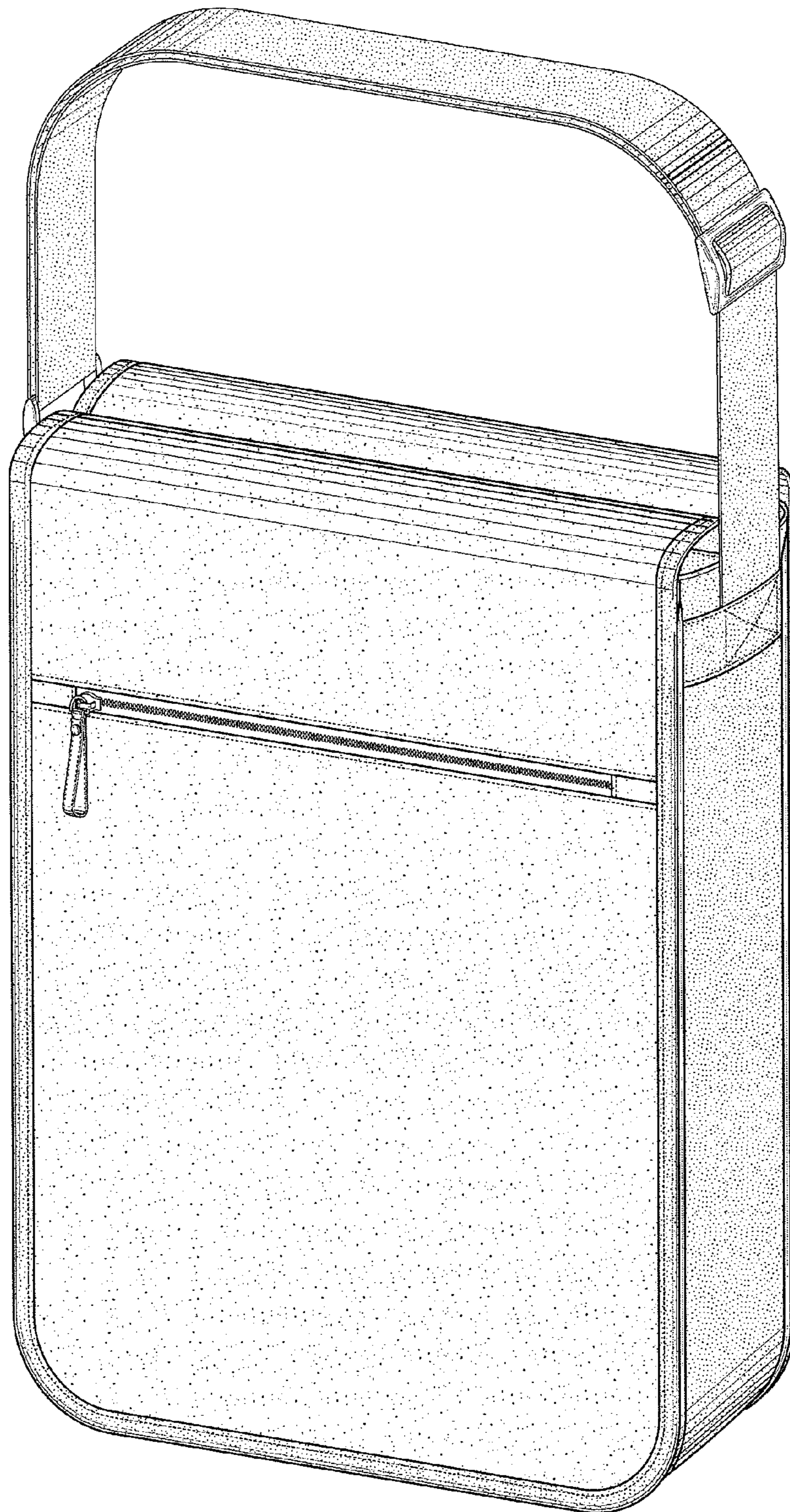

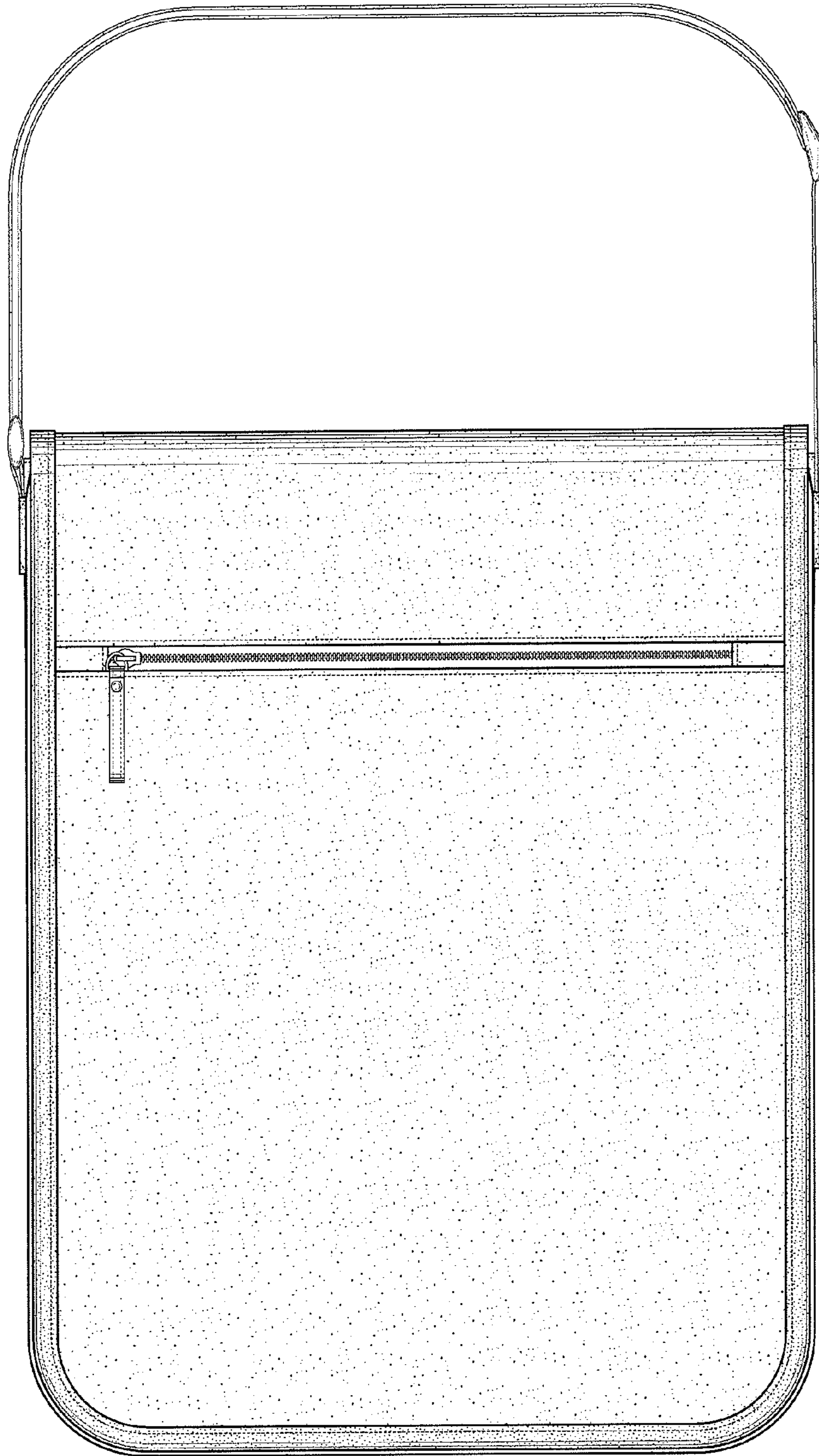

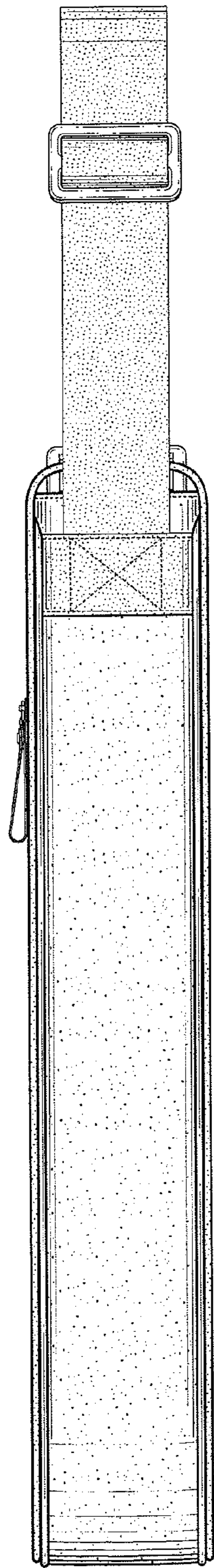

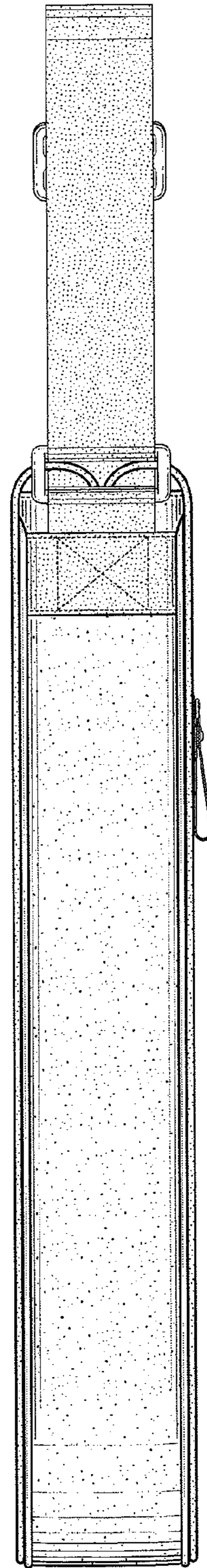

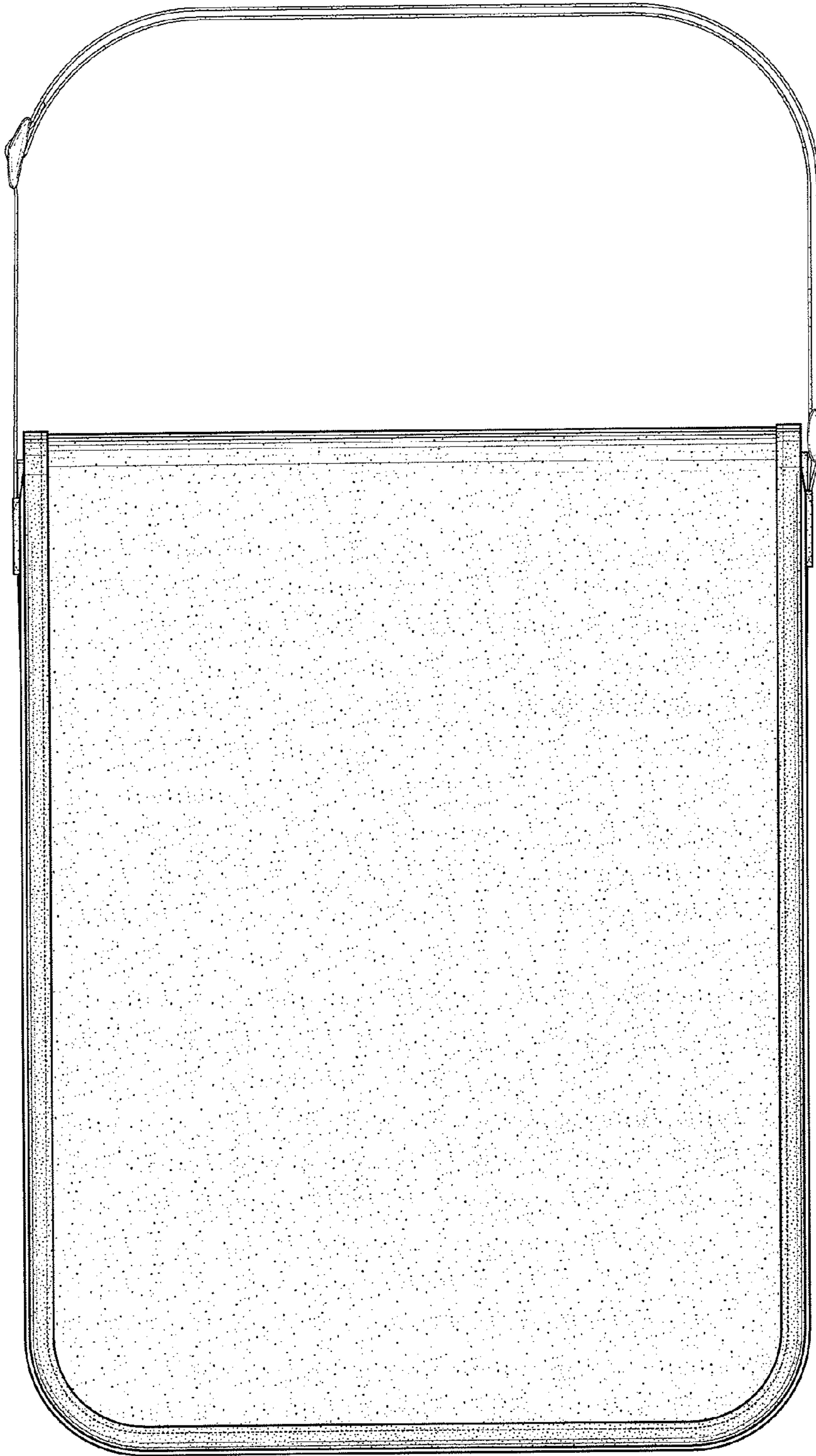

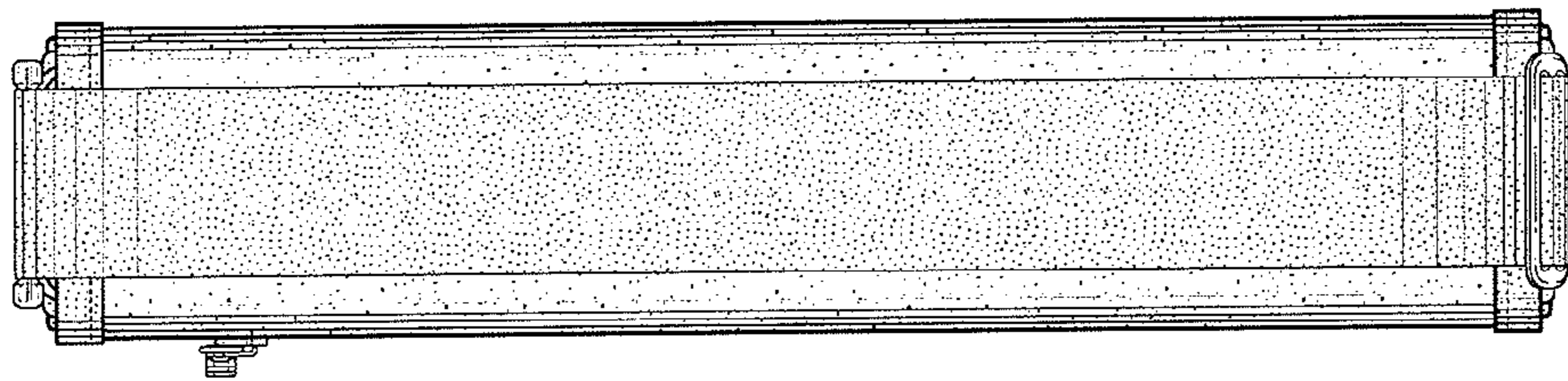

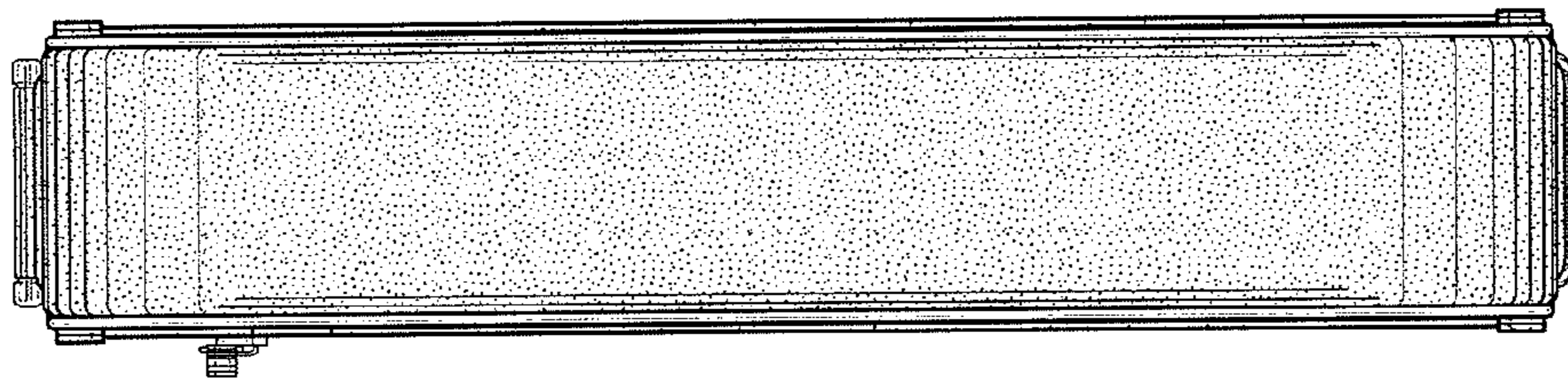

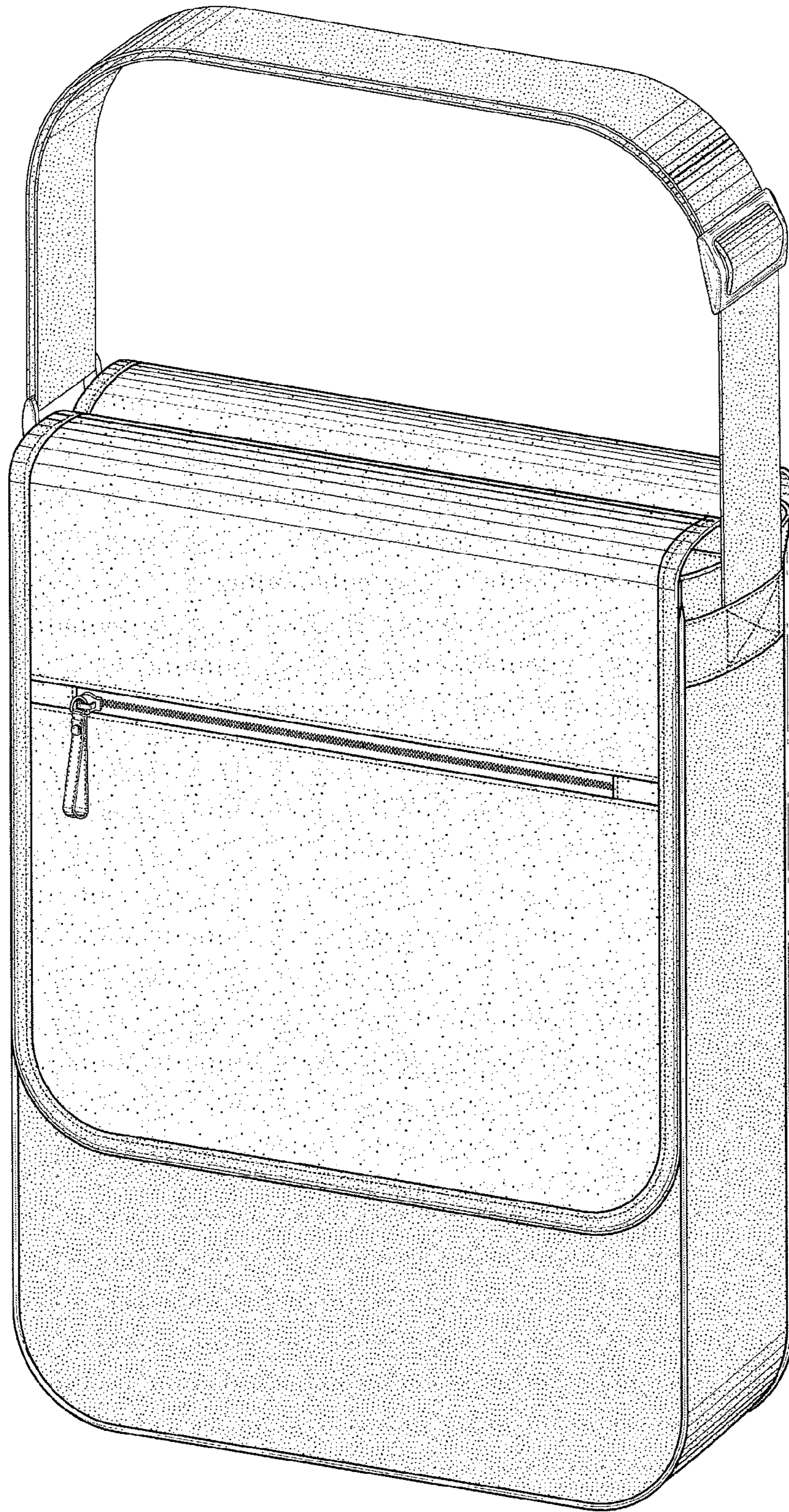

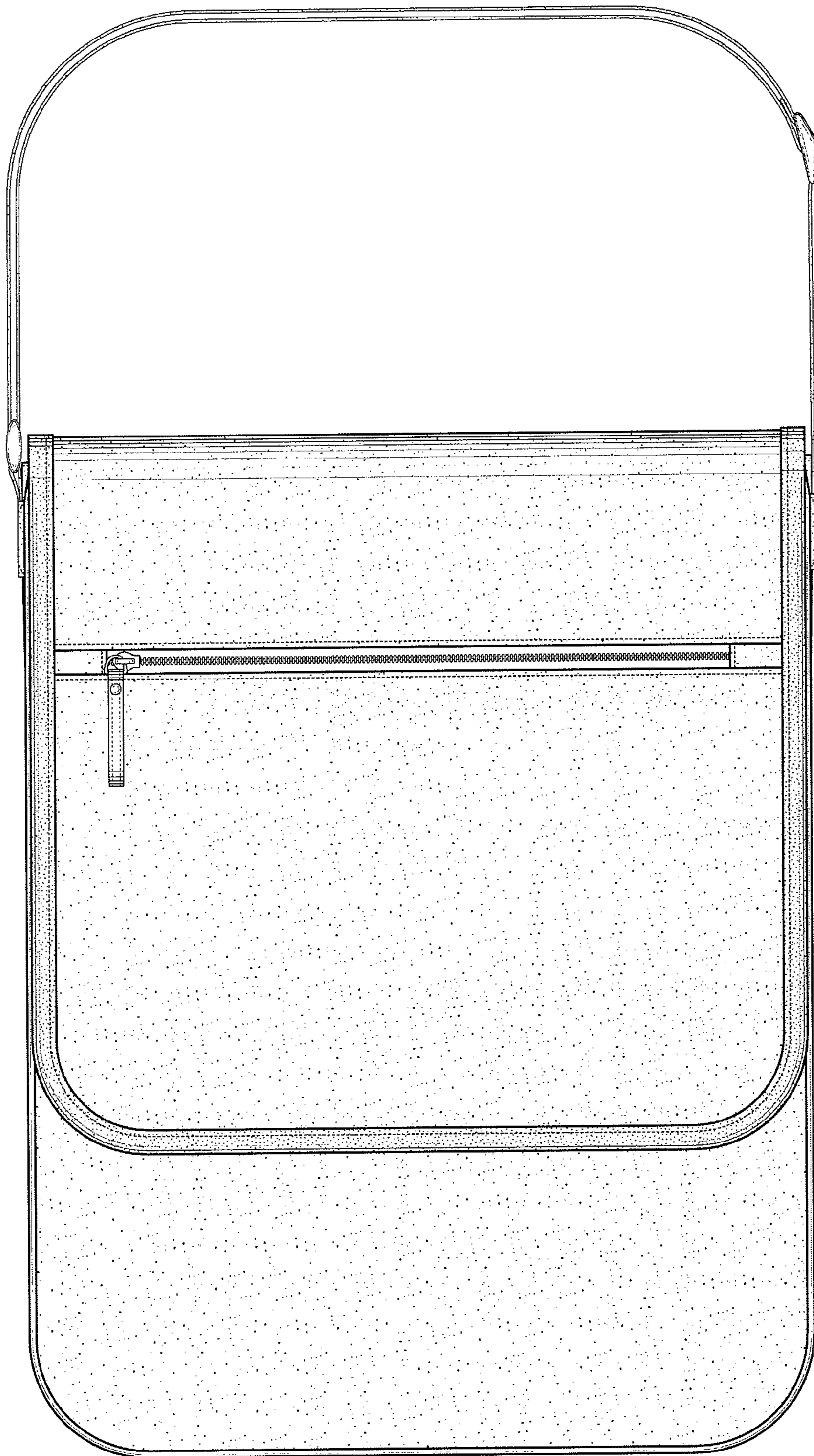

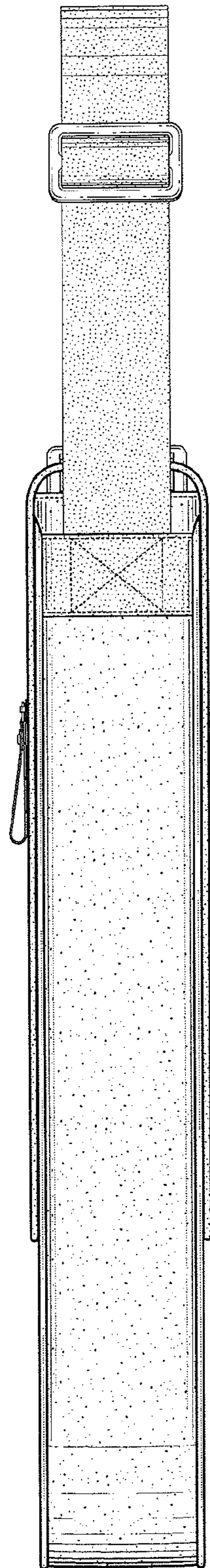

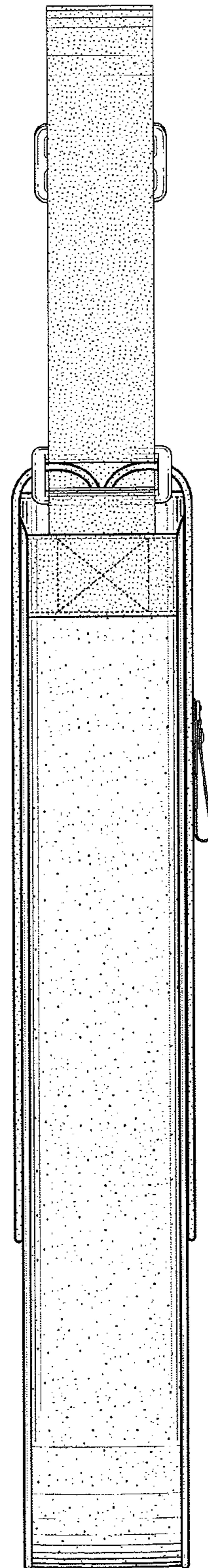

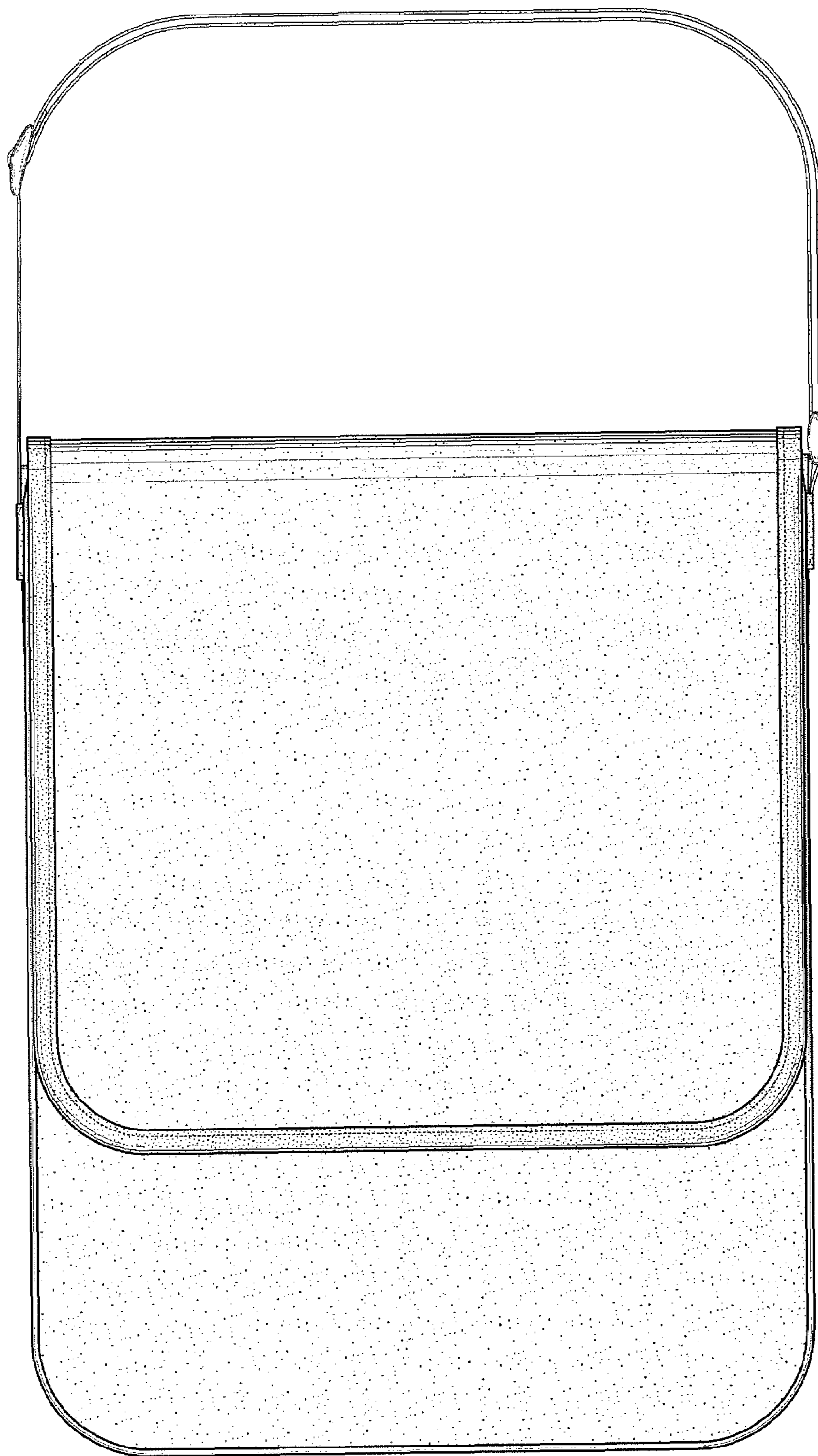

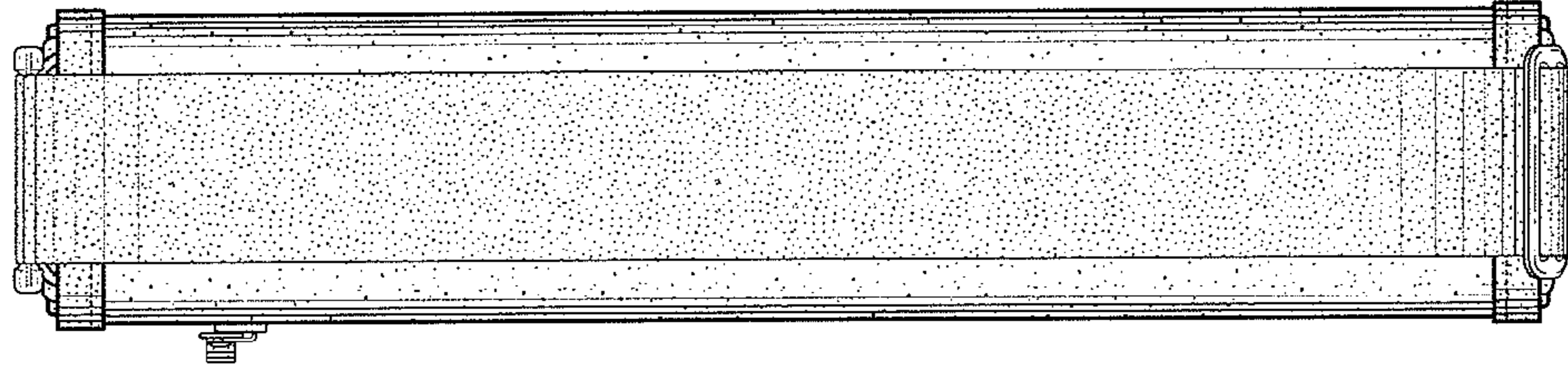

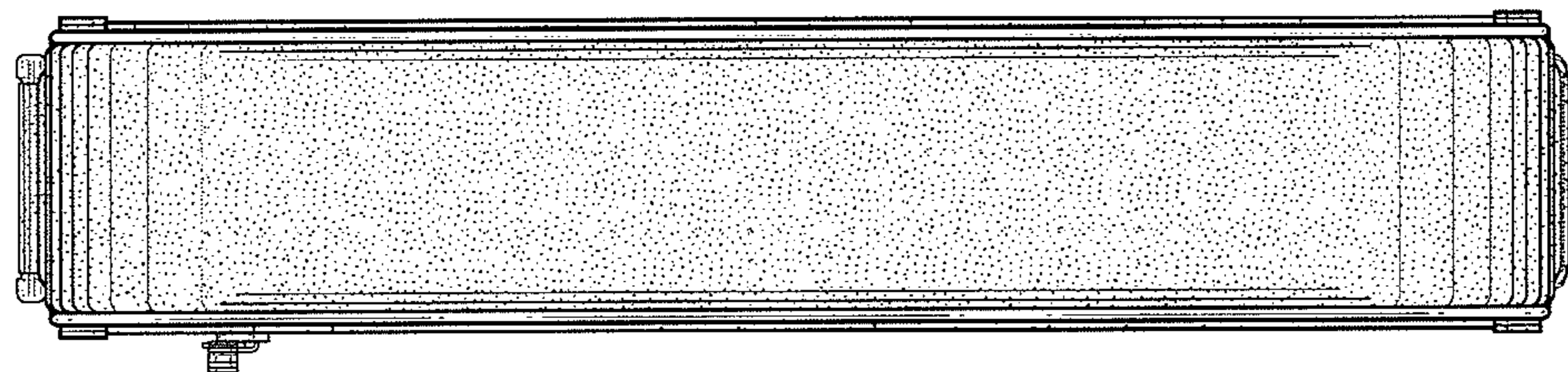
