I claim the ornamental design for a tool organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tool organizer showing my new design;

FIG. 2 is a back perspective view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

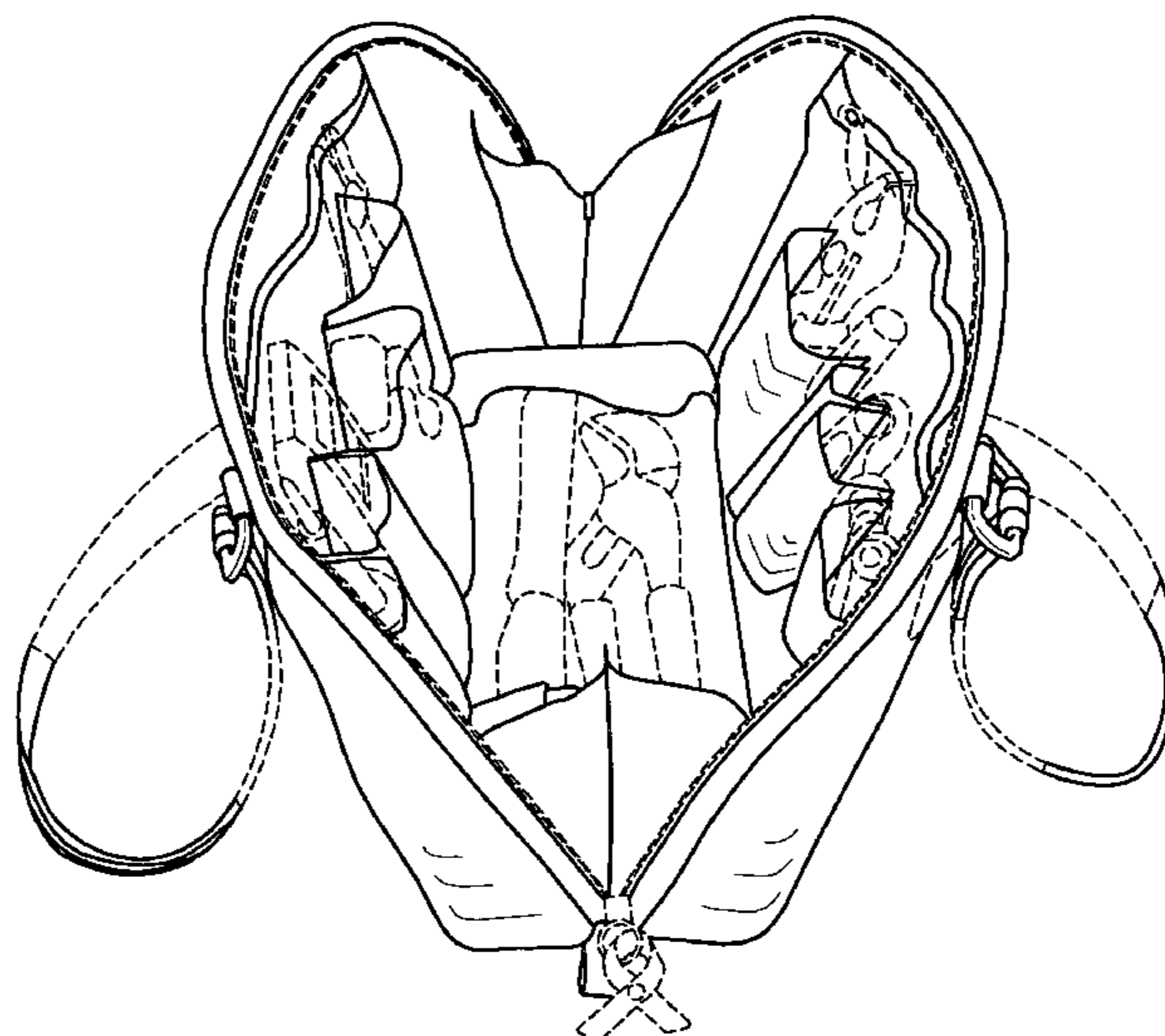
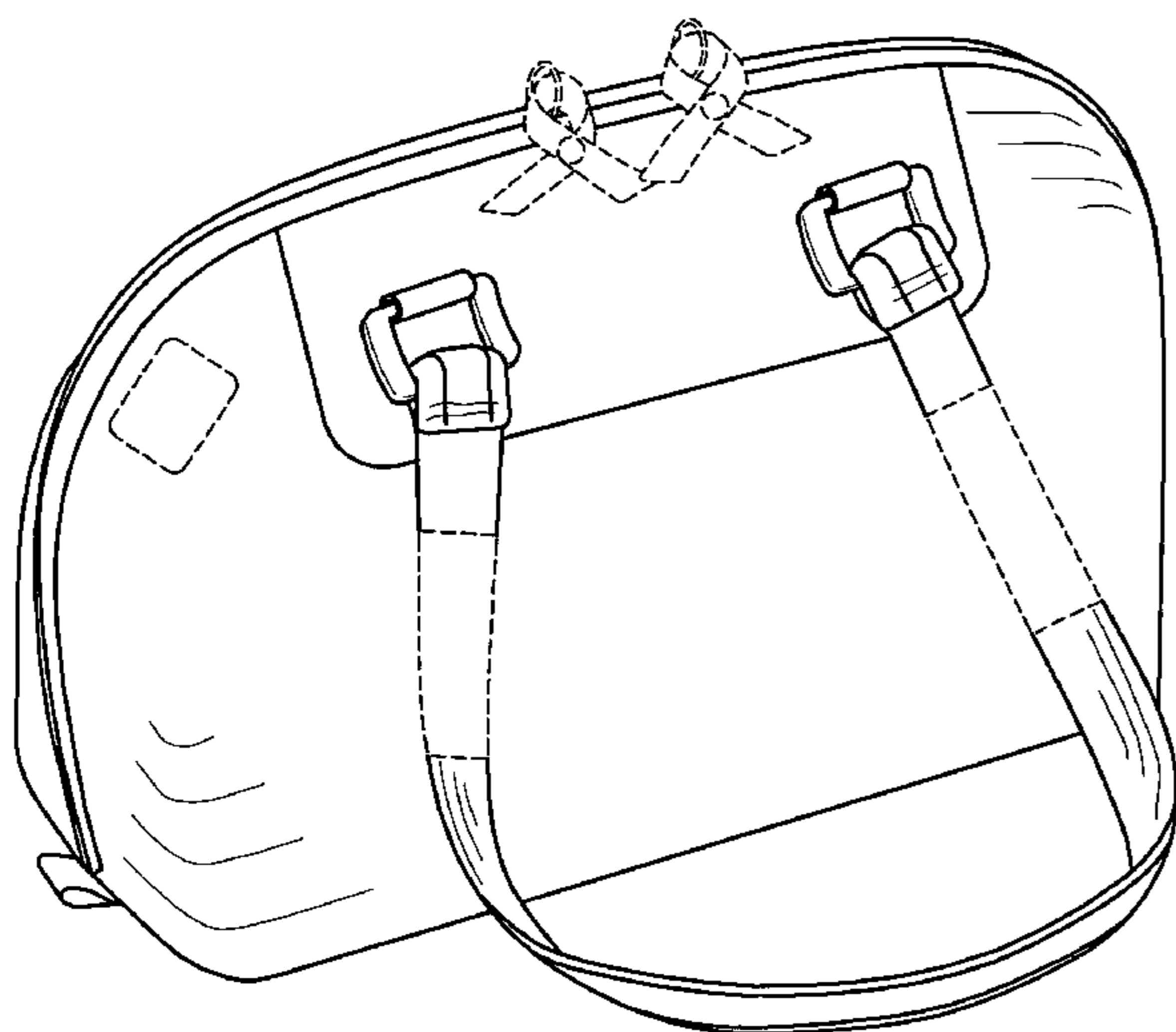
FIG. 5 is a top perspective view thereof, with the tool organizer open and with a zipper shown in broken lines;

FIG. 6 is a second top perspective view thereof, with the tool organizer open and with exemplary tools contained therein and the zipper shown in broken lines; and,

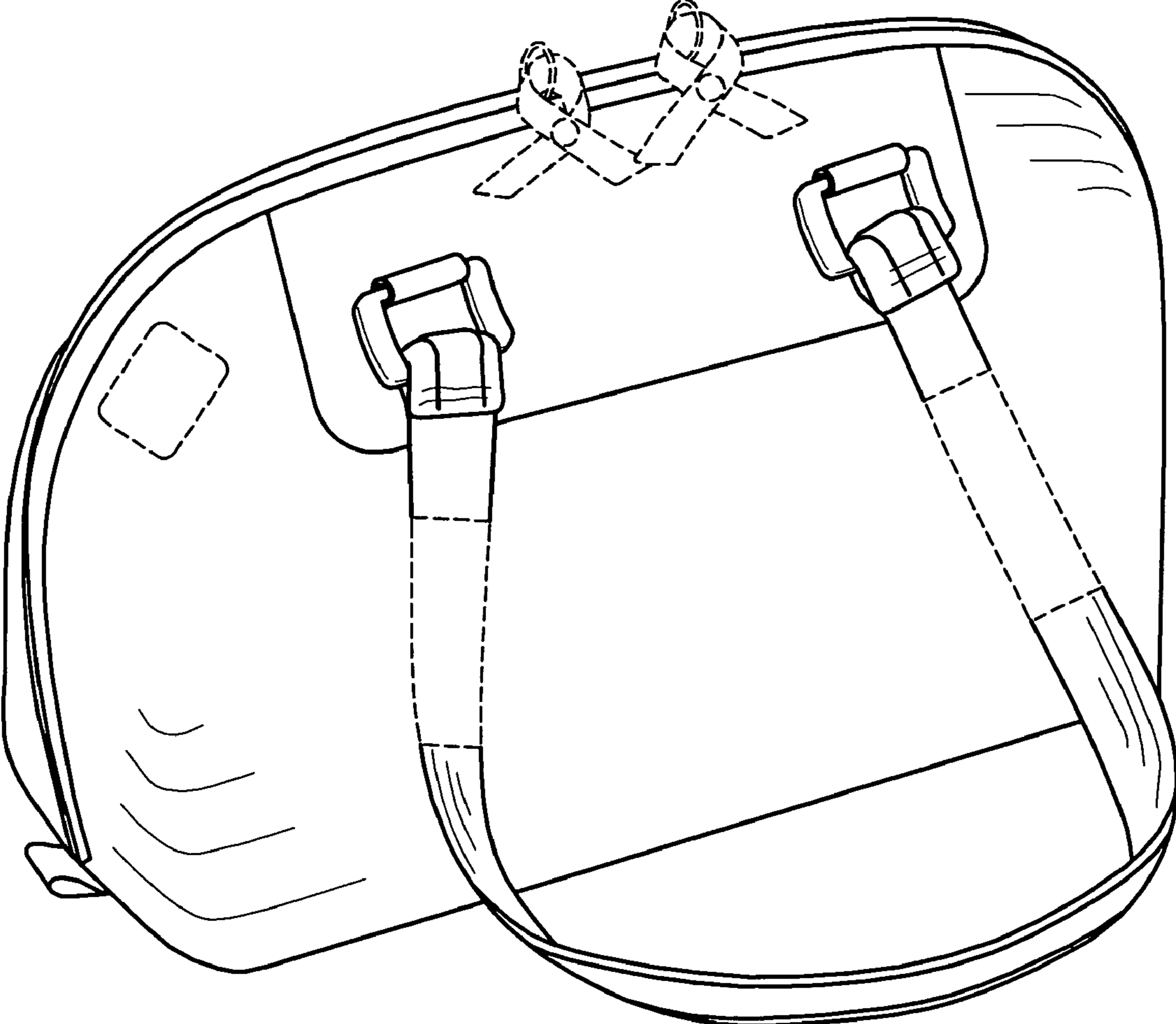

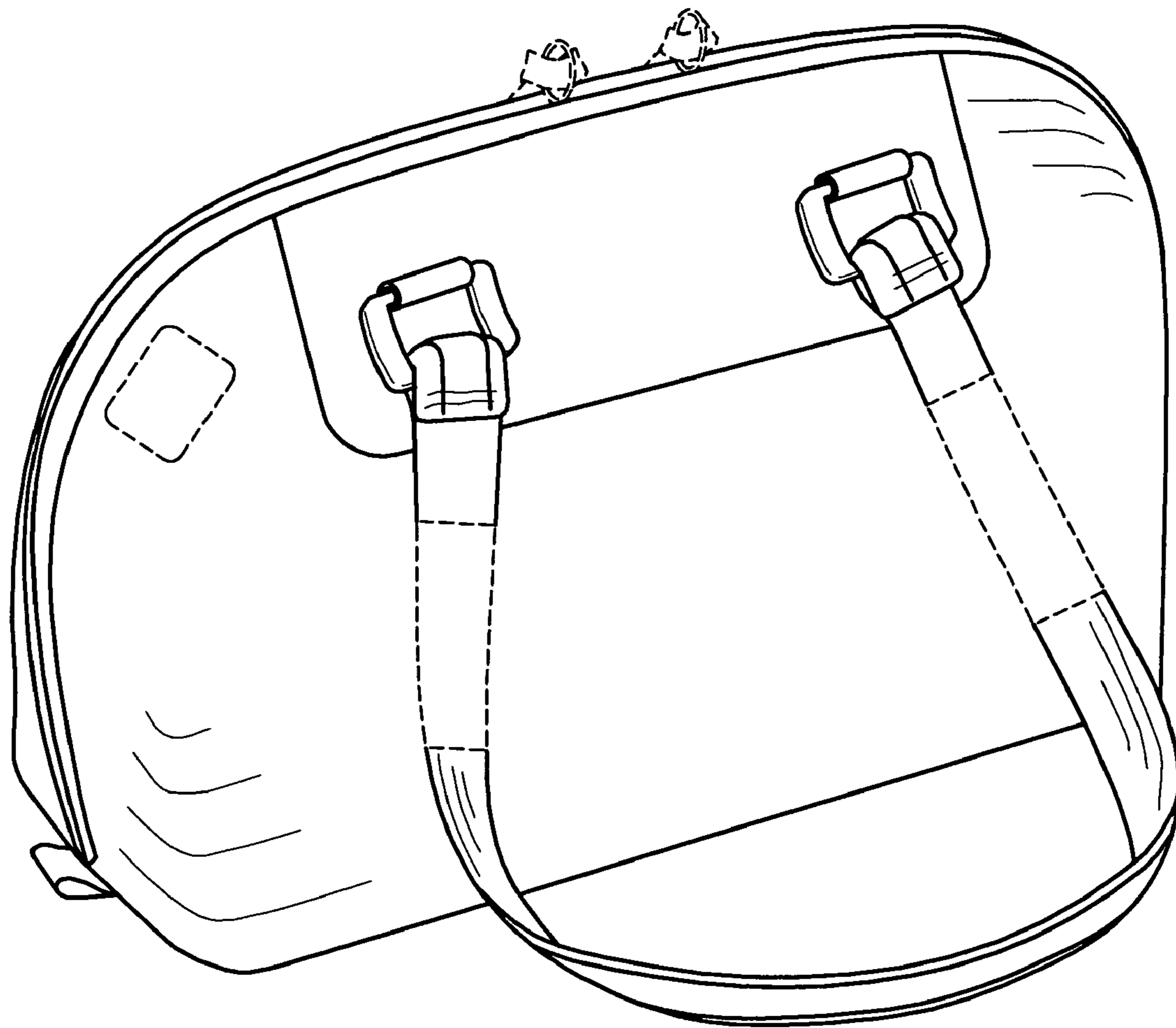

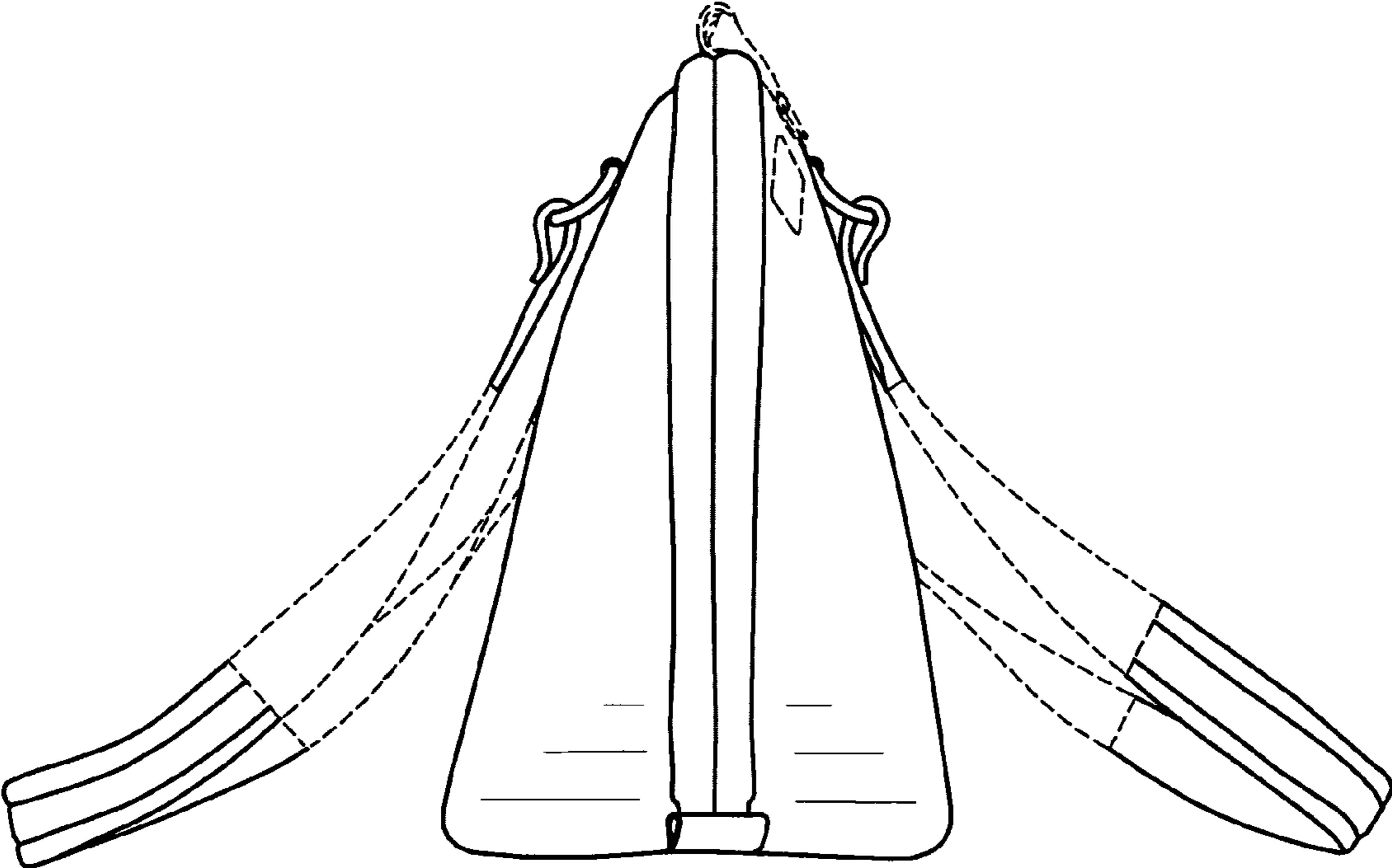

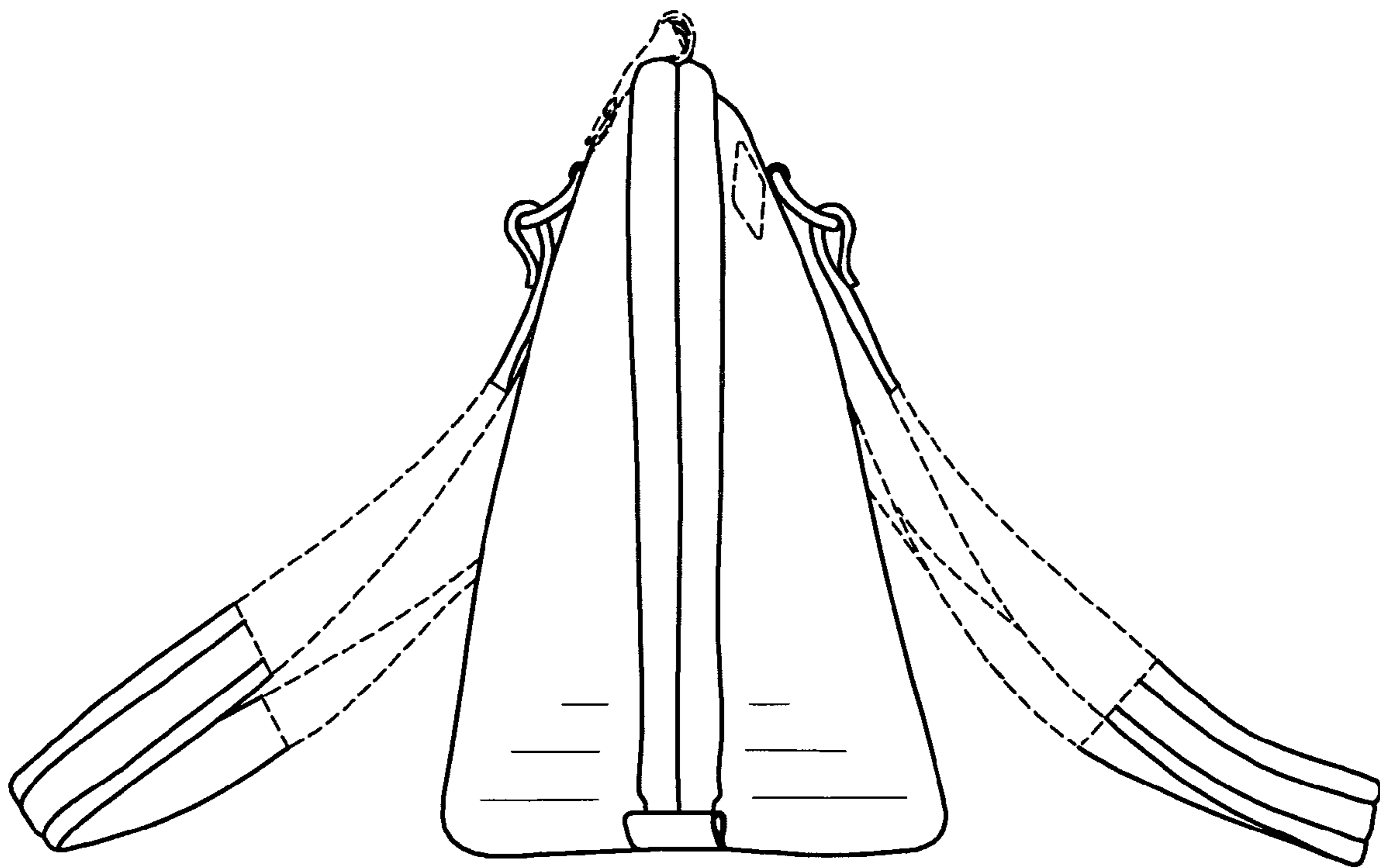

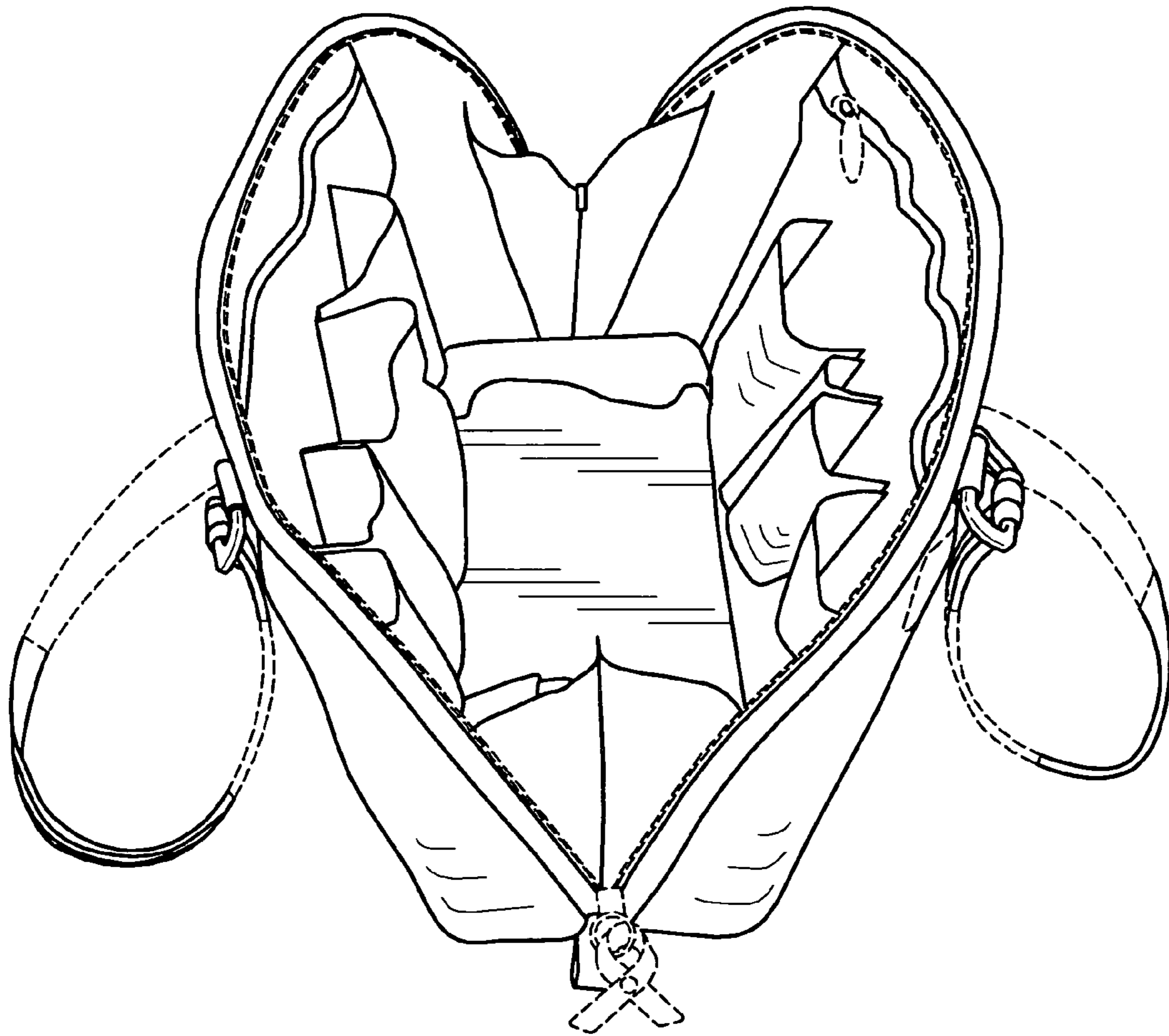

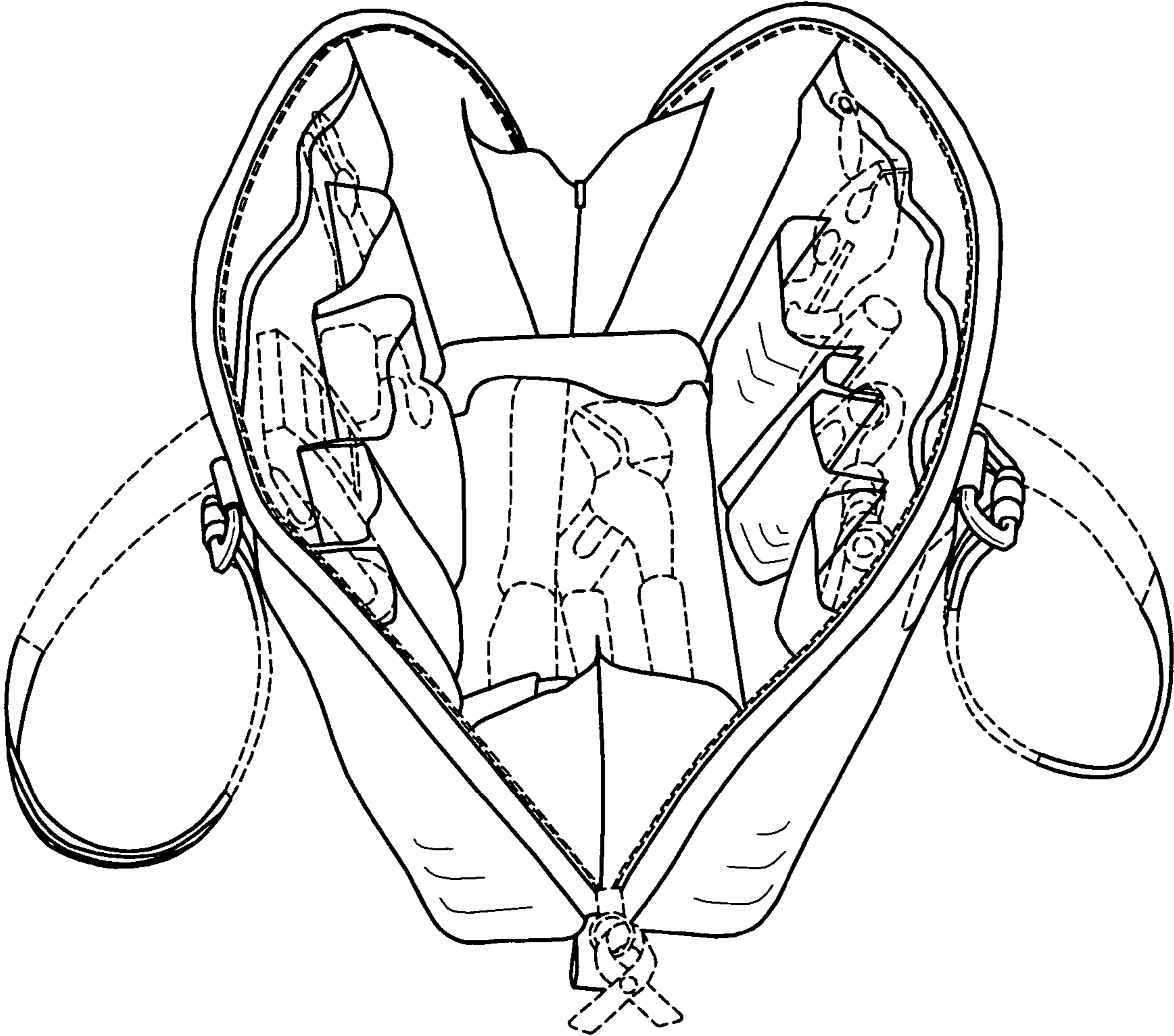

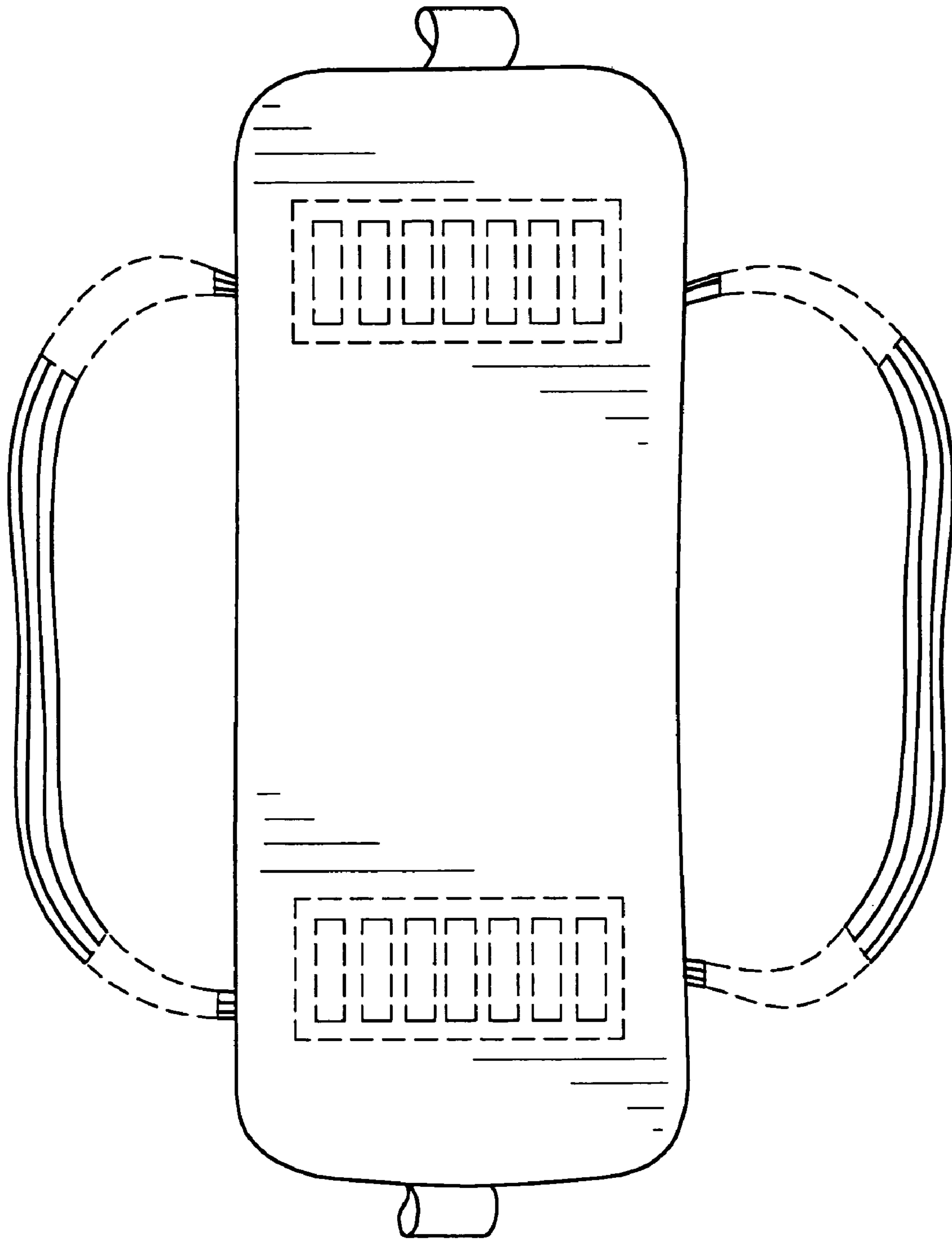
