(57) **CLAIM**

The ornamental design for a continuous folded sheet with diamond and boxweave pattern, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a continuous folded sheet with diamond and boxweave pattern showing the diamond pattern side of my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a back view thereof showing the boxweave pattern side; and,
FIG. 5 is a left side view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a top view thereof, shown in an unfolded state.

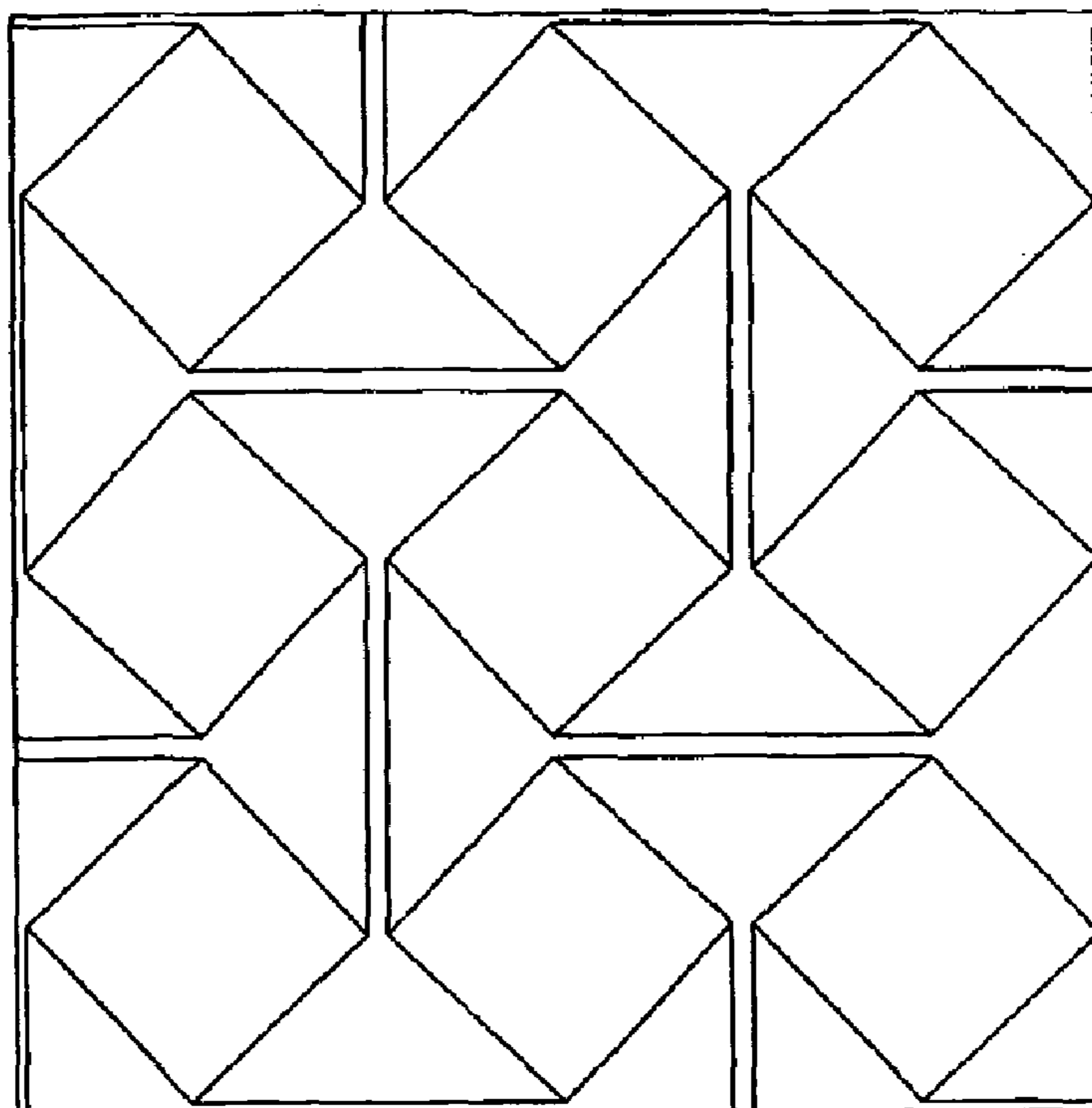

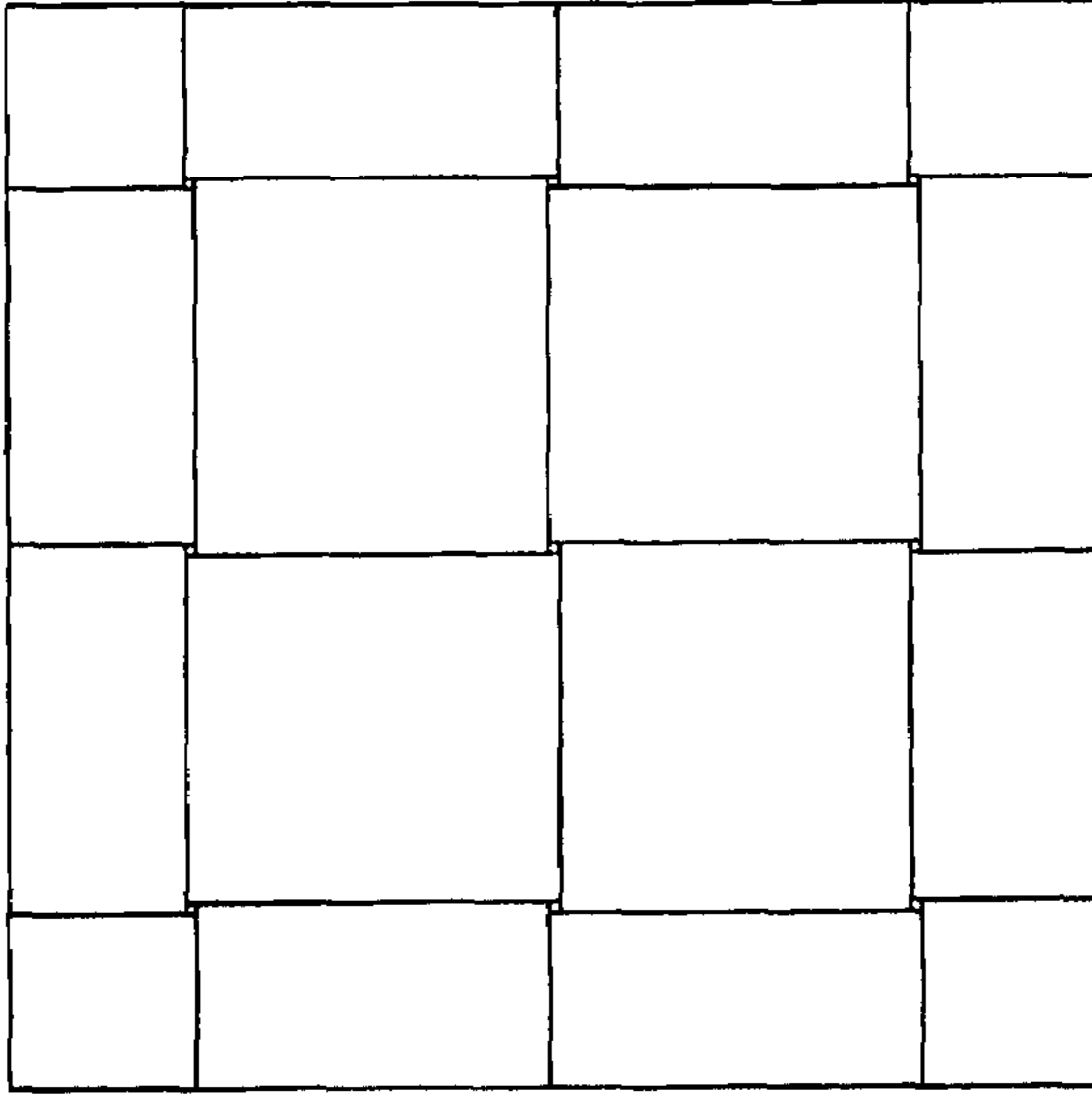

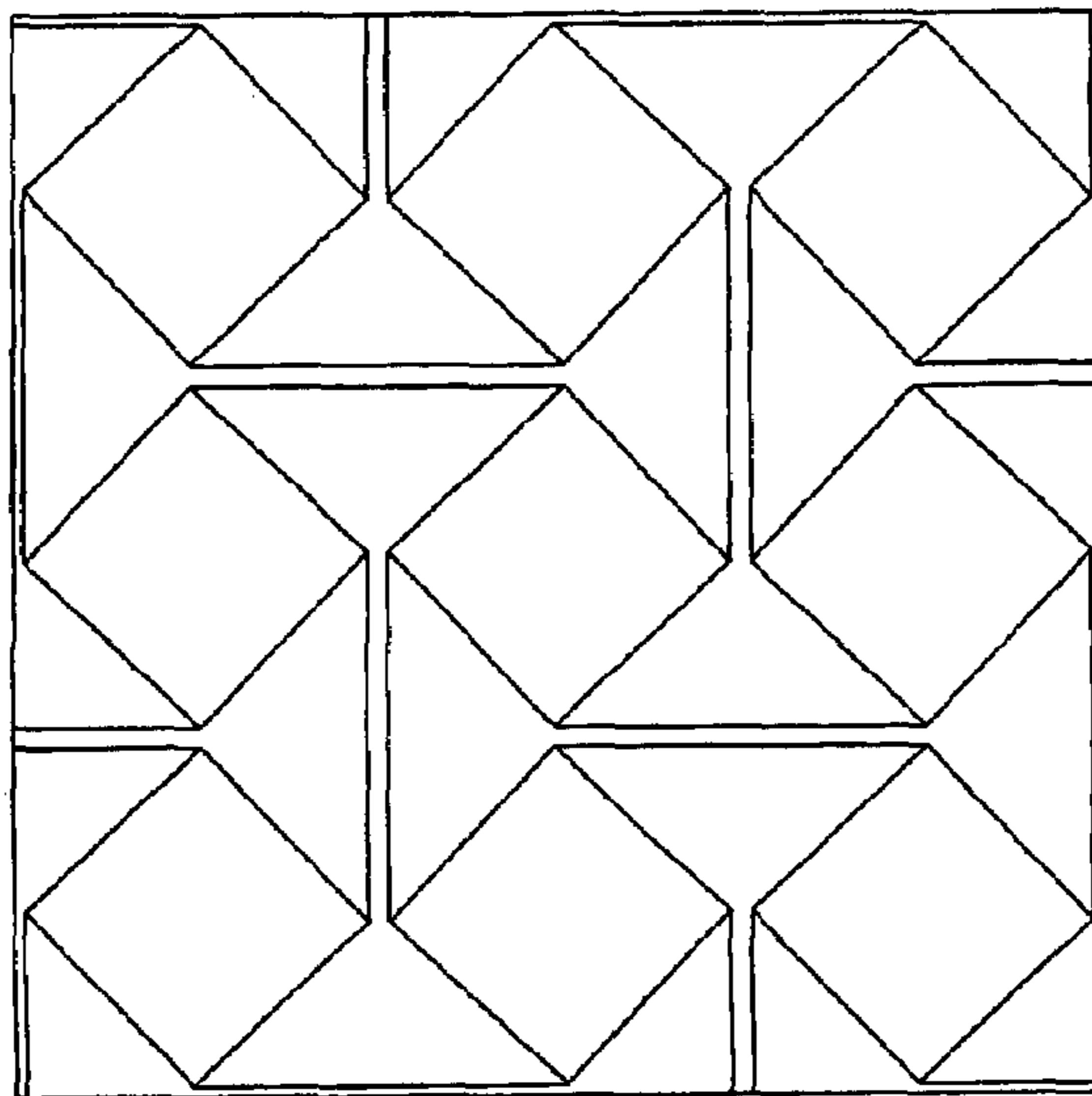

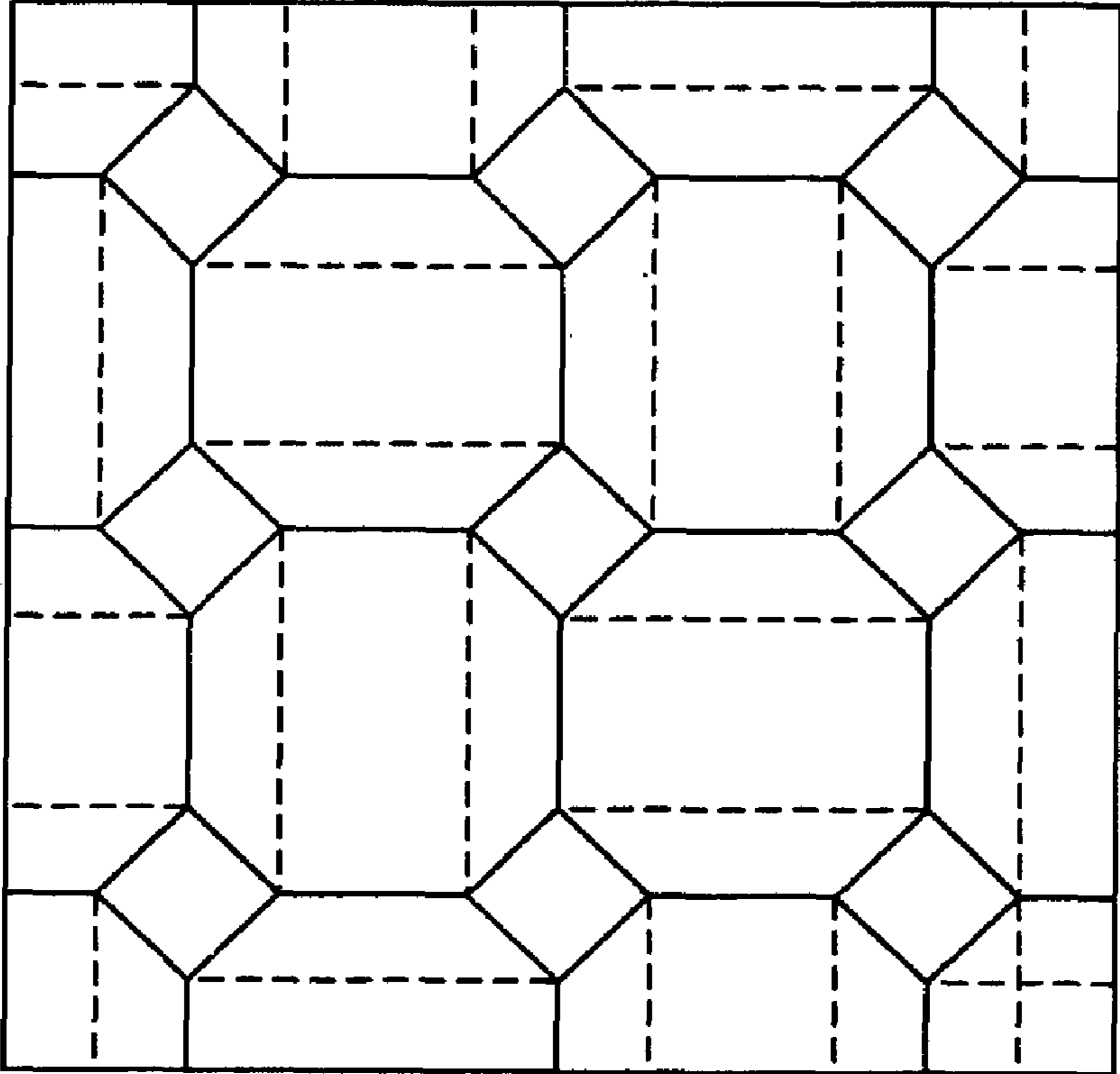
