FIG. 6 is a back elevational view thereof.

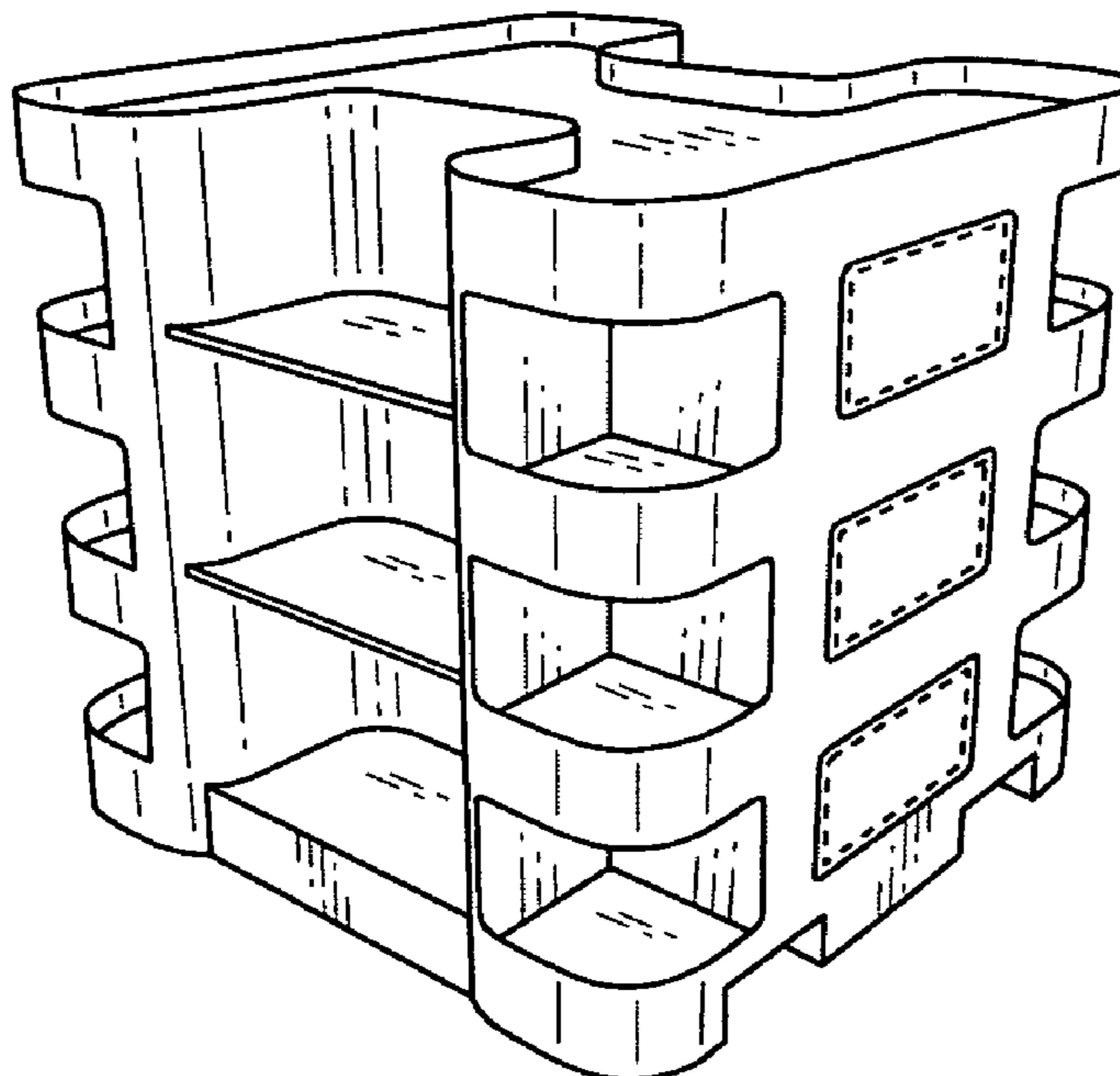

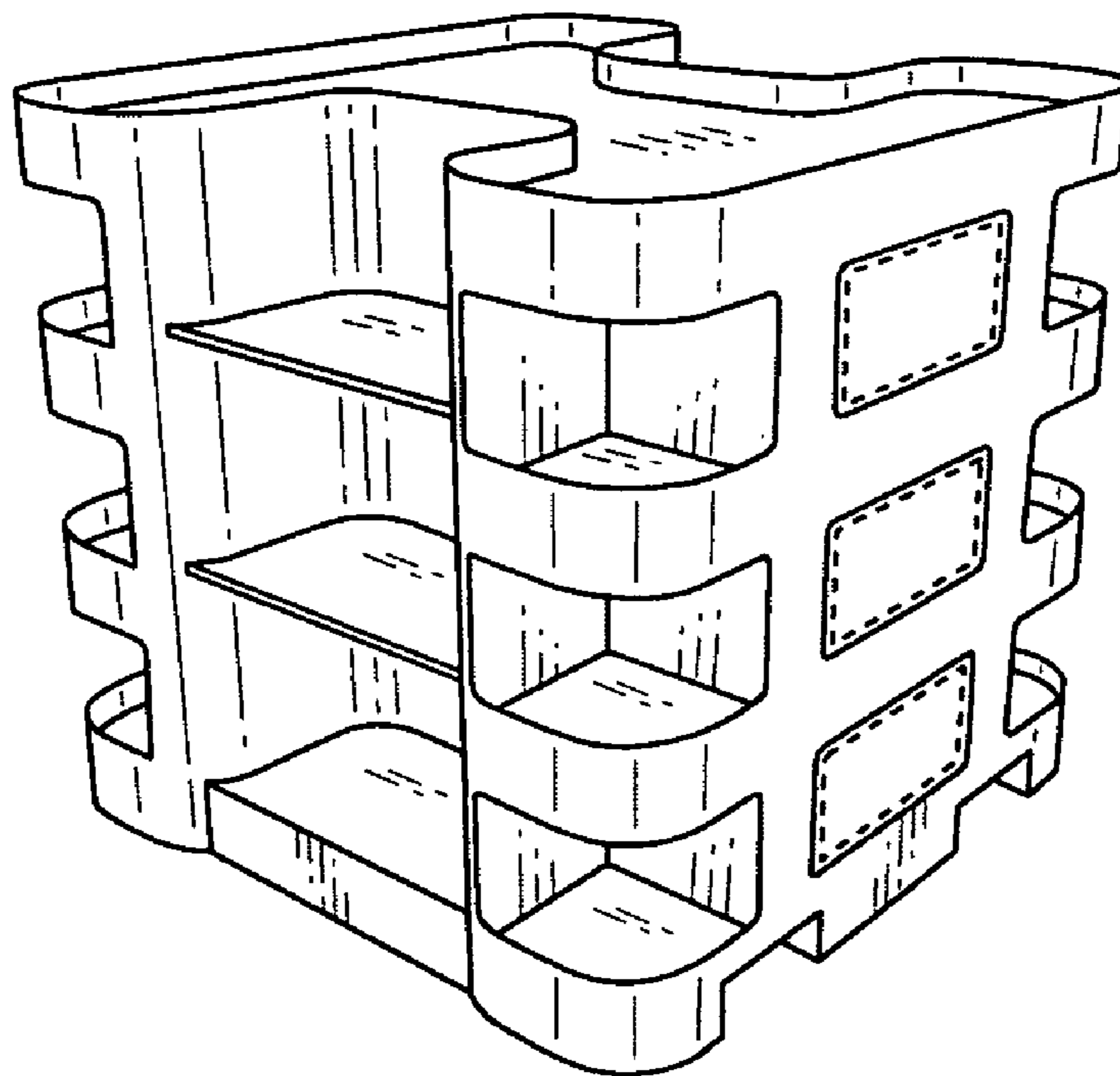

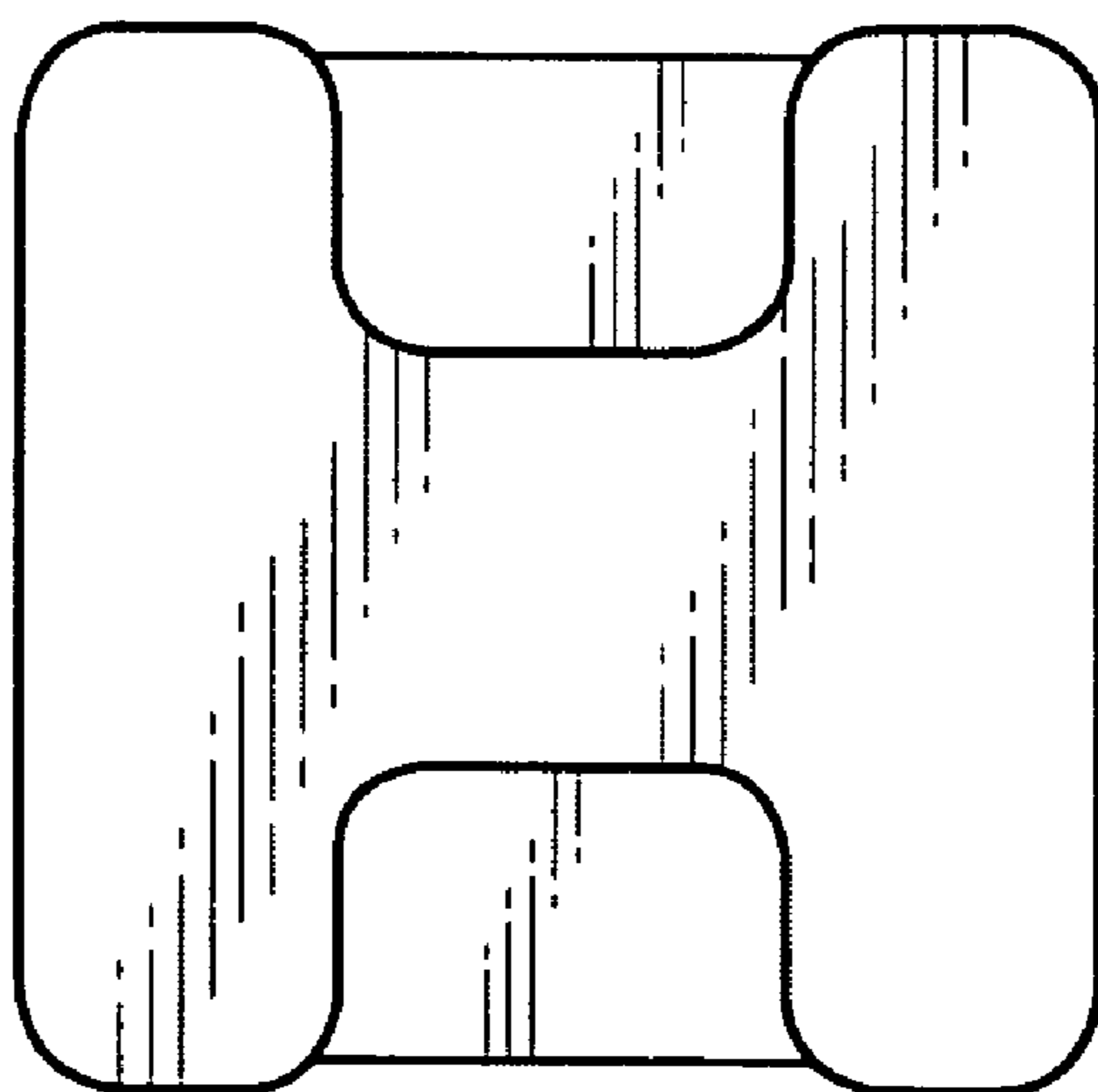

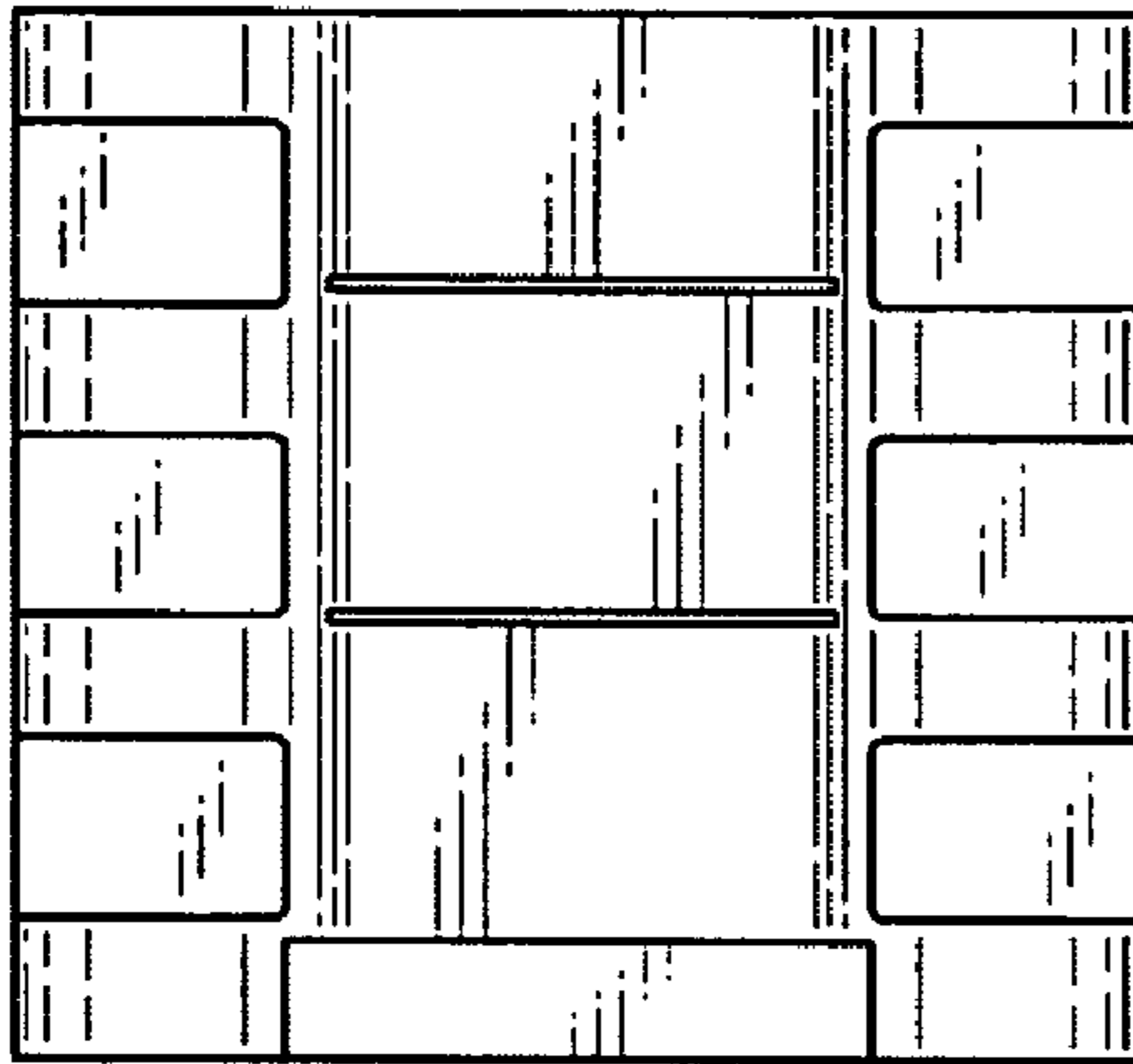




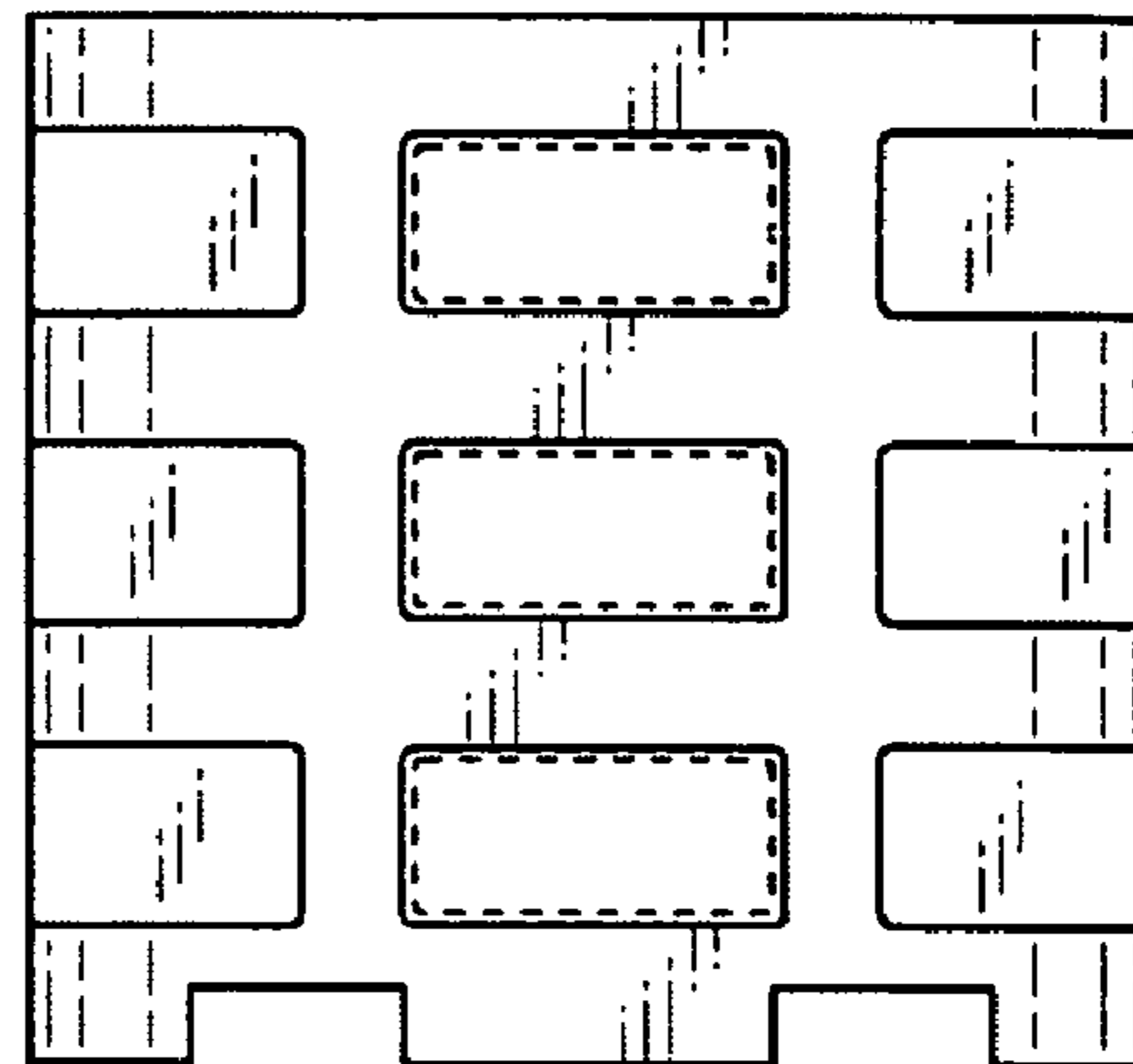

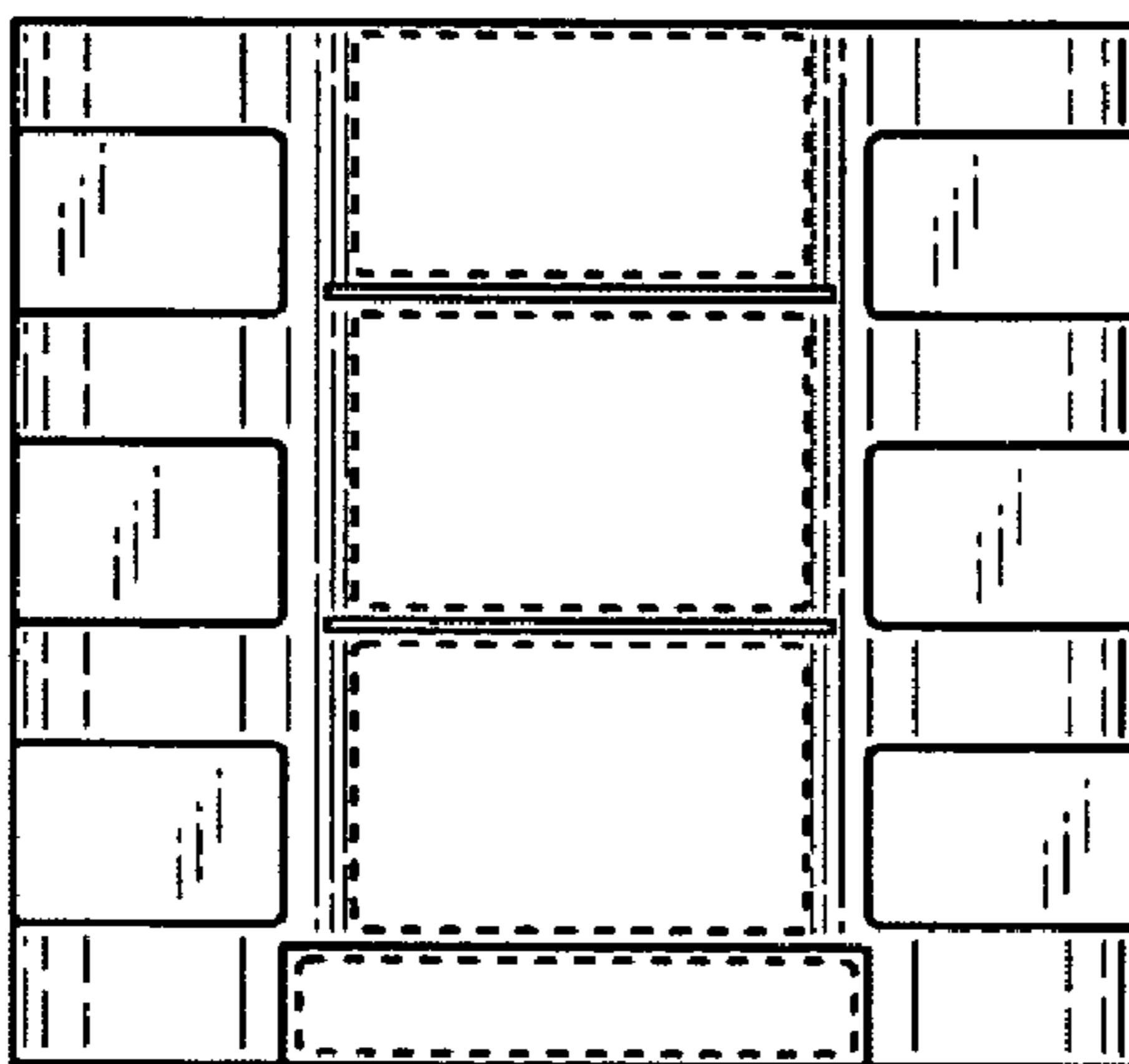

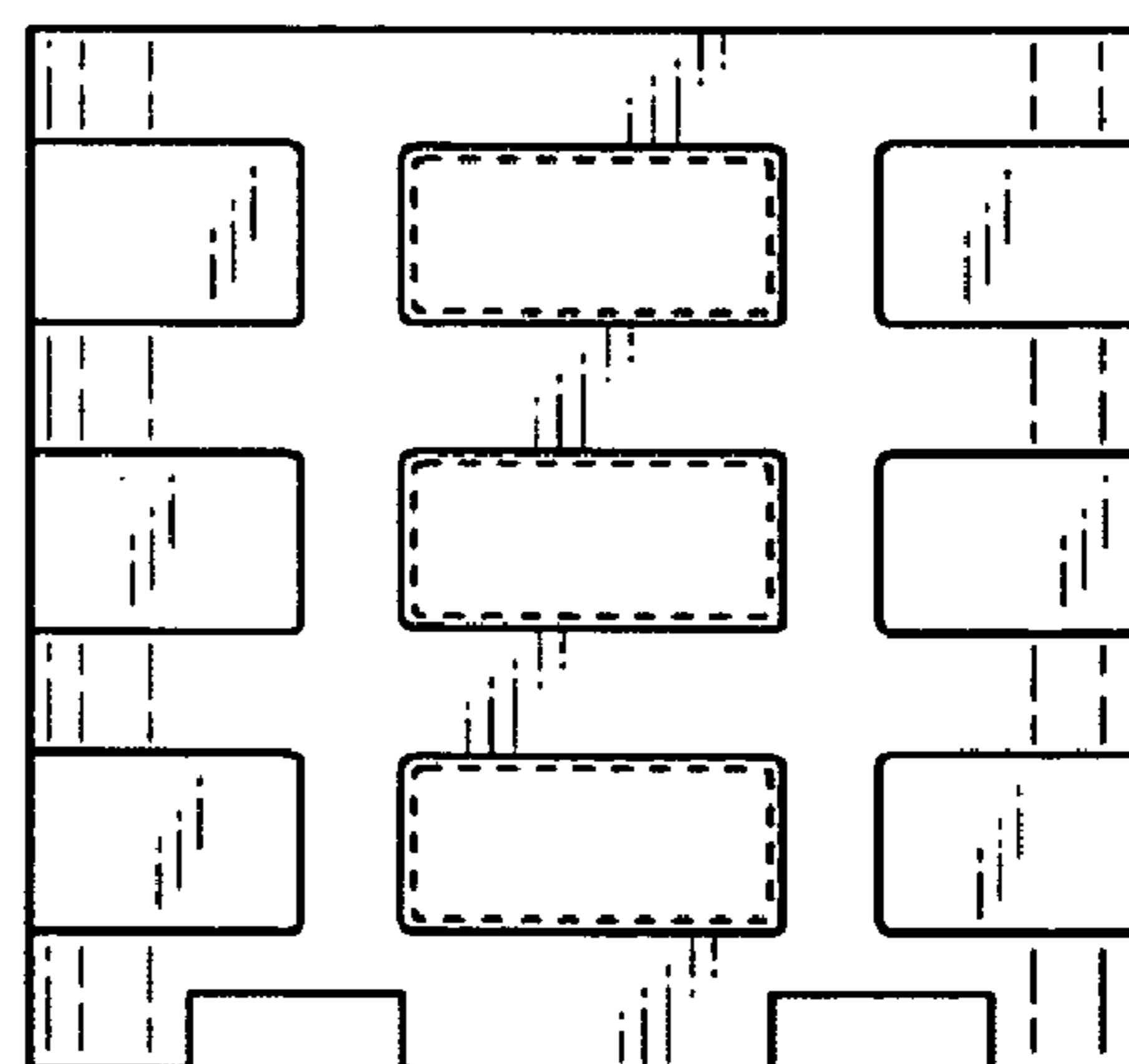
