The ornamental design for a portion of a countertop, as shown and described.

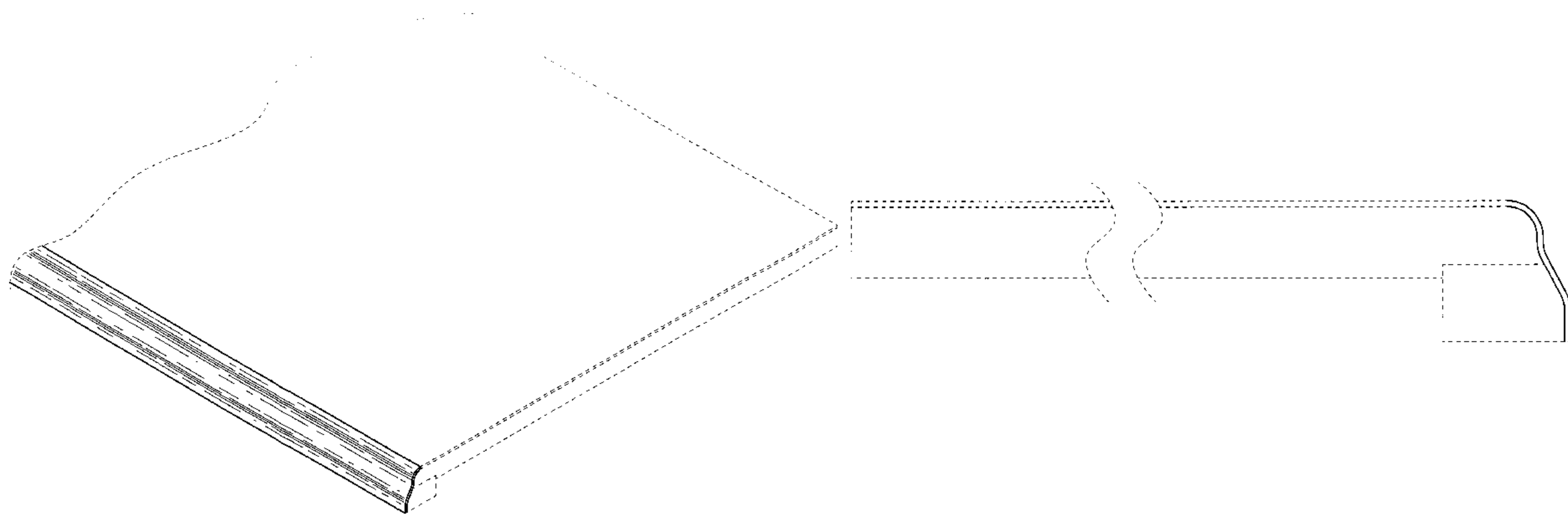
DESCRIPTION

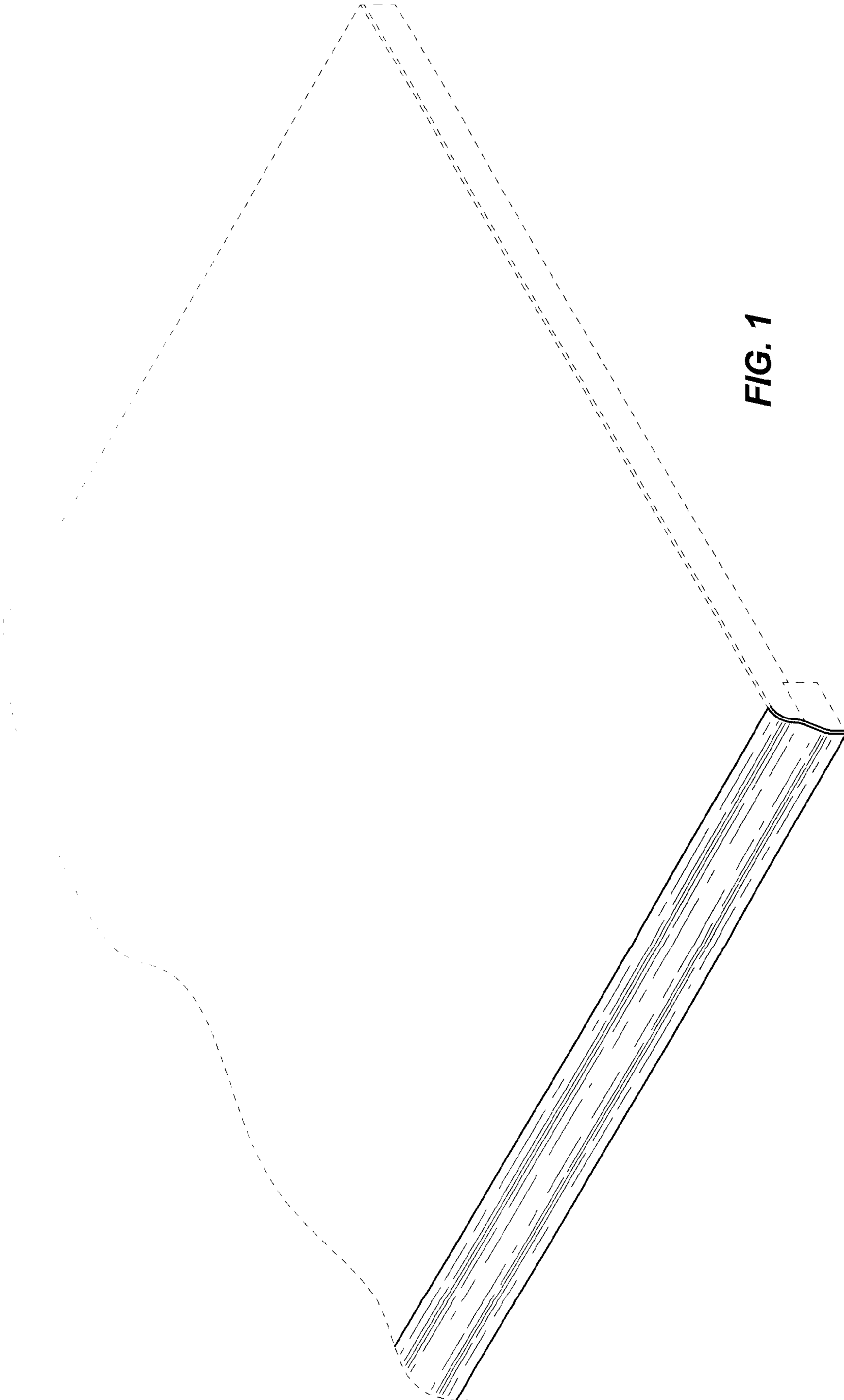

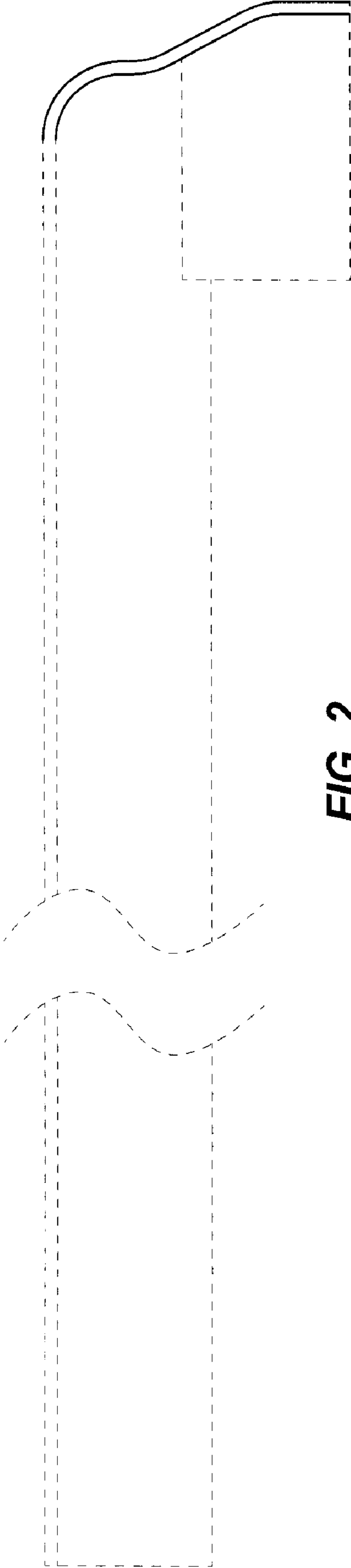
