(57) **CLAIM**

The ornamental design for a spray pump mechanism with pass through for spray bottles, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a spray pump mechanism with pass through for spray bottles;

FIG. 2 is a side view of the spray mechanism for a spray bottle;

FIG. 3 is a top view of the spray mechanism for a spray bottle;

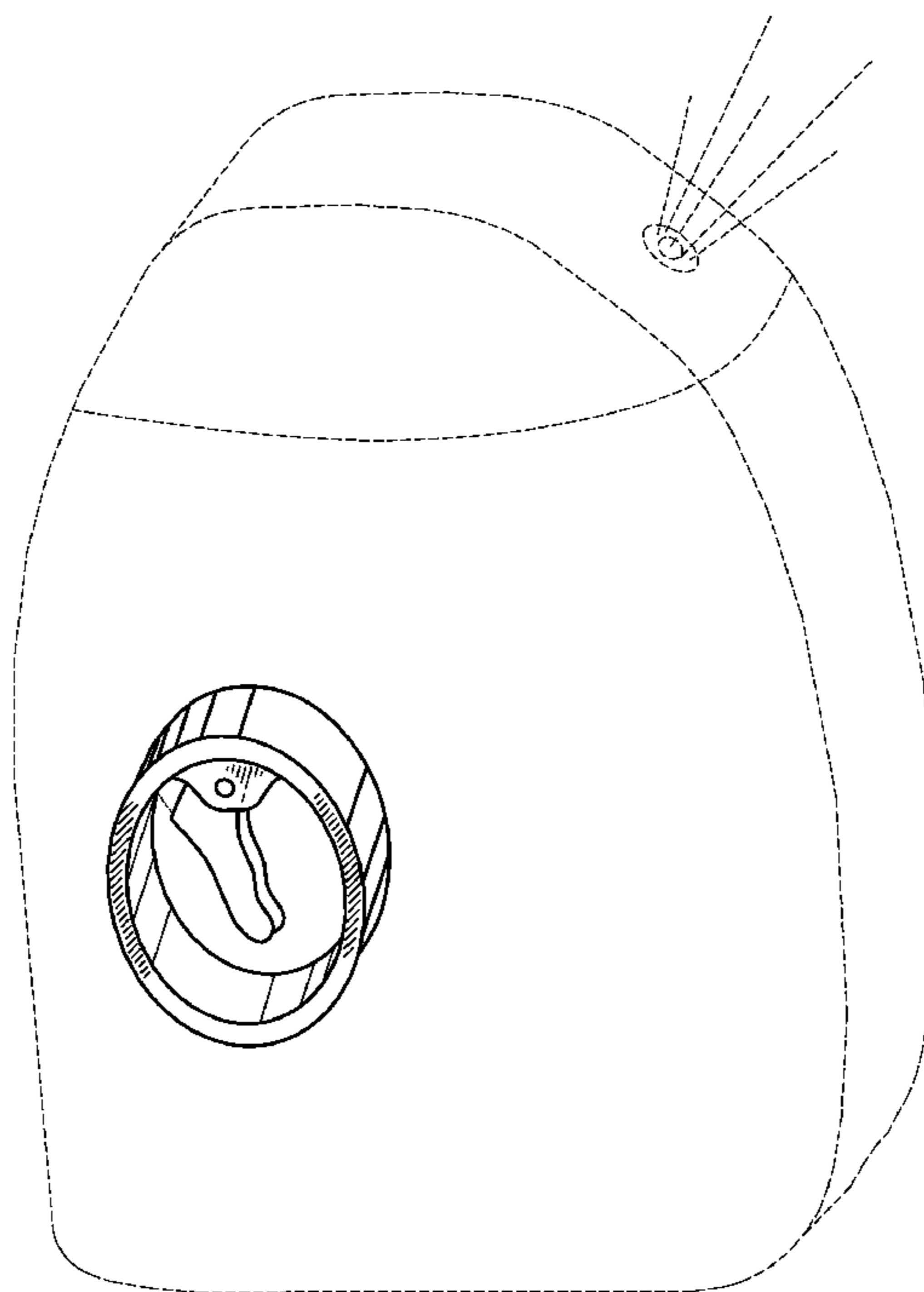
FIG. 4 is a rear view of the spray mechanism for a spray bottle as viewed from a left-hand side to a right-hand side of the spray mechanism shown in FIG. 2;

FIG. 5 is a frontal view of the spray mechanism for a spray bottle as viewed from a right-hand side to a left-hand side of the spray mechanism shown in FIG. 2; and,

FIG. 6 is an upward view of the spray mechanism for a spray bottle as viewed along line 6—6 shown in FIG. 2.

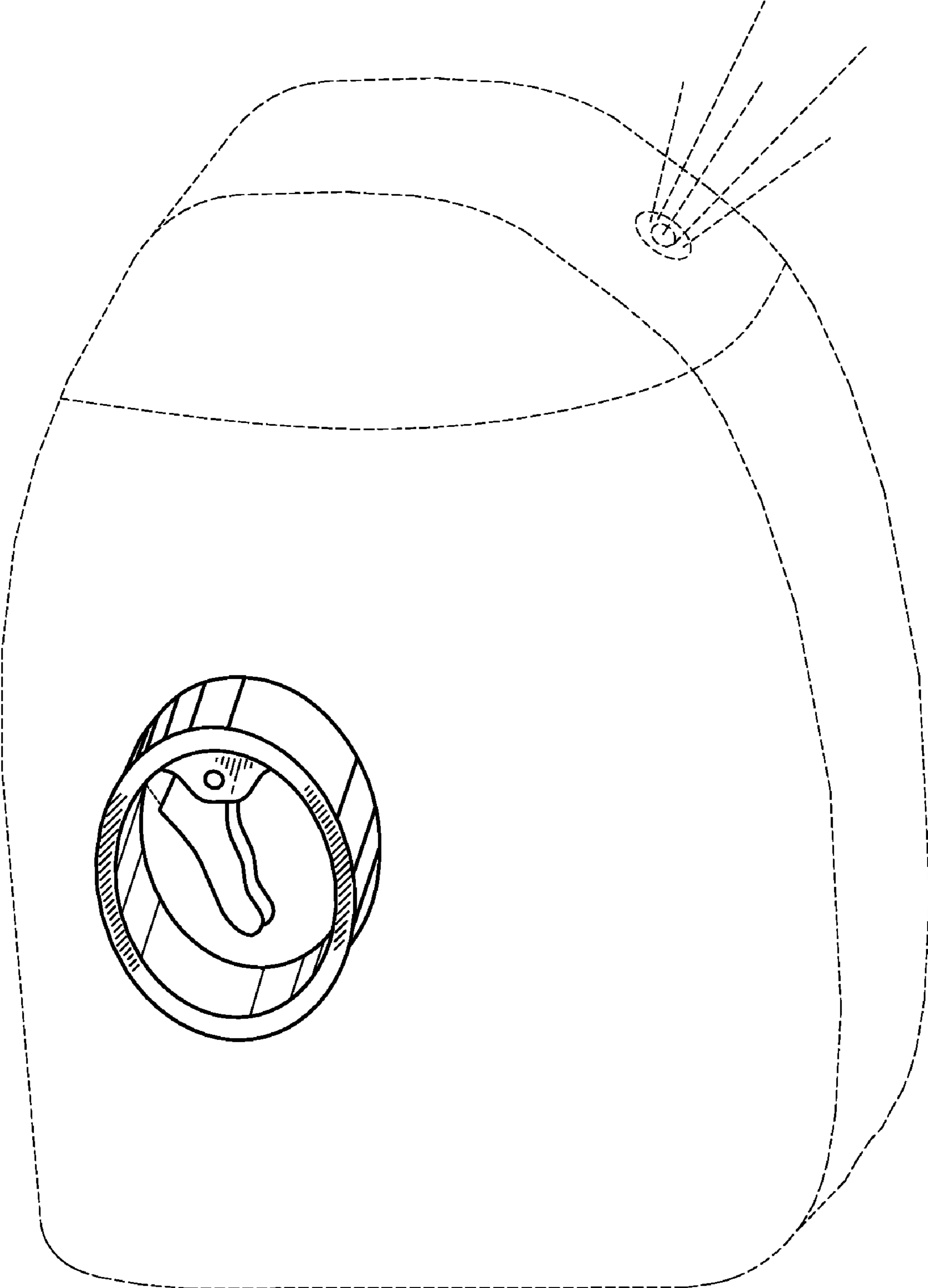

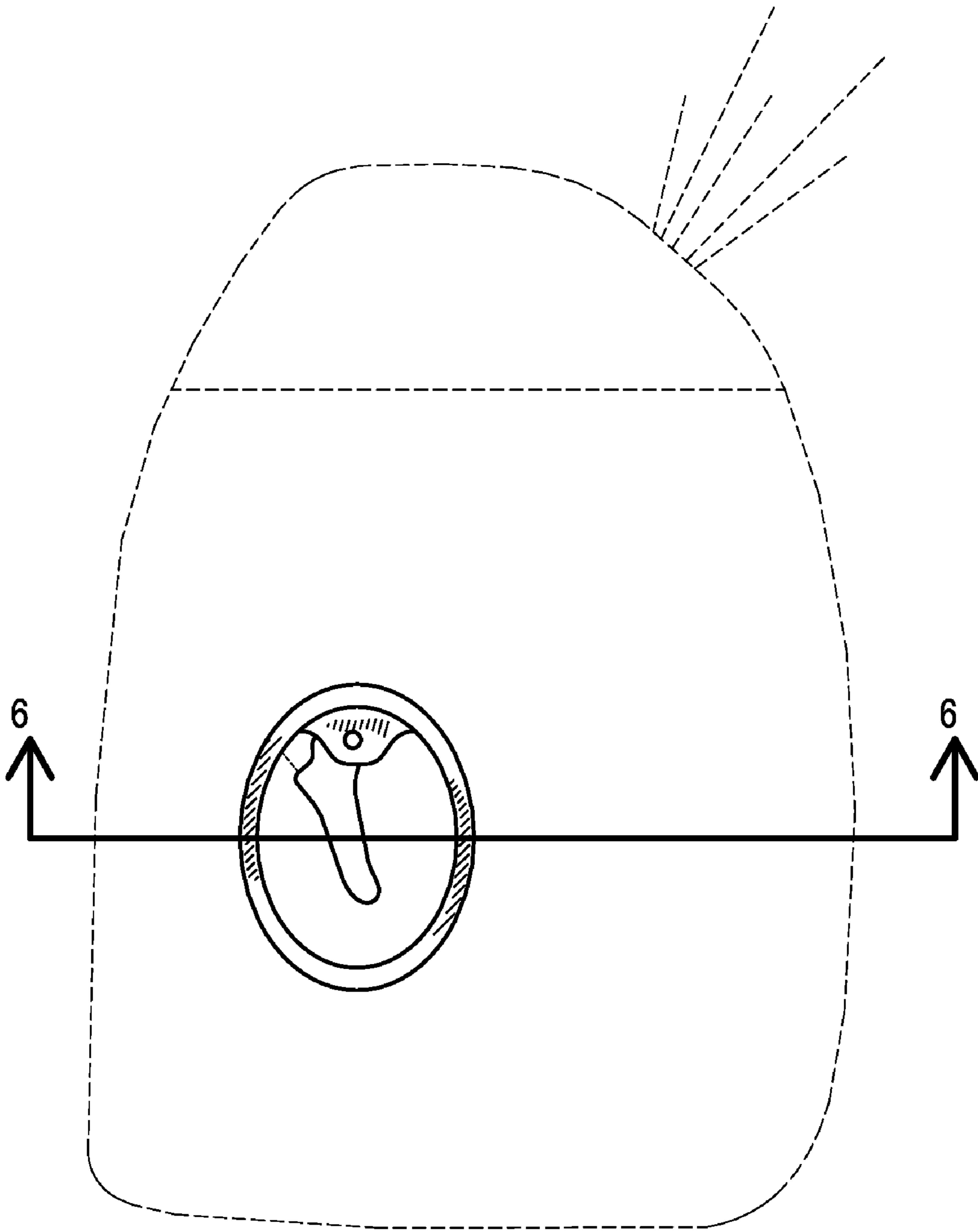

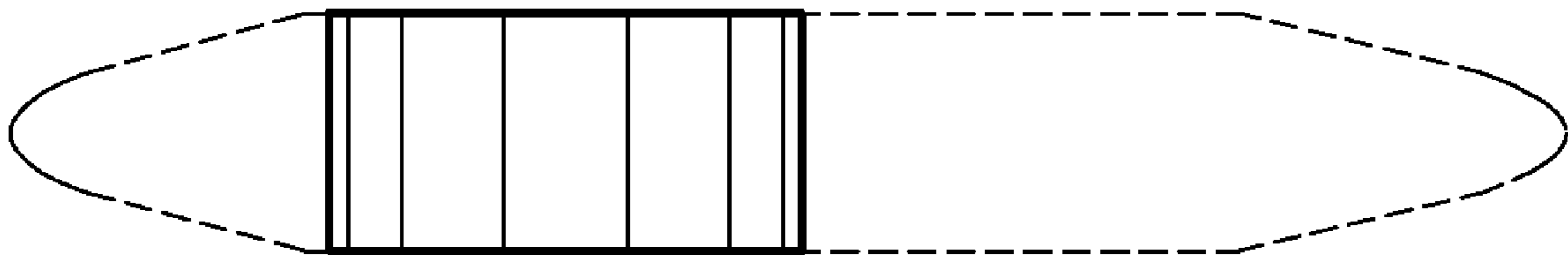

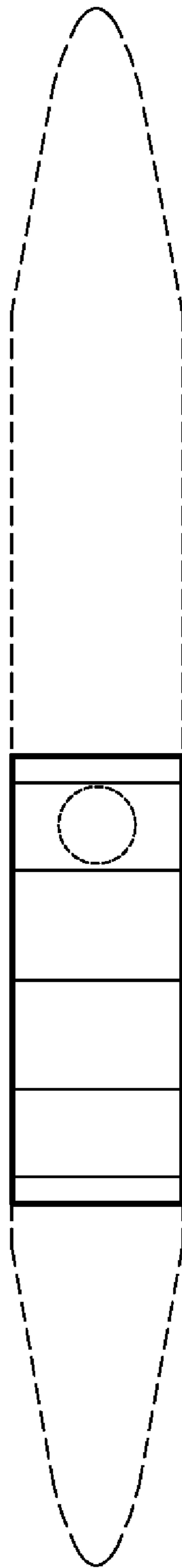

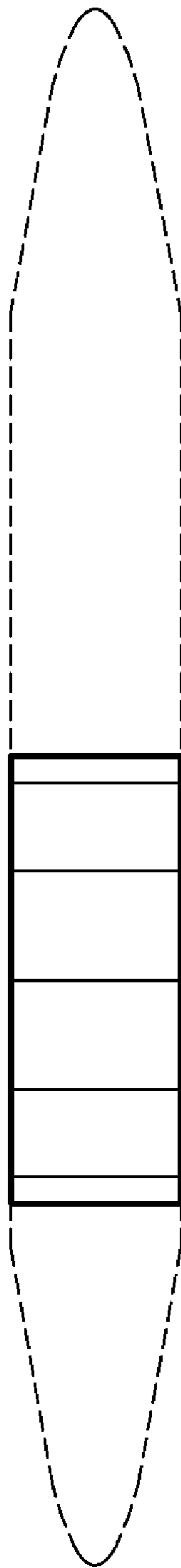

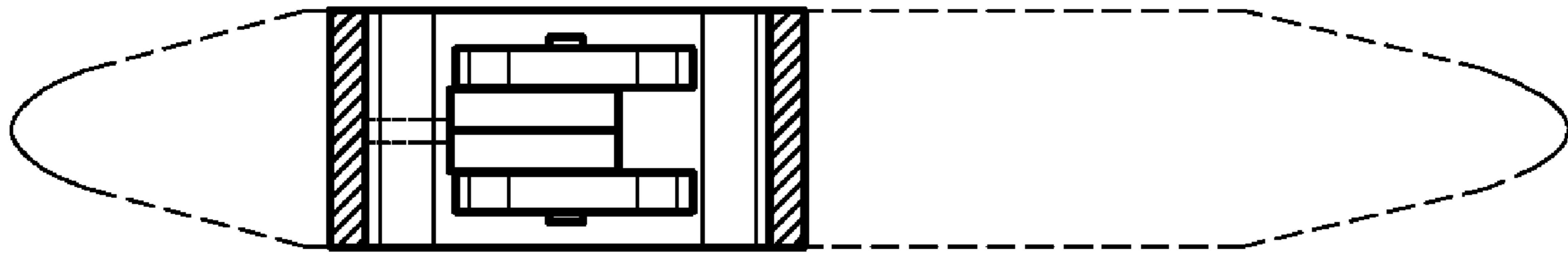
