FIG. 3 is a side view from the right of FIG. 1.

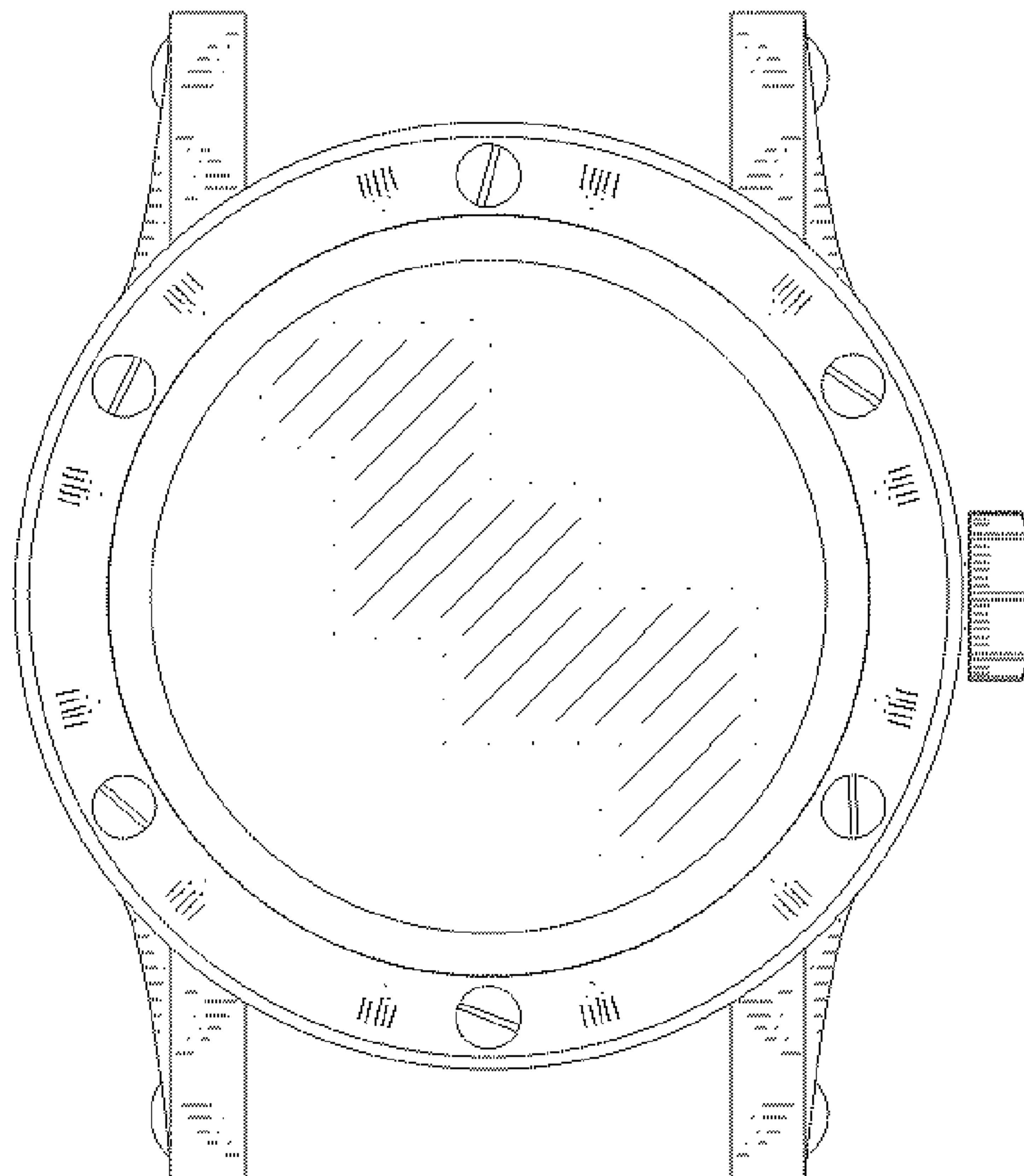
FIG. 4 is a side view from the left of FIG. 1.

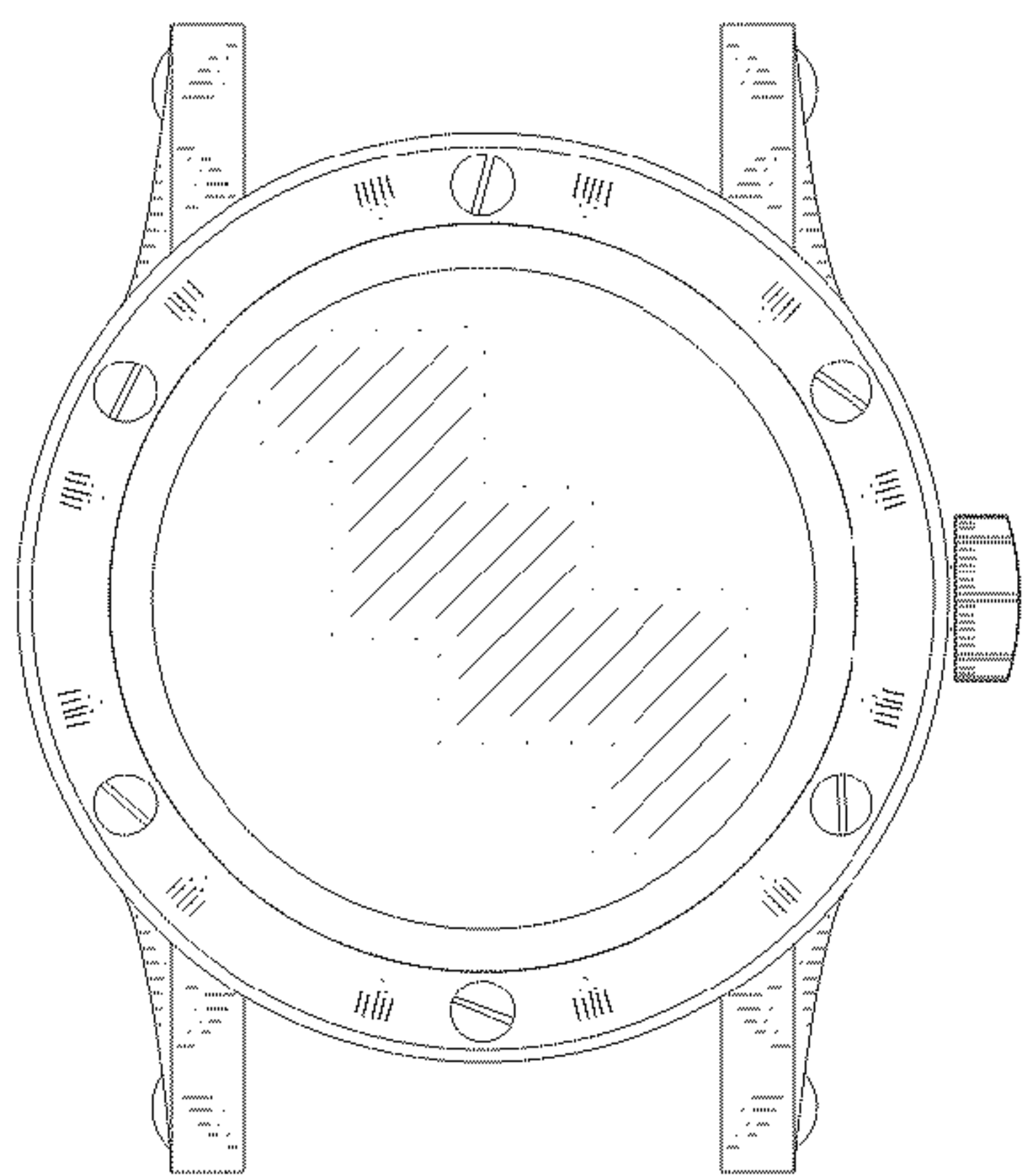

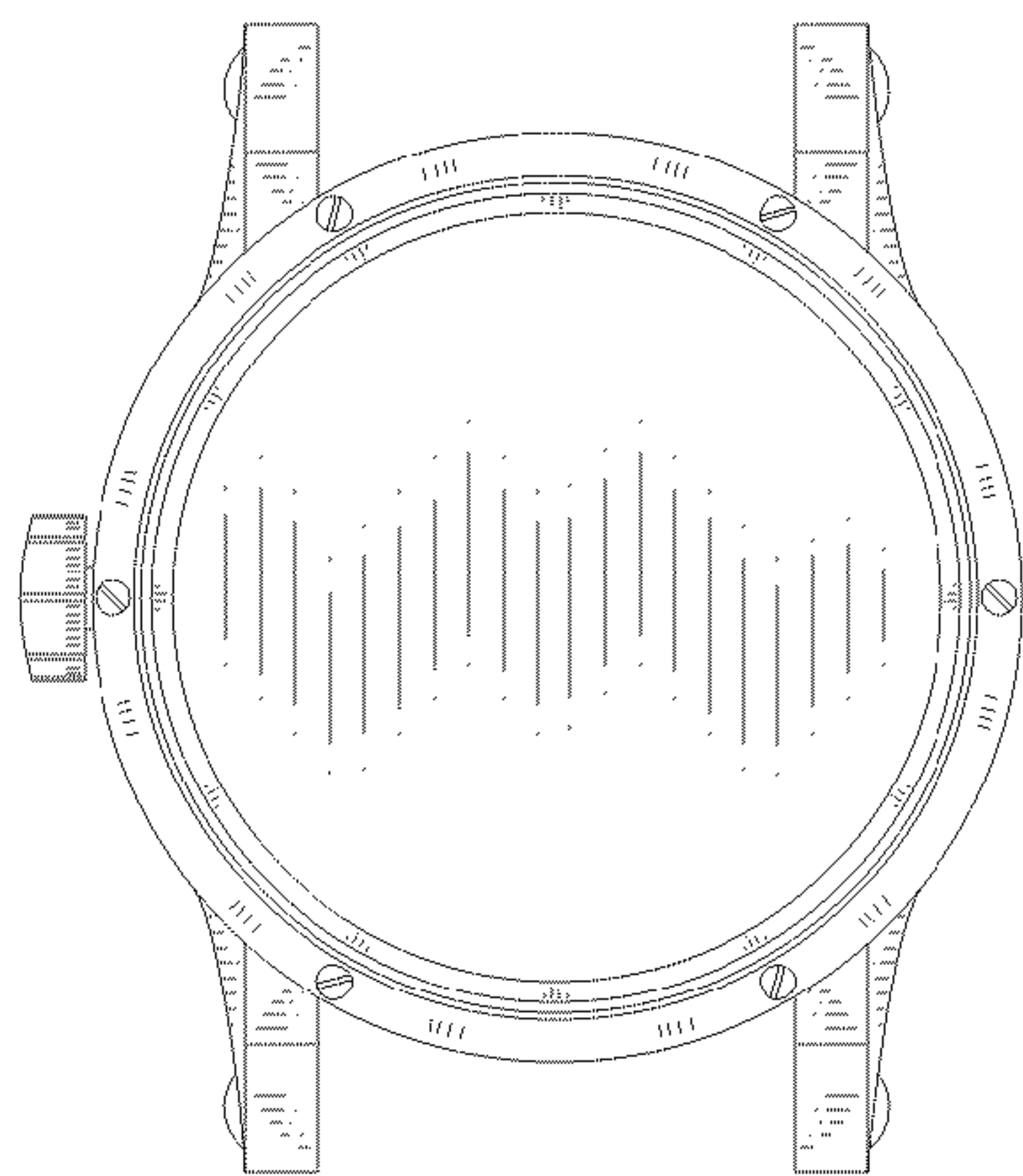

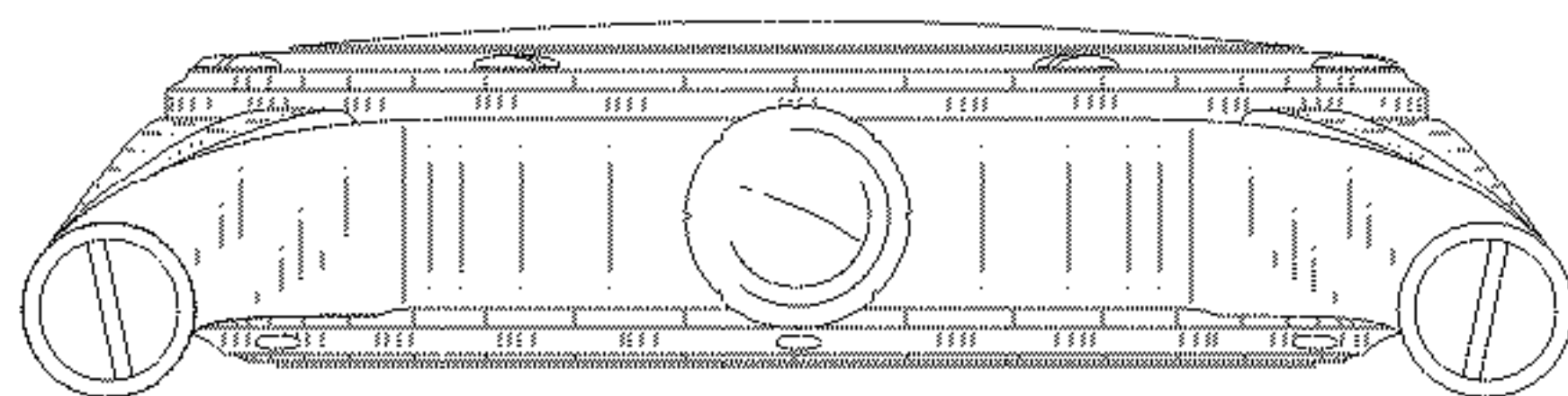

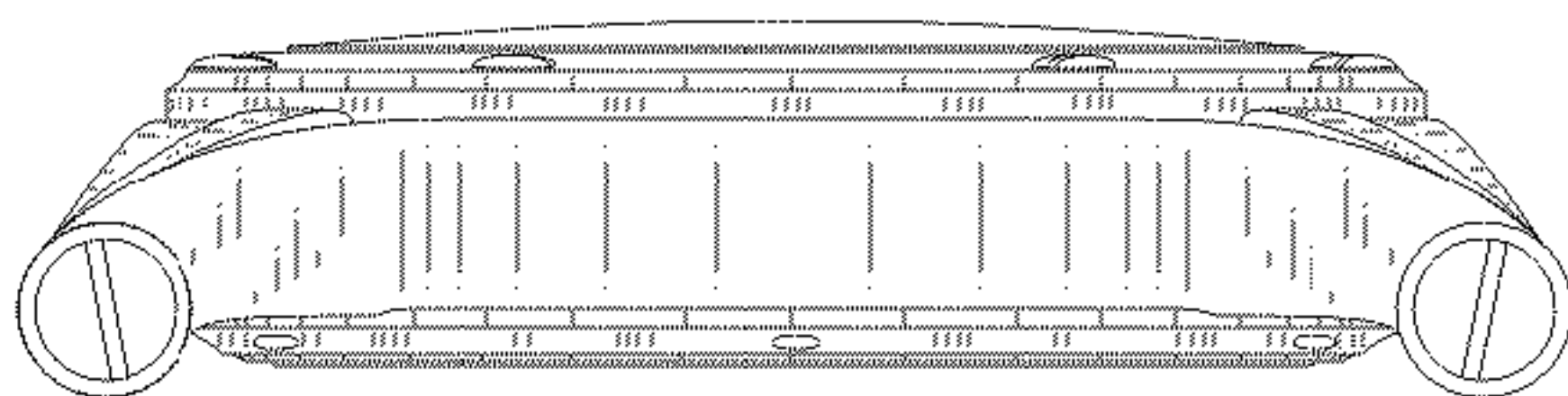

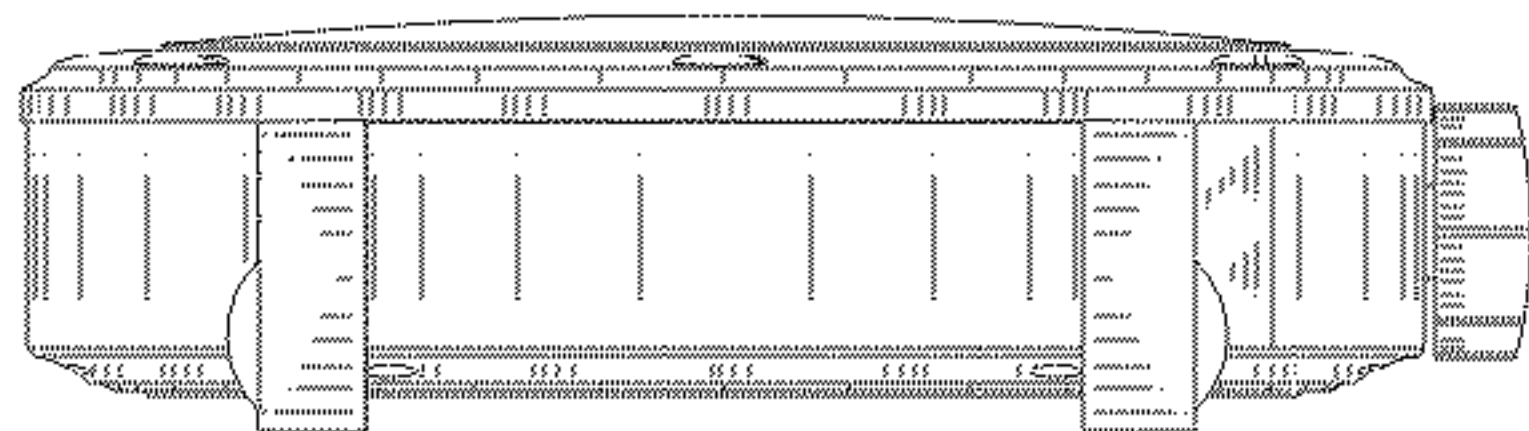

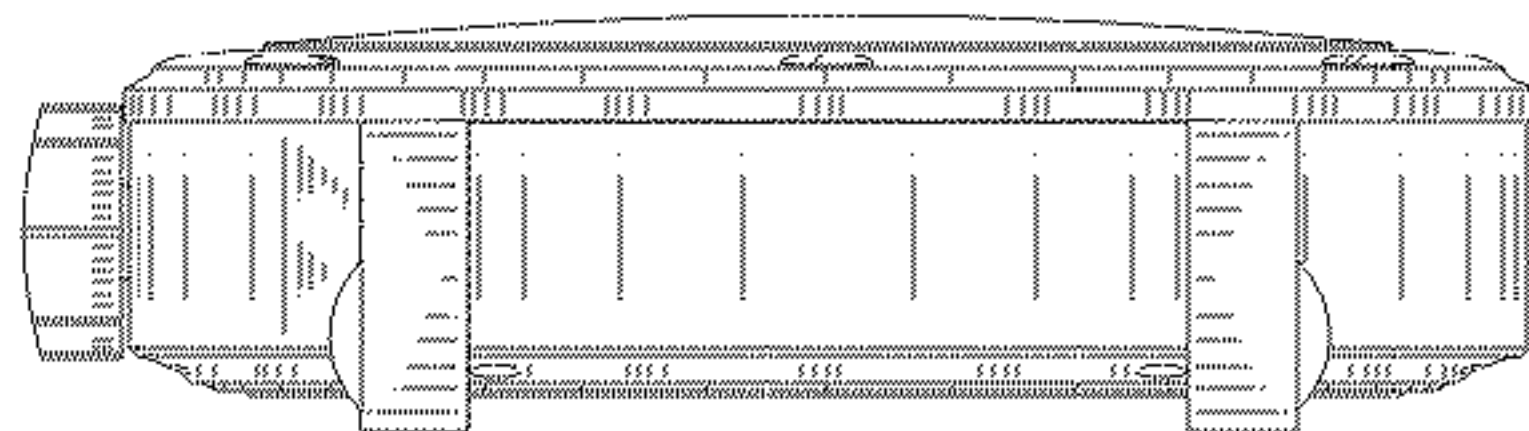

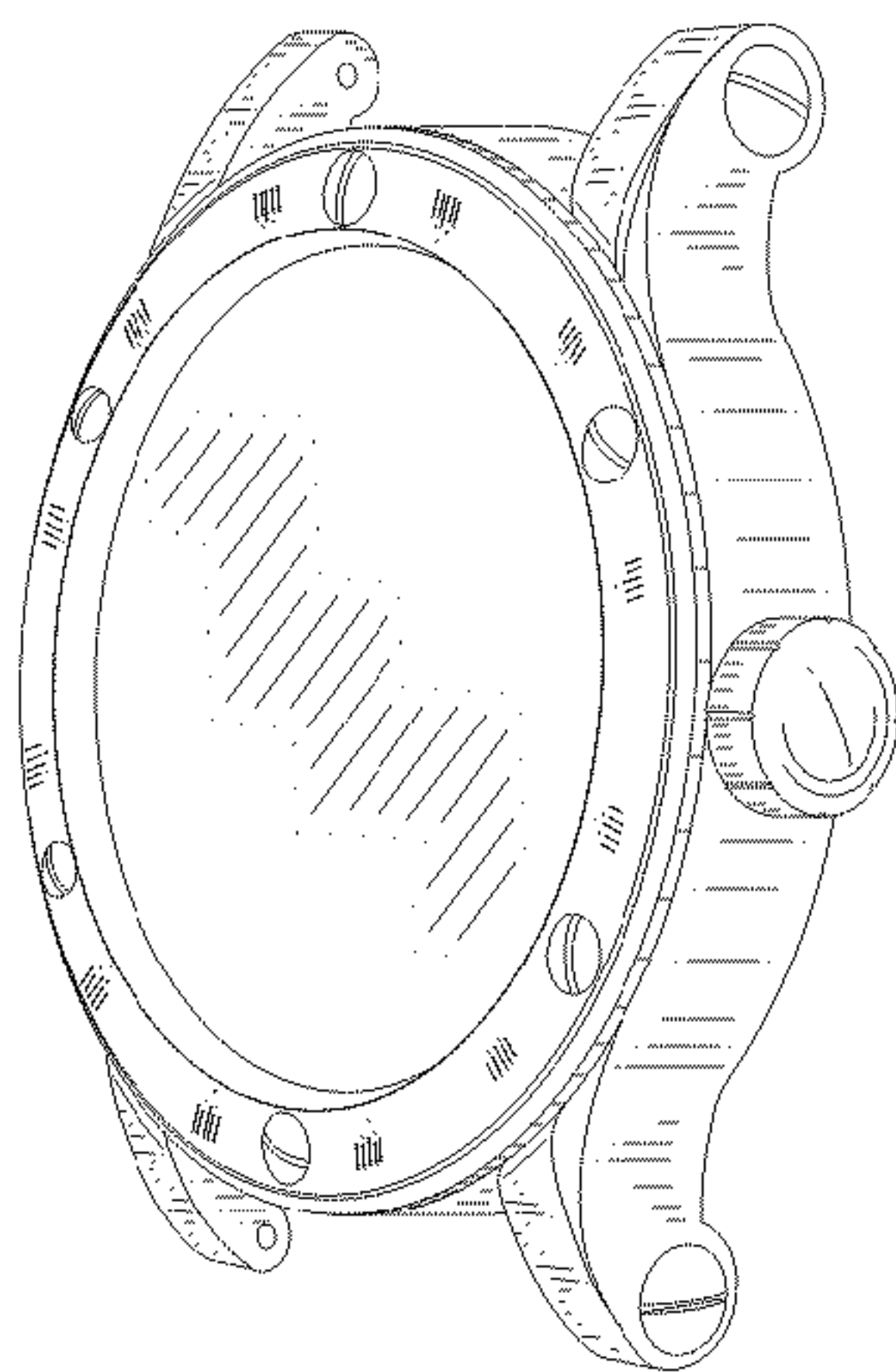
