FIG. 2 is a left side elevation view thereof, the right side being a mirror image;

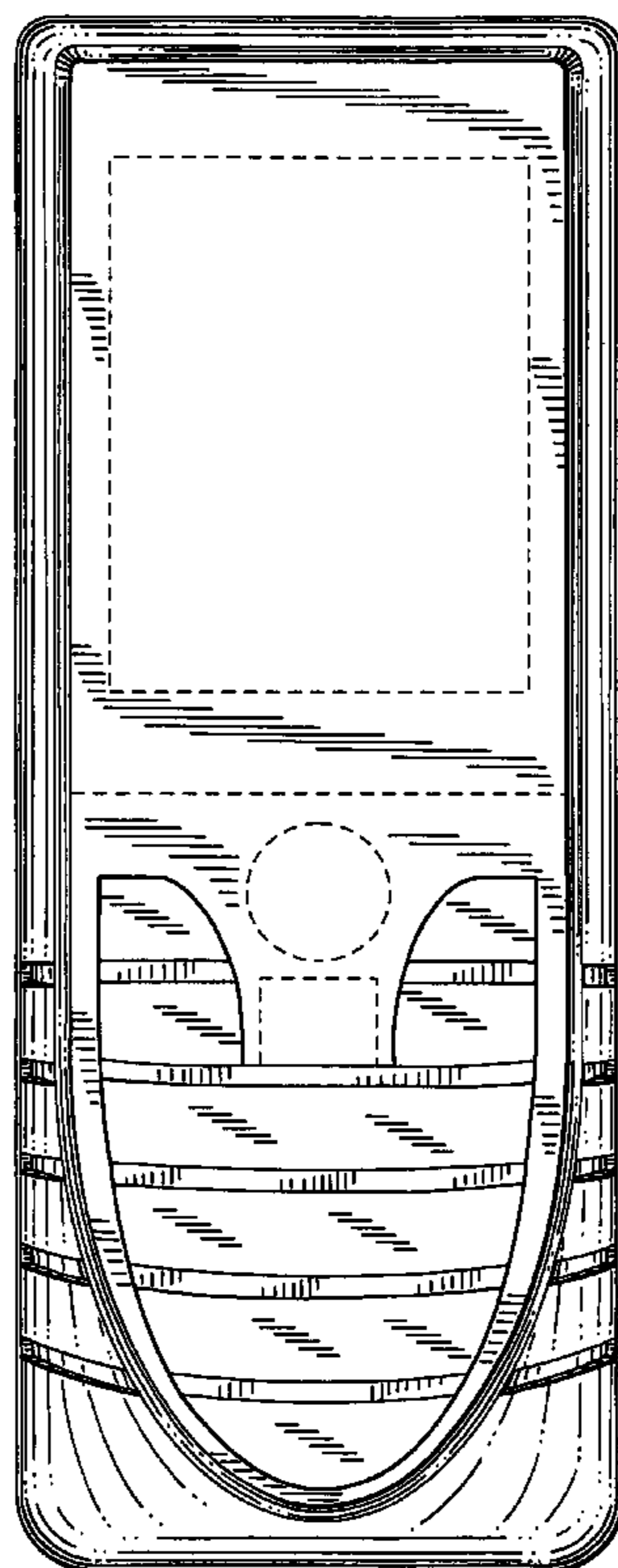
FIG. 3 is a front elevation view thereof;

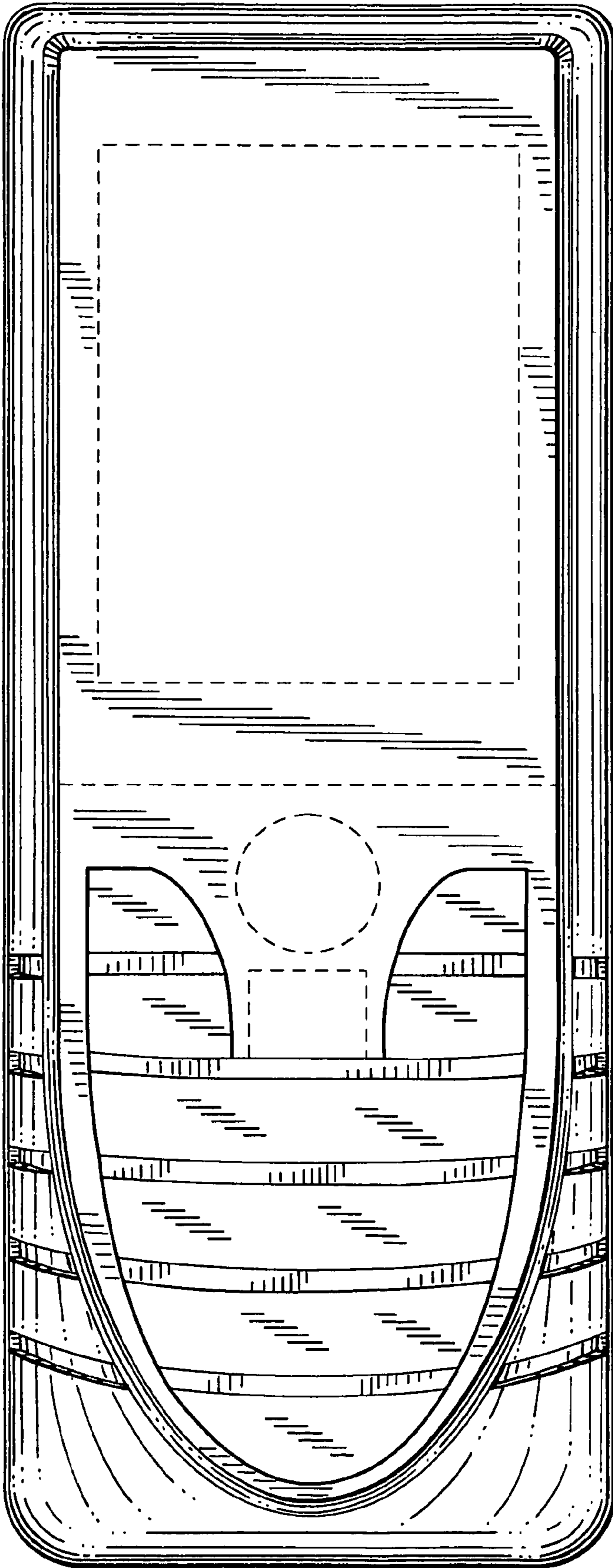

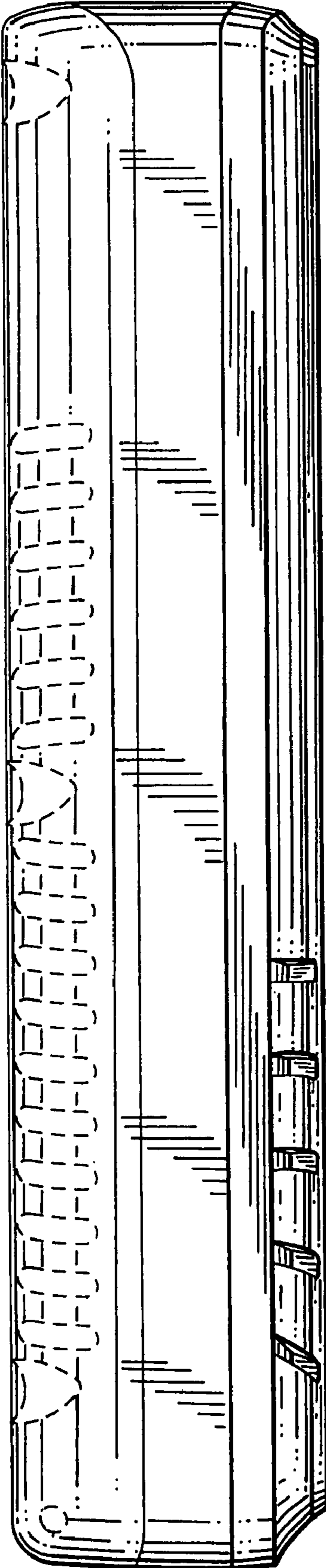

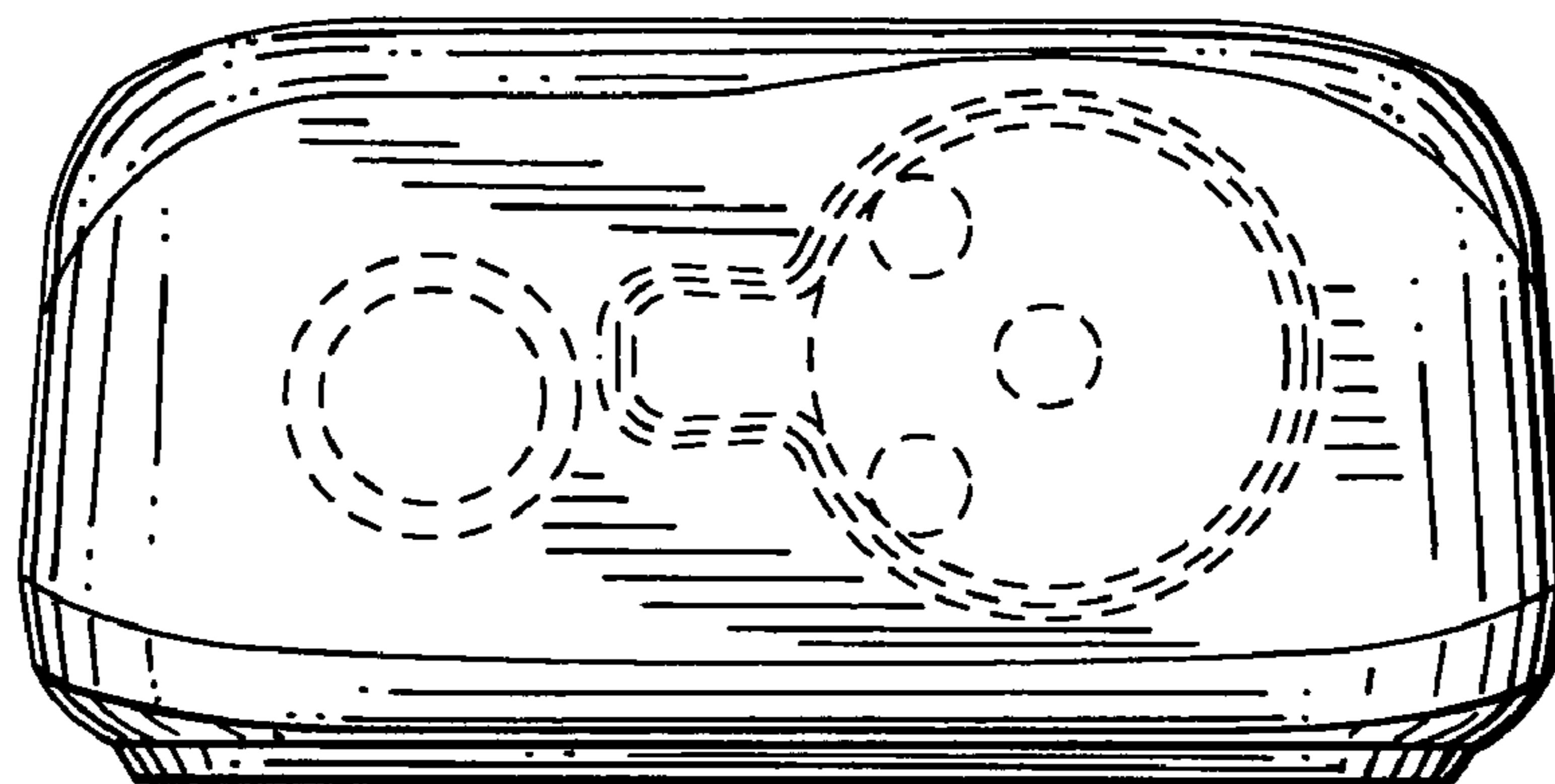

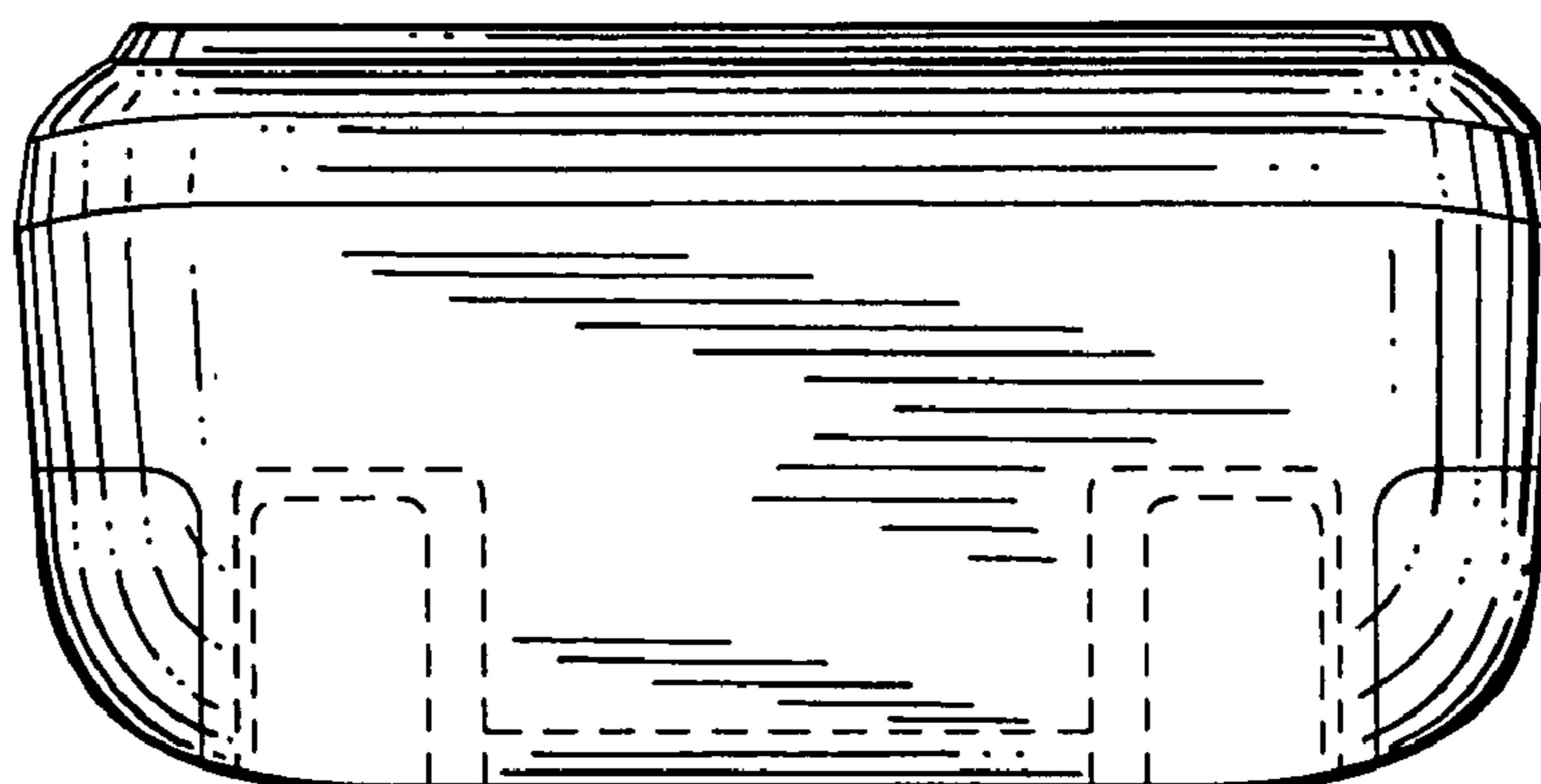

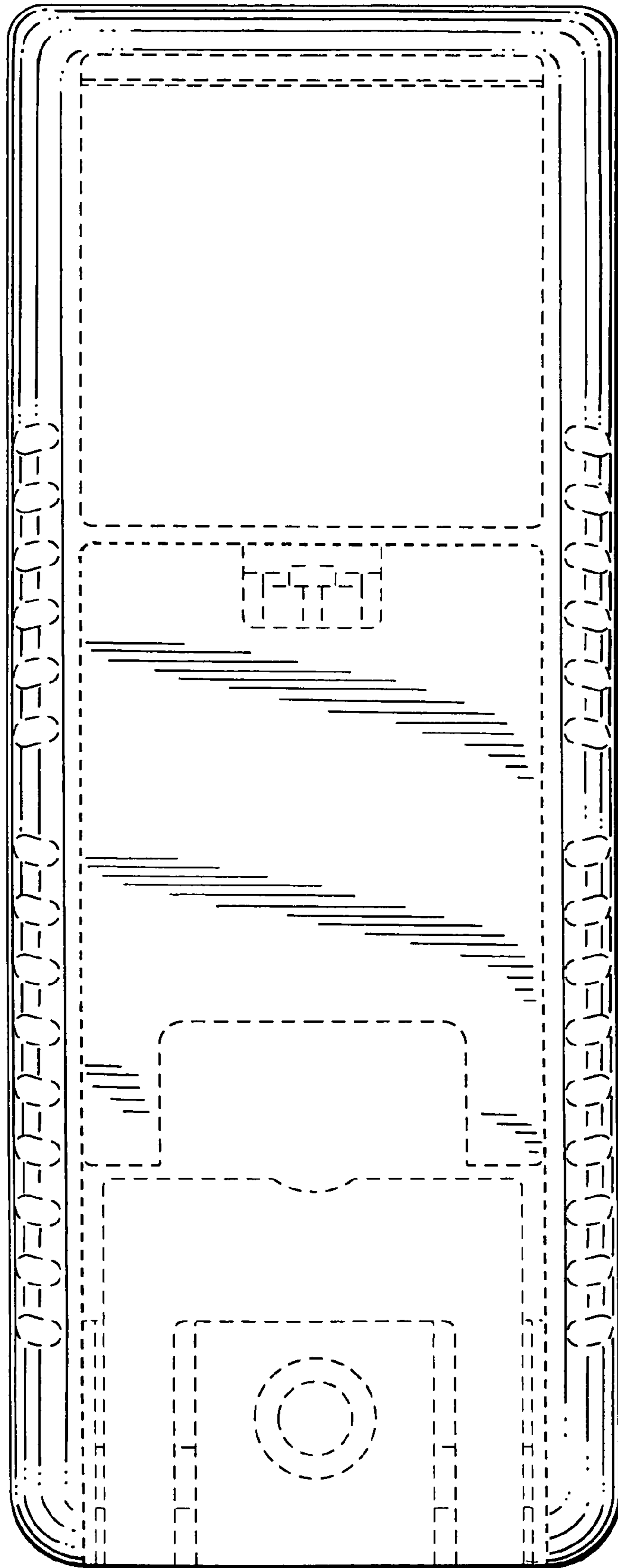
