FIG. 2 is a top plan view thereof;

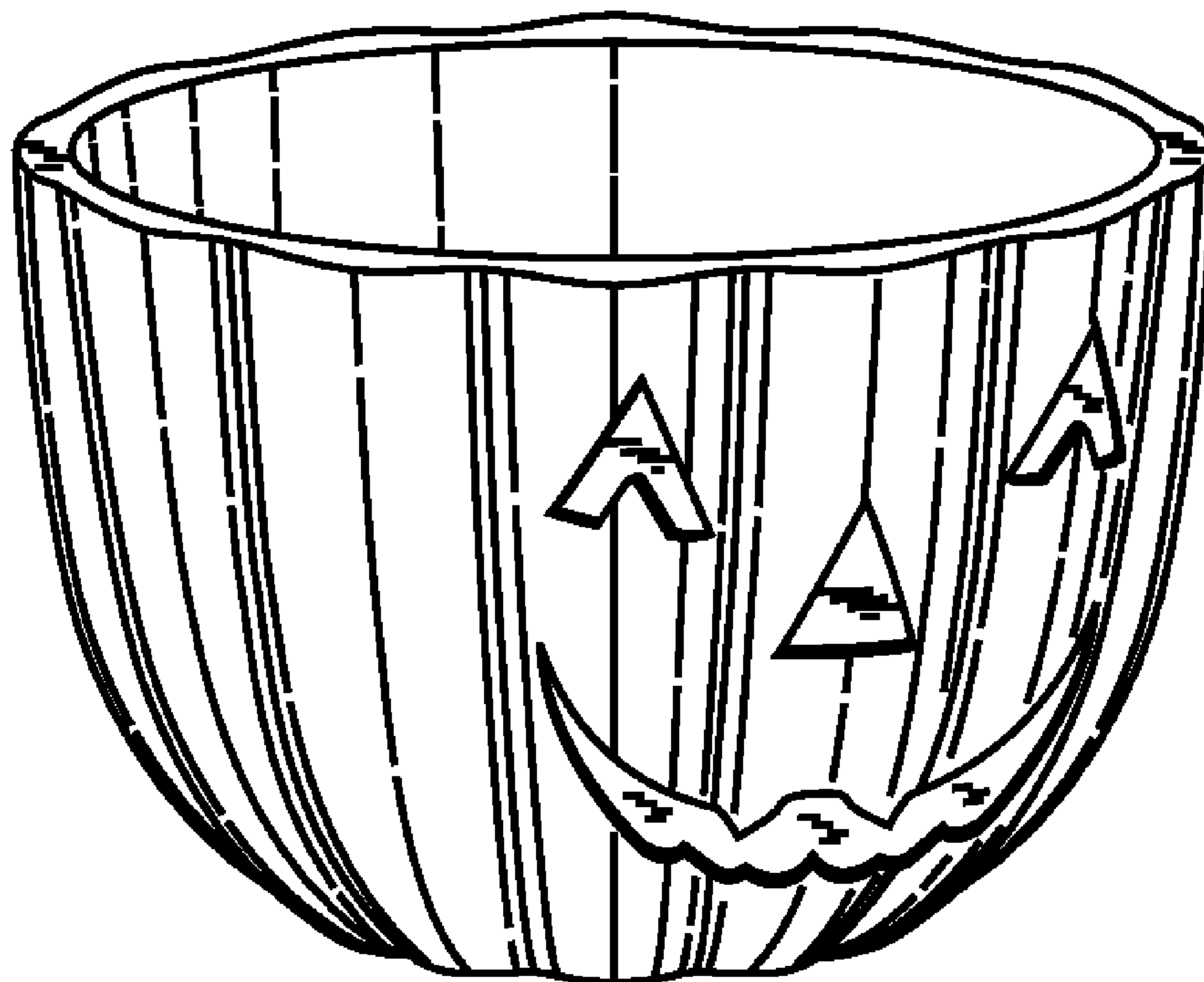
FIG. 3 is a right side elevation view thereof, the left side view being a mirror image thereto;

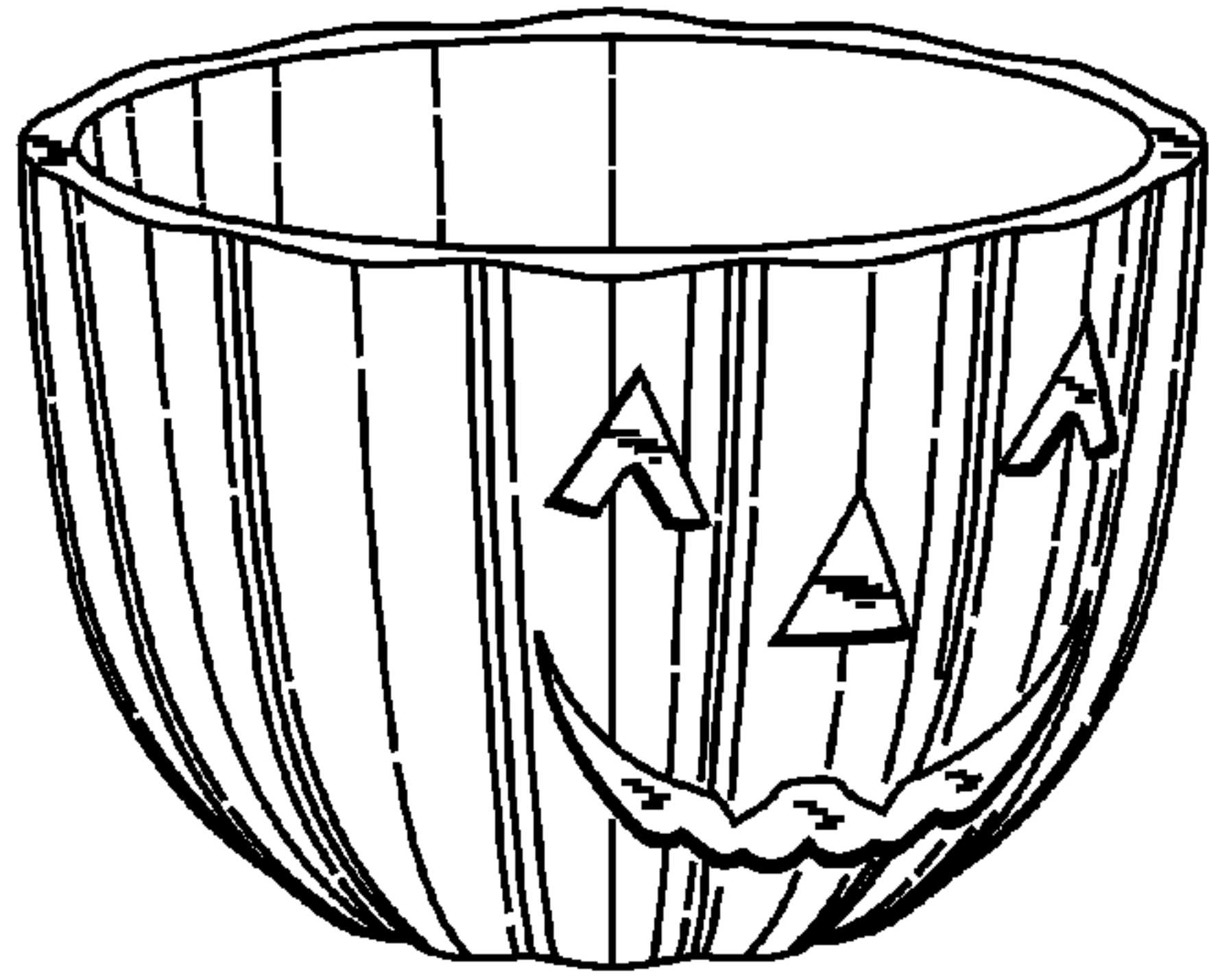

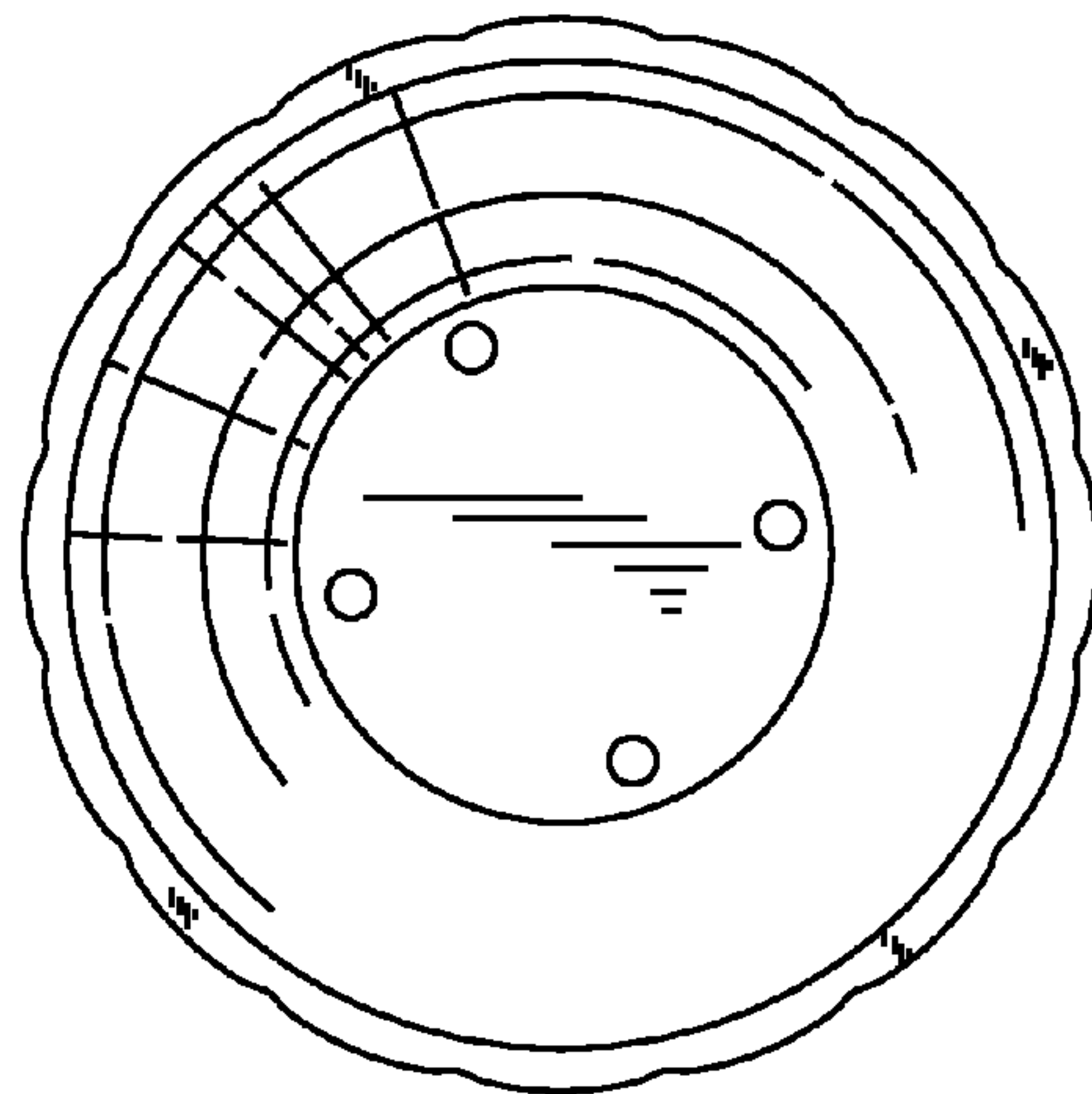

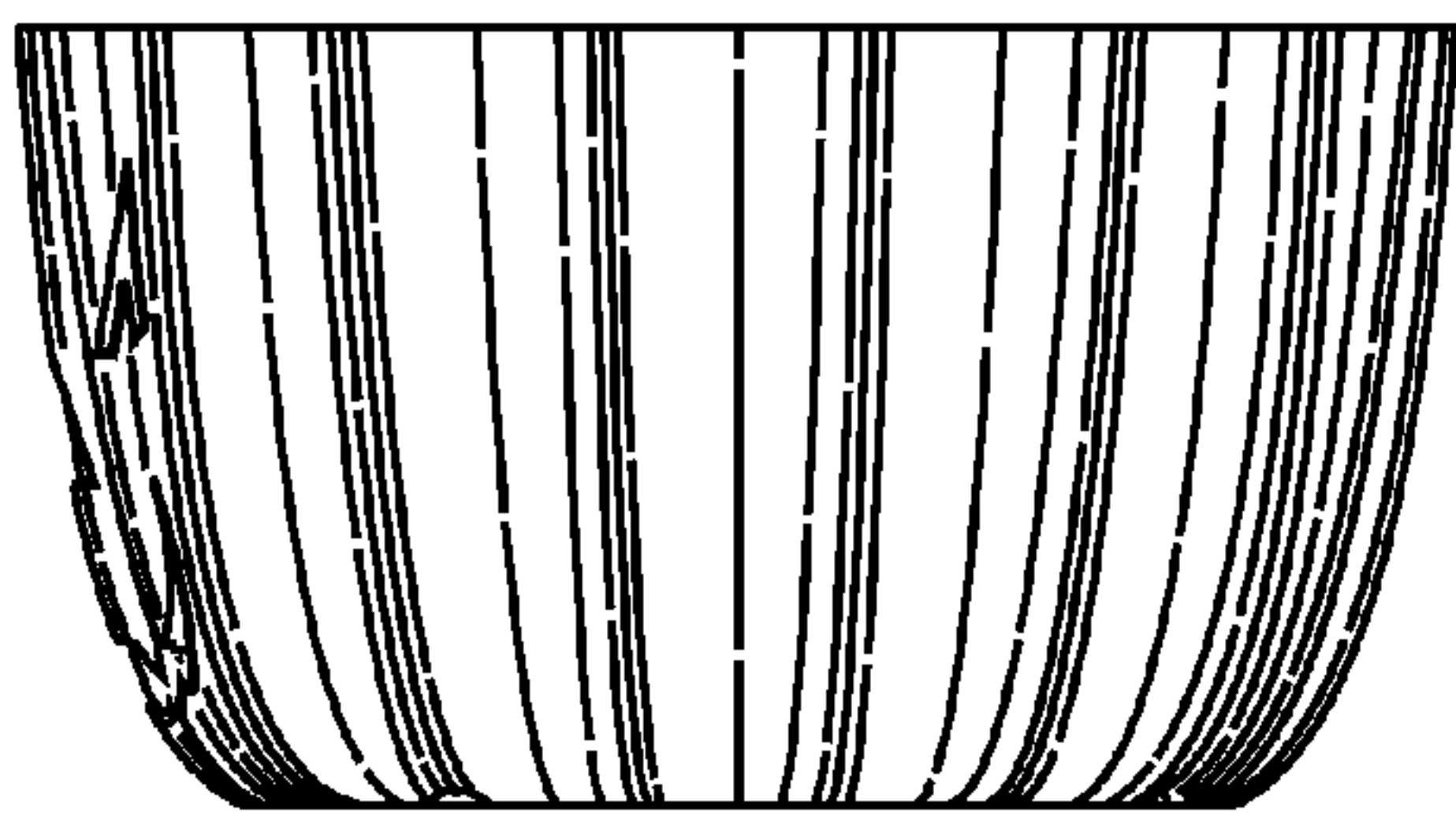

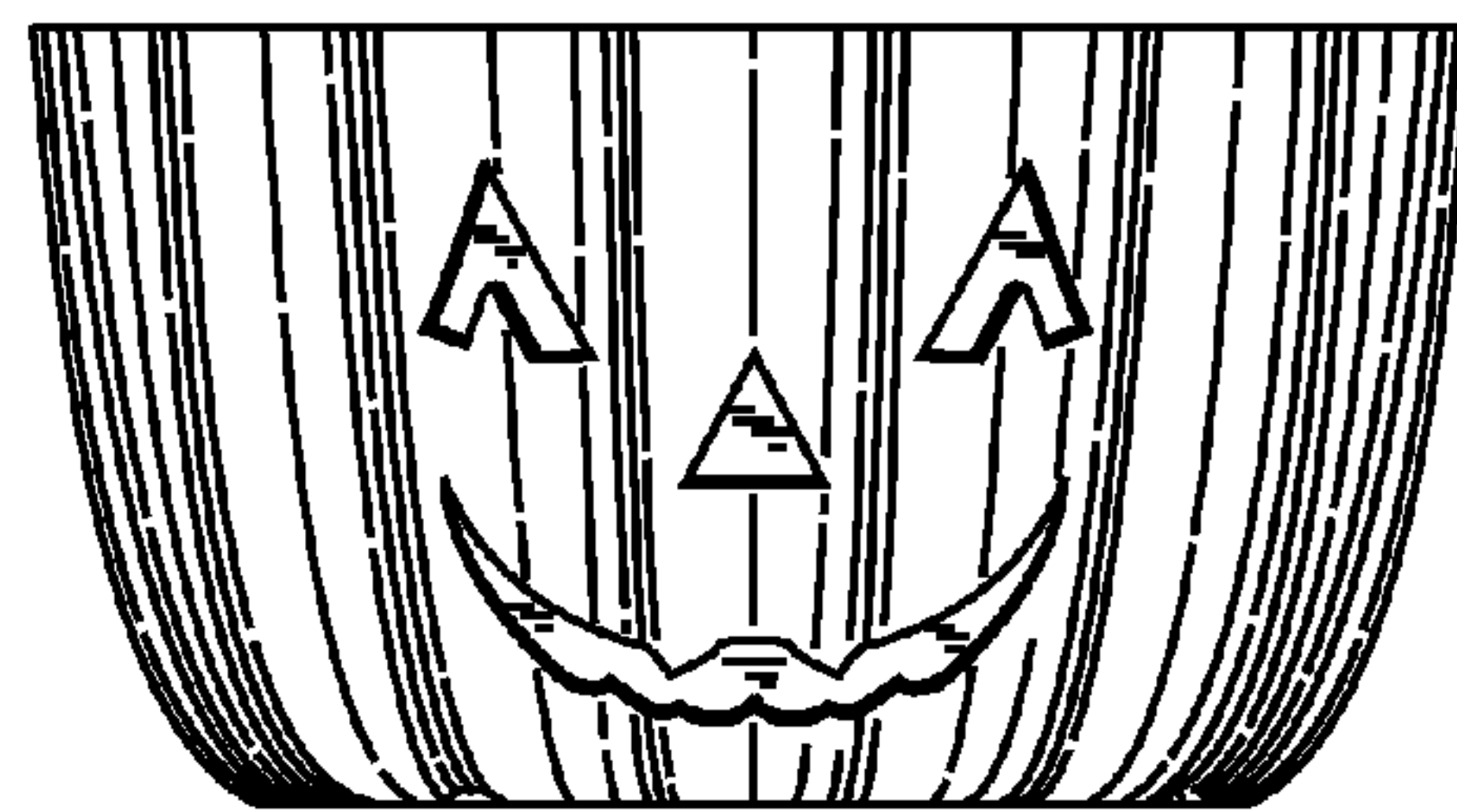

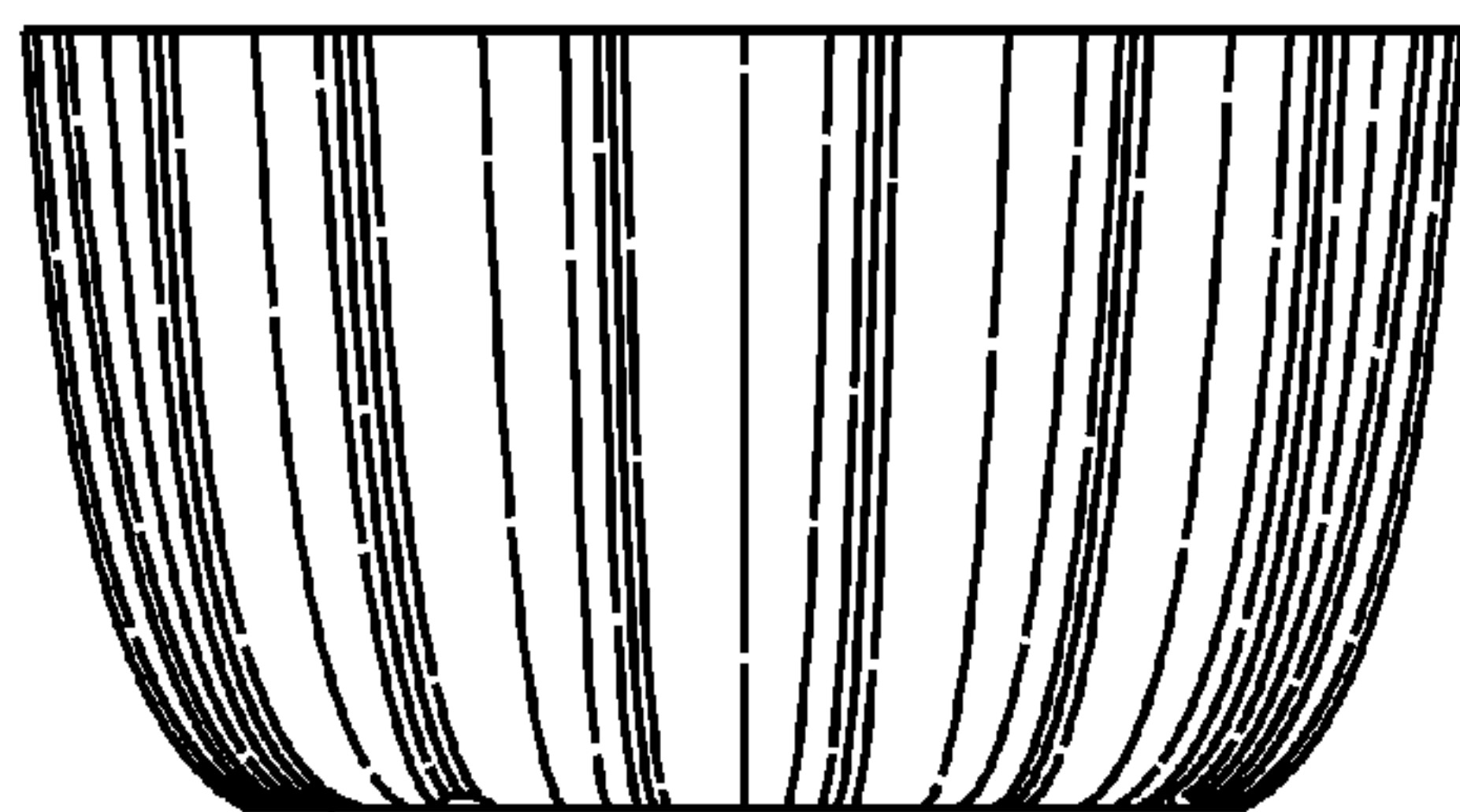

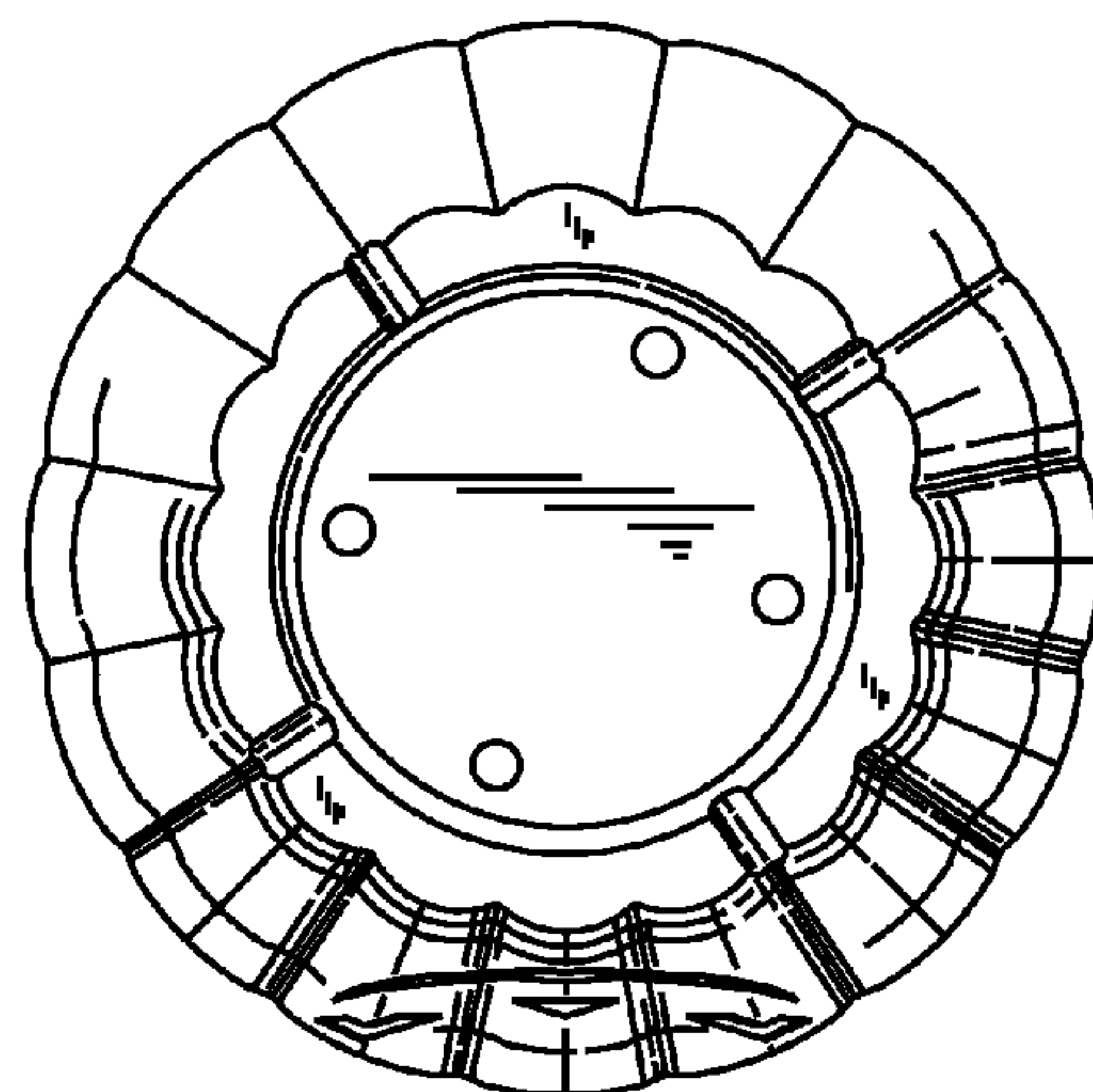
