(57) **CLAIM**

The ornamental design for a transport vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevation view of the transport vehicle showing our new design;

FIG. 4 is a rear elevation view thereof;

FIG. 10 is a partially enlarged view thereof taken on line 10—10 in FIG. 1;

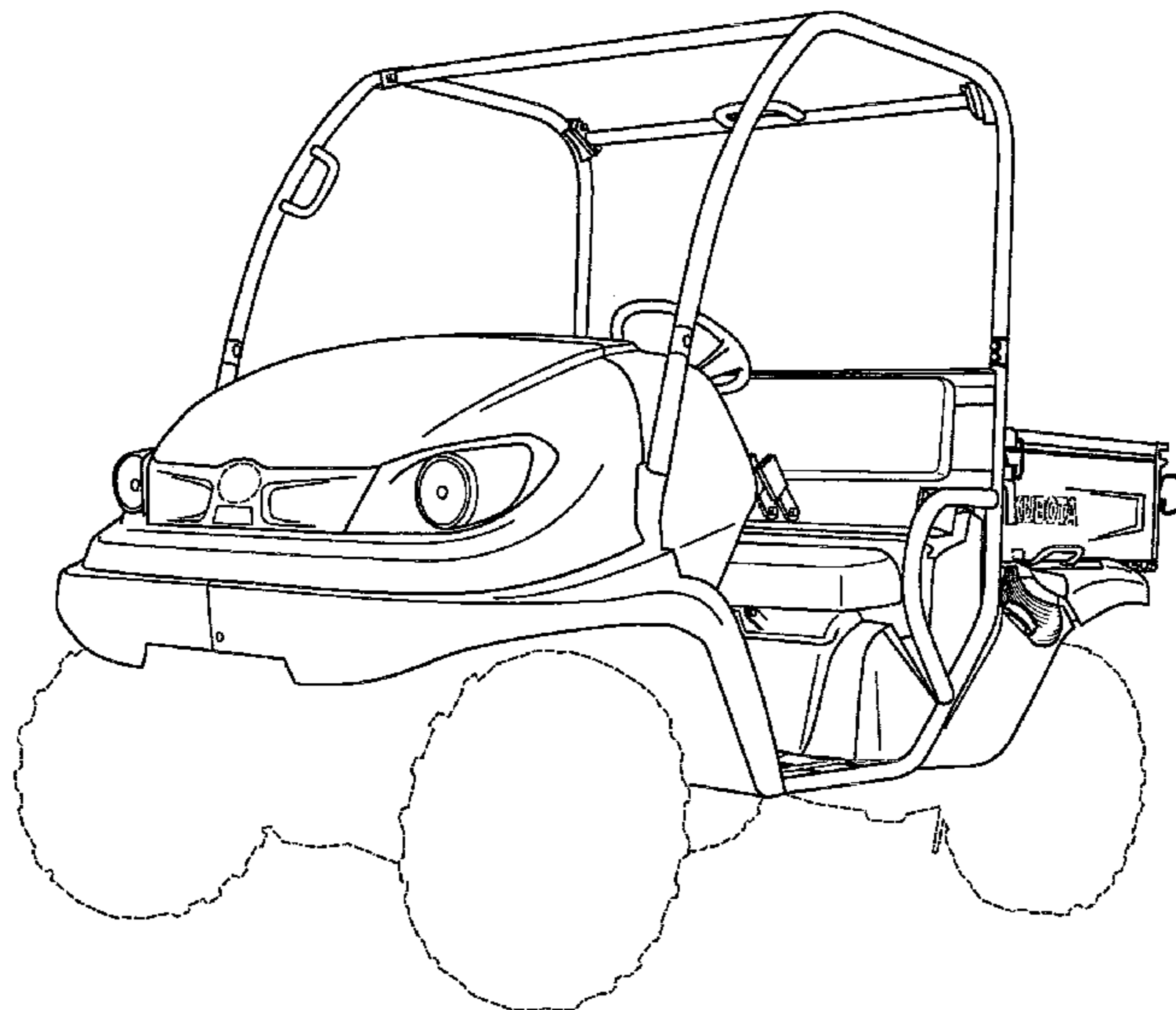
FIG. 11 is a partially enlarged view thereof taken on line 11—11 in FIG. 1;

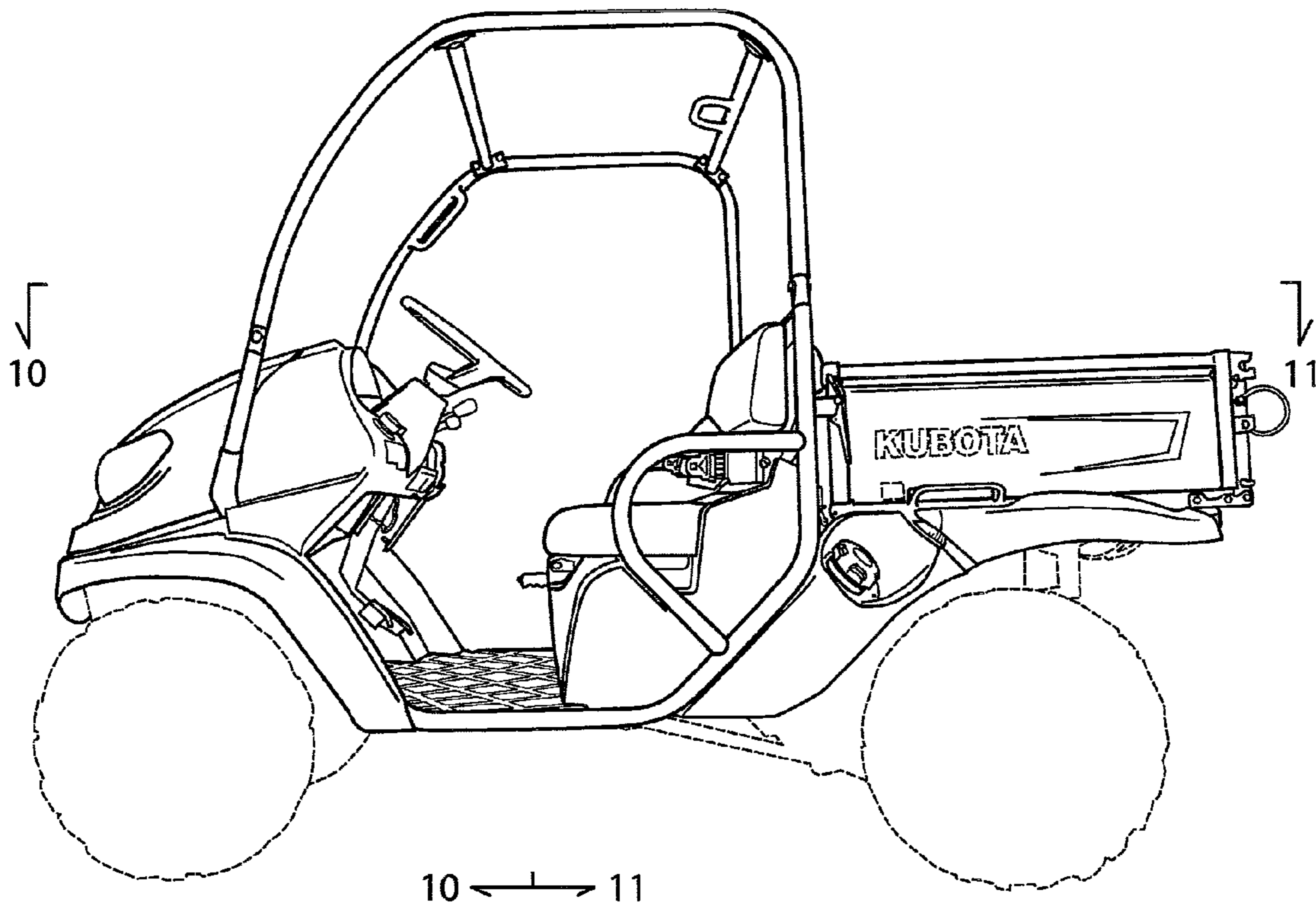

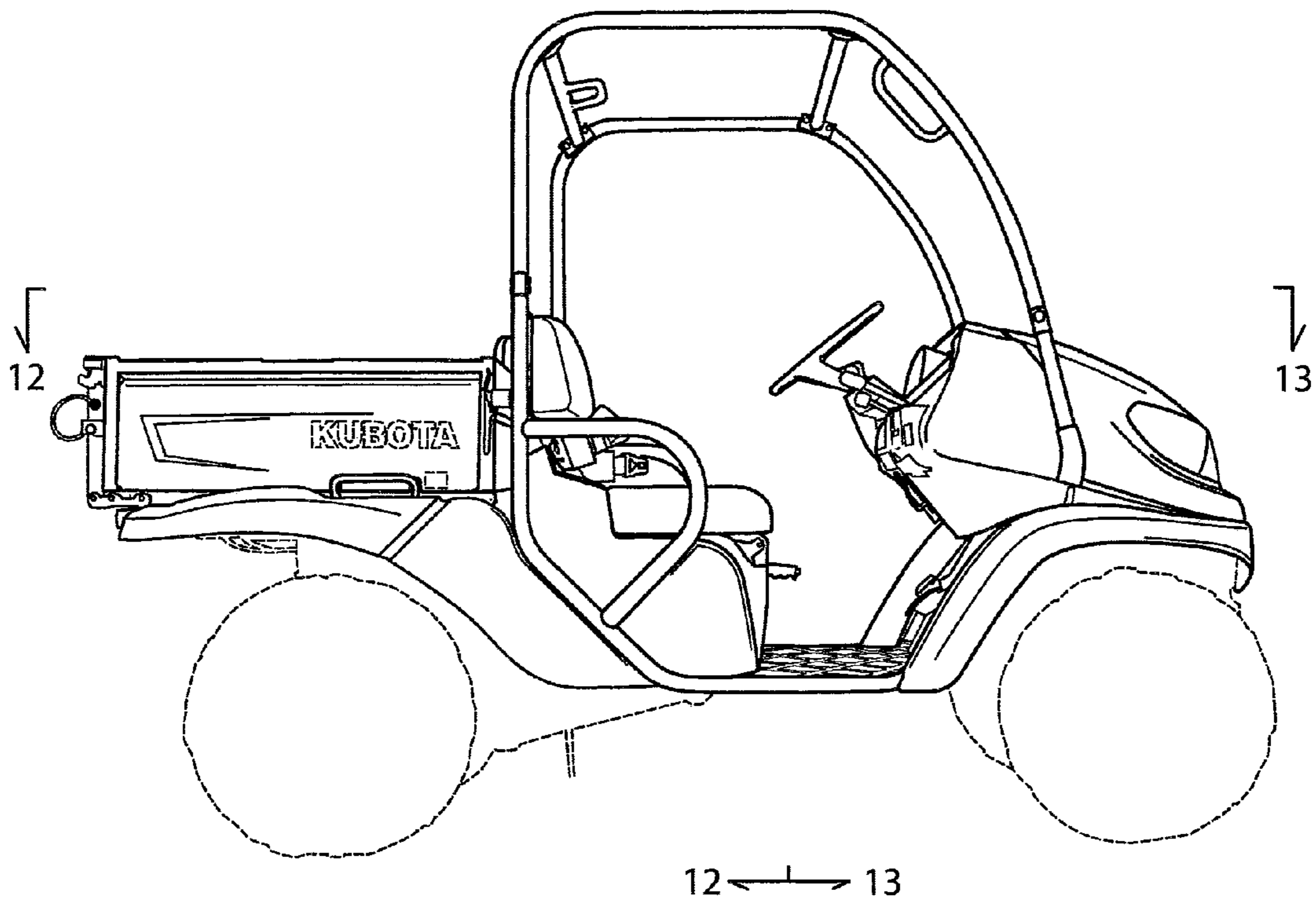
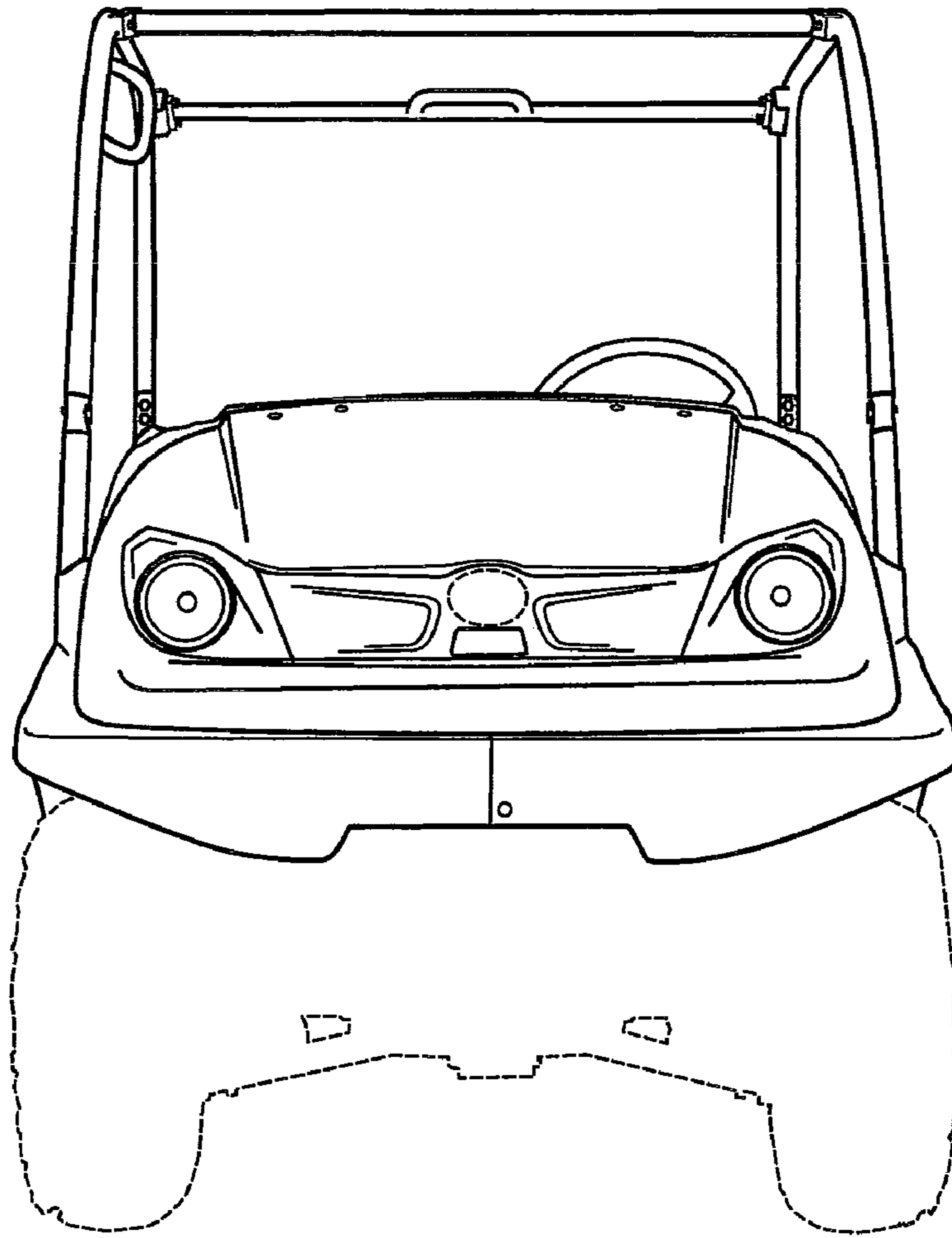
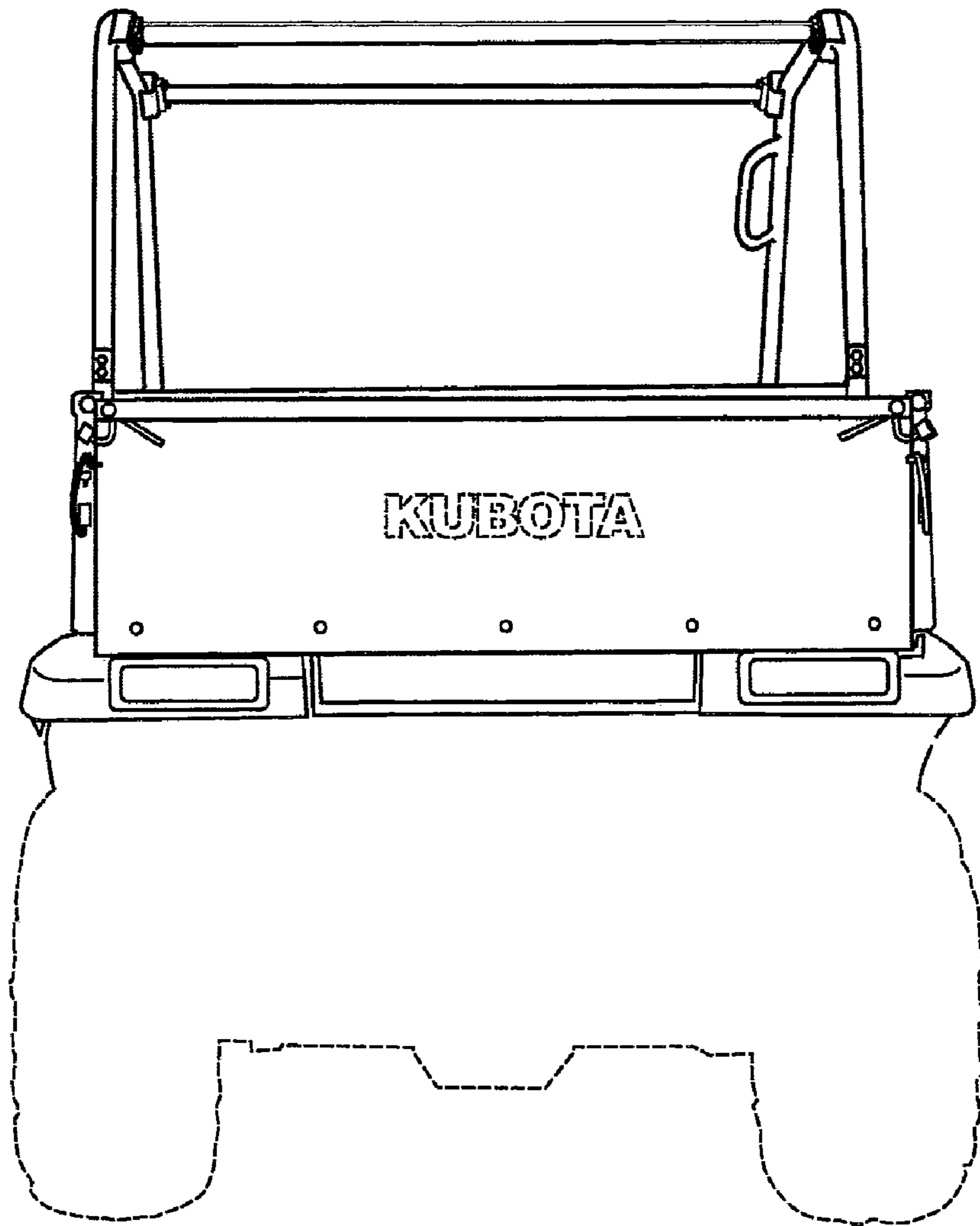

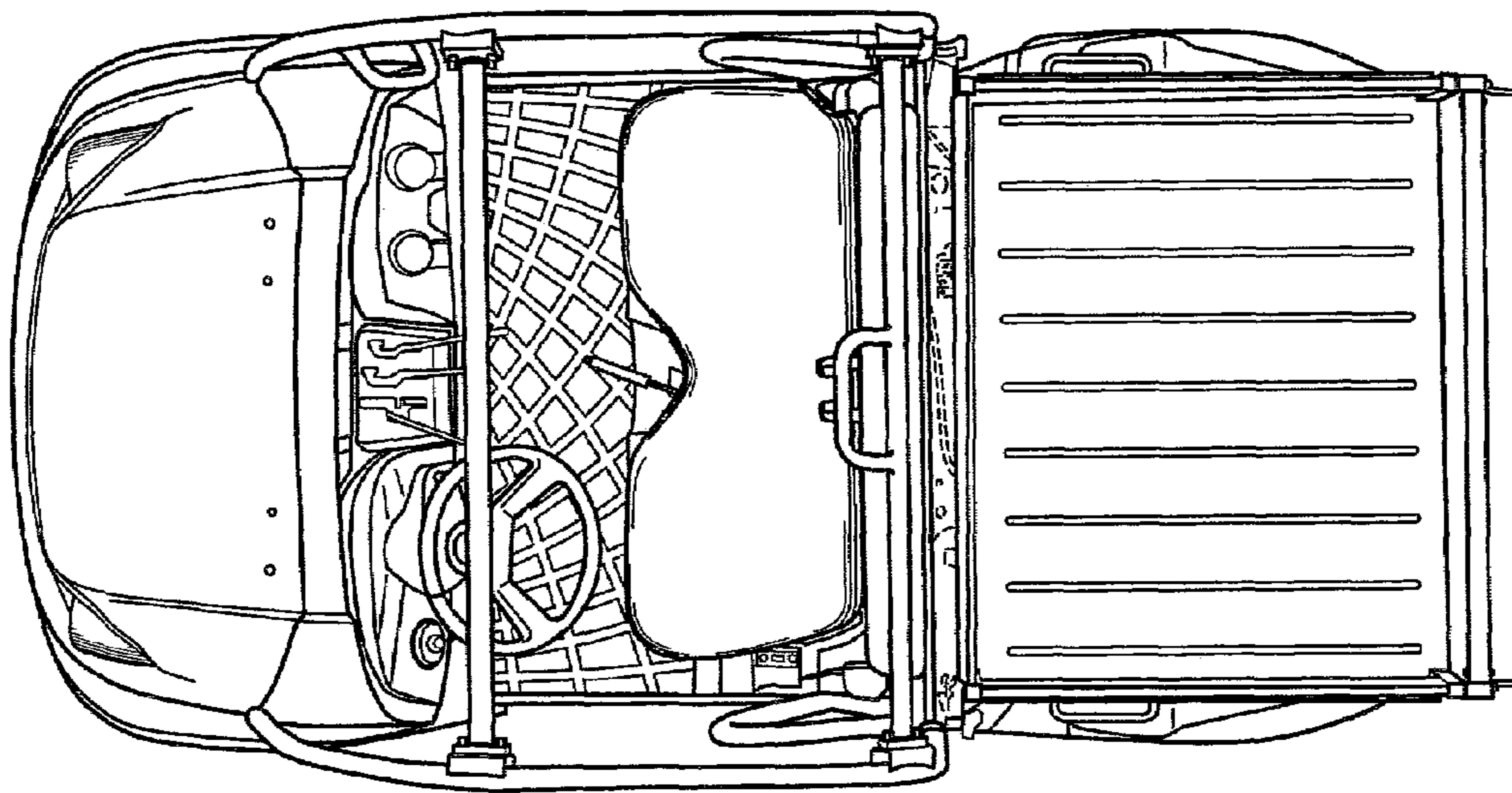
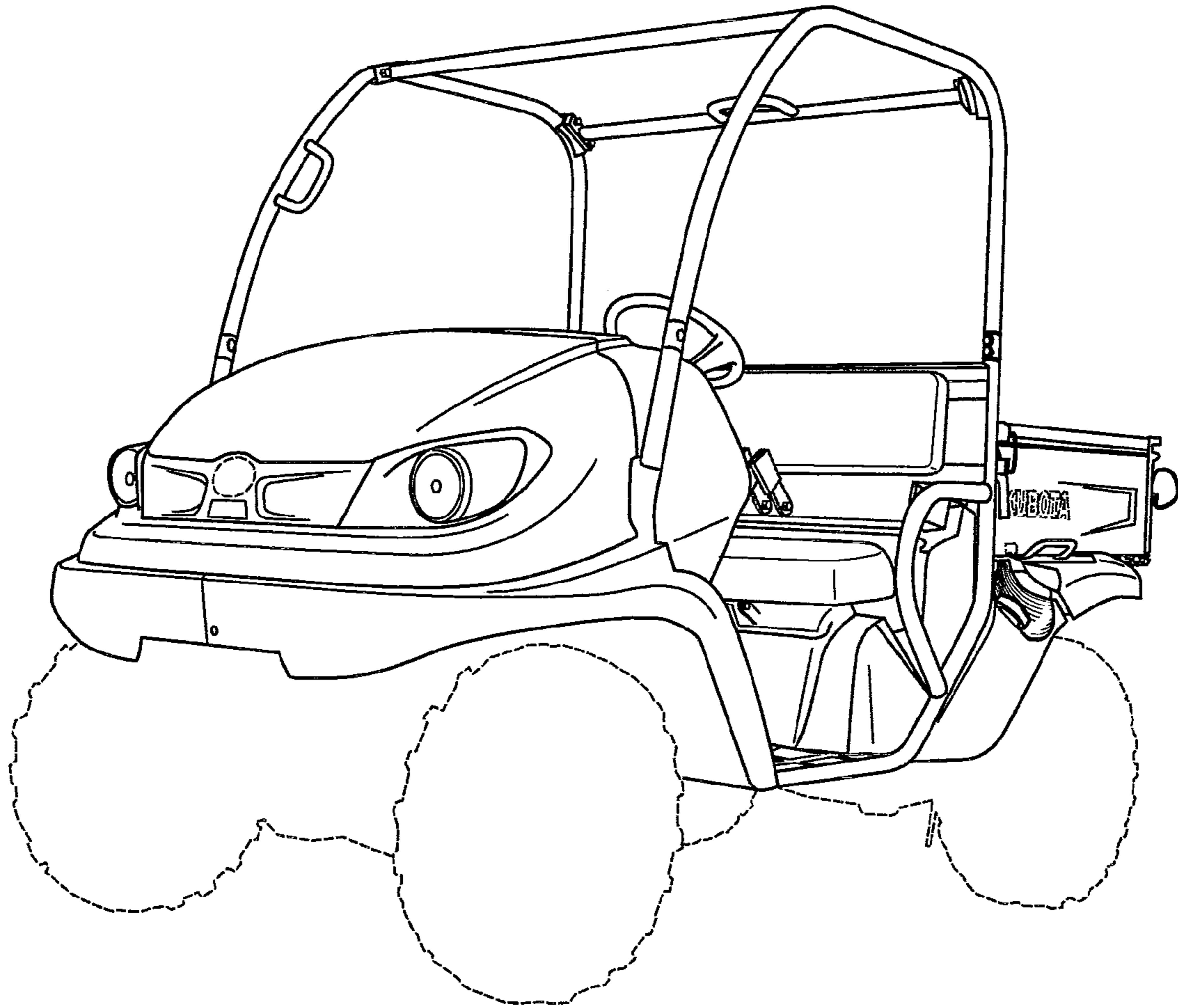
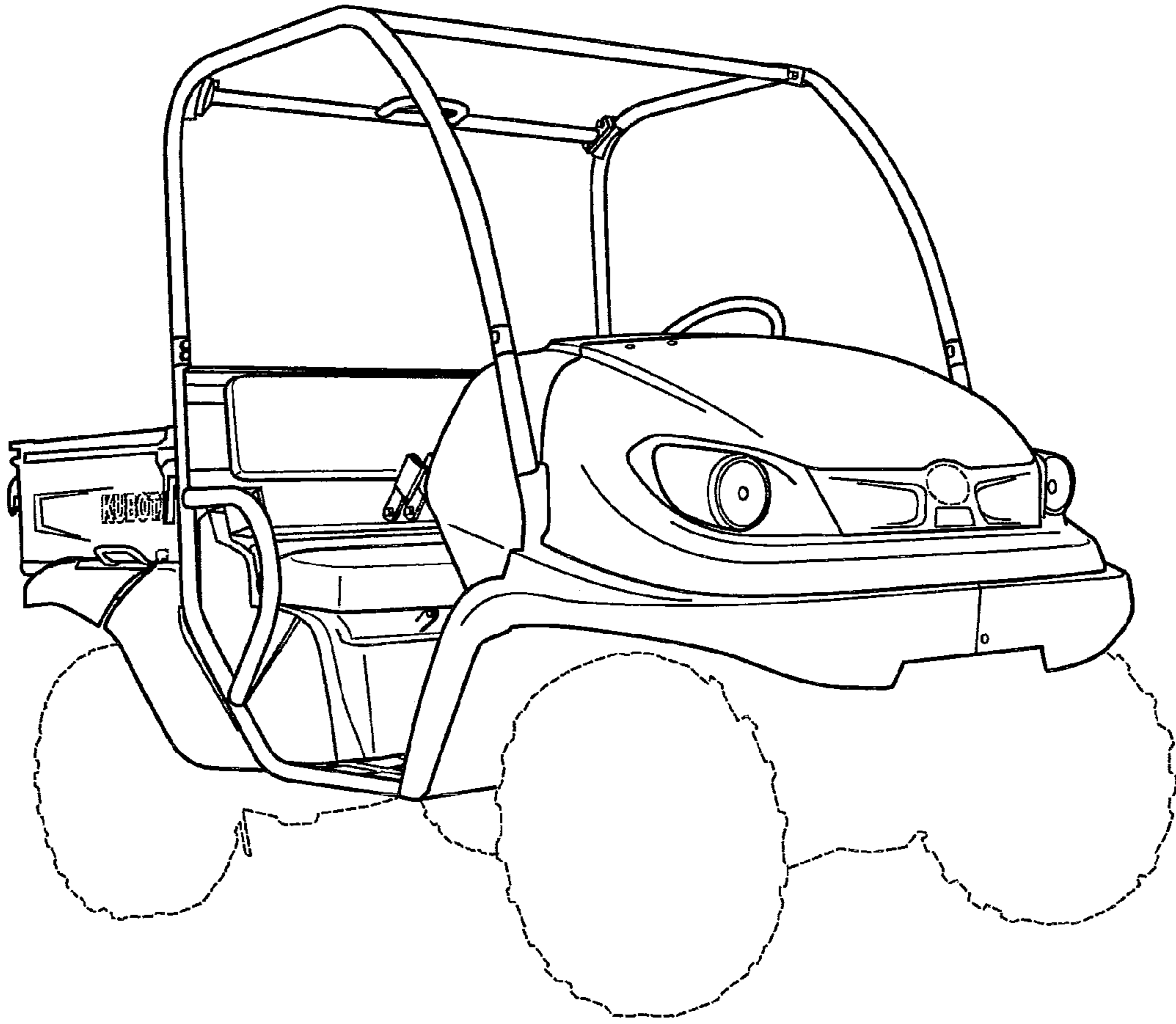

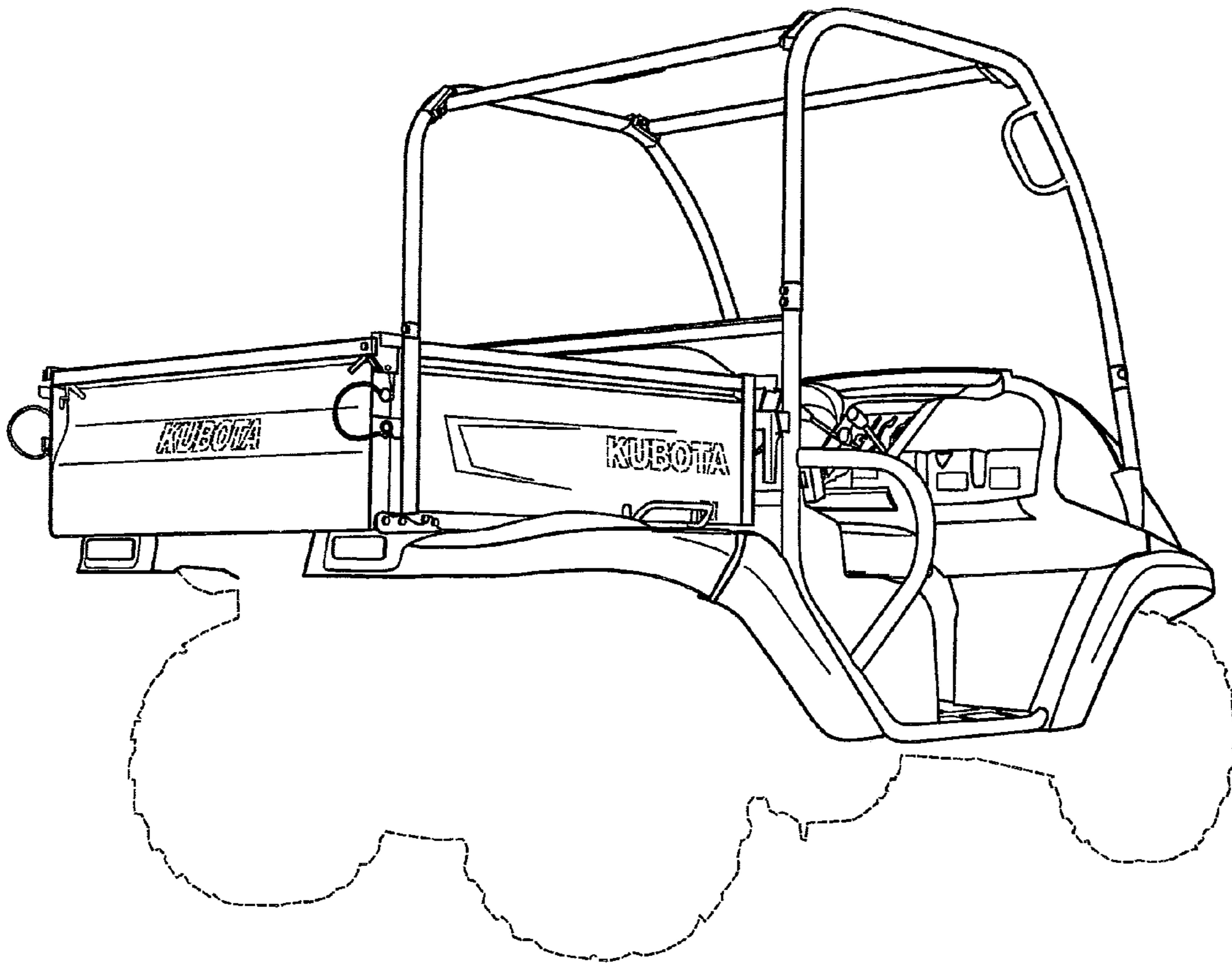

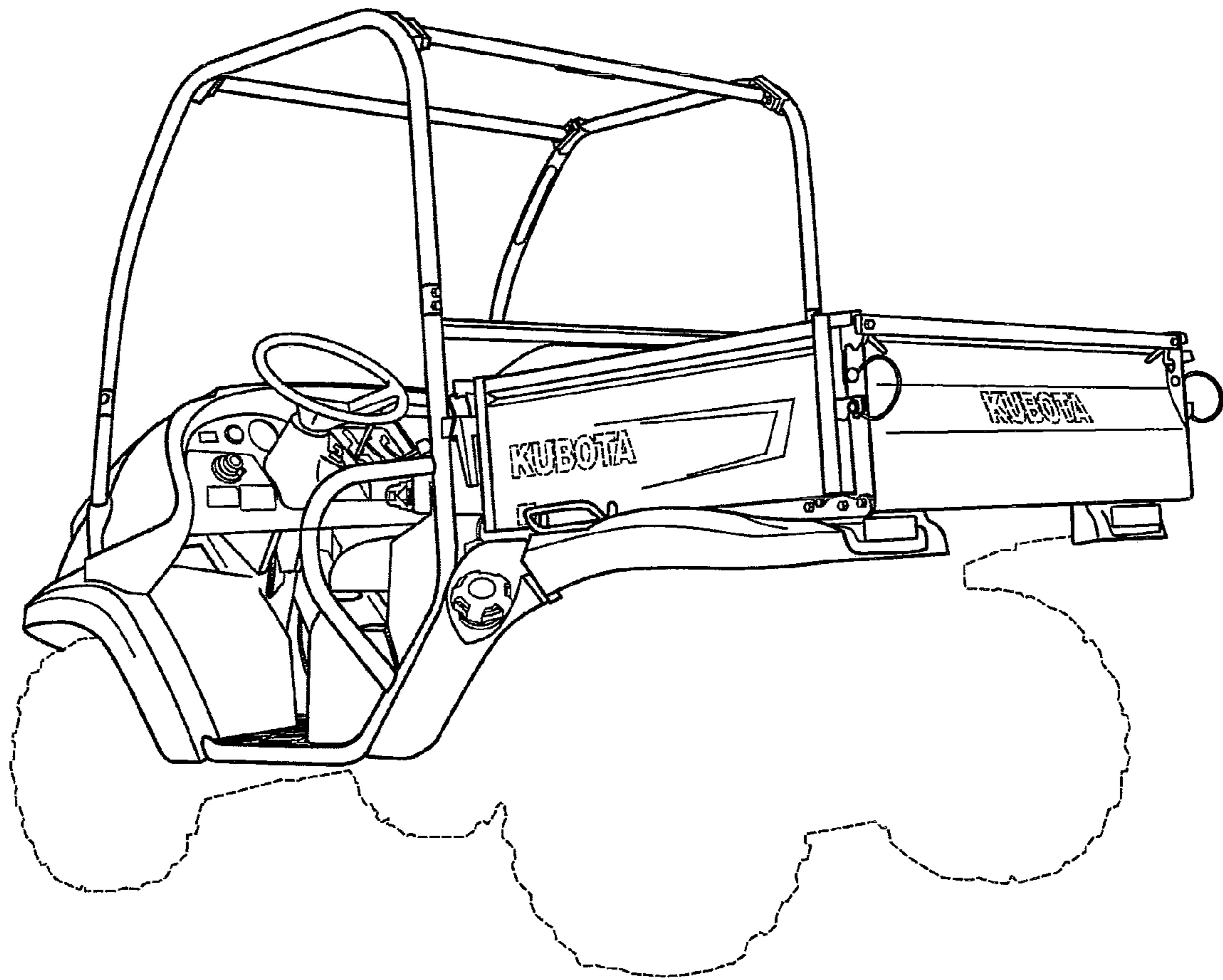

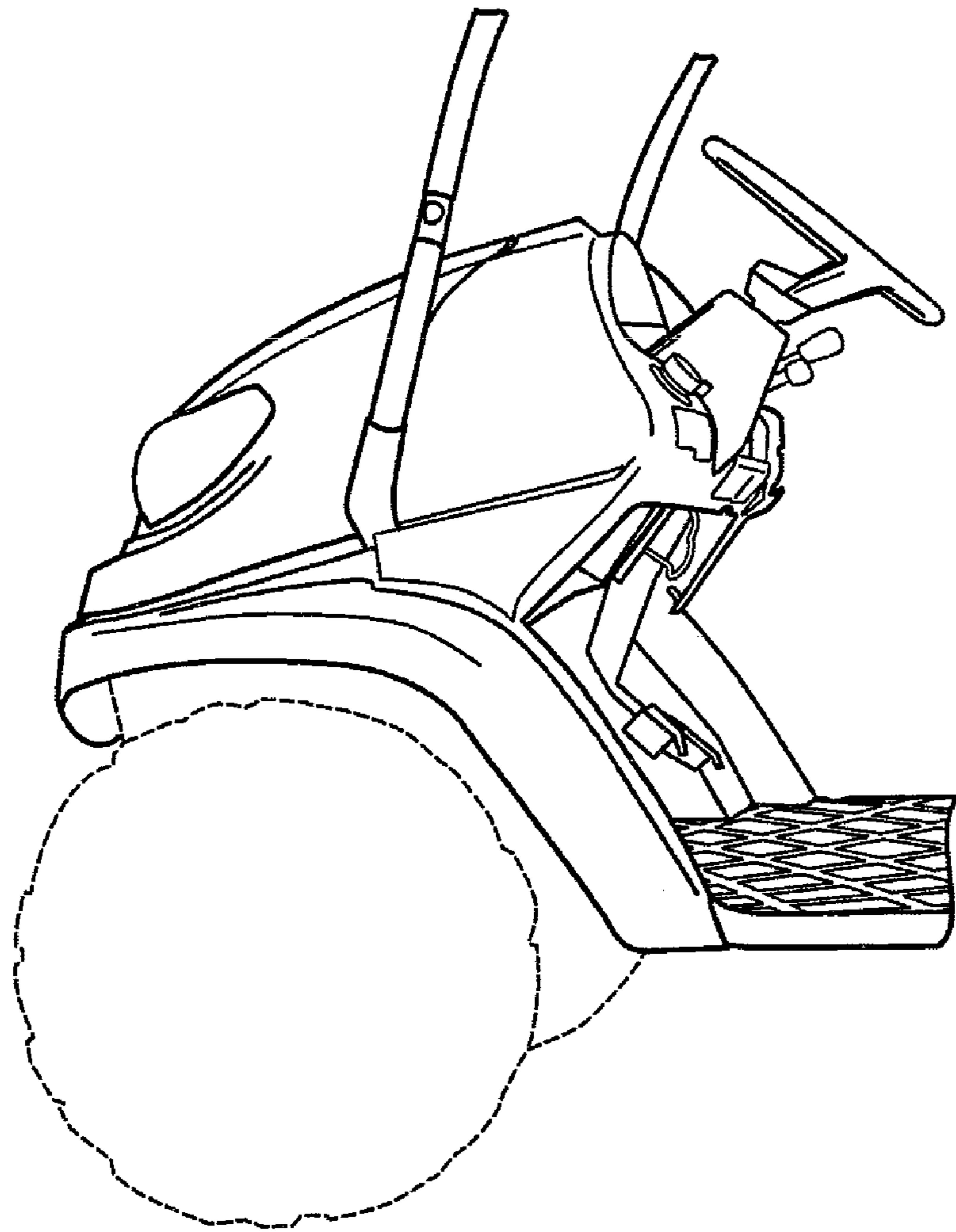




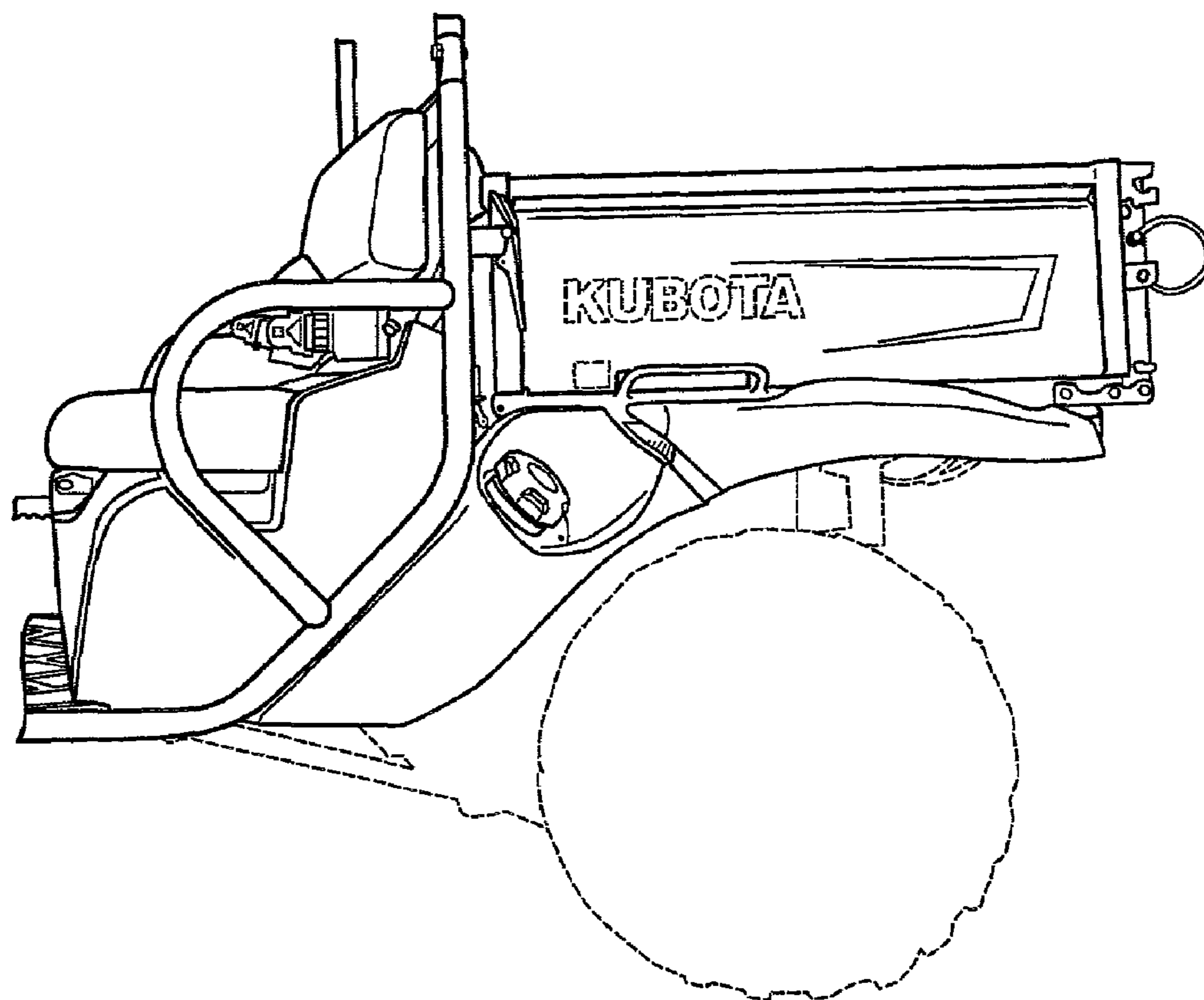

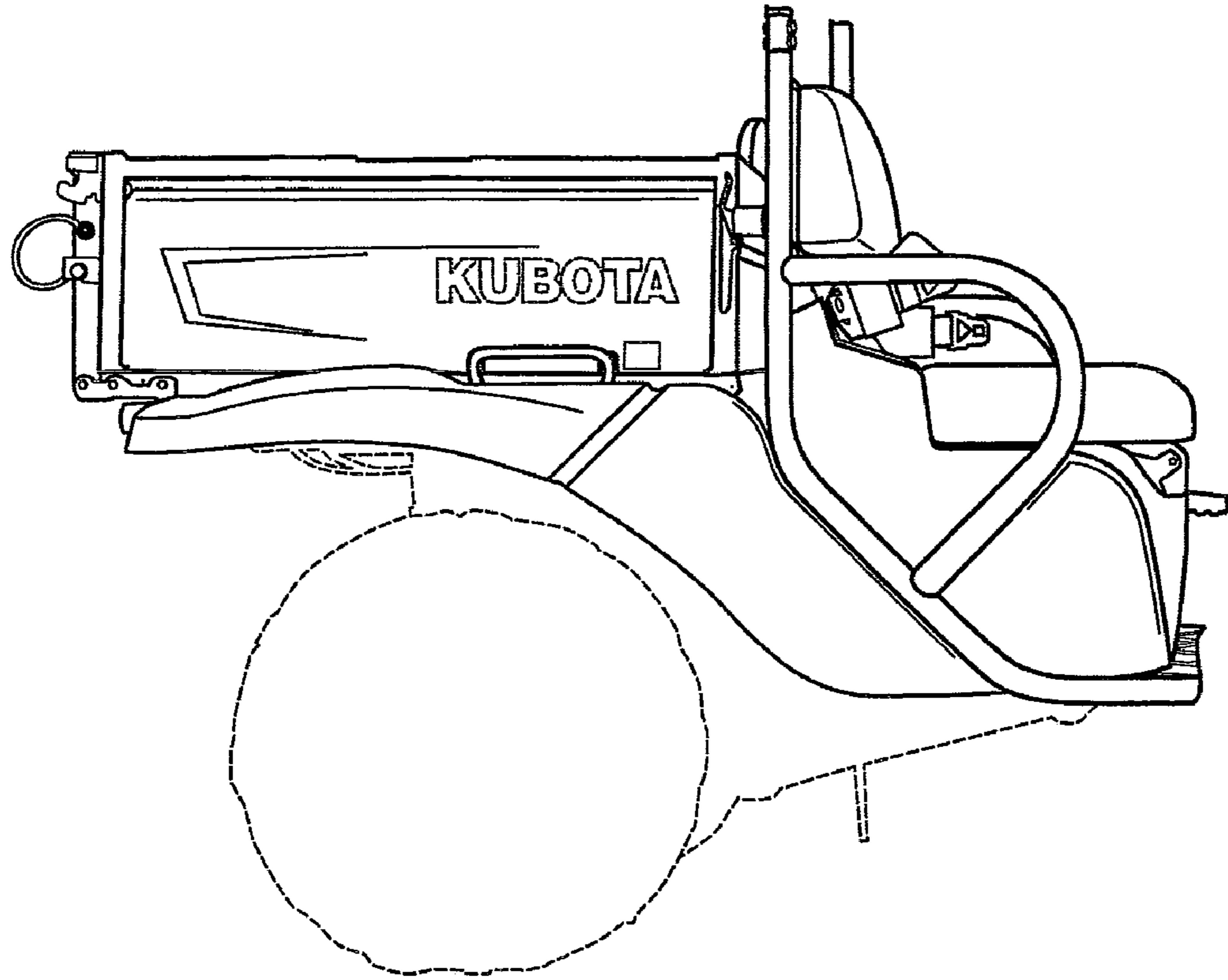

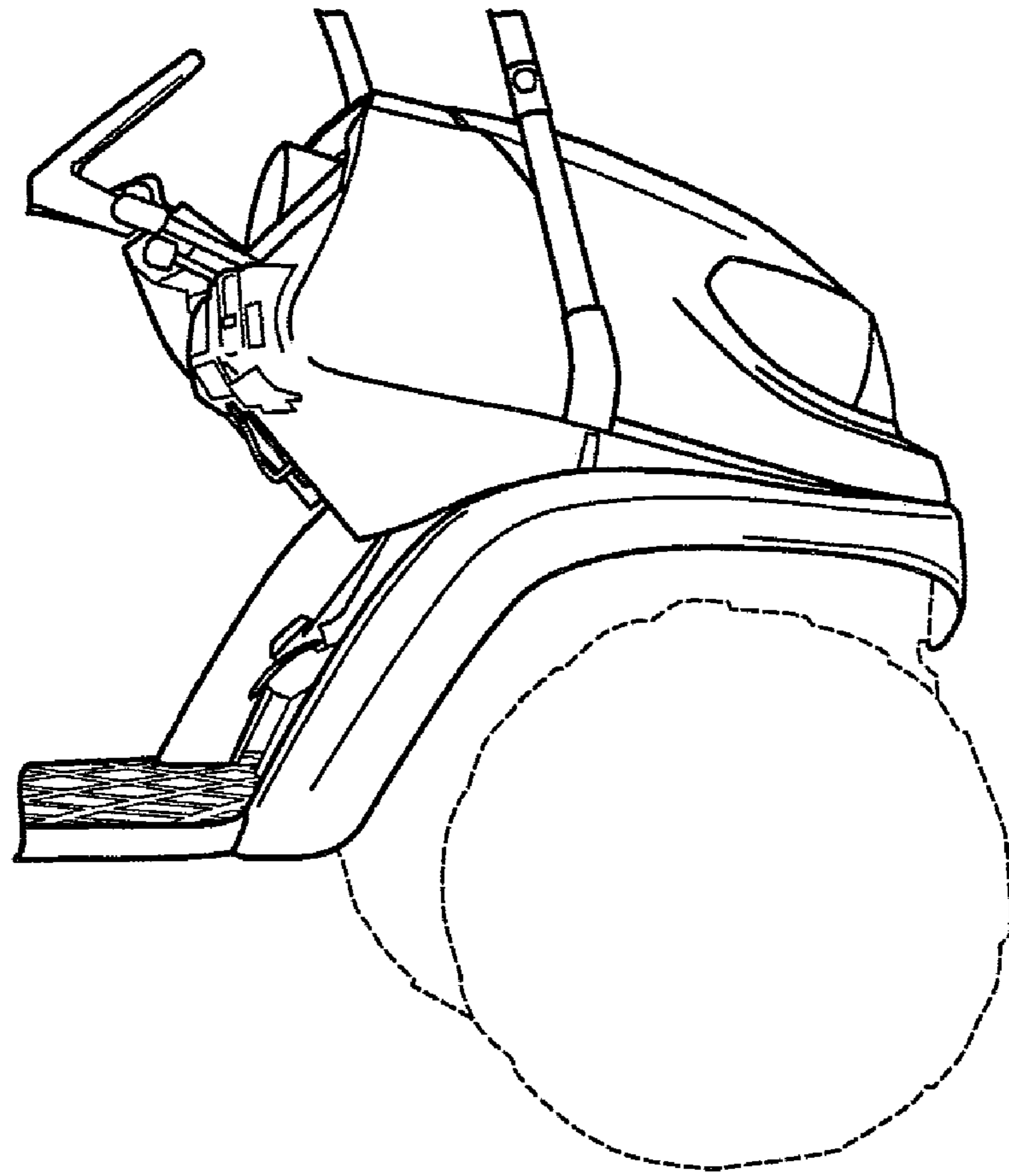
