The ornamental design for a miniature personal computer base, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing a preferred embodiment of a miniature personal computer base showing our new design;

FIG. 2 is a front side view of a preferred embodiment of the miniature personal computer of FIG. 1;

FIG. 3 is a rear side view of a preferred embodiment of the miniature personal computer of FIG. 1;

FIG. 4 is a top plan view of a preferred embodiment of the miniature personal computer of FIG. 1;

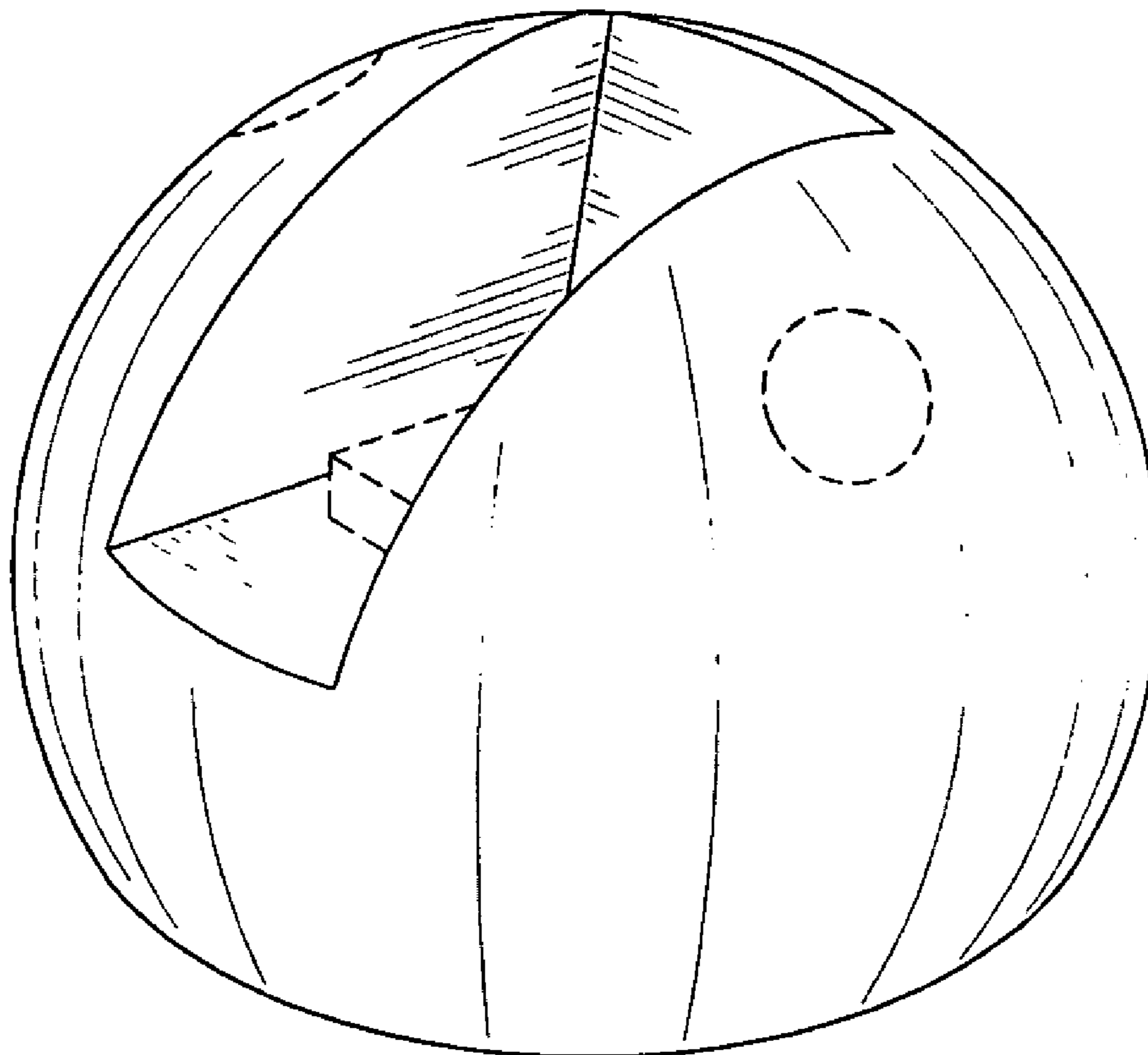
FIG. 5 is a bottom plan view of a preferred embodiment of the miniature personal computer of FIG. 1;

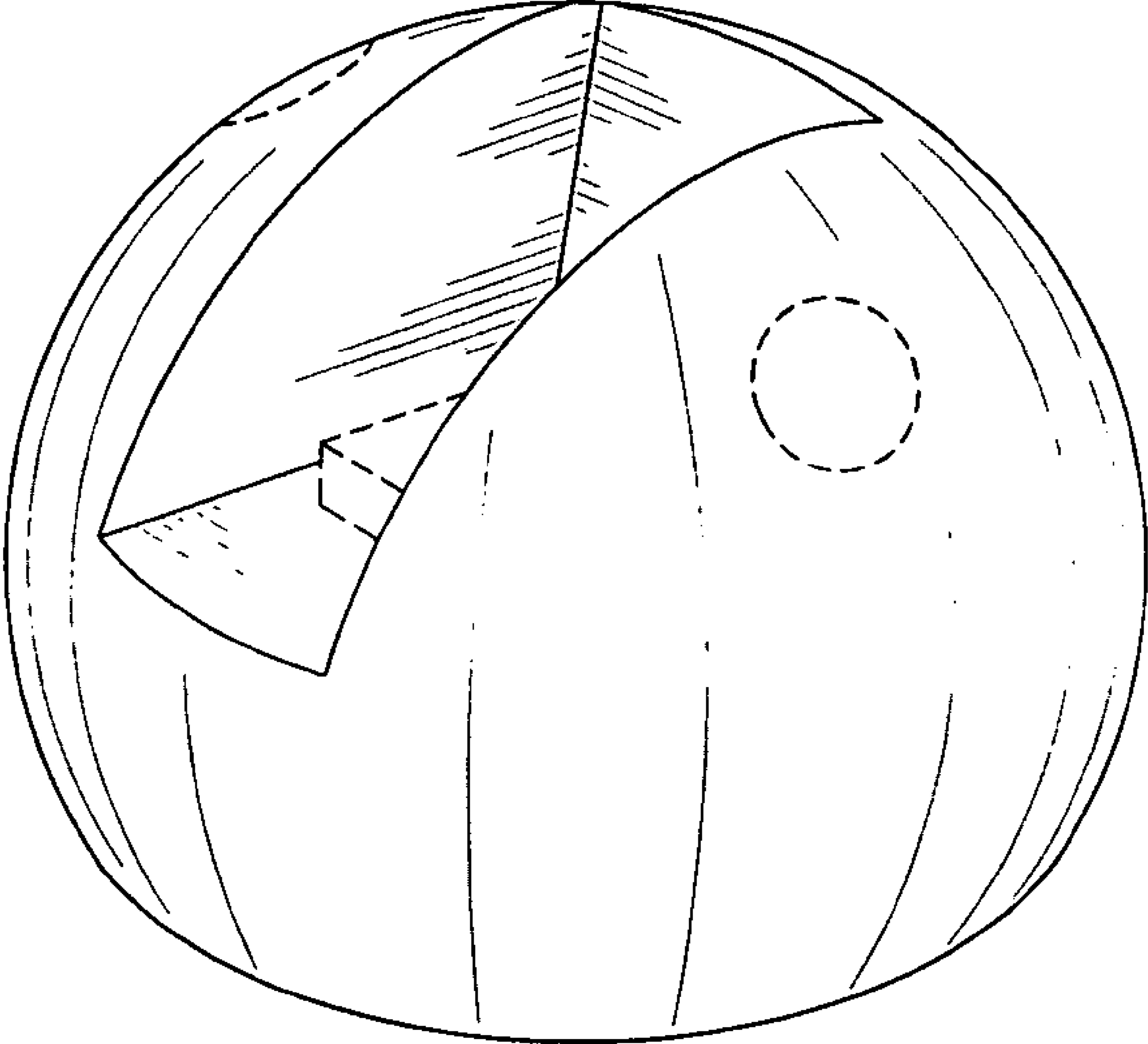

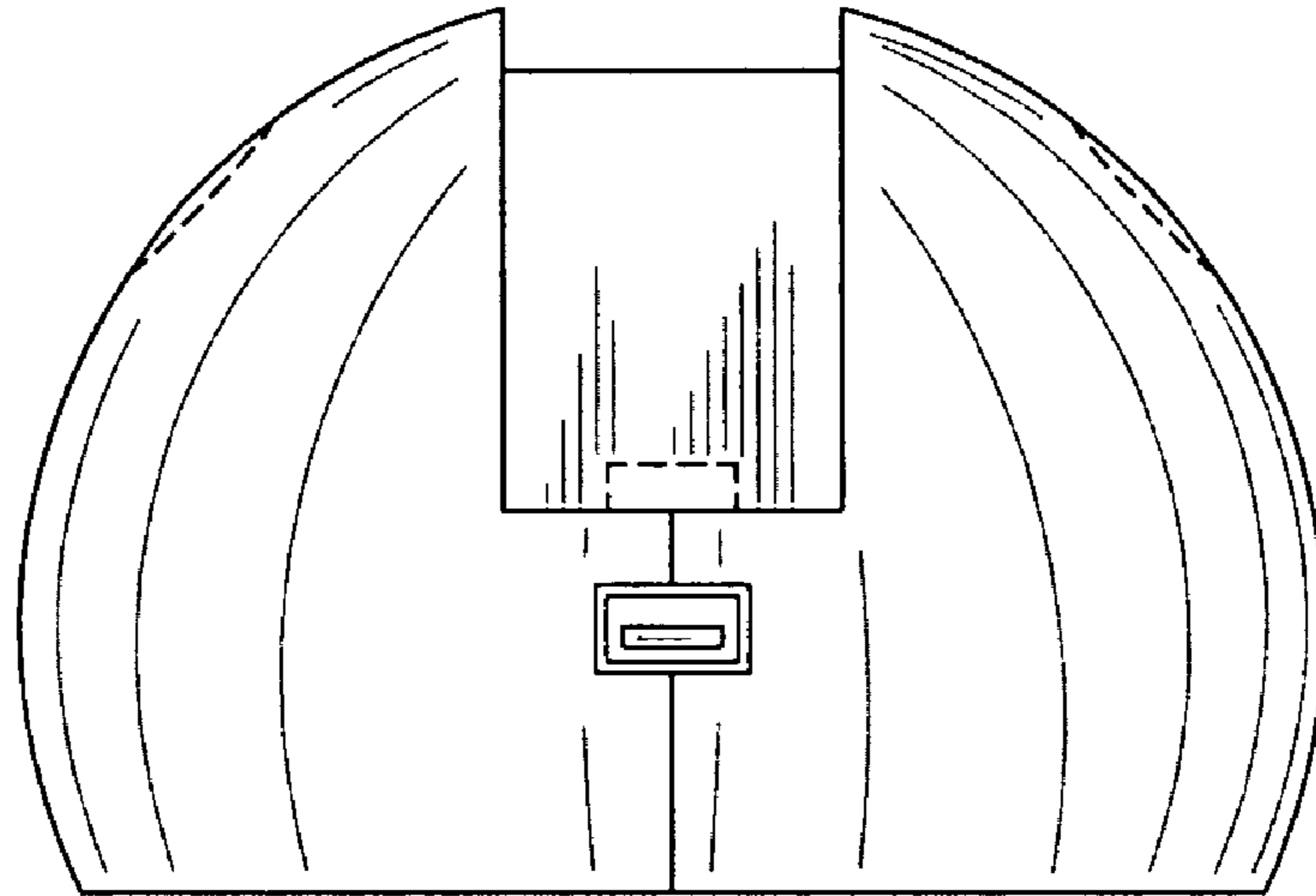

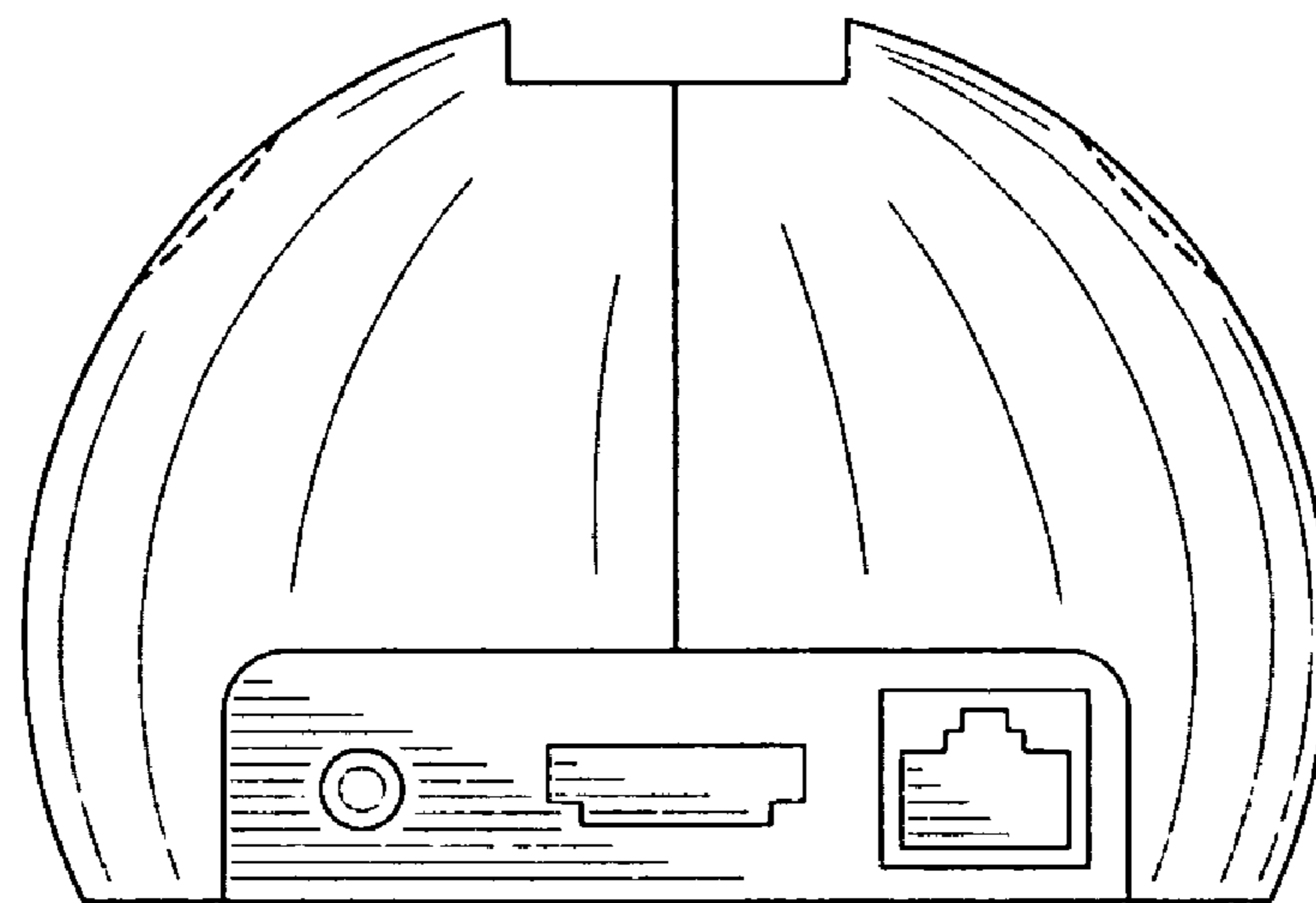

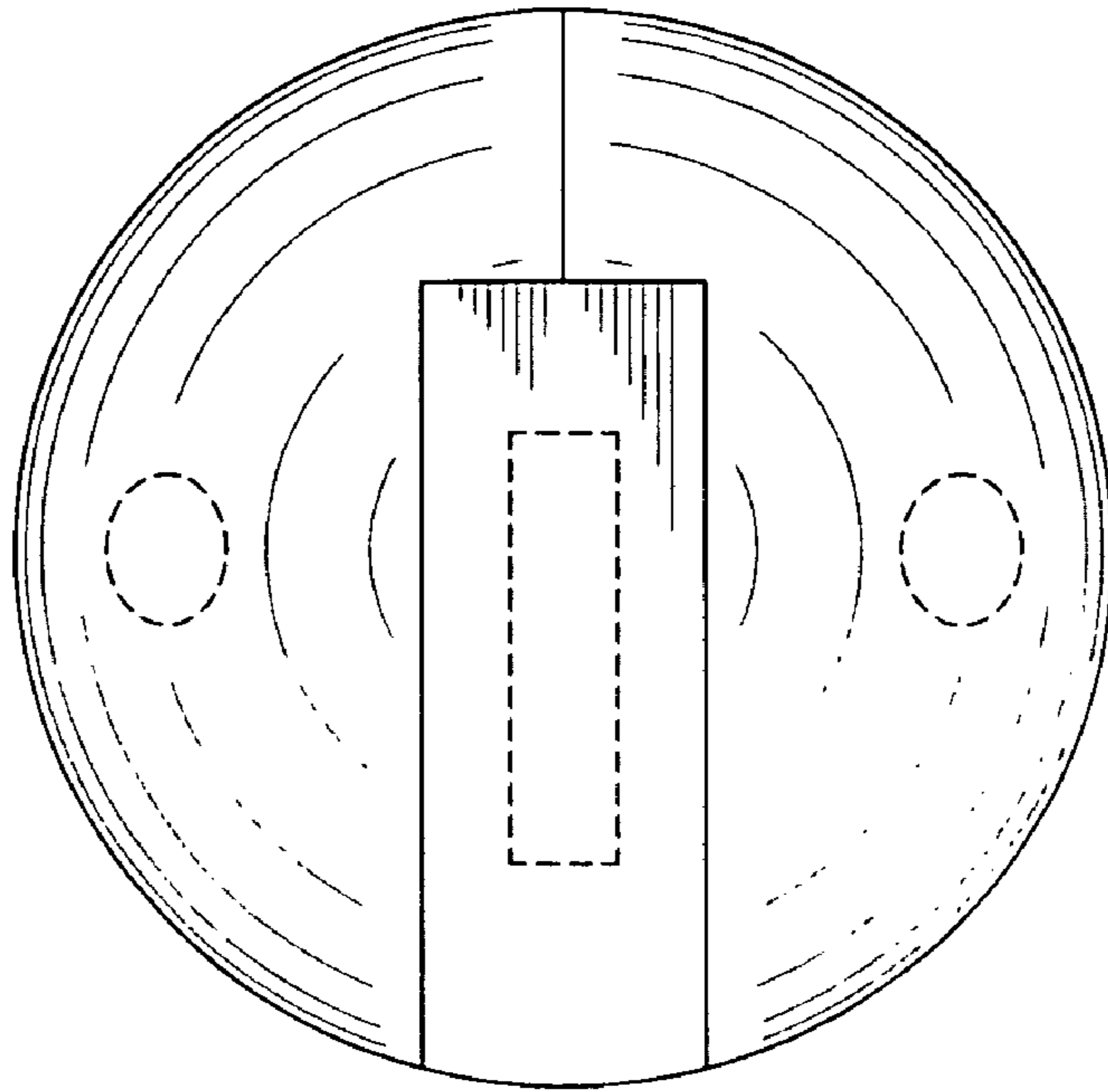

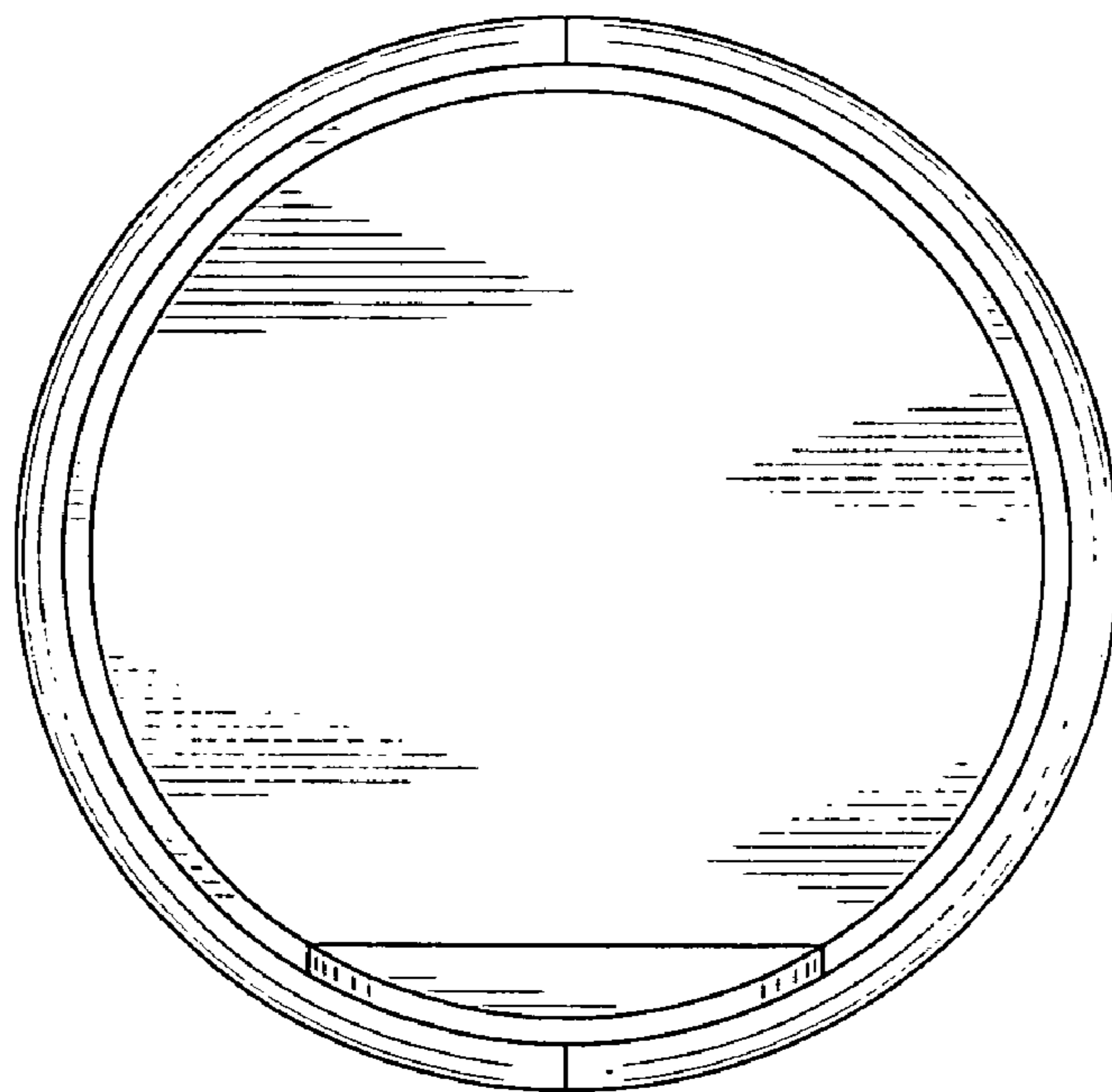

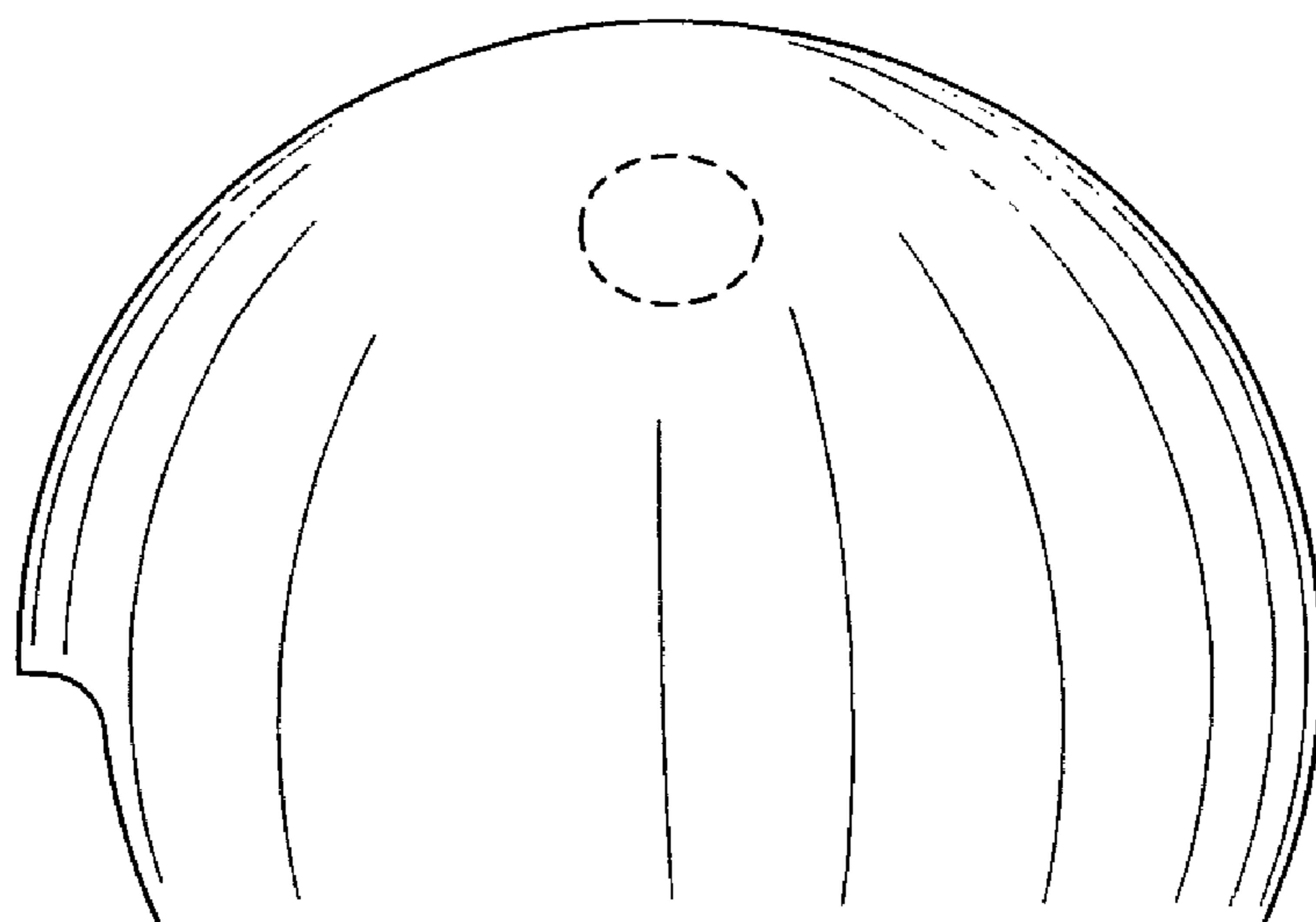

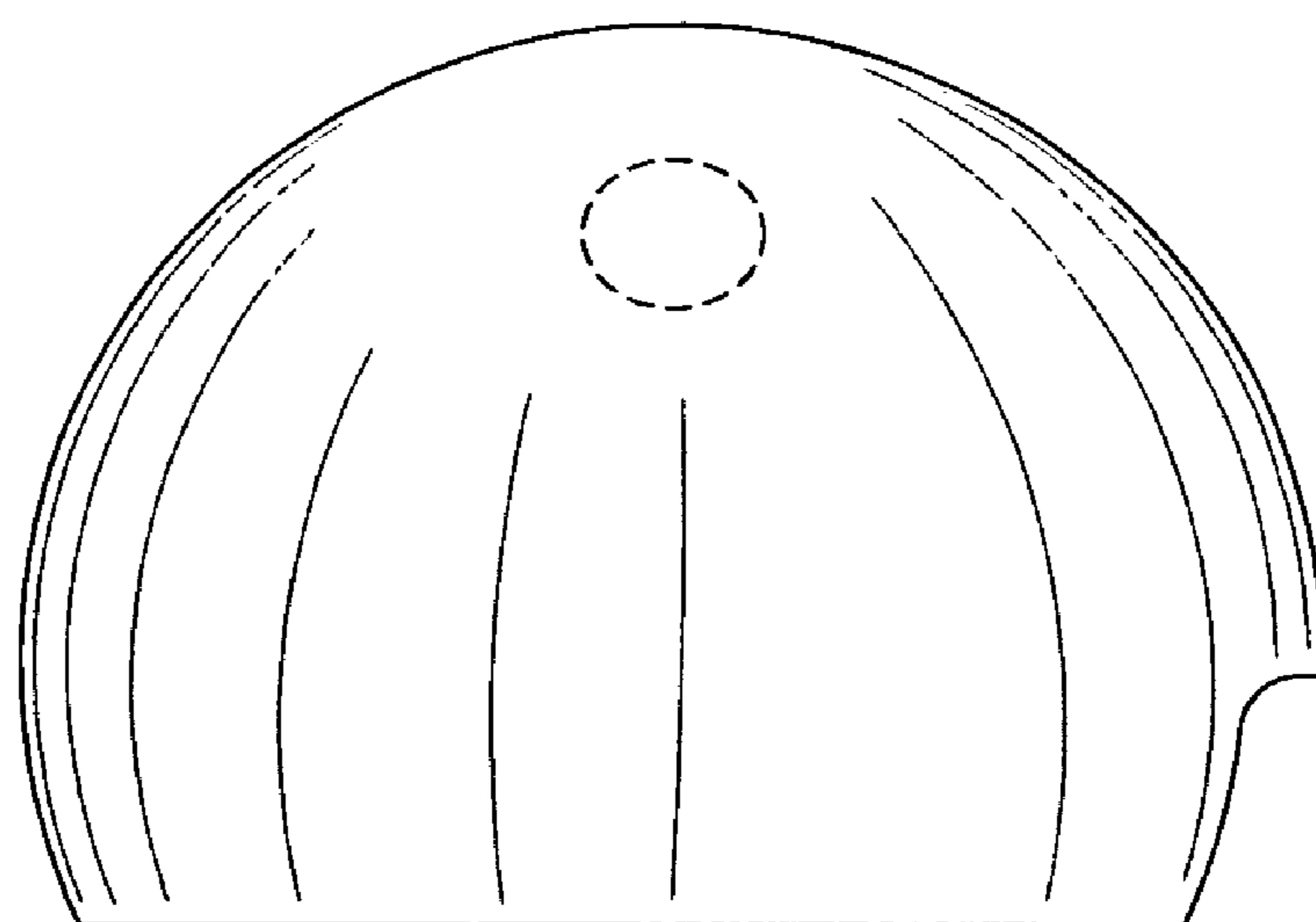
