tising monitors, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a point of sale terminal  
with advertising monitors;

FIG. 2 is a front elevation view thereof;

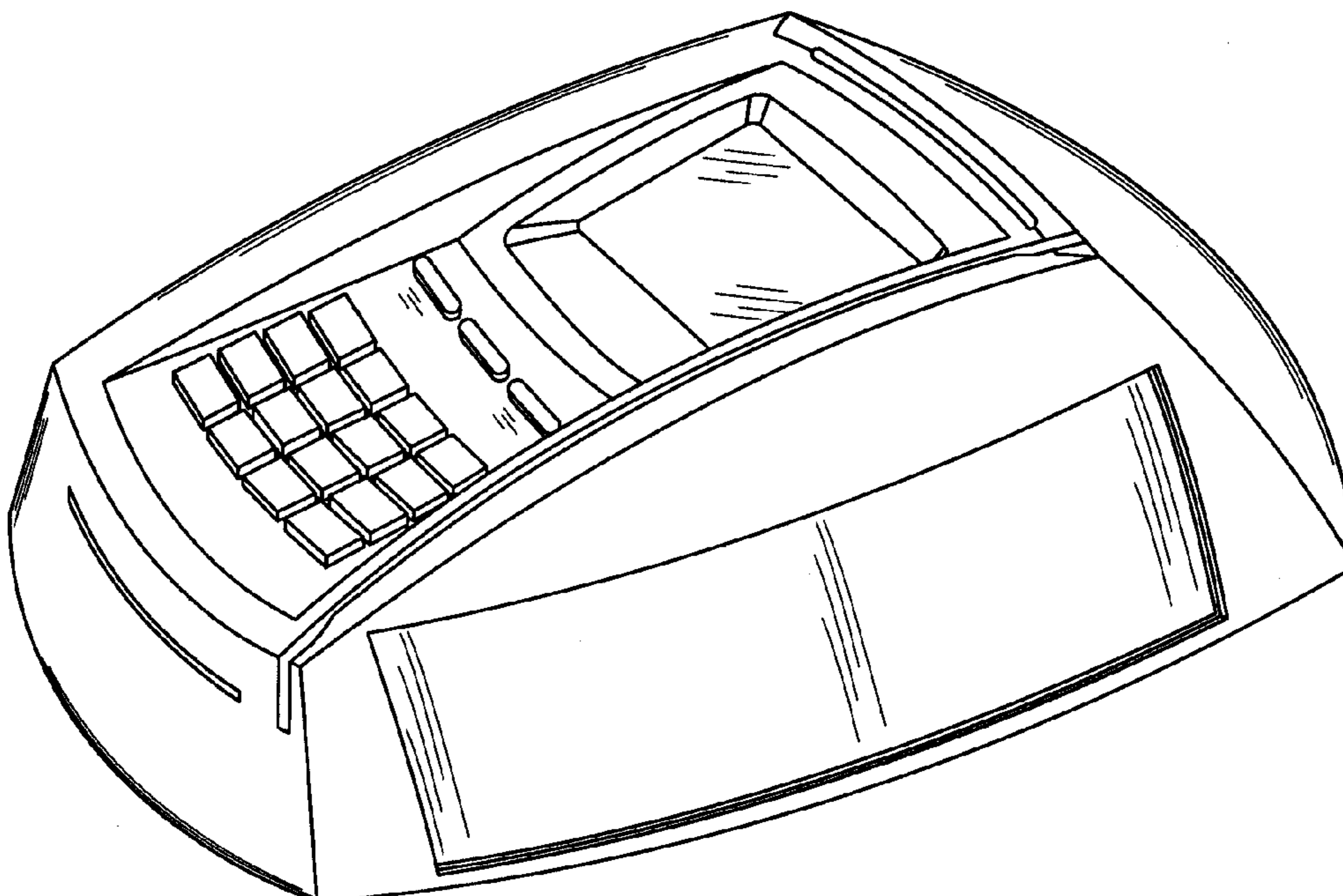
FIG. 3 is a left side elevation view thereof;

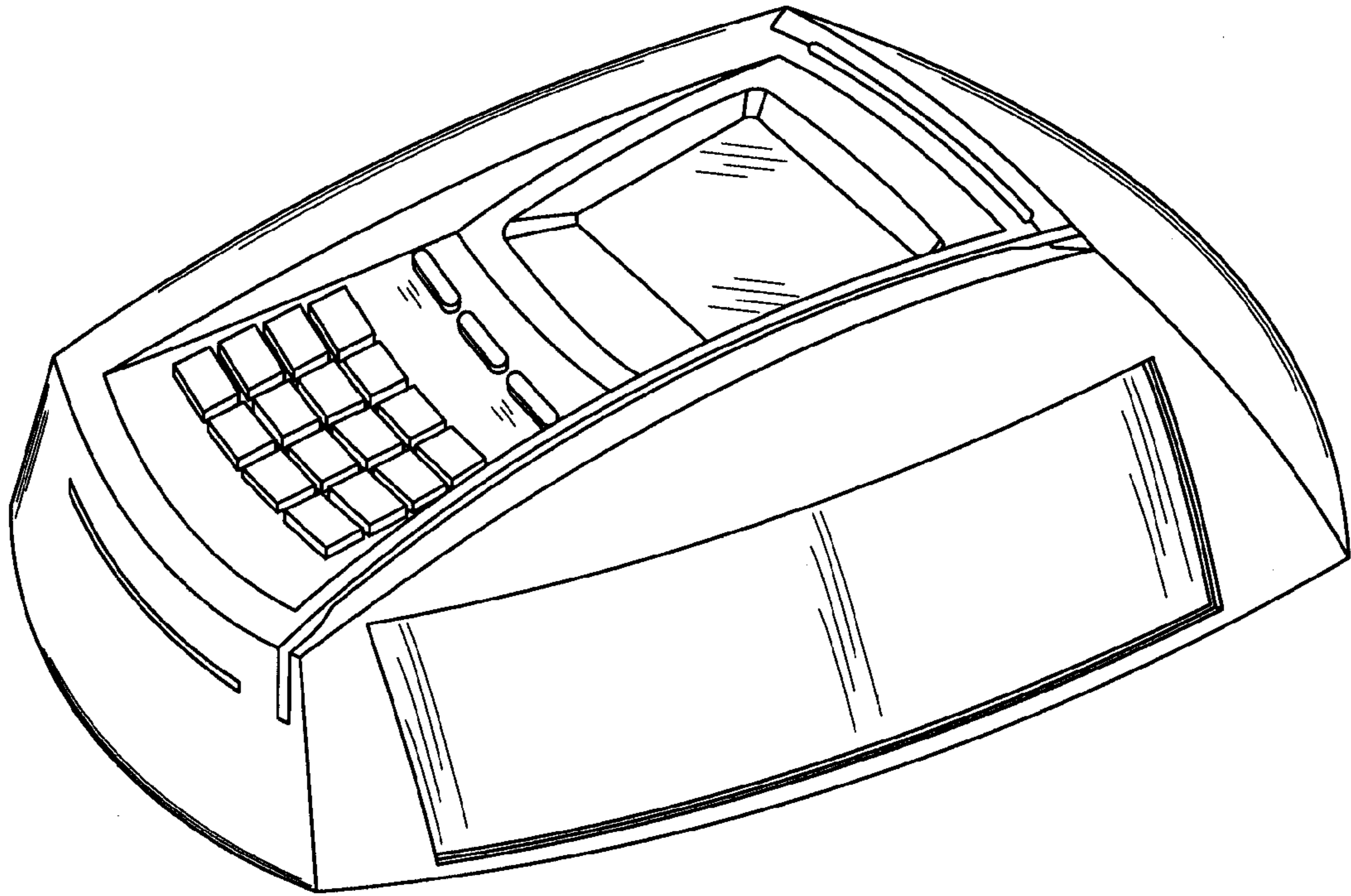

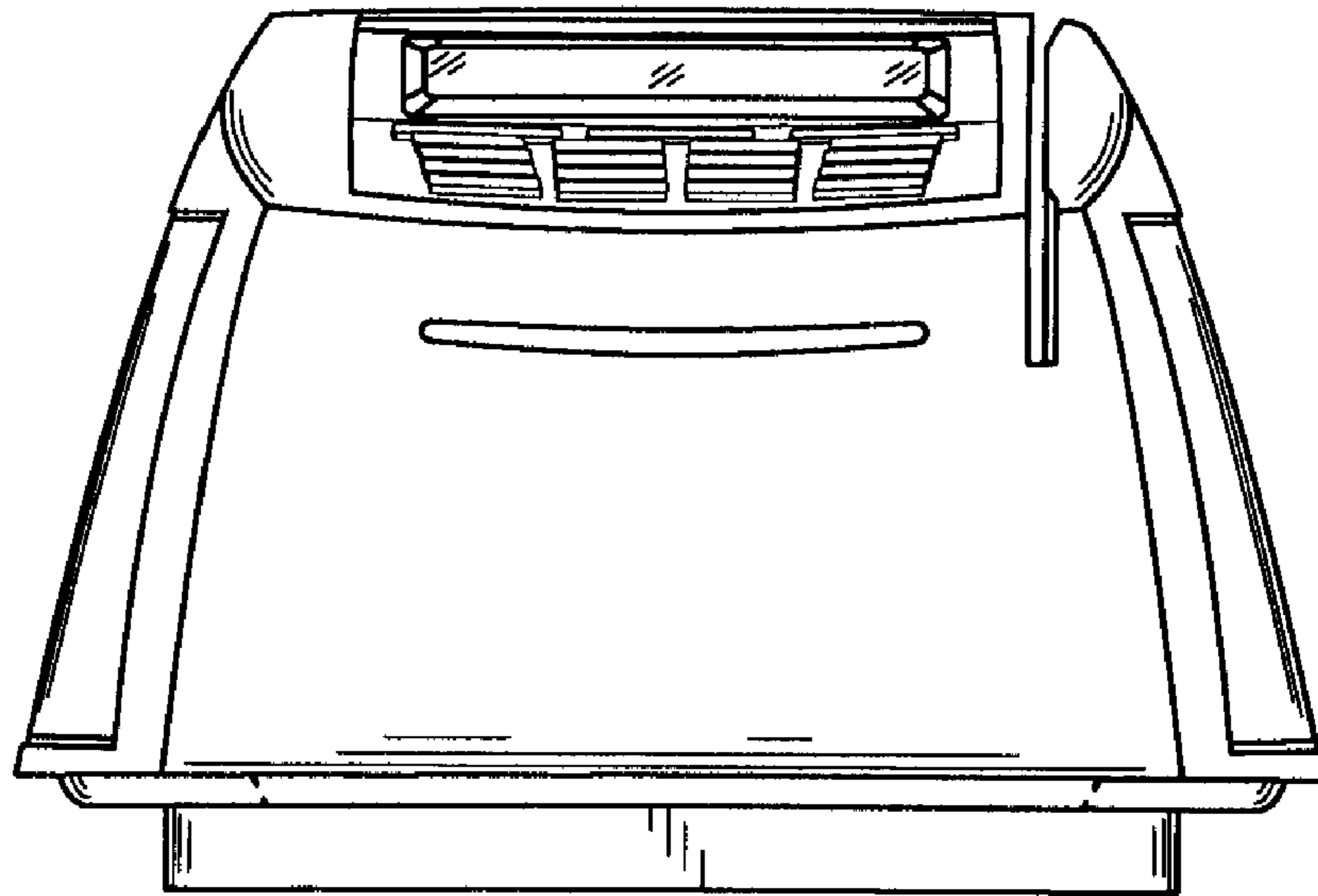

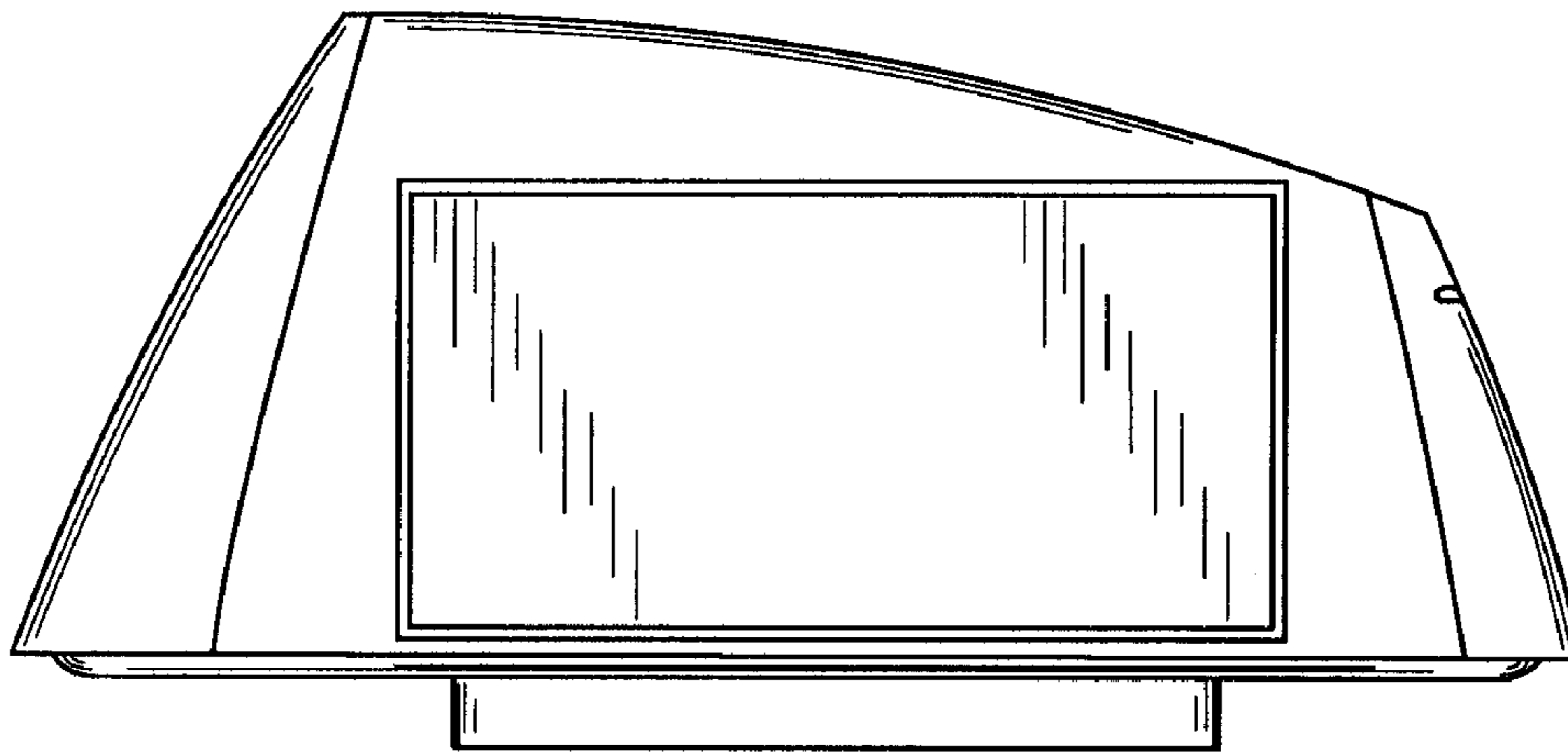

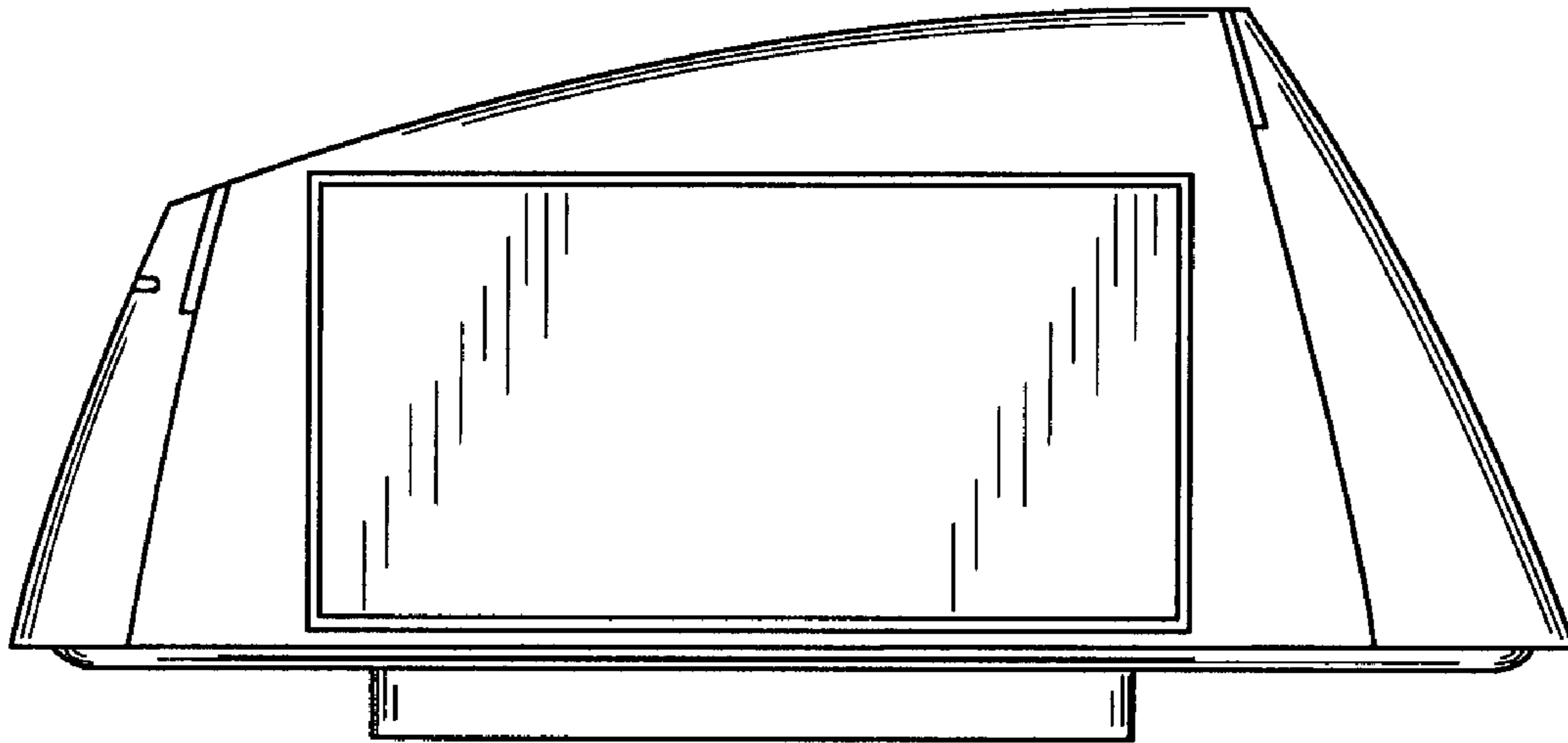

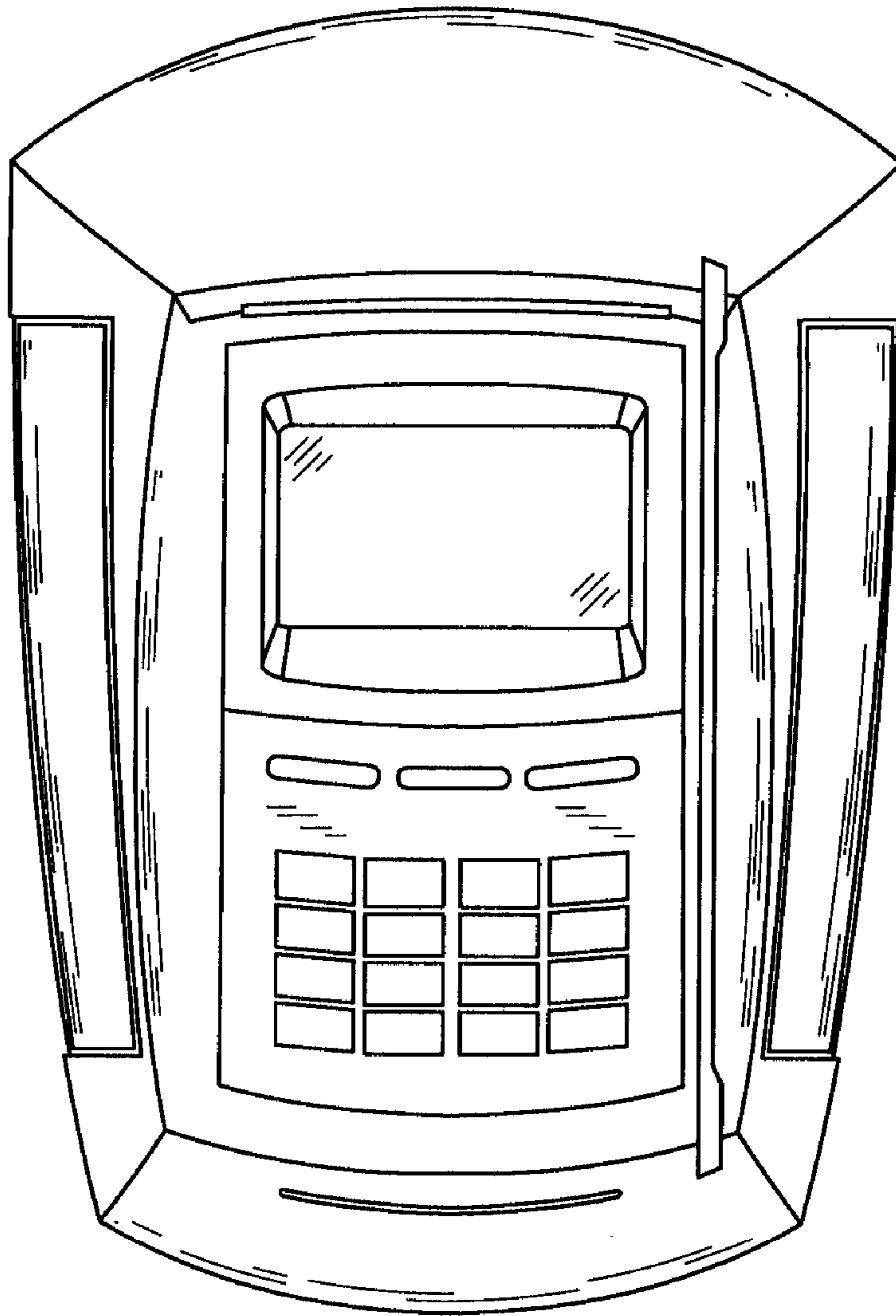
