FIG. 3 is a rear view of the flapper disc design of the present invention;

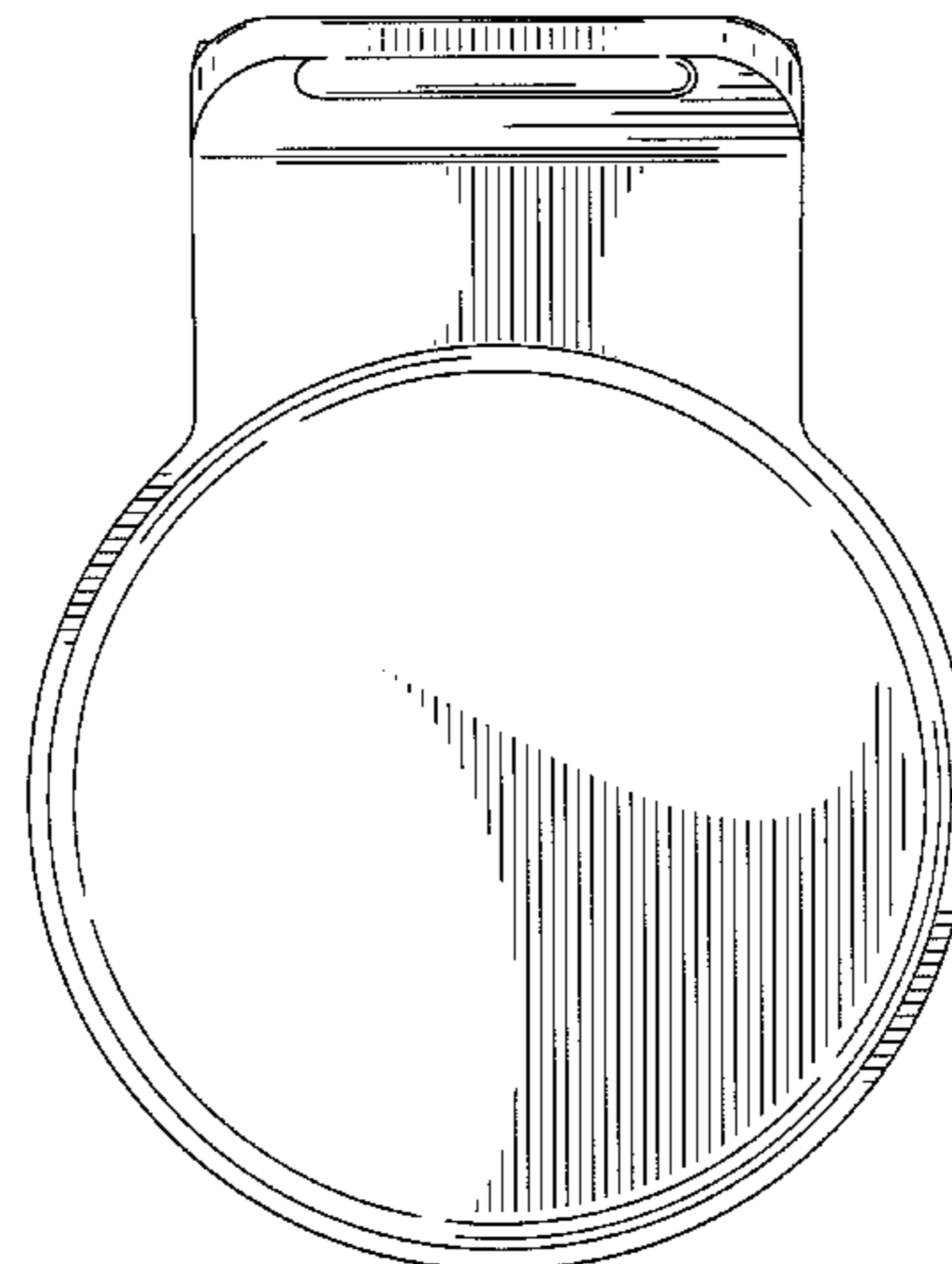
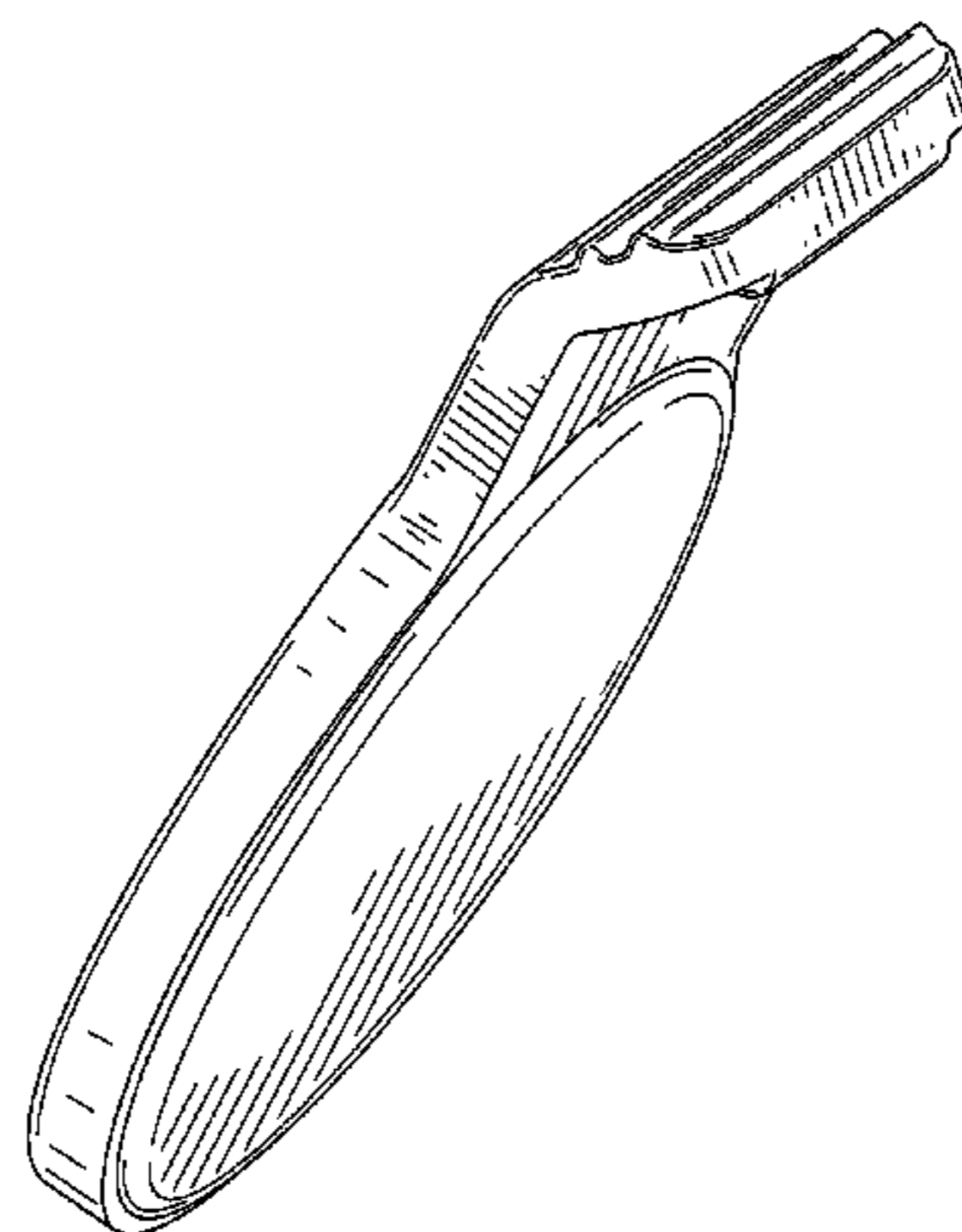
FIG. 4 is a side view of the flapper disc design of the present invention;

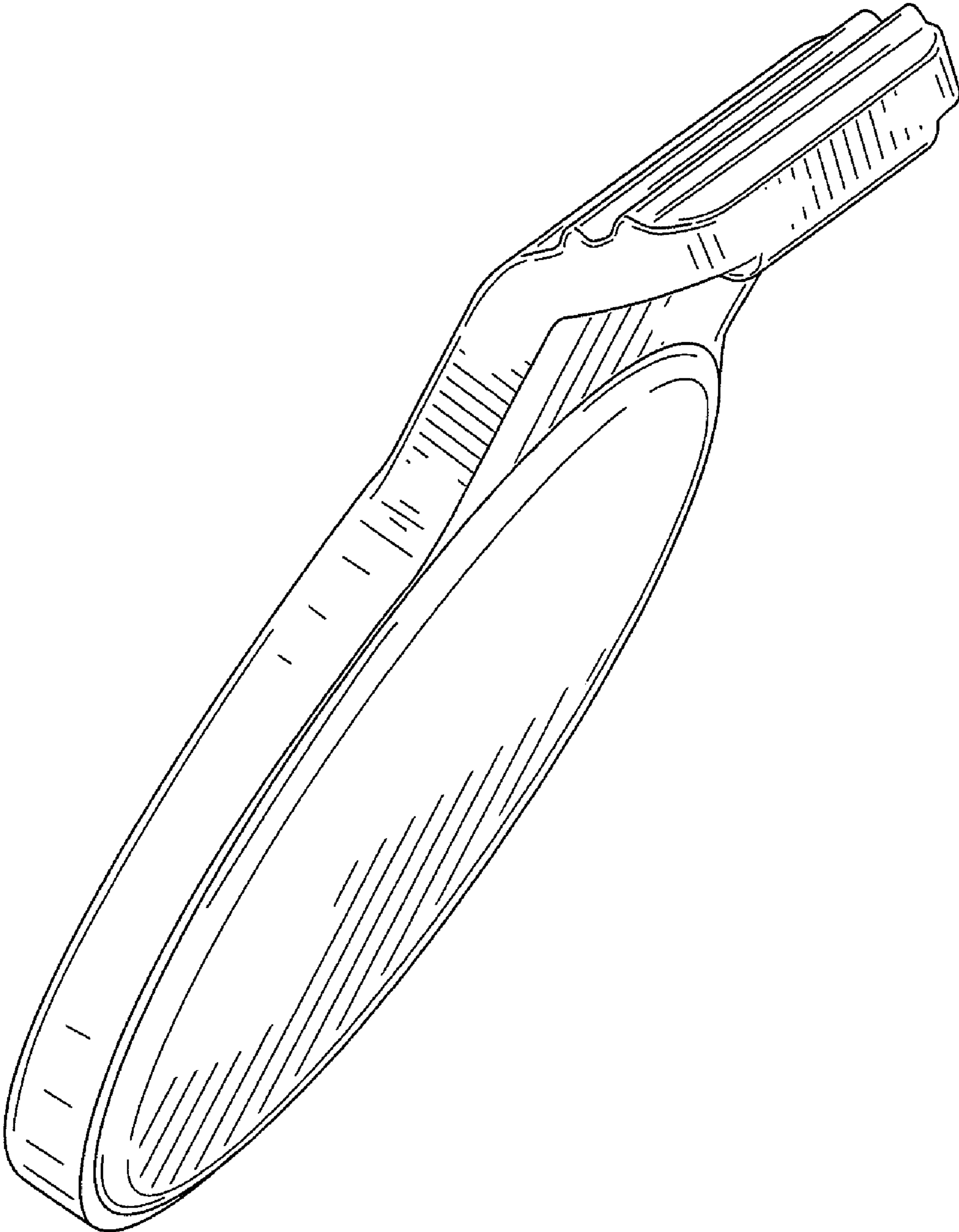

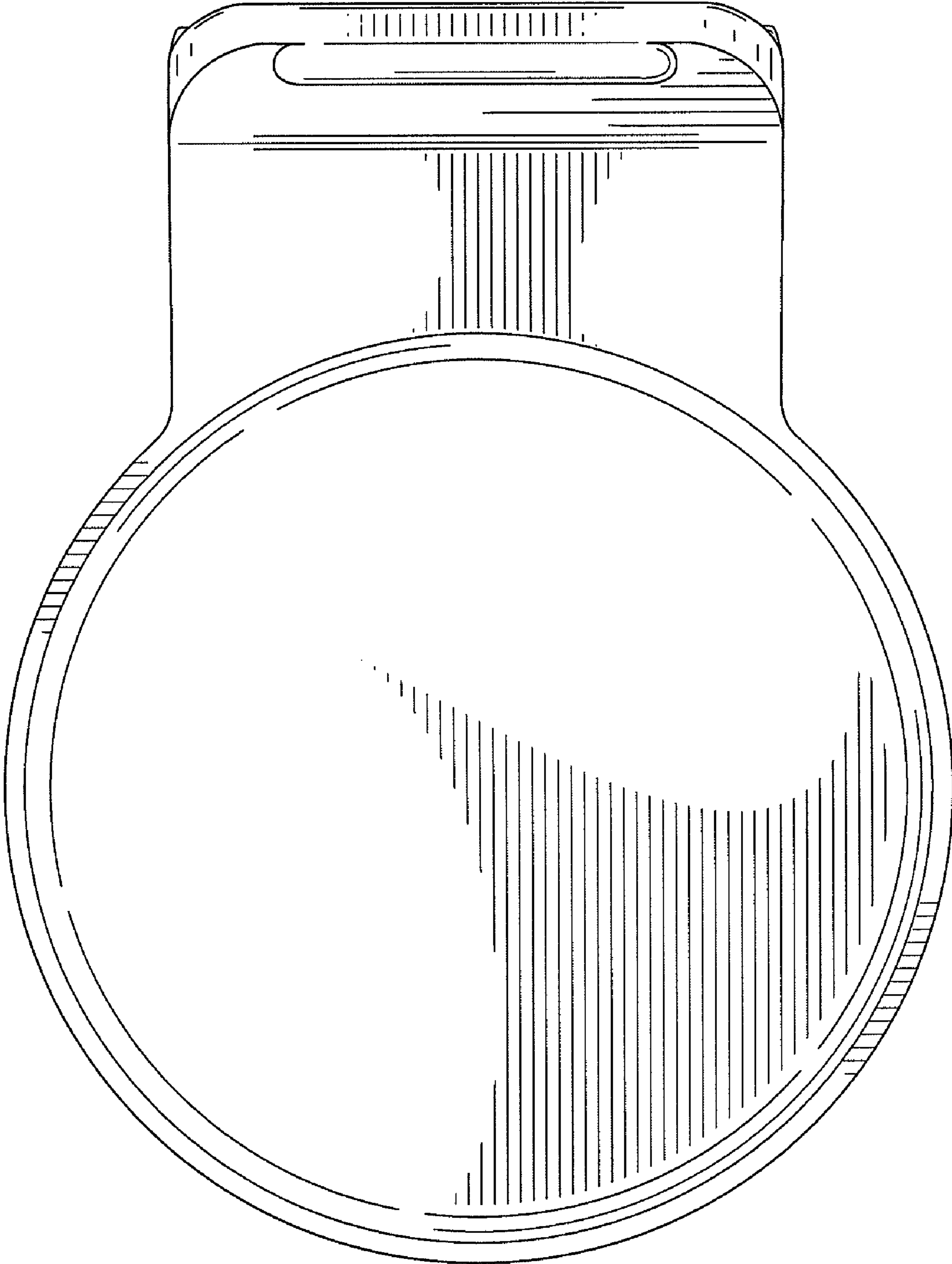

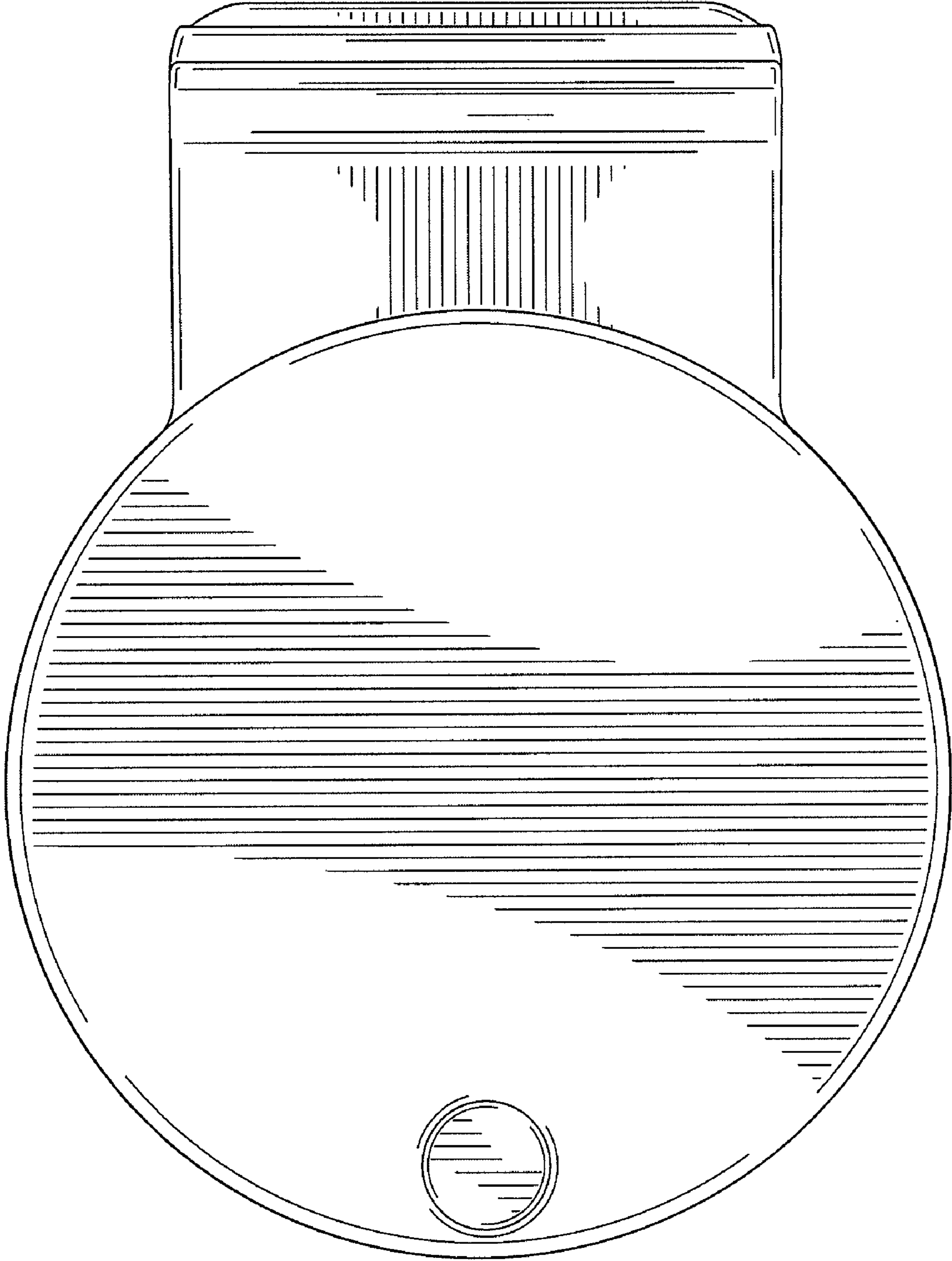

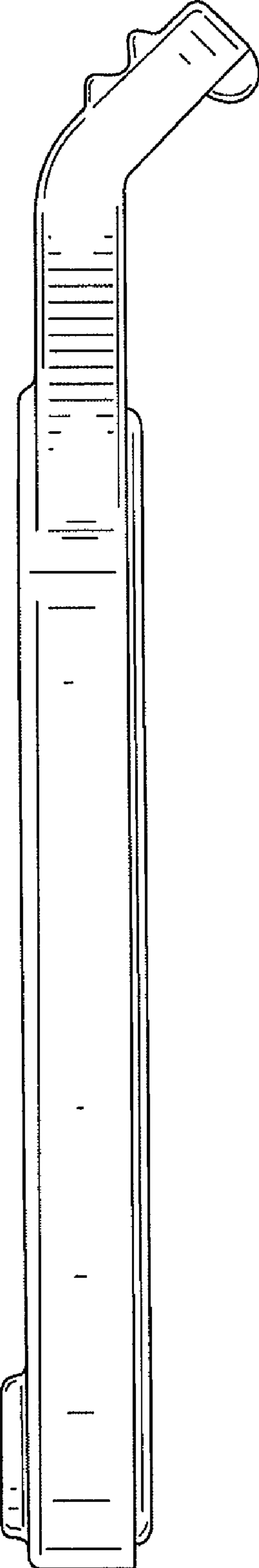

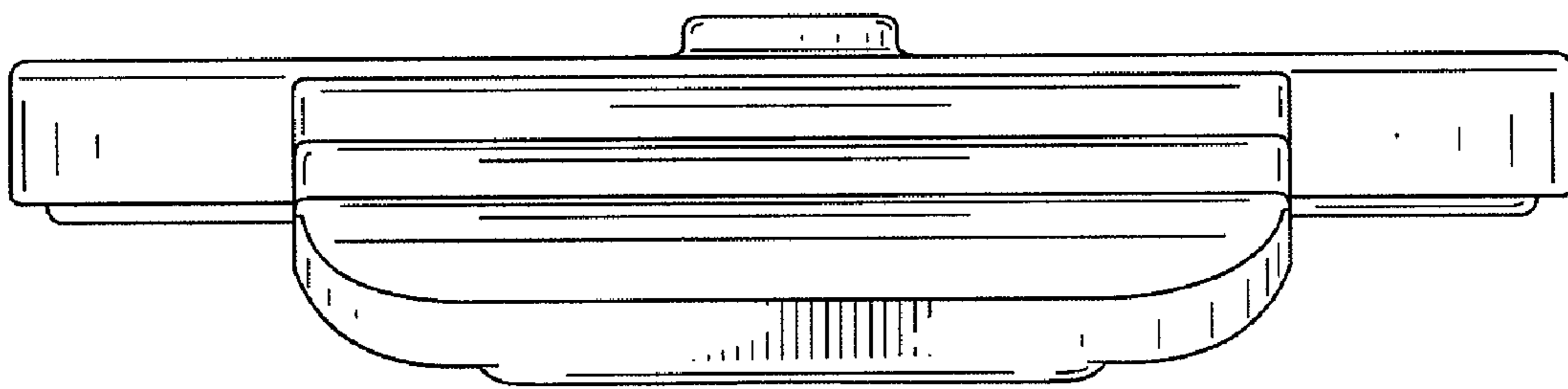

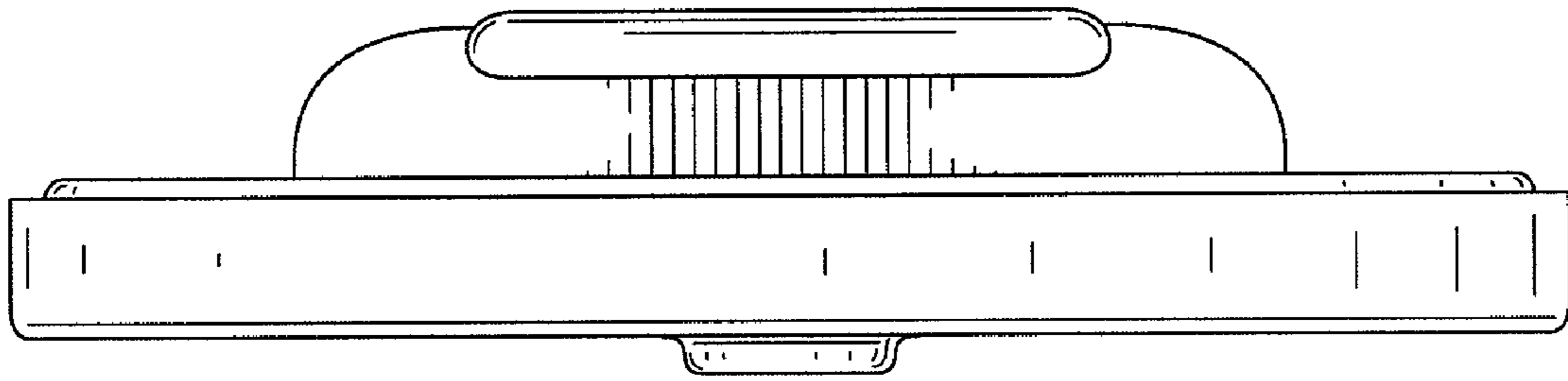

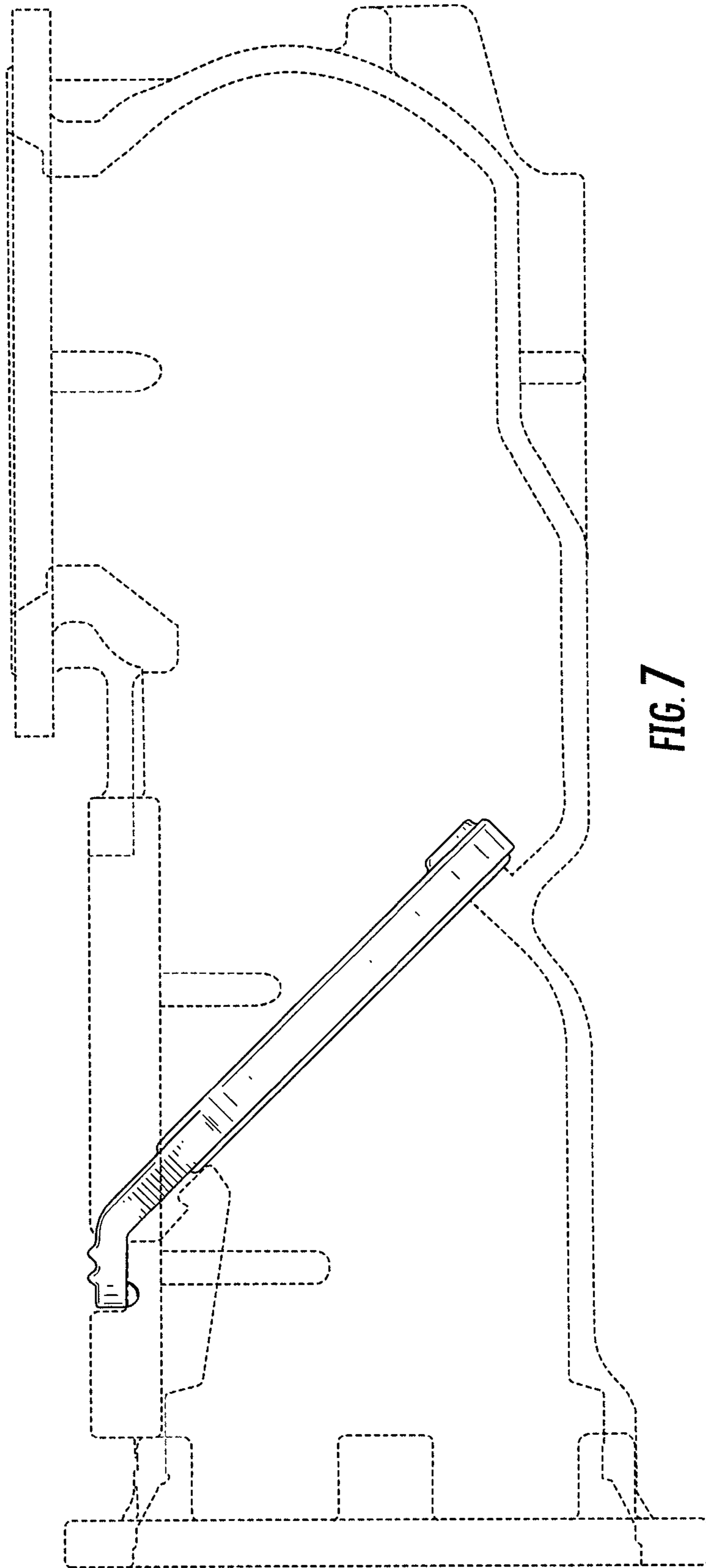
