(57) **CLAIM**

We claim the ornamental design for a flexible ribbed pipe coupling, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of our design for a flexible ribbed pipe coupling;

FIG. 2 is a front view of the design for a flexible ribbed pipe coupling shown in FIG. 1, the rear view being identical;

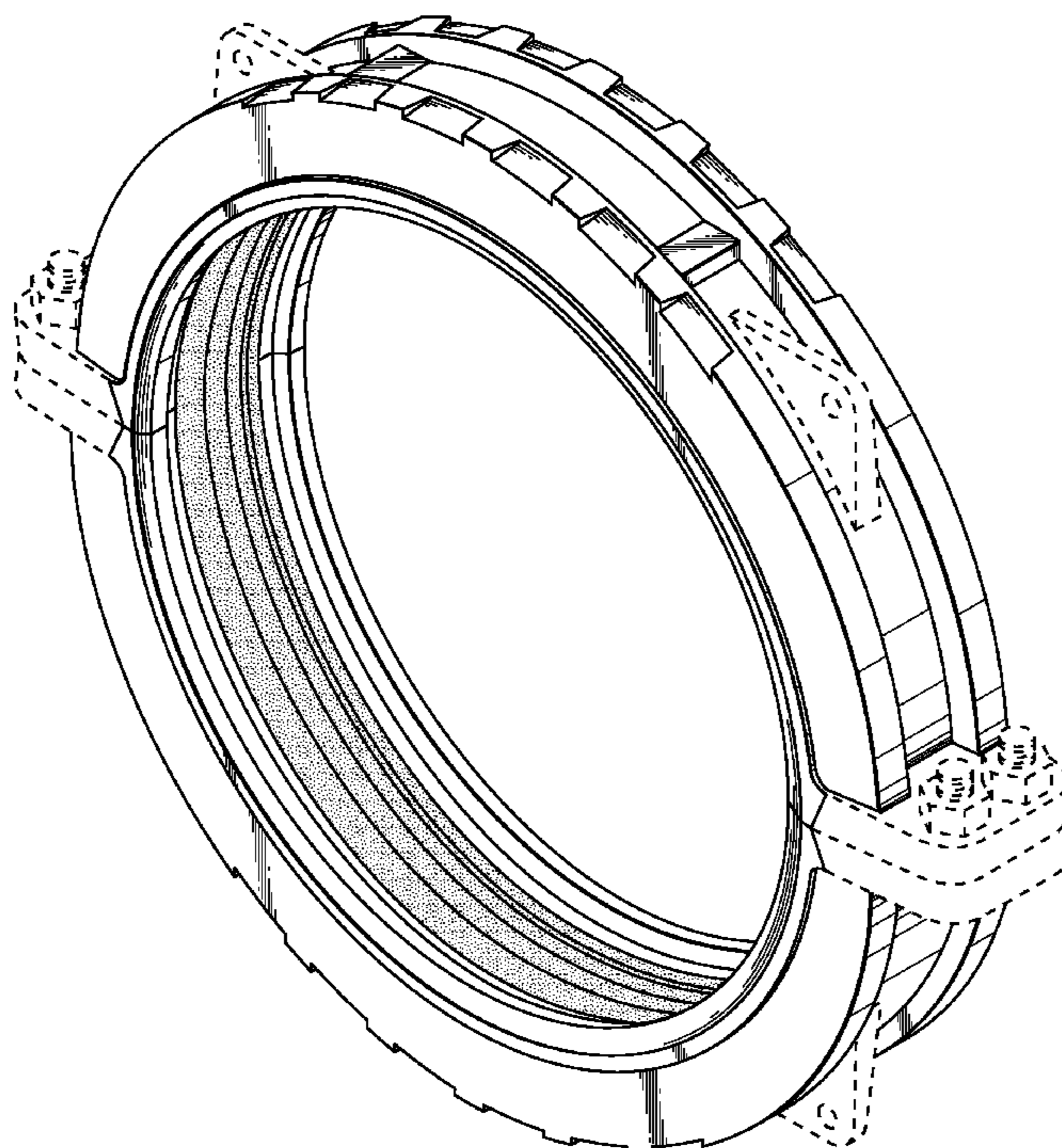
FIG. 3 is a top view of the design for a flexible ribbed pipe coupling shown in FIG. 1;

FIG. 4 is a bottom view of the design for a flexible ribbed pipe coupling shown in FIG. 1; and,

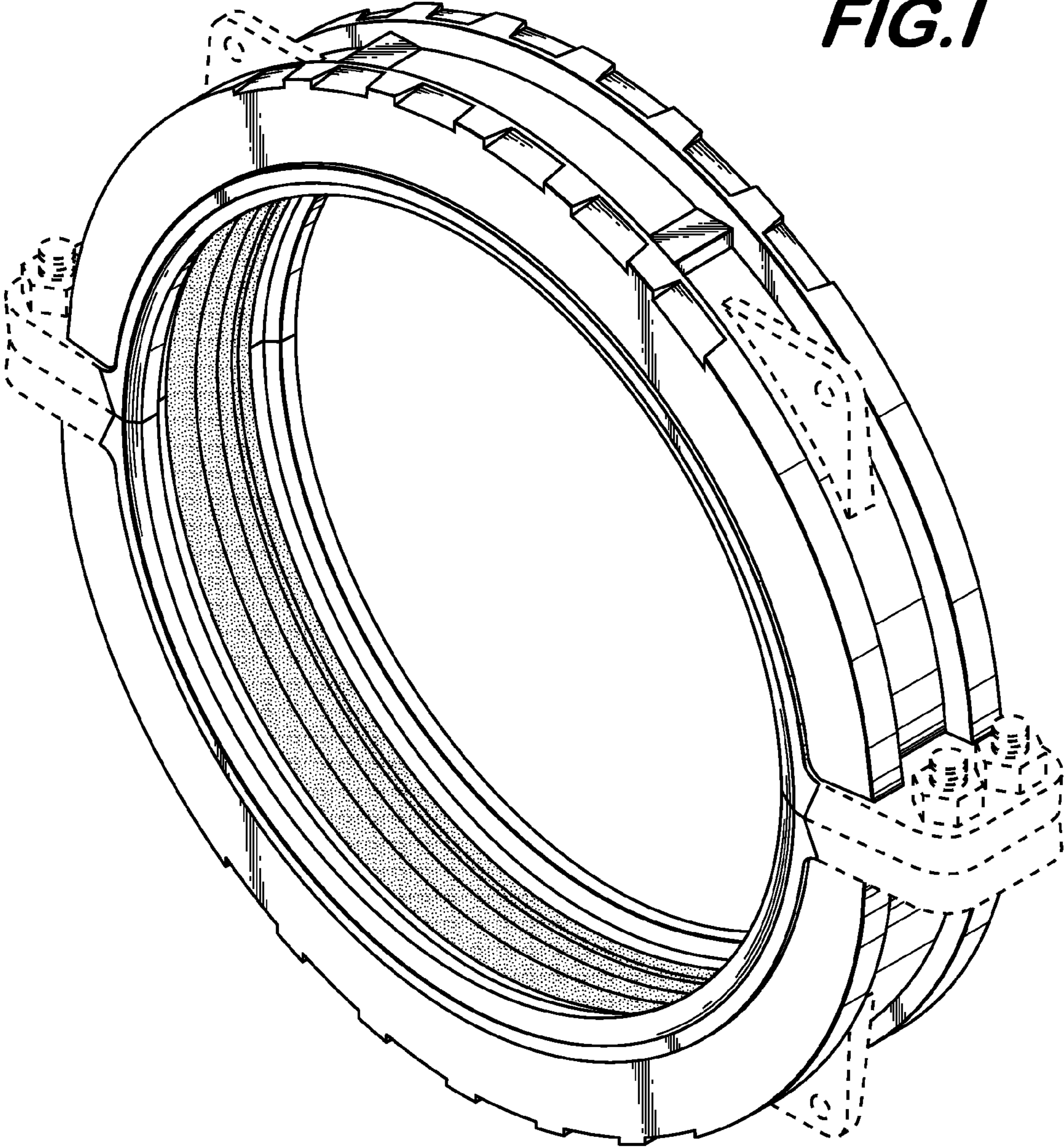
FIG. 5 is a left side view of the design for a flexible ribbed pipe coupling shown in FIG. 1, the right side view being identical.

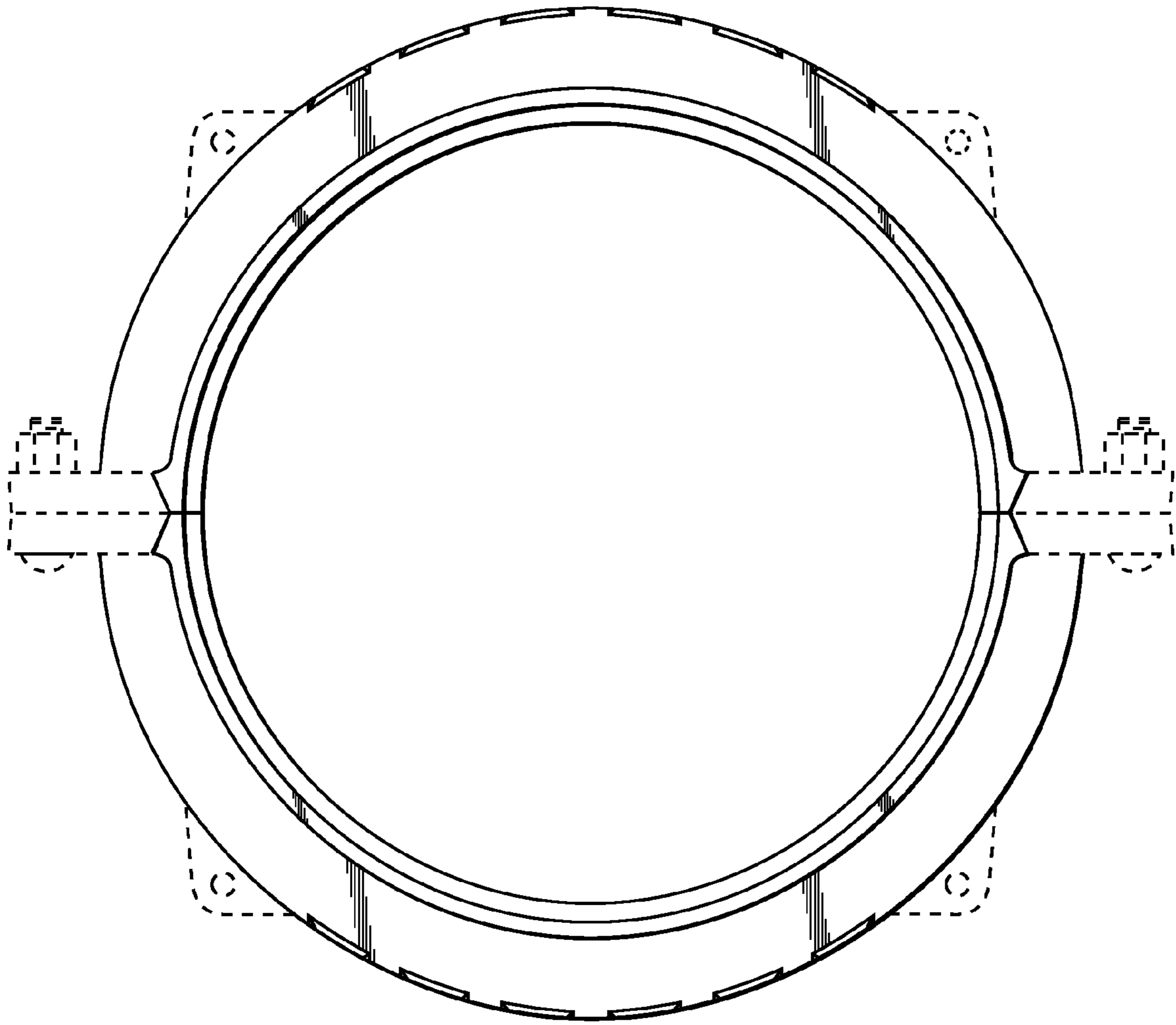
The broken lines in FIGS. 1–5 are for illustrative purposes only and form no part of the claimed design.

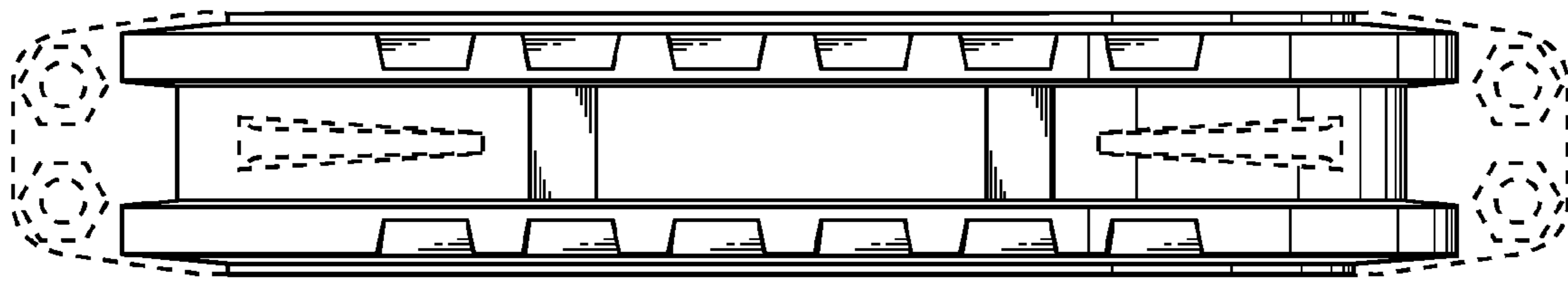

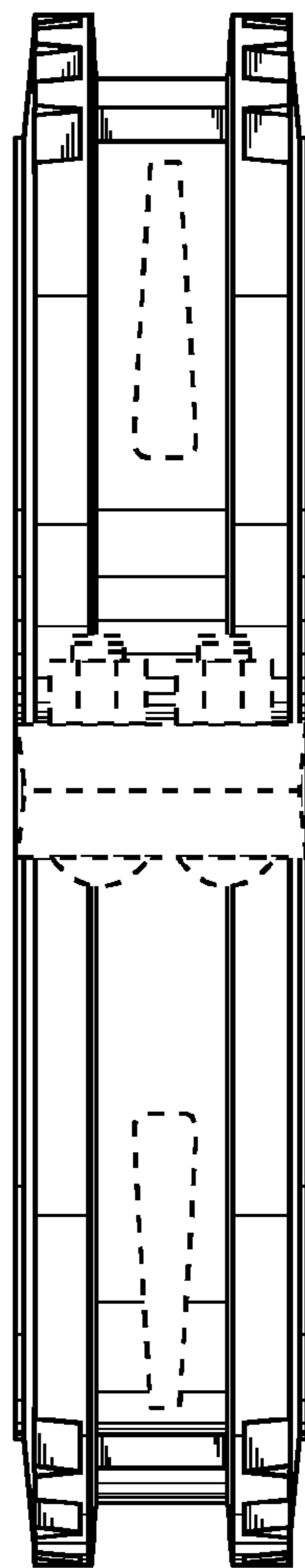
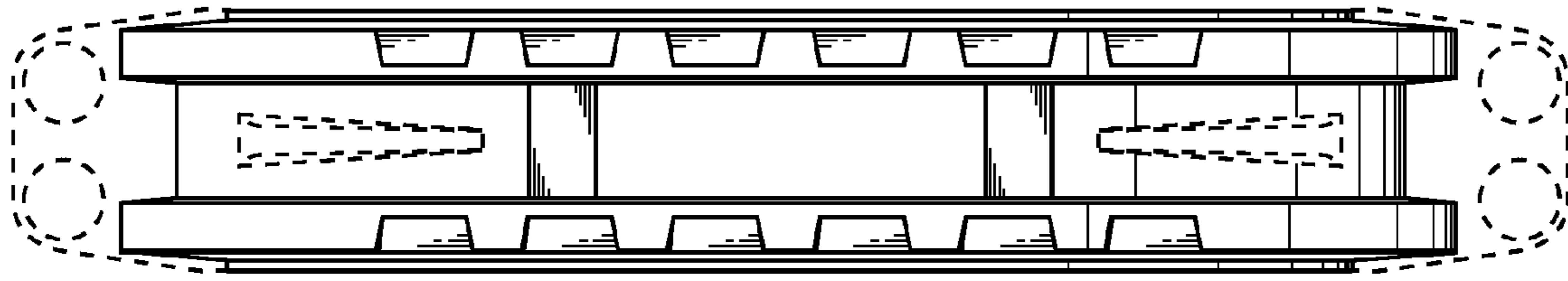
