DESCRIPTION

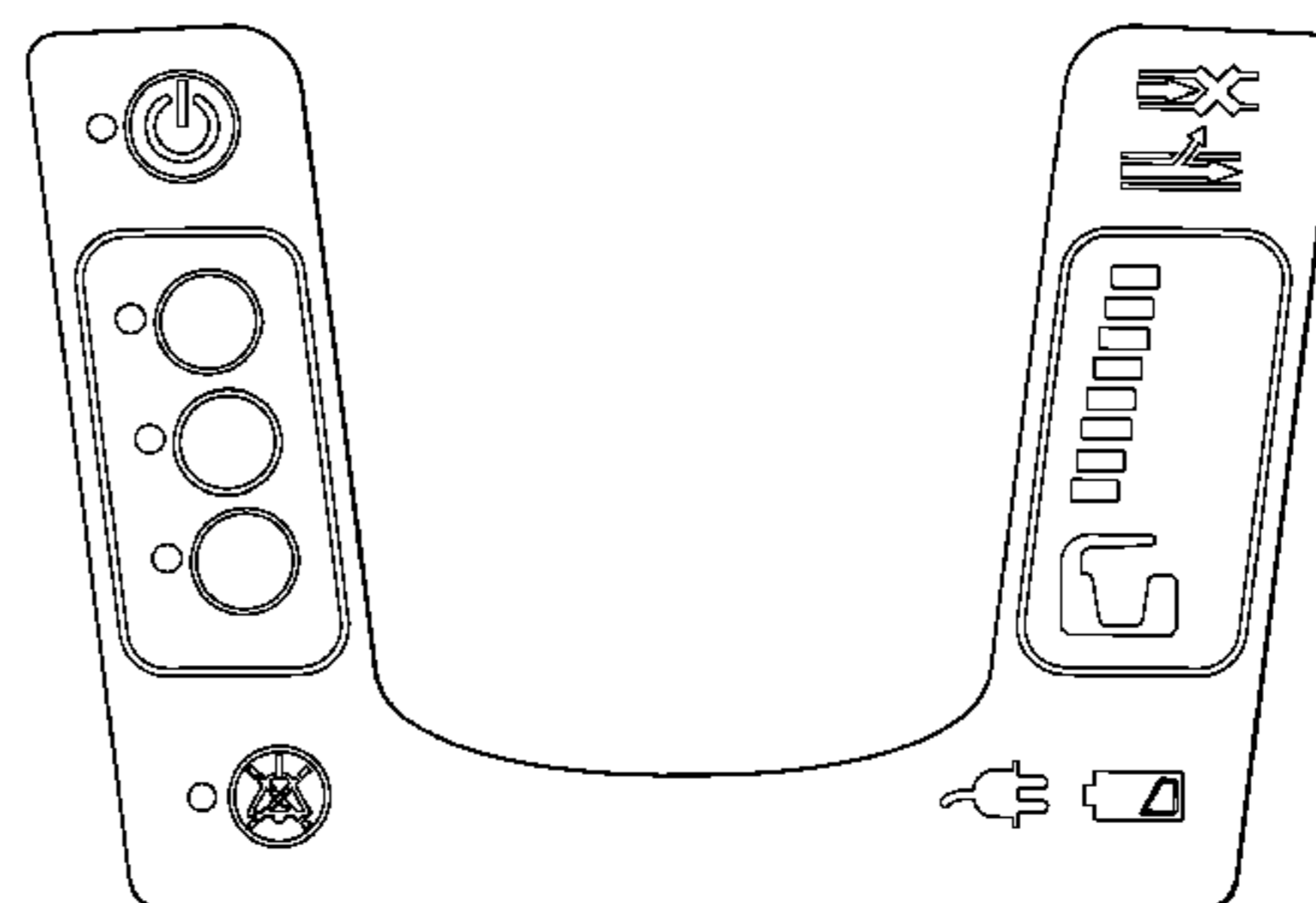
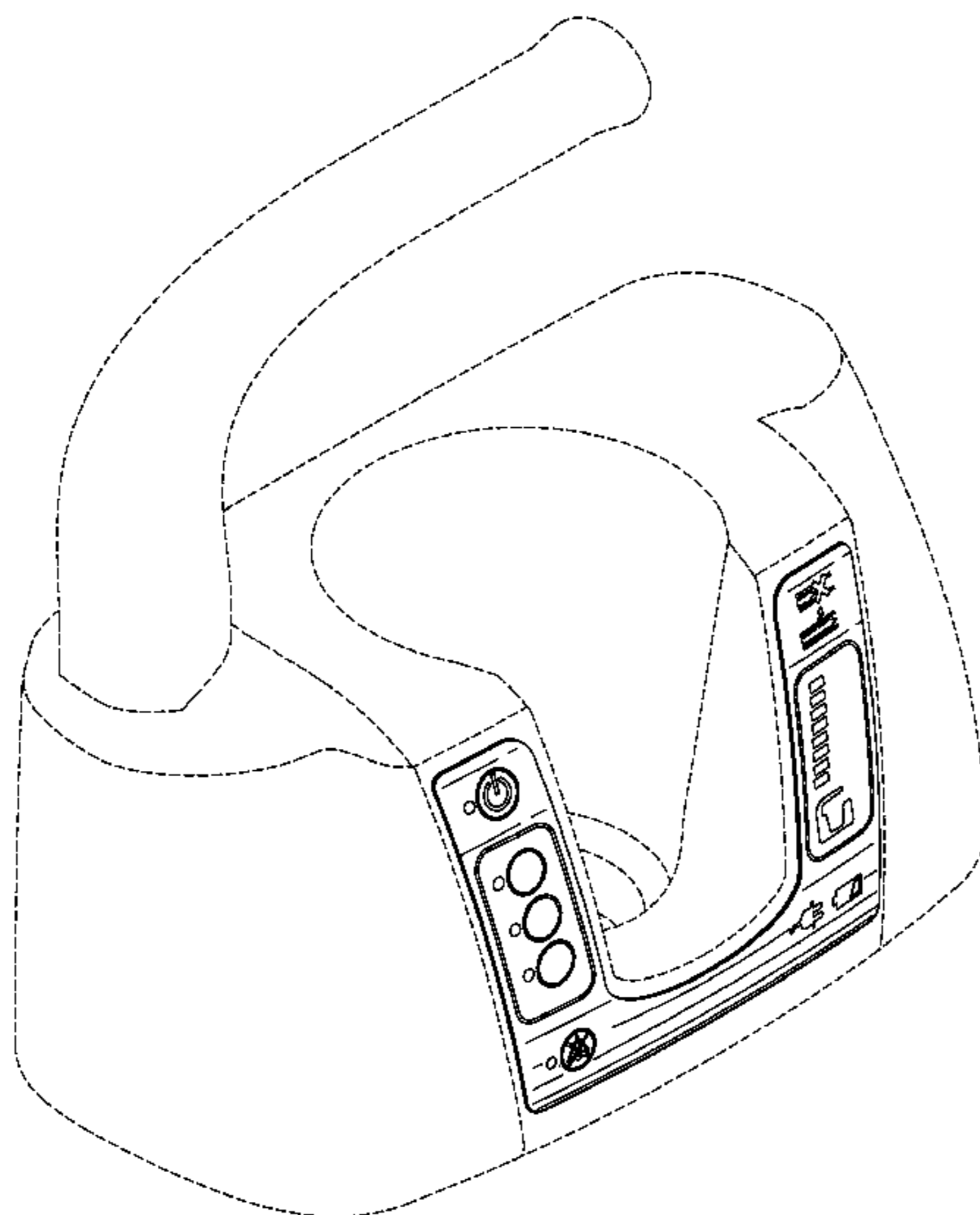
FIG. 1 is a perspective view of a display panel with a user interface for a reduced-pressure source;

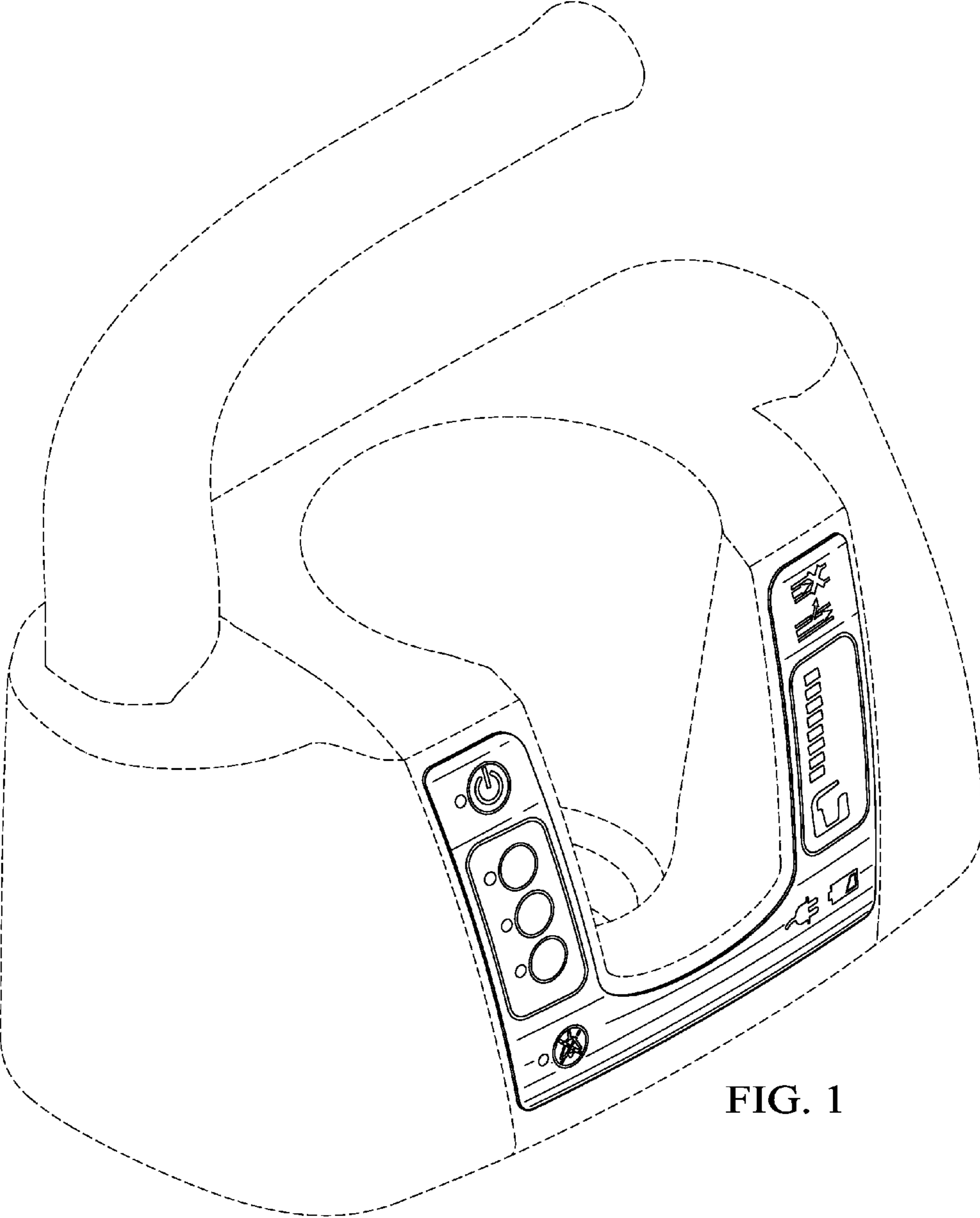

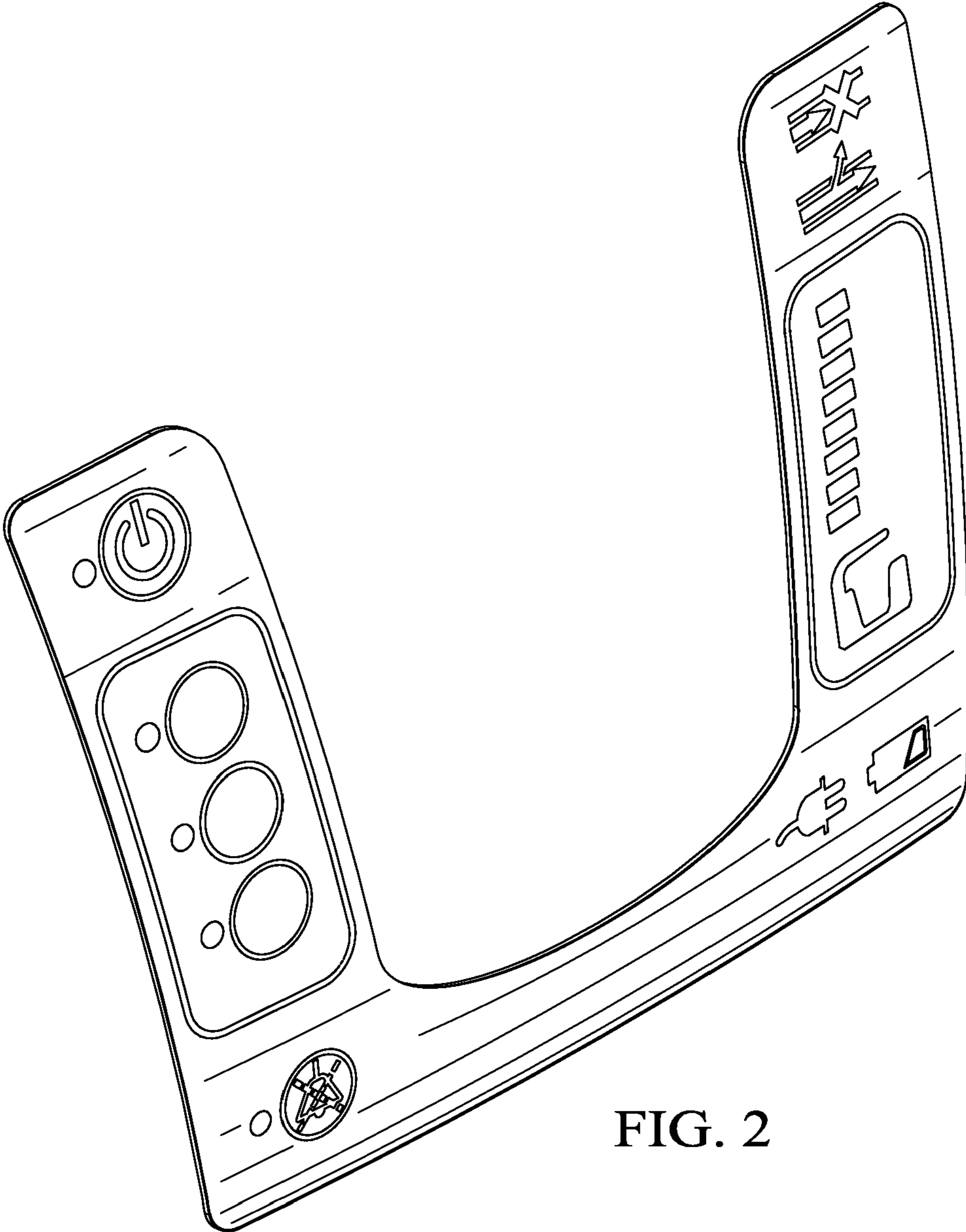

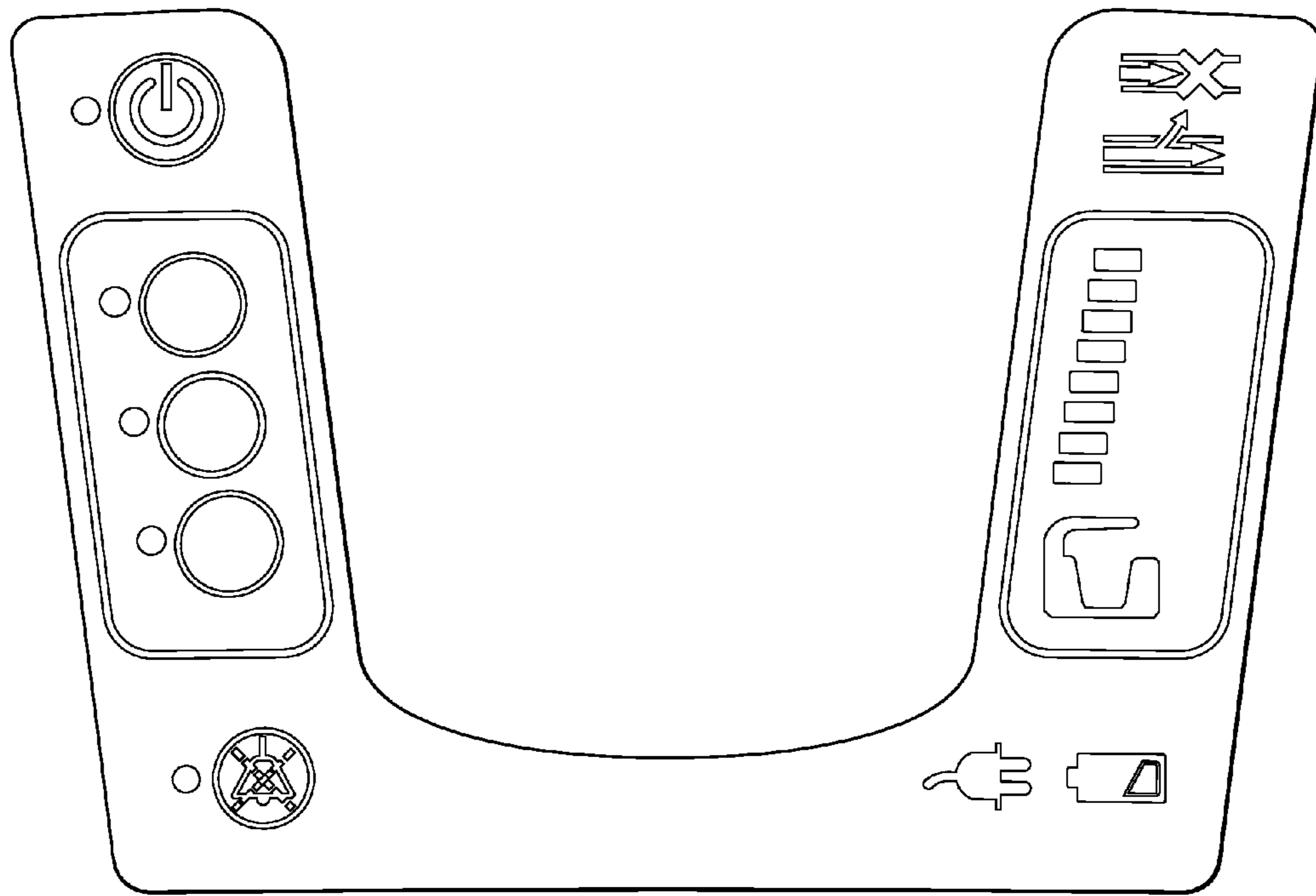
