(57) **CLAIM**

The ornamental design for a combined bollard and light fix-
ture, as shown and described.

DESCRIPTION

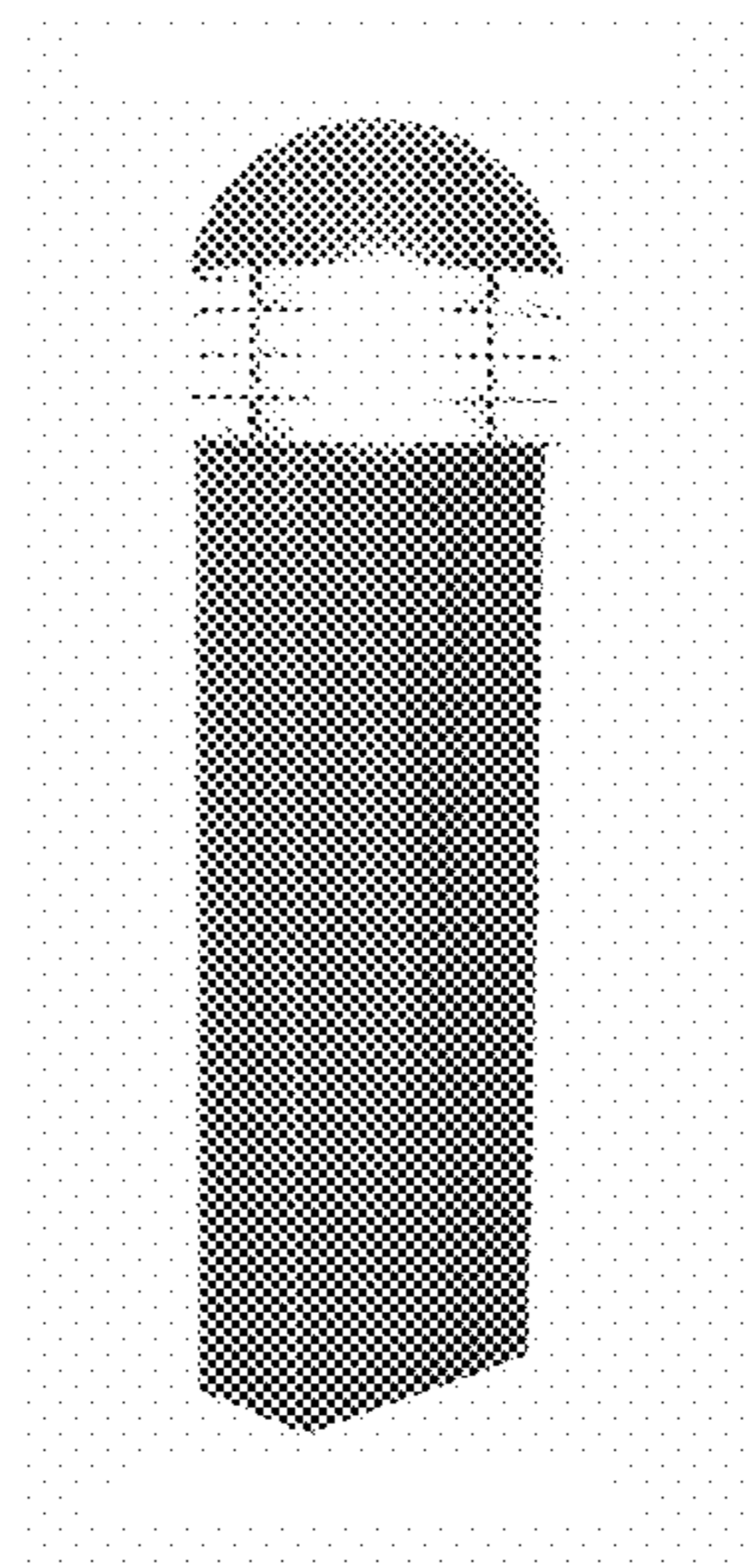
The patent or application file contains at least one drawing

FIG. 1 is a photograph of a perspective view of the combined
bollard and light fixture, the right side being identical with the
left side as shown and the back being identical with the front
as shown, color but not the specific wavelength of light for the
wash forming a part of the design, the color of the surface of
the combined bollard and light fixture not forming a part of
the design.

FIG. 2 is a photograph of a front view inclined from above of
the combined bollard and light fixture, the back being iden-
tical with the front as shown, color but not the specific wave-
length of light for the wash forming a part of the design, the
color of the surface of the combined bollard and light fixture
not forming a part of the design.

The bottom view does not form part of the design.

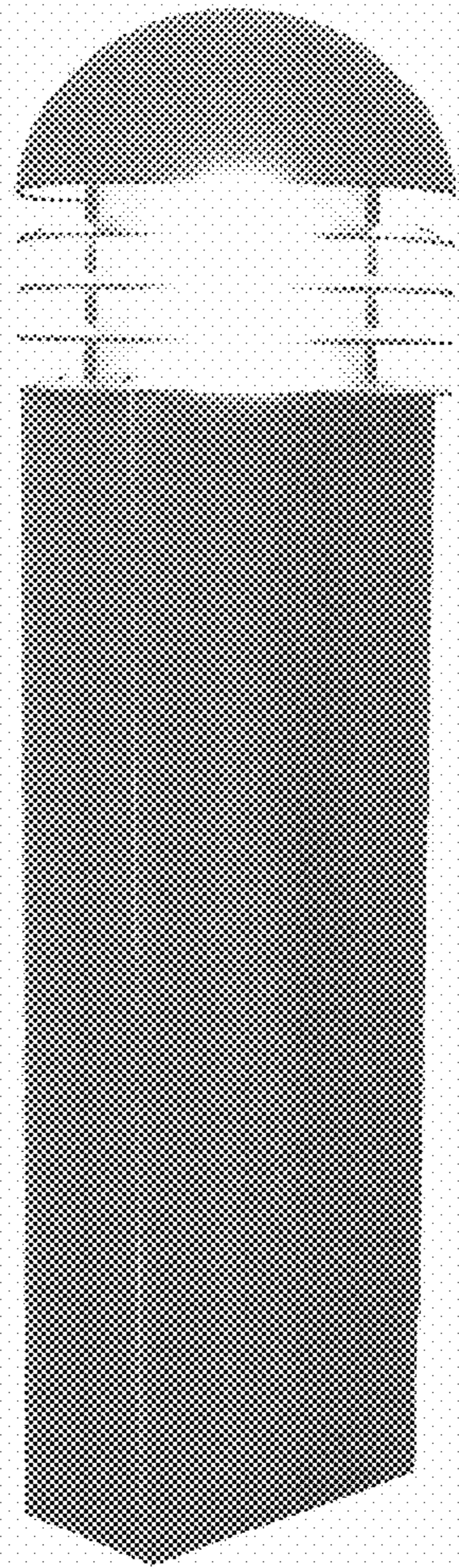

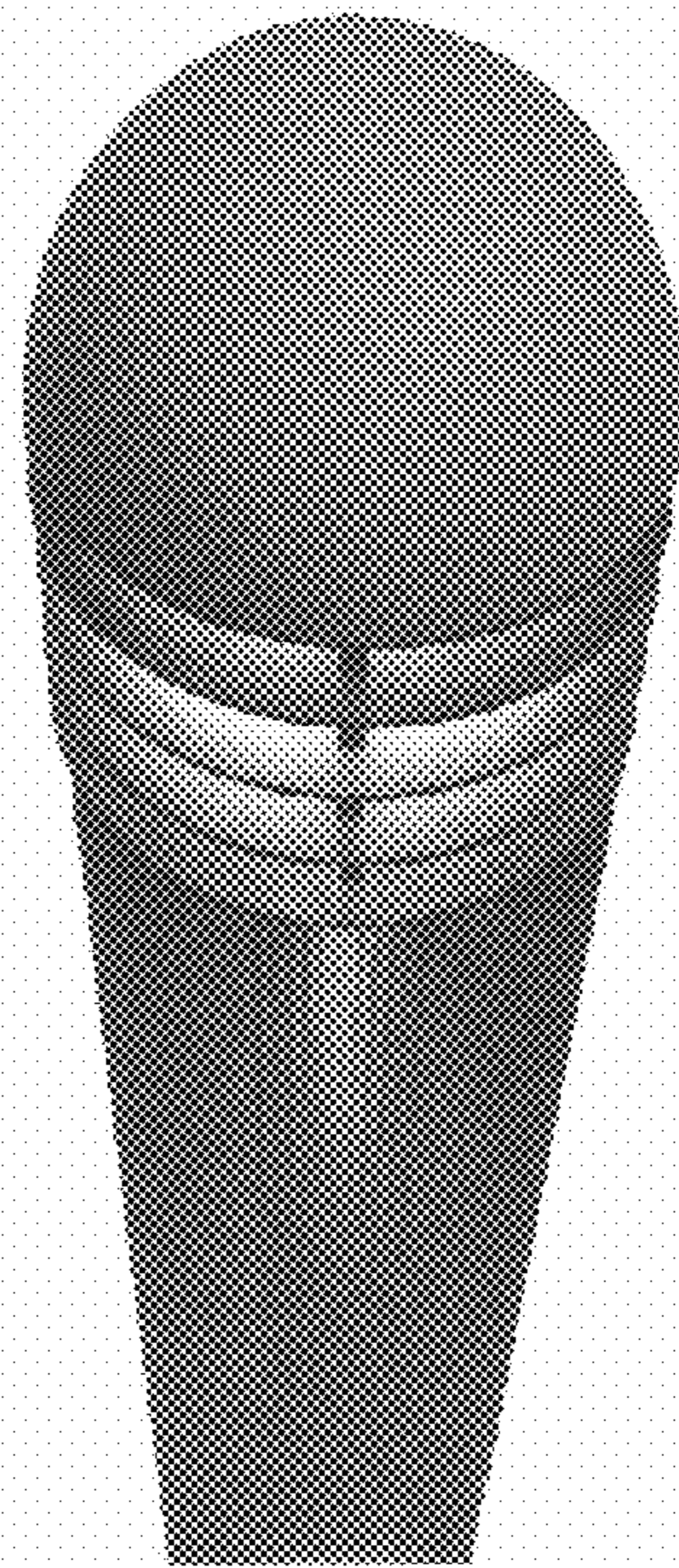
