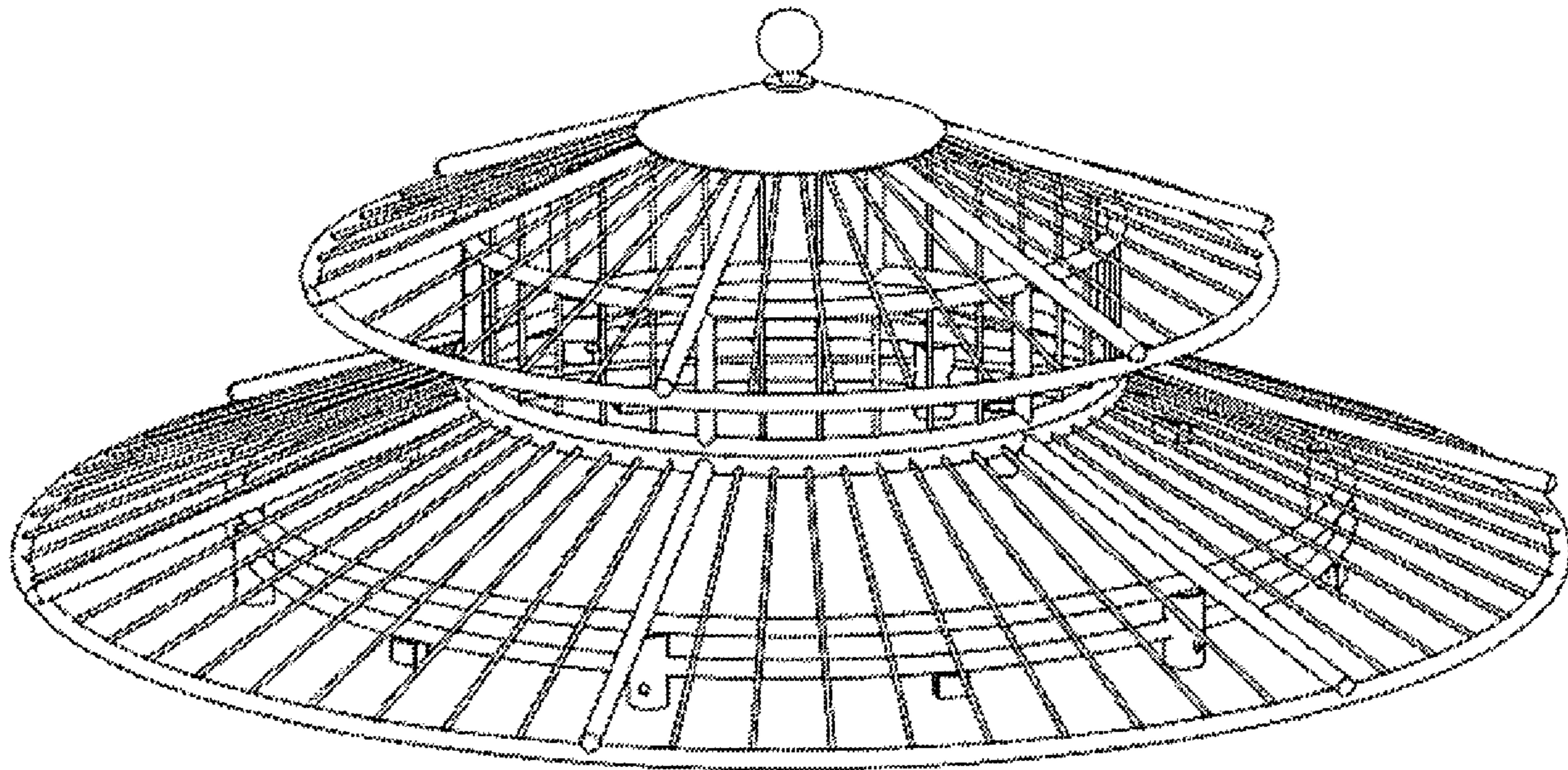
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the birdcage roof;  
FIG. 2 is a front view of FIG. 1, the rear view being a mirror image thereof;  
FIG. 3 is a left side view of FIG. 1, the right side view being a mirror image thereof;  
FIG. 4 is a top plan view of FIG. 1; and,

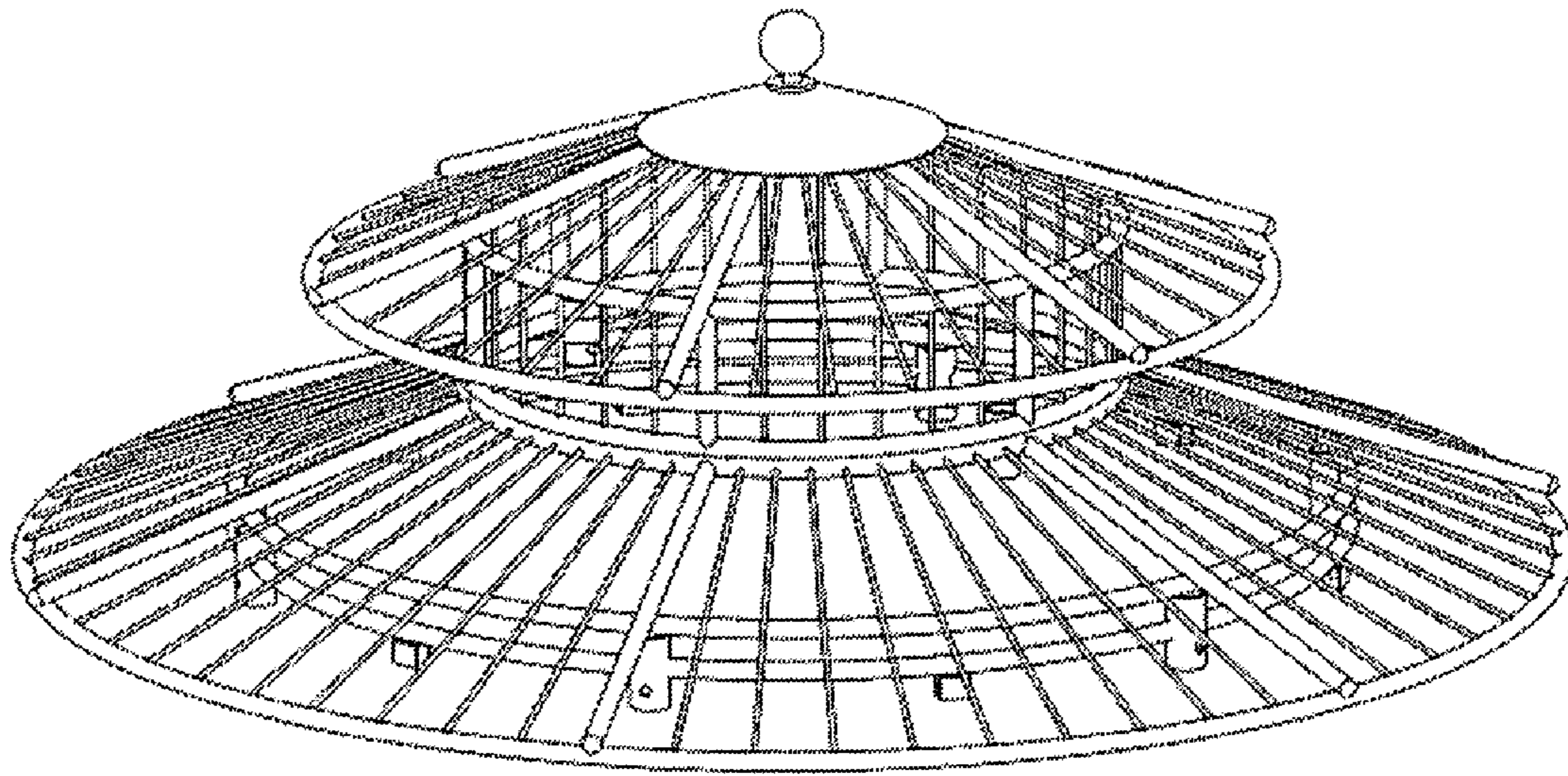
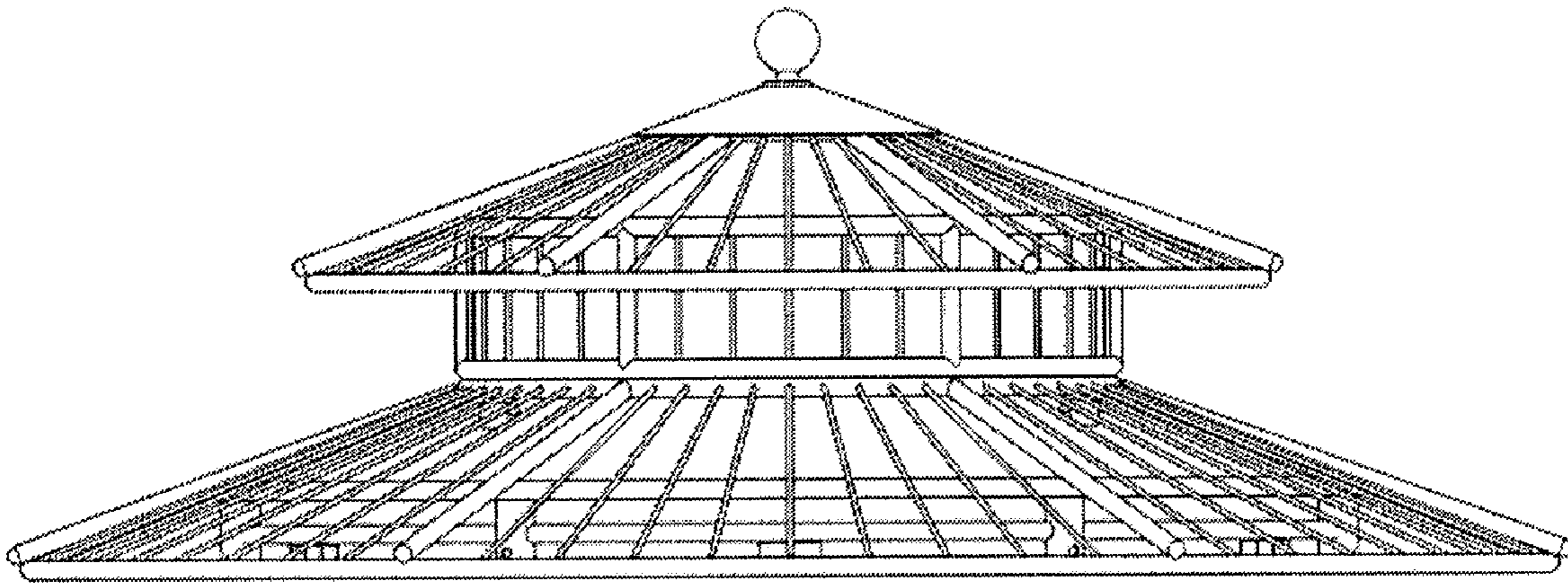
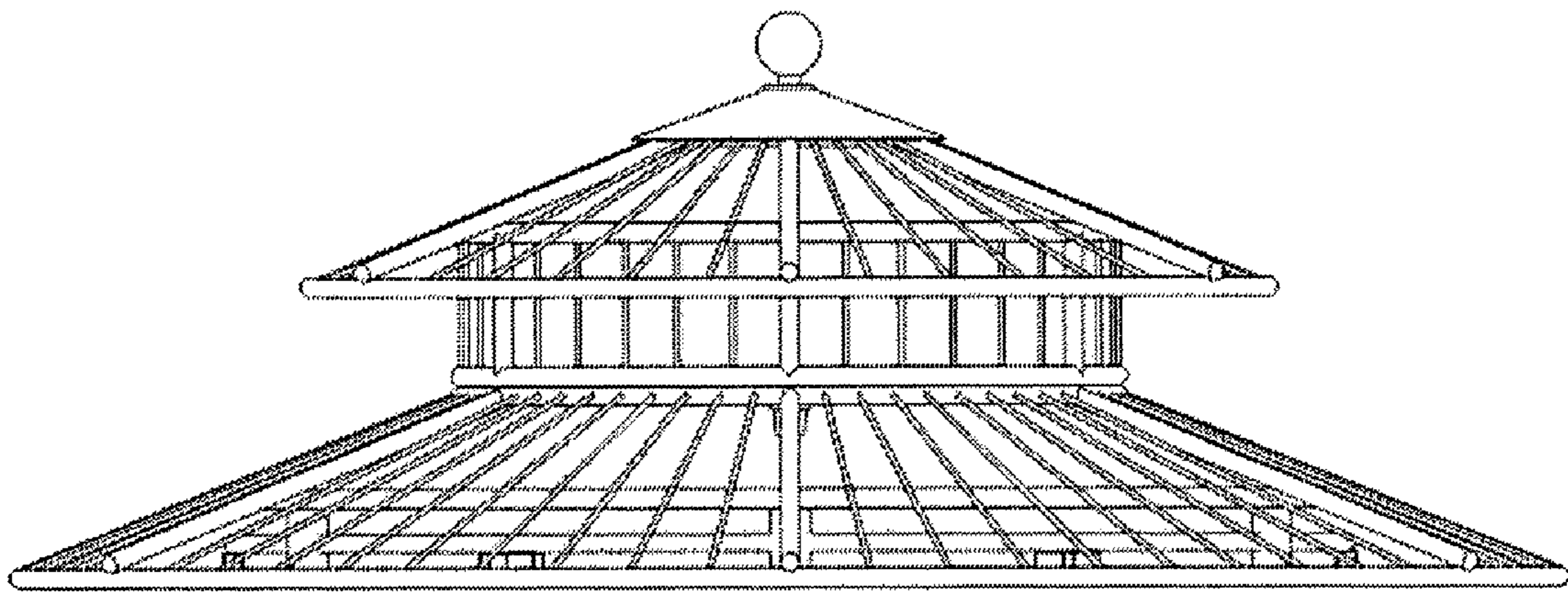


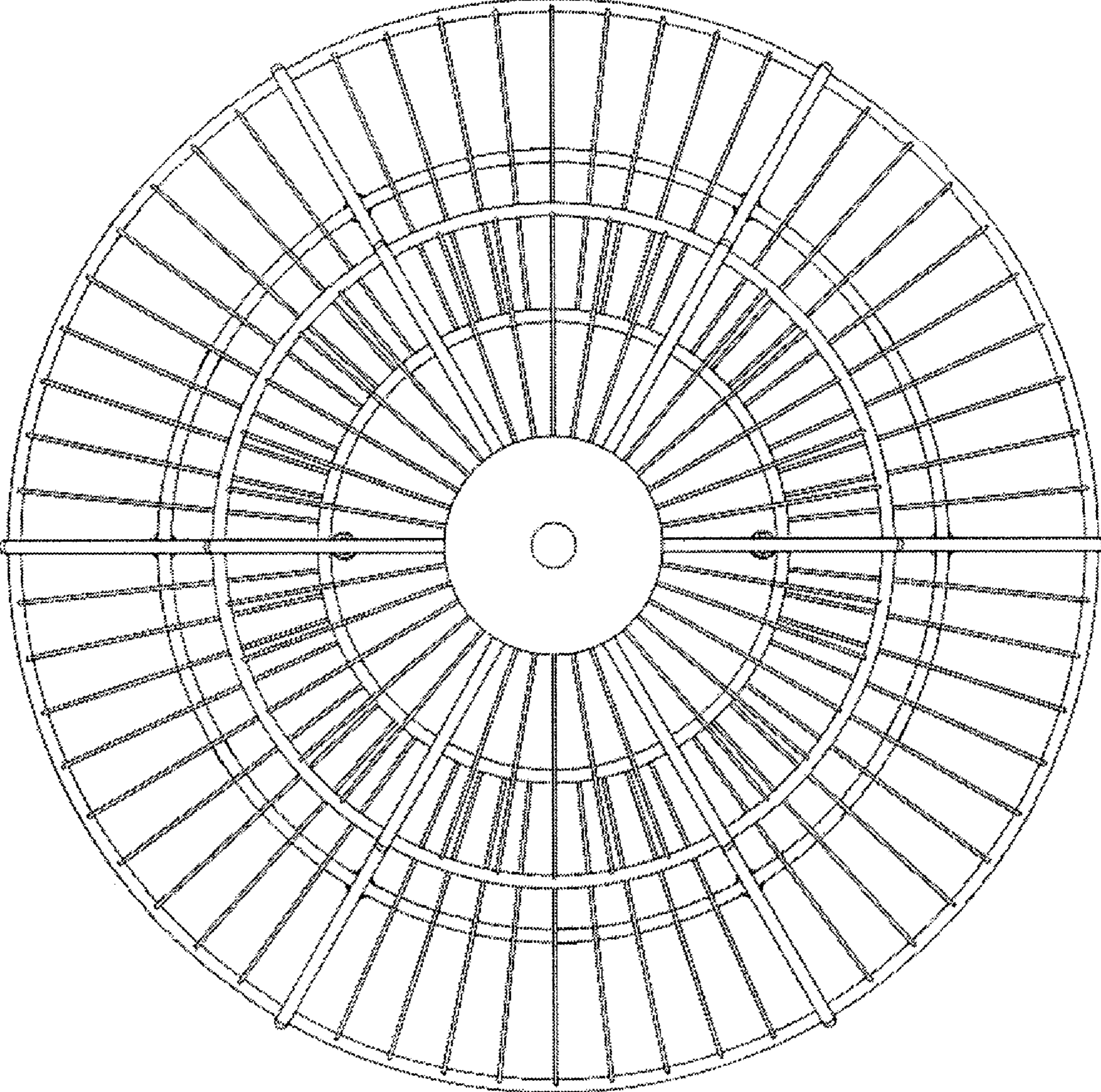

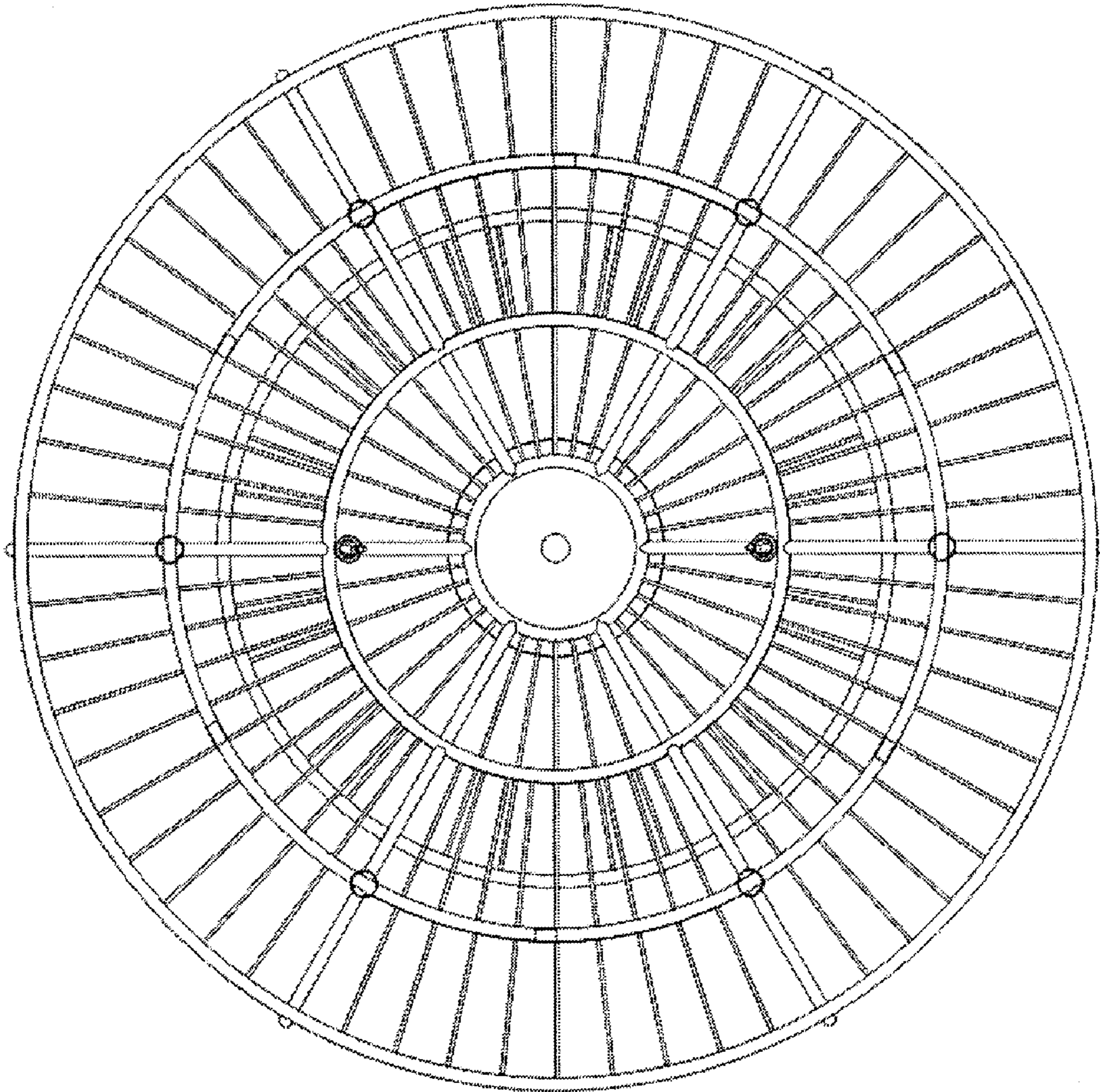
