I claim the ornamental design for a visor, as shown and described.

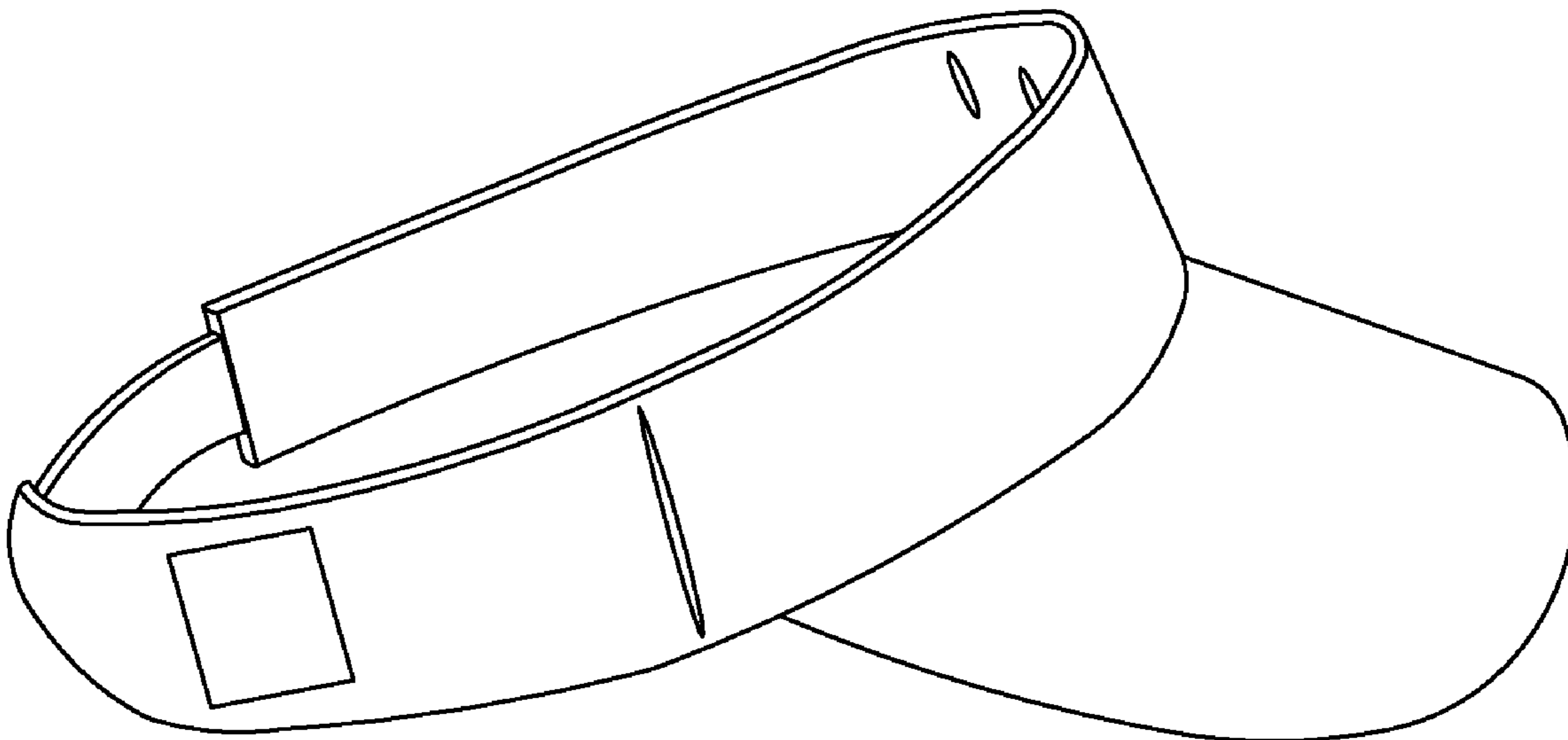
**DESCRIPTION**

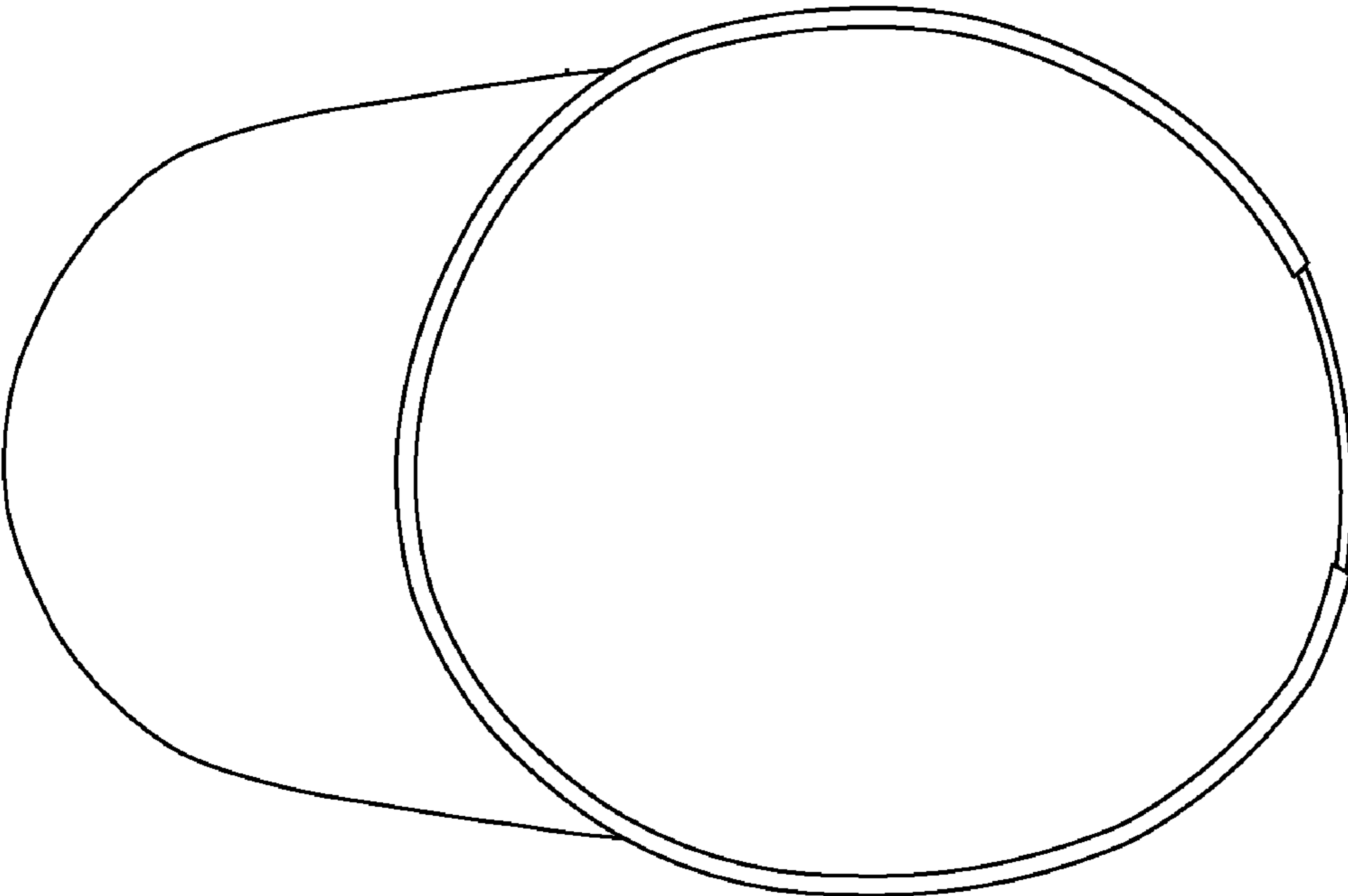

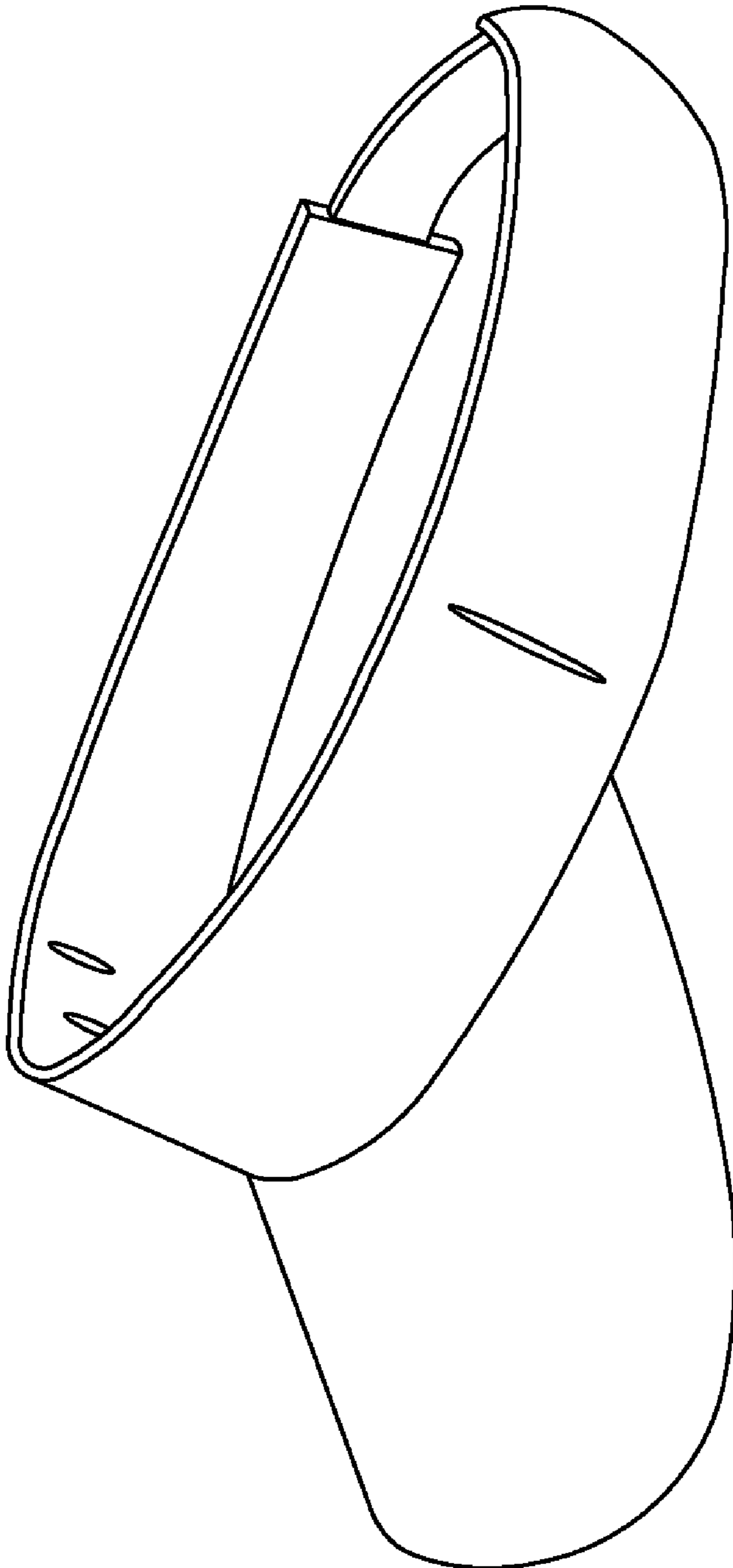

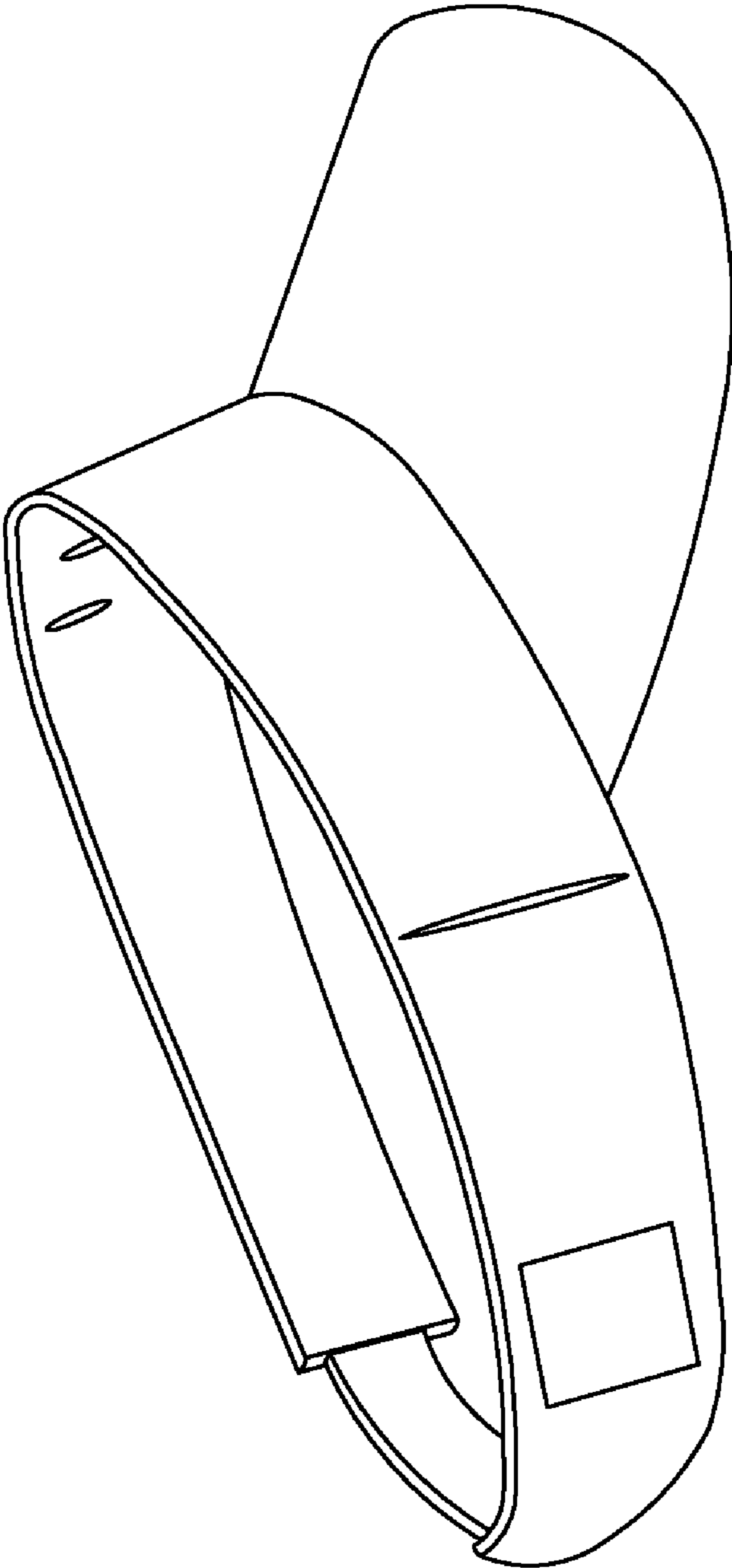
