DESCRIPTION

9.

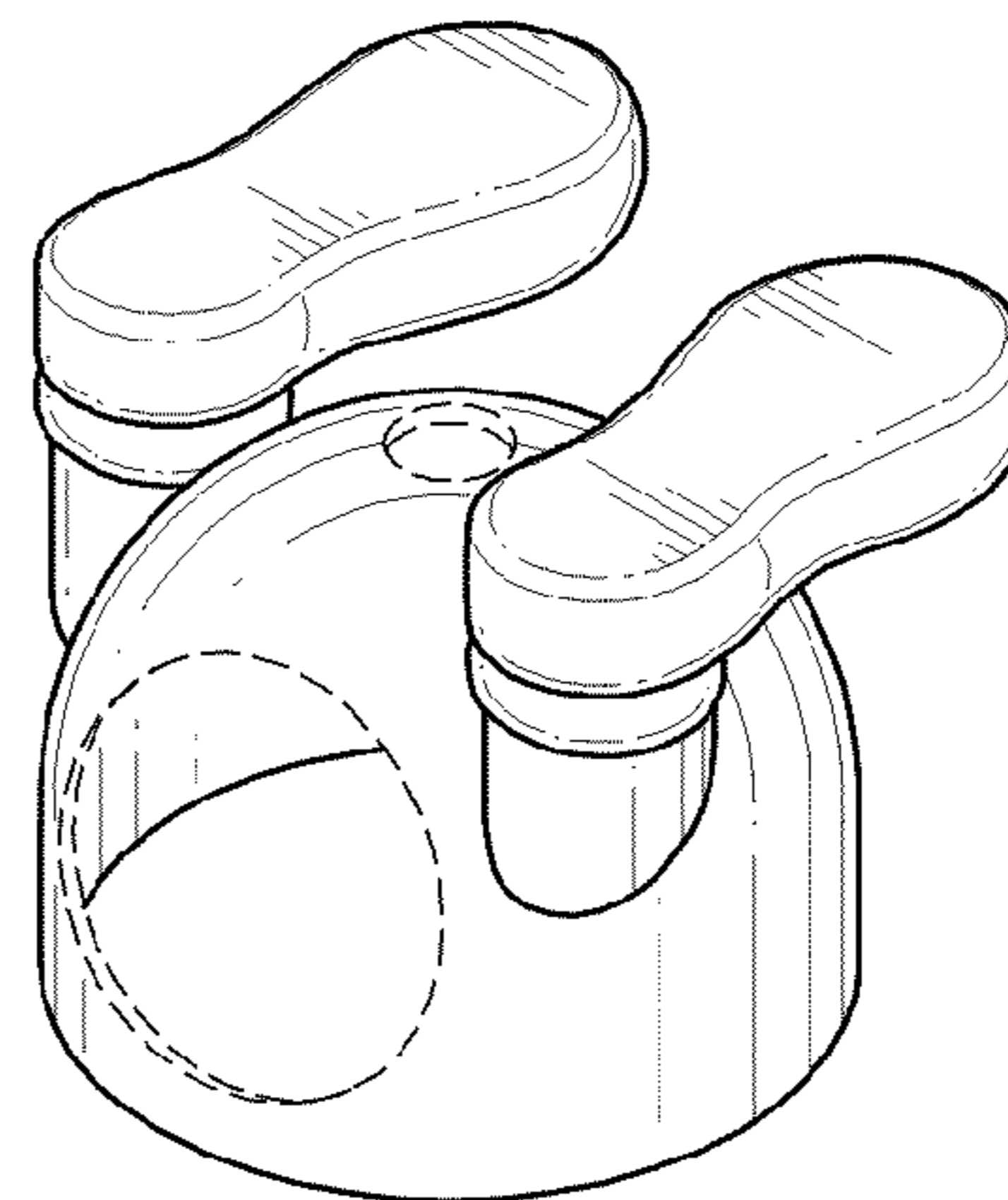
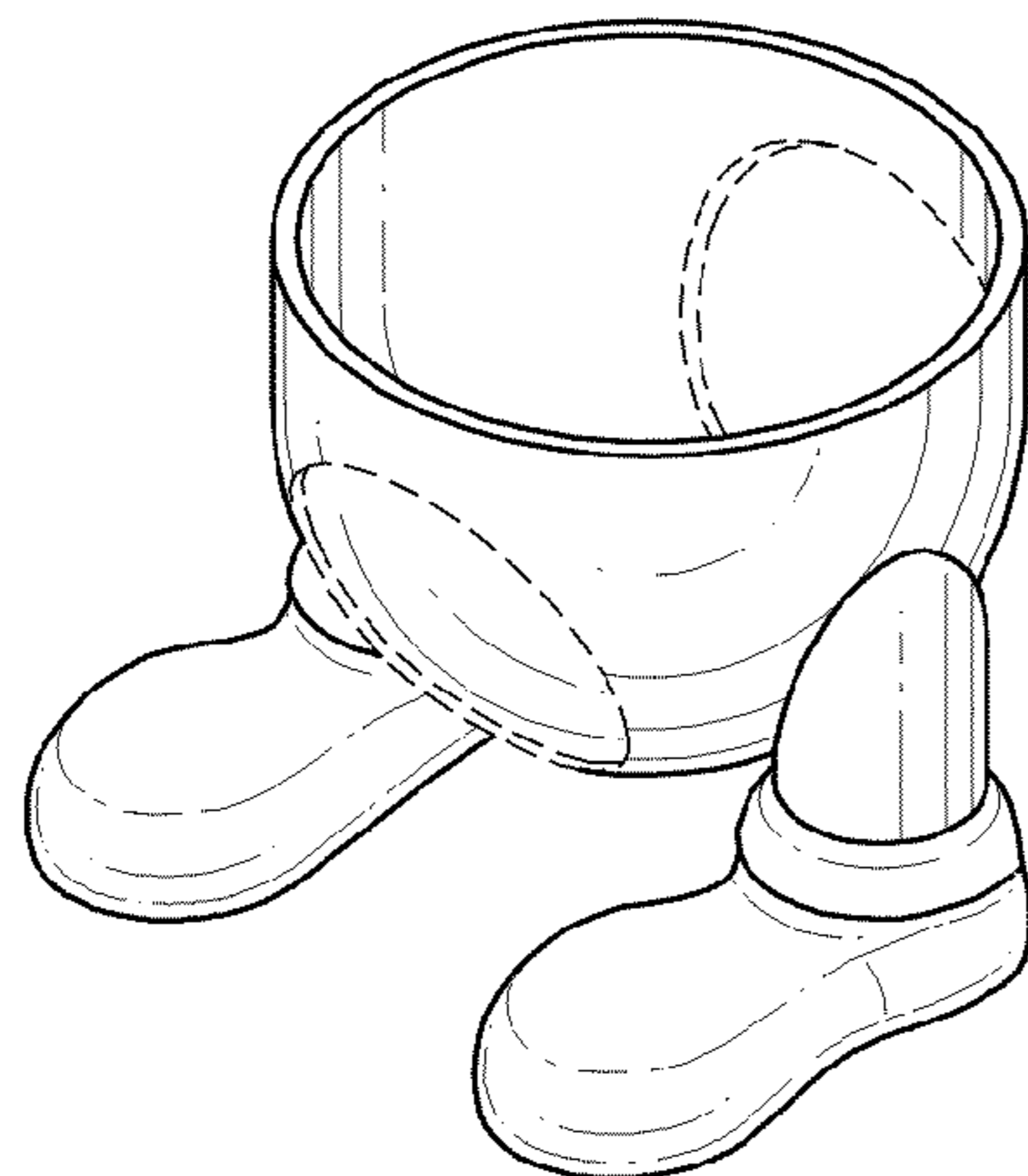
FIG. 14 is a right side view of the embodiment of FIG. 9.

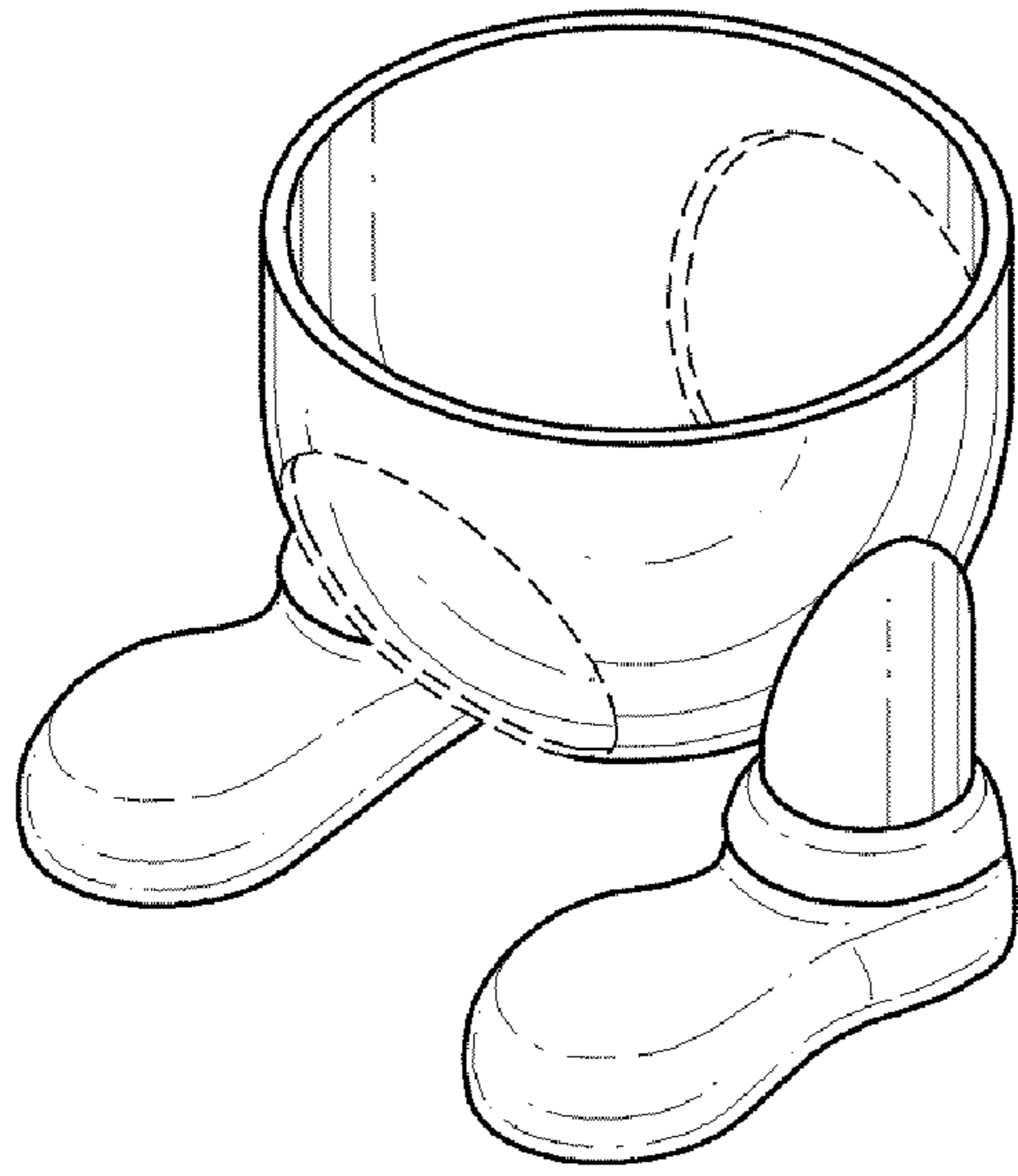

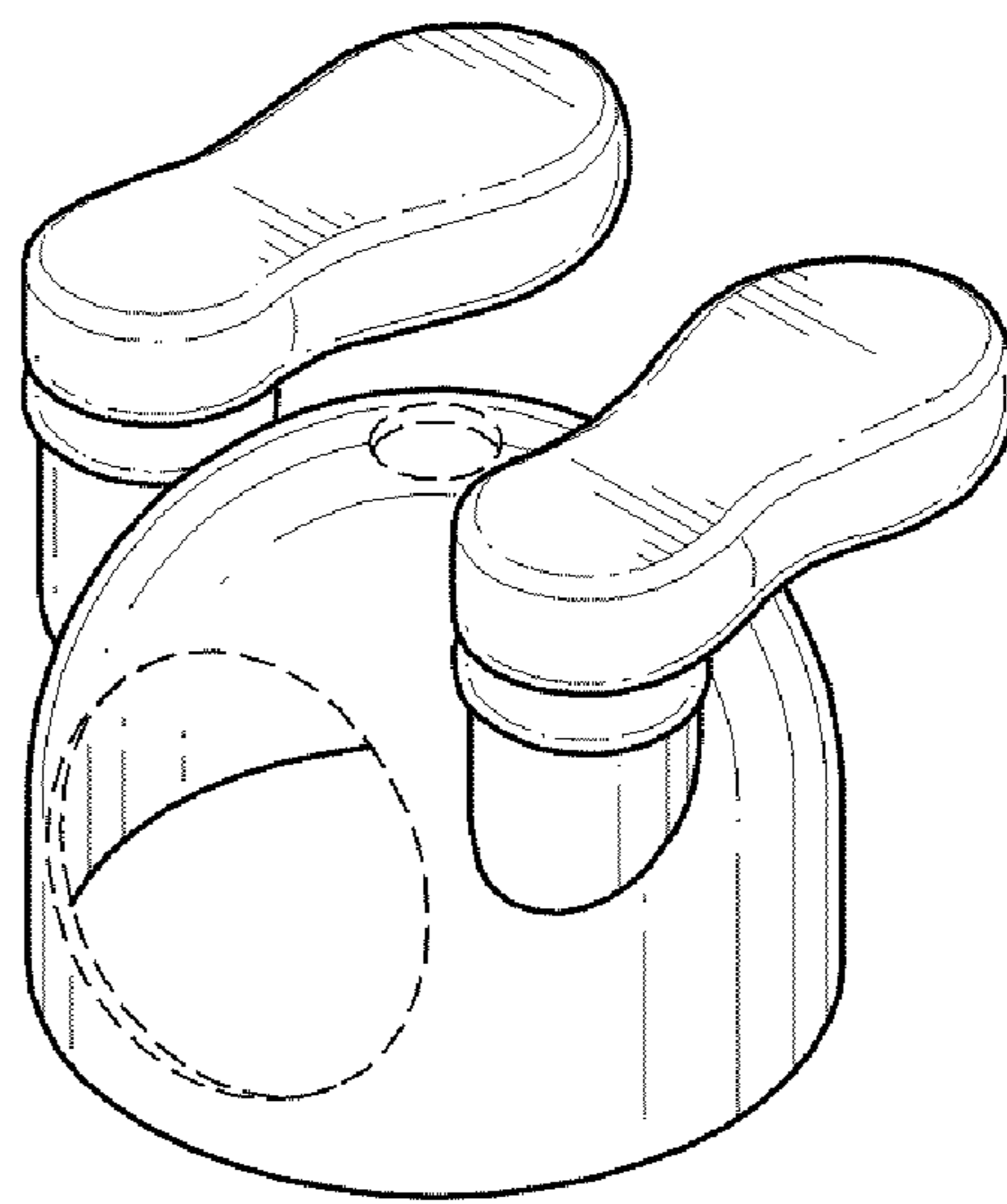

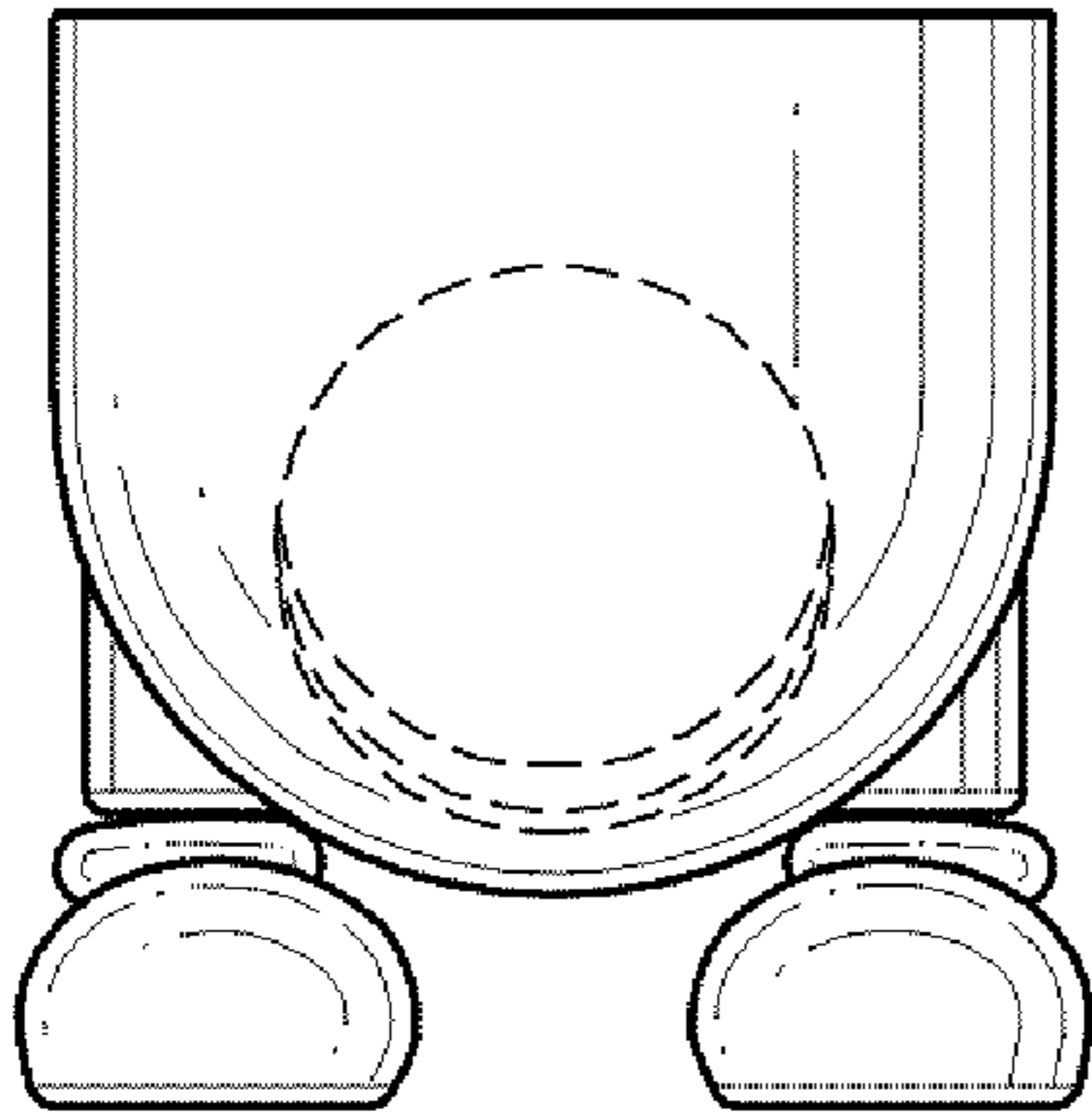

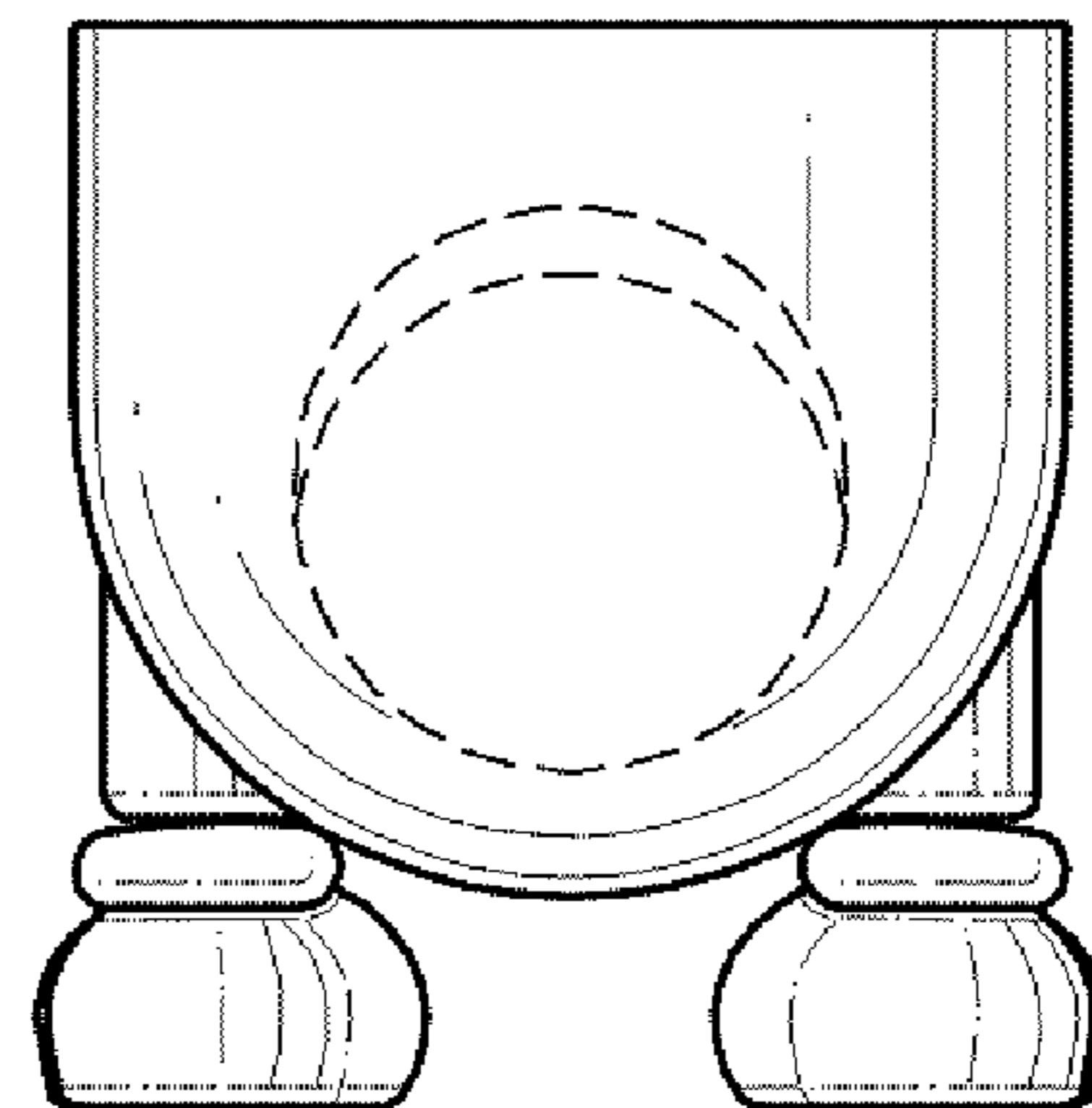

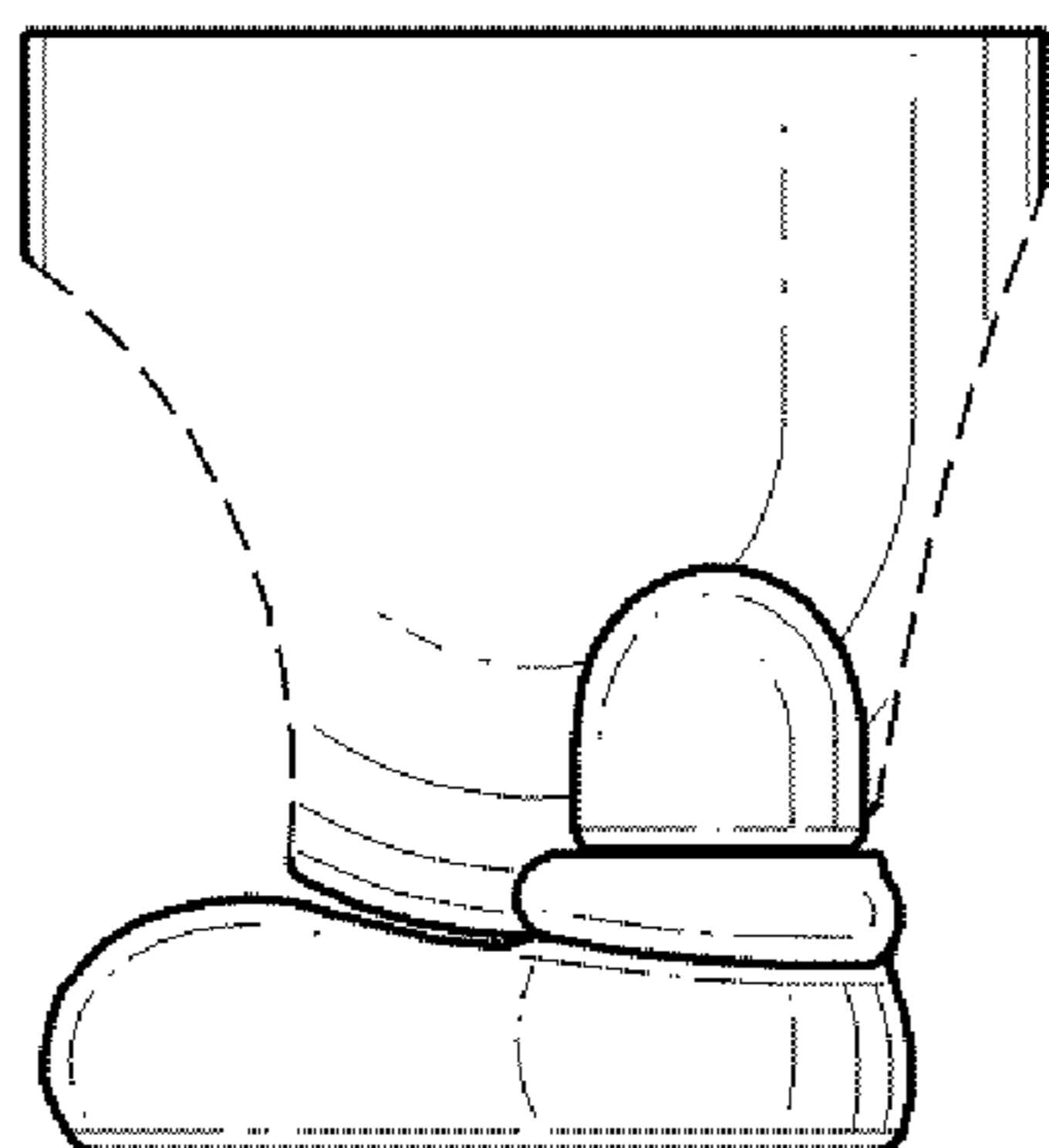

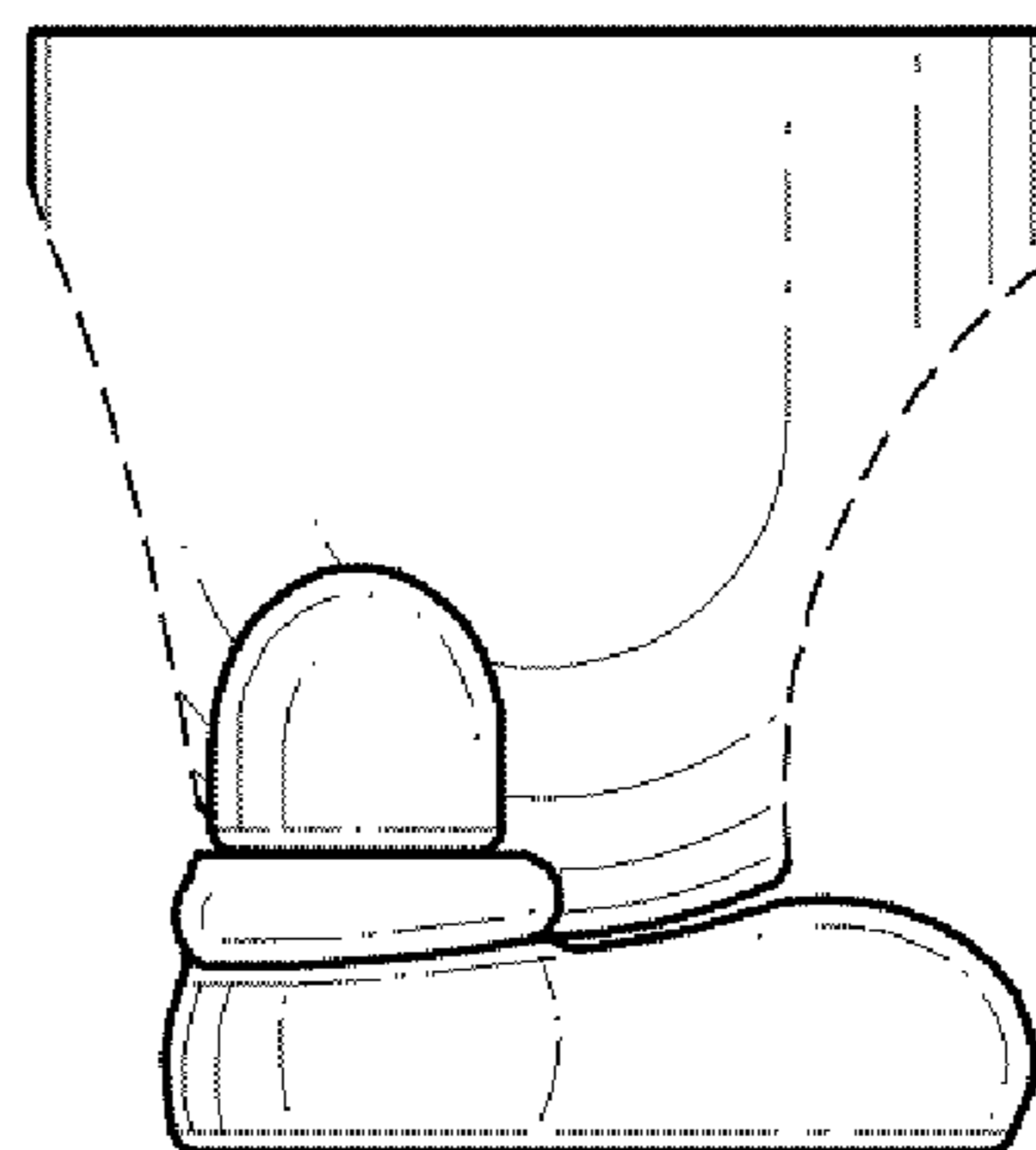

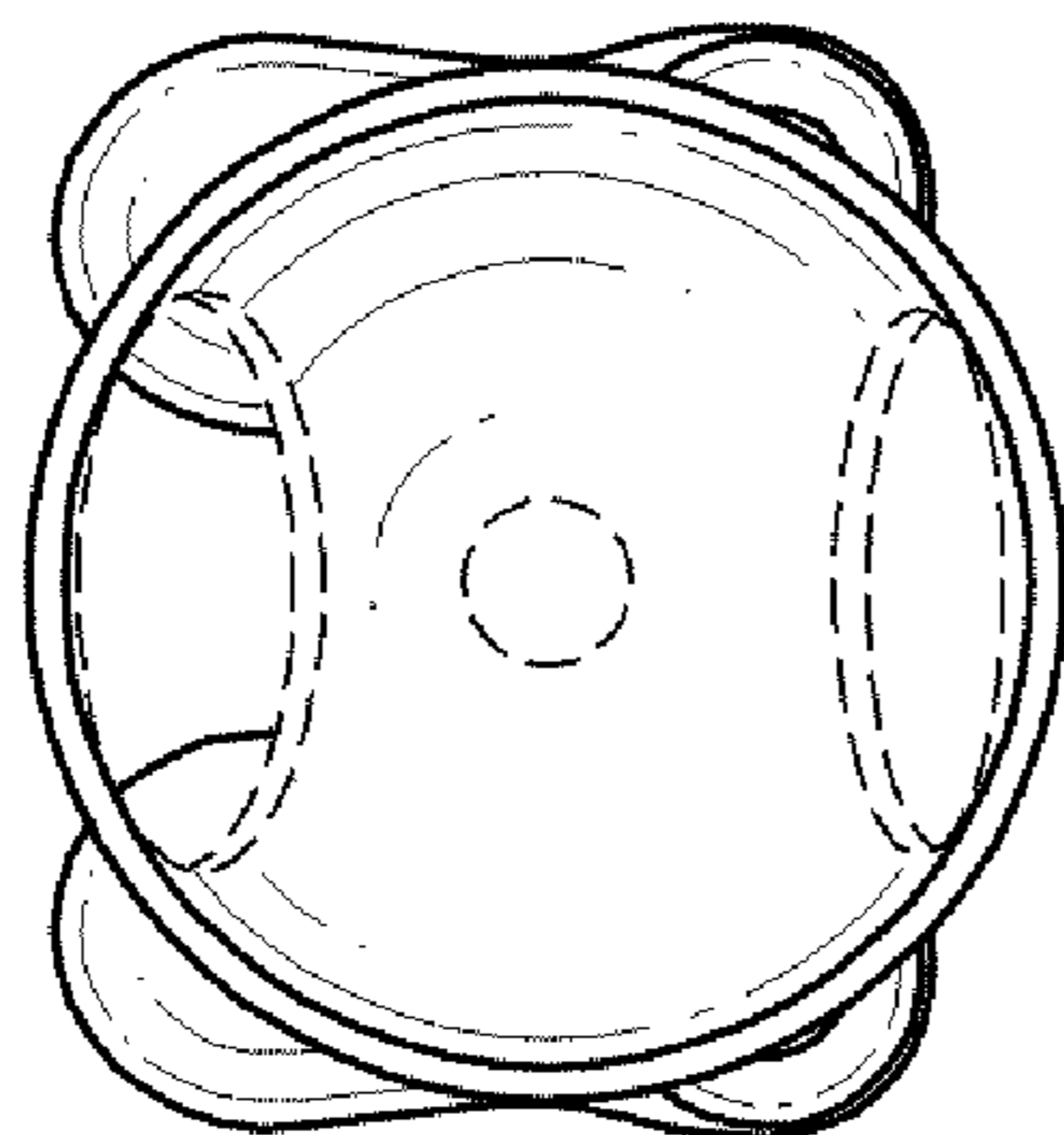

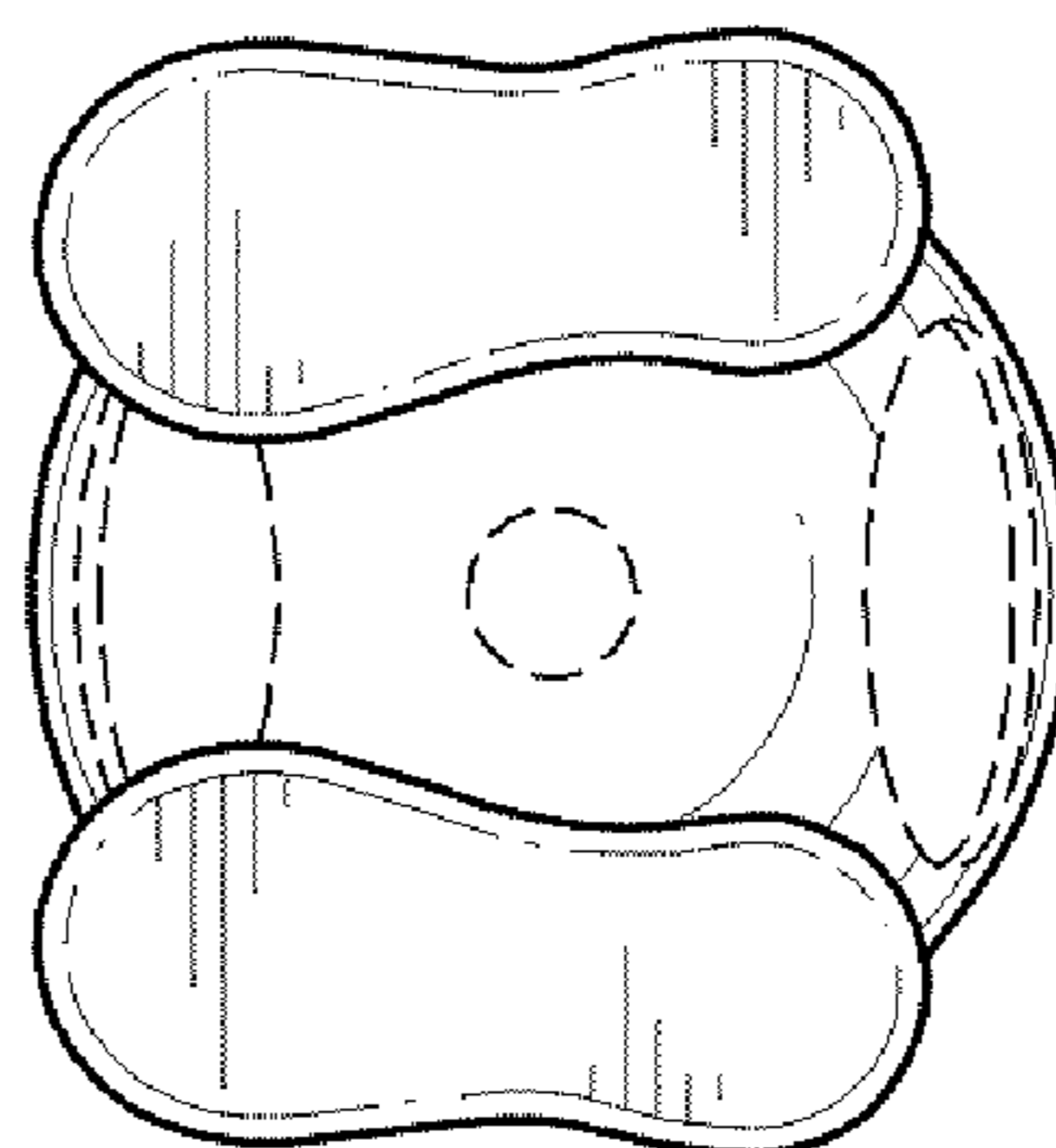

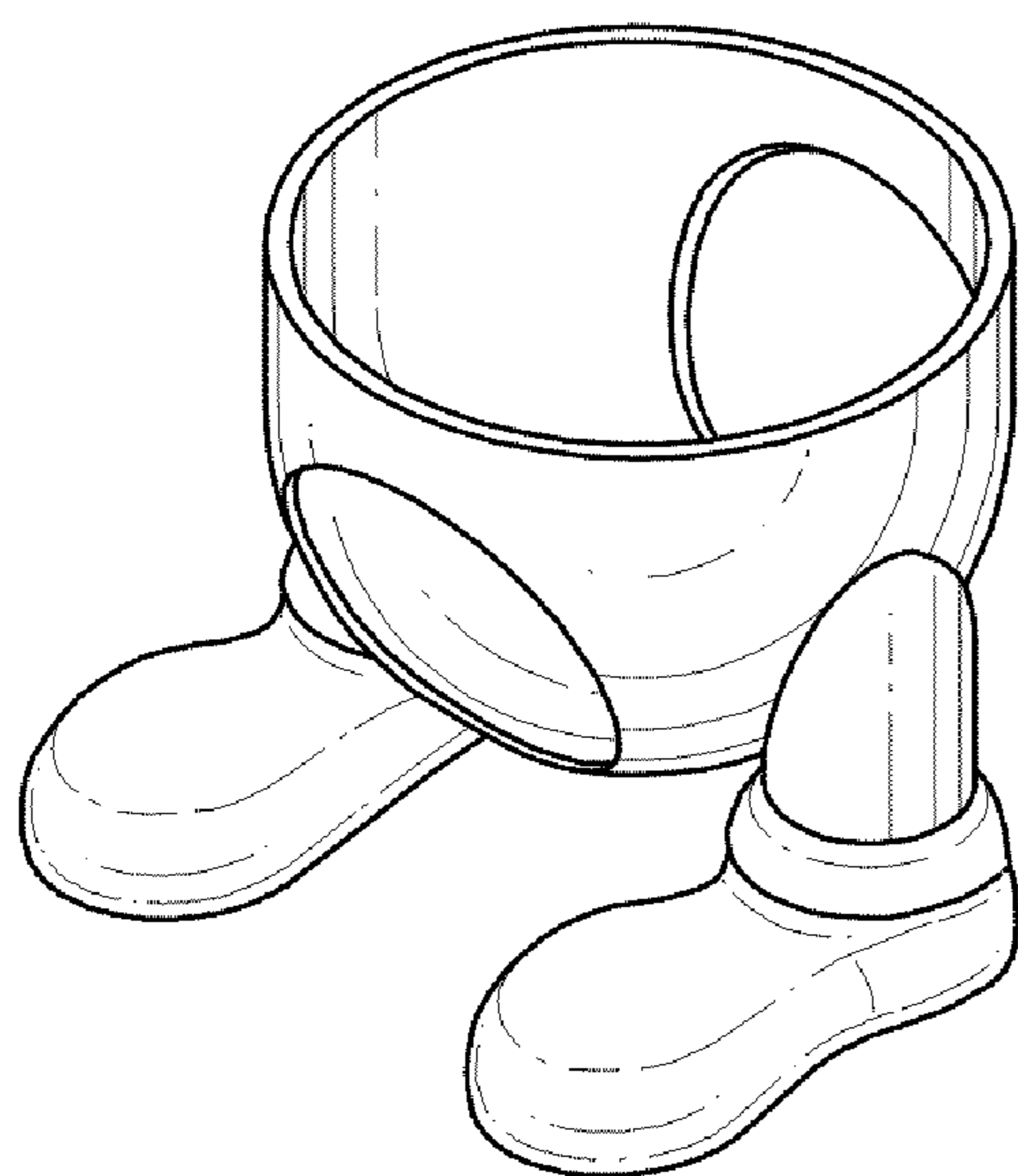

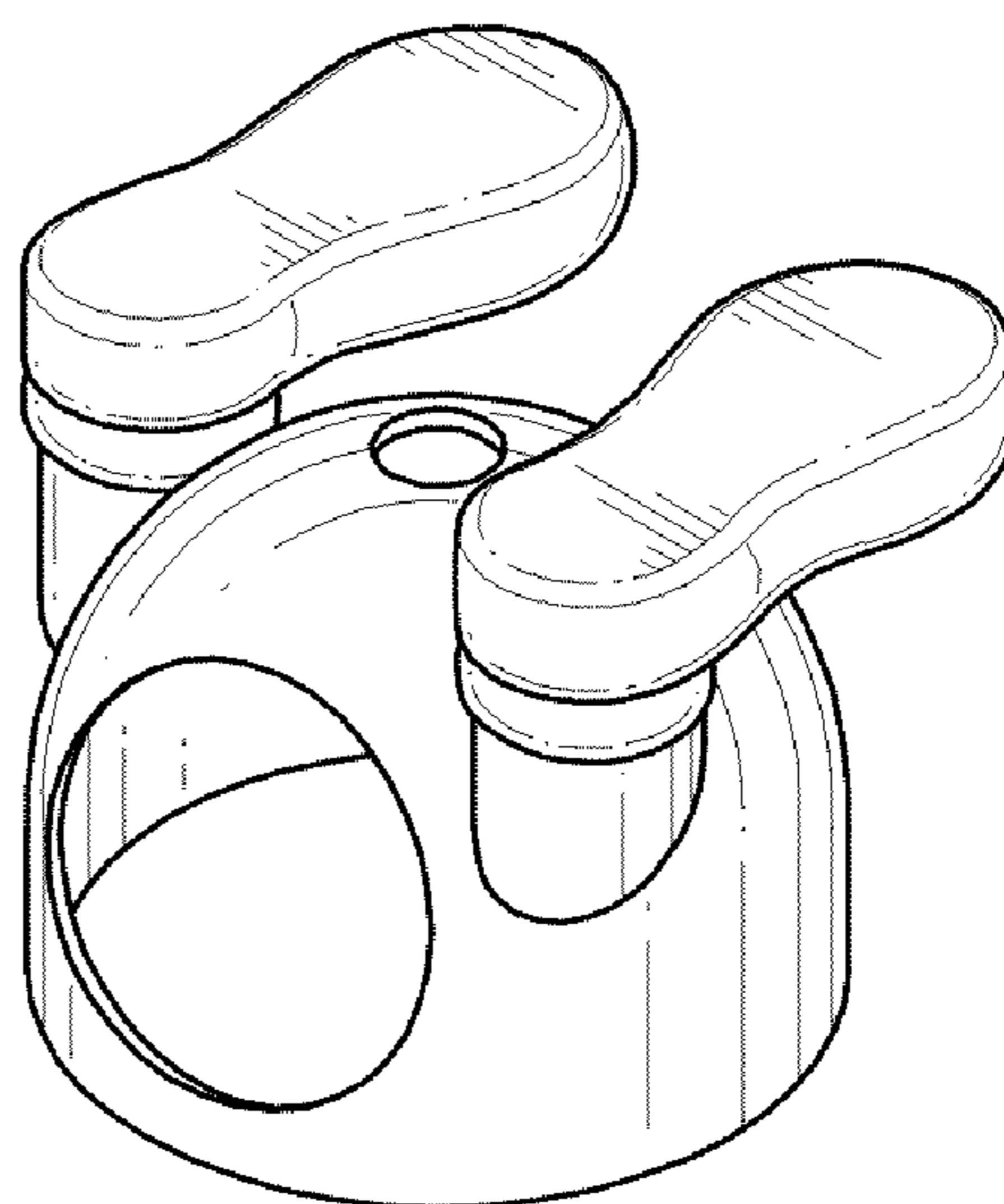

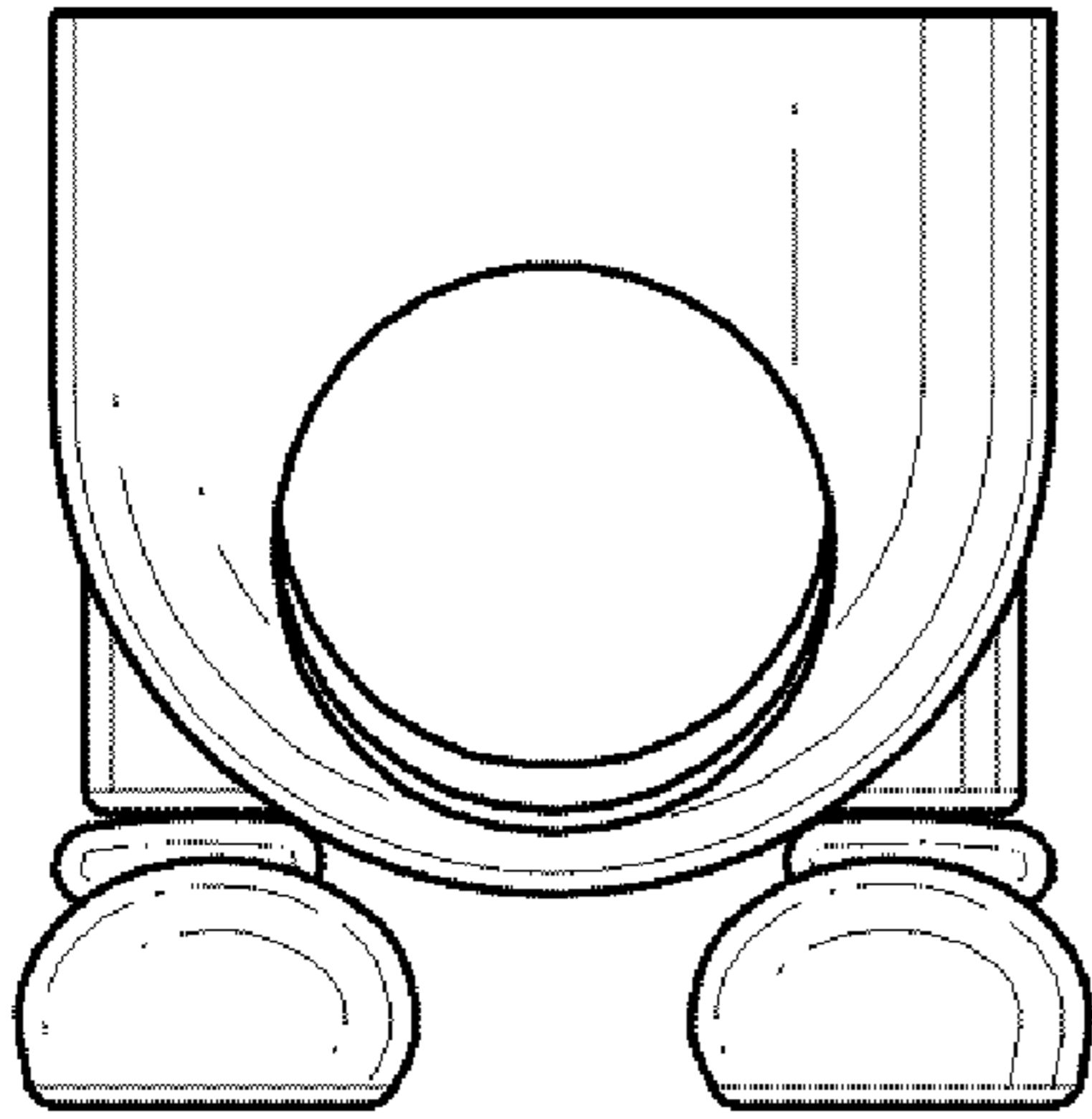

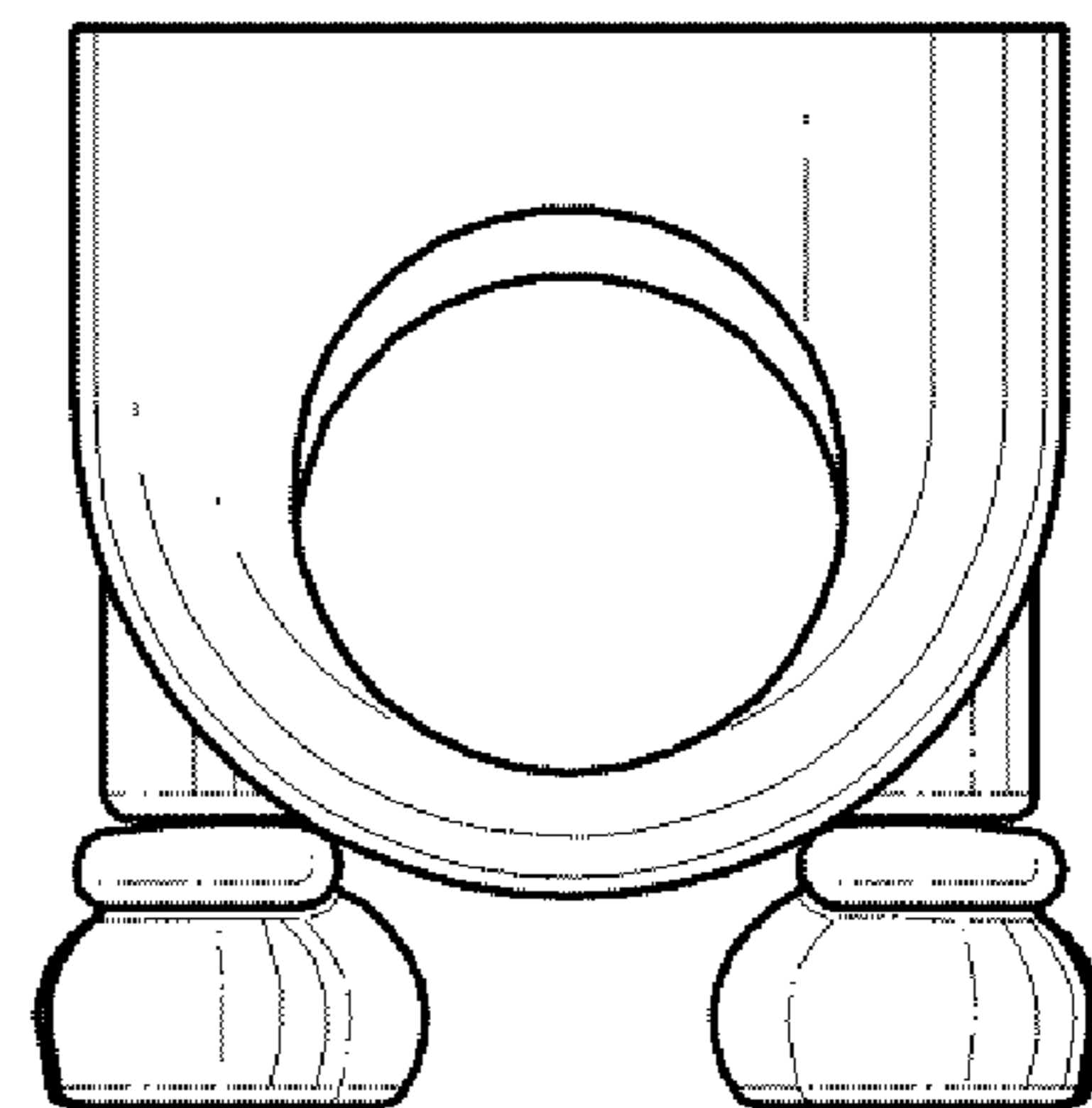

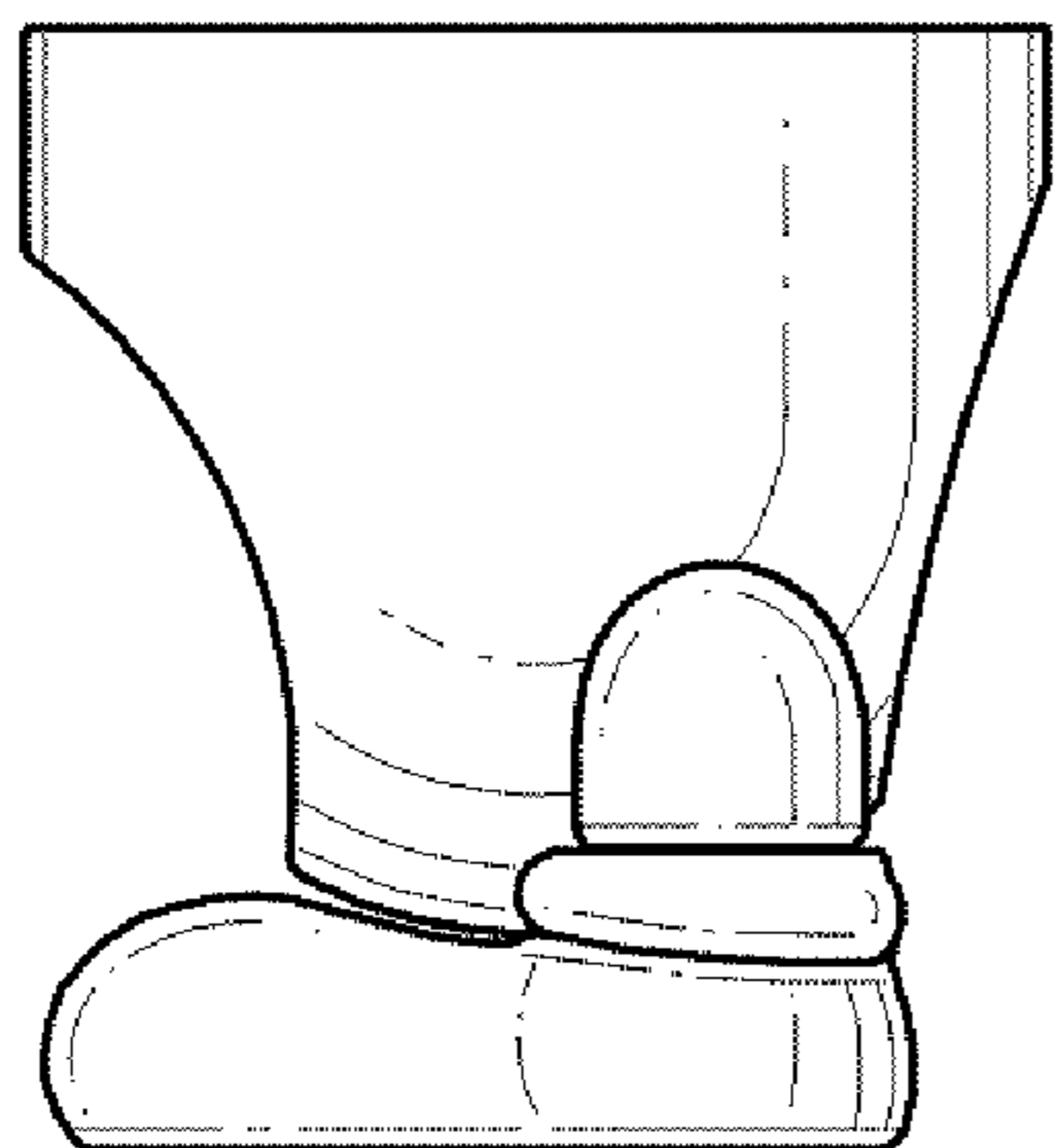

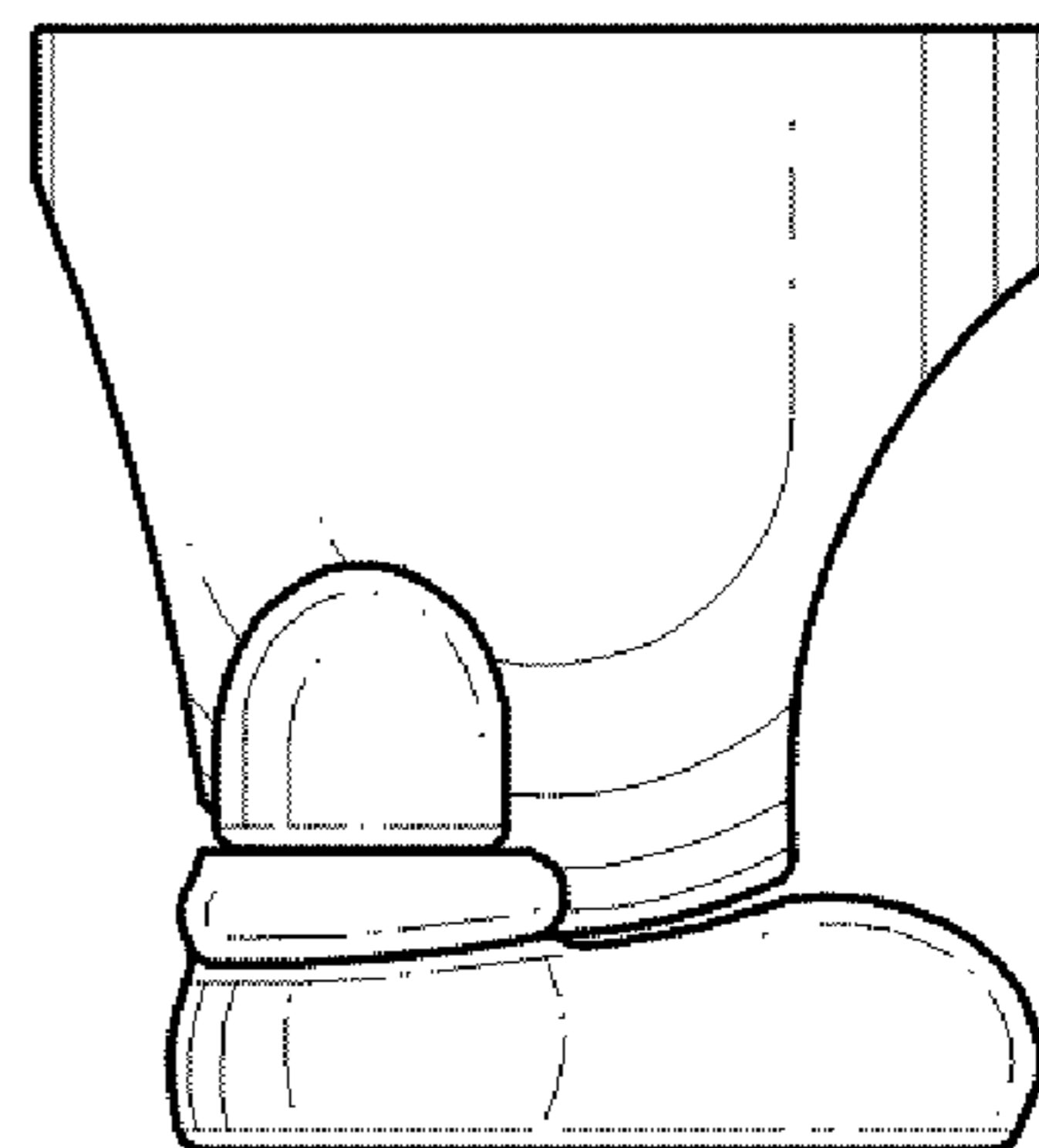

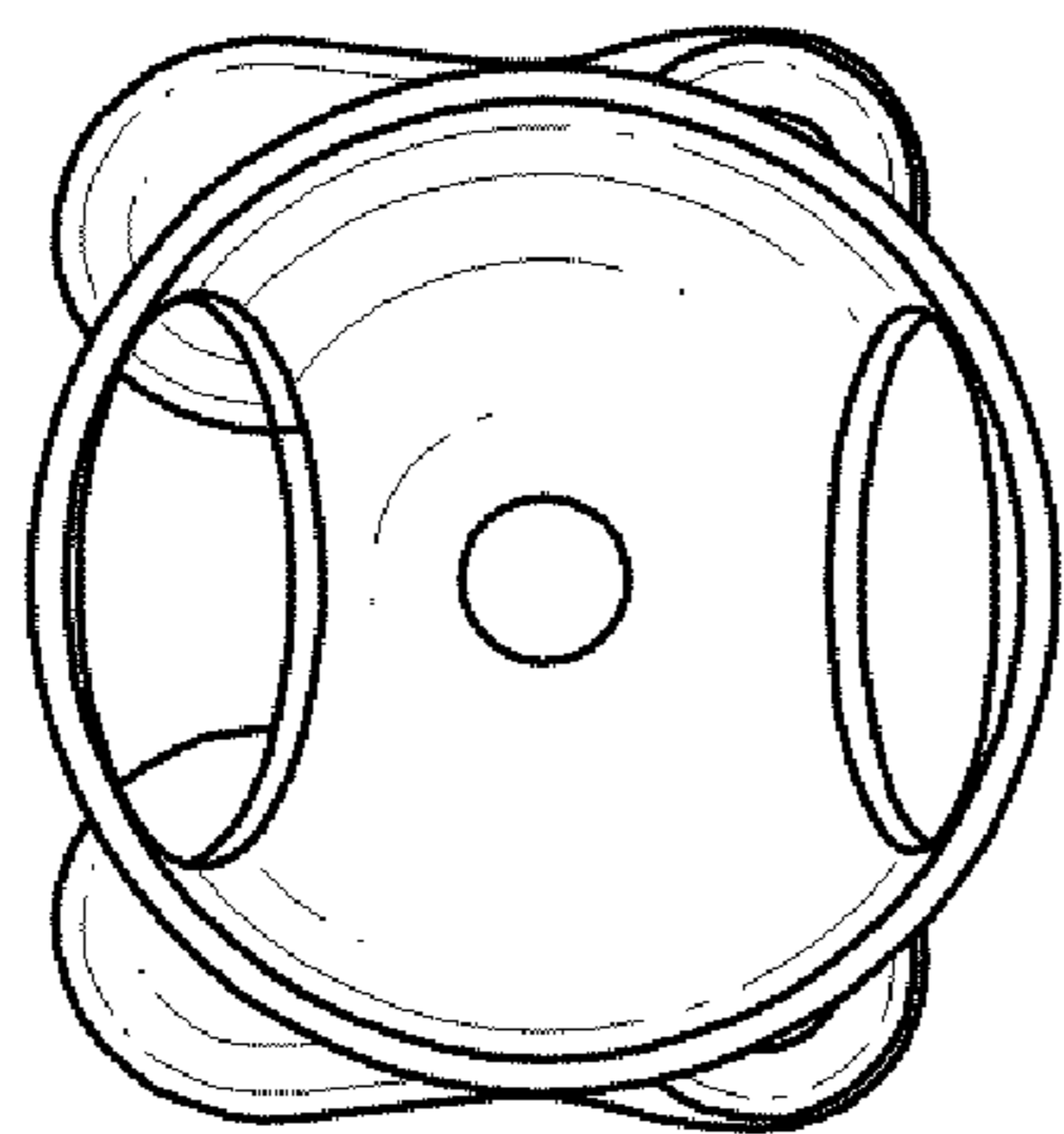

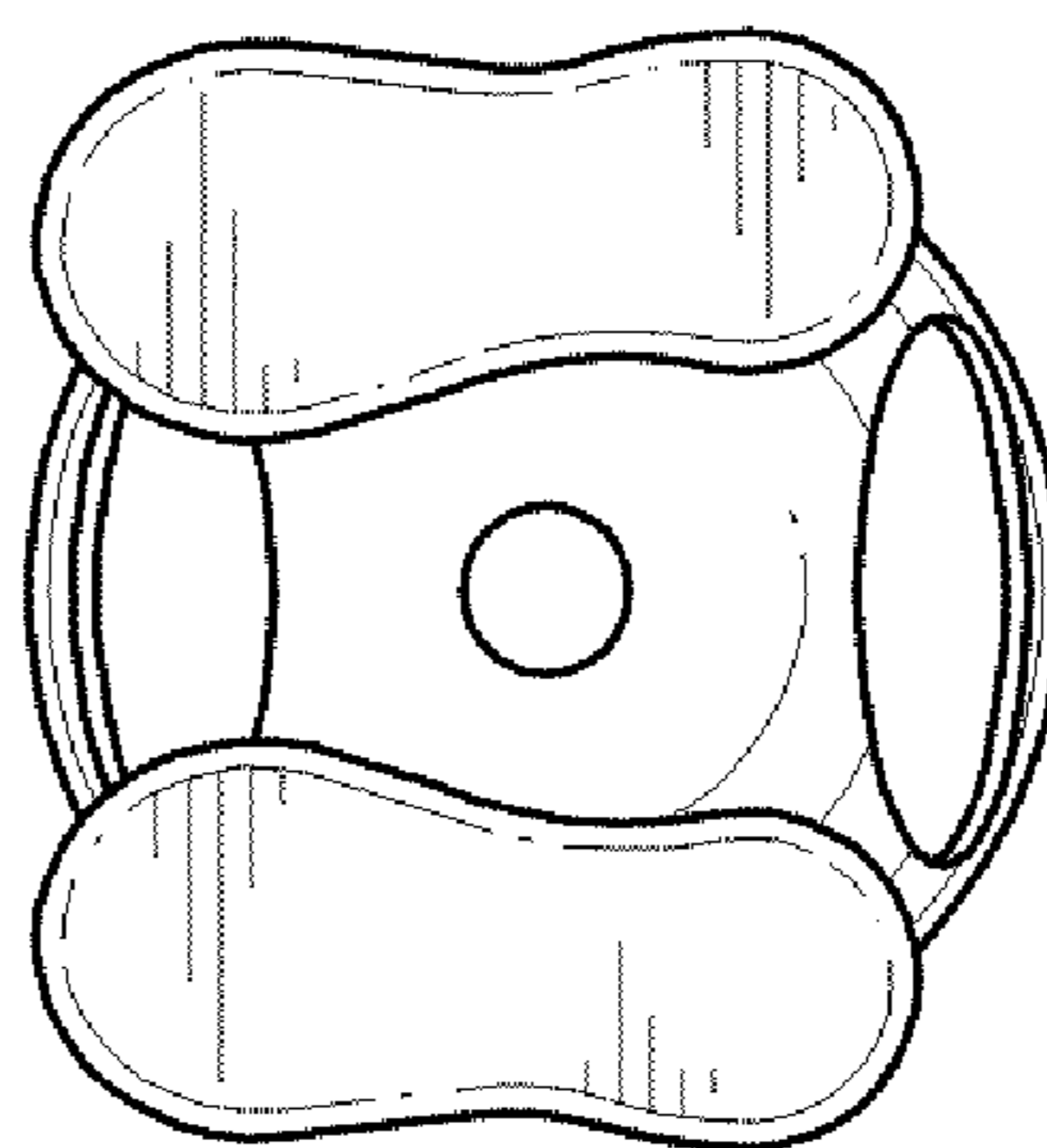
