DESCRIPTION

FIG. 1 is a perspective view, taken from the front, right side, of the infant carrier according to my design;

FIG. 2 is a front view thereof;

FIG. 3 is rear view thereof;

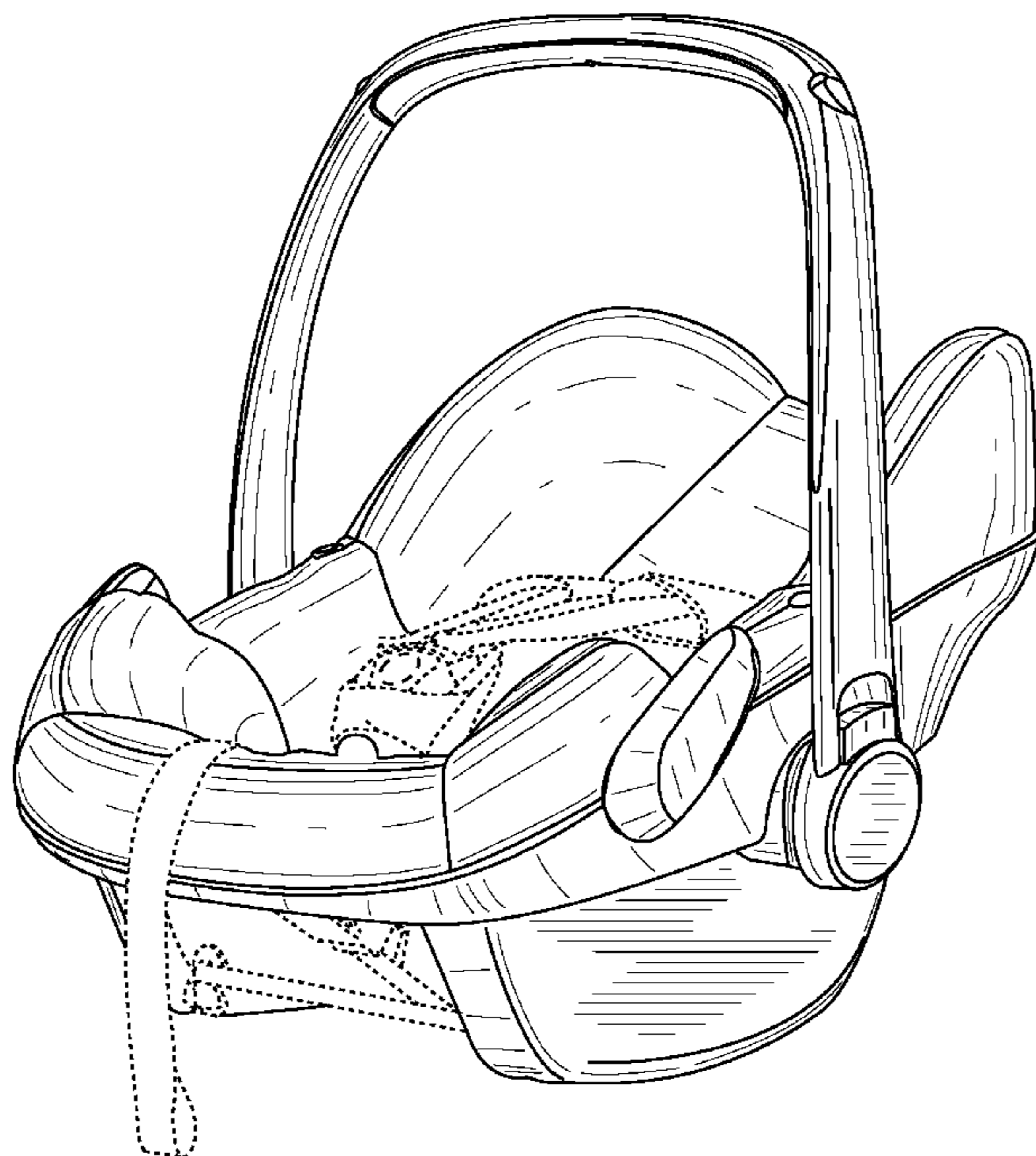
FIG. 4 is a left side view thereof, the right side view being a mirror image thereof;

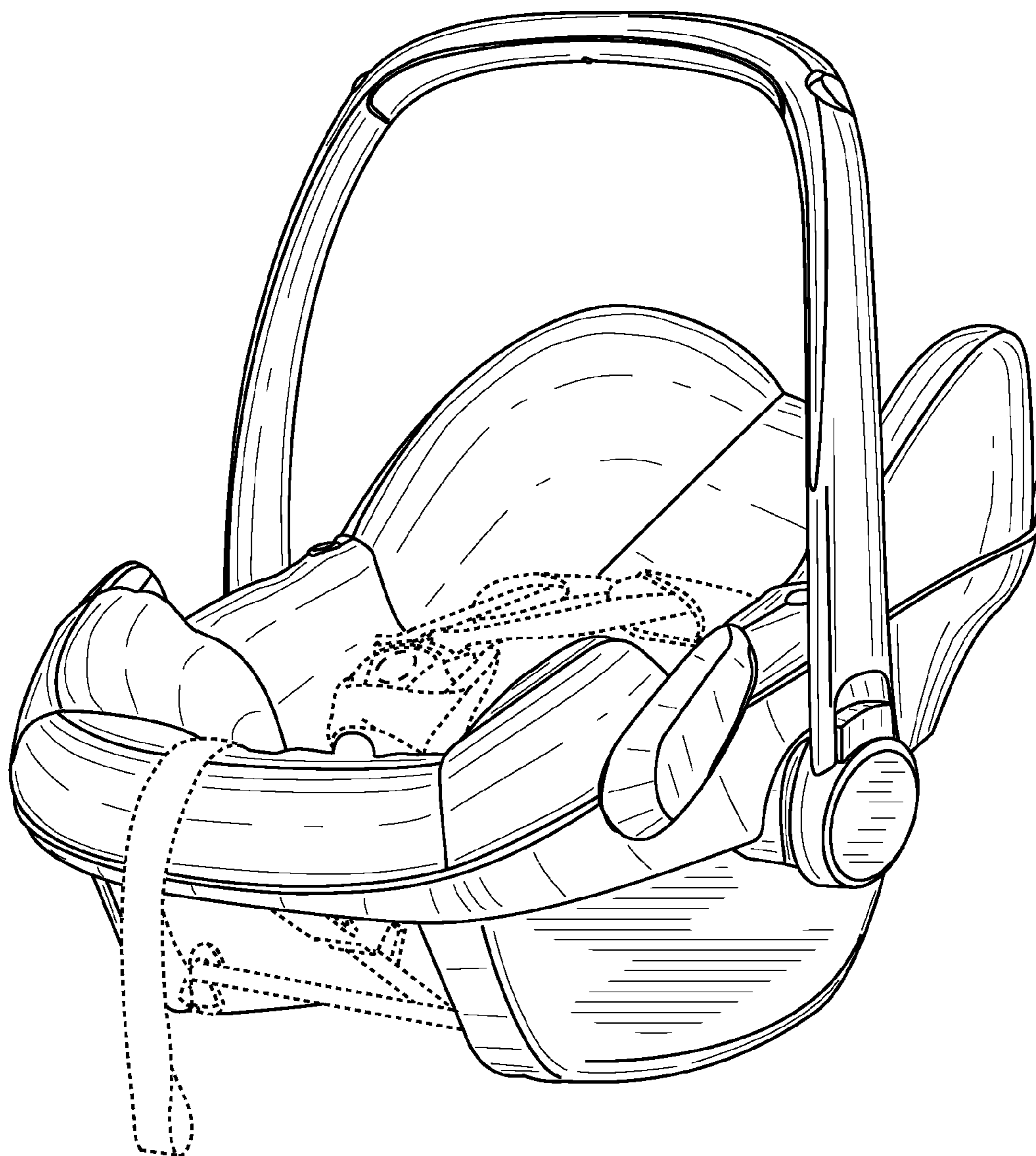

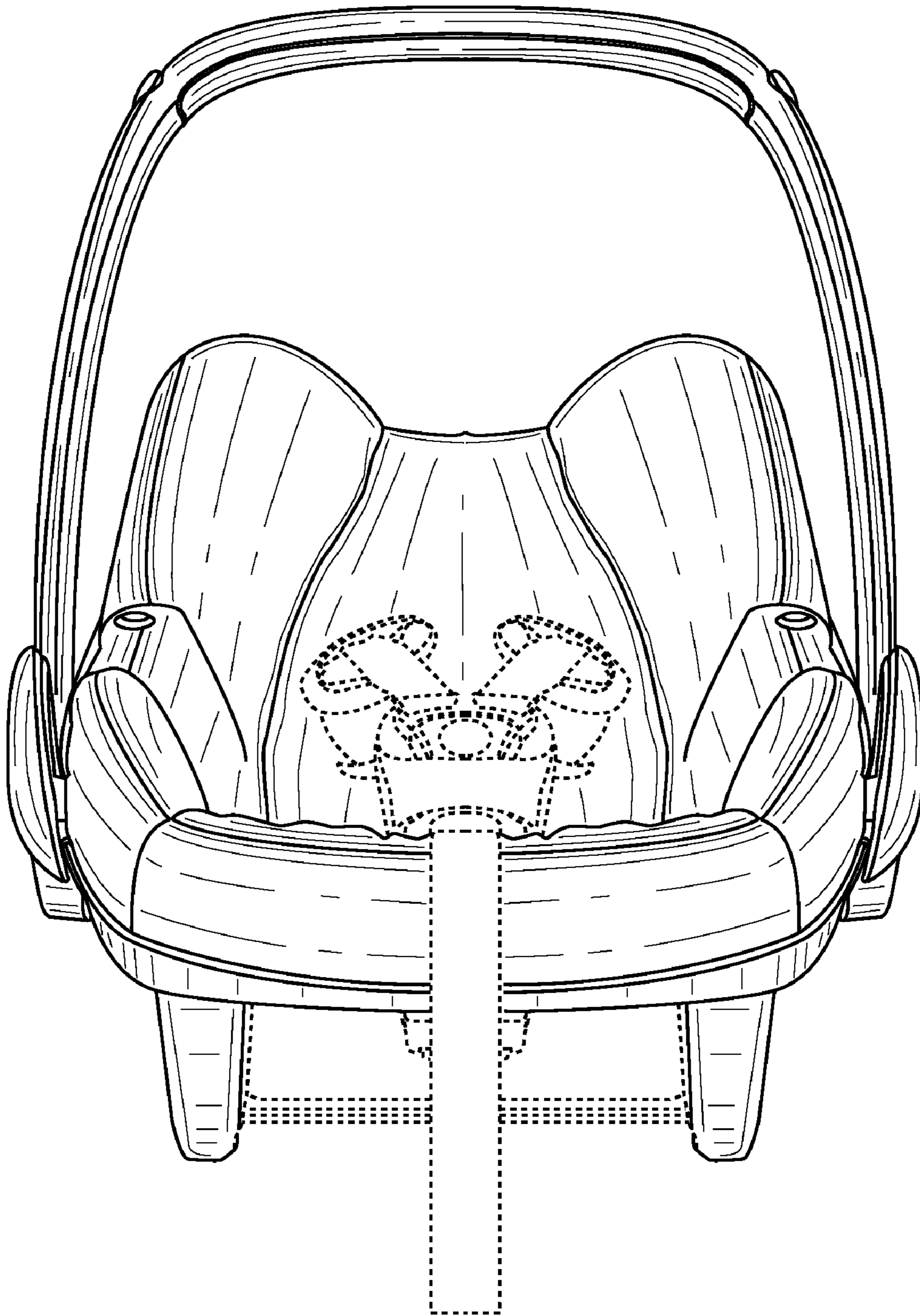

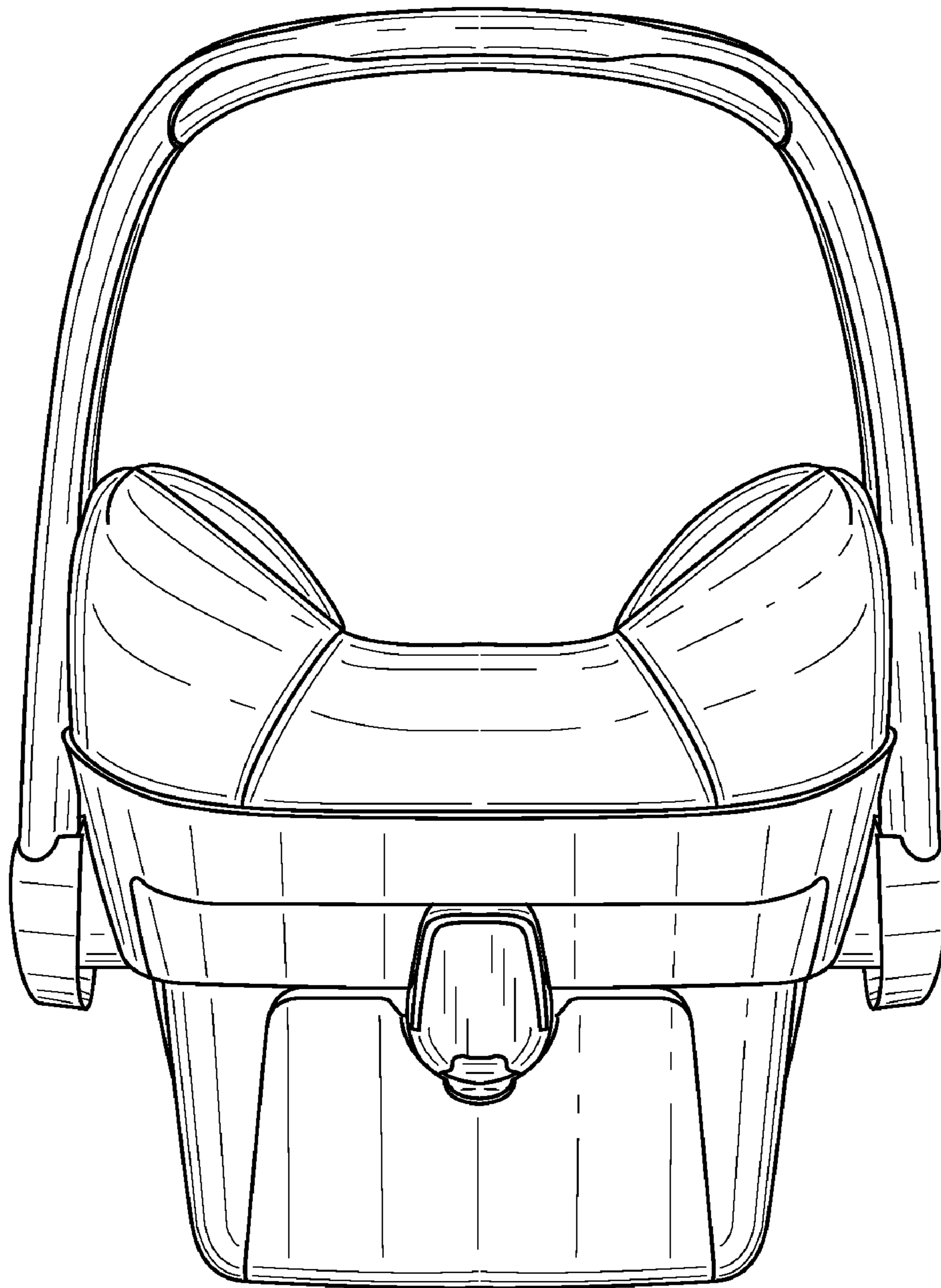

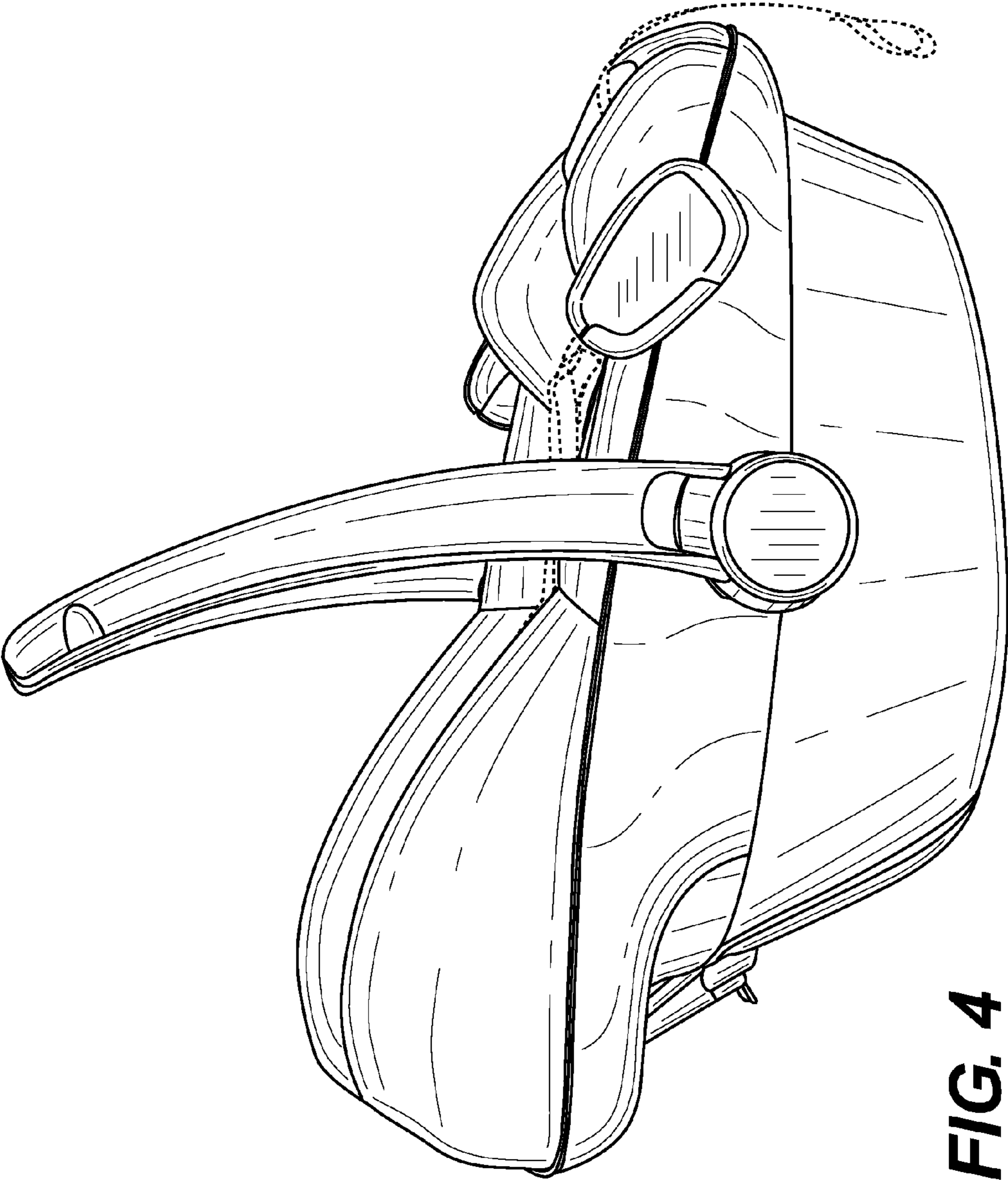

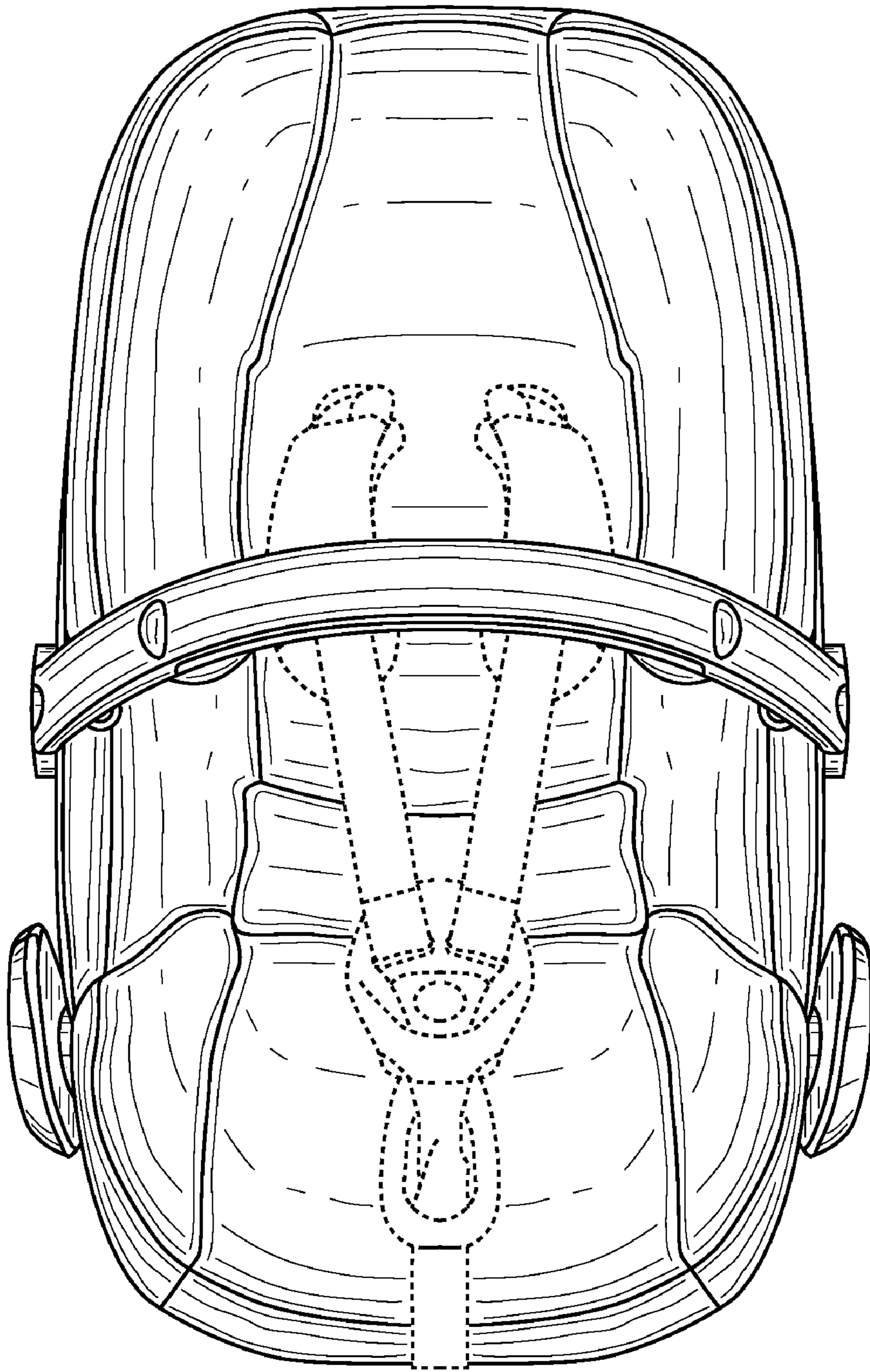

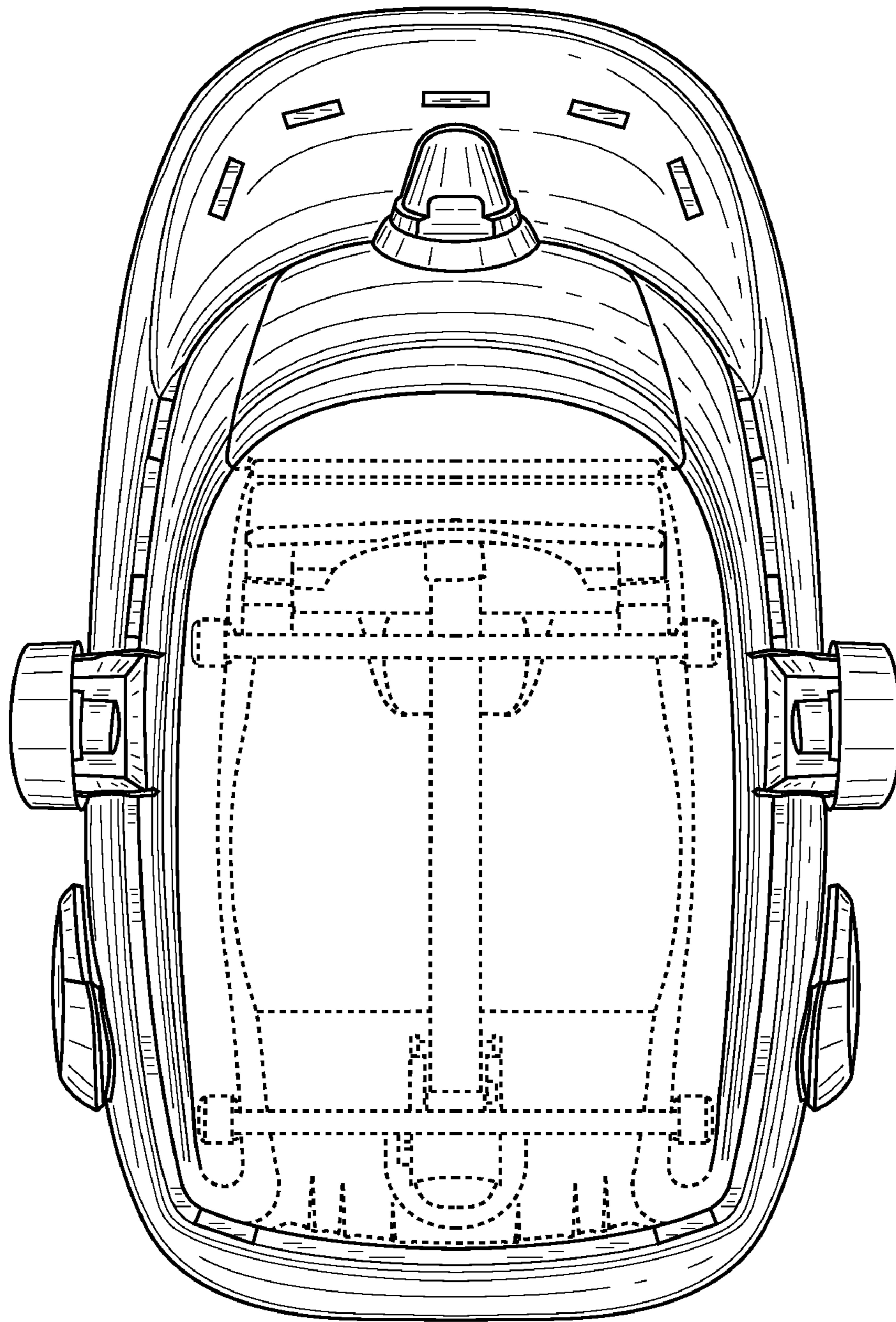
