FIG. 3 is a top view thereof,

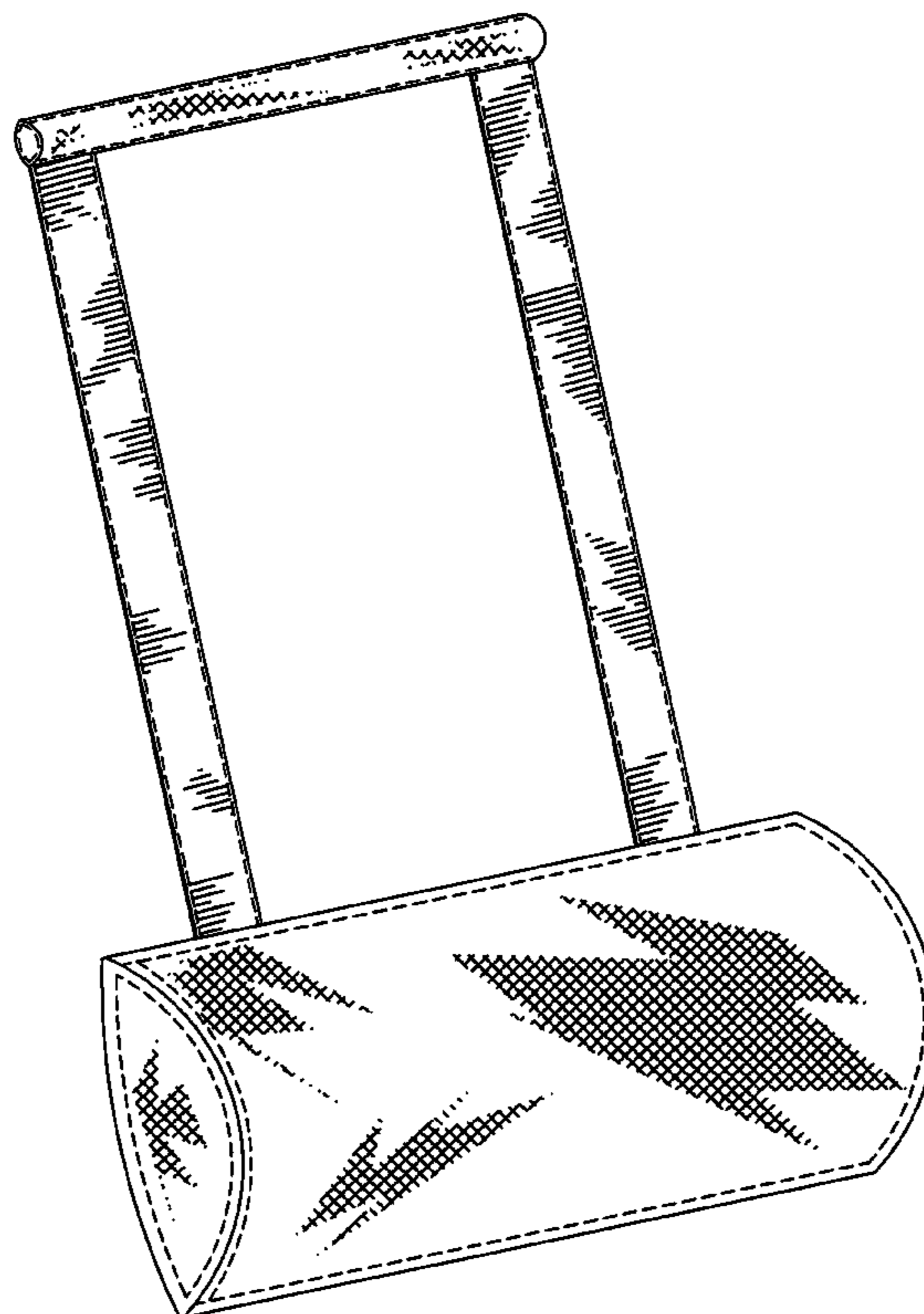
FIG. 4 is a bottom view thereof,

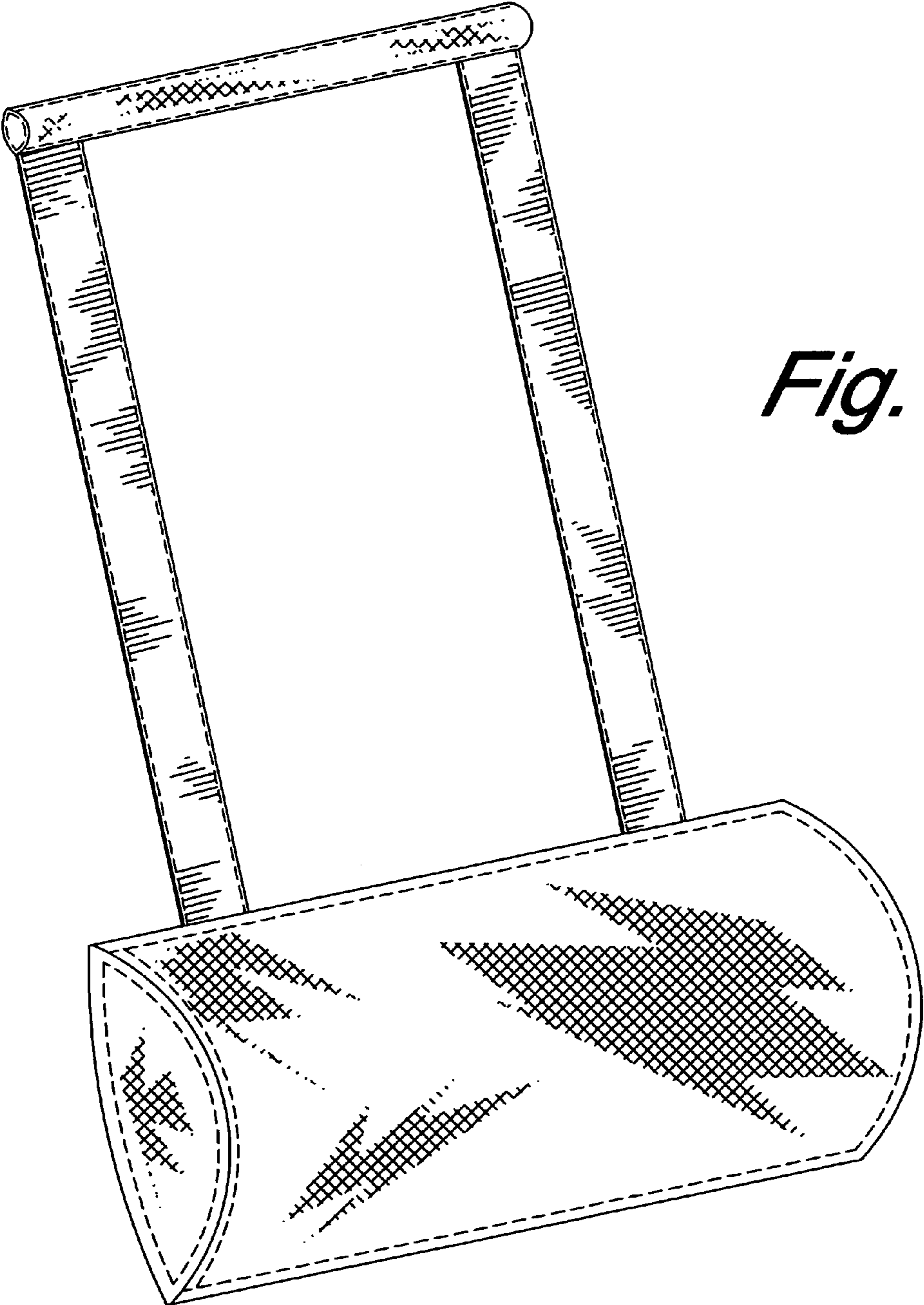
FIG. 5 is a right view thereof; and,

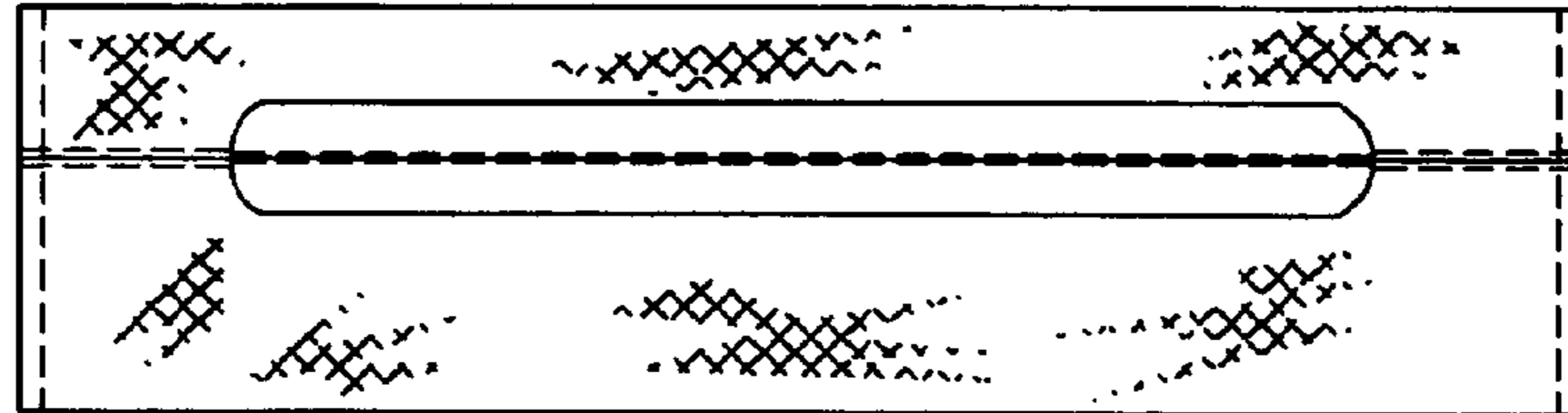




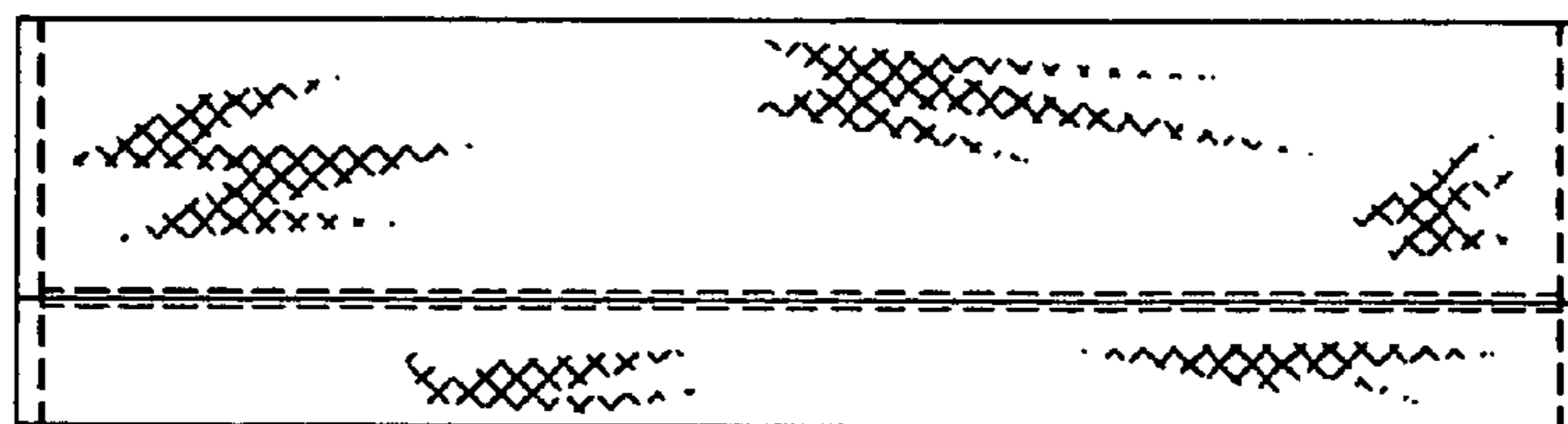

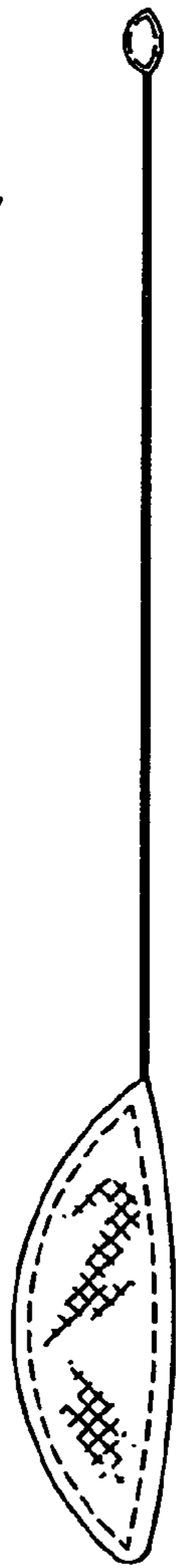
