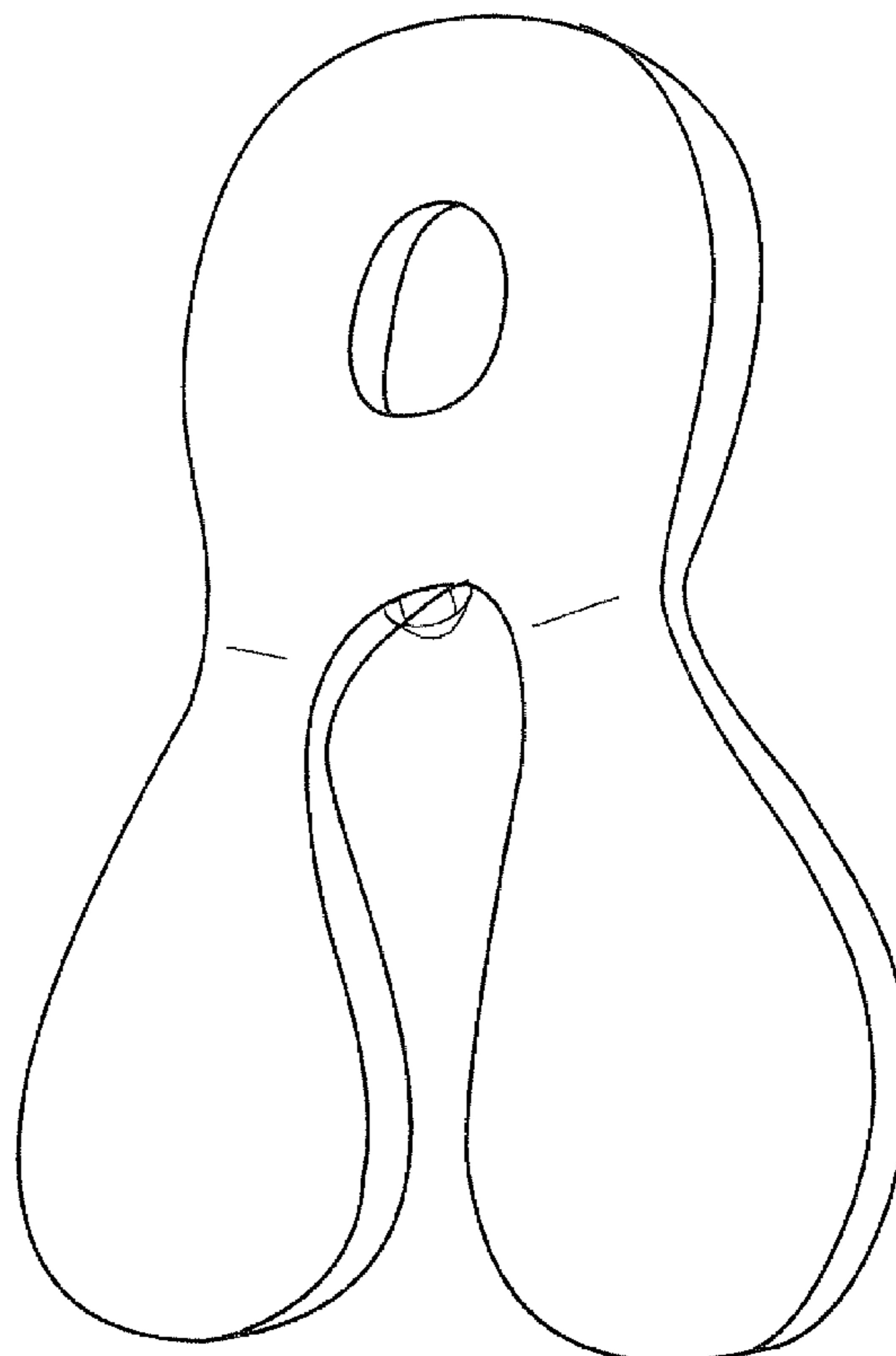
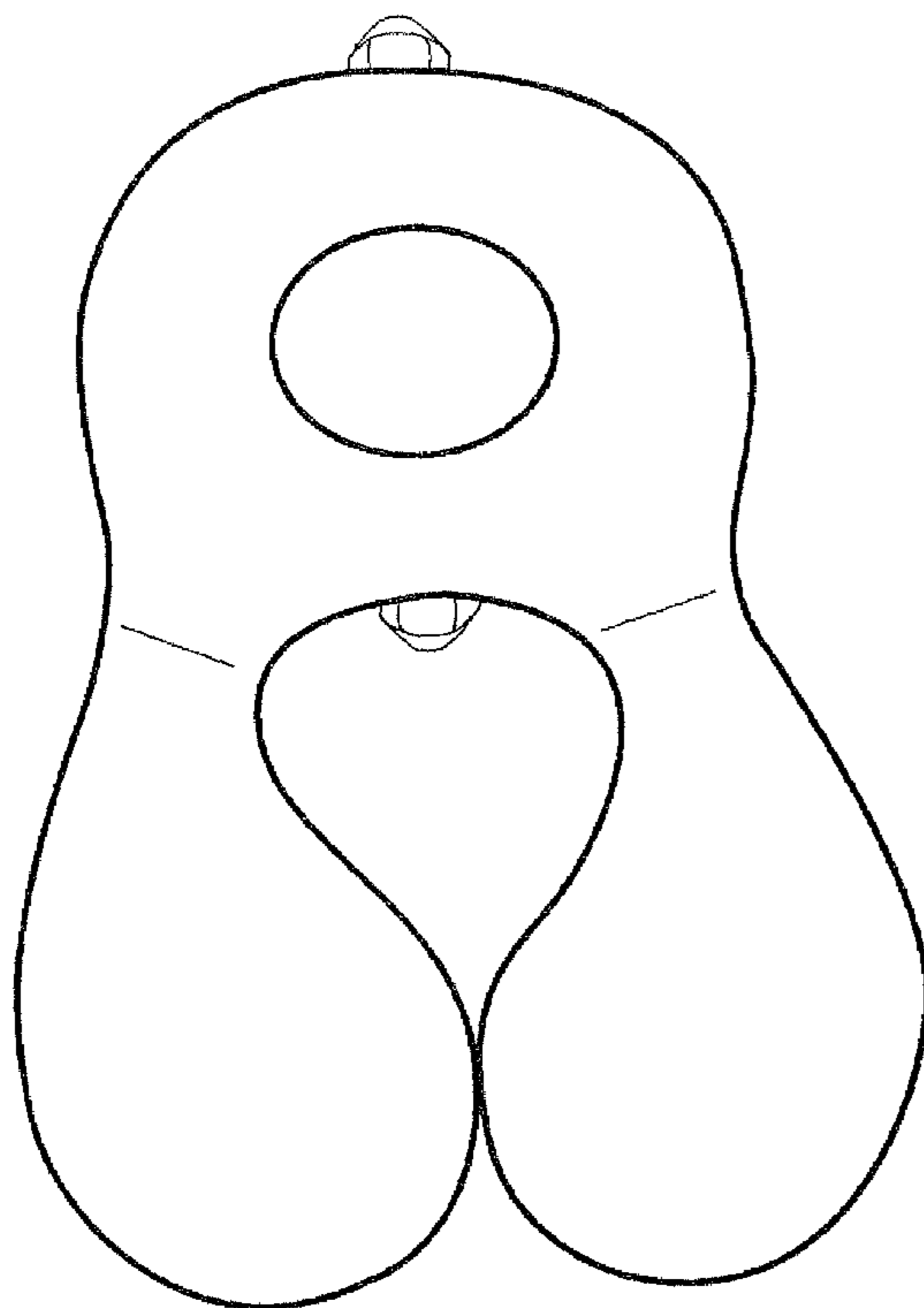
(57) **CLAIM**

The ornamental design for a head rest, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a head rest, showing our new design, in closed position;
FIG. 2 is a rear elevational view thereof;

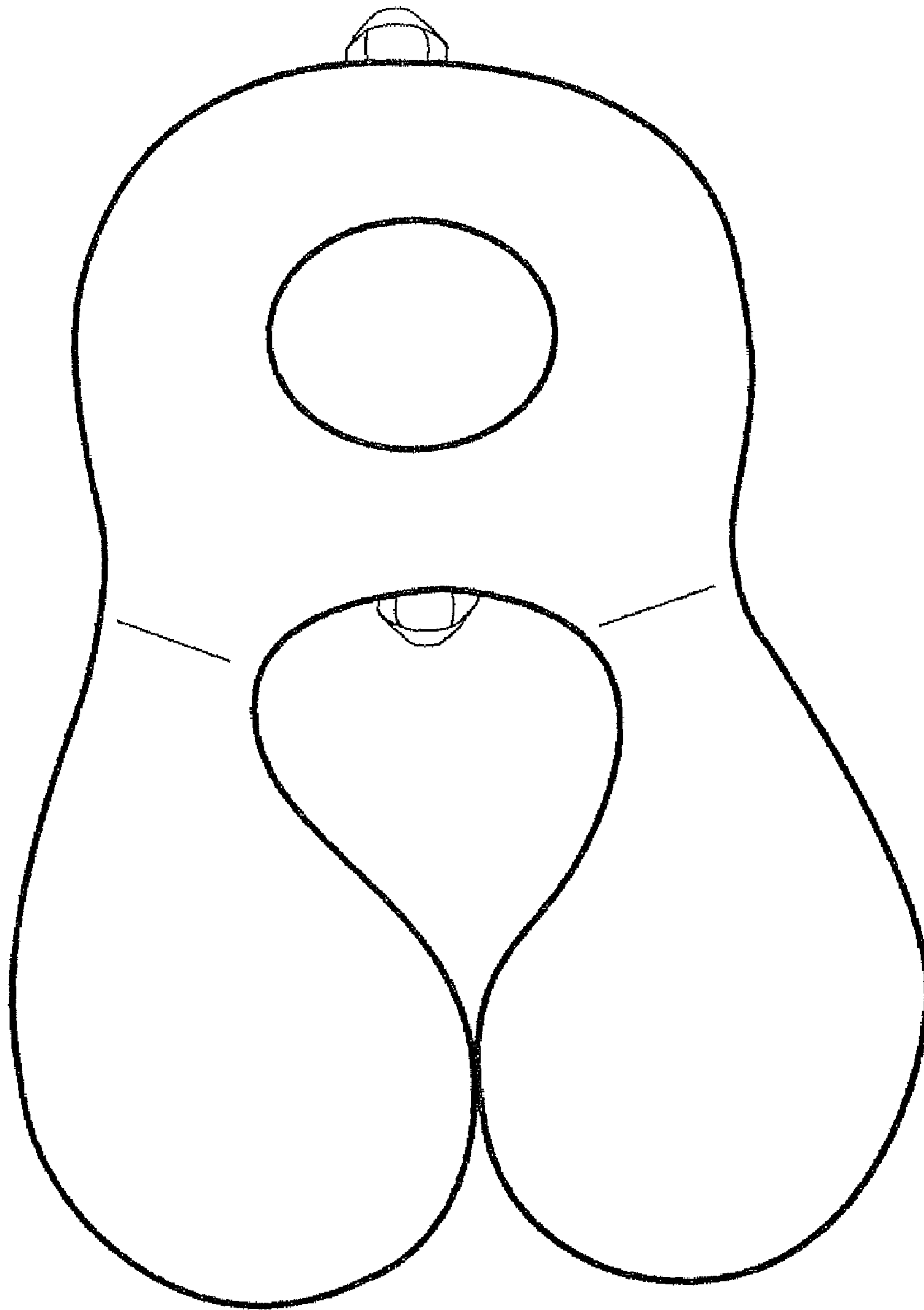

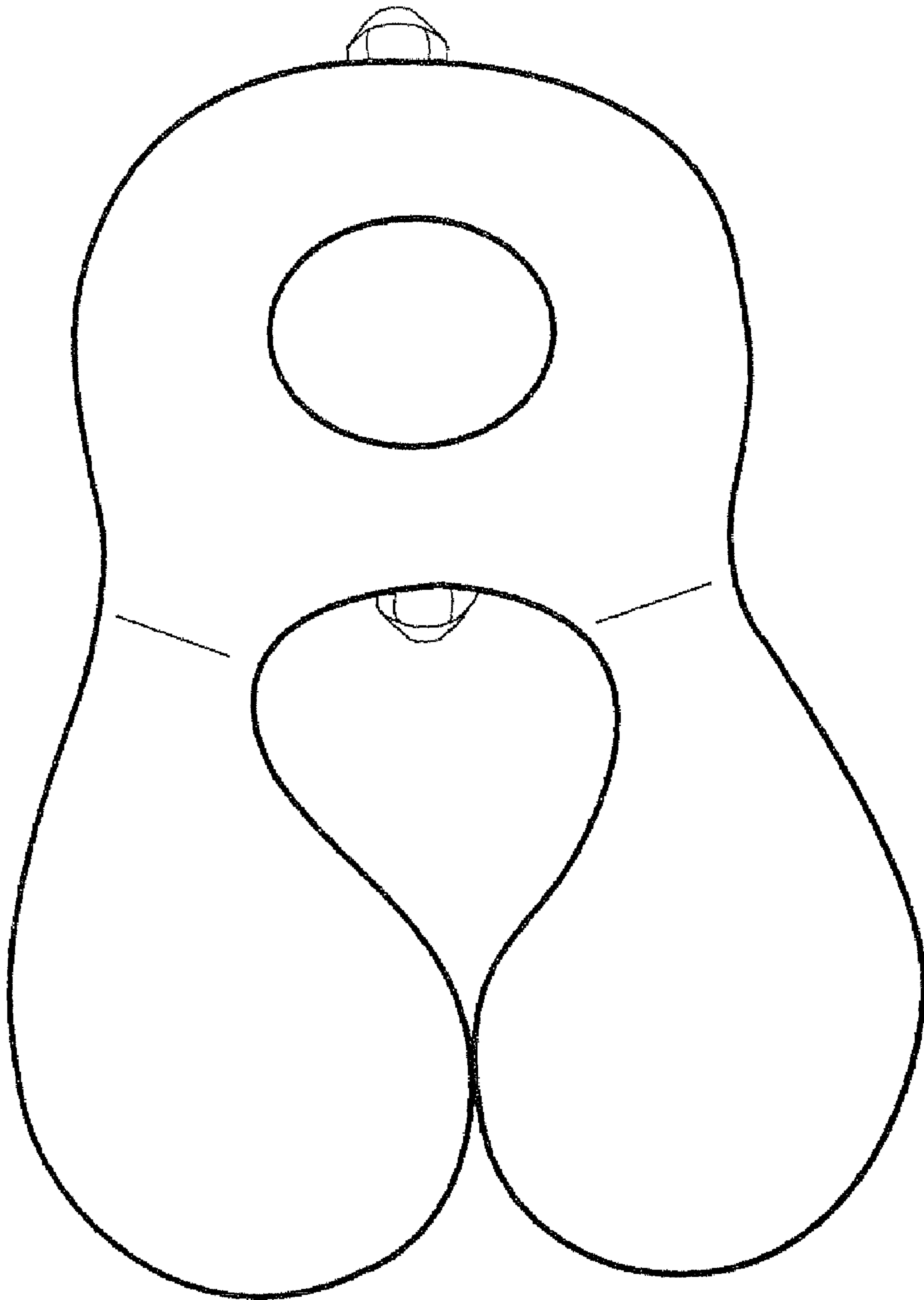

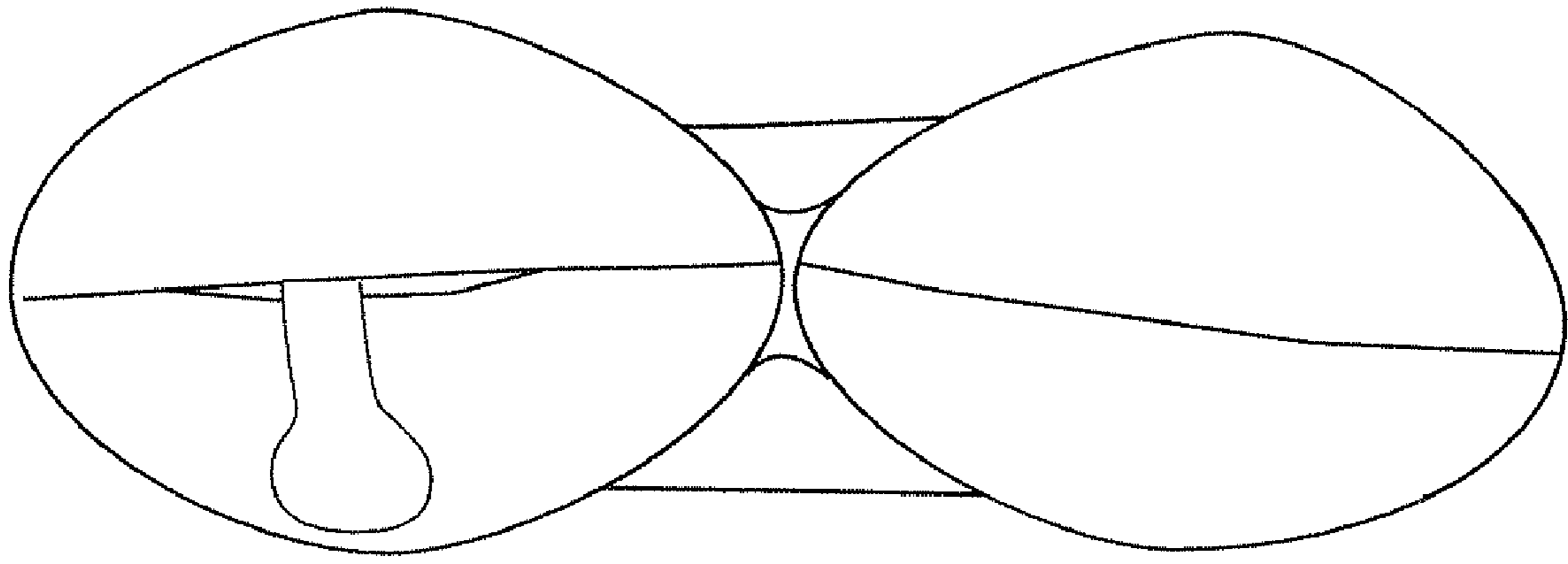

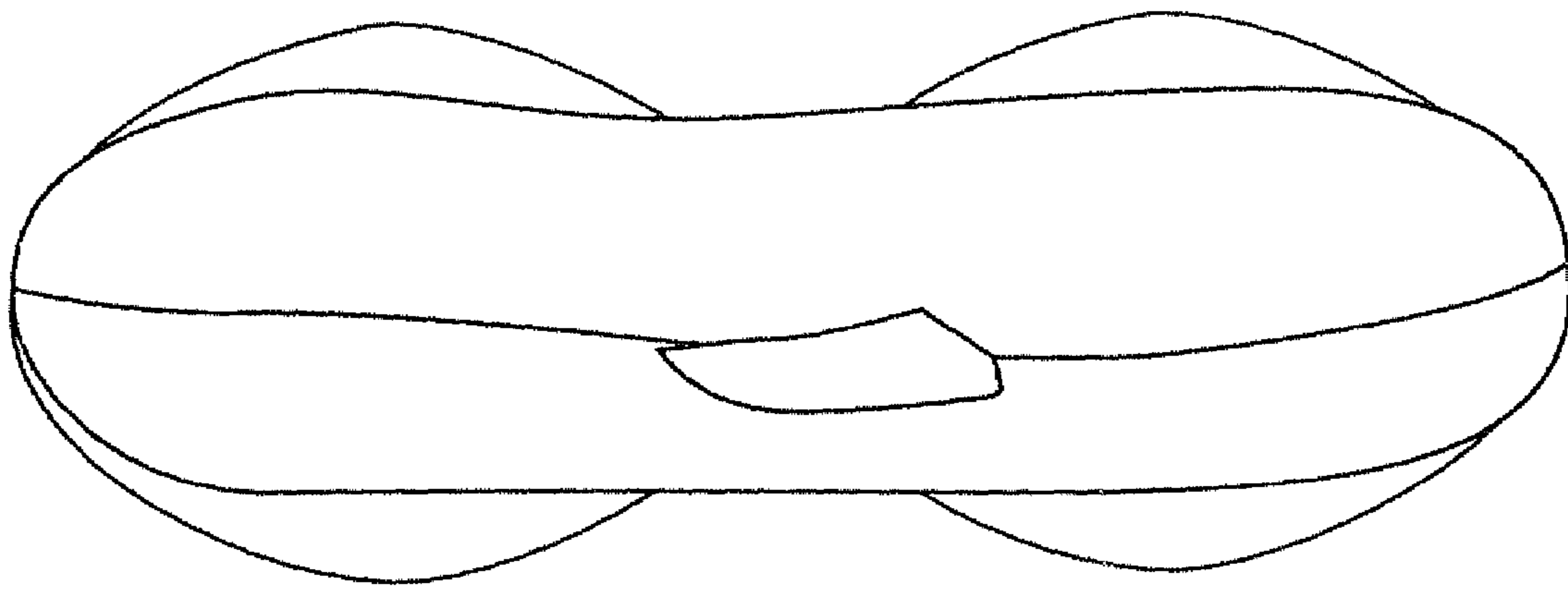

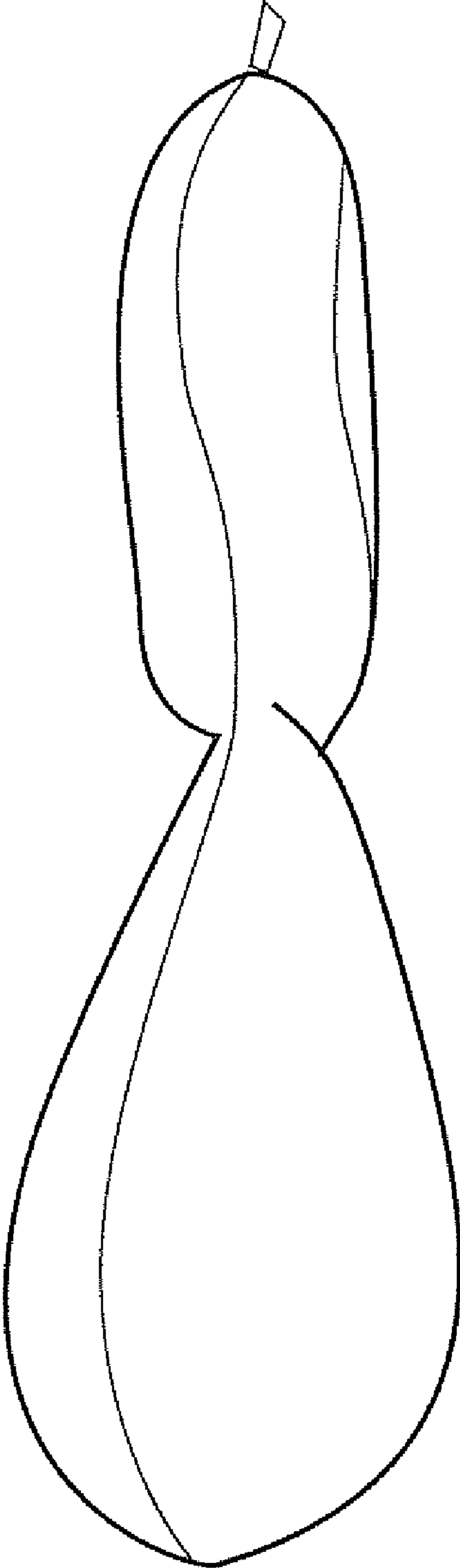

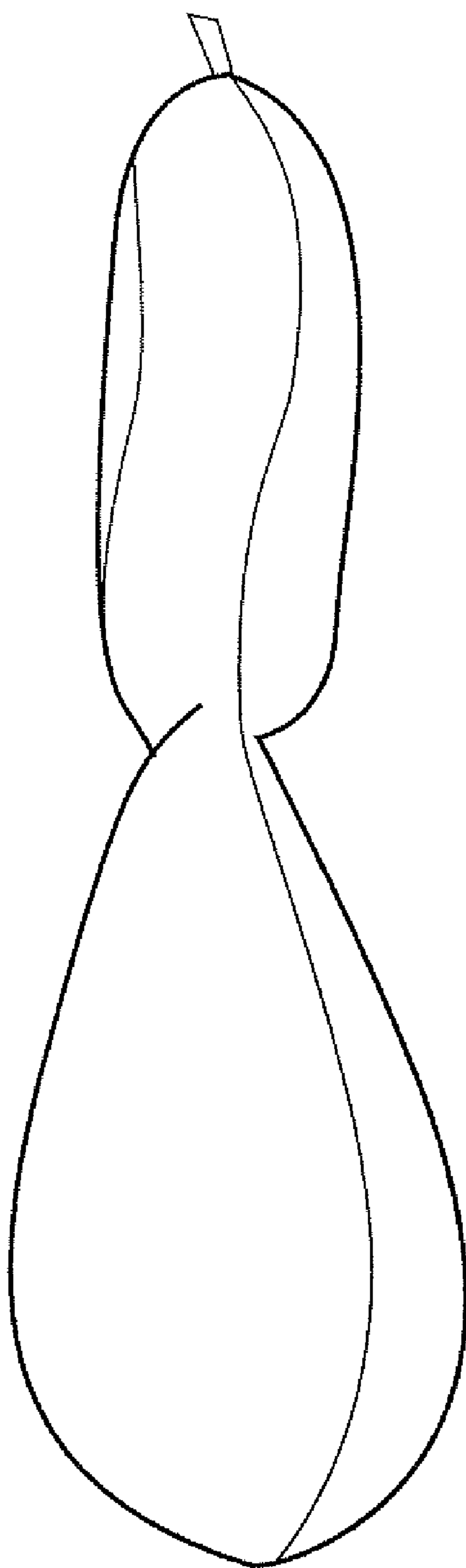

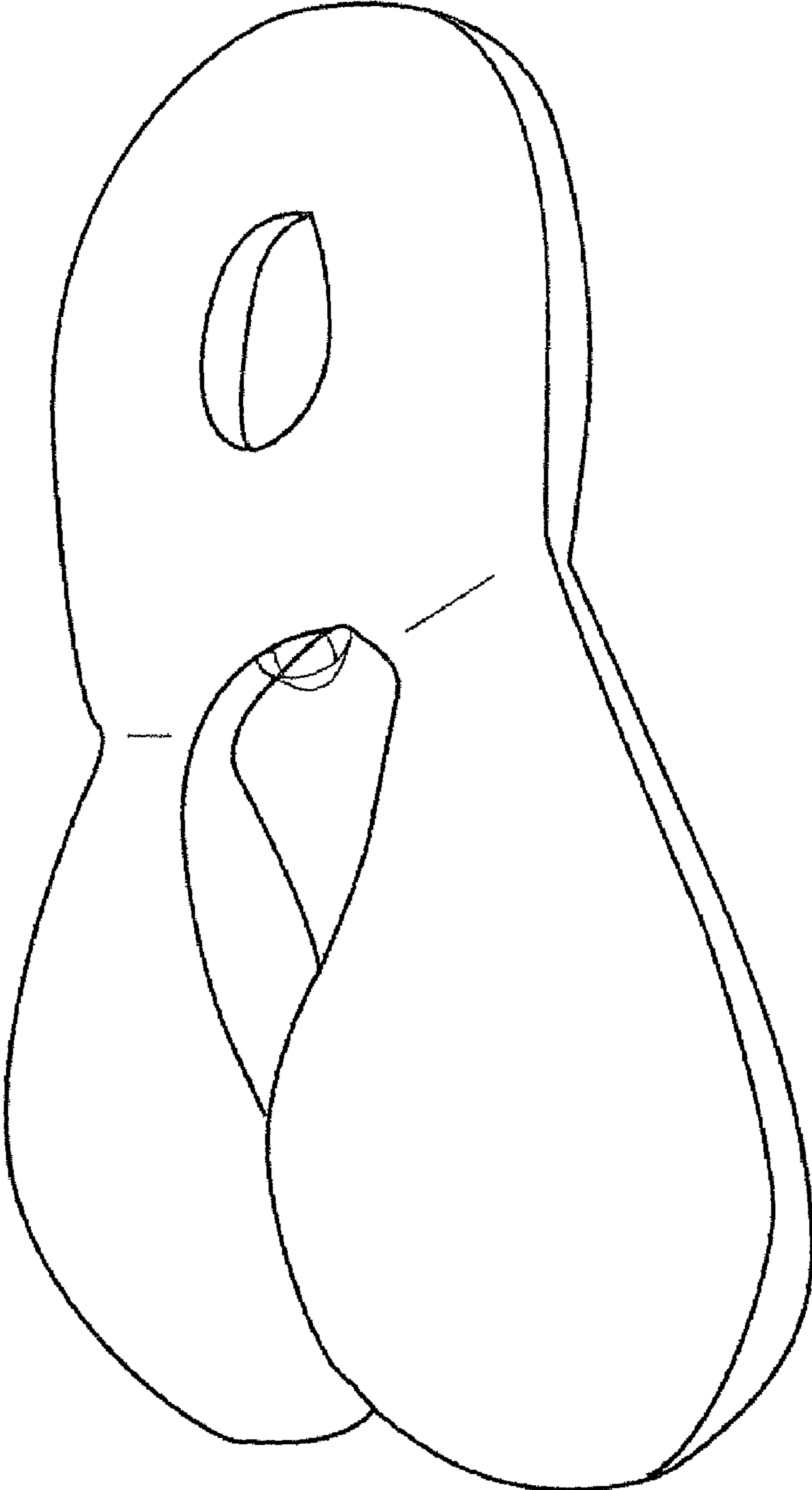

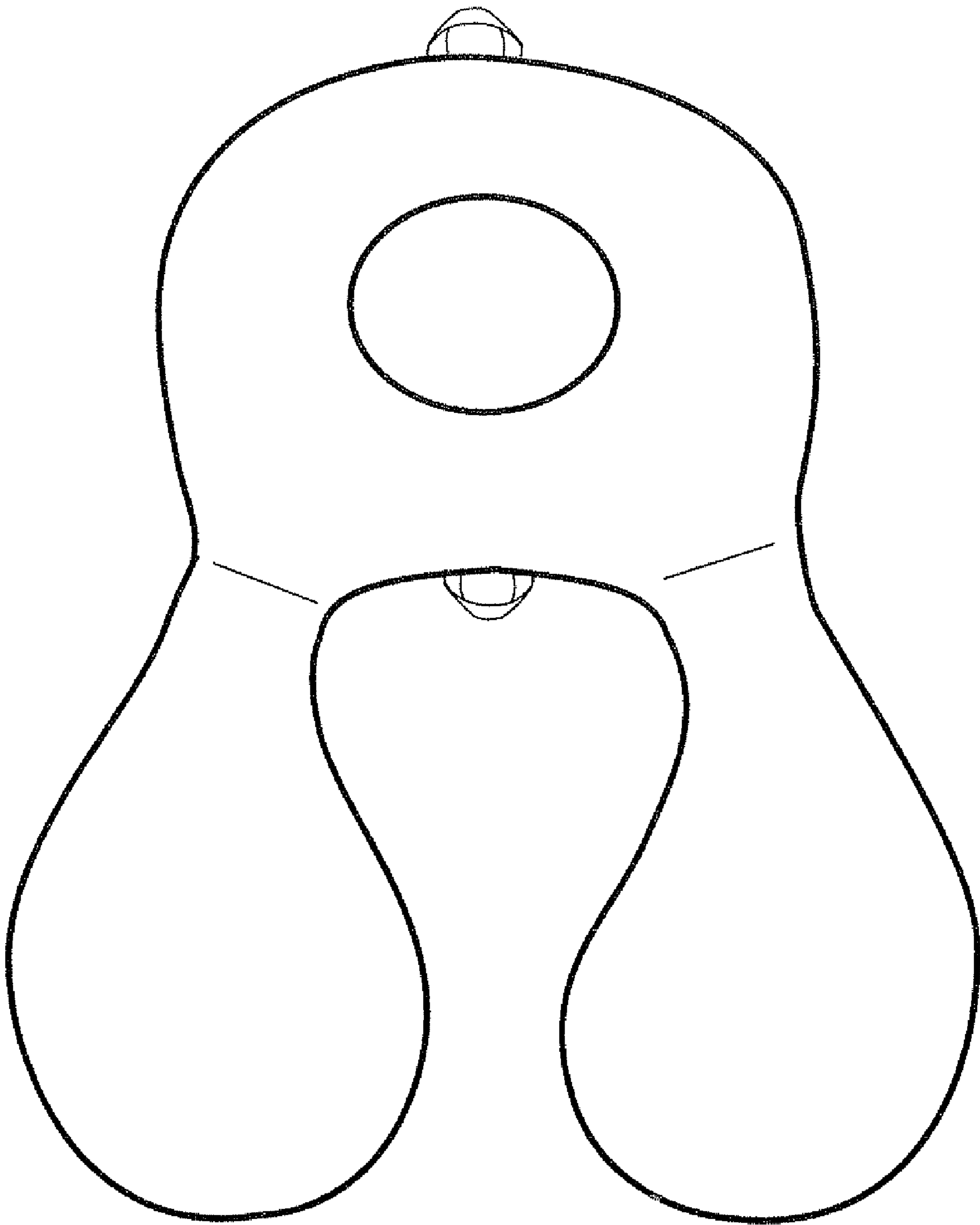

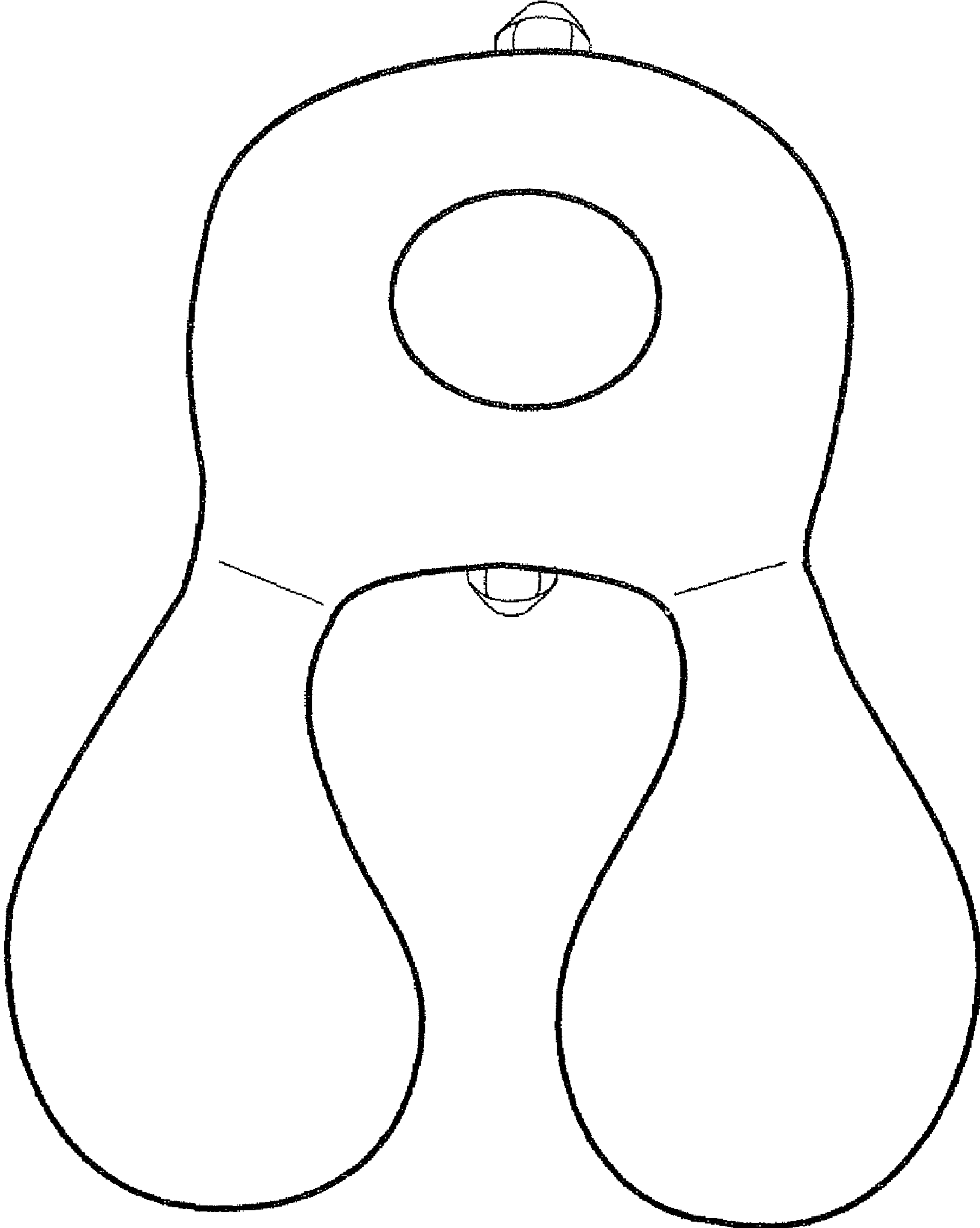

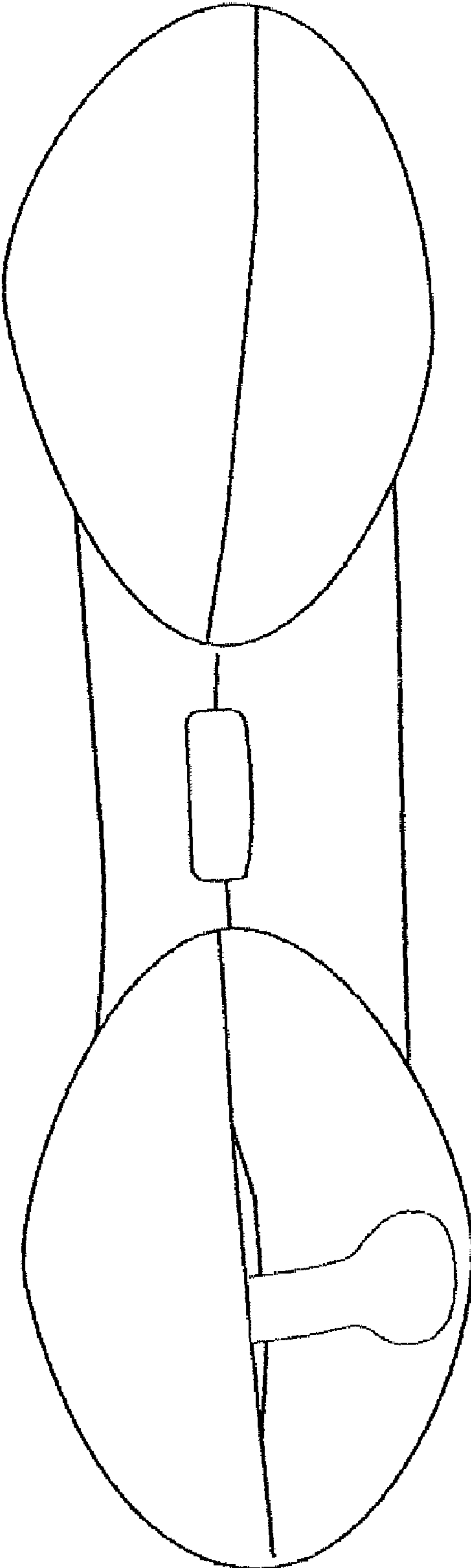

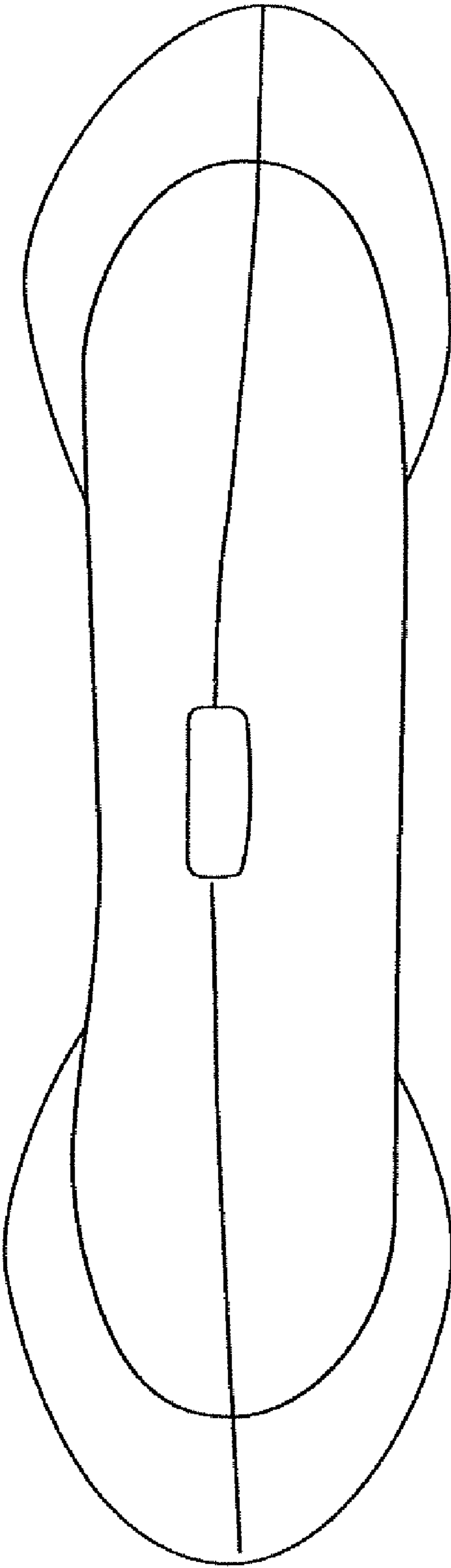

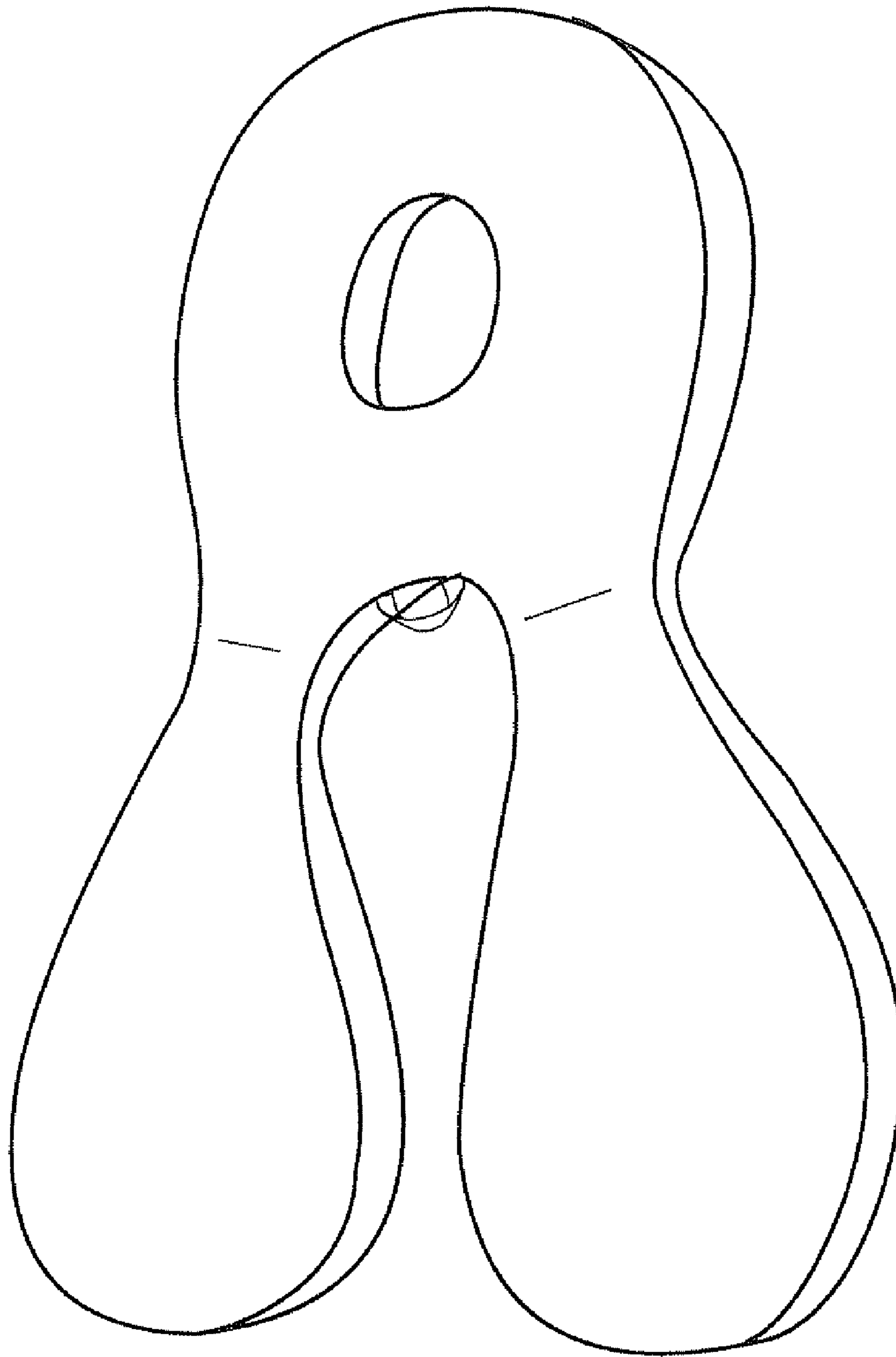
