FIG. 5 is a perspective view of a food and beverage tray taken from the front, top and right.

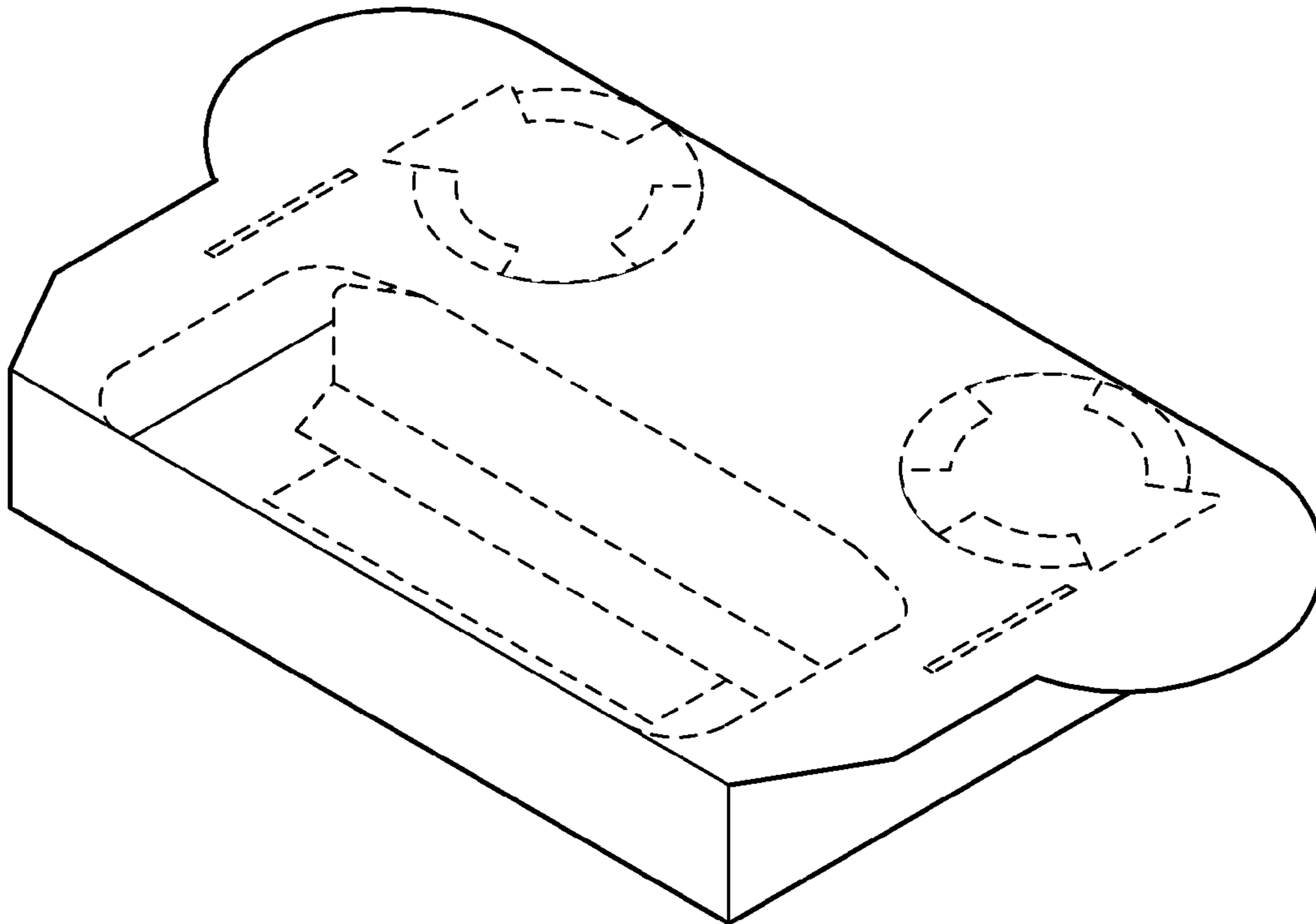

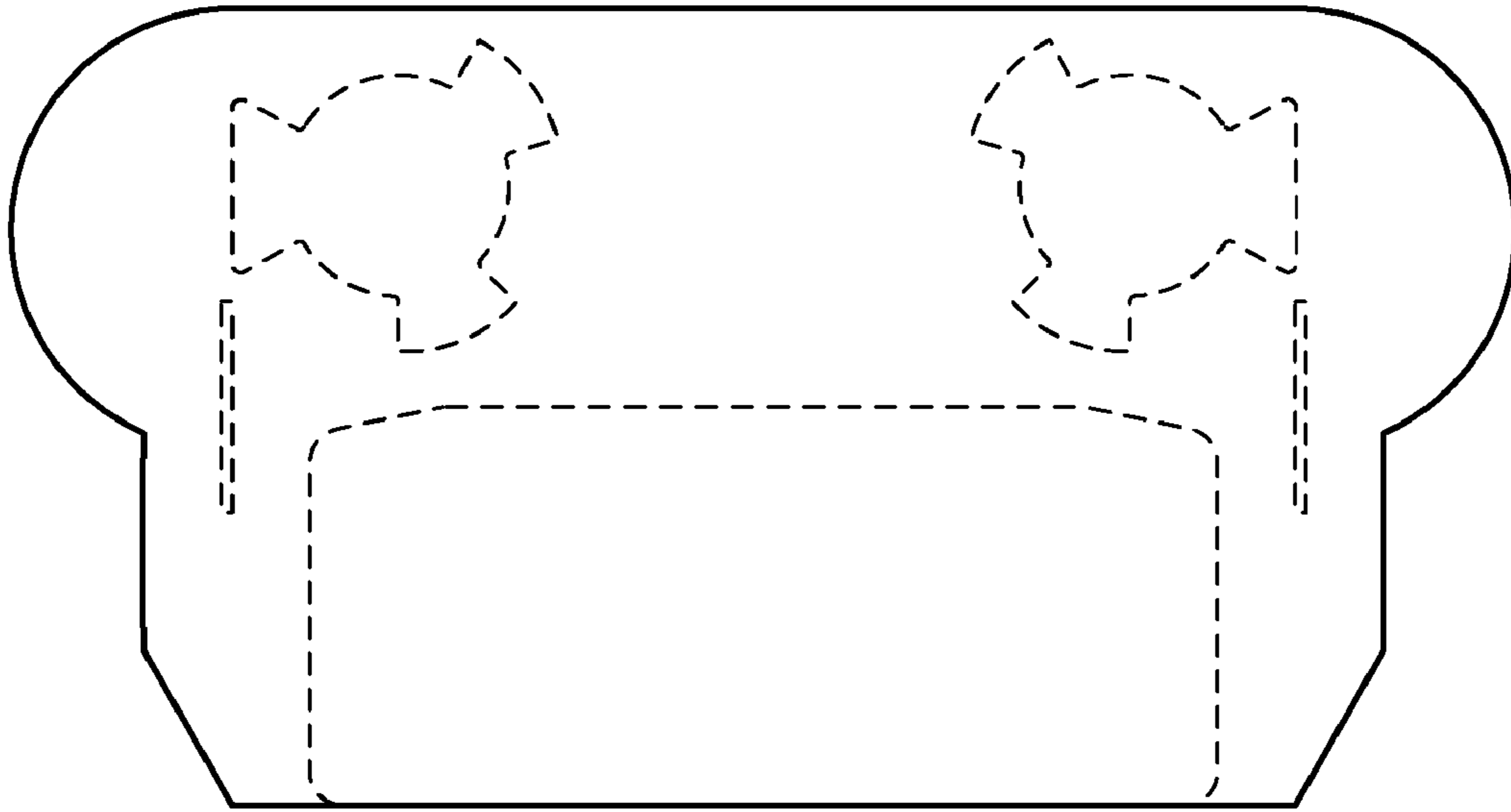

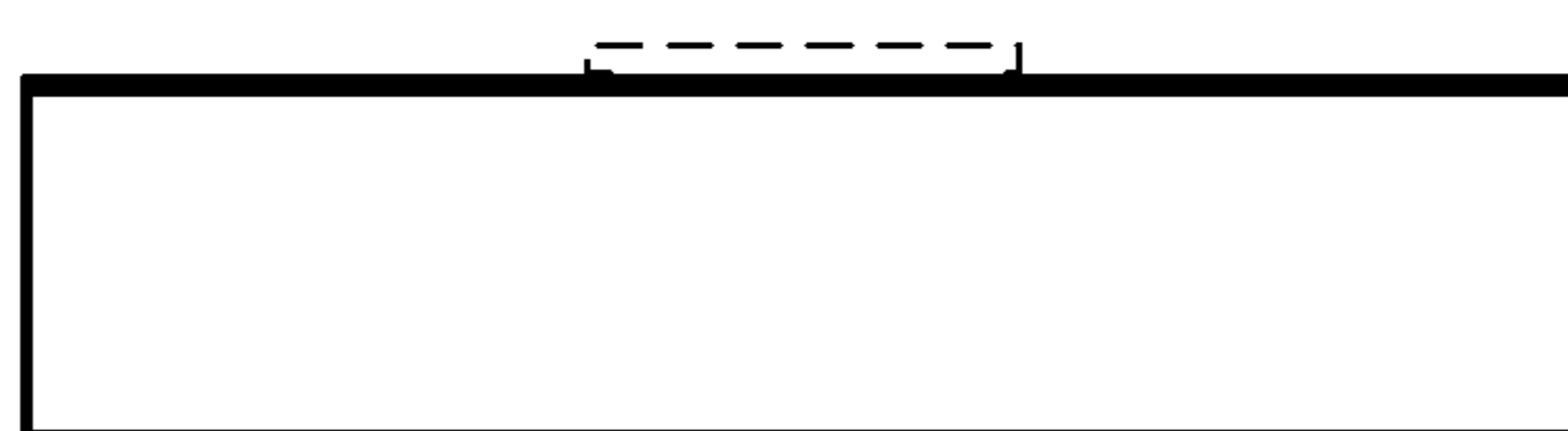

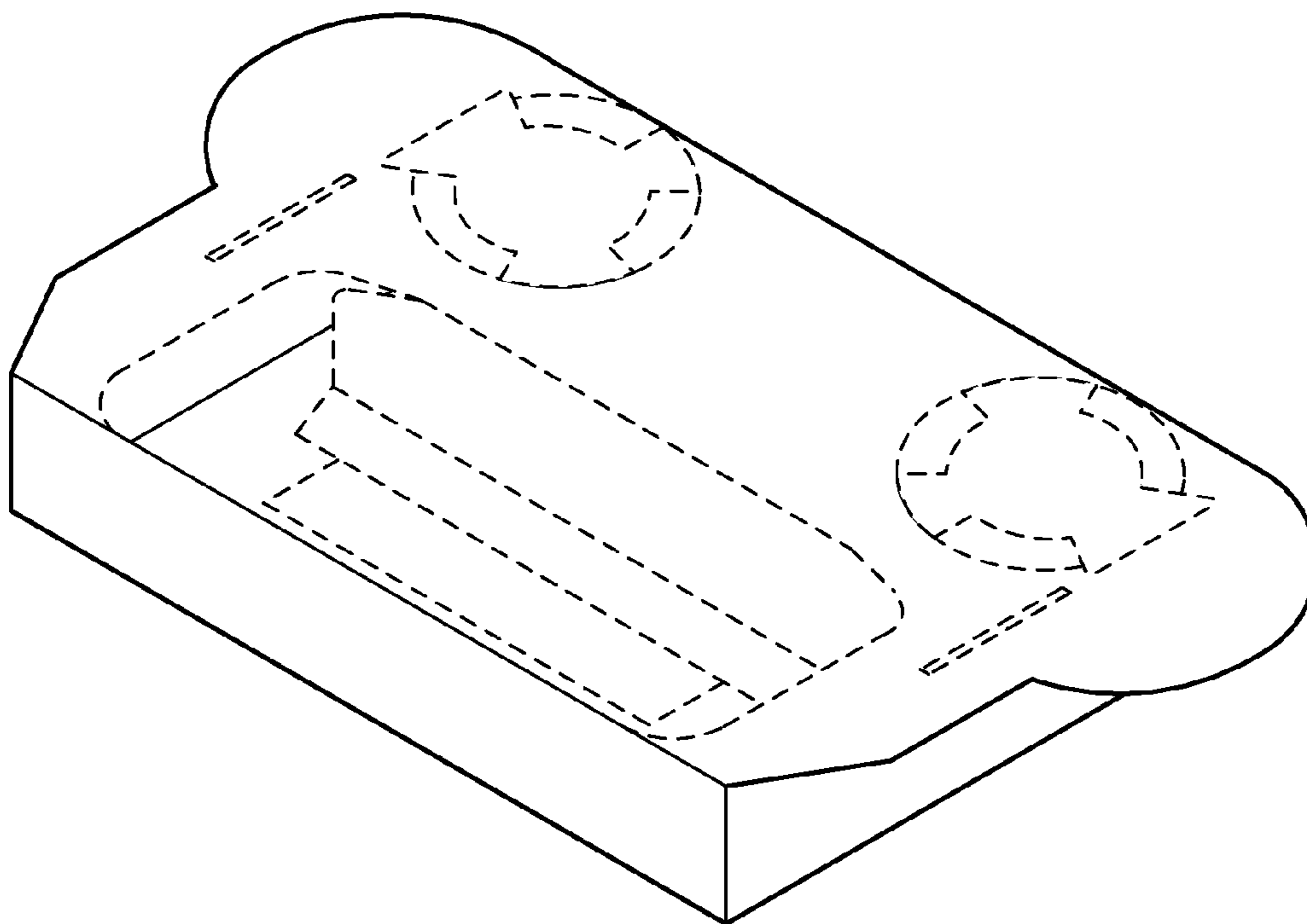
