(57) **CLAIM**

The ornamental design for multi-sized offset handle tongue and groove pliers, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the first embodiment of my design.

FIG. 2 is a front view thereof.

FIG. 4 is the top plan view thereof.

FIG. 5 is a left side elevational view thereof; the left side elevational views of embodiments 2 and 3 being identical to this view.

FIG. 12 is a bottom plan view thereof.

FIG. 13 is a perspective view of the third embodiment of my design.

FIG. 17 is a bottom plan view thereof.

FIG. 18 is a perspective view of the fourth embodiment of my design.

FIG. 20 is a rear view thereof.

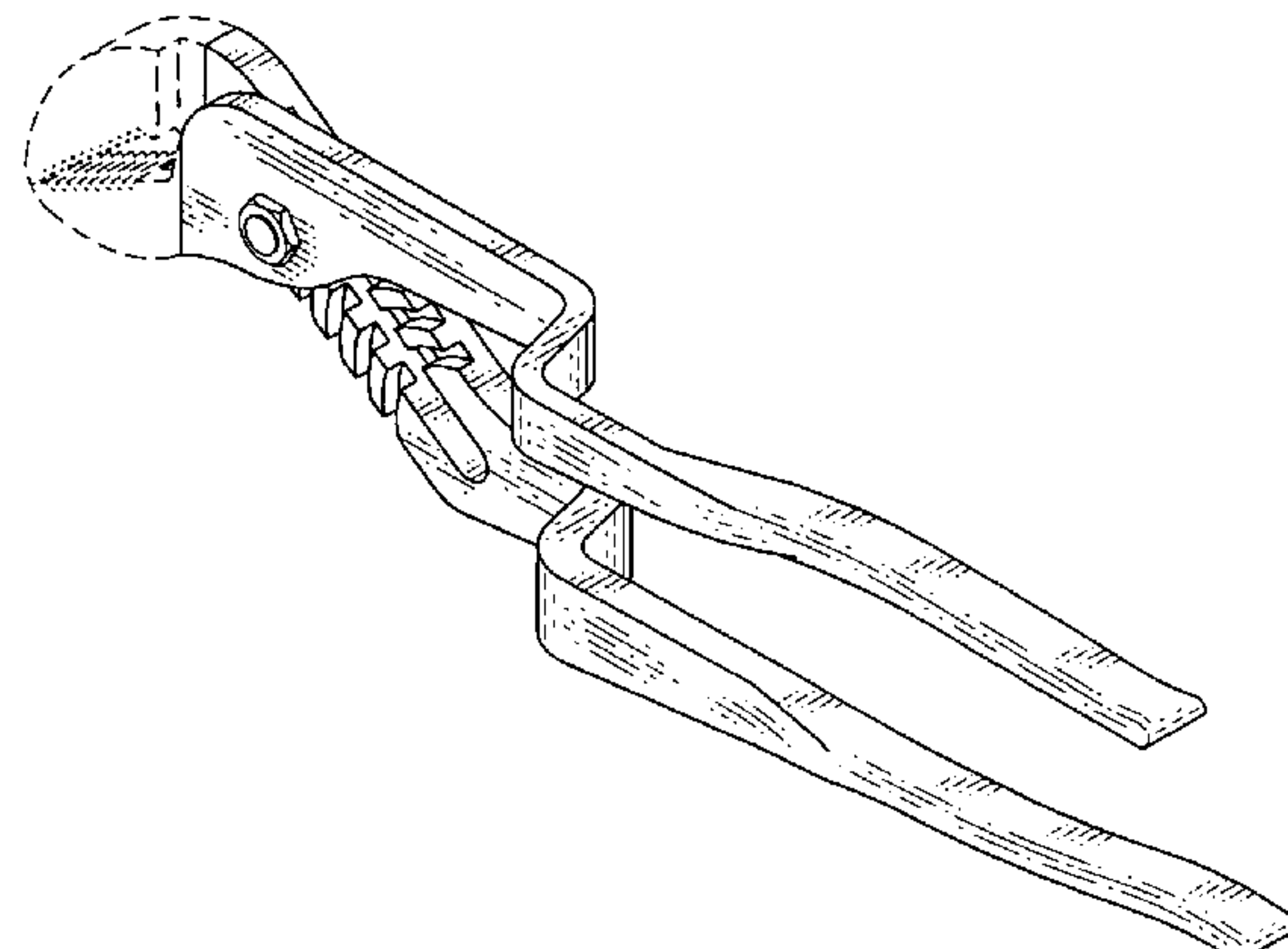
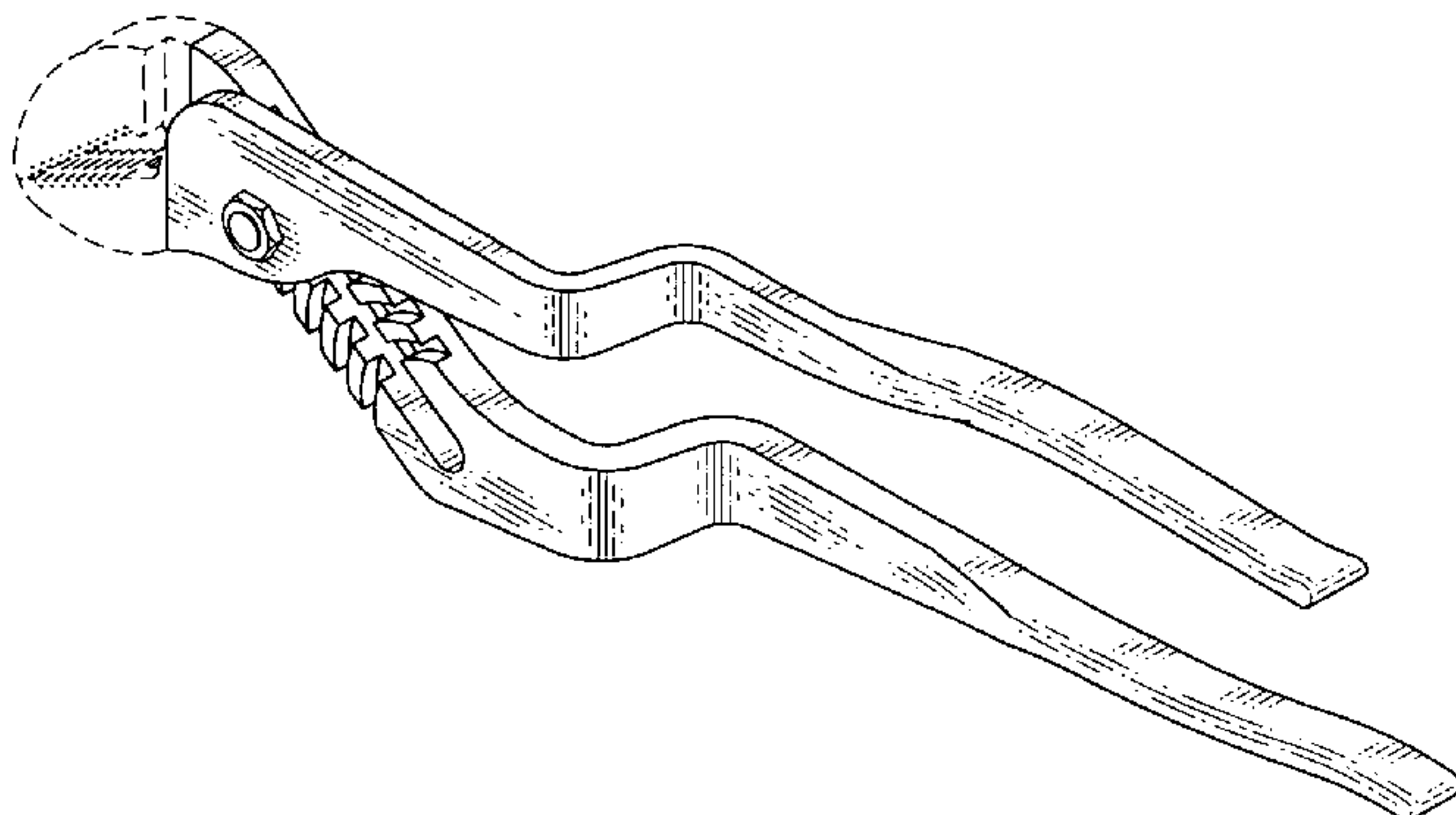


FIG. **21** is a top plan view of the right hand version of the first embodiment.

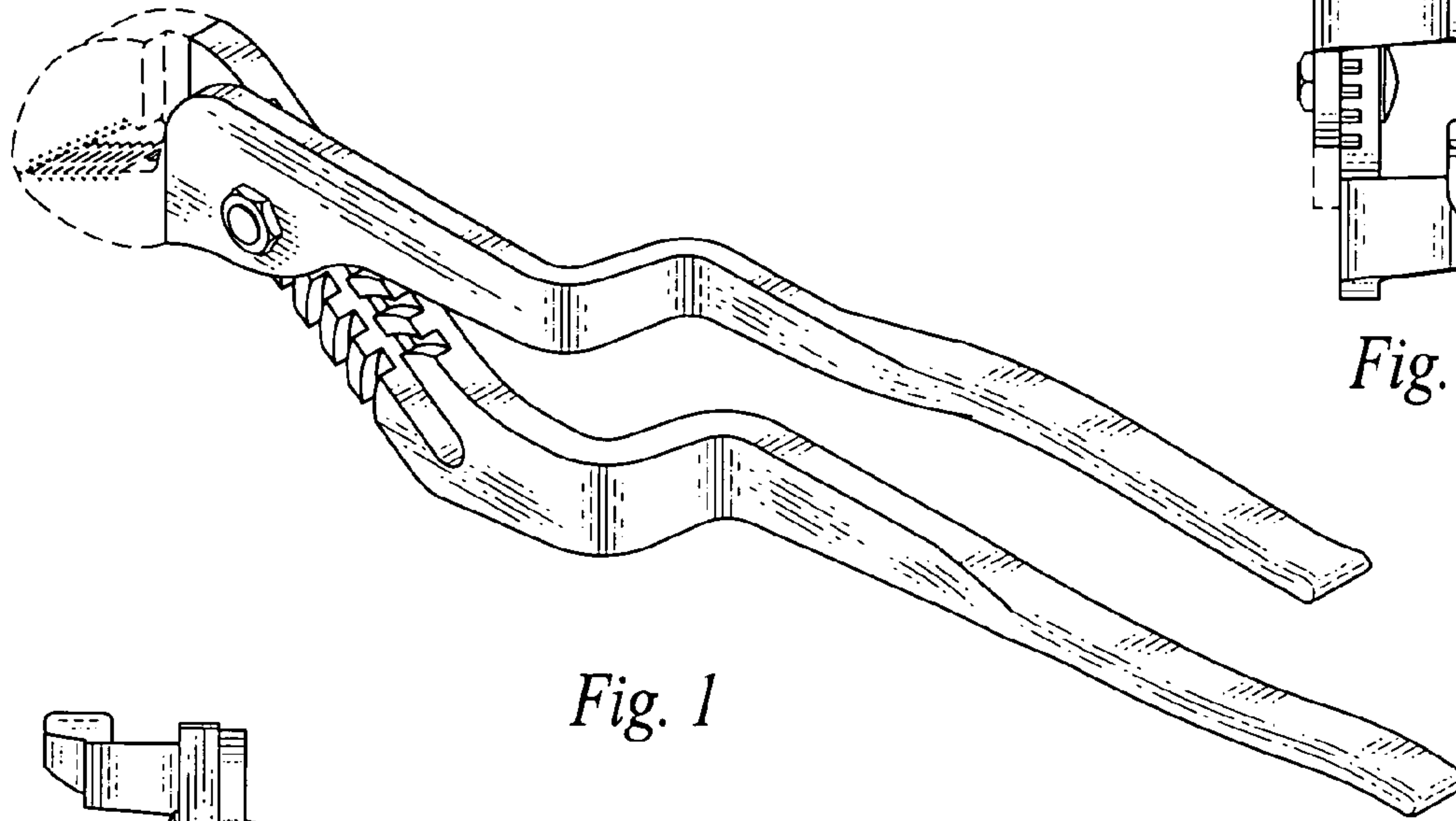

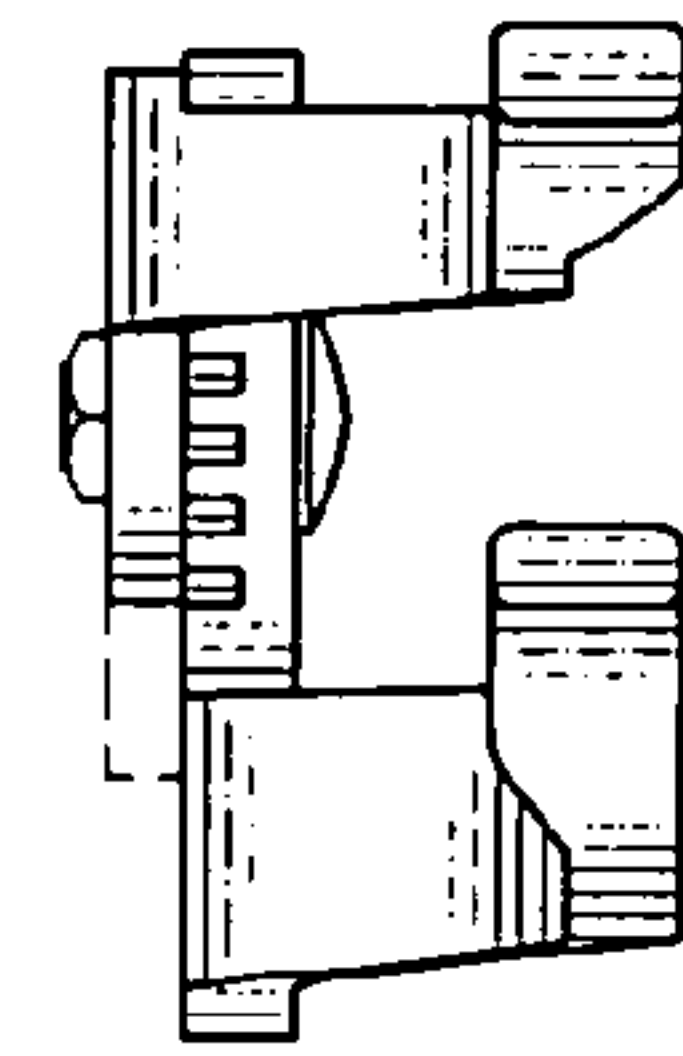

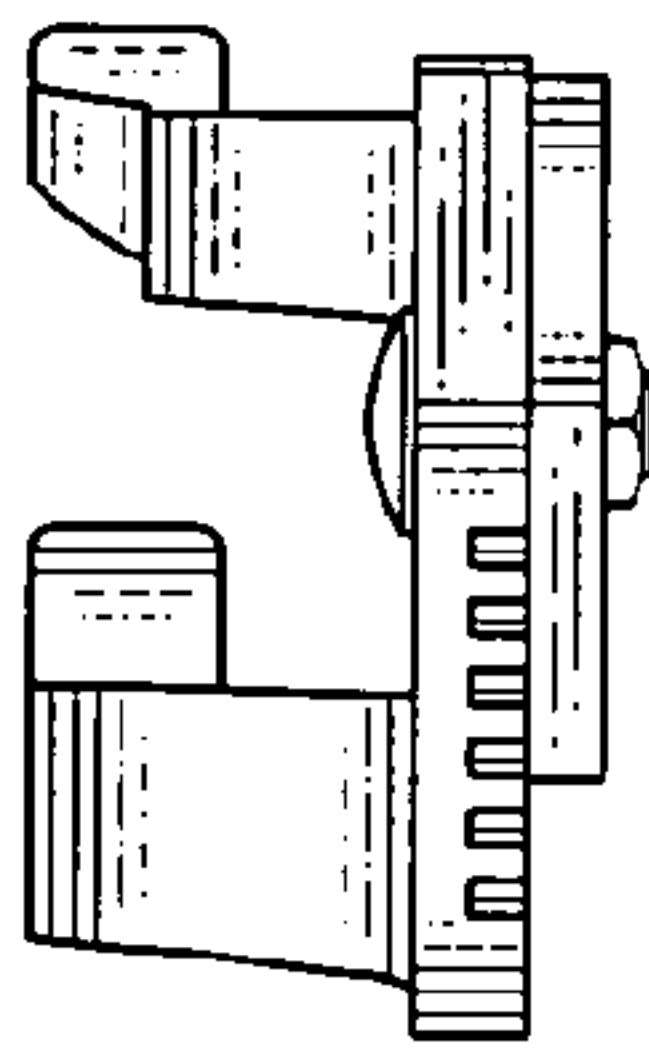

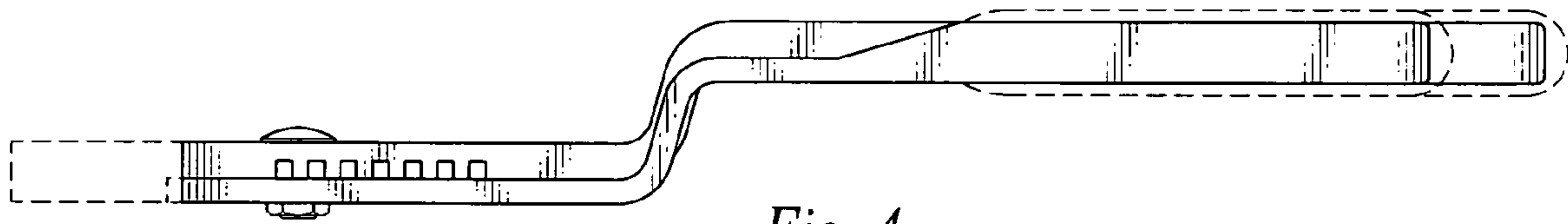

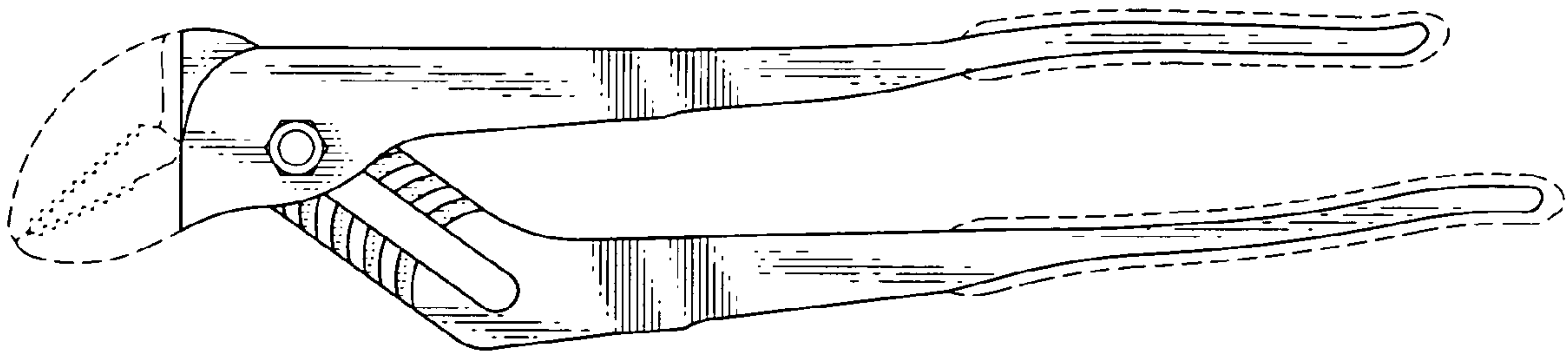

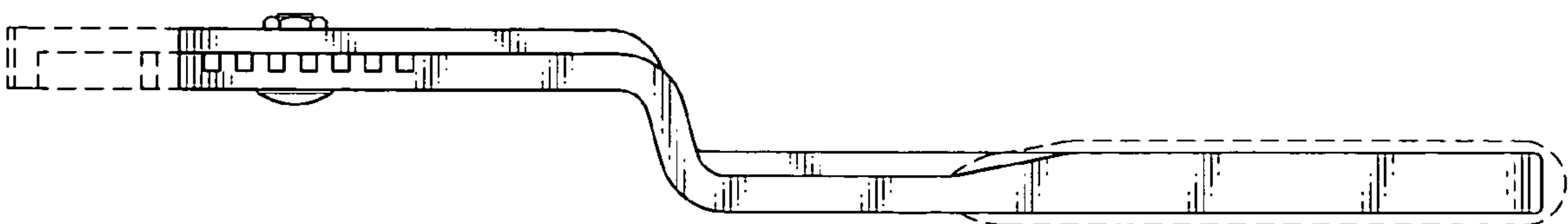

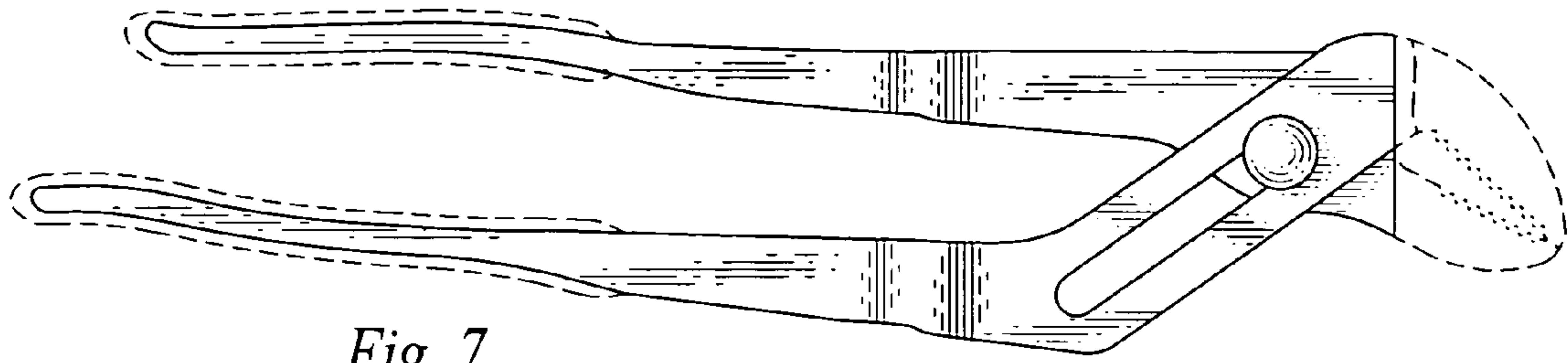

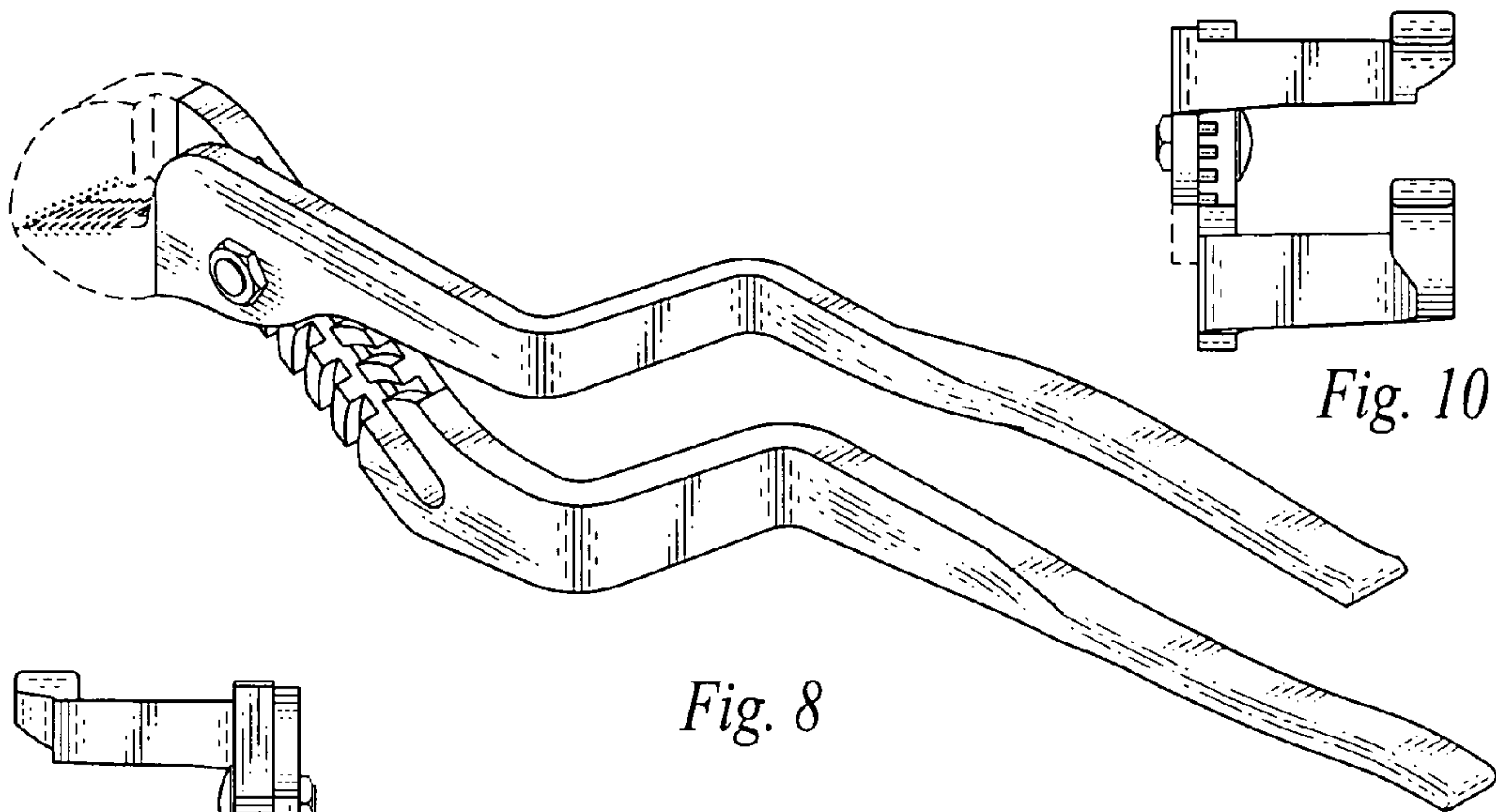

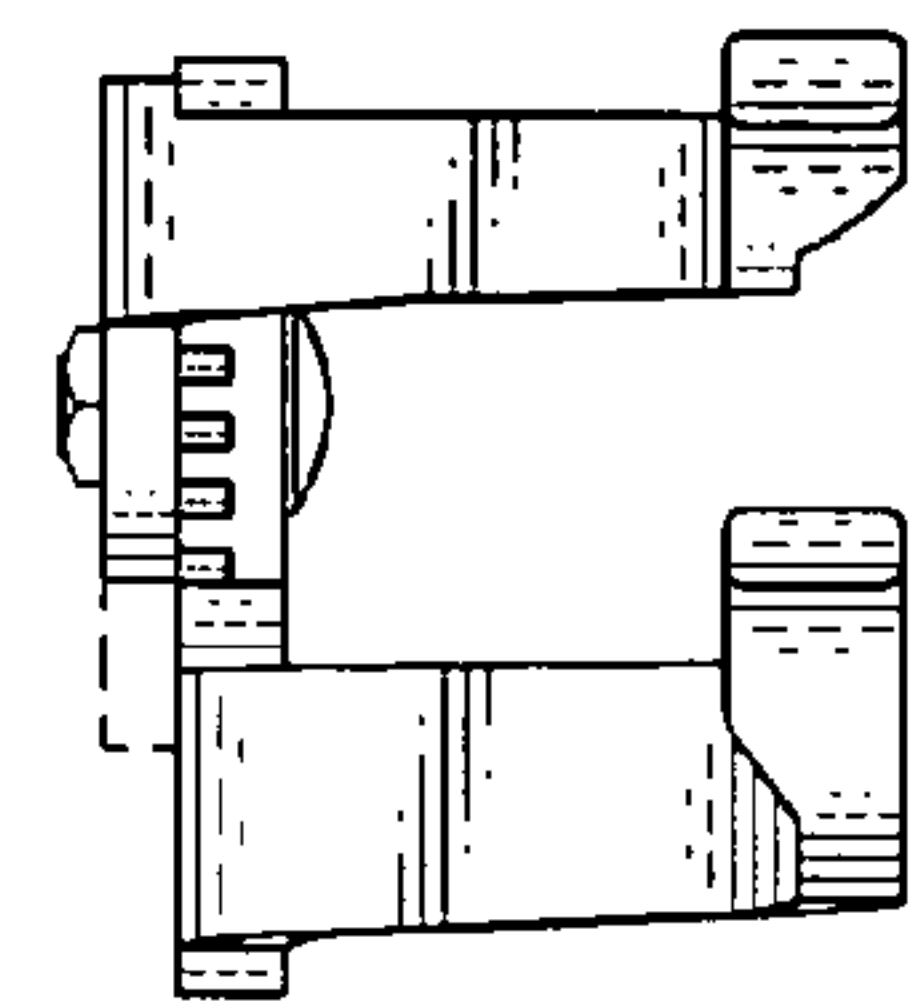

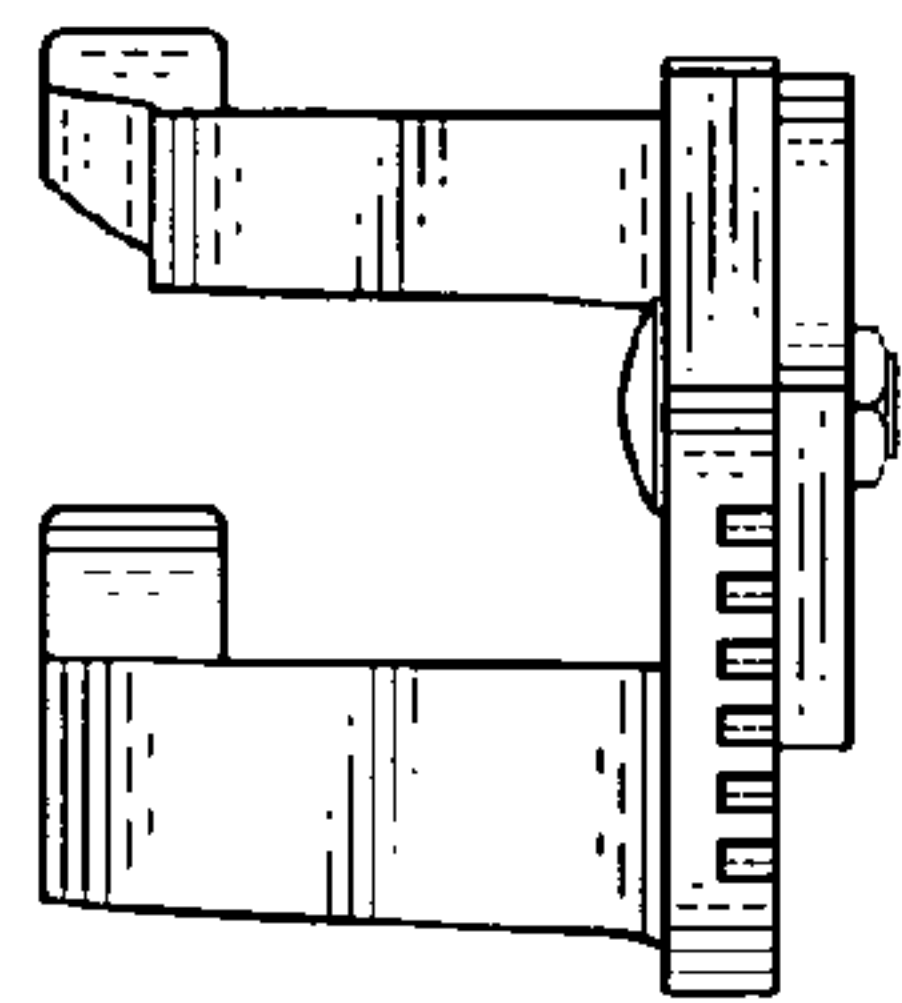

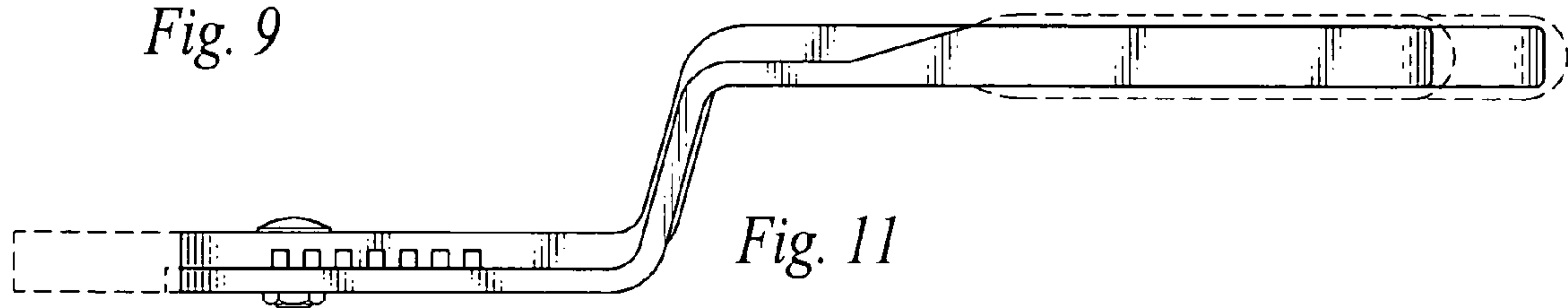

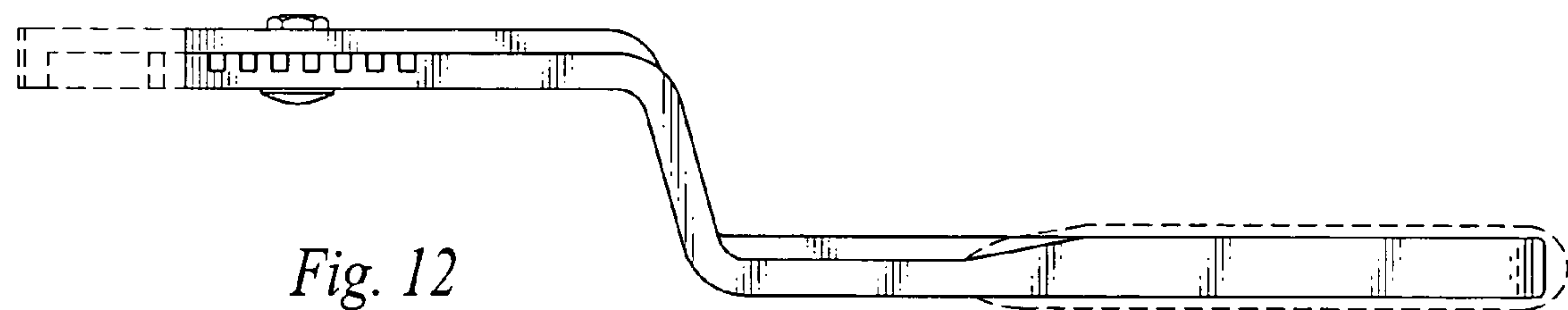

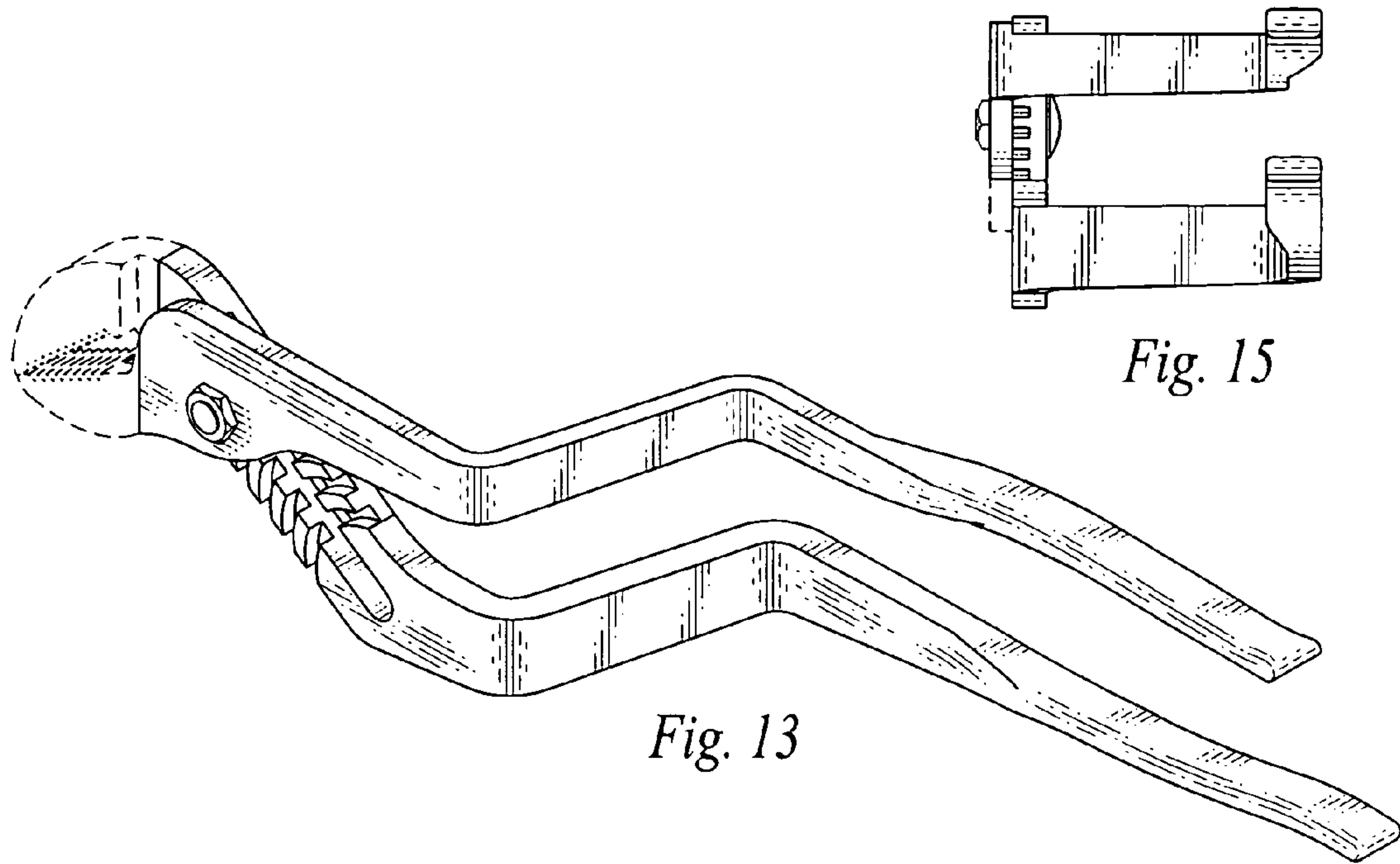

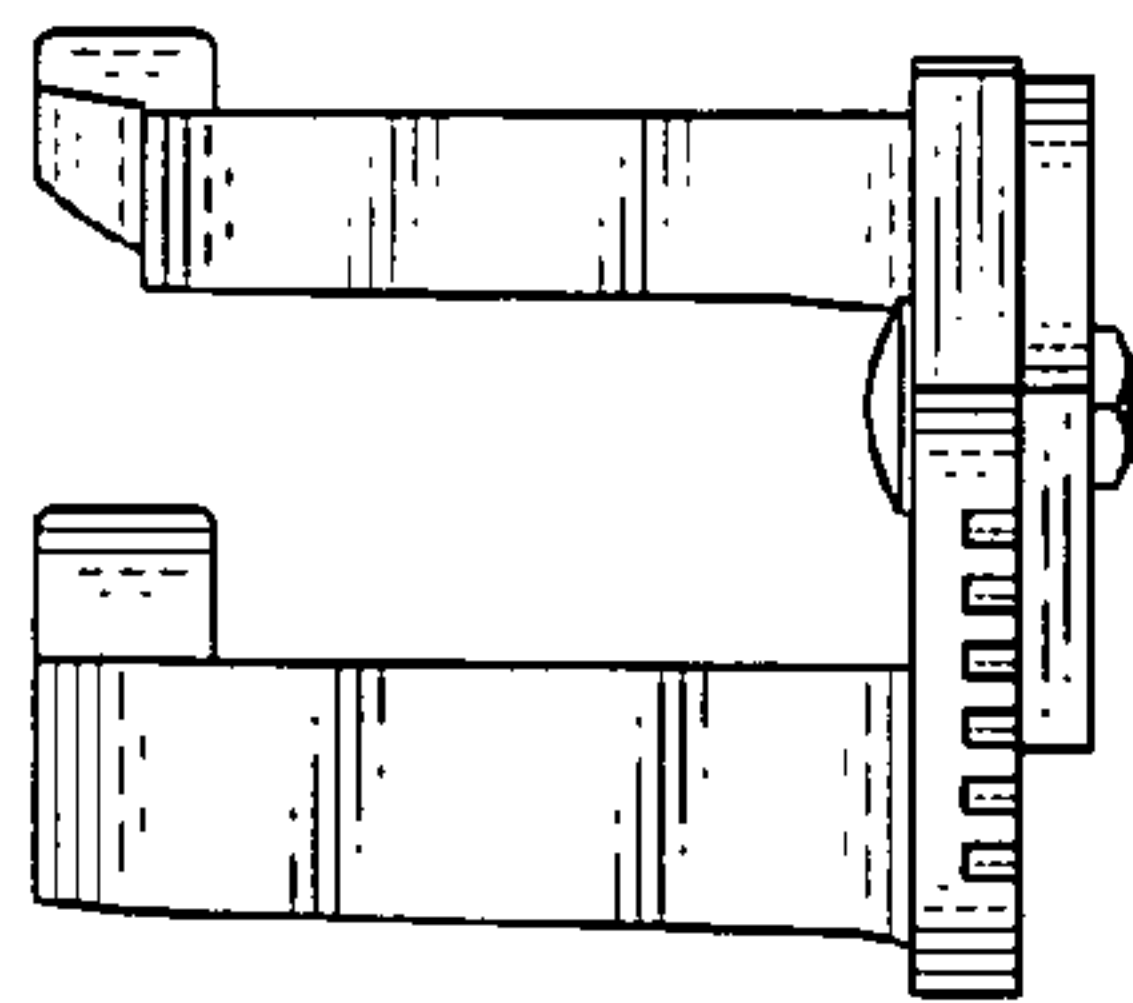

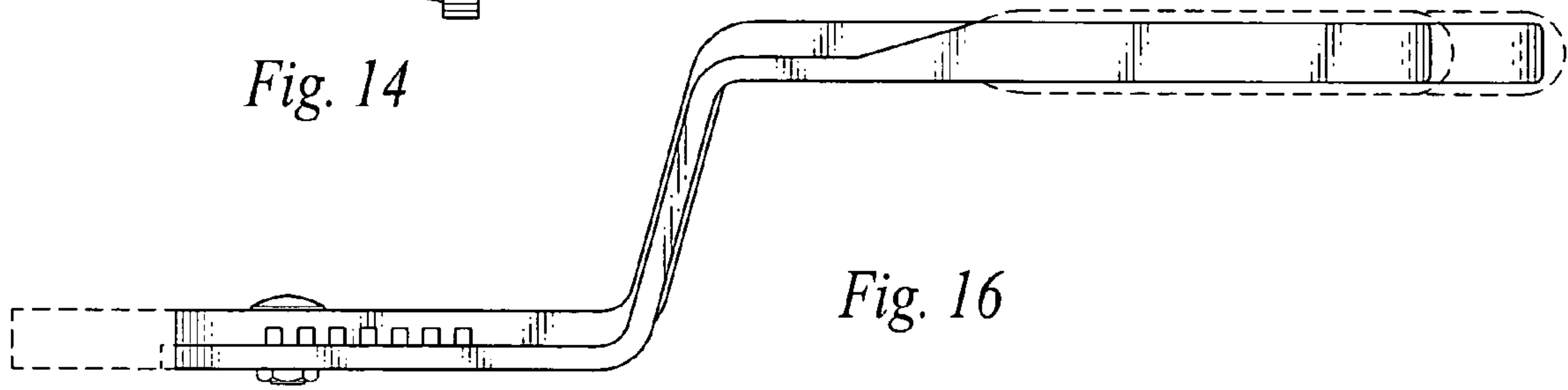

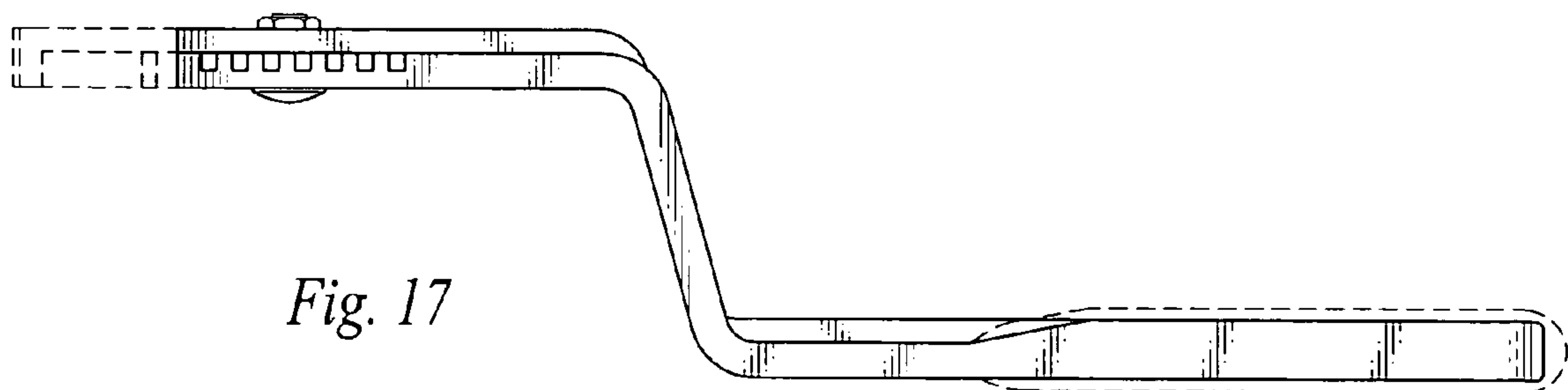

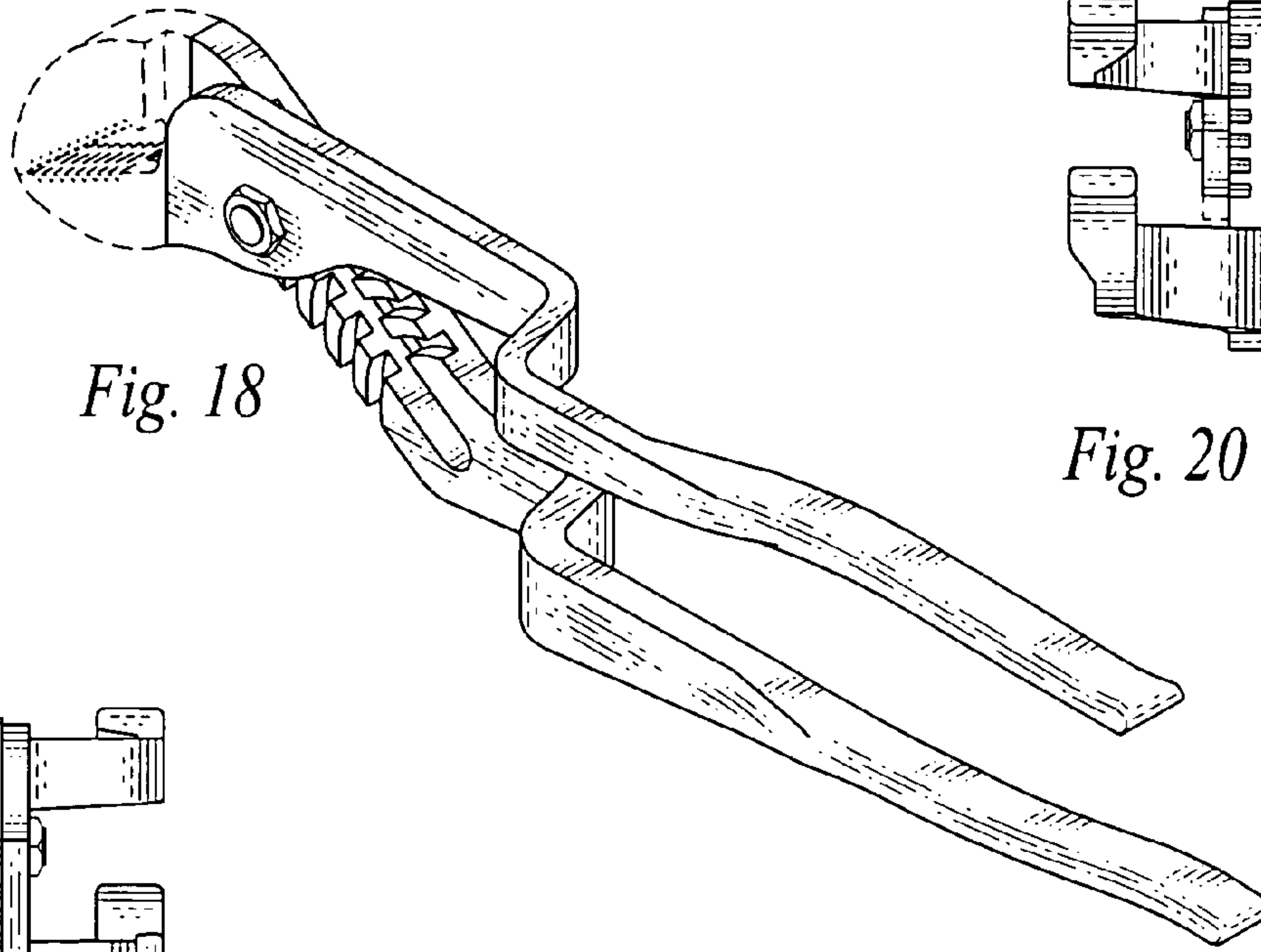

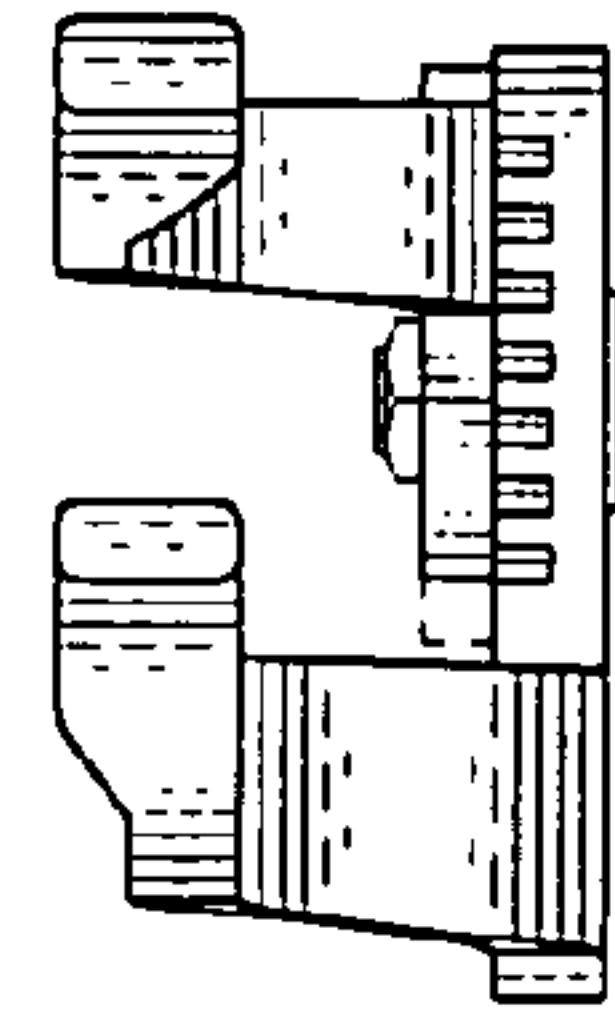

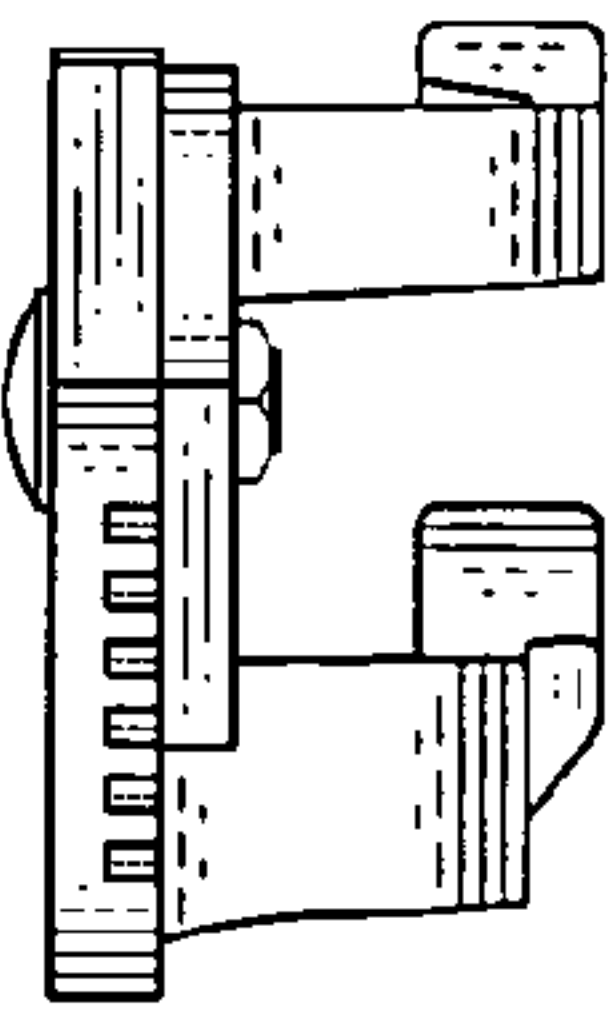

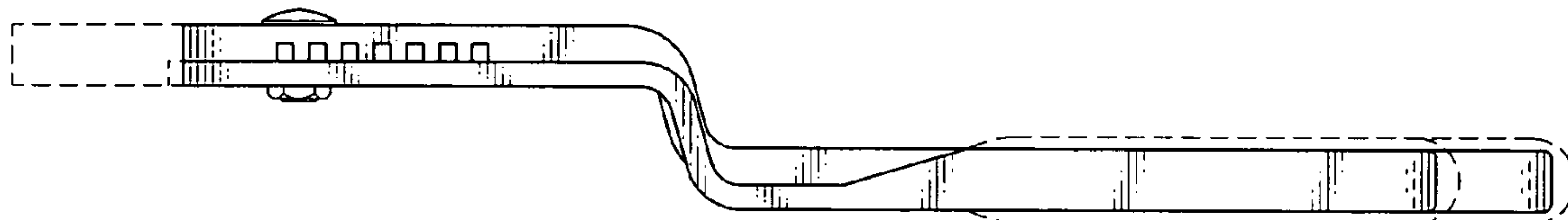

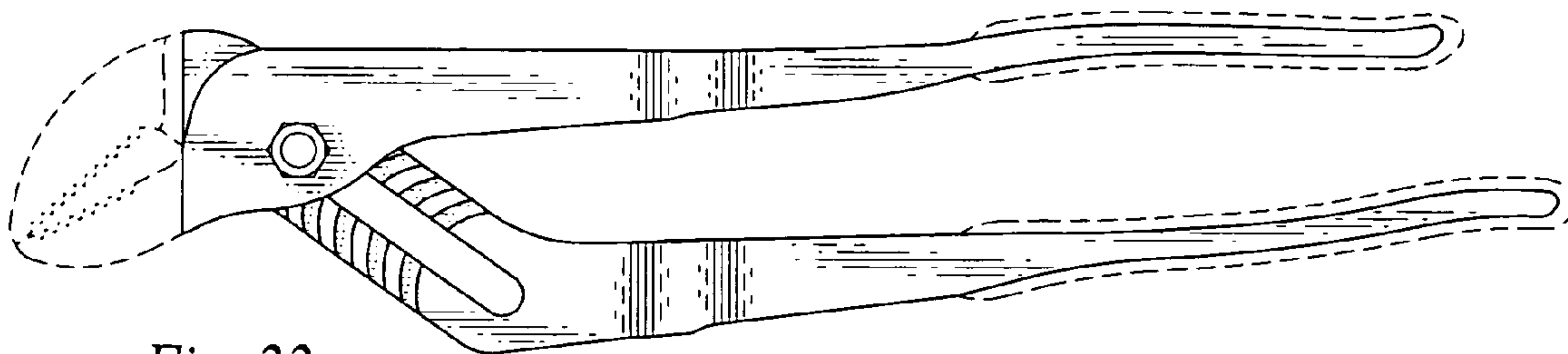

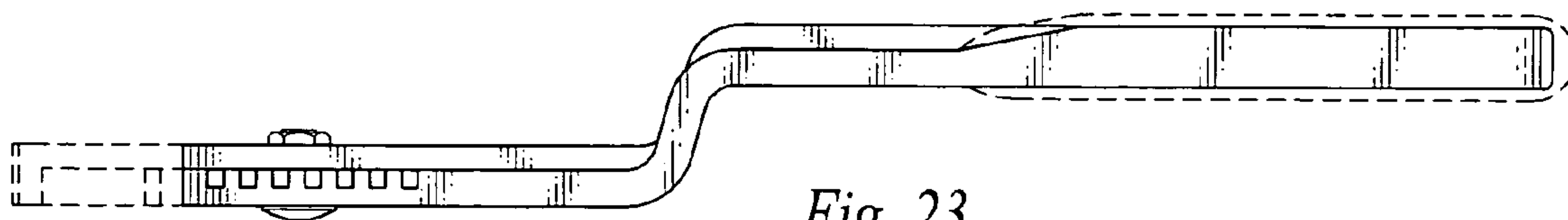

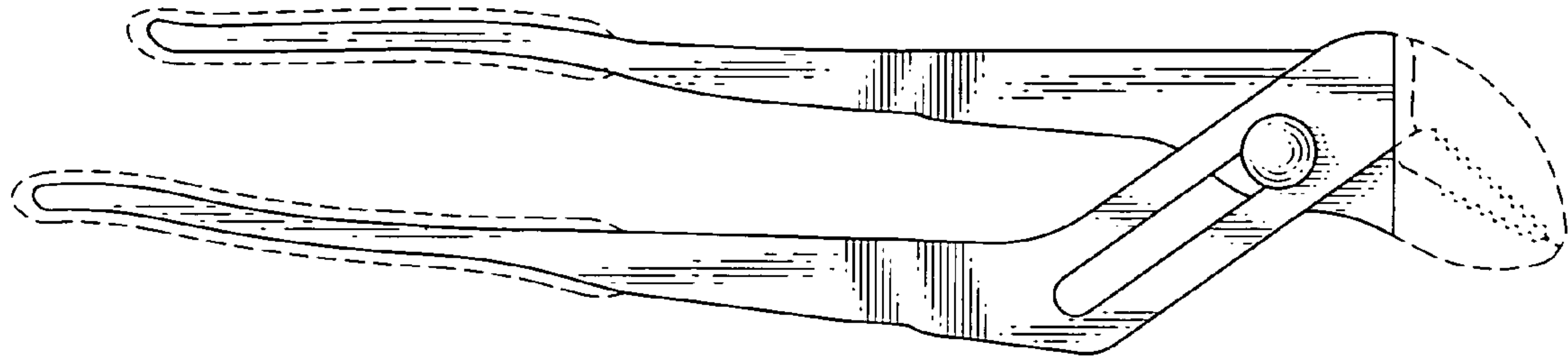

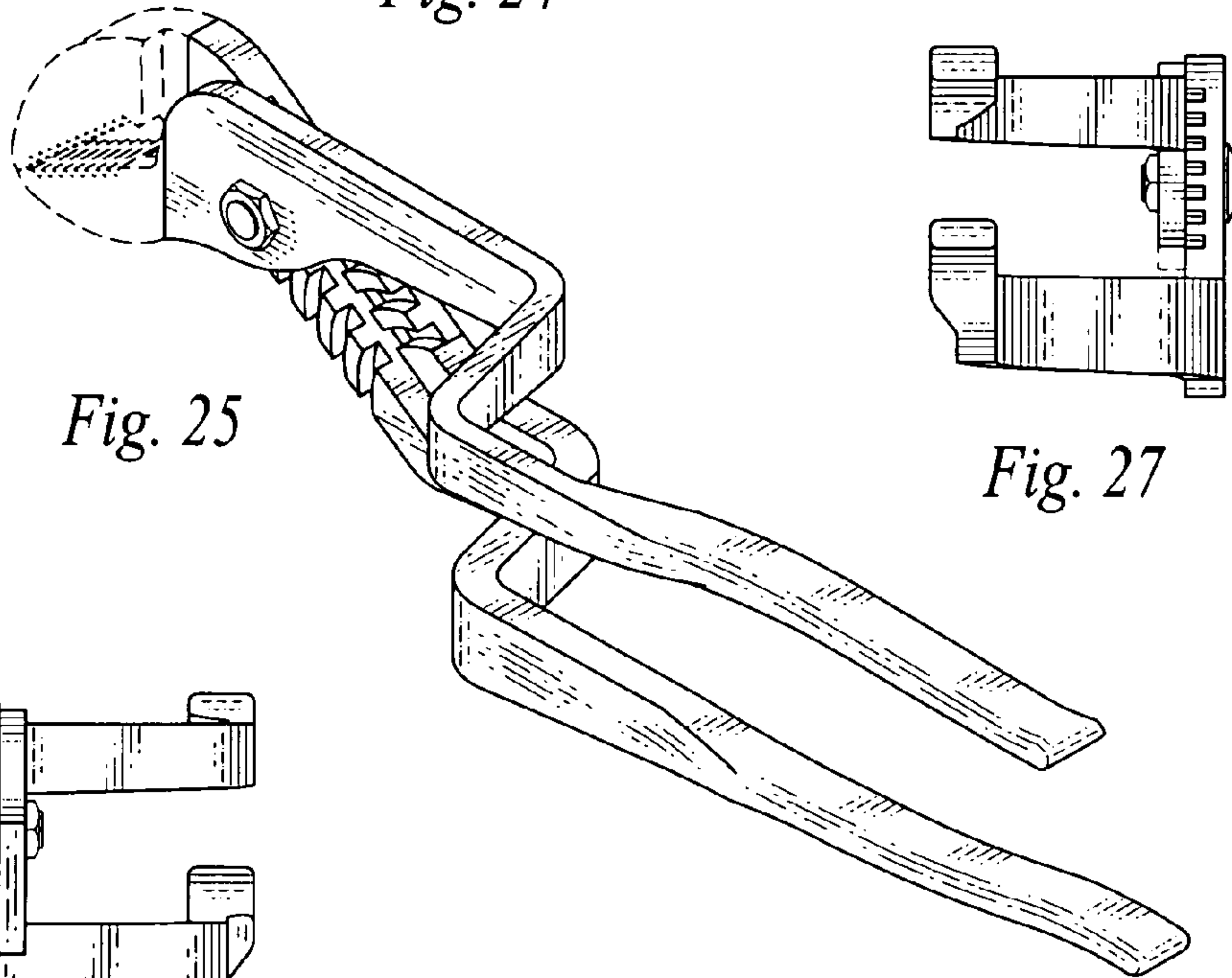

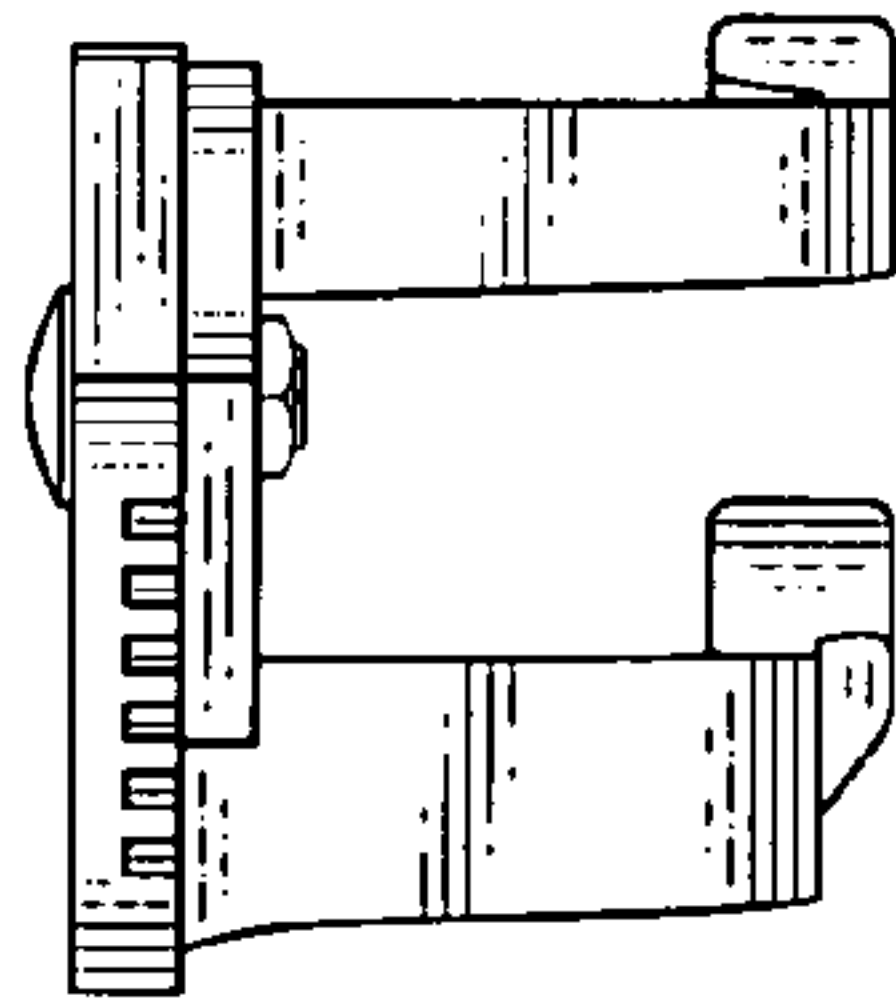

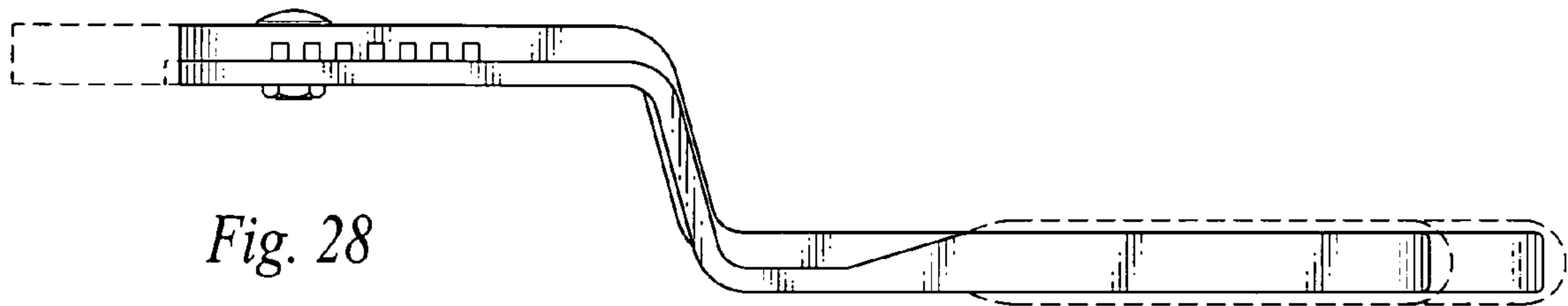

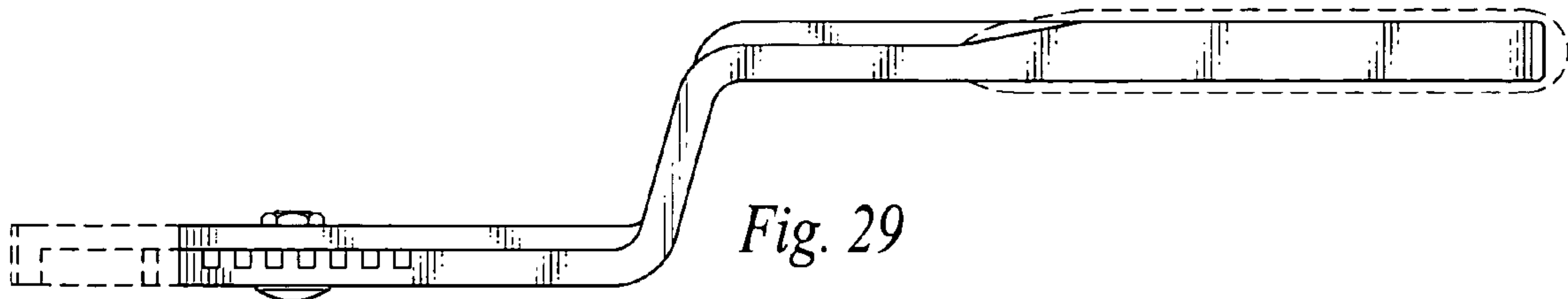

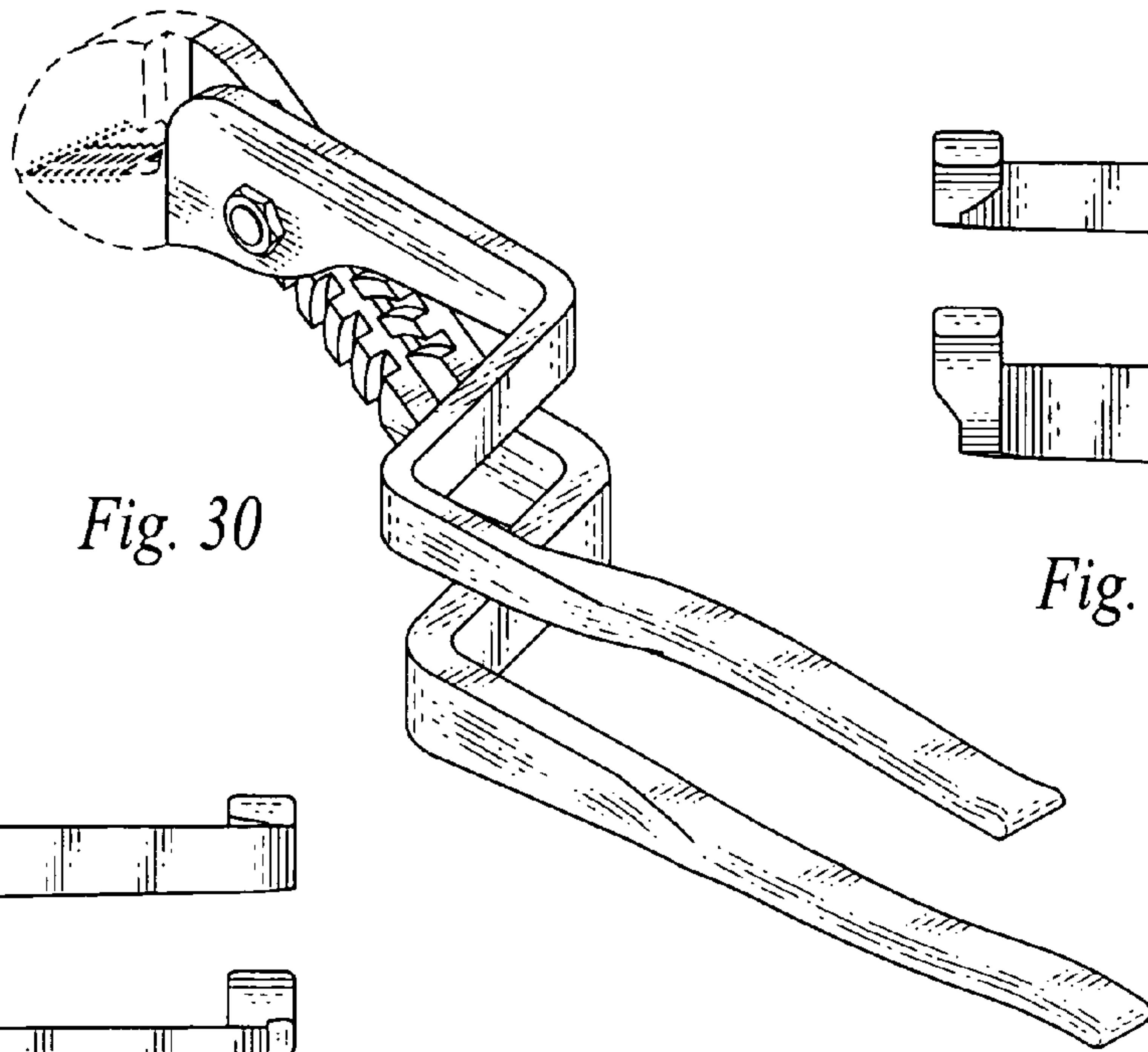

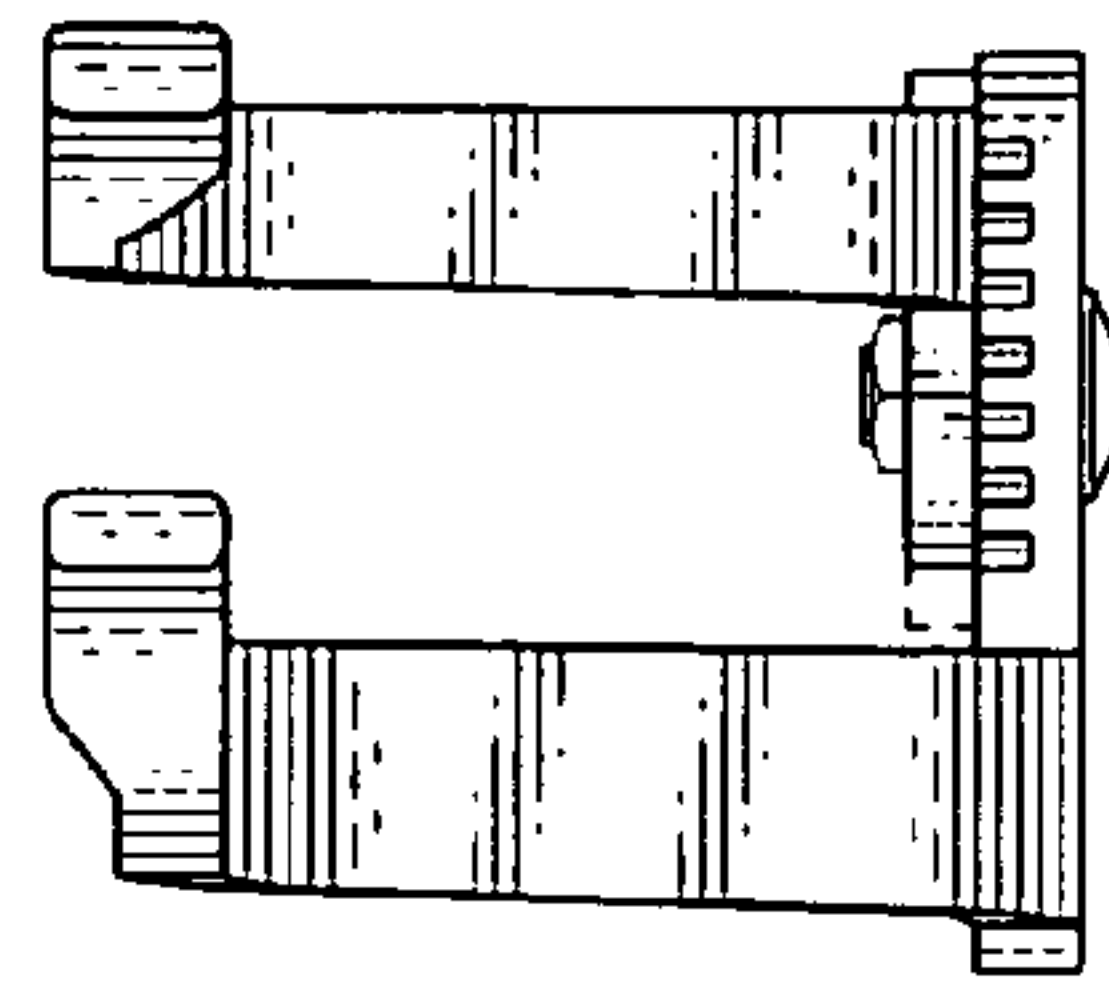

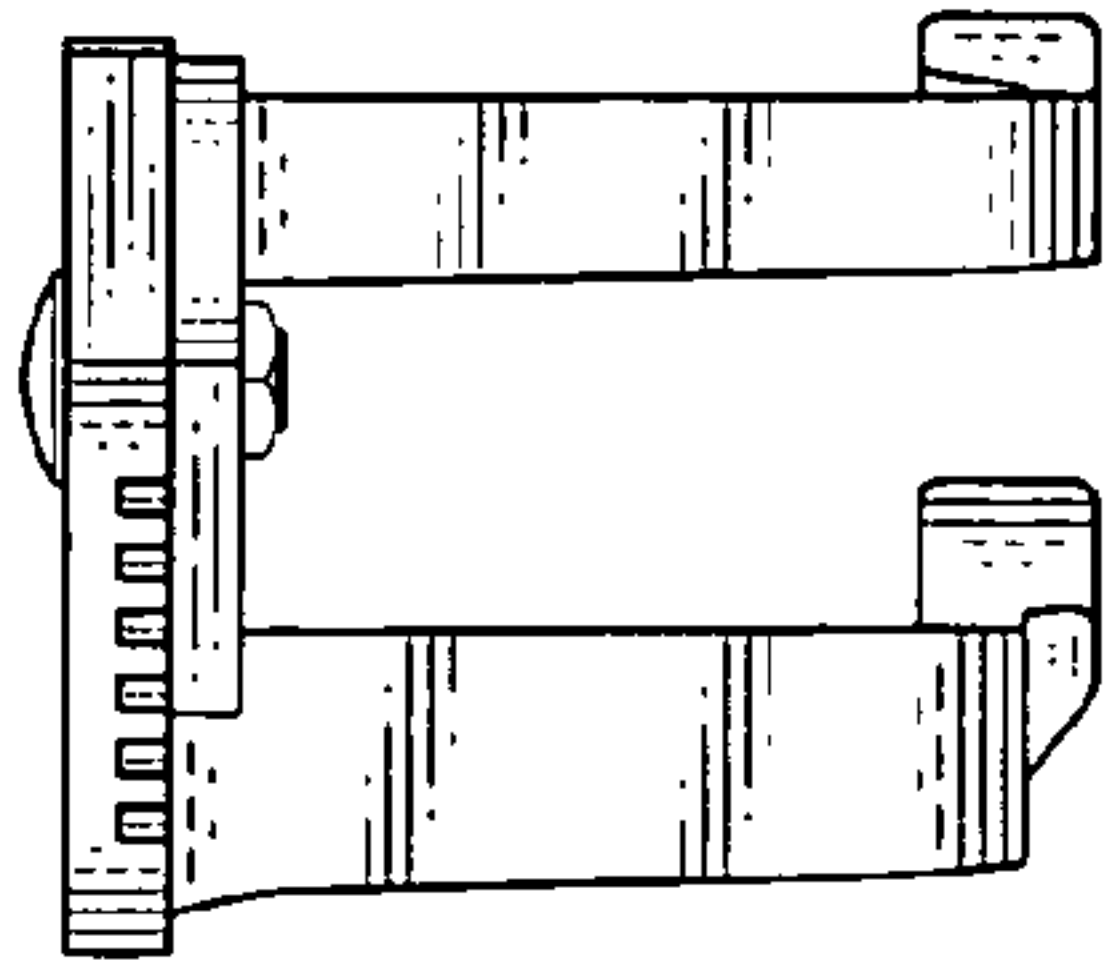

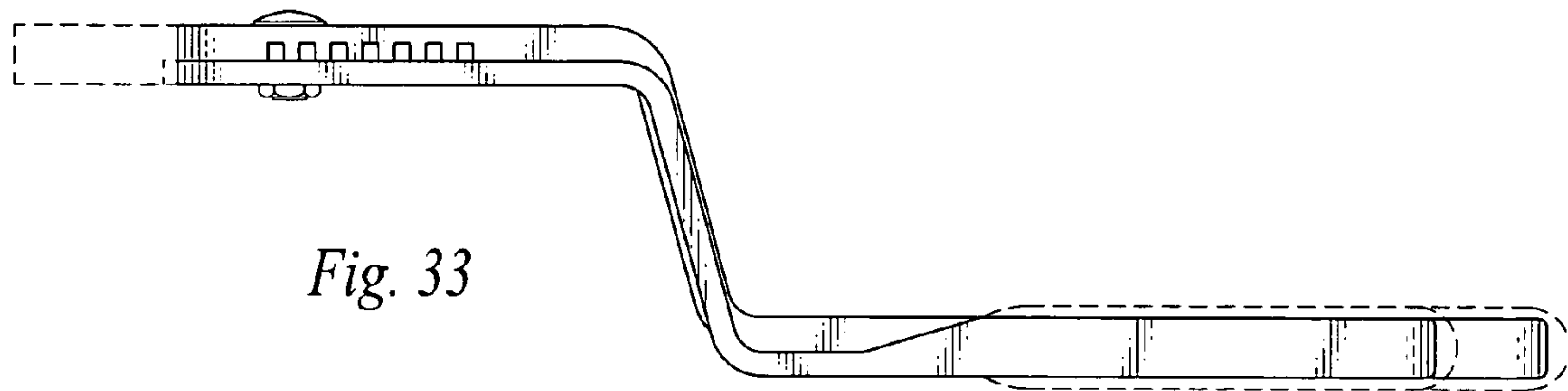

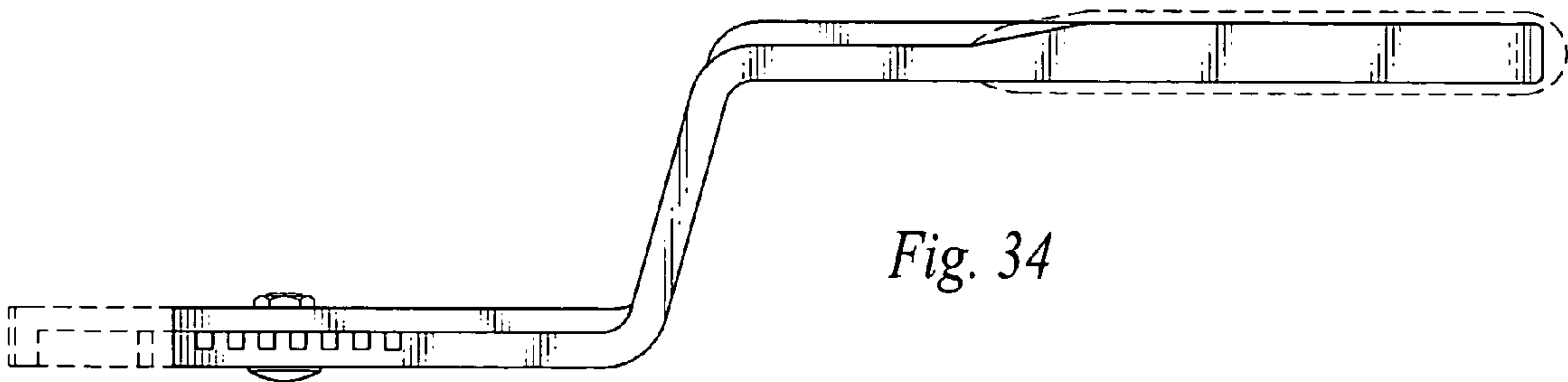
