I claim the ornamental design for a bottle with label, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a bottle with label showing my new design, the broken lines being for illustrative purposes only and forming no part of my design;

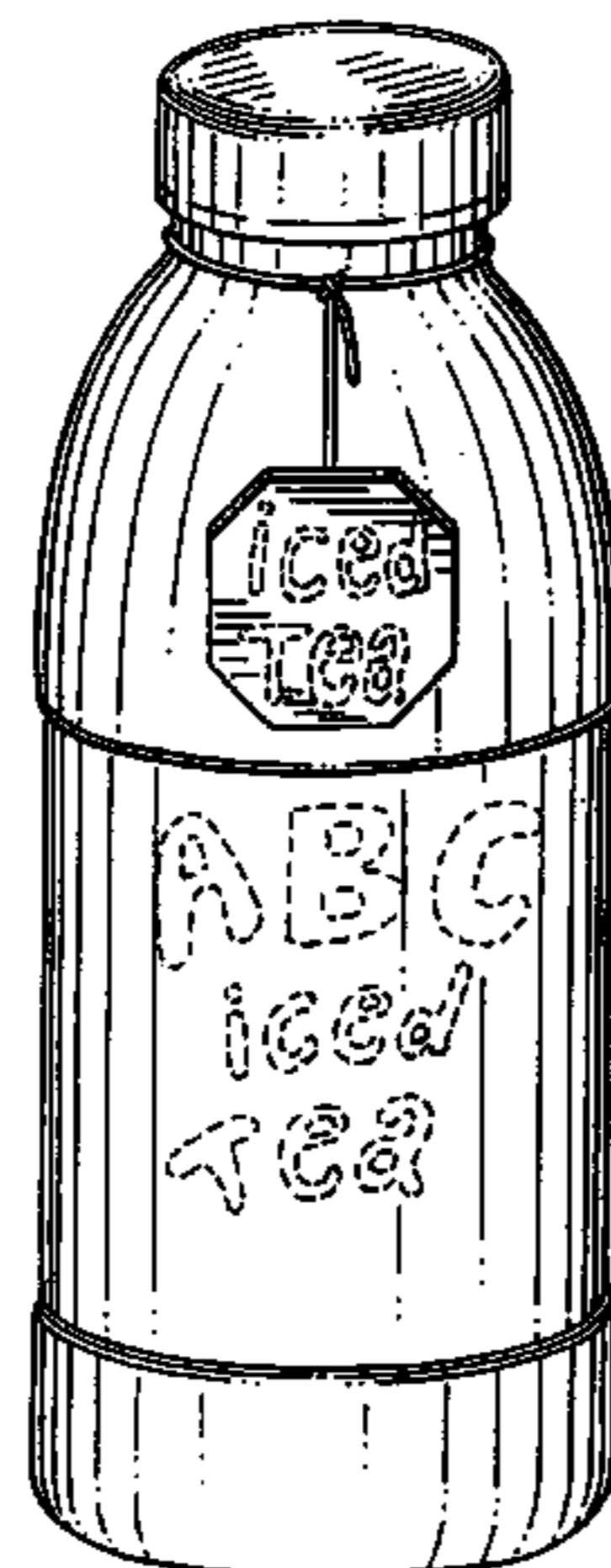
FIG. 2 is a top view thereof;

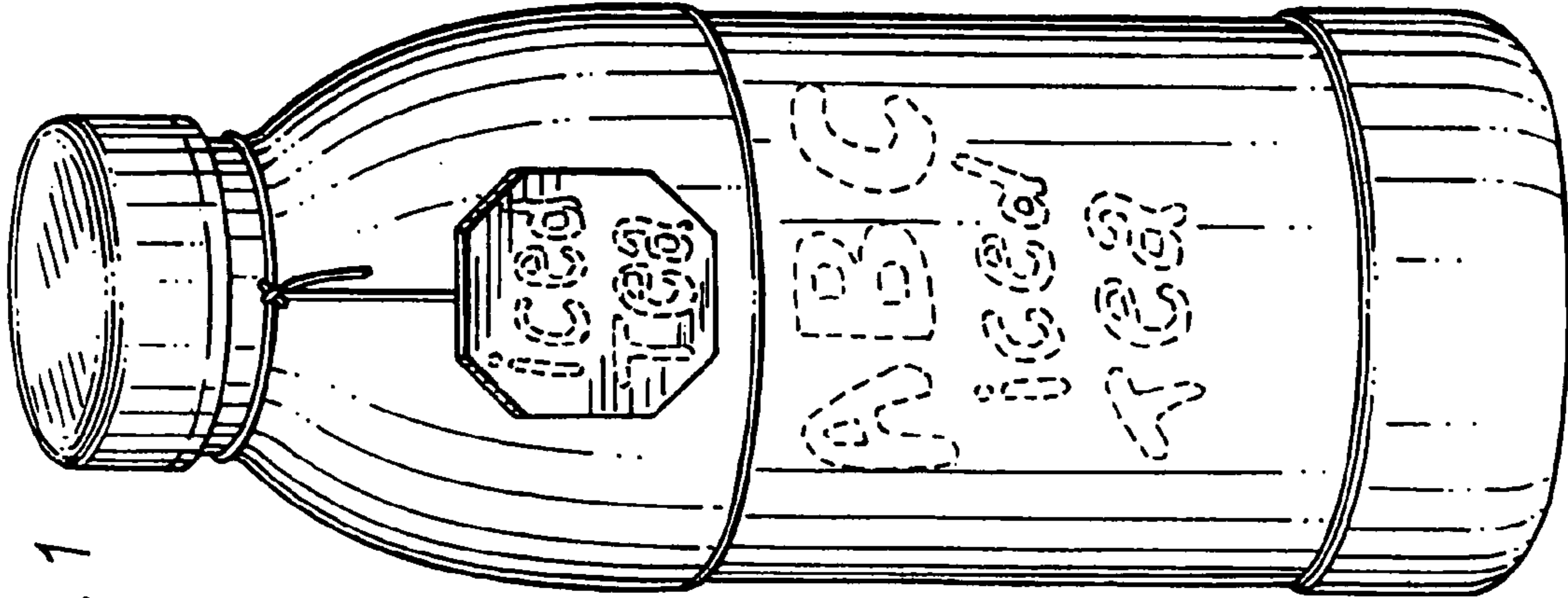

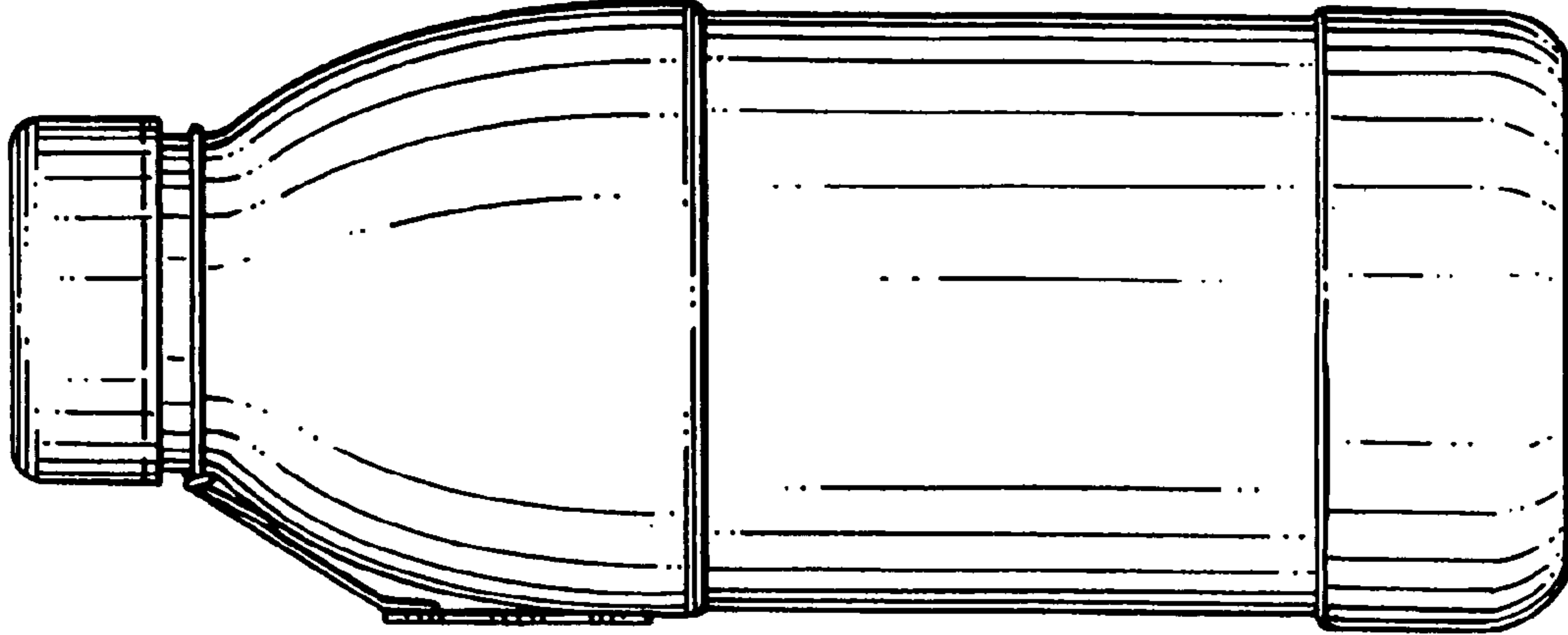

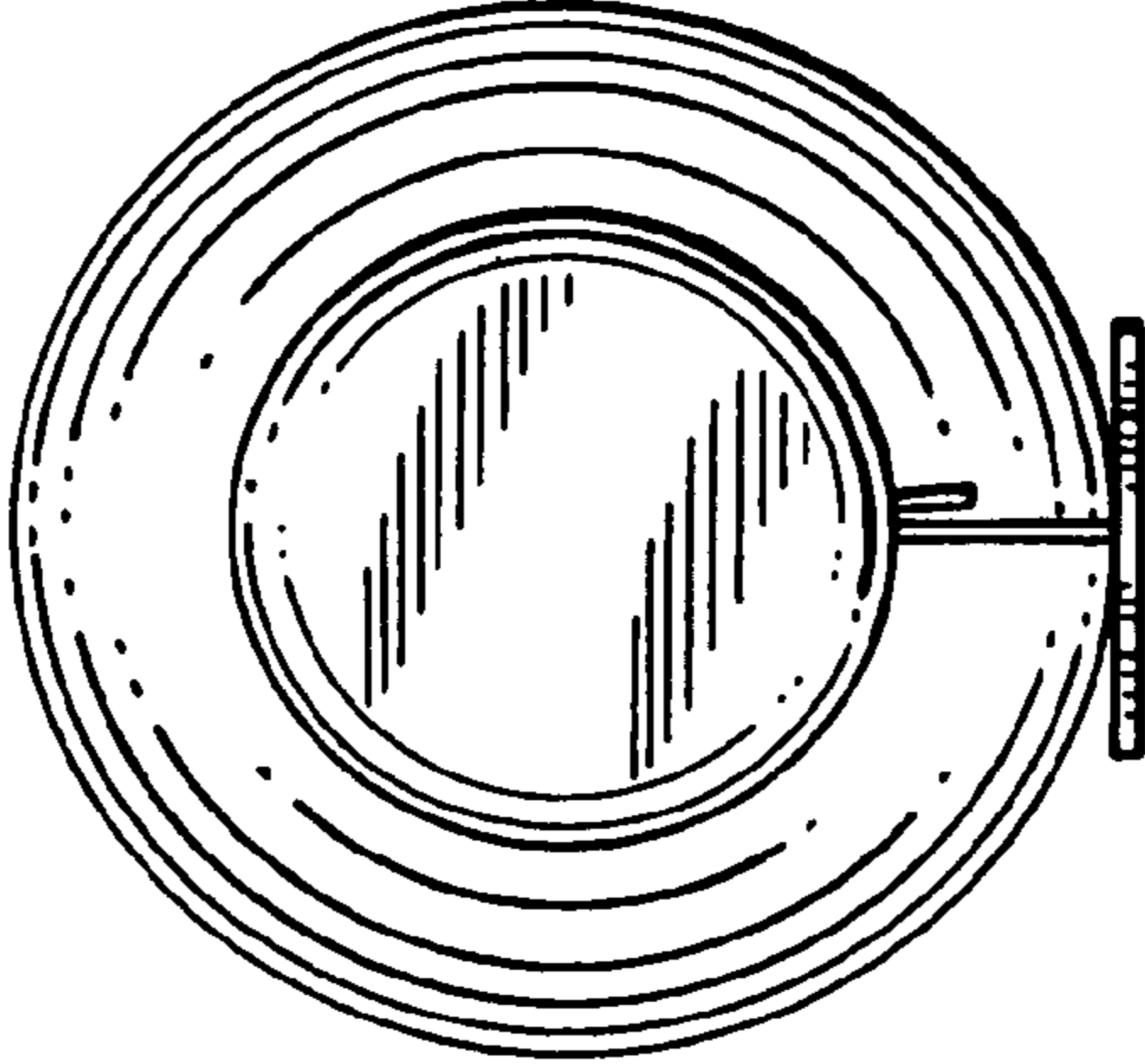

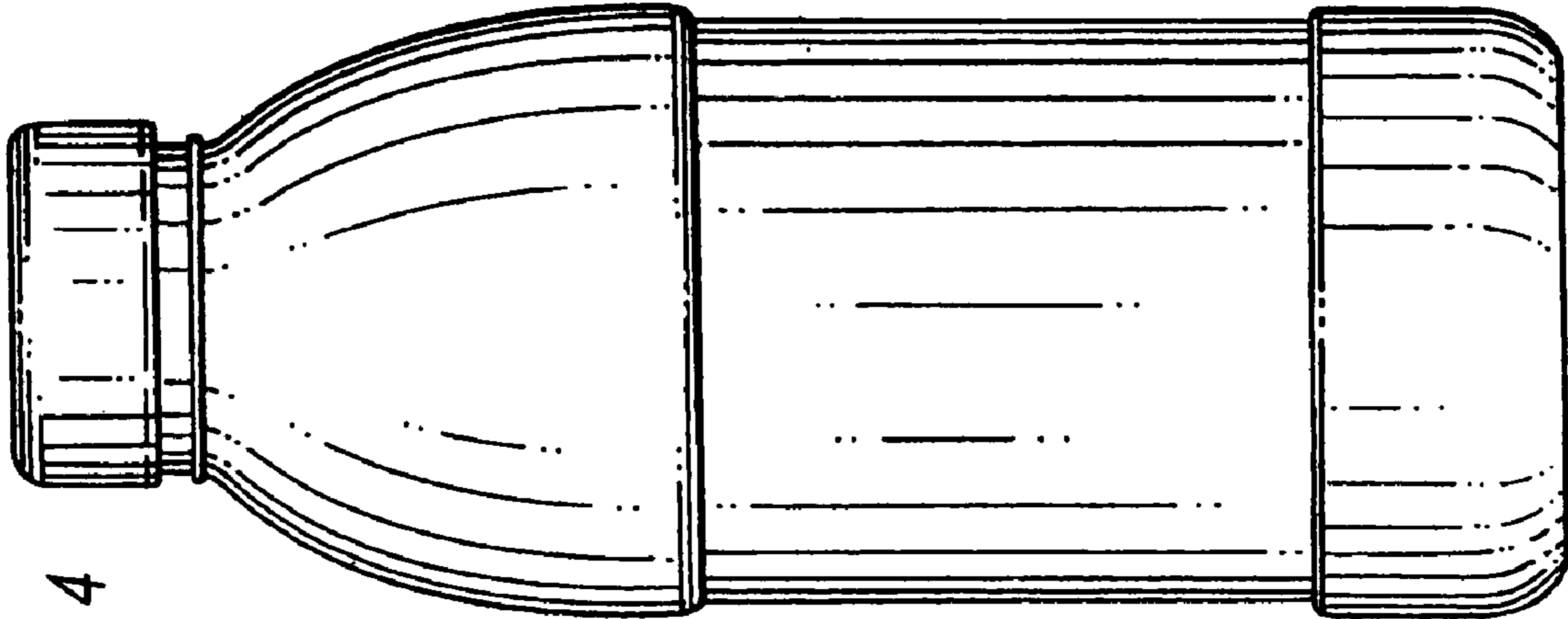

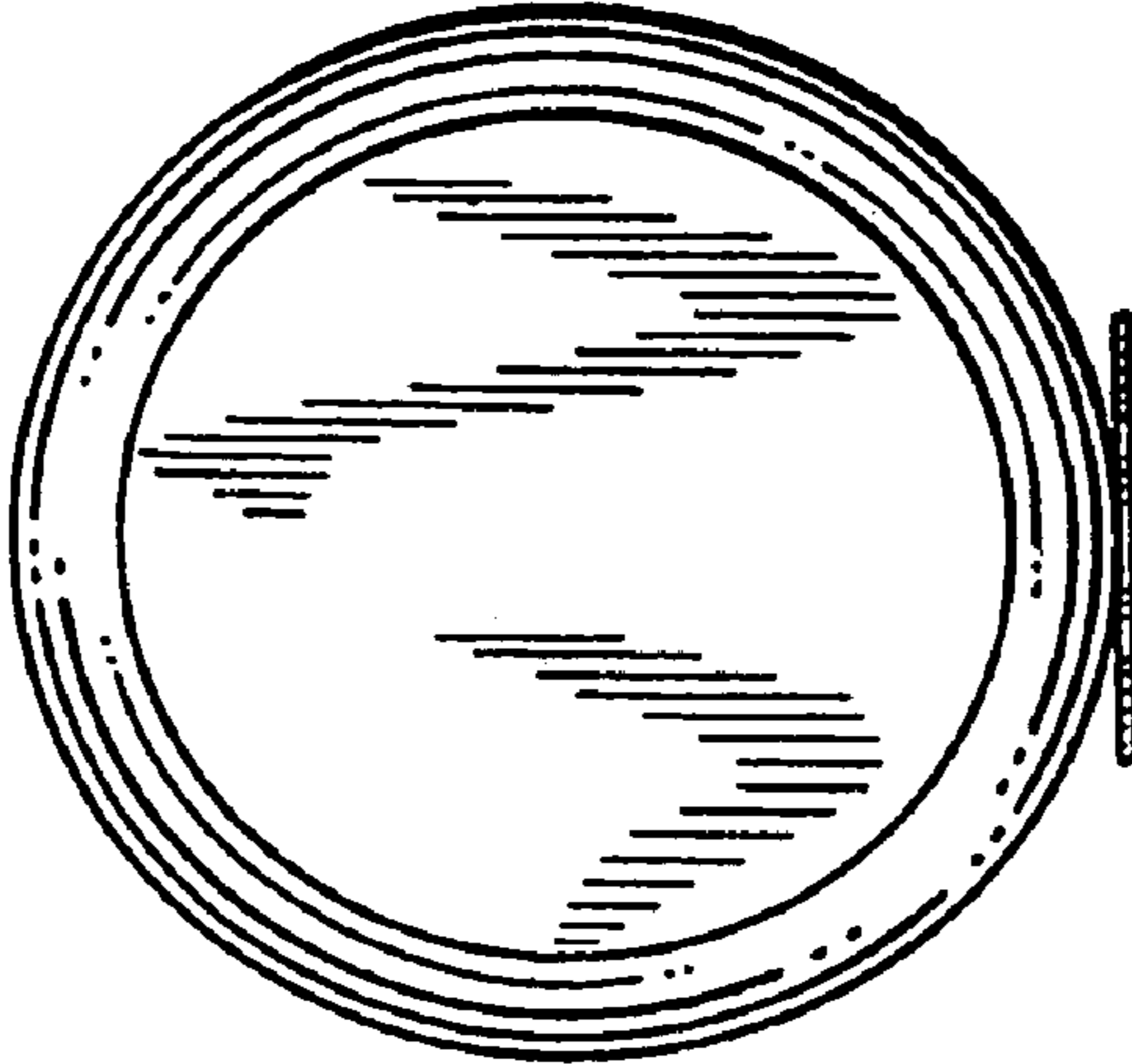
