second alternate unclaimed environmental structure.

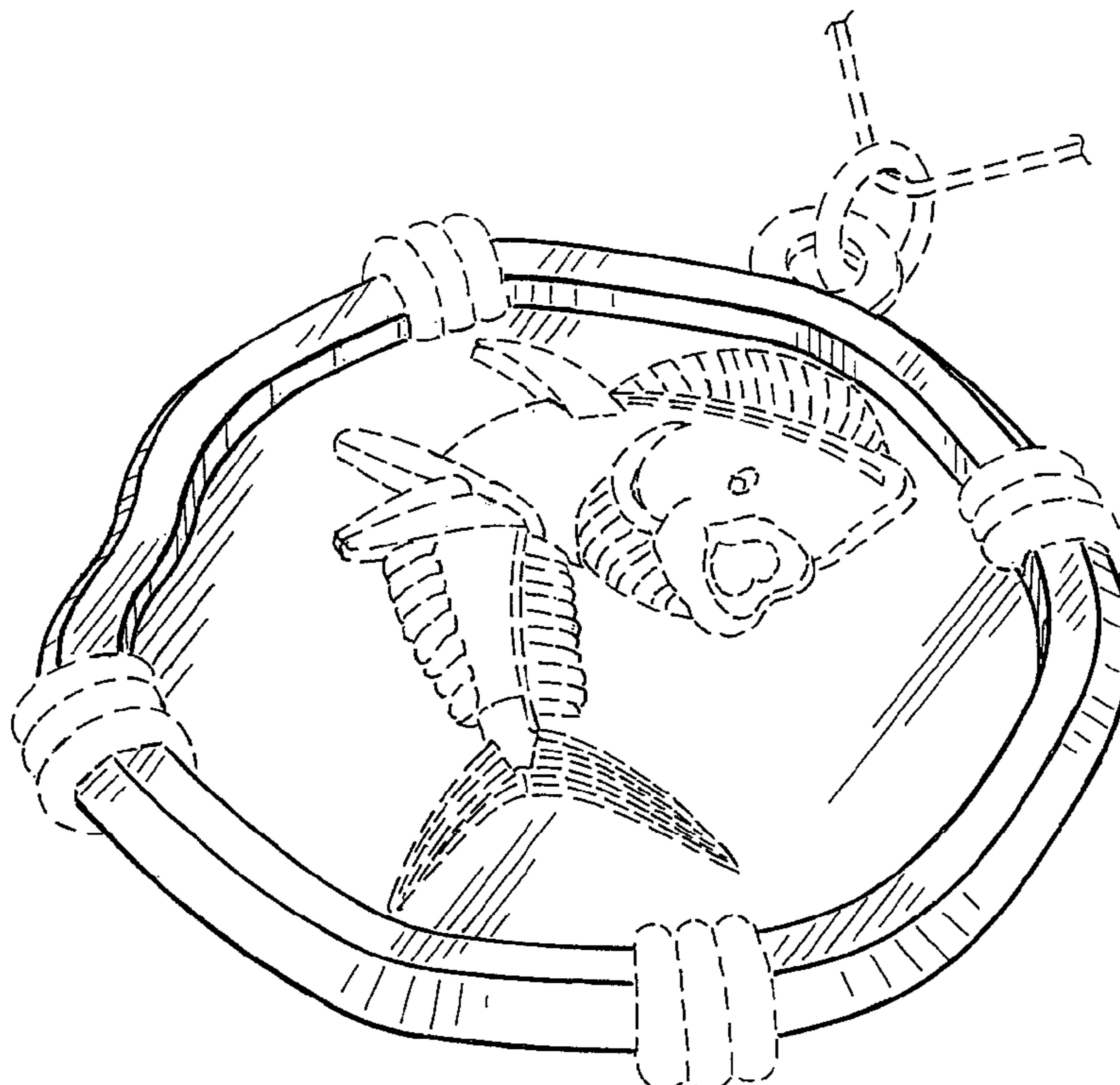

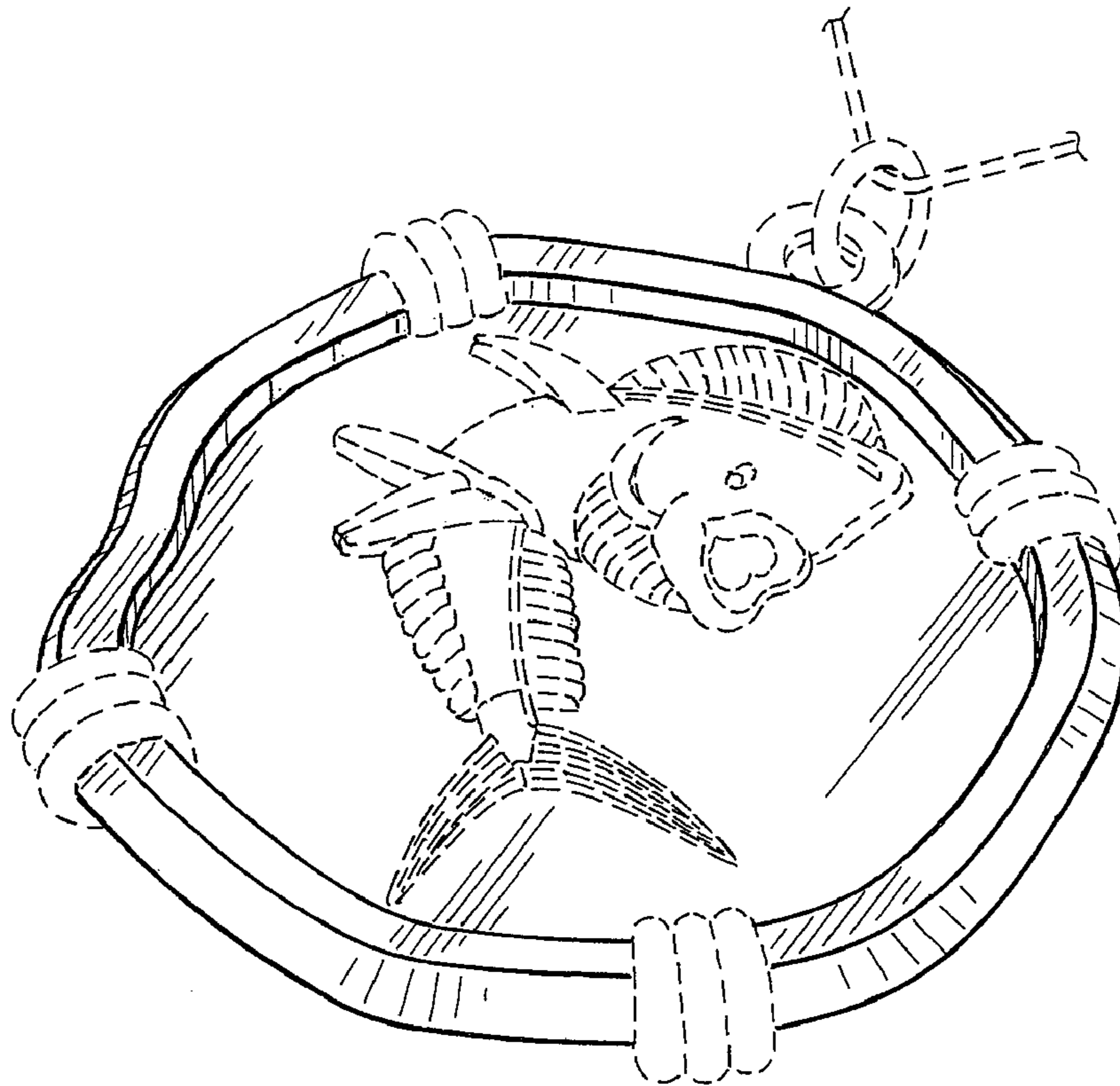

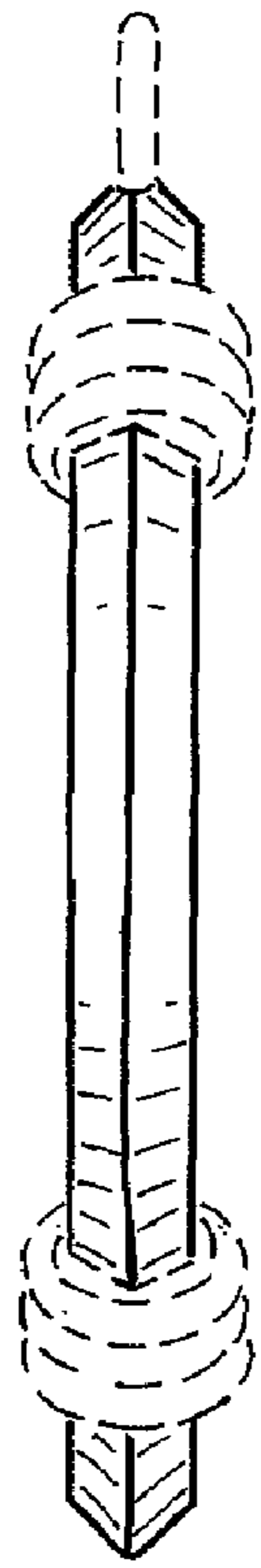

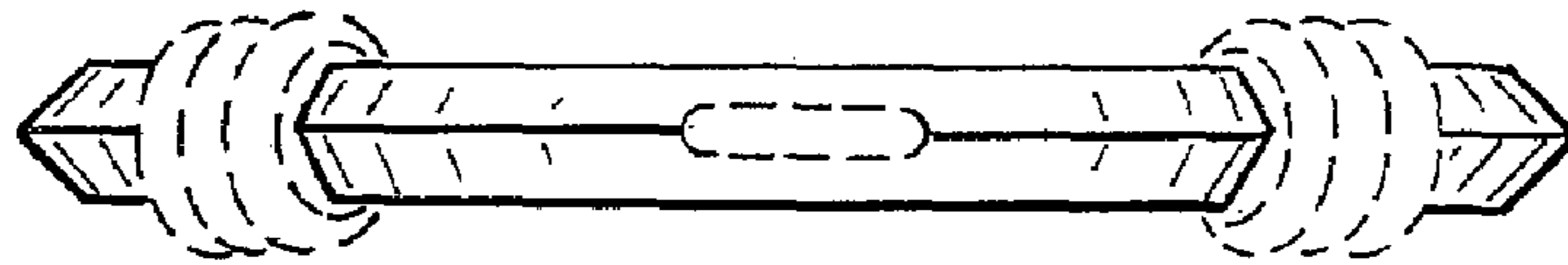

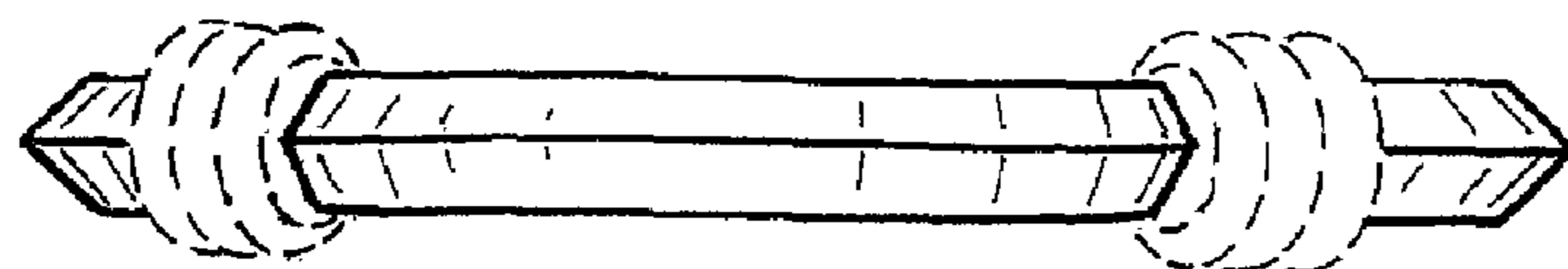

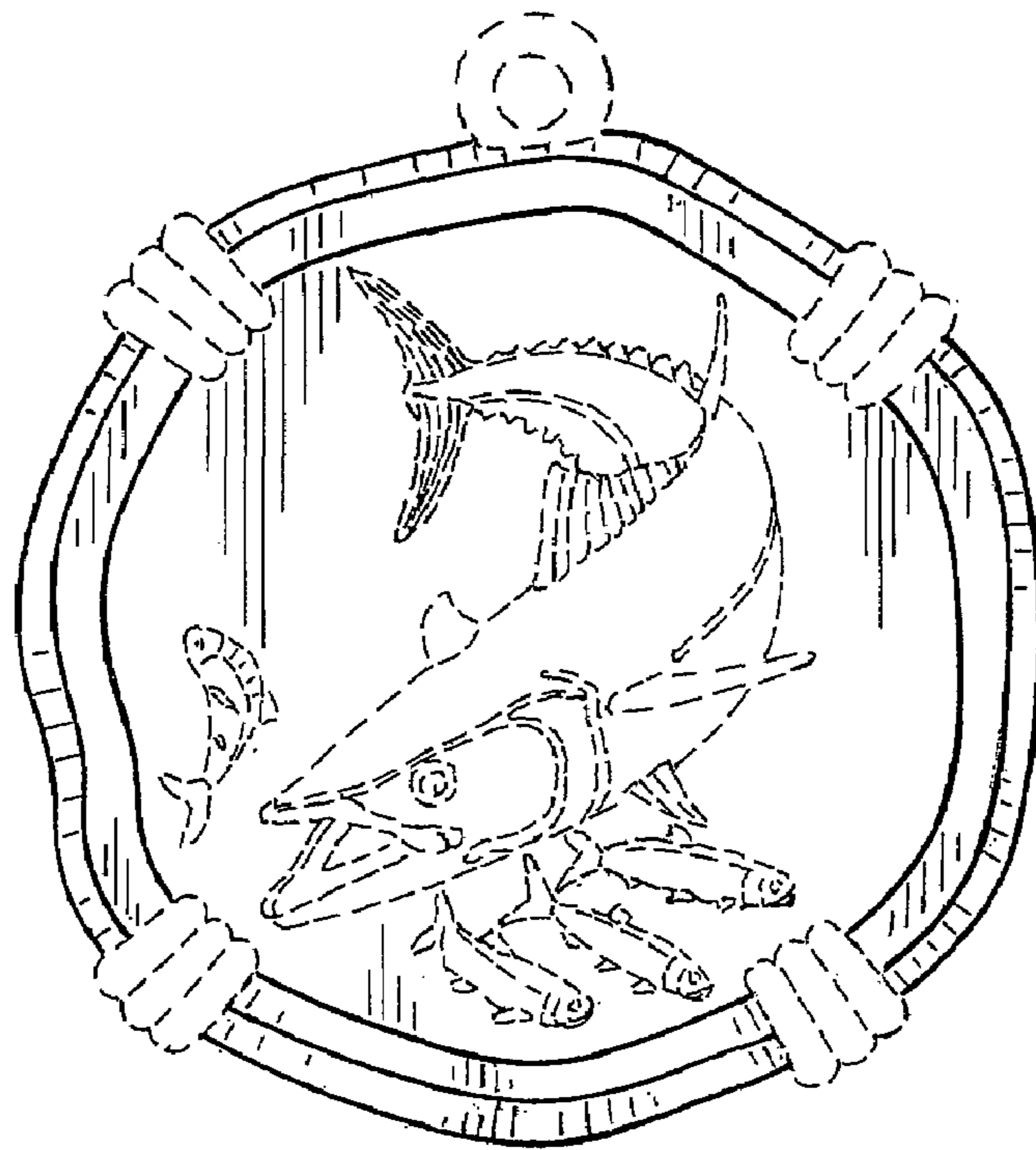

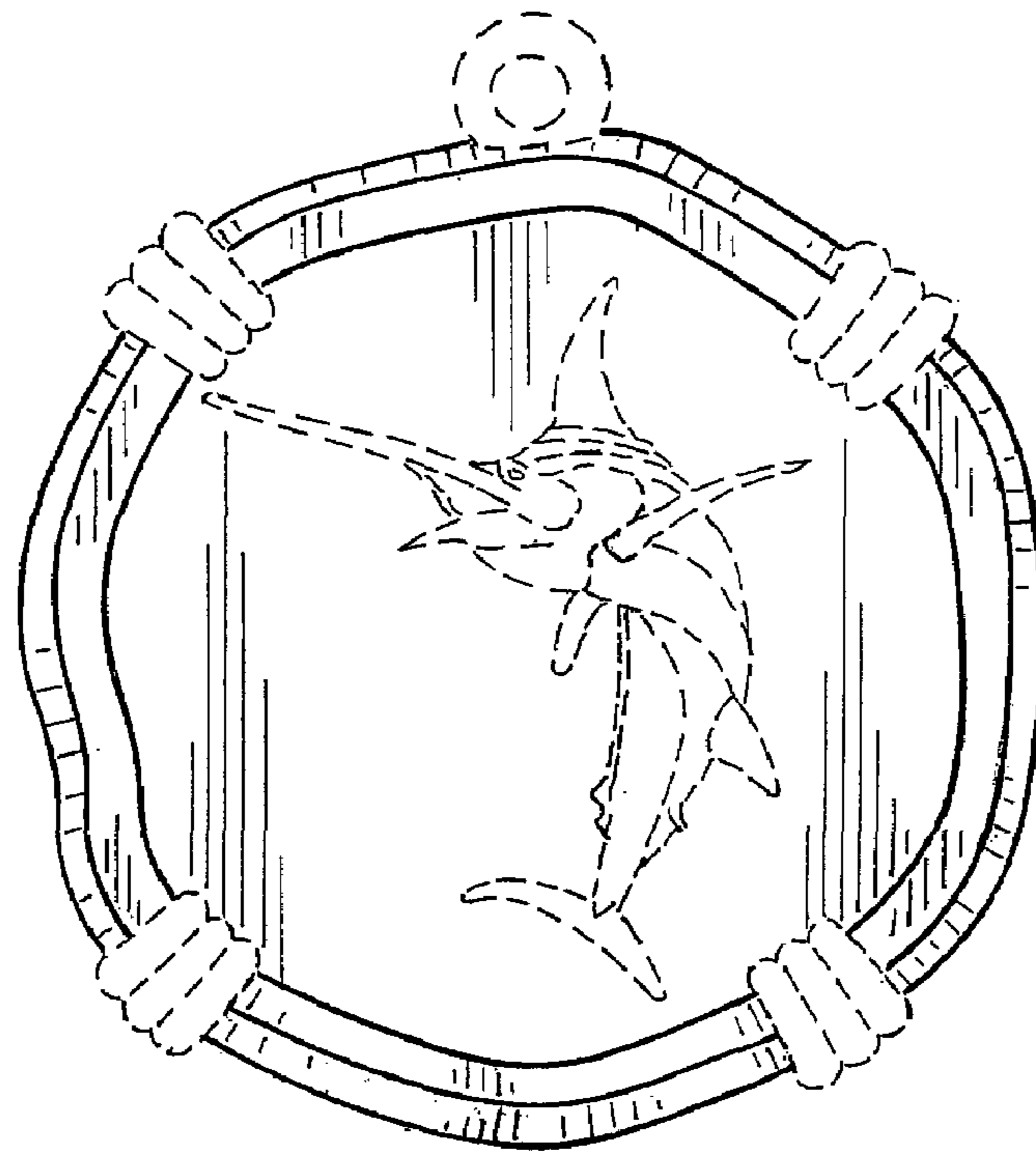
