FIG. 6 is a perspective view of the vehicle grille.

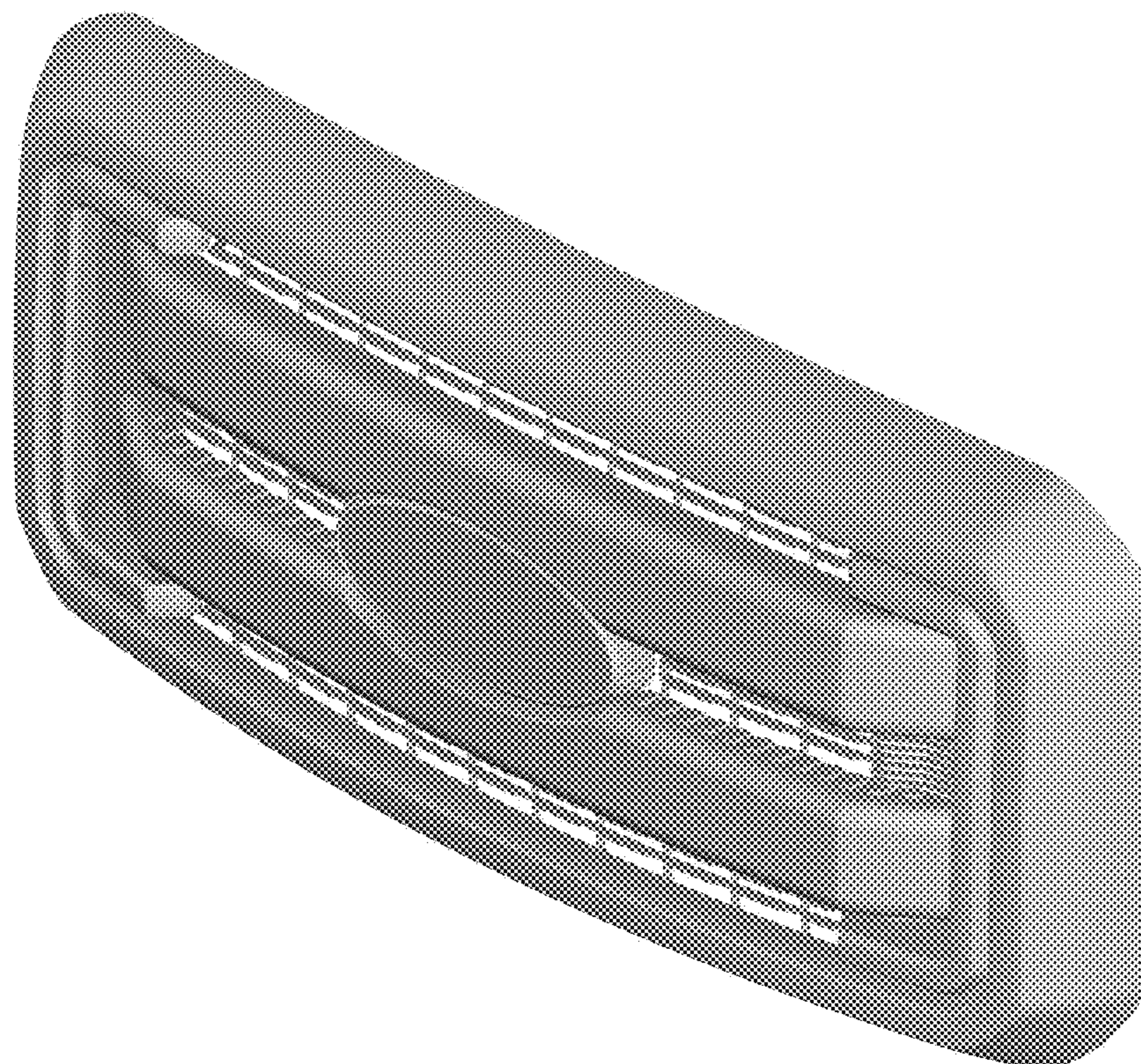

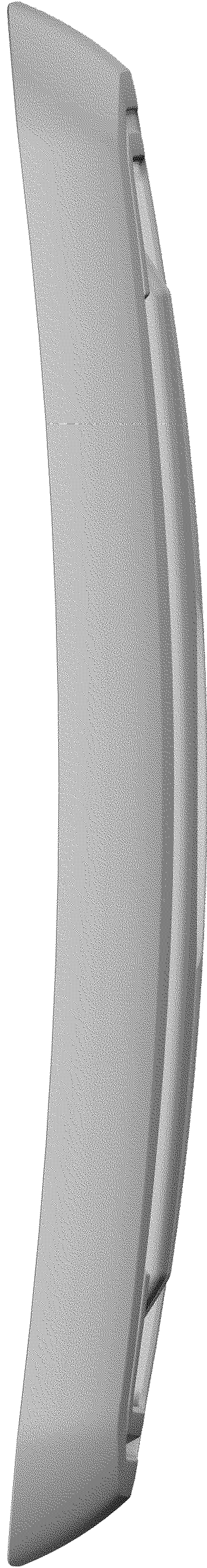

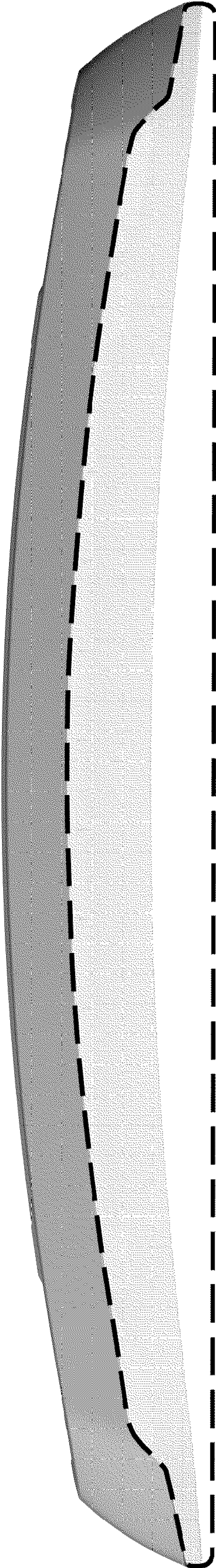

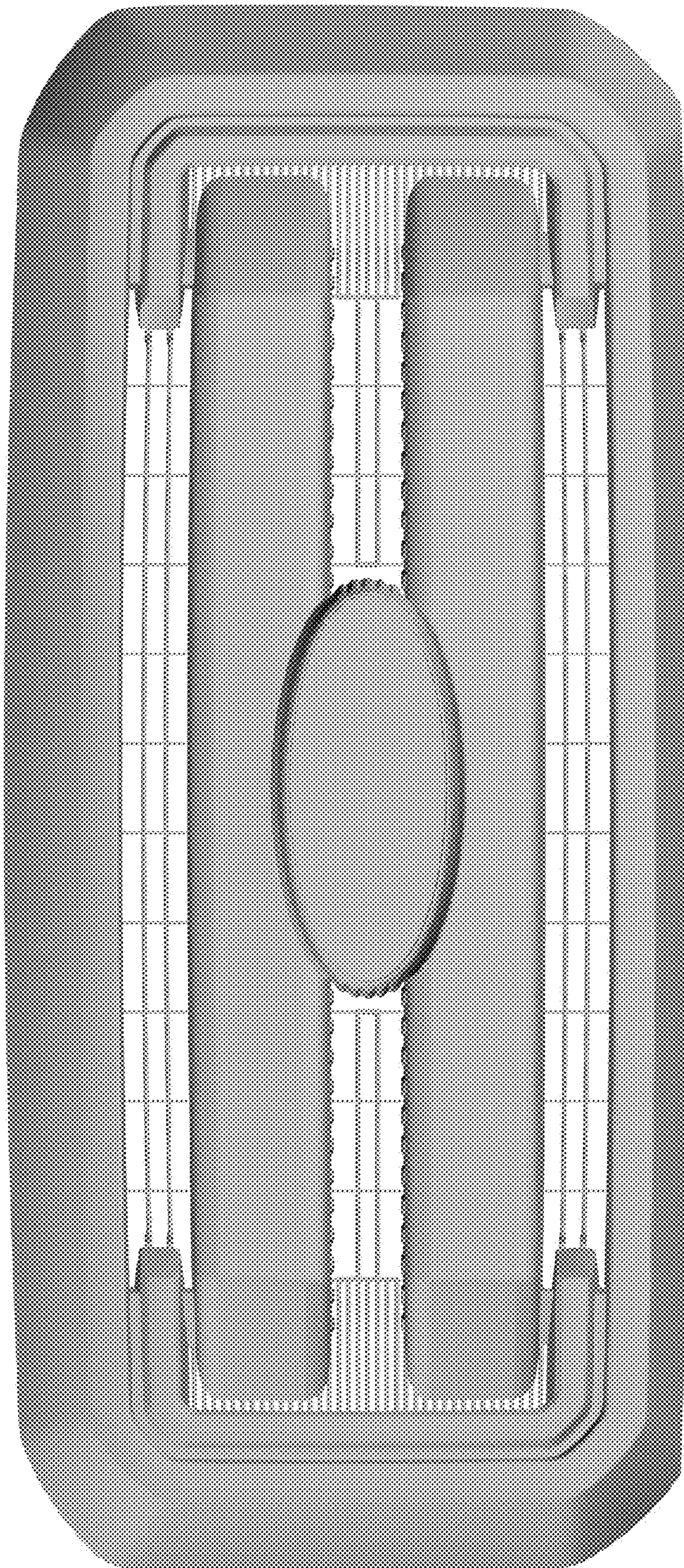
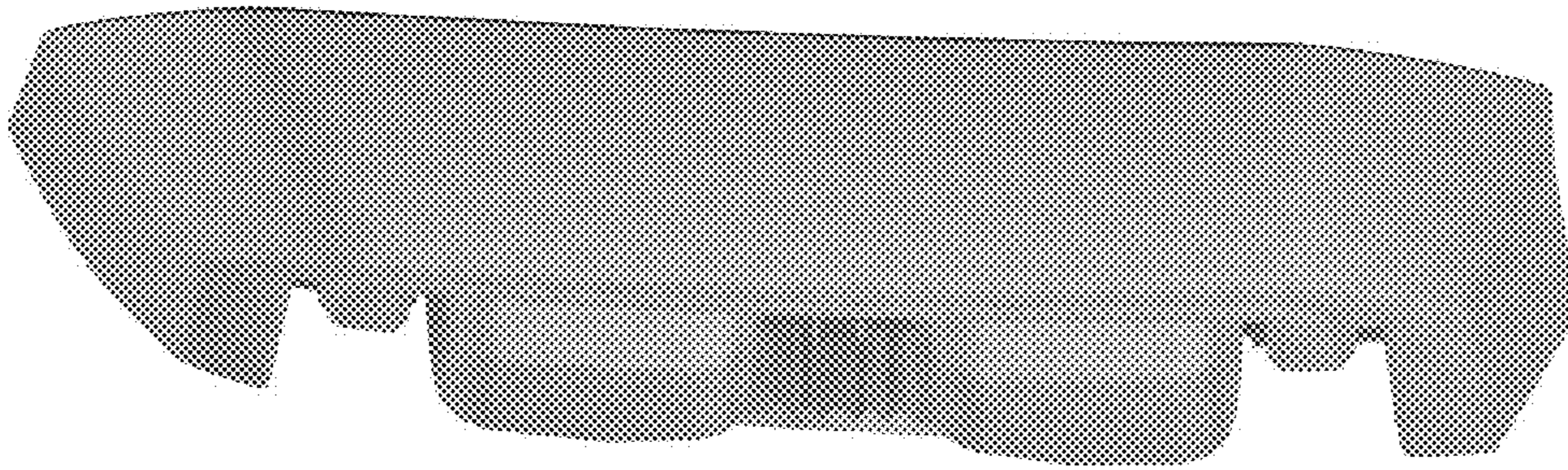
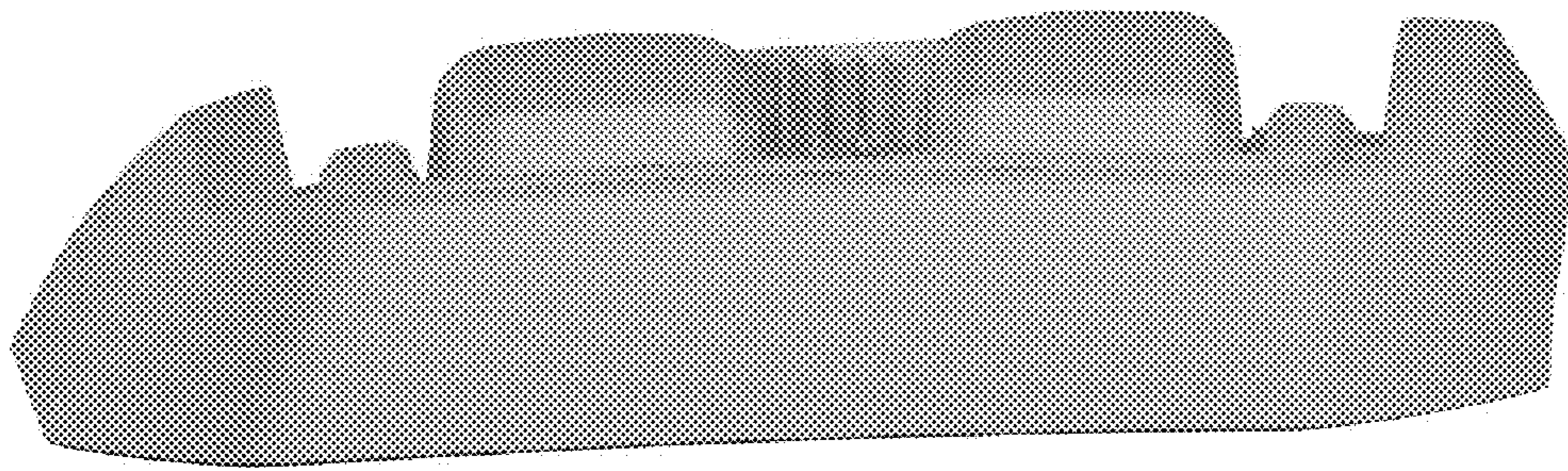
