(57) **CLAIM**

The ornamental design for a power boat, as shown and described.

DESCRIPTION

FIG. 1 is a rear and left perspective view of a power boat embodying the design of the present invention;

FIG. 2 is a front perspective view of the power boat of FIG. 1;

FIG. 3 is a rear perspective view of the power boat of FIG. 1;

FIG. 4 is a left side elevational view of the power boat of FIG. 1;

FIG. 5 is a right side elevational view of the power boat of FIG. 1;

FIG. 6 is a top plan view of the power boat of FIG. 1;

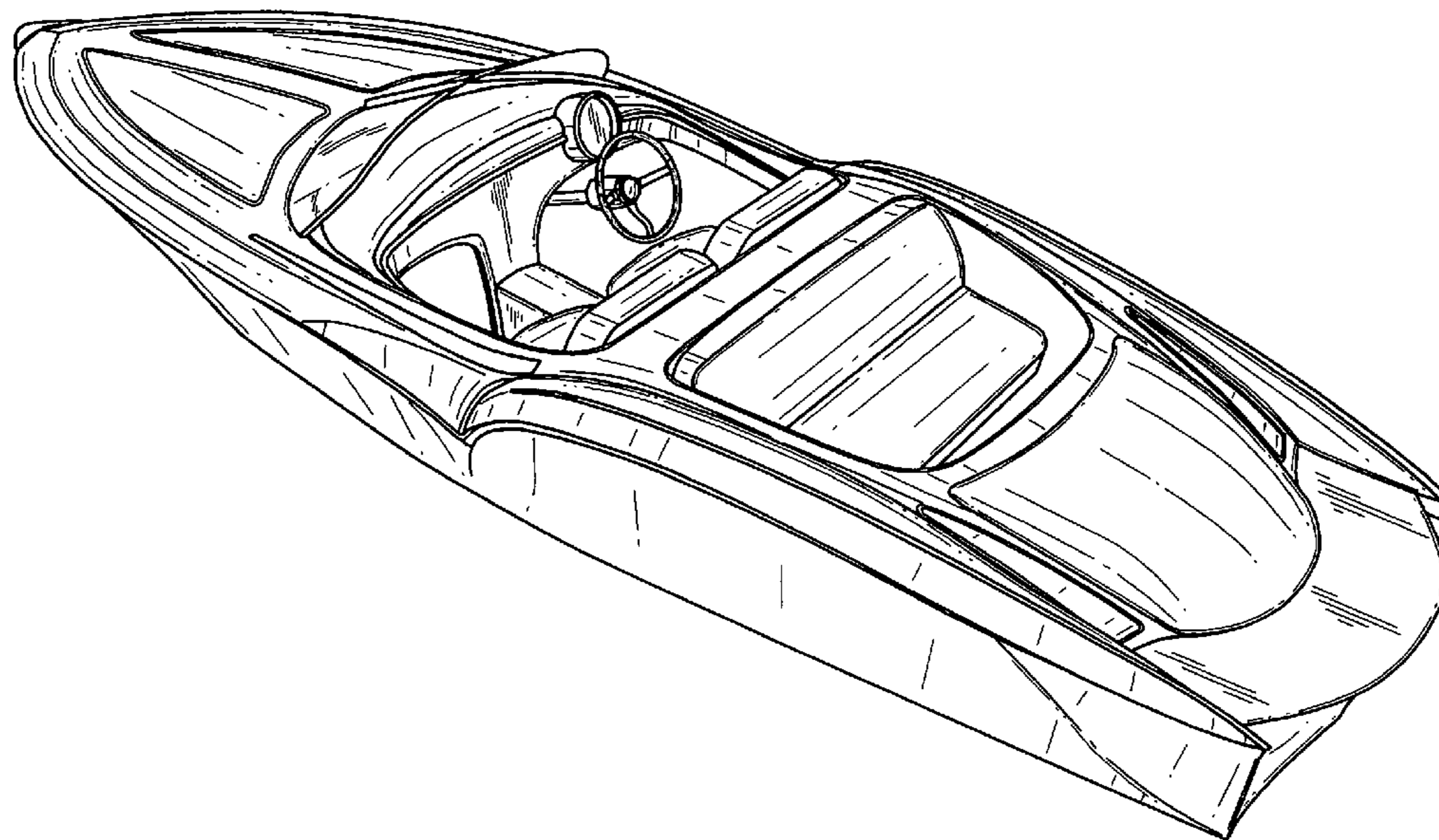
FIG. 7 is a bottom plan view of the power boat of FIG. 1;

FIG. 8 is a rear and left perspective view of the power boat of FIG. 1, shown with a back seat cover in broken lines; and,

FIG. 9 is a rear and left perspective view of the power boat of FIG. 1, shown with a back seat cover and a canopy in broken lines.

The broken lines shown in FIGS. 8 & 9 represent portions of the design that form no part of the claim.

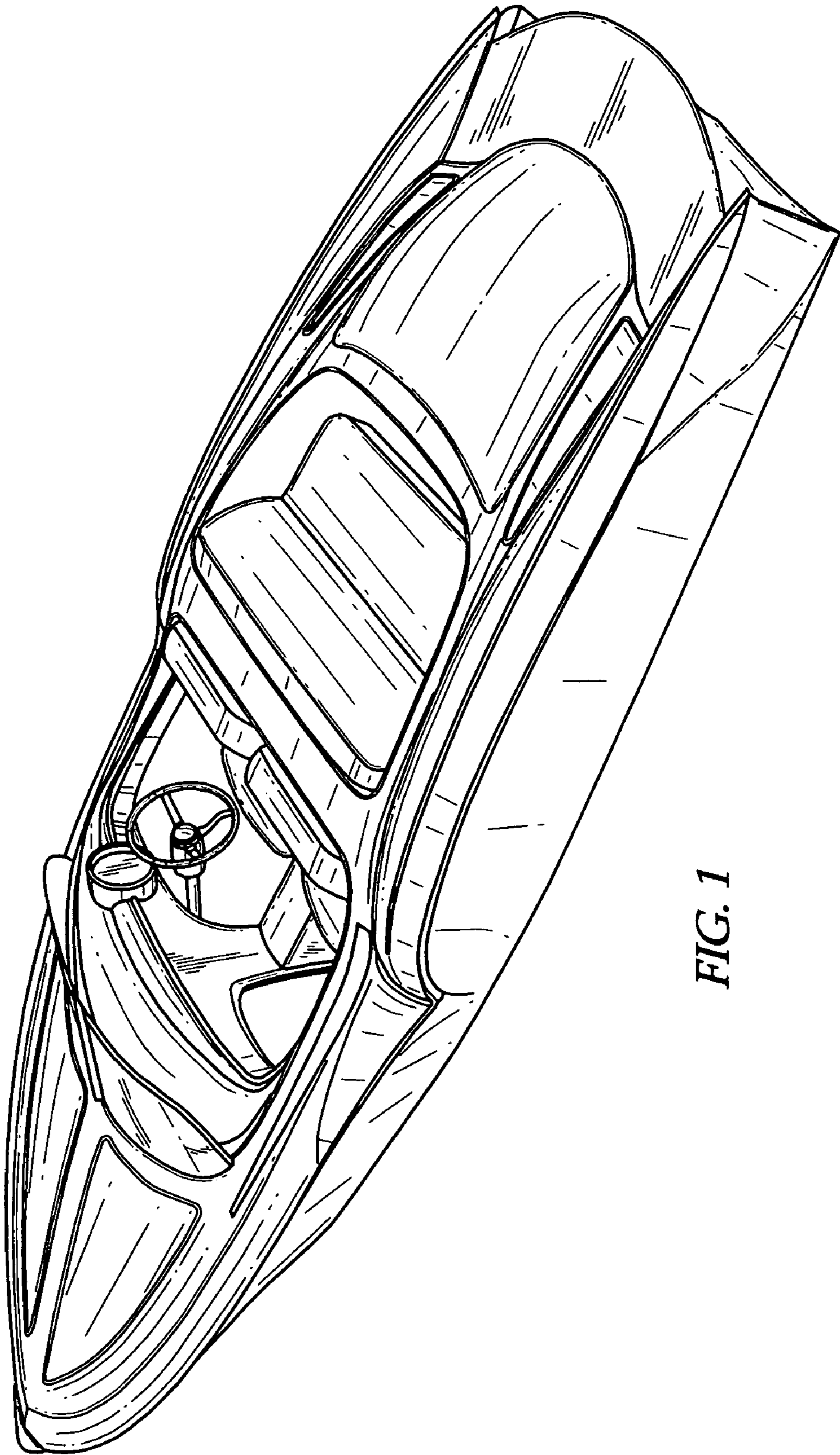

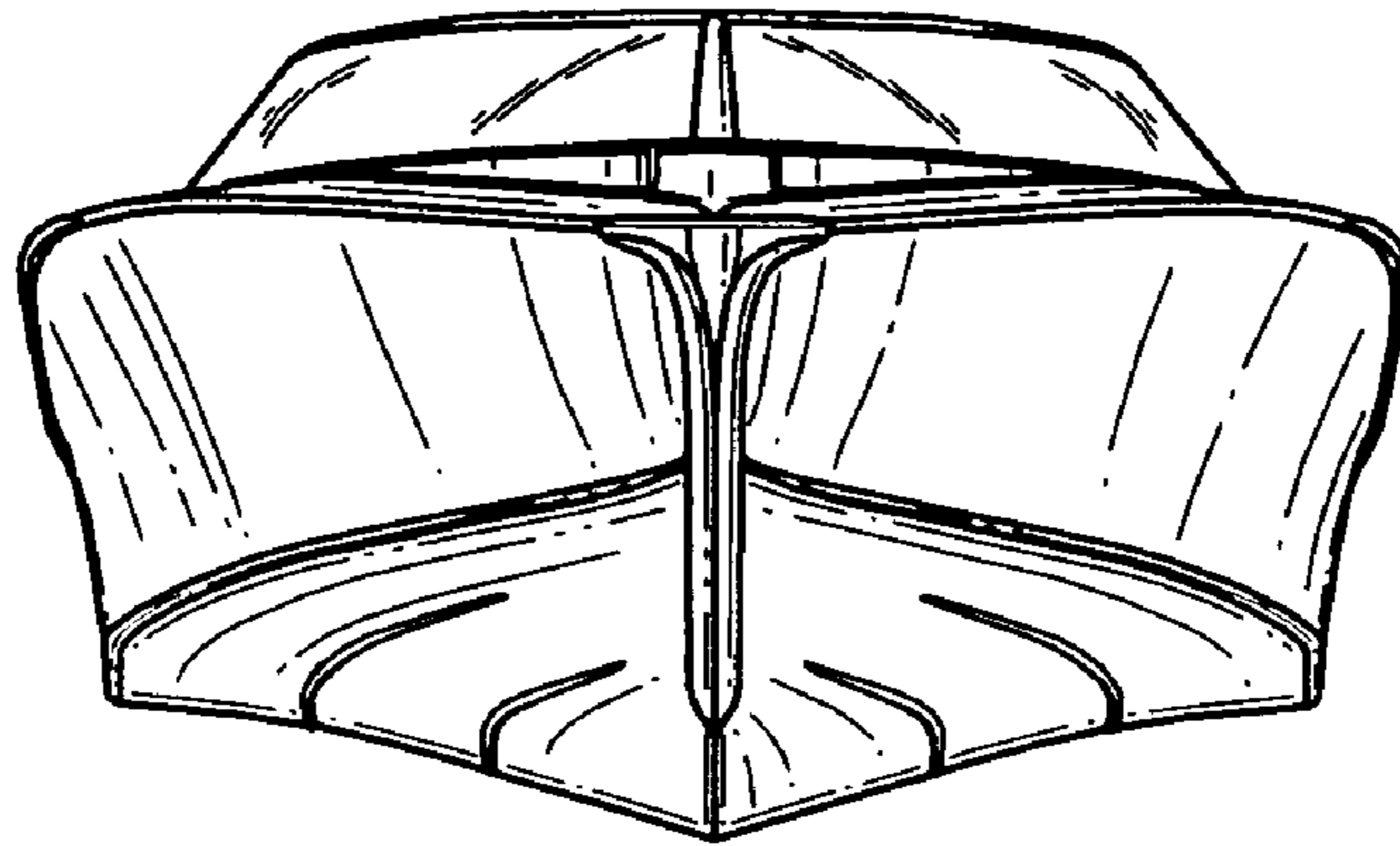

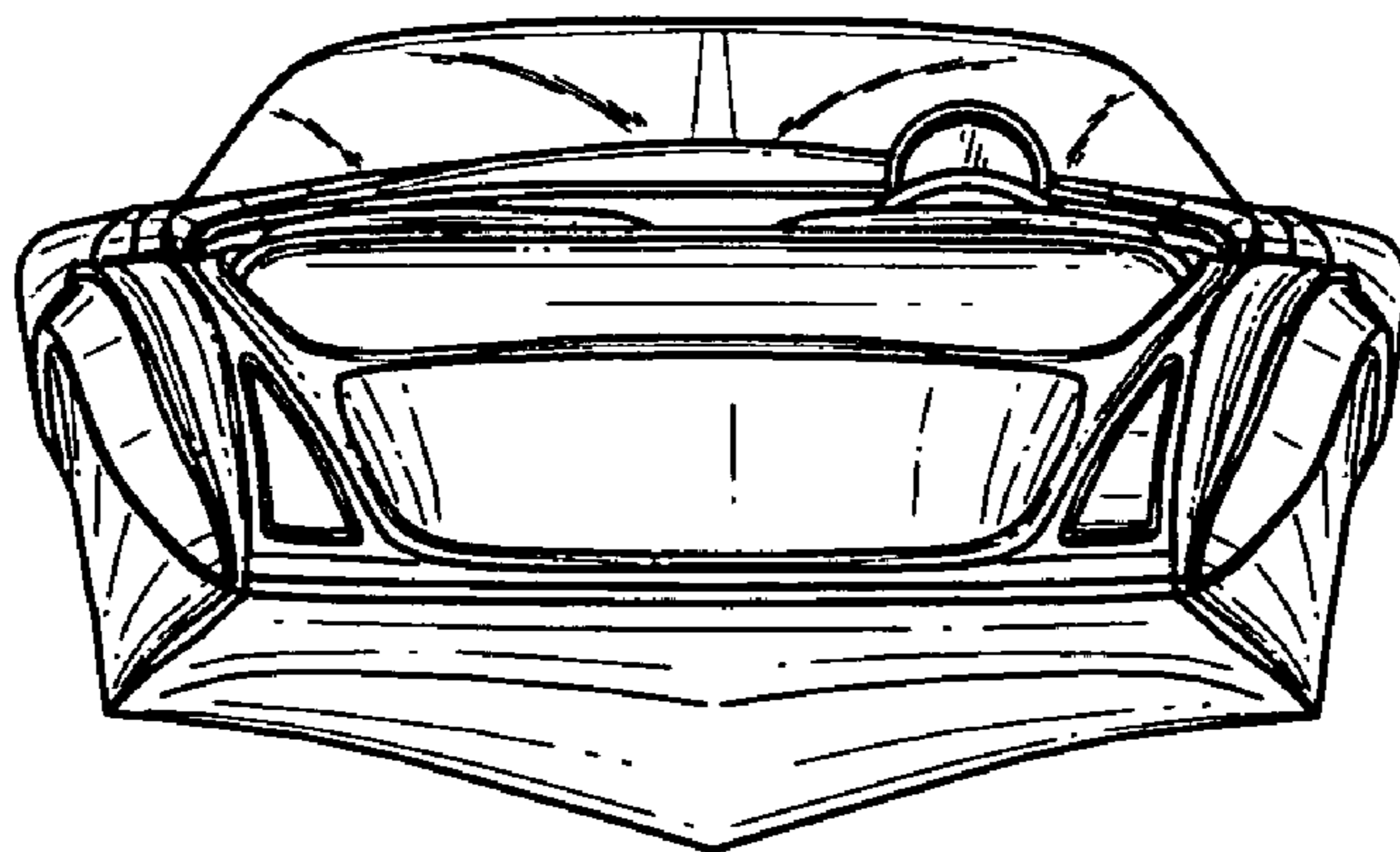

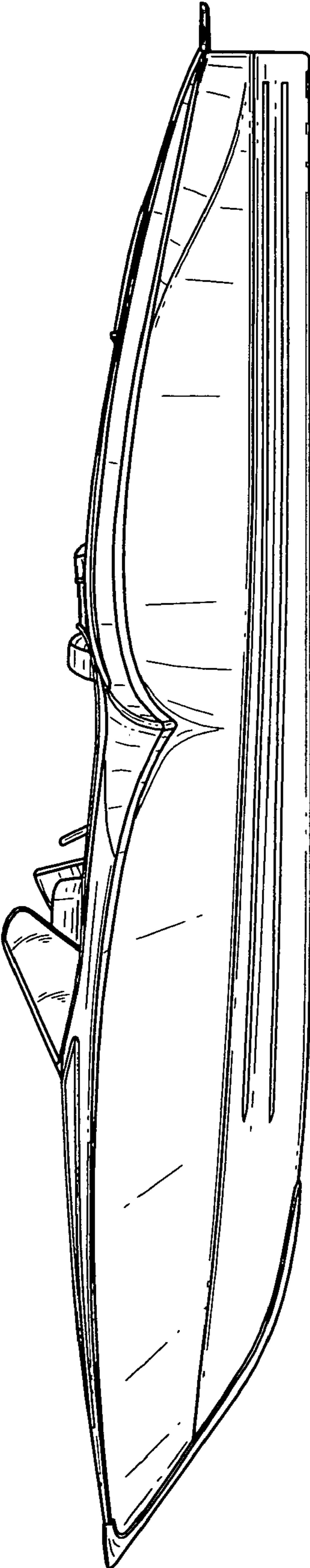

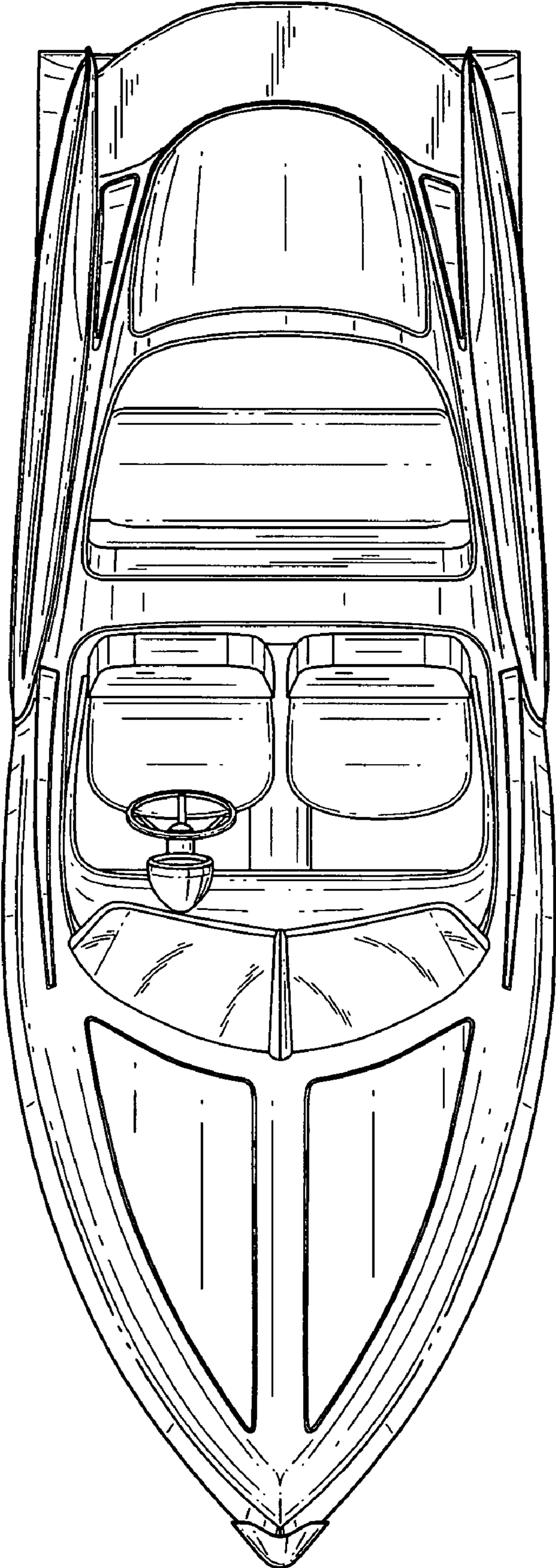

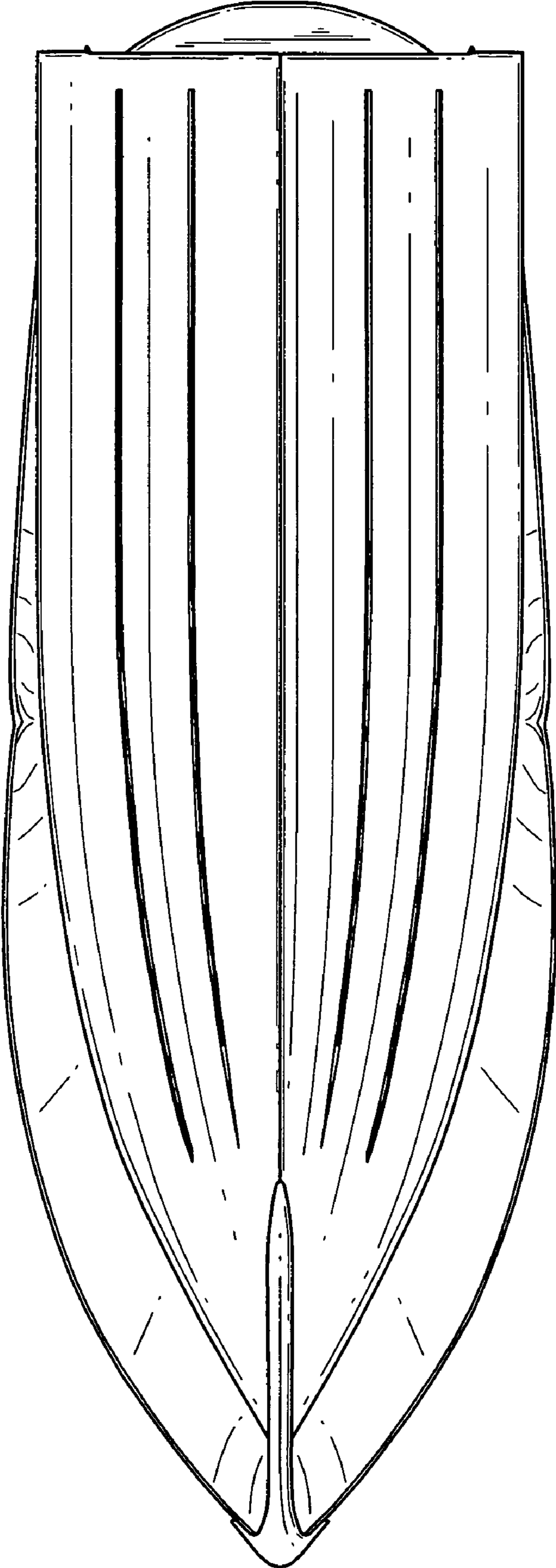

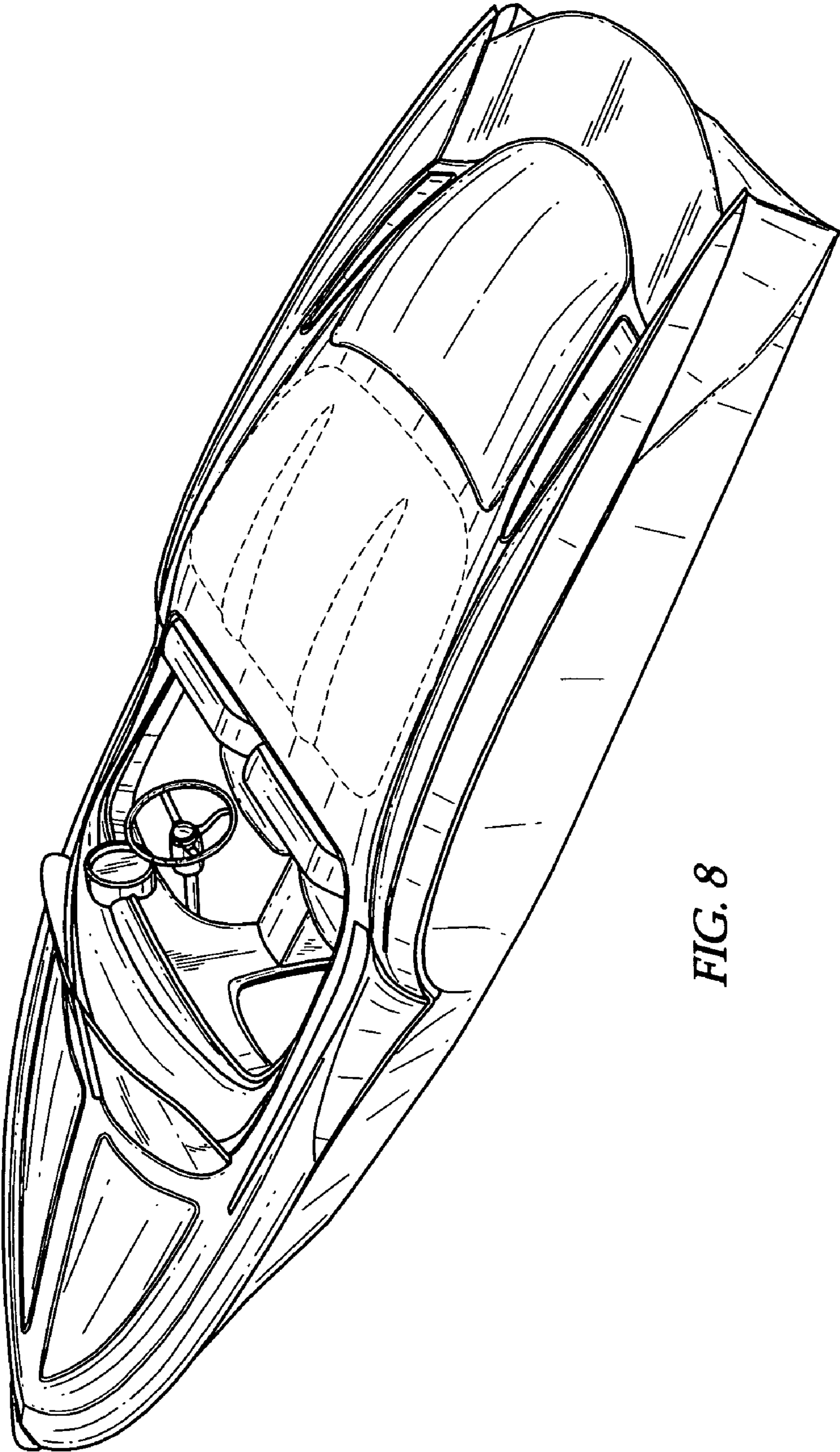

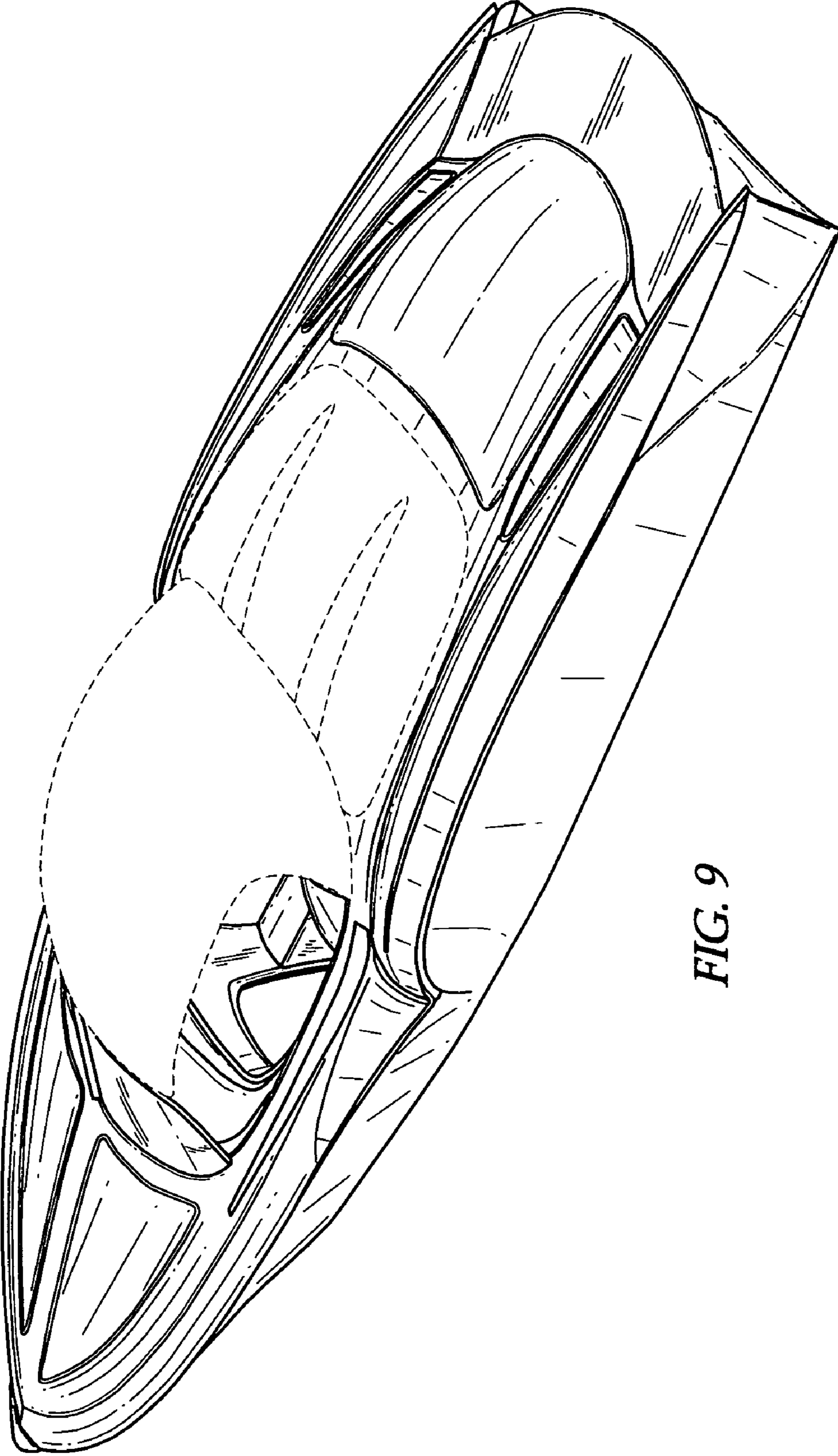
