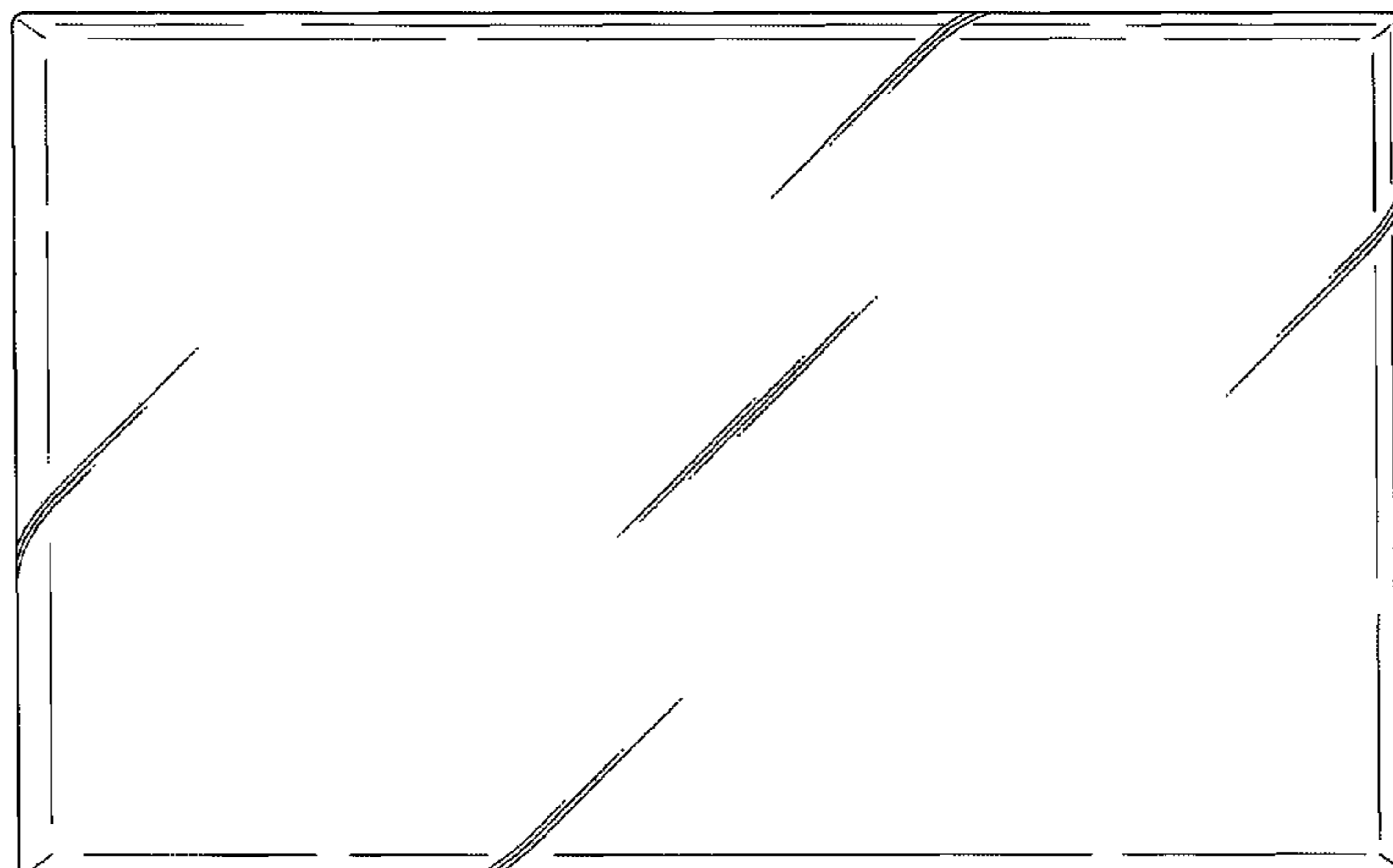
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front and right side perspective view of a television set, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a right side view thereof; the opposite side being a mirror image thereof; and,
FIG. 7 is an enlarged fragmented right side view thereof, taken along the line 7—7 in FIG. 6.

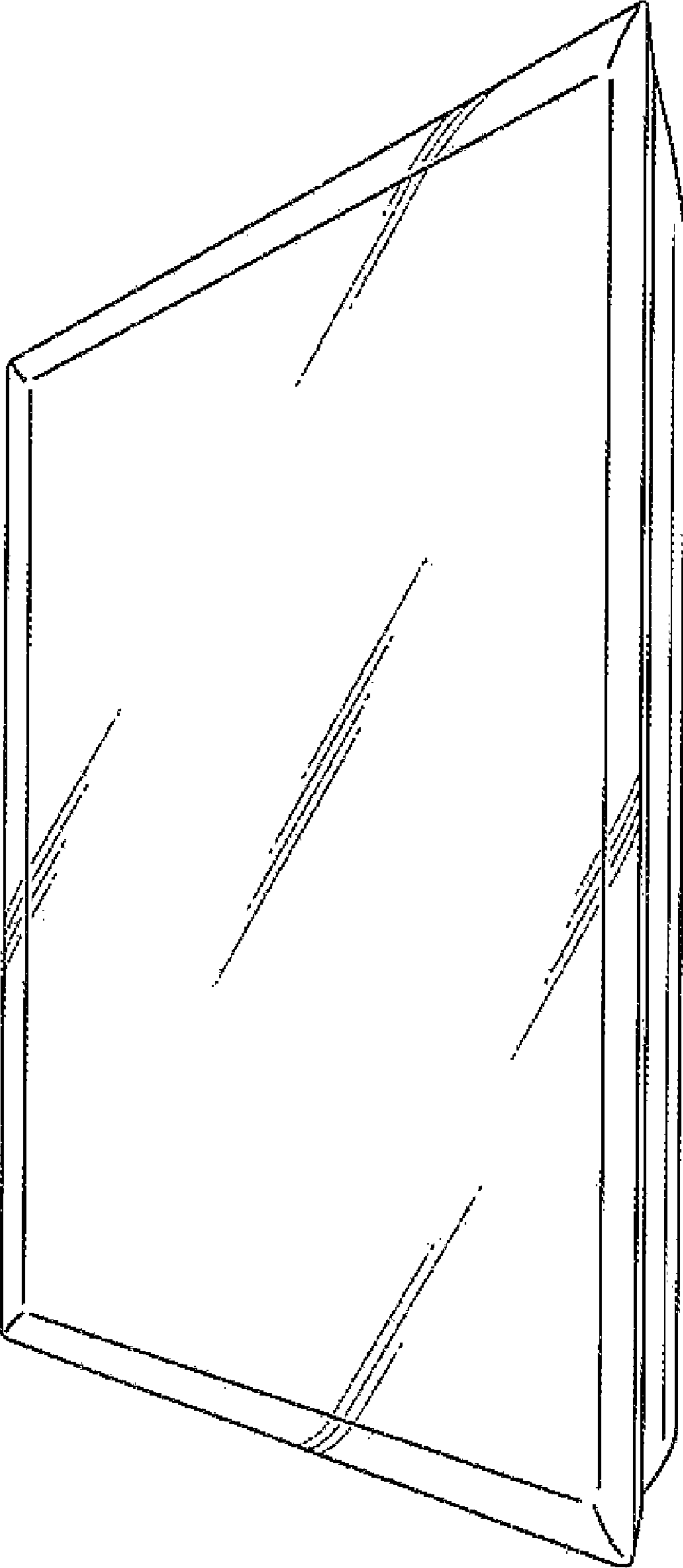

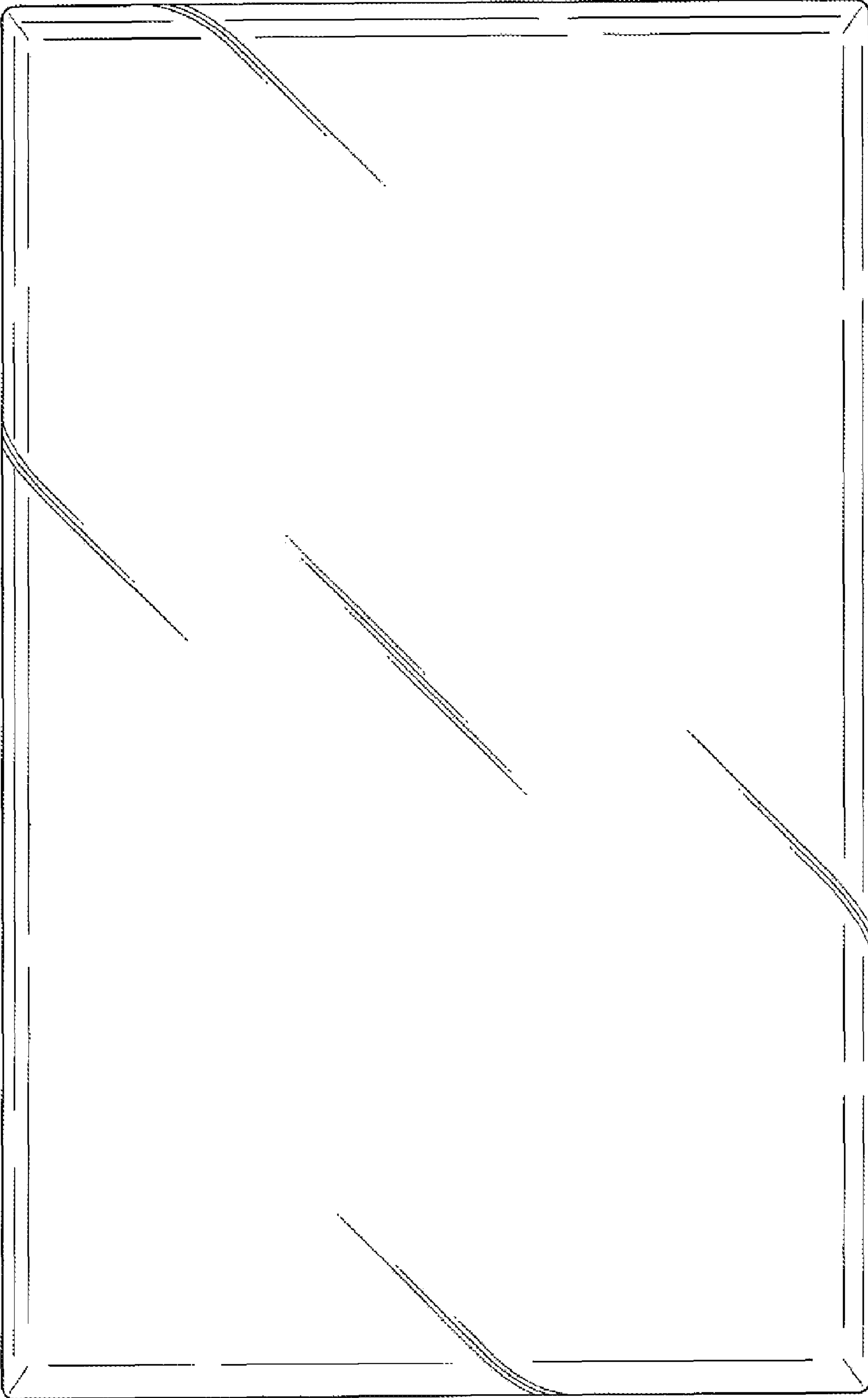

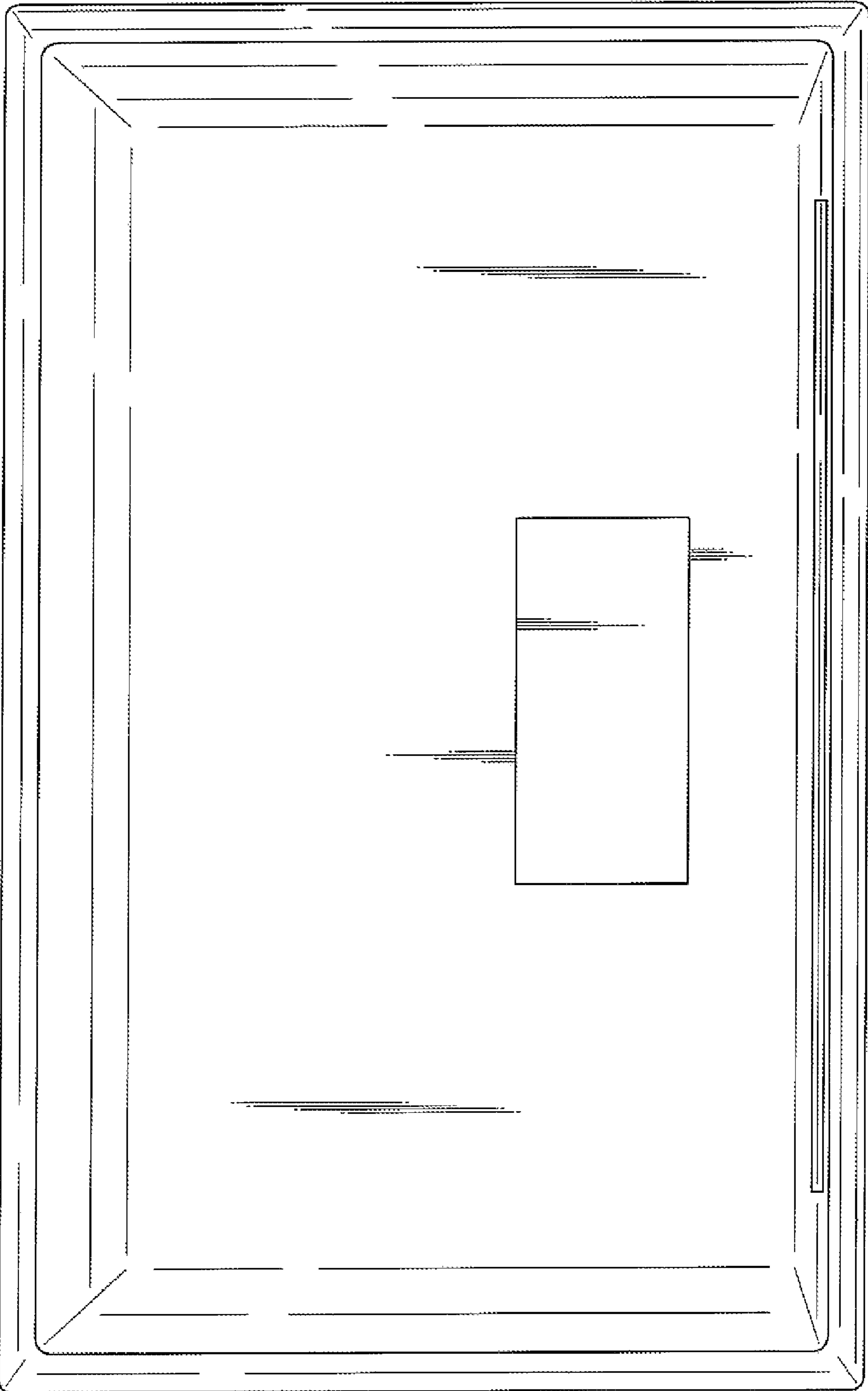

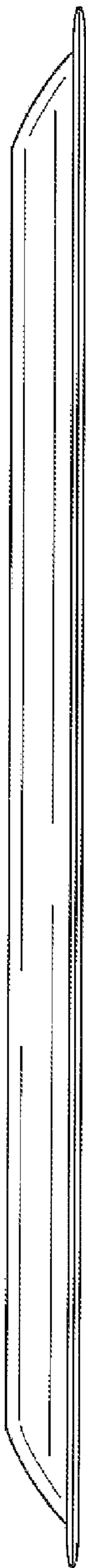

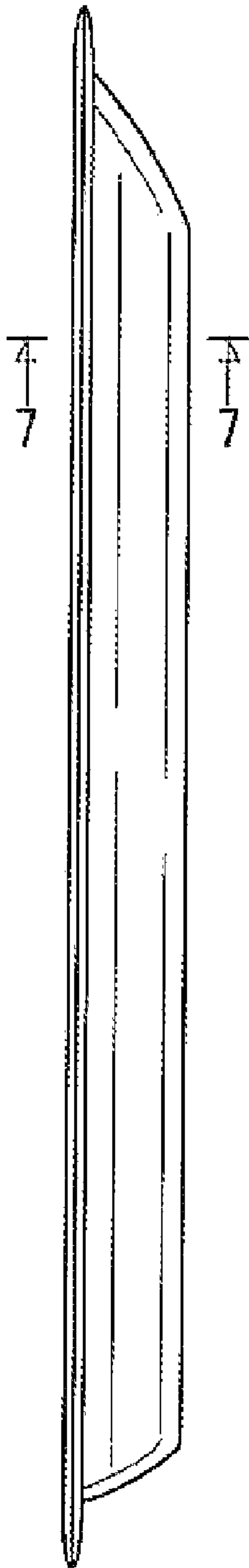

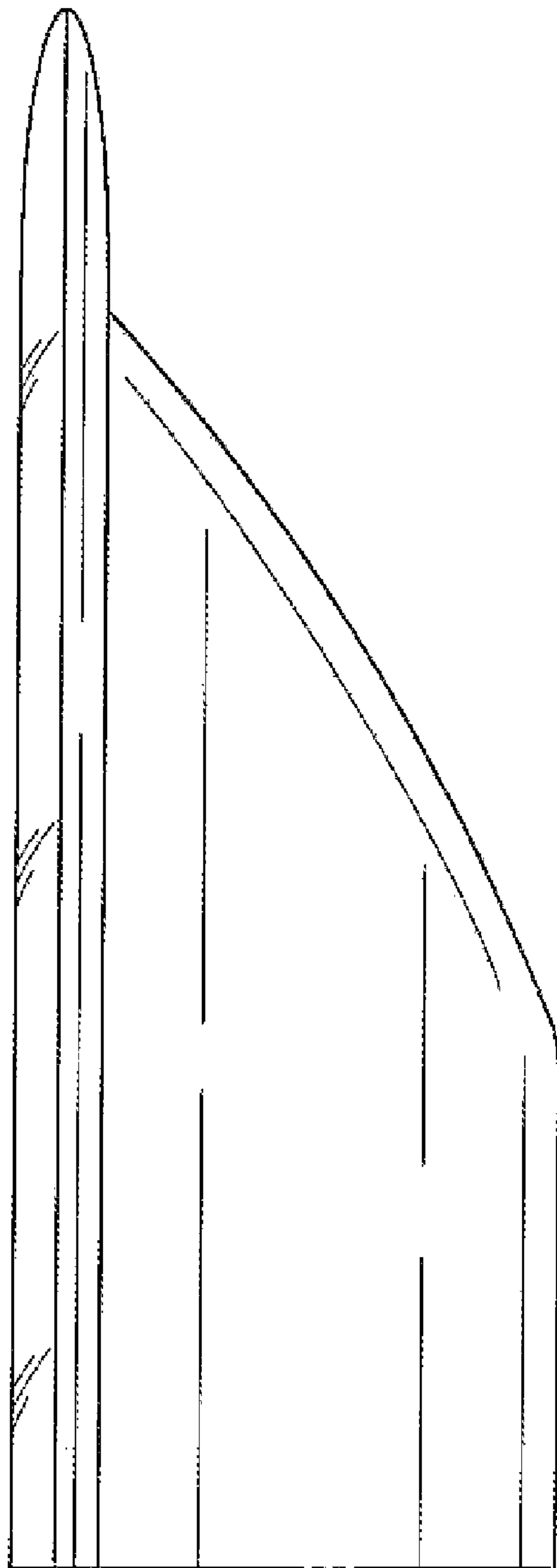
