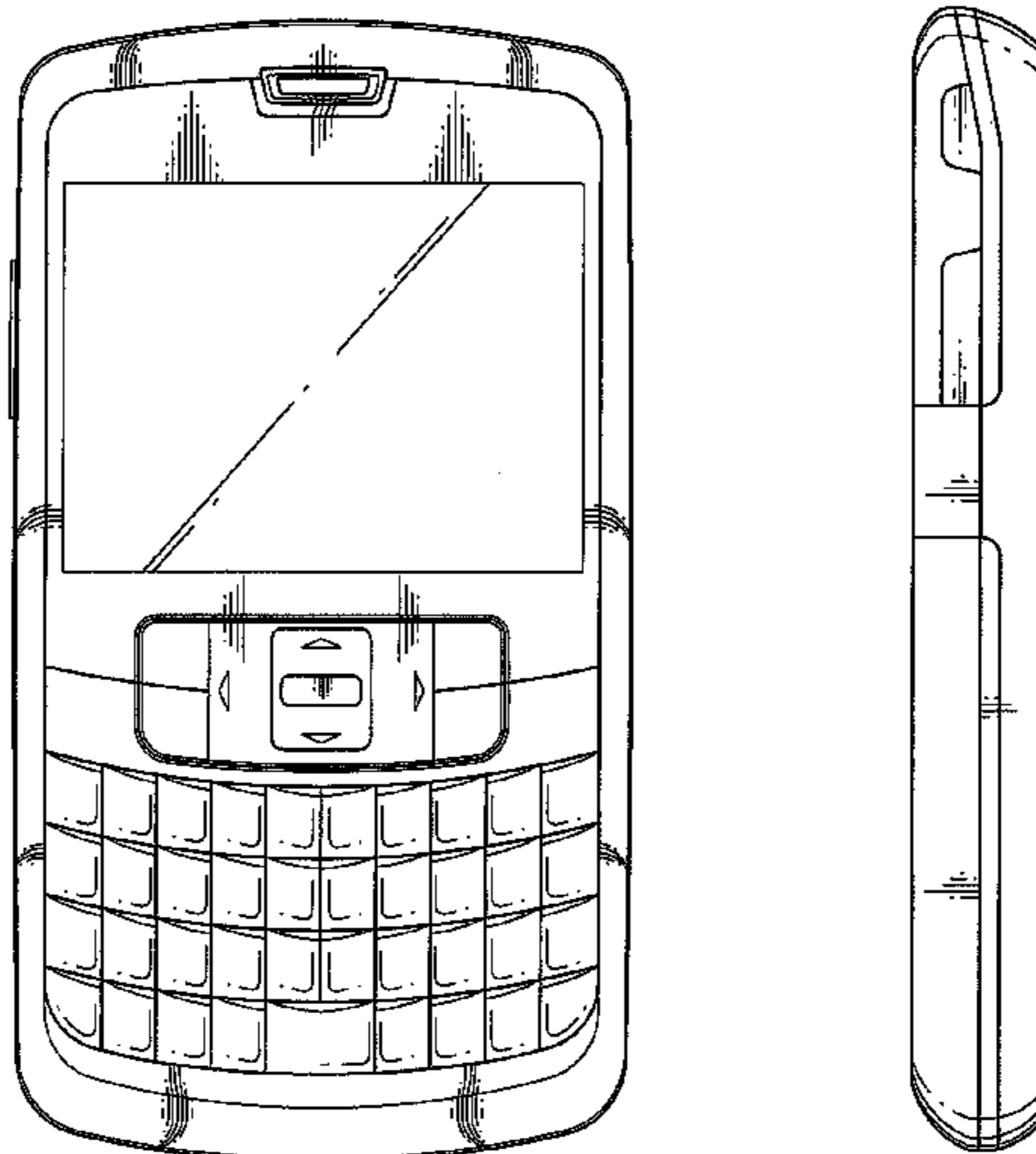
CLAIM

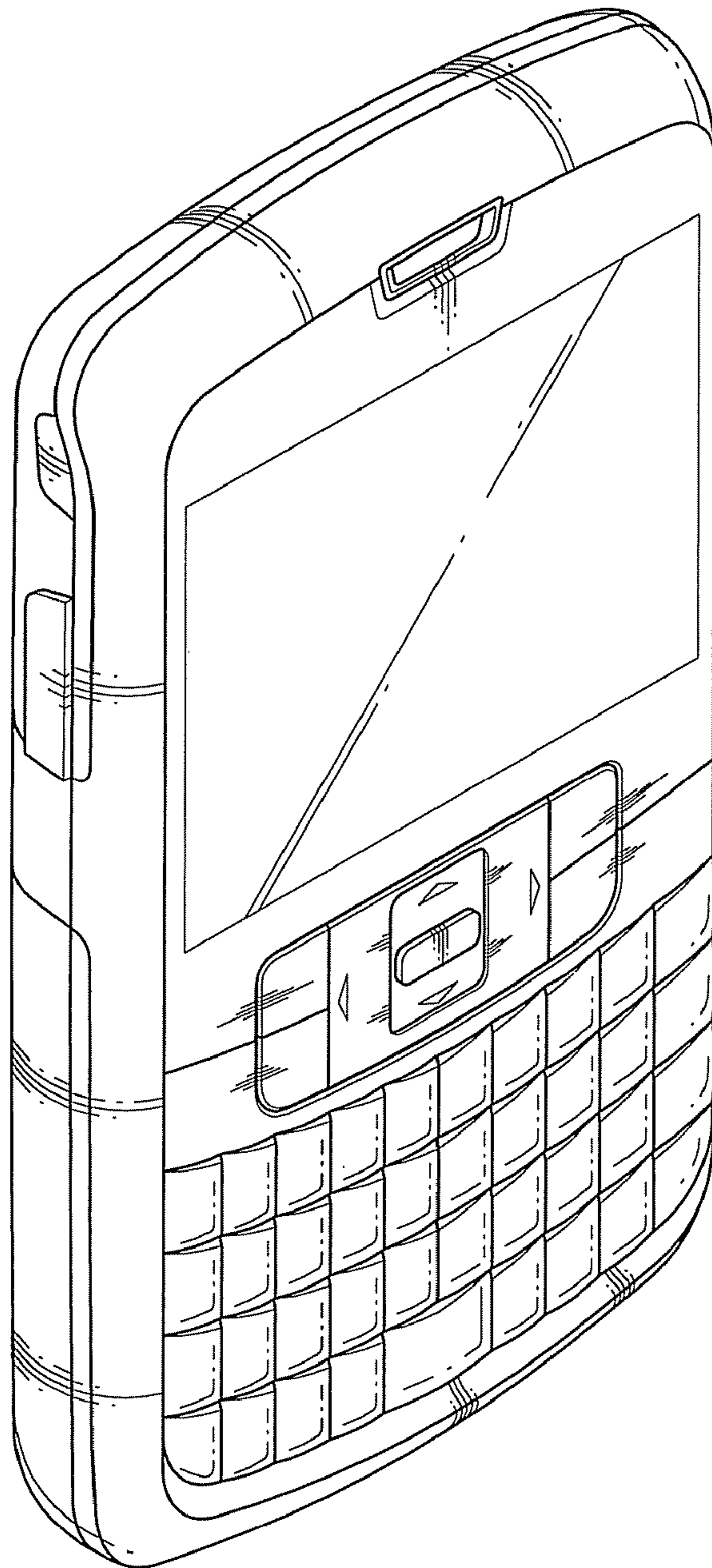

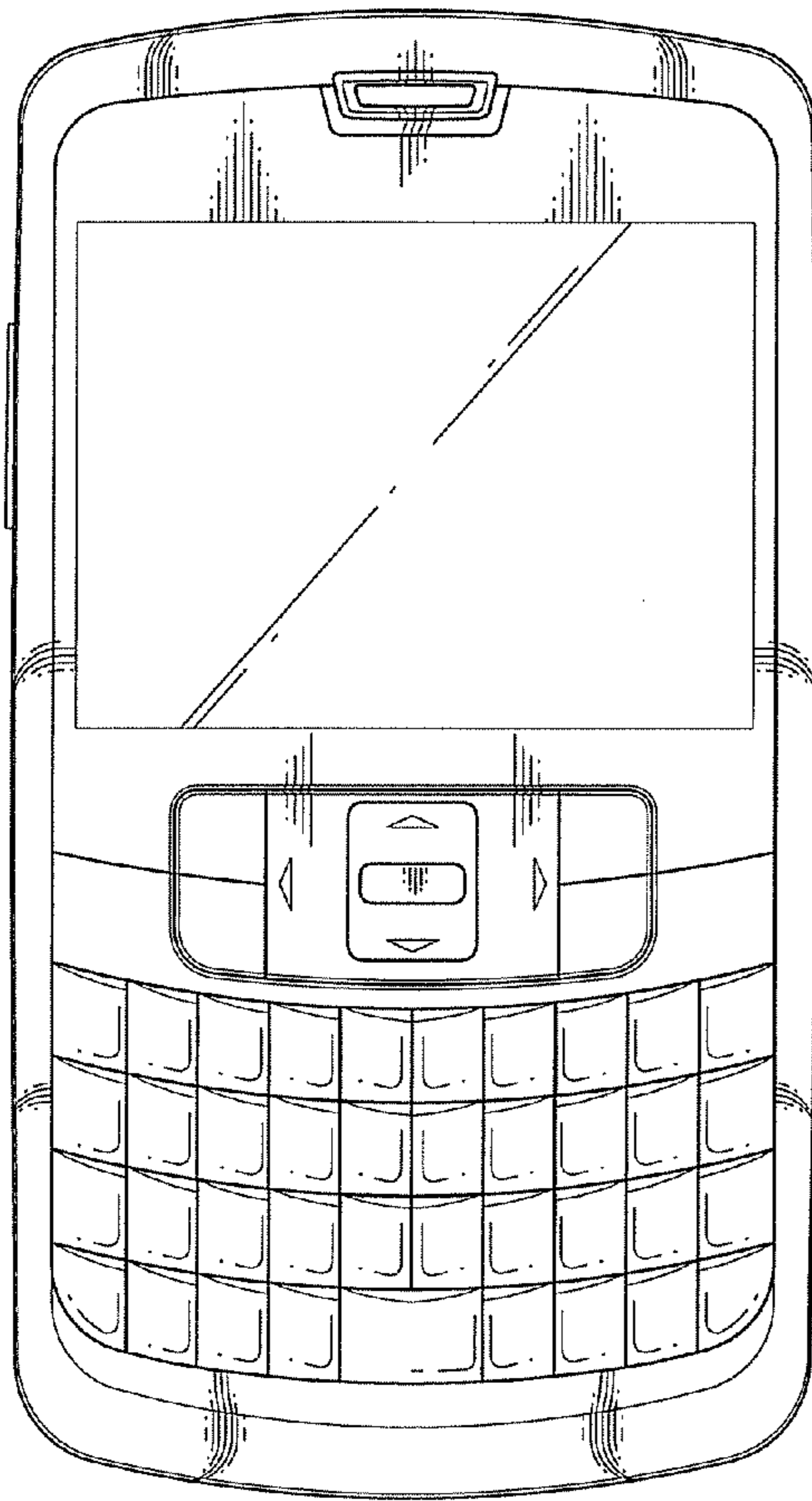

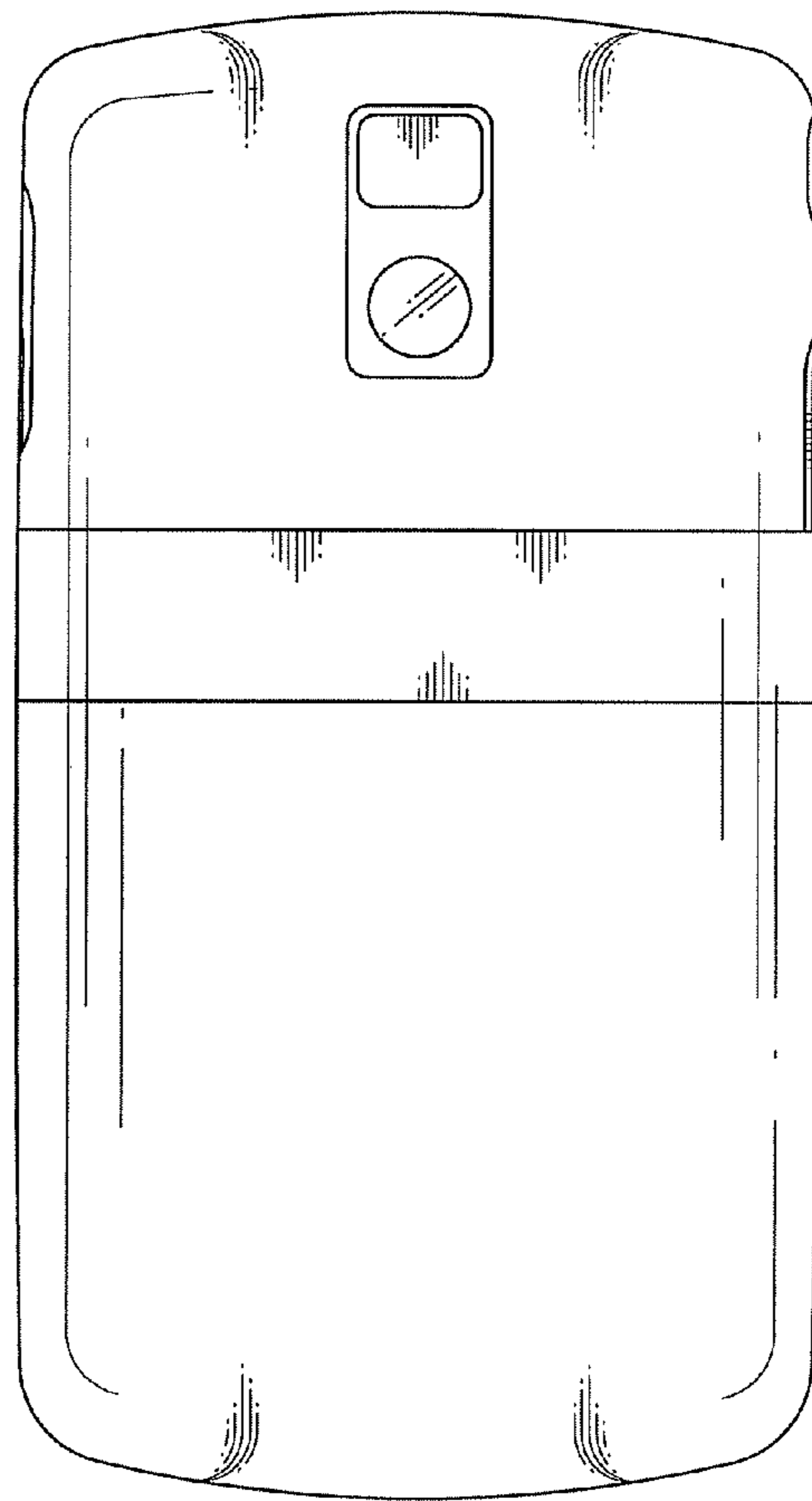

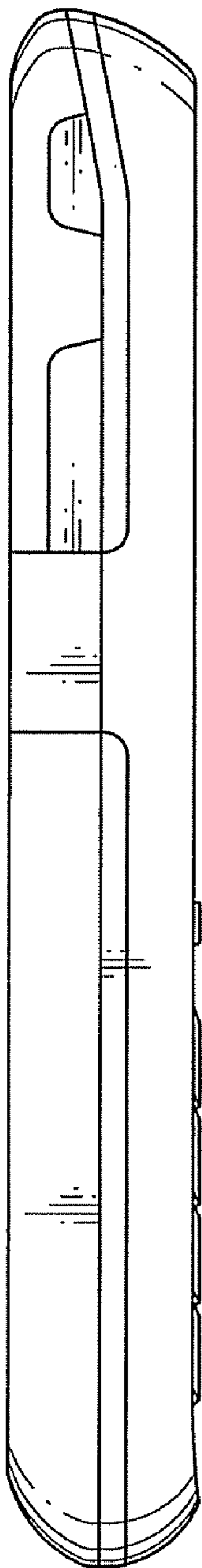

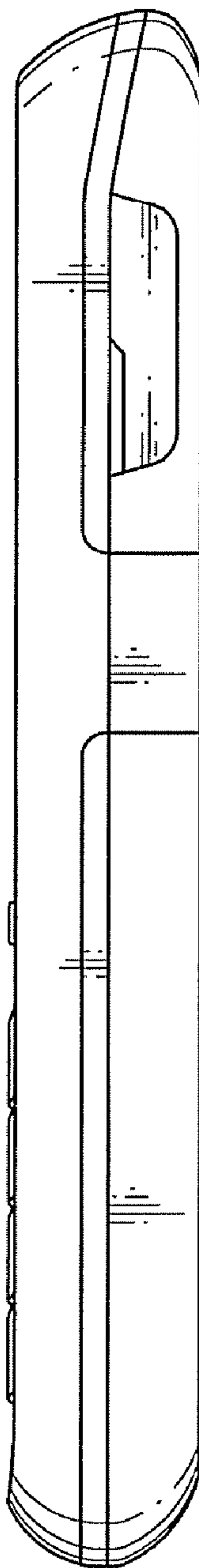

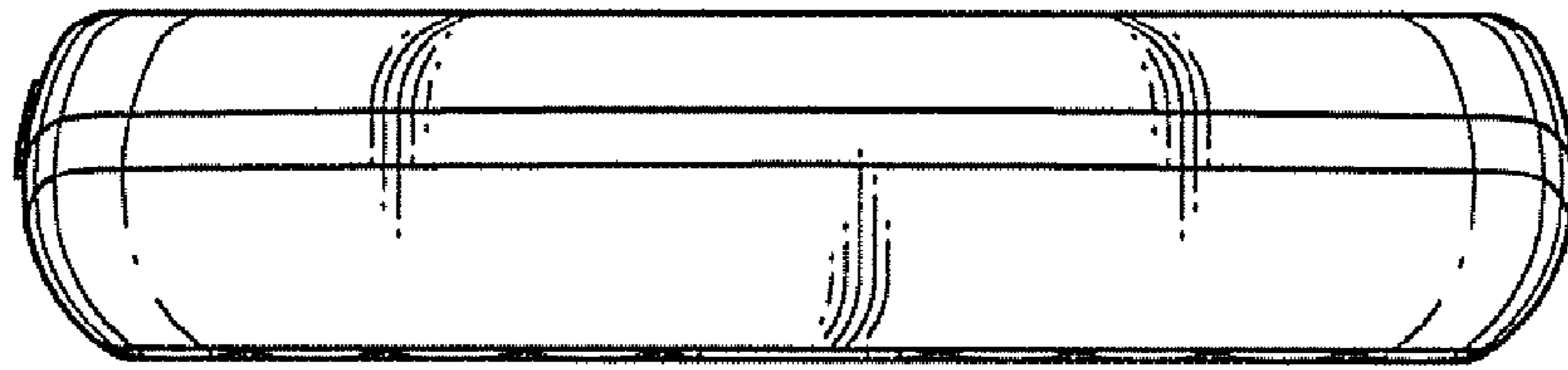
