The ornamental design for a PC card adapter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a PC card adapter according to one embodiment.

FIG. 2 is a top view of the PC card adapter of FIG. 1.

FIG. 3 is a bottom view of the PC card adapter of FIG. 1.

FIG. 4 is a proximal end view of the PC card adapter of FIG. 1.

FIG. 5 is a distal end view of the PC card adapter of FIG. 1.

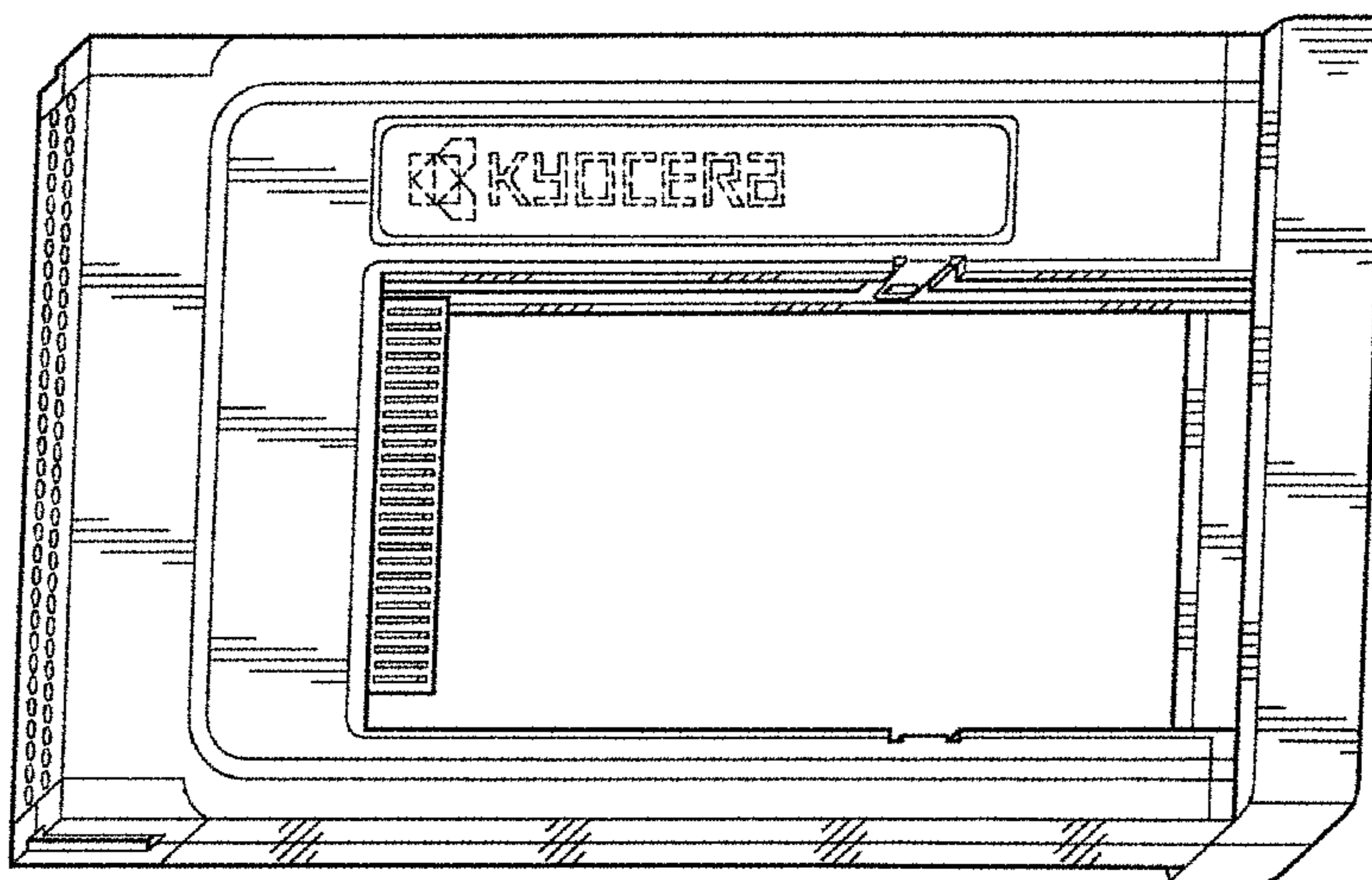
FIG. 6 is a right side view of the PC card adapter of FIG. 1; and,

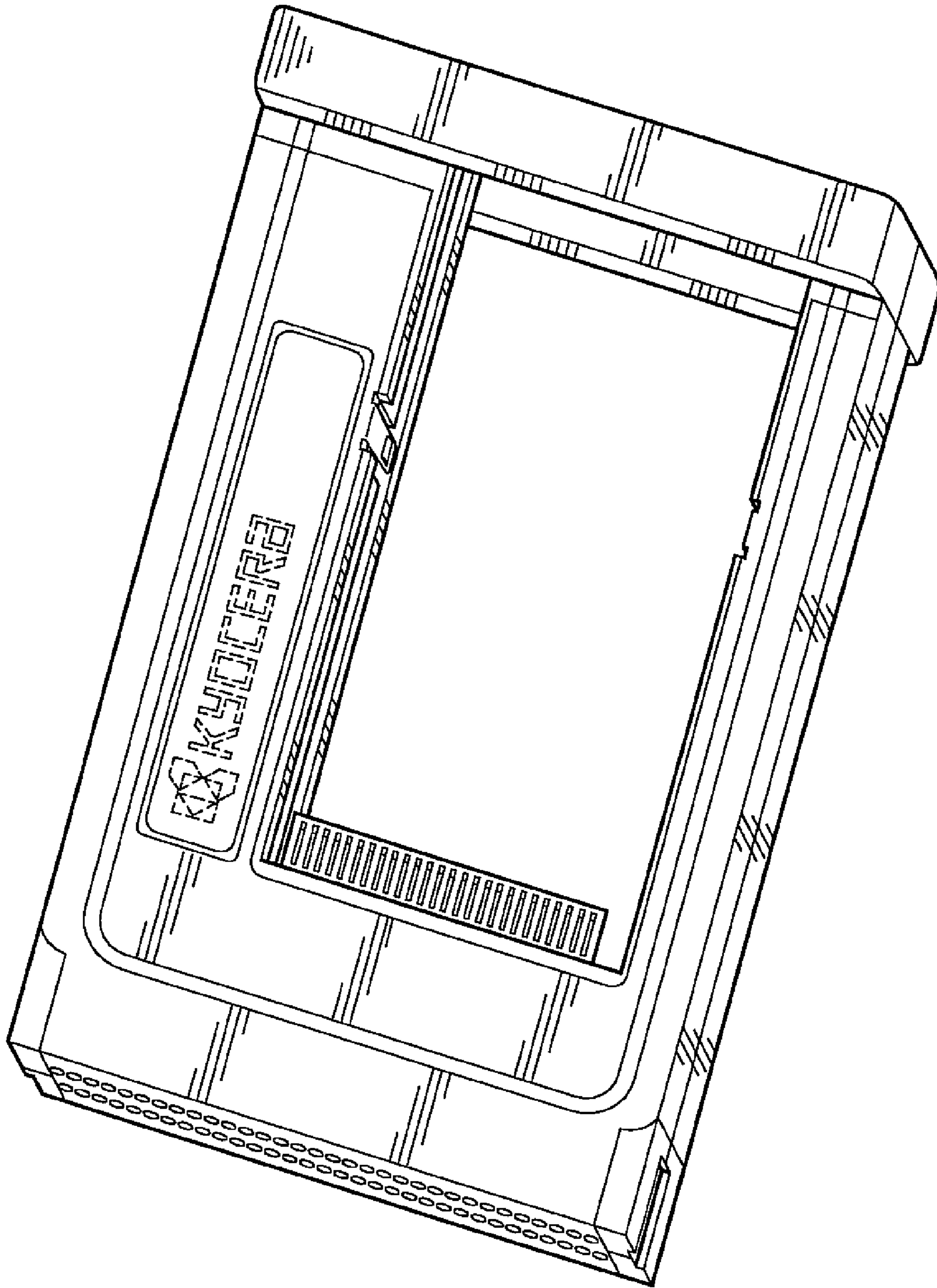

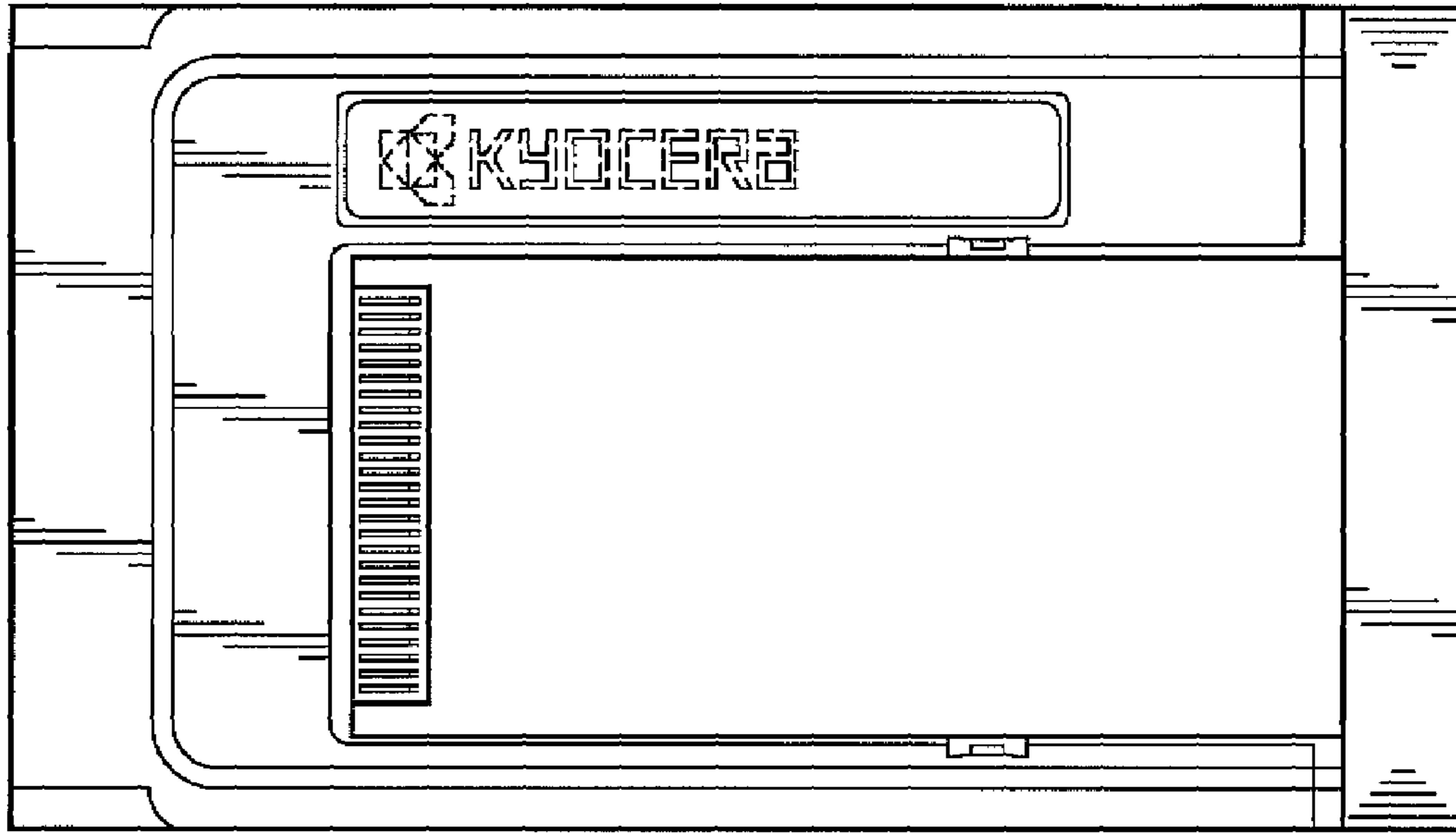

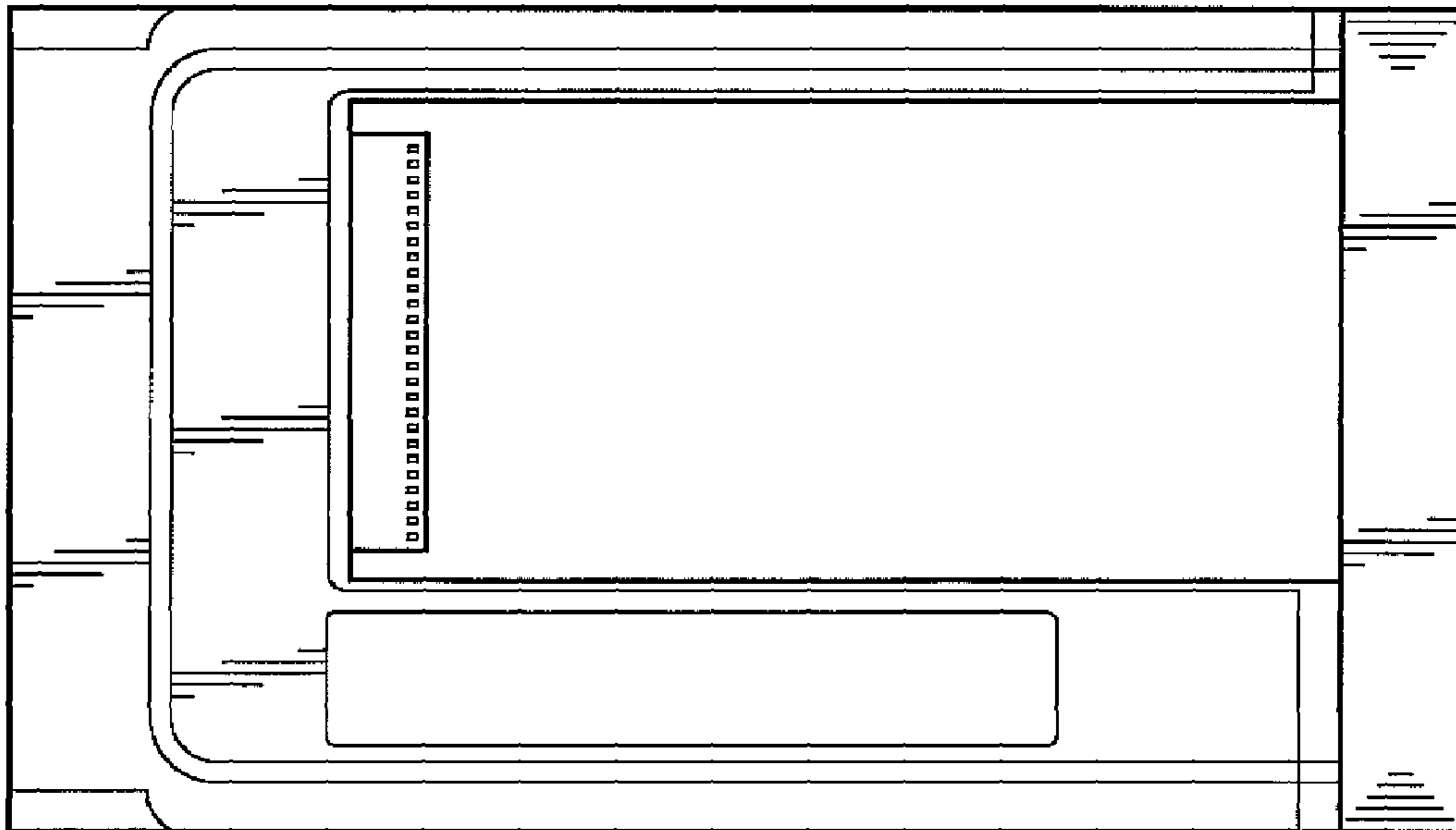

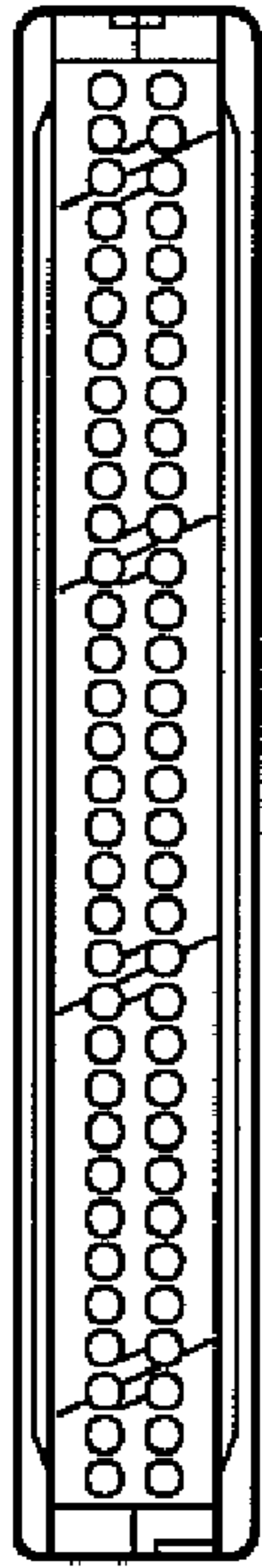

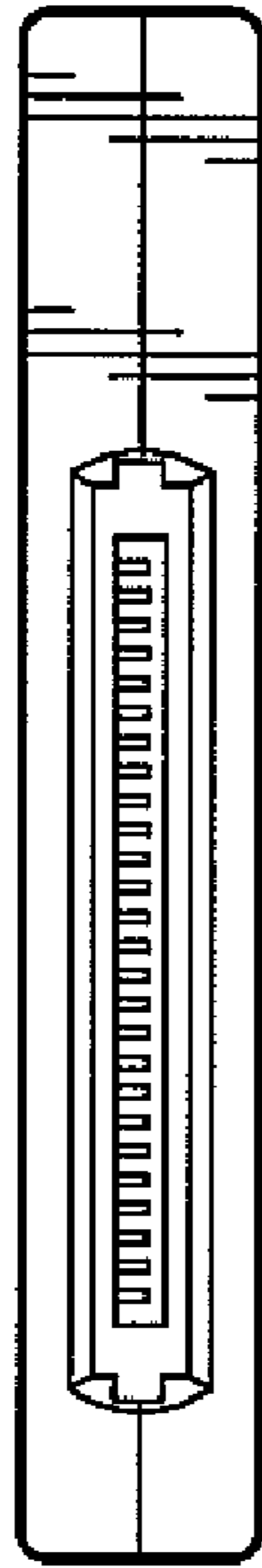

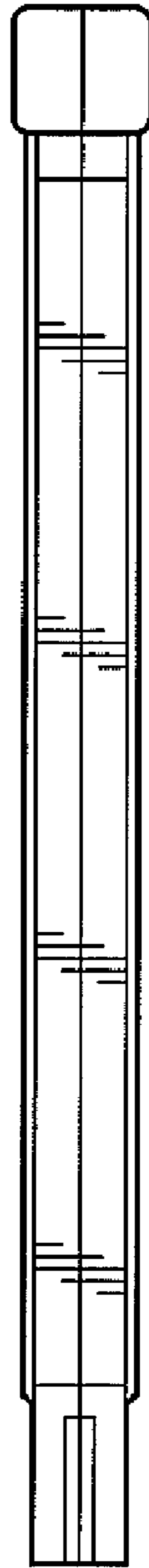

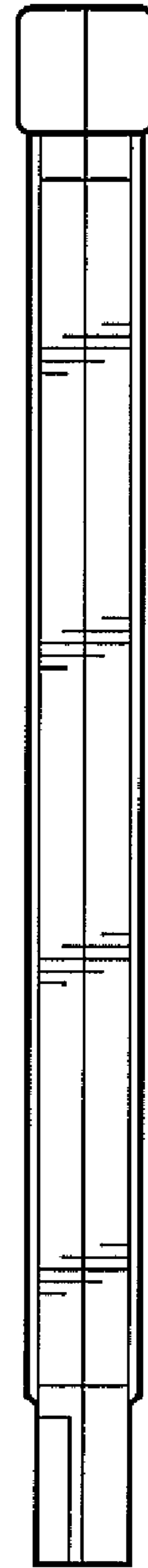
