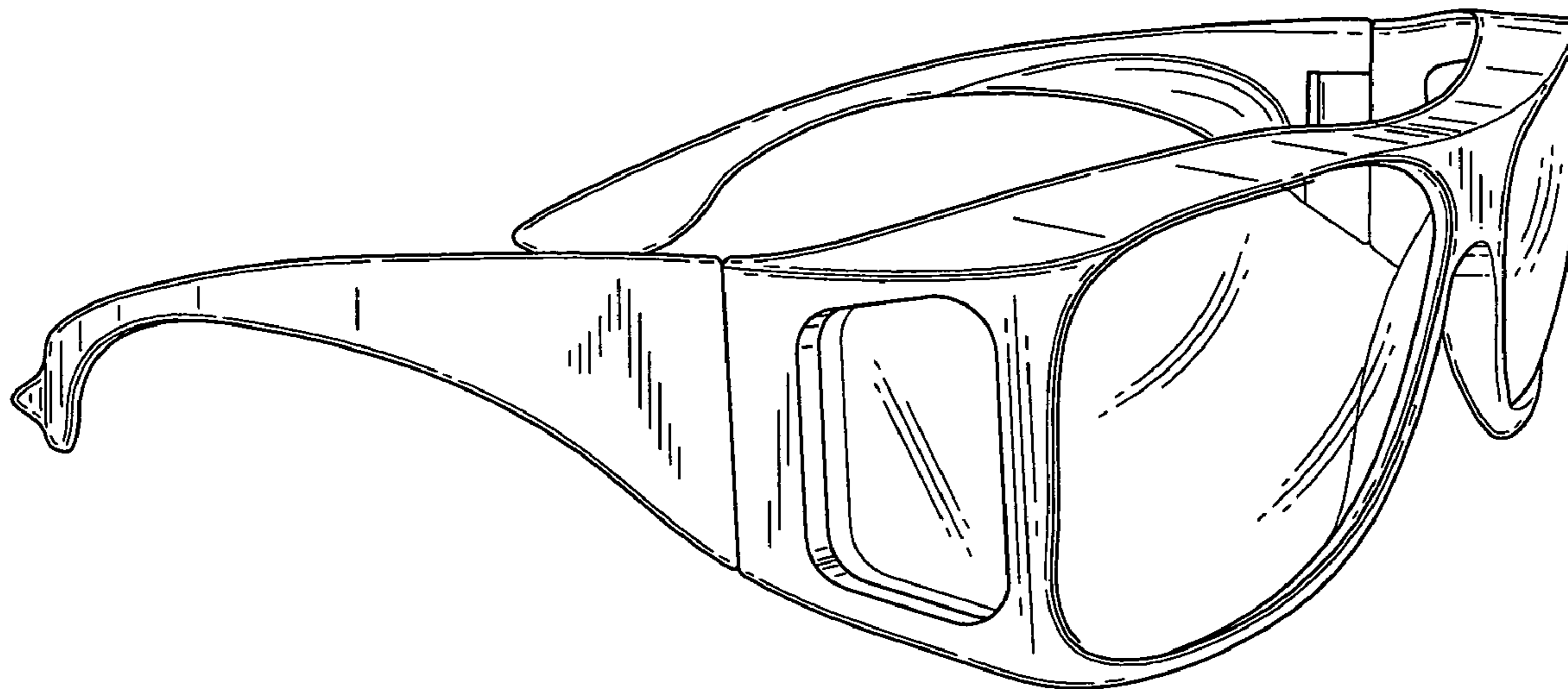

The ornamental design for sunglasses, substantially as shown and described.

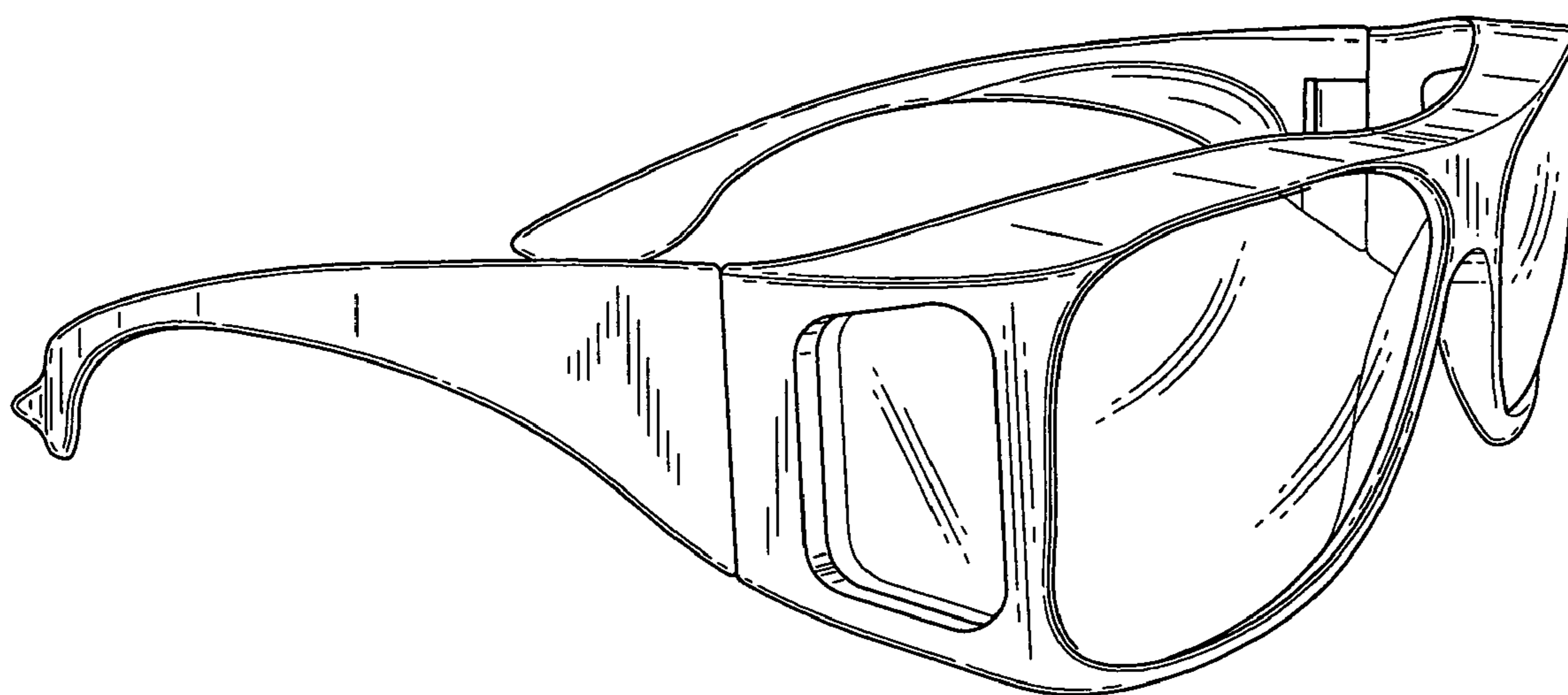
**DESCRIPTION**

FIG. 6 is a bottom elevation view of my design.

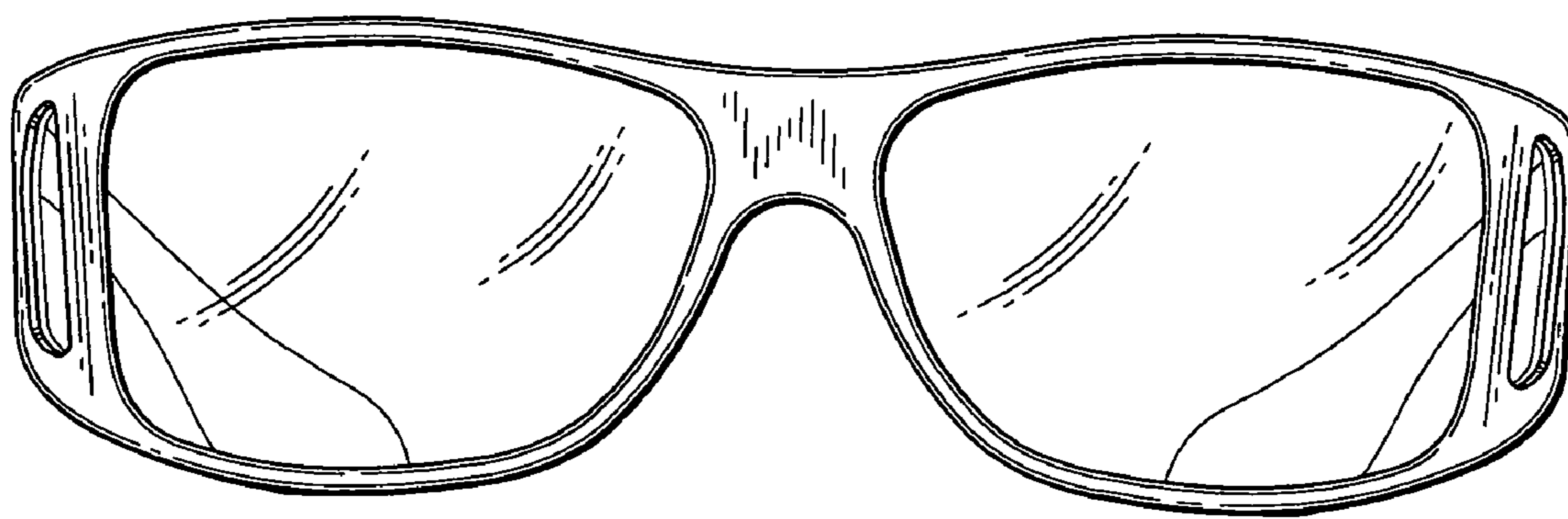

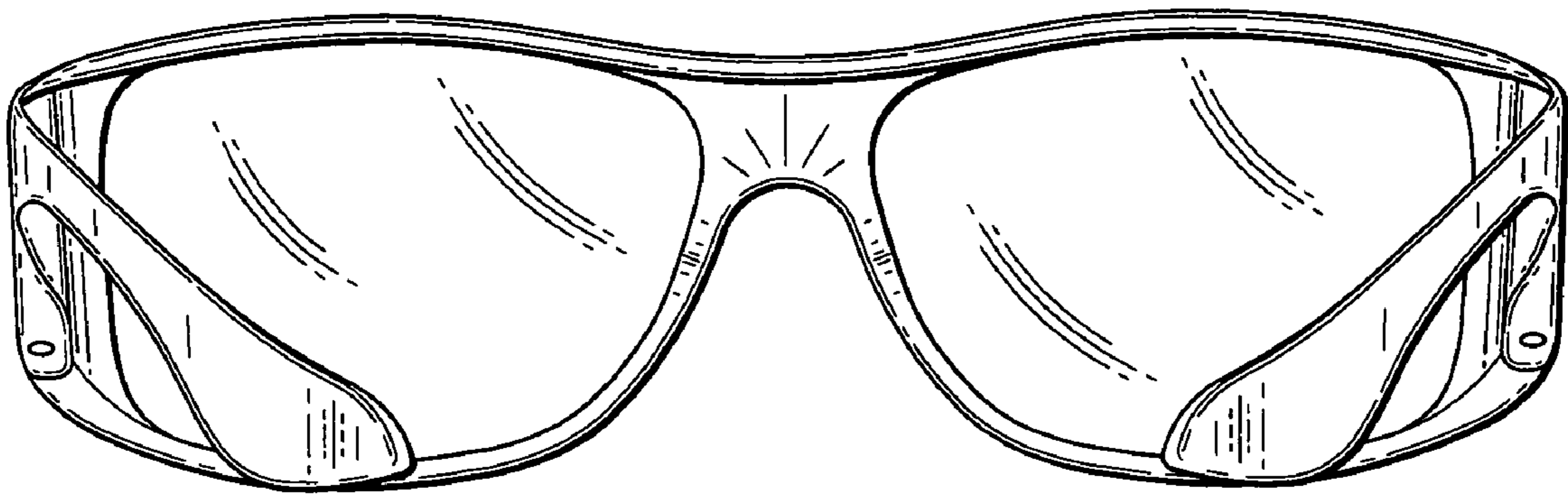

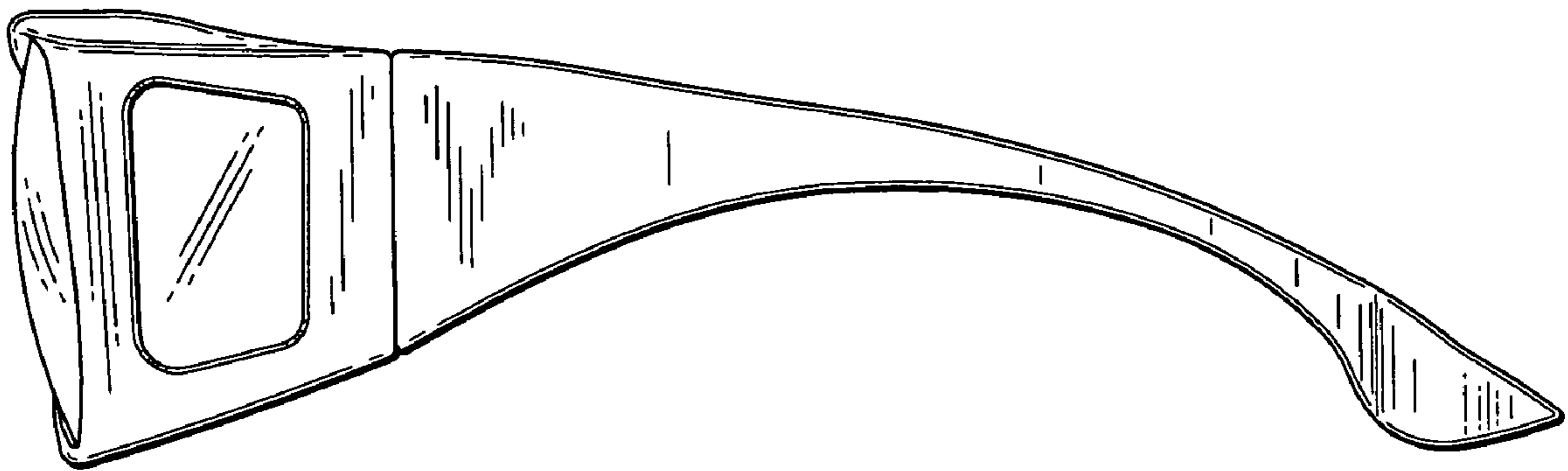

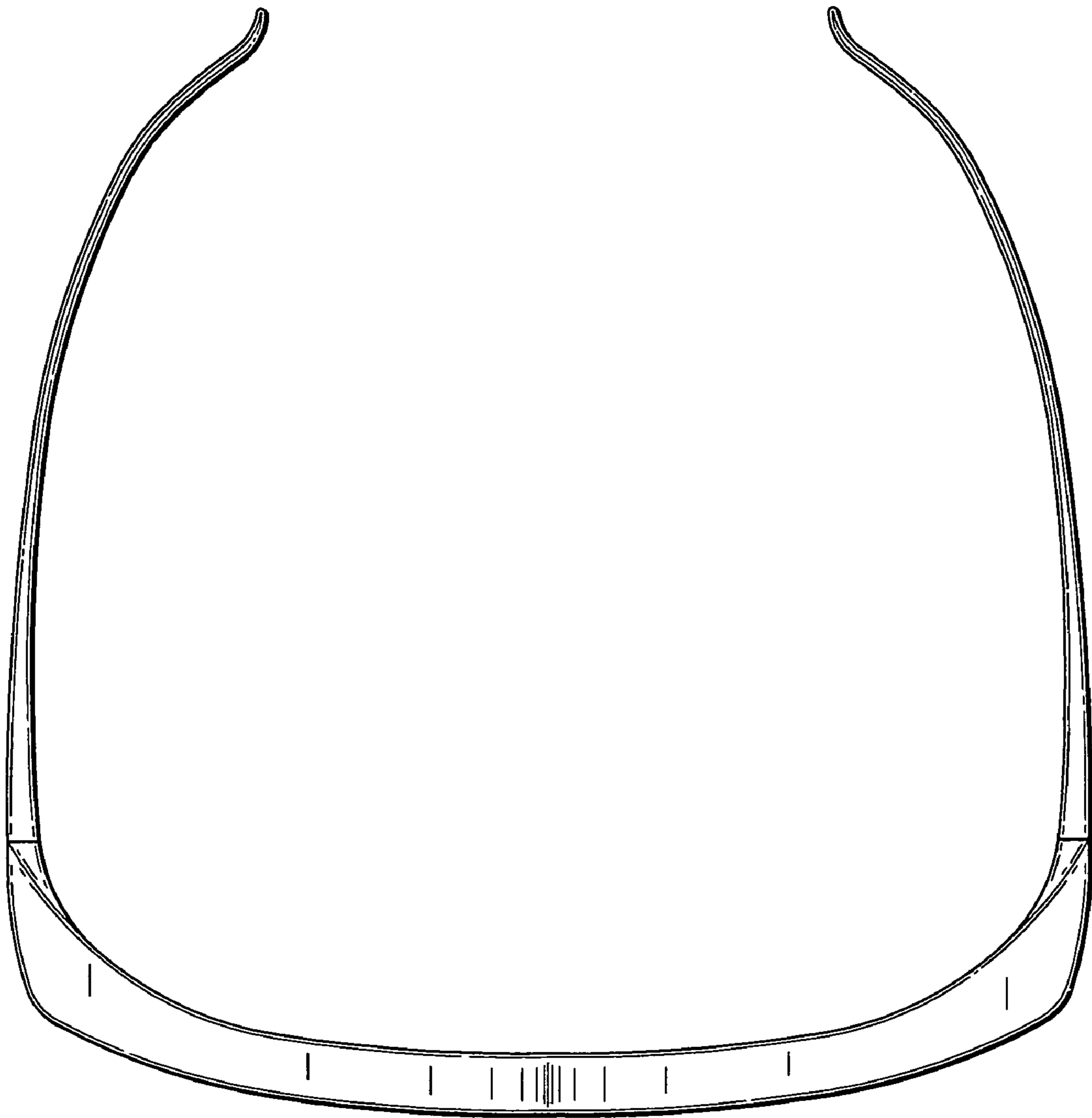
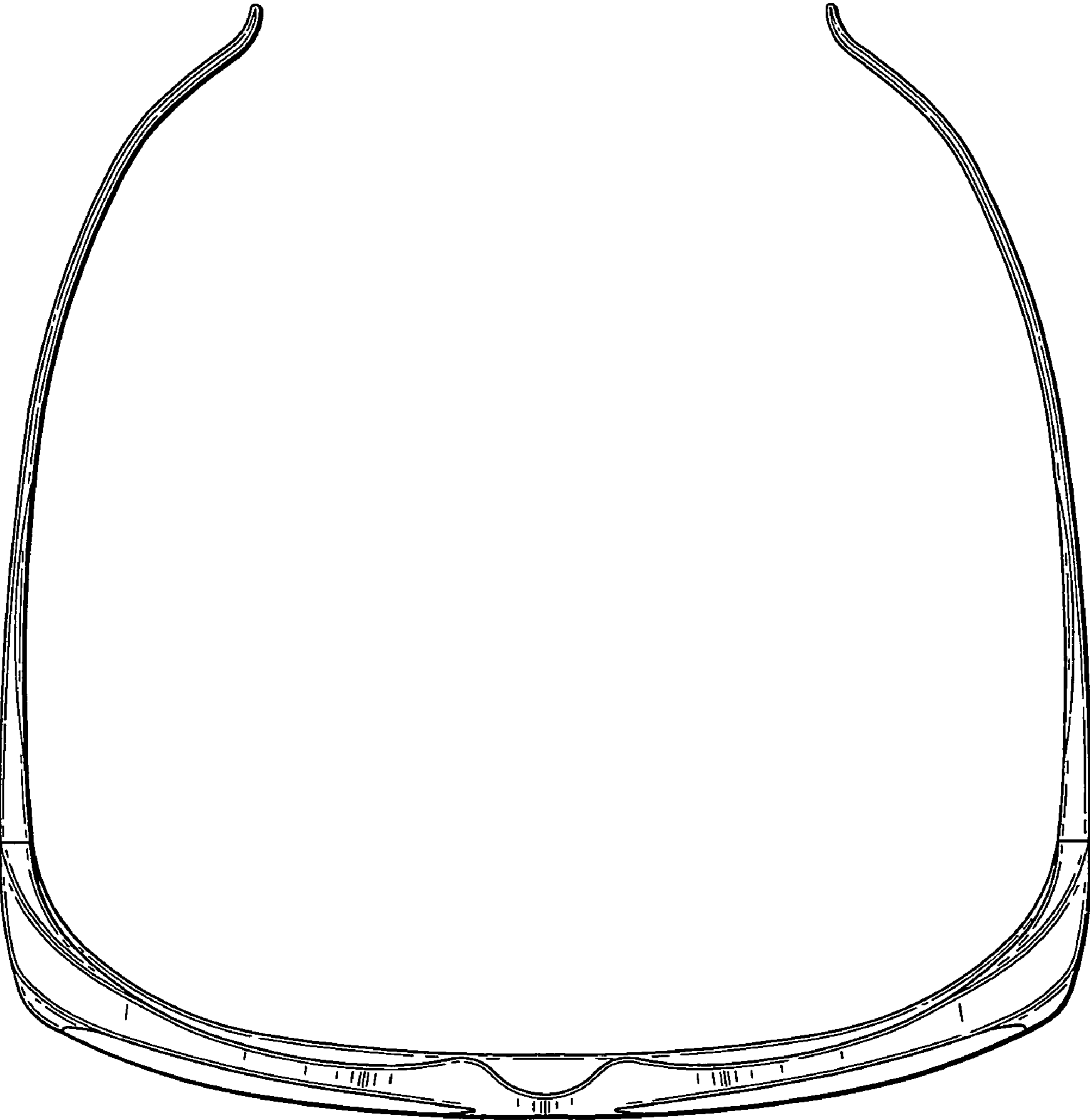
