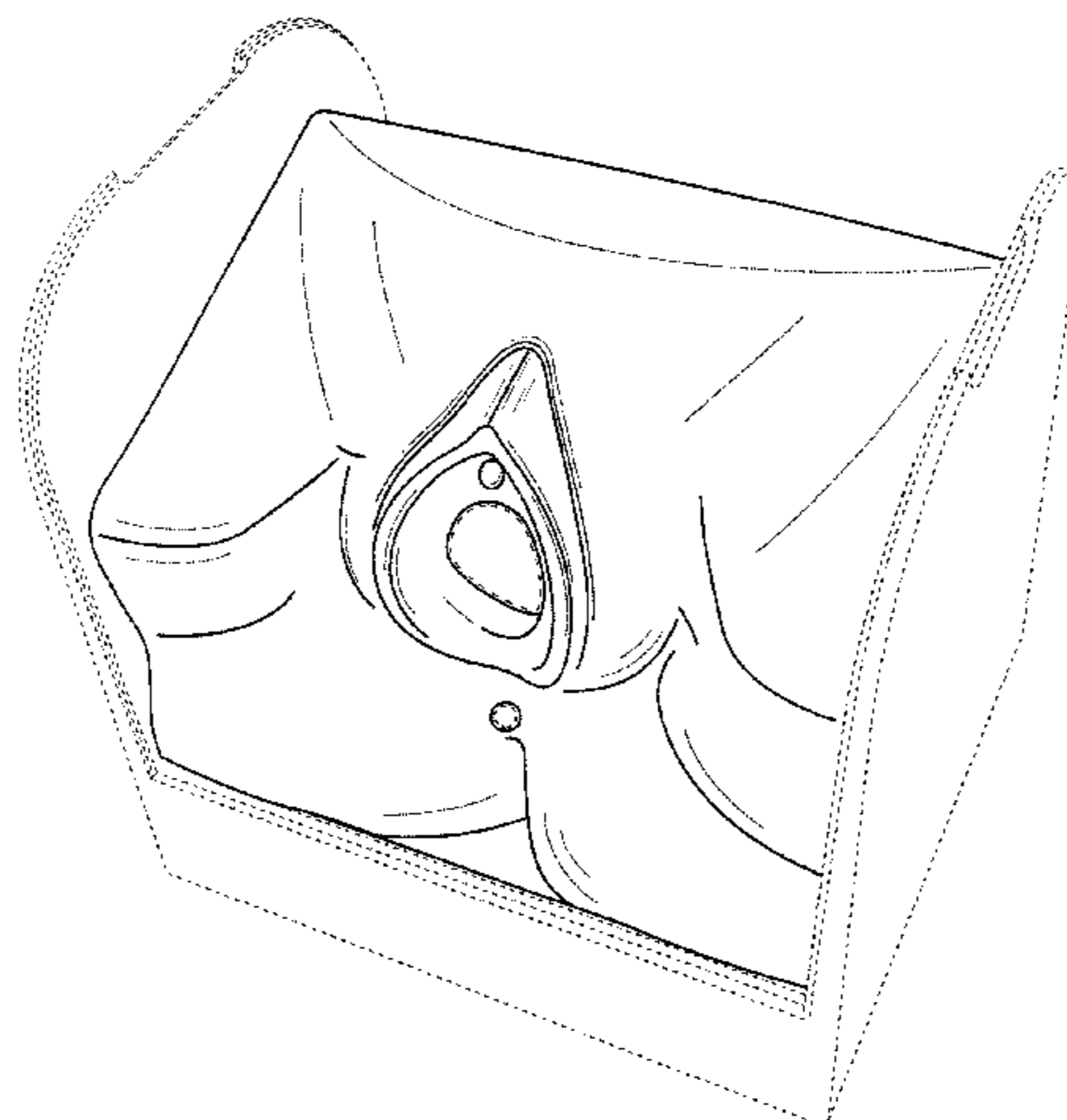
(57) **CLAIM**

I claim the ornamental design for an anatomic female pelvic model, as shown.

DESCRIPTION

FIG. 1 is a perspective view of an anatomic female pelvic model showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a first side view with the opposite side view is a mirror image of the first side view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
The broken lines are included for the purpose of illustrating portions of the anatomic female pelvic model that forms no part of the claimed design.

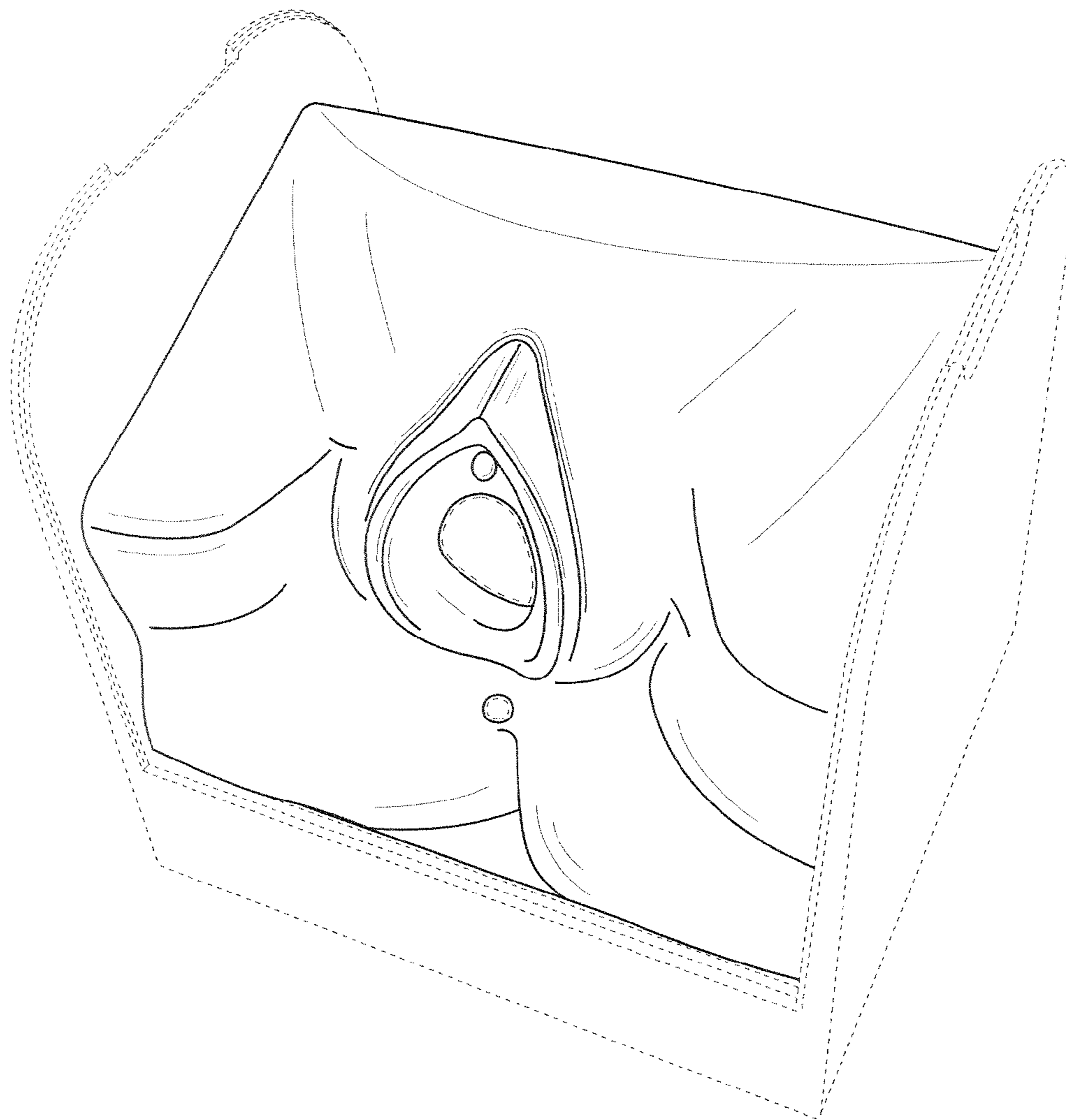

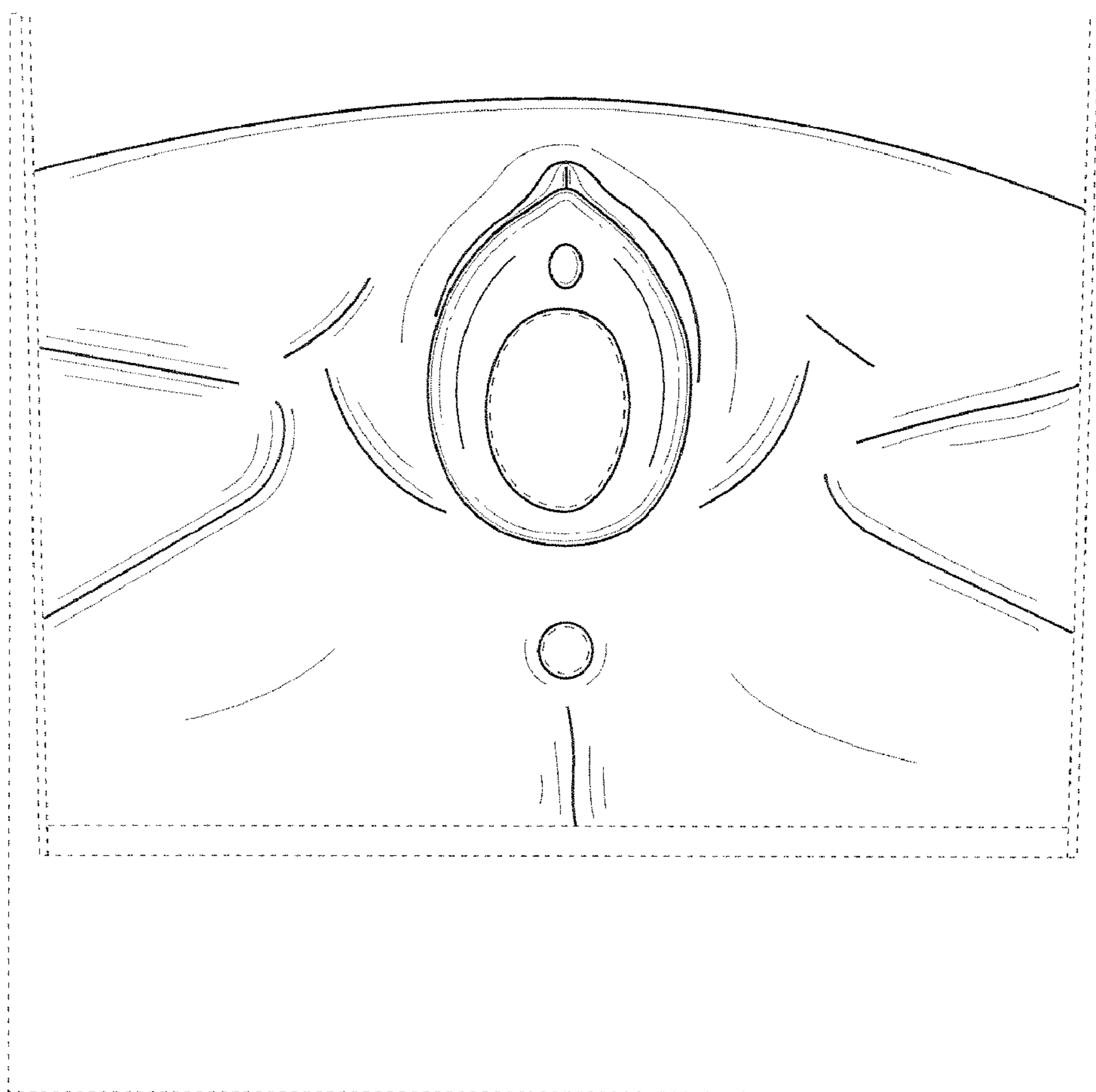

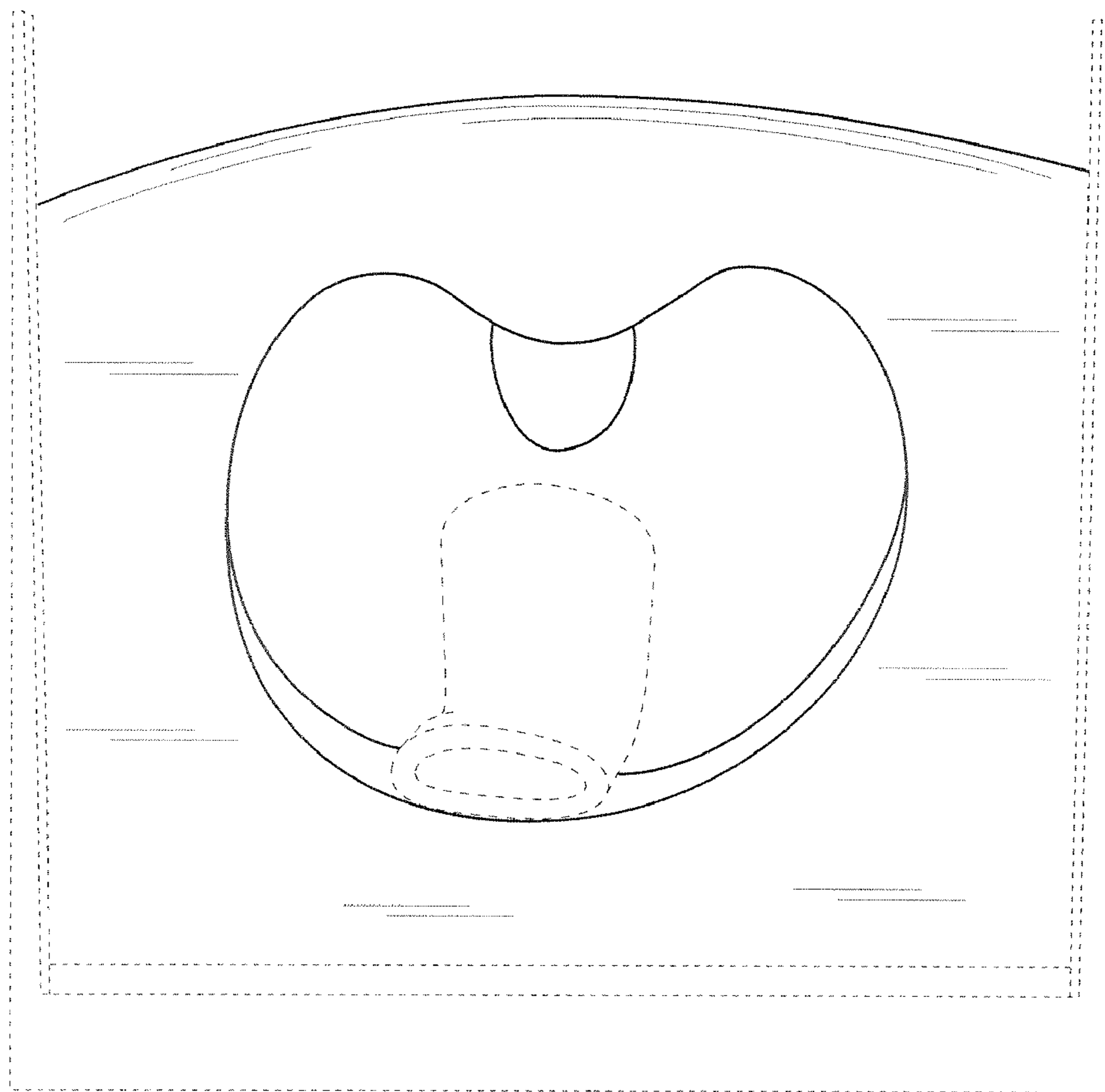

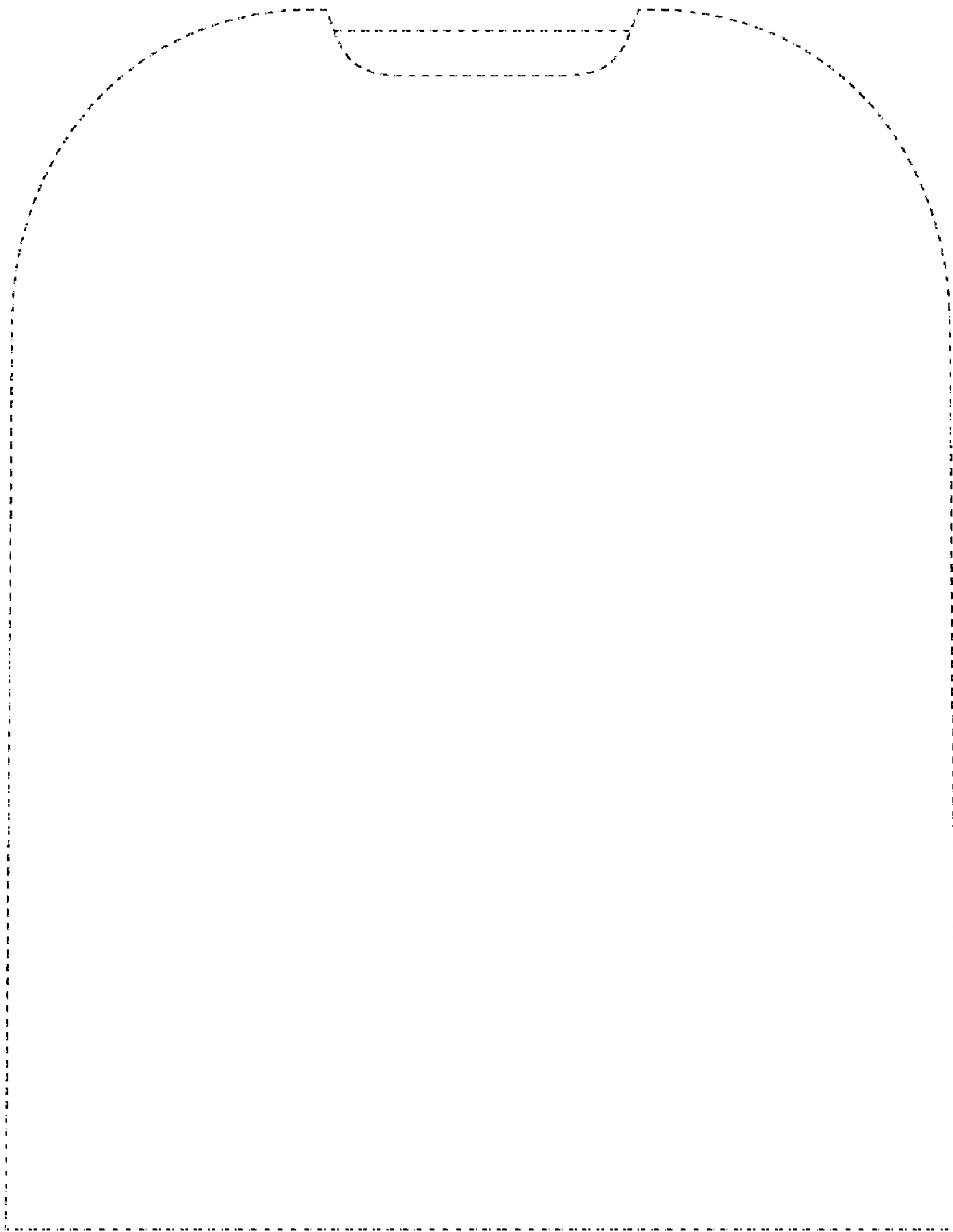

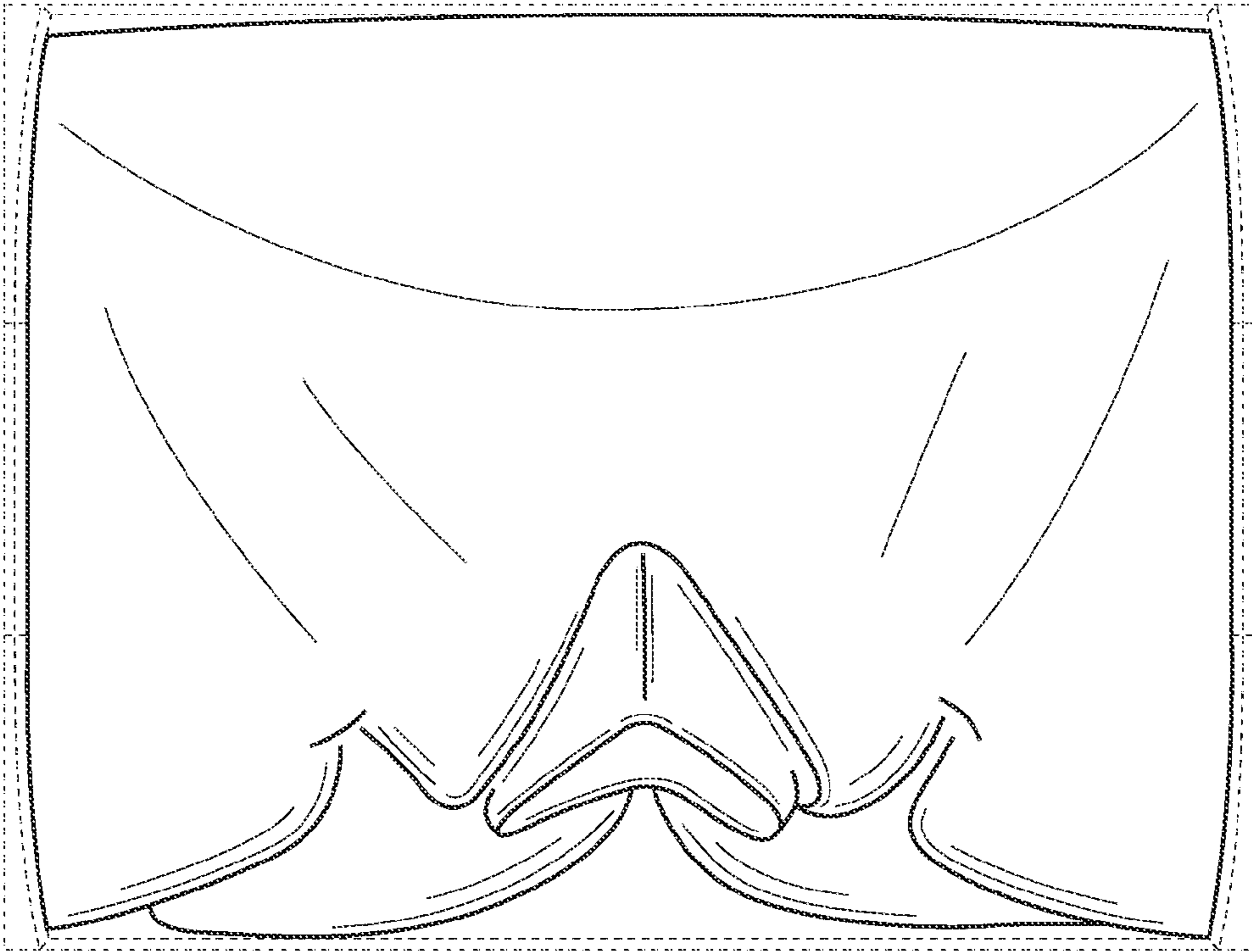
