FIG. 1 shows a perspective view of the invention;

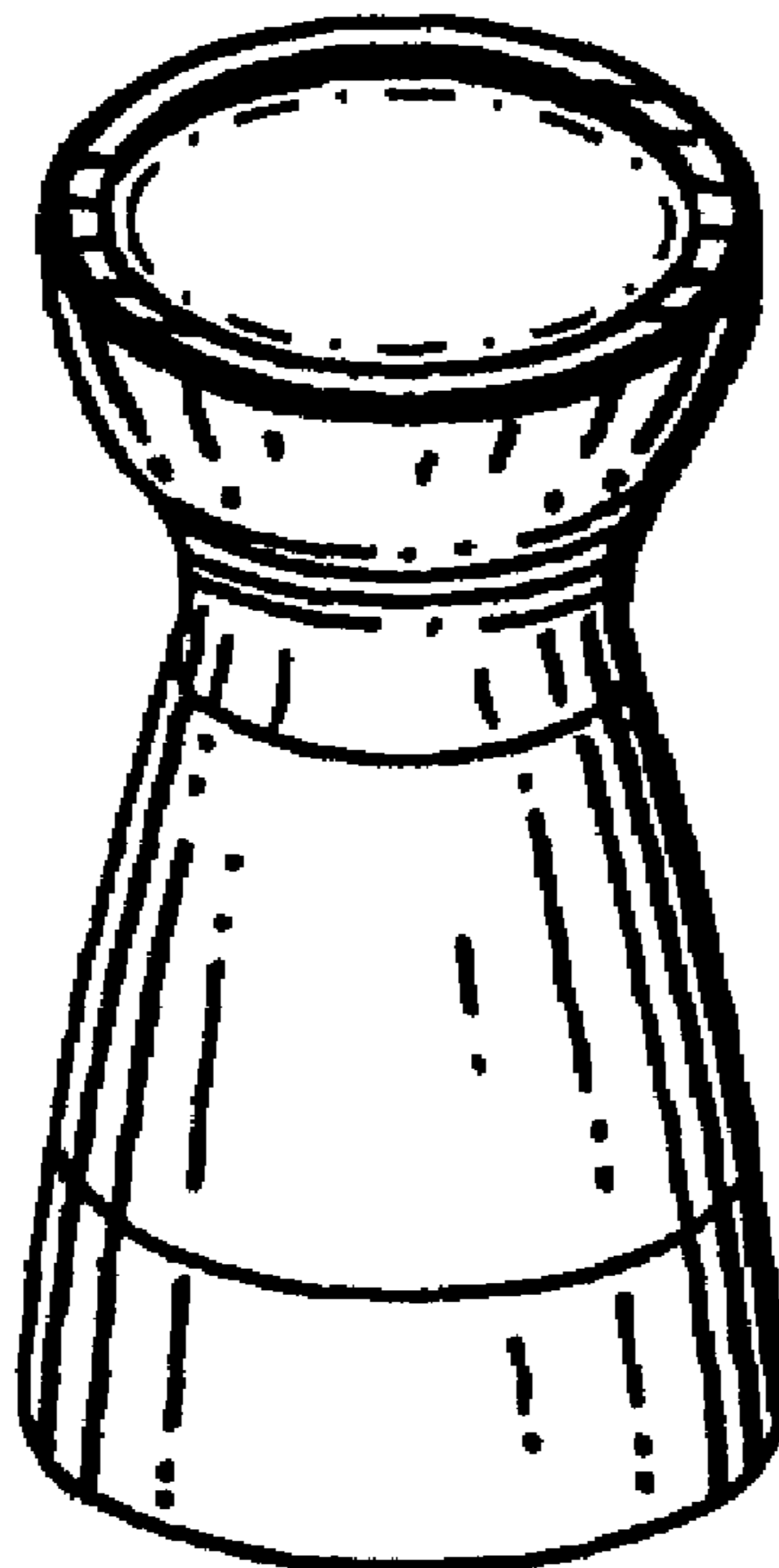
FIG. 2 shows a top view of the invention;

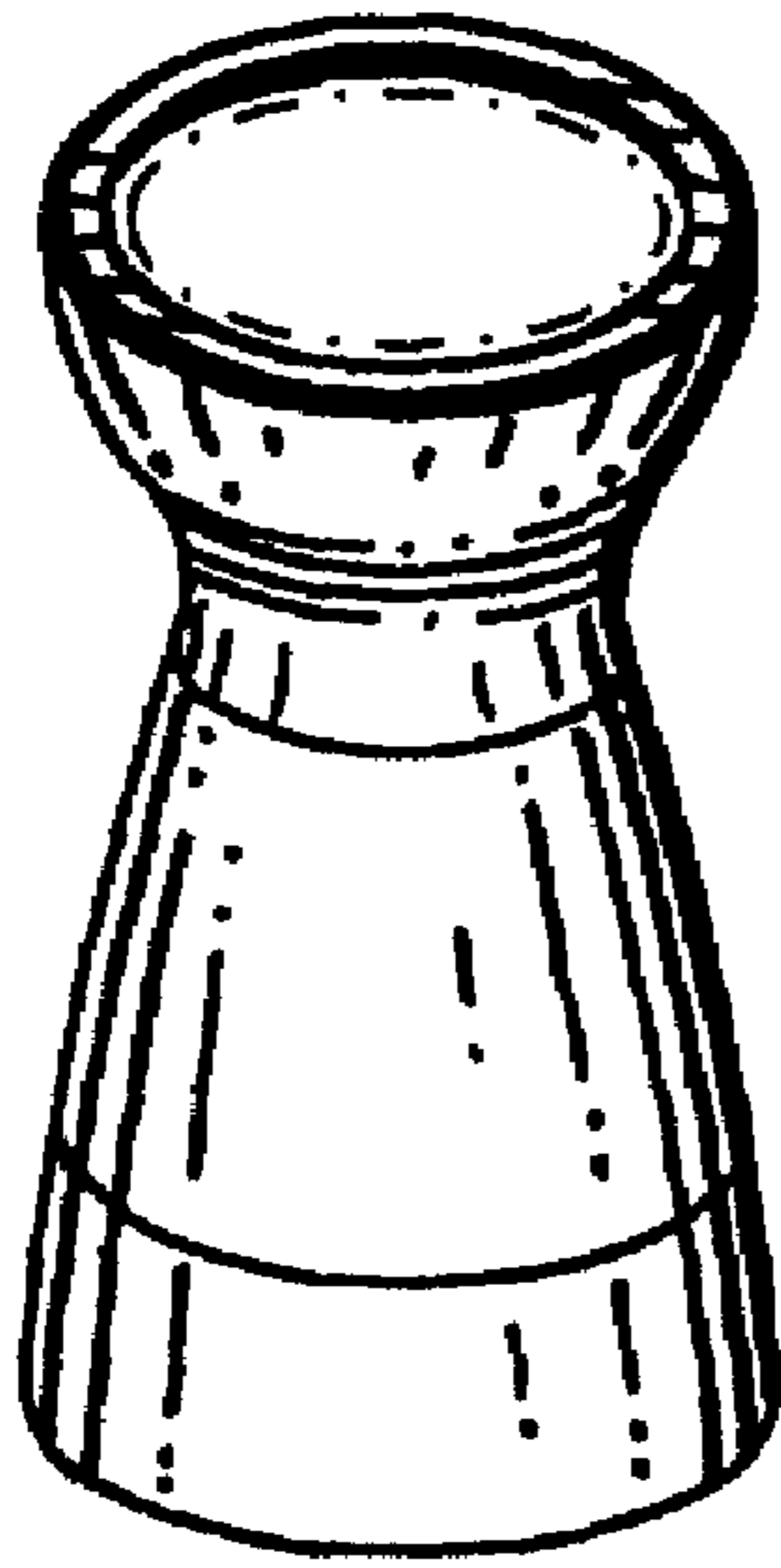

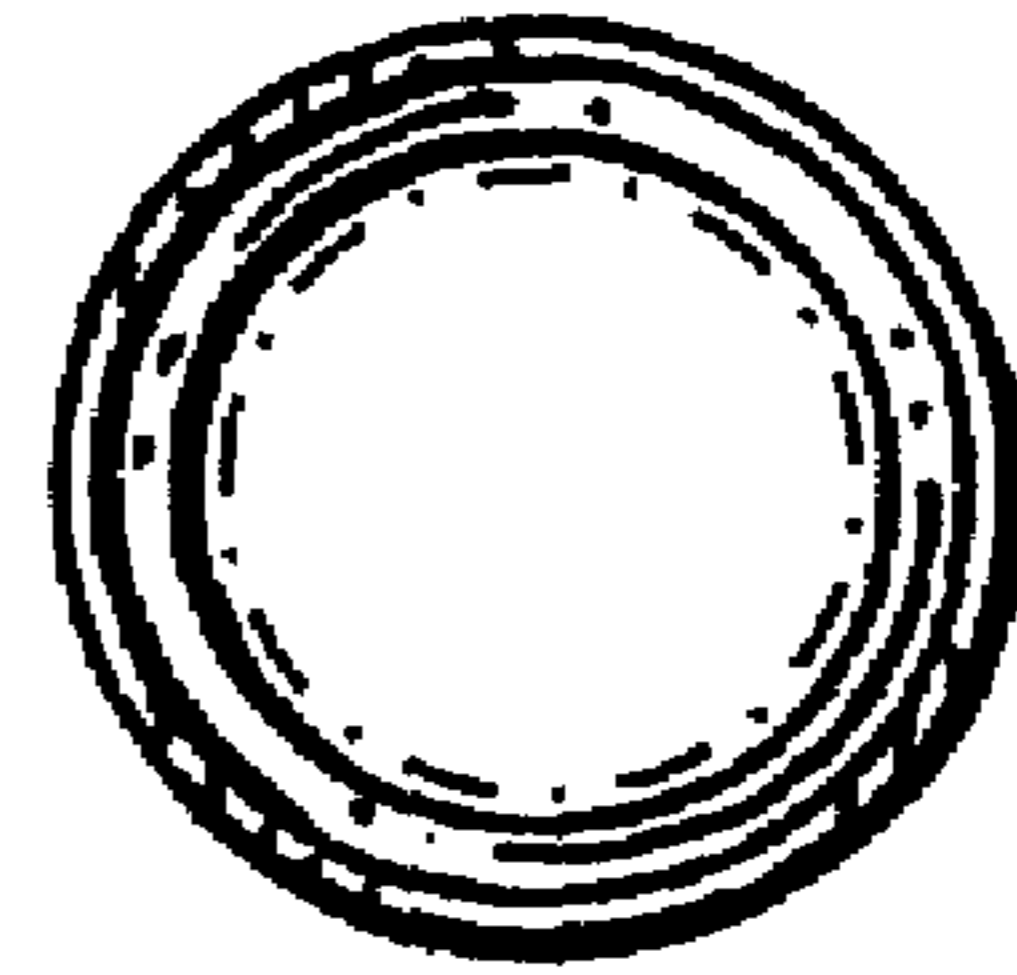

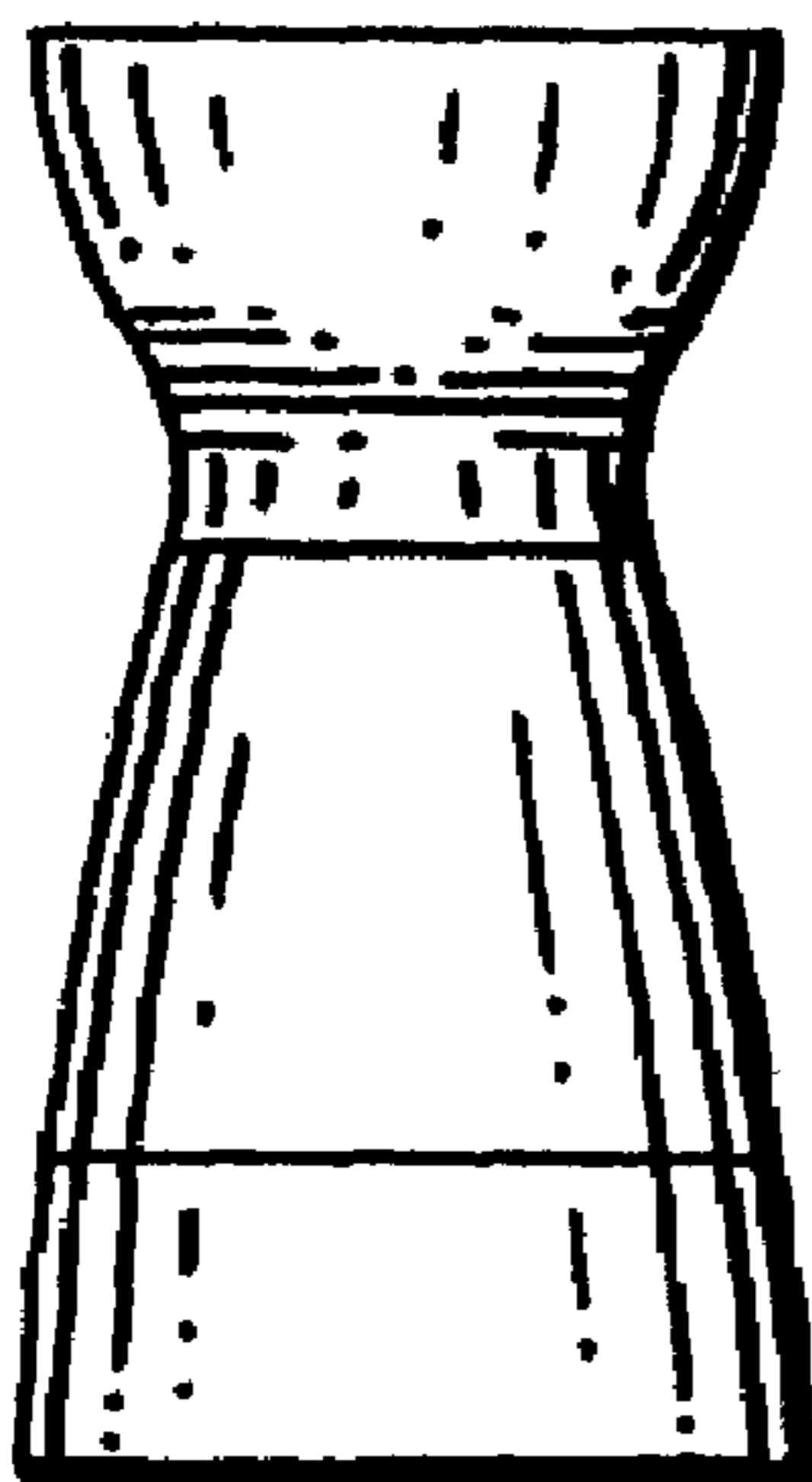

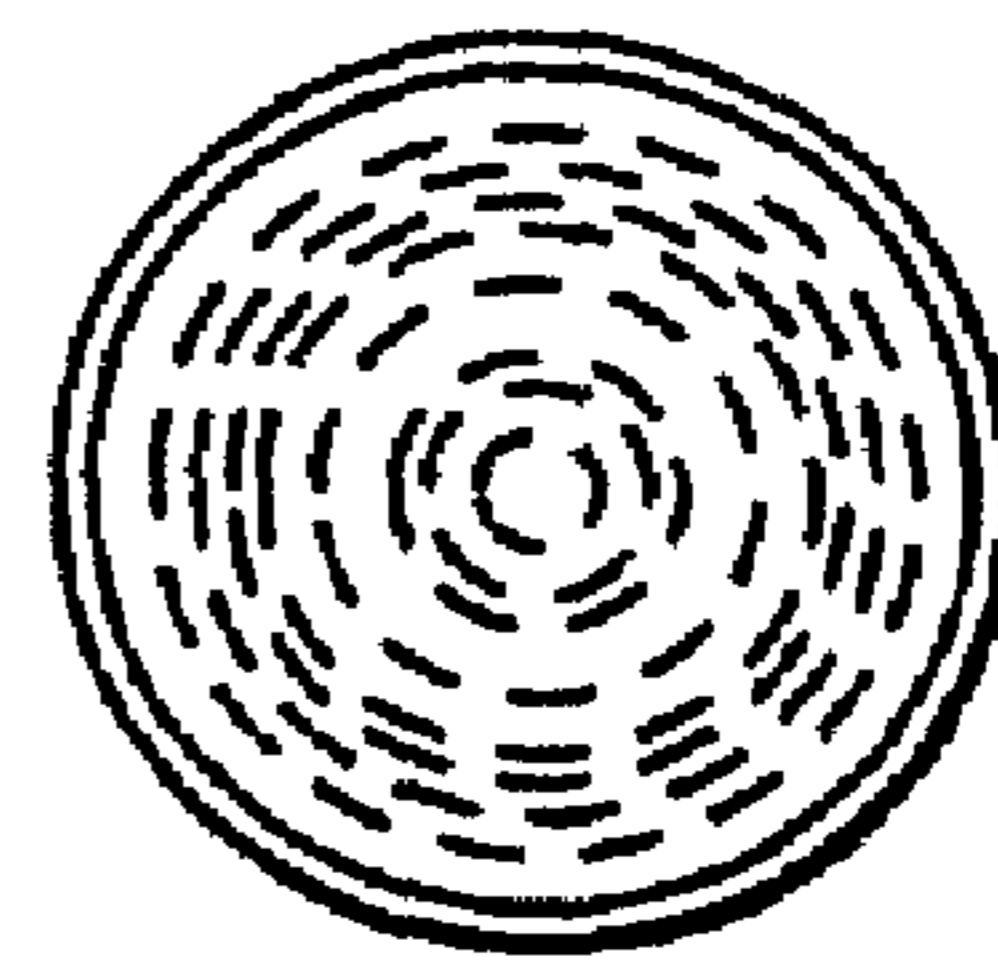
