FIG. 3 is a side view, opposite of FIG. 2,

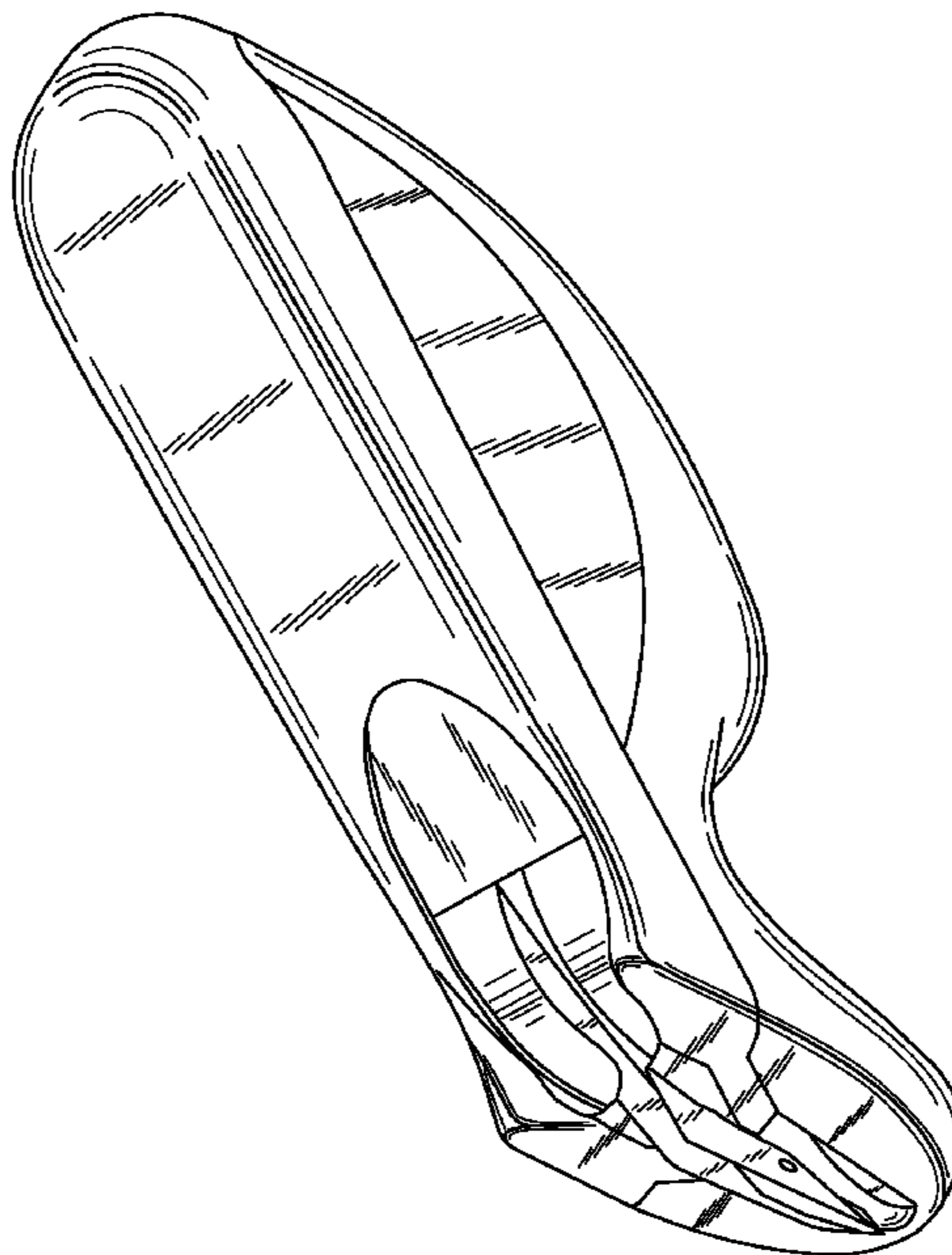
FIG. 4 is a front view,

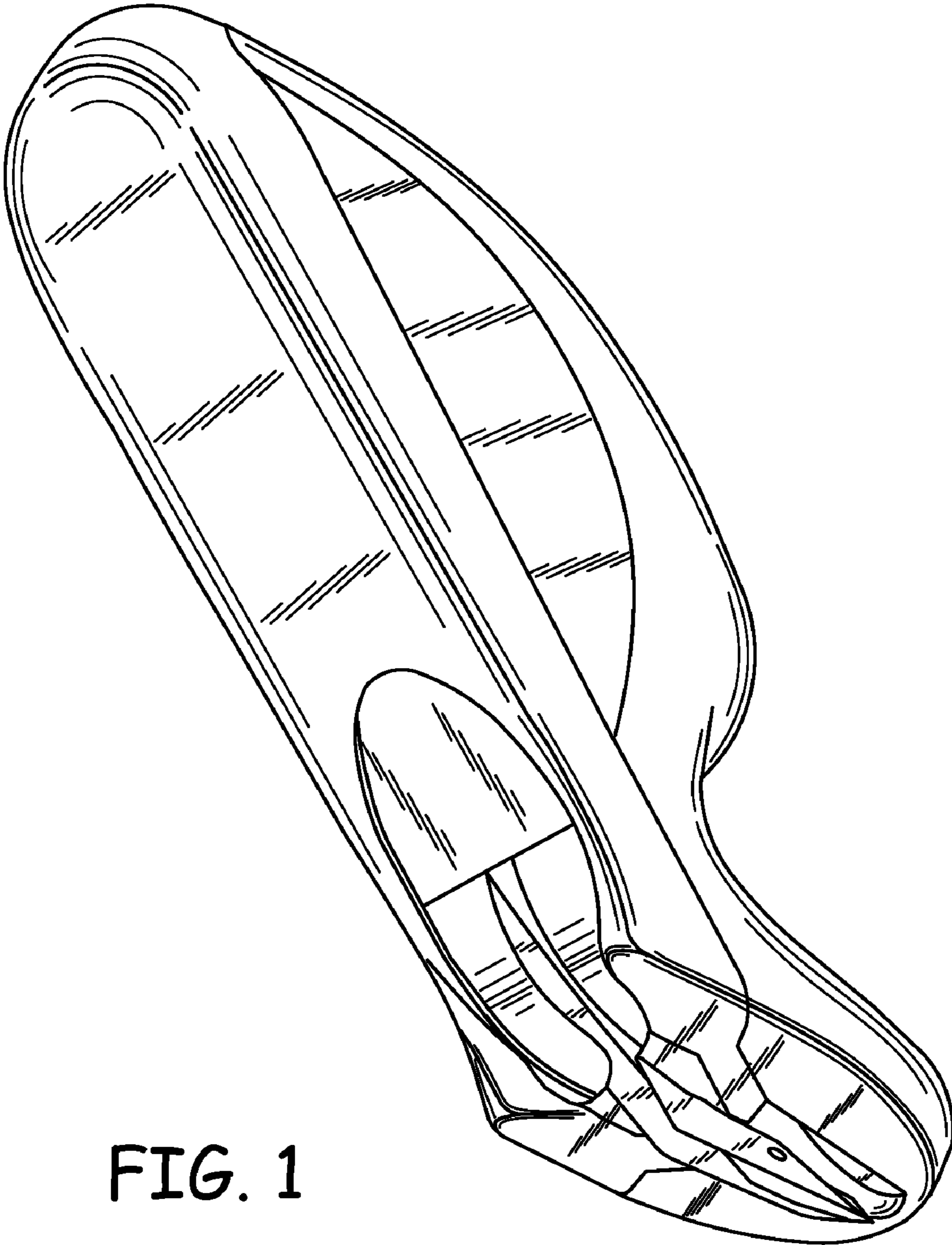

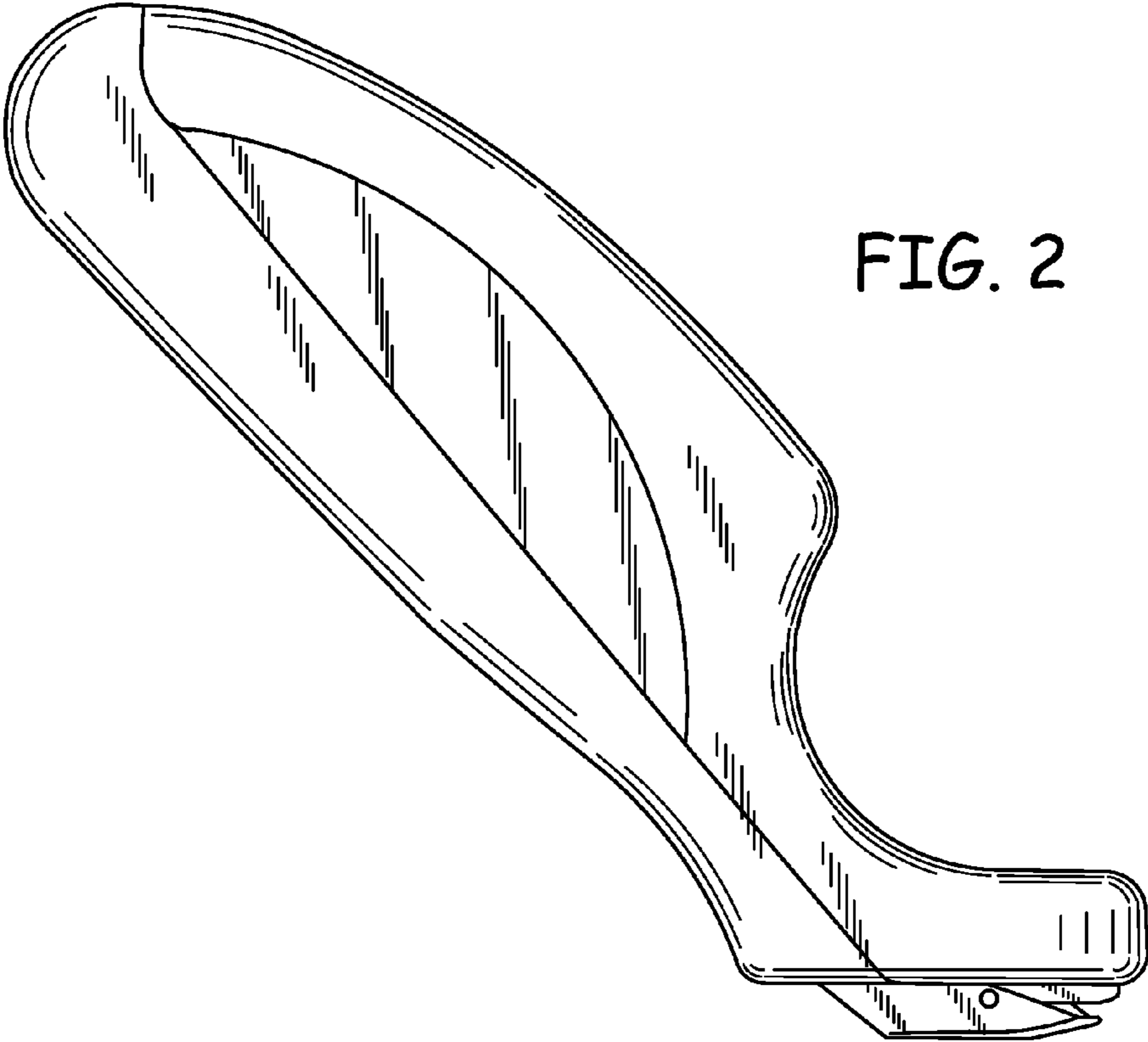

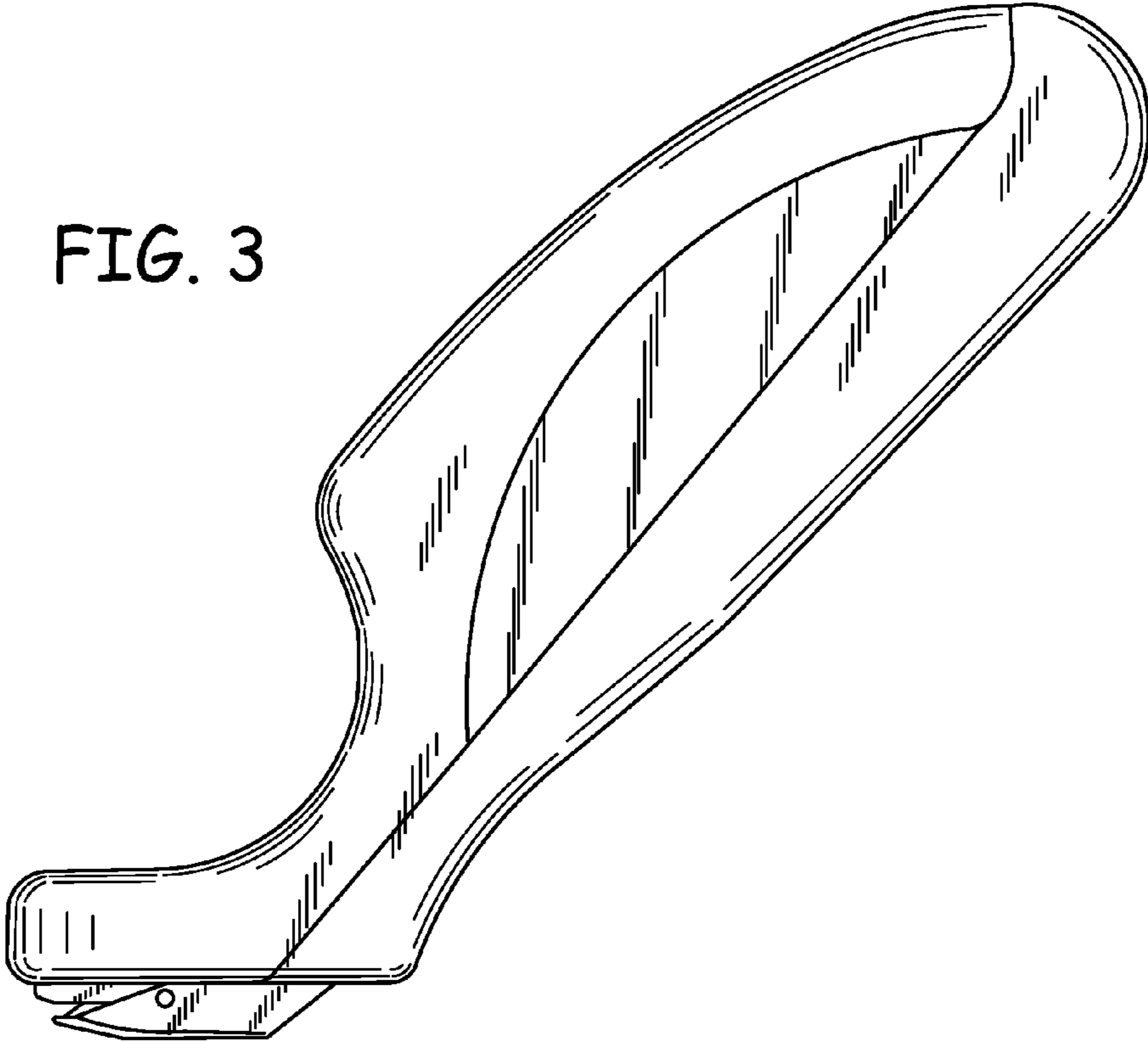

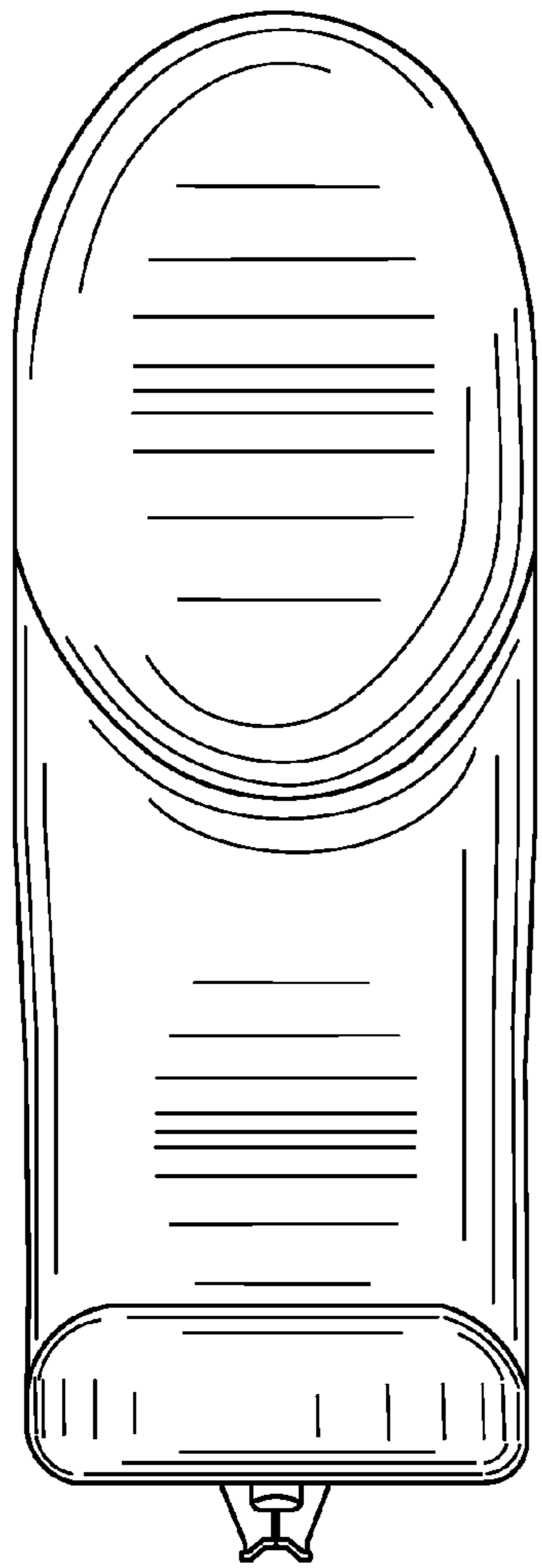

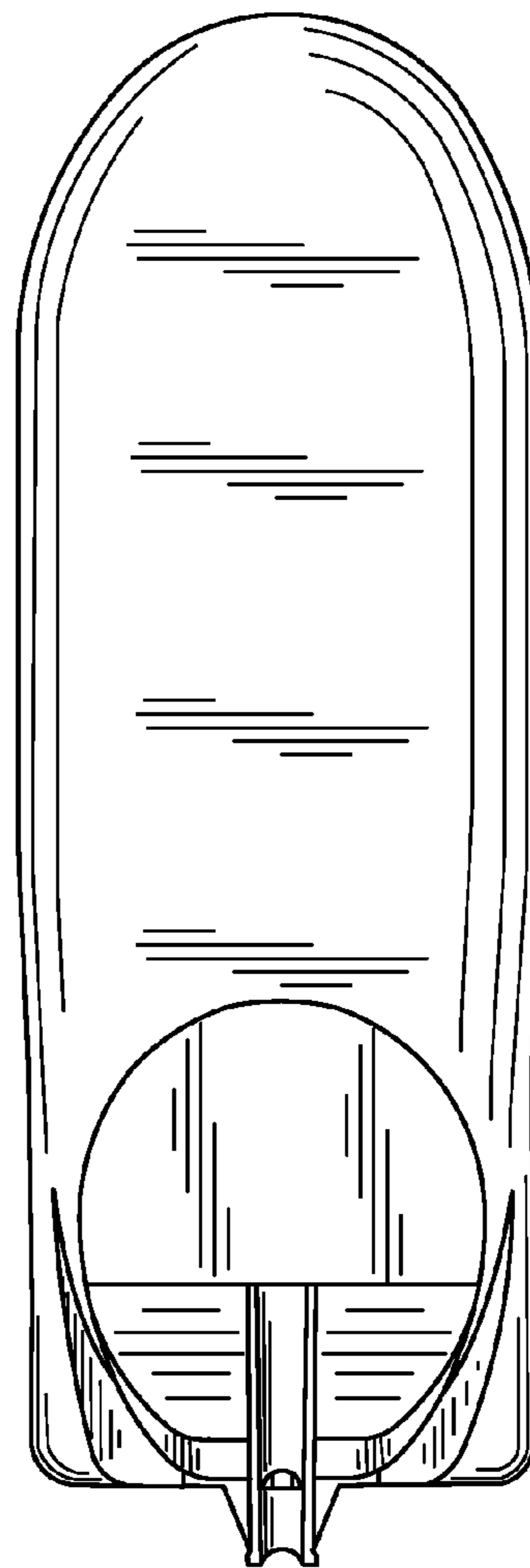

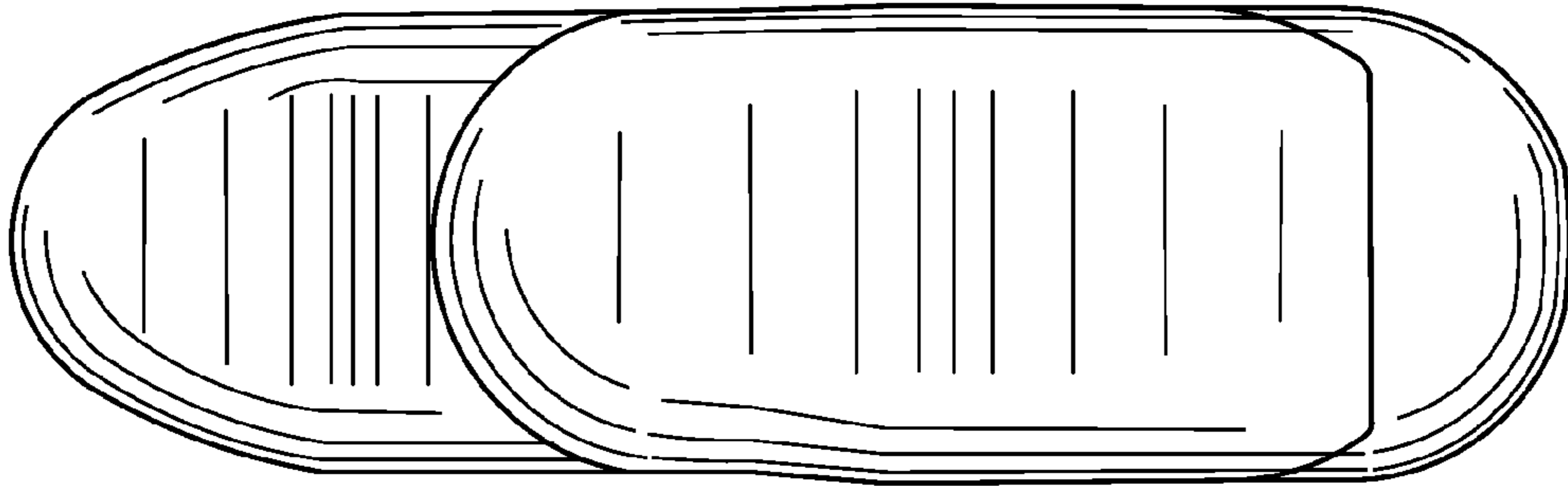

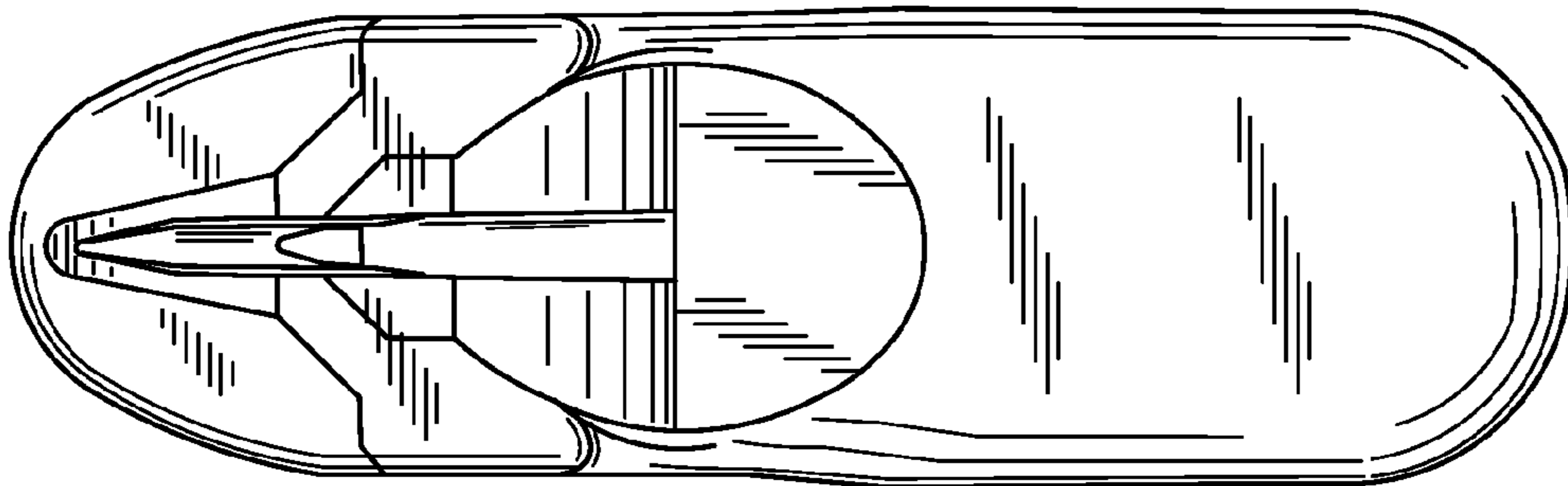
