(57) **CLAIM**

The ornamental design for a vial, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of a vial showing our new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a left side elevation view thereof; the right side elevation view being a mirror image thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front left top perspective view thereof;

FIG. 7 is a front left bottom perspective view thereof;

FIG. 8 is a front elevation view of a second embodiment of a vial showing our new design;

FIG. 9 is a rear elevation view thereof;

FIG. 10 is a left side elevation view thereof; the right side elevation view being a mirror image thereof;

FIG. 11 is a top plan view thereof;

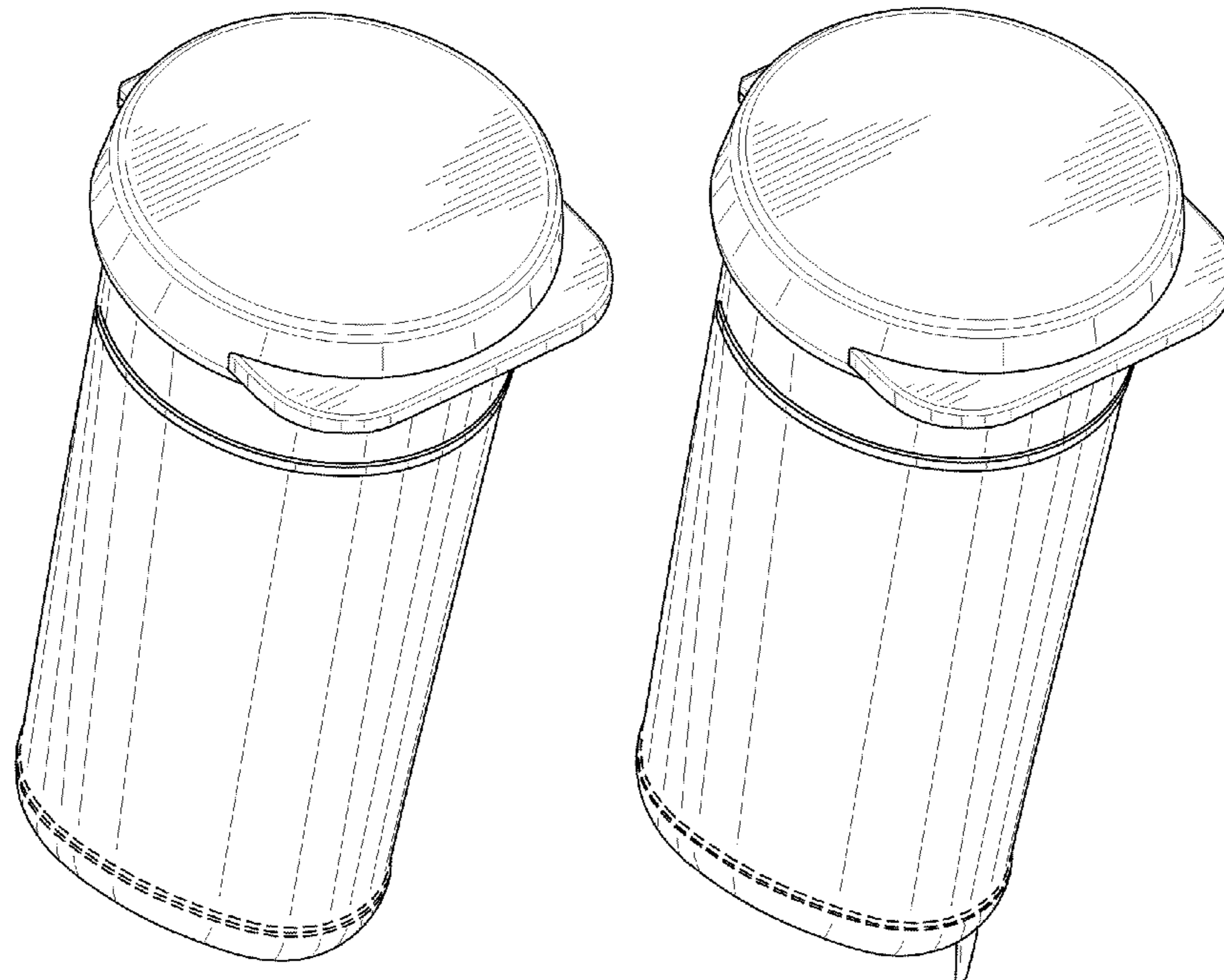
FIG. 12 is a bottom plan view thereof;

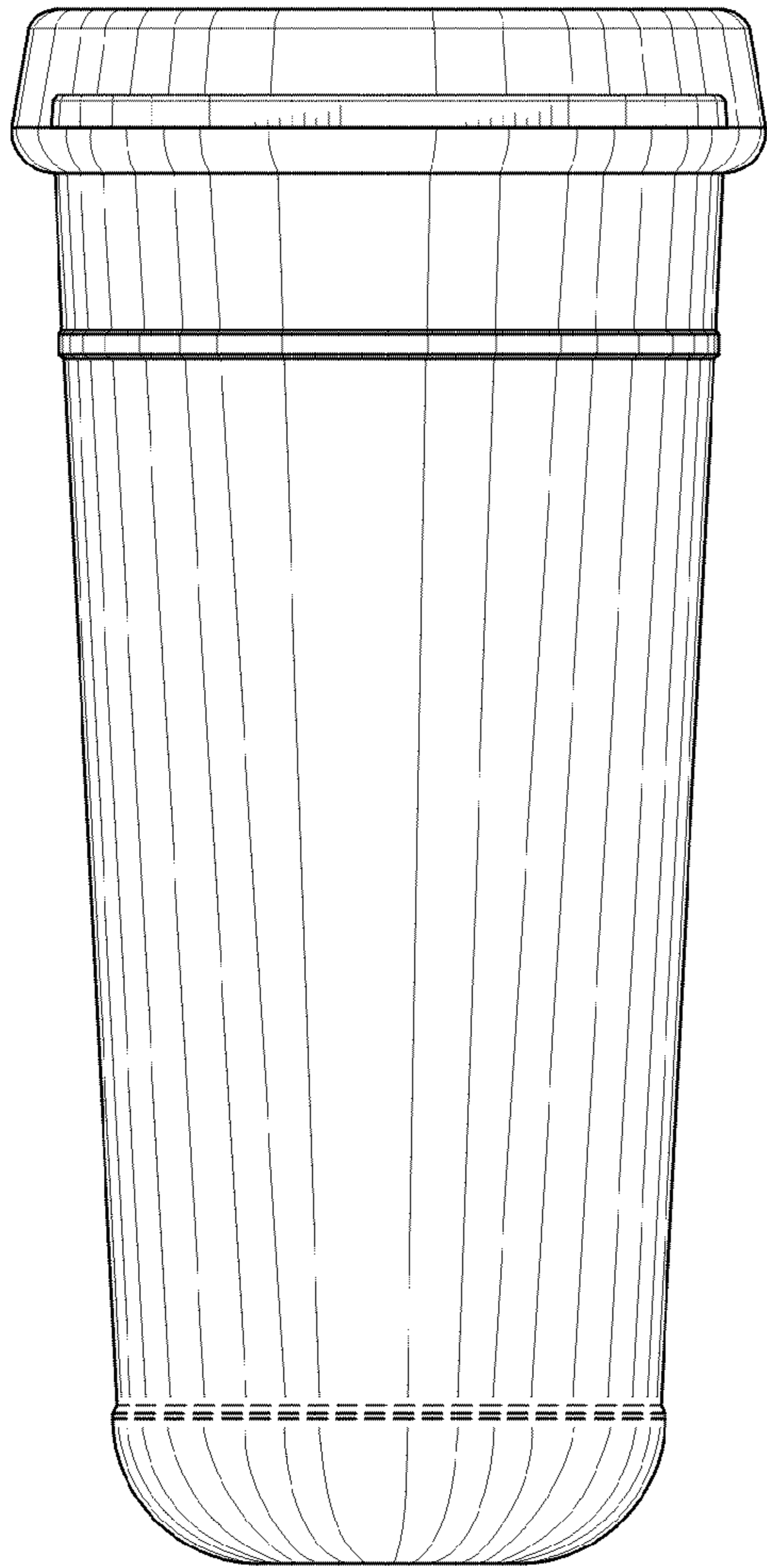

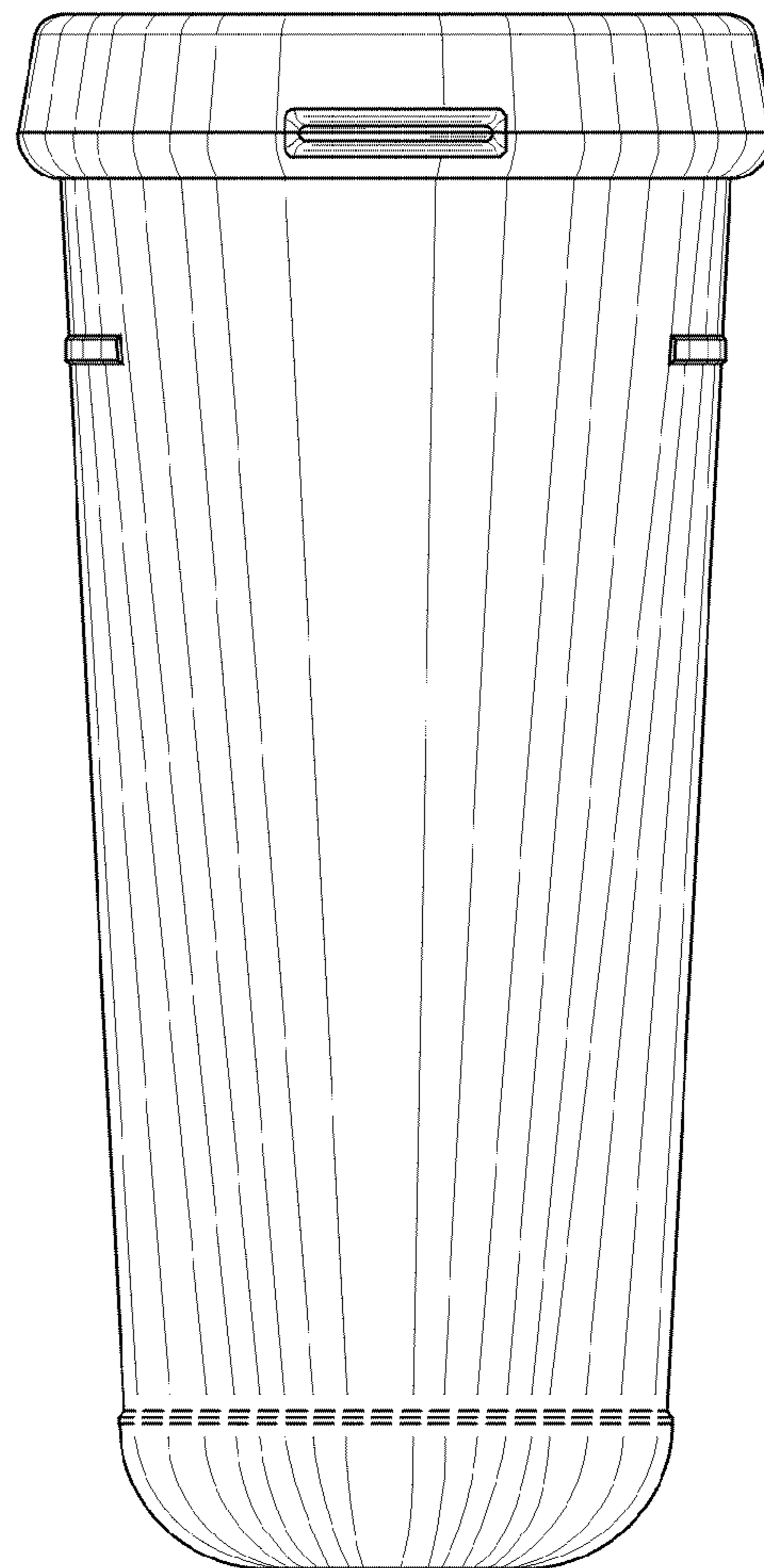

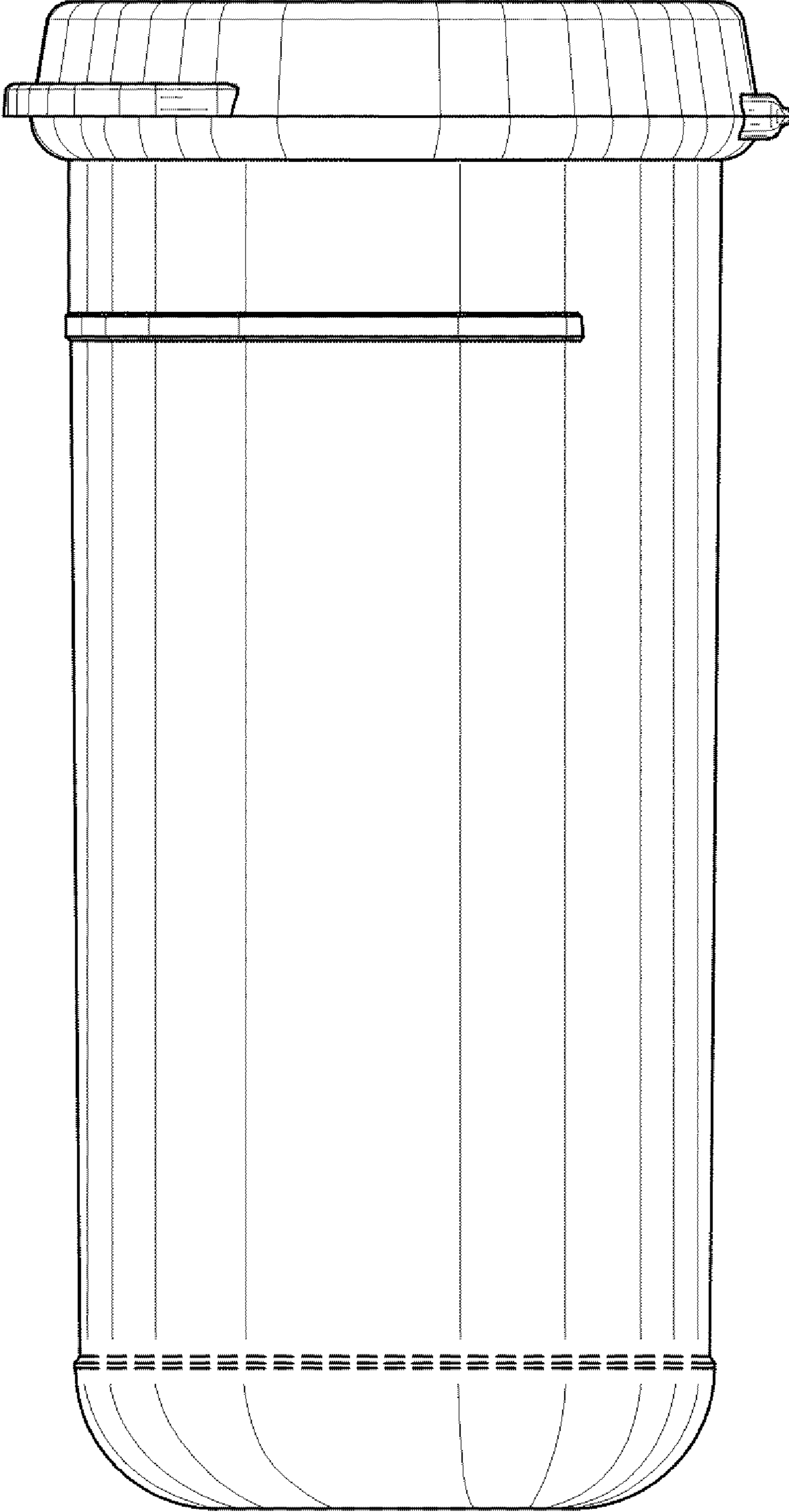

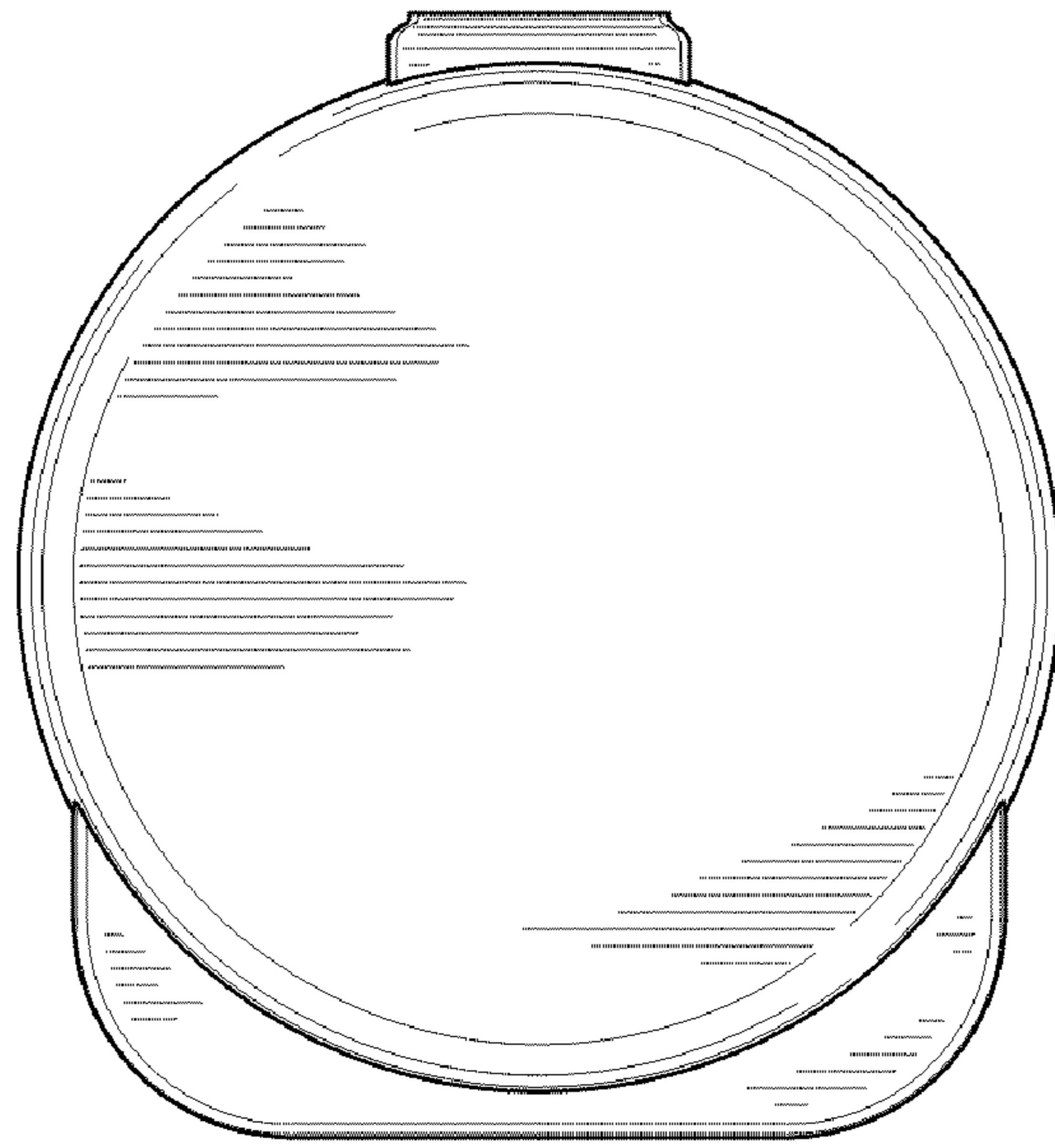

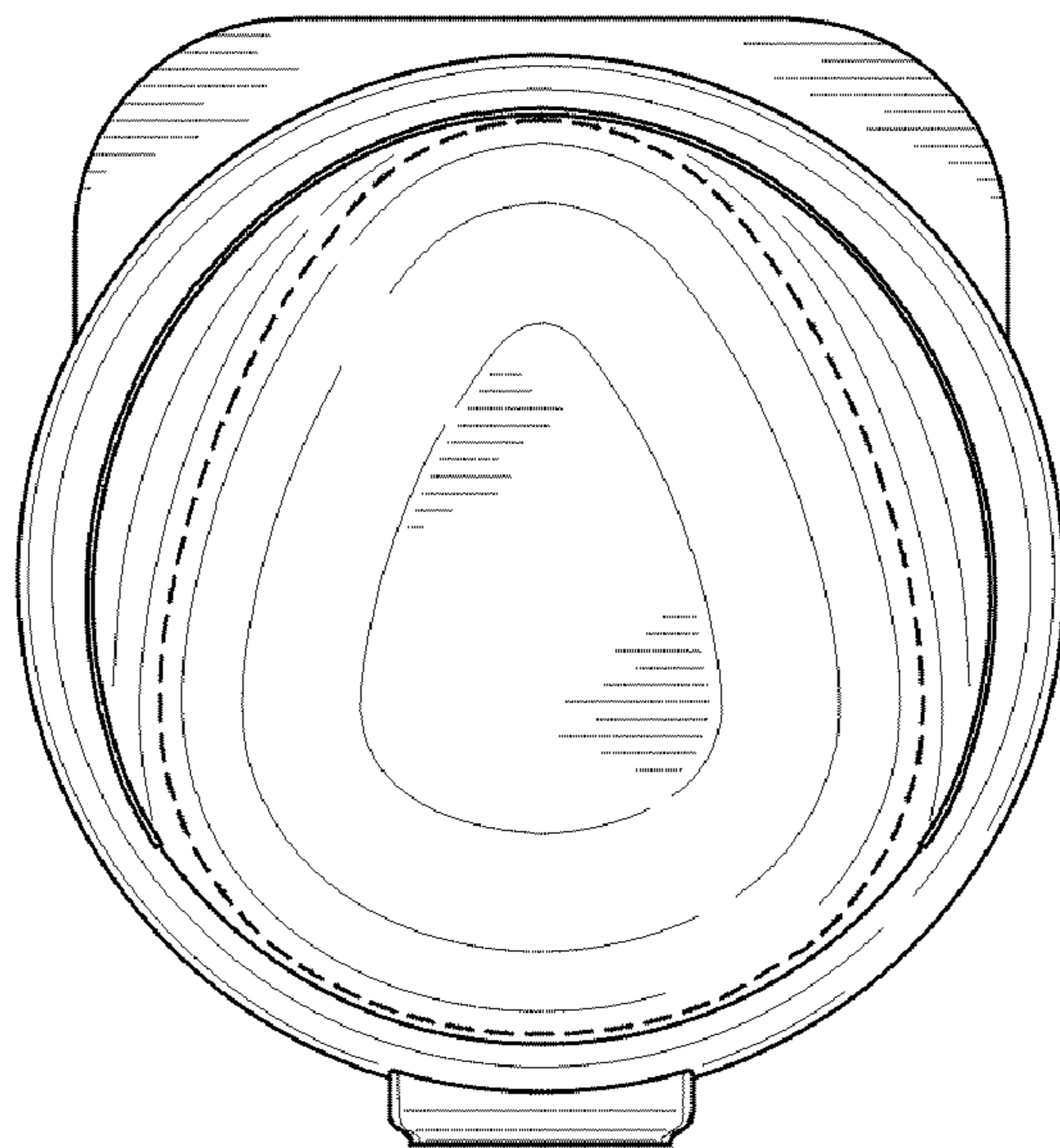

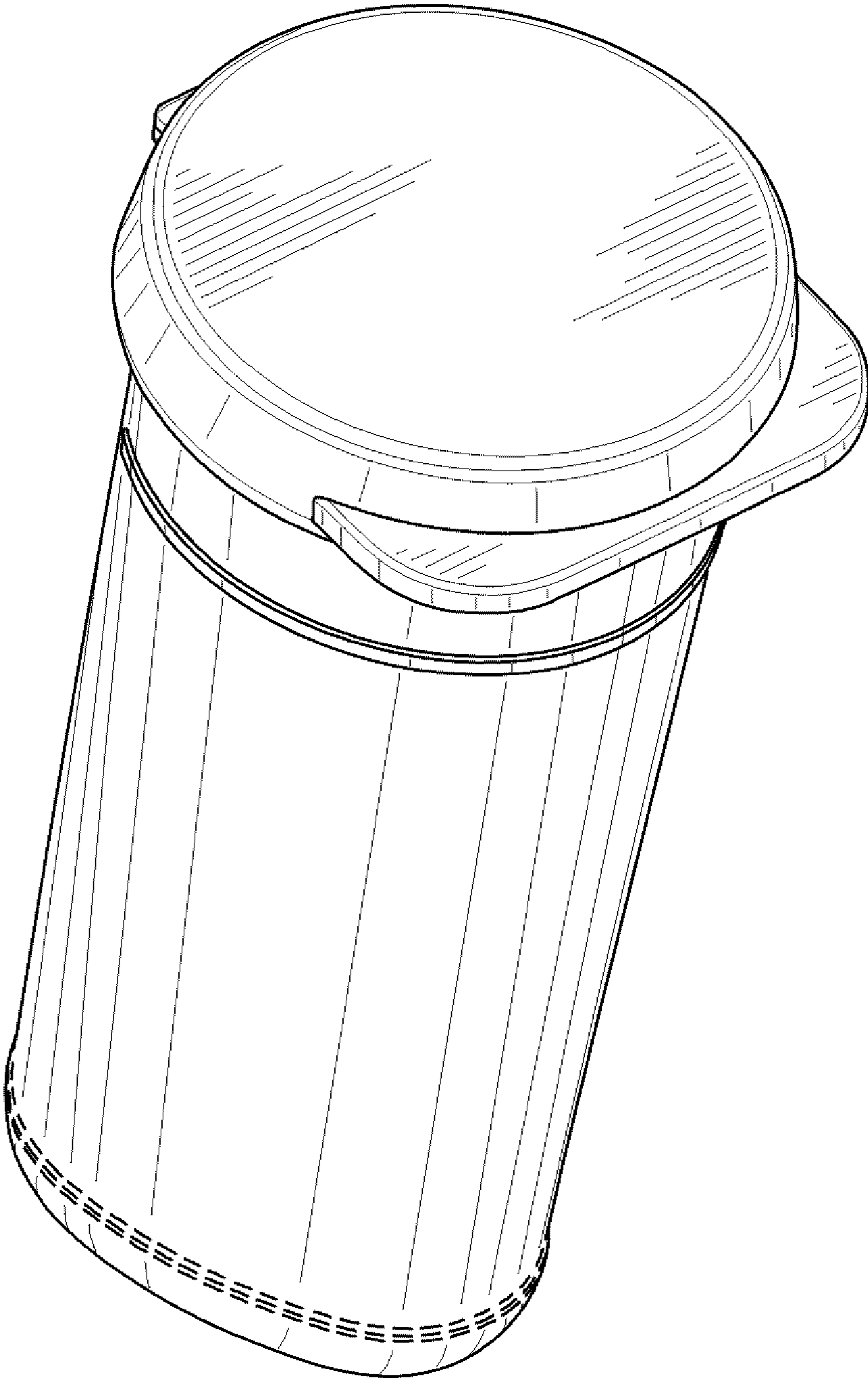

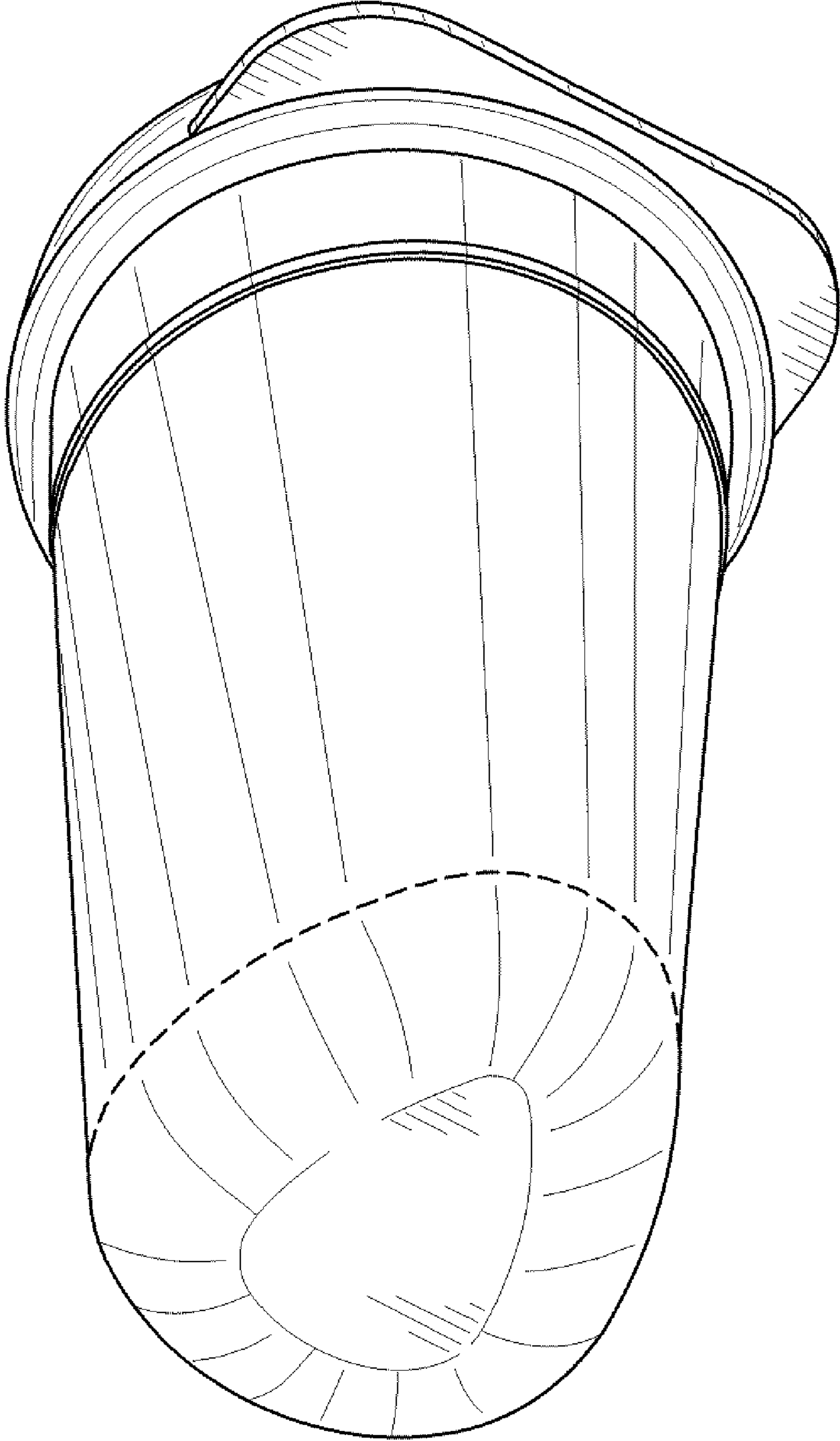

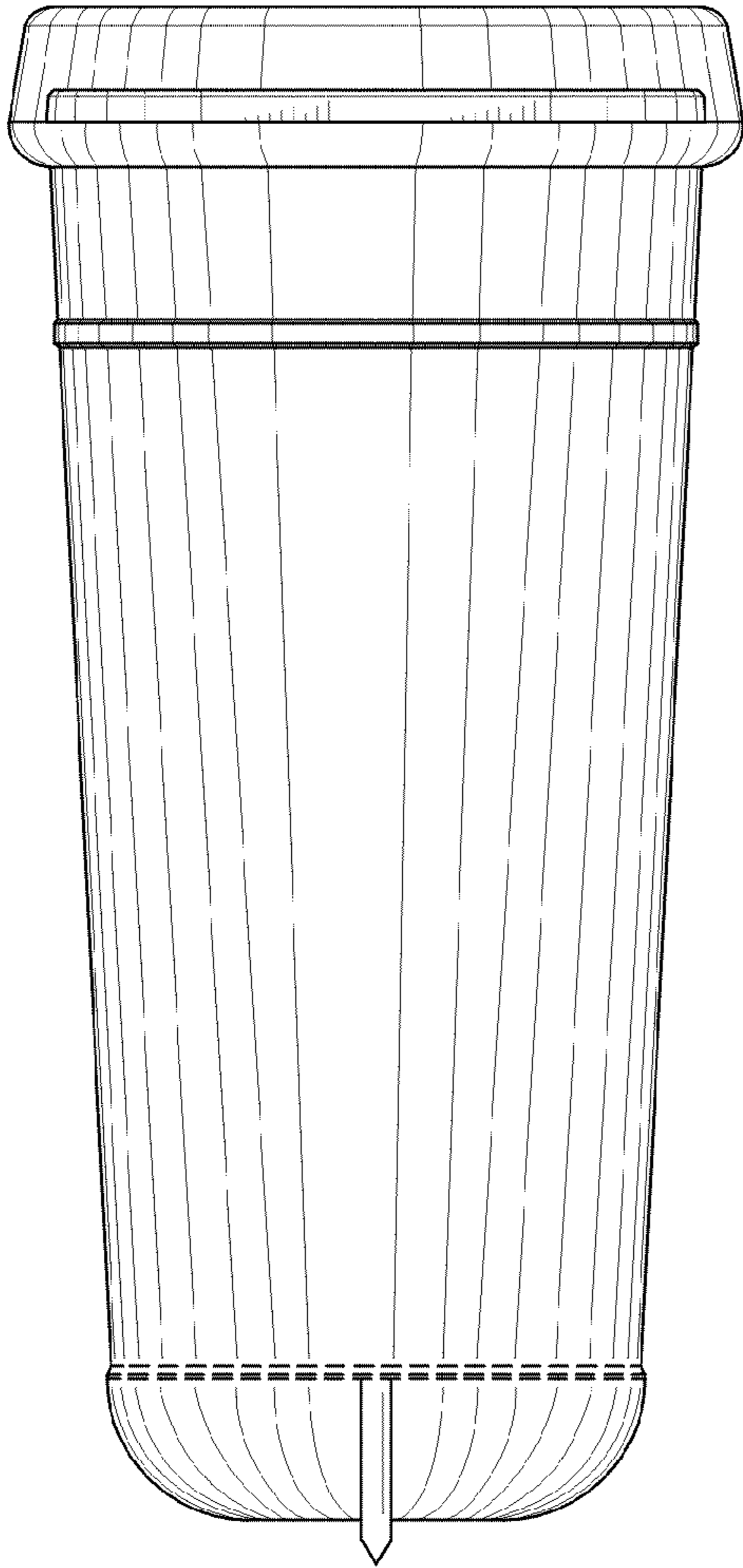

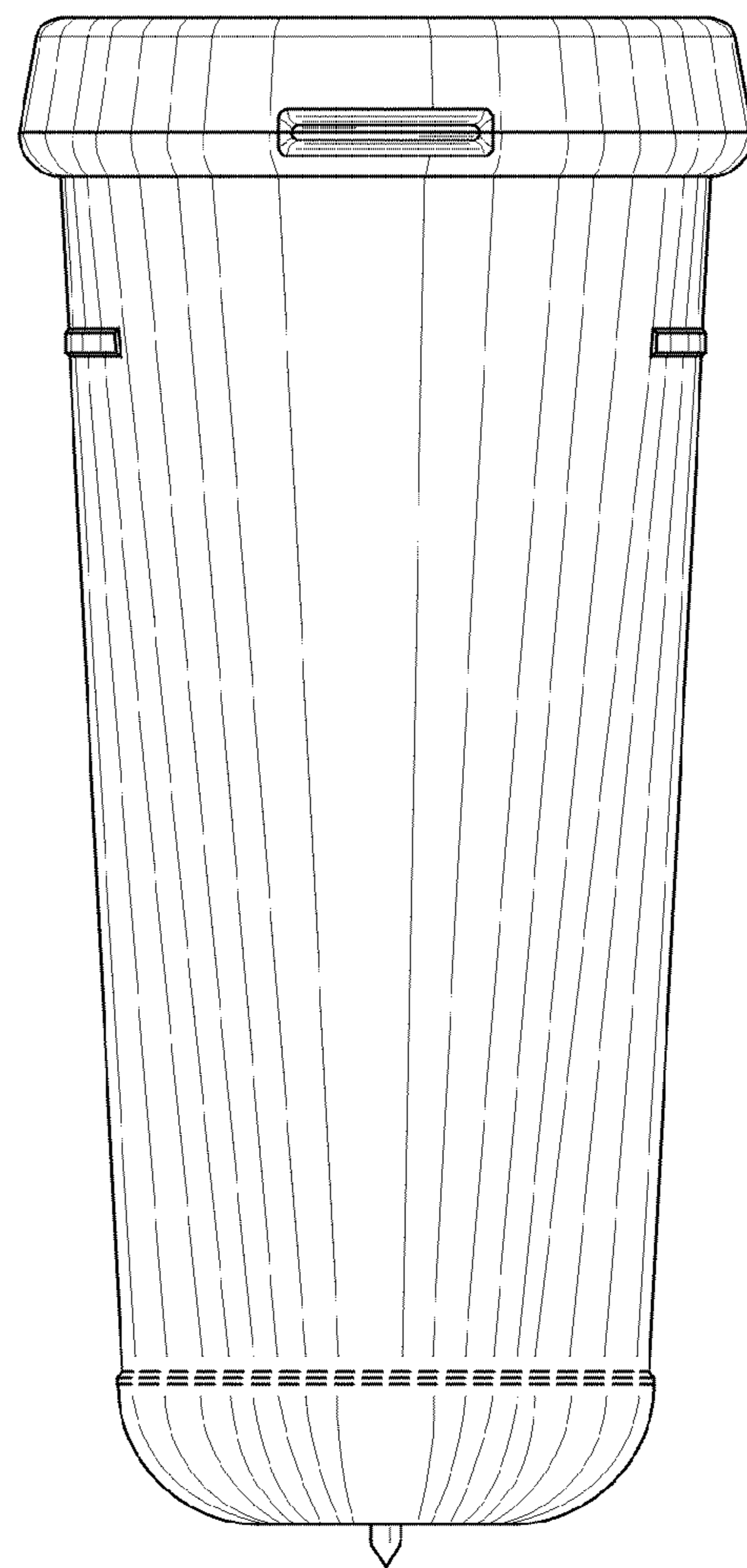

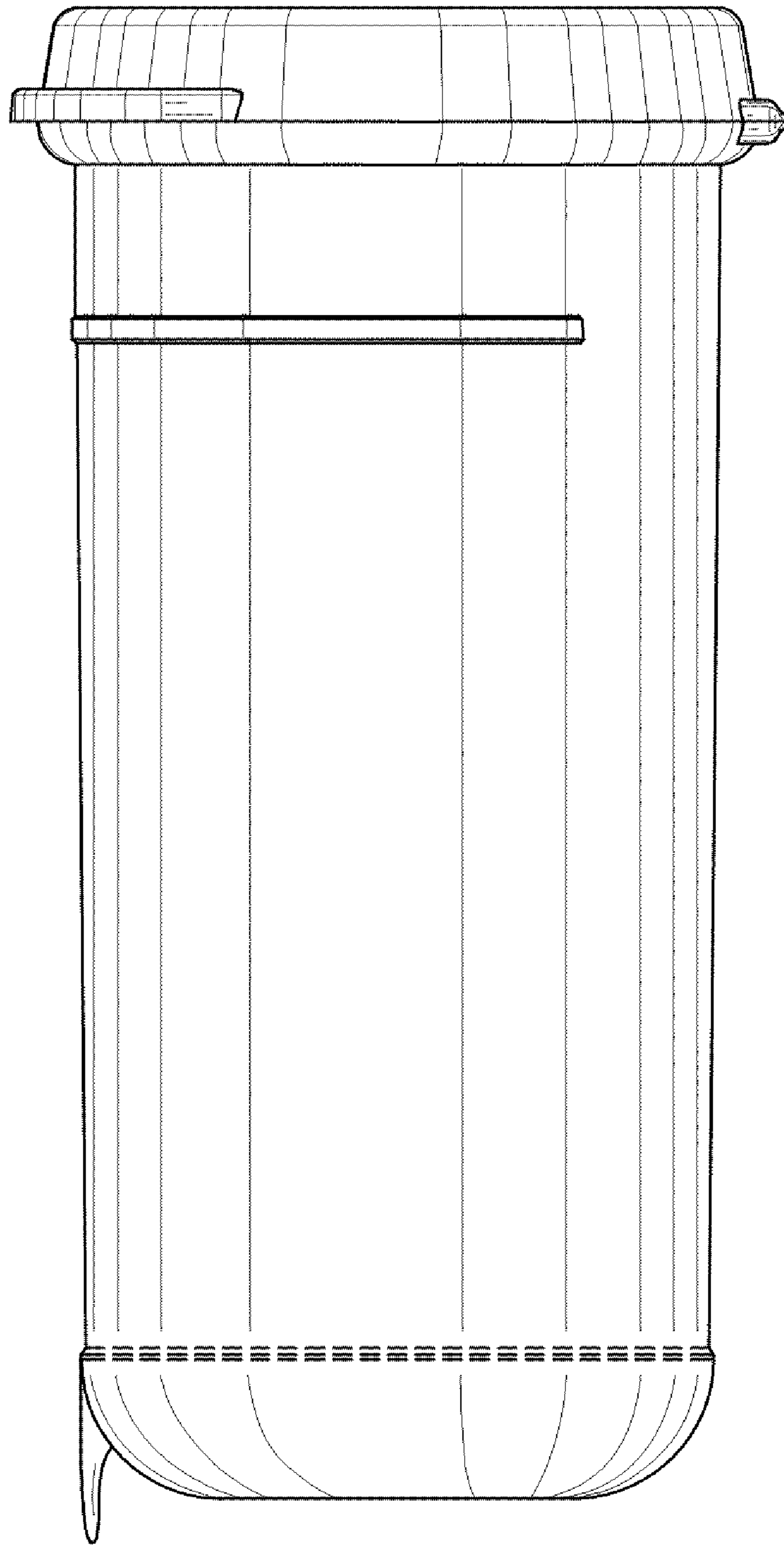

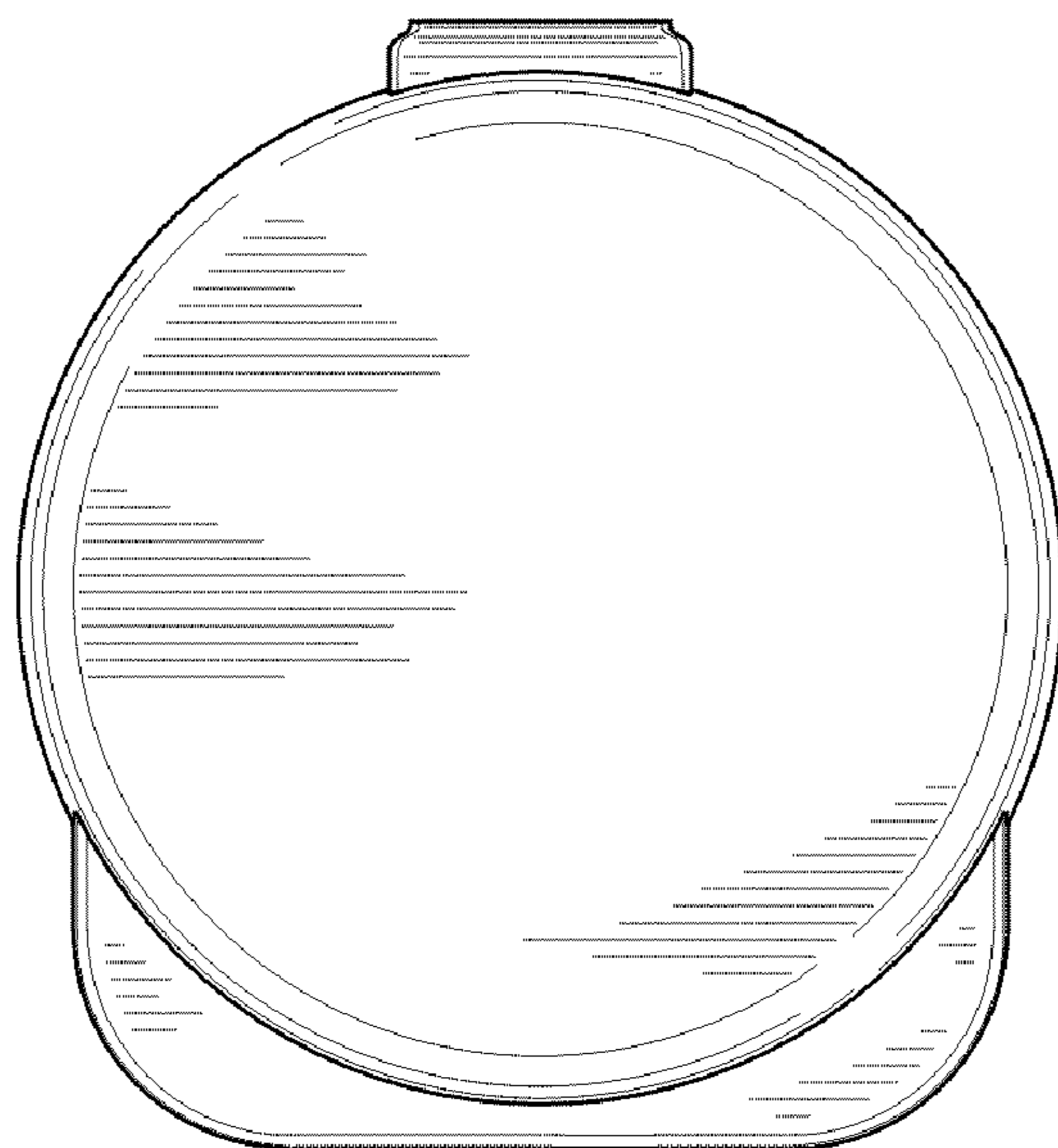

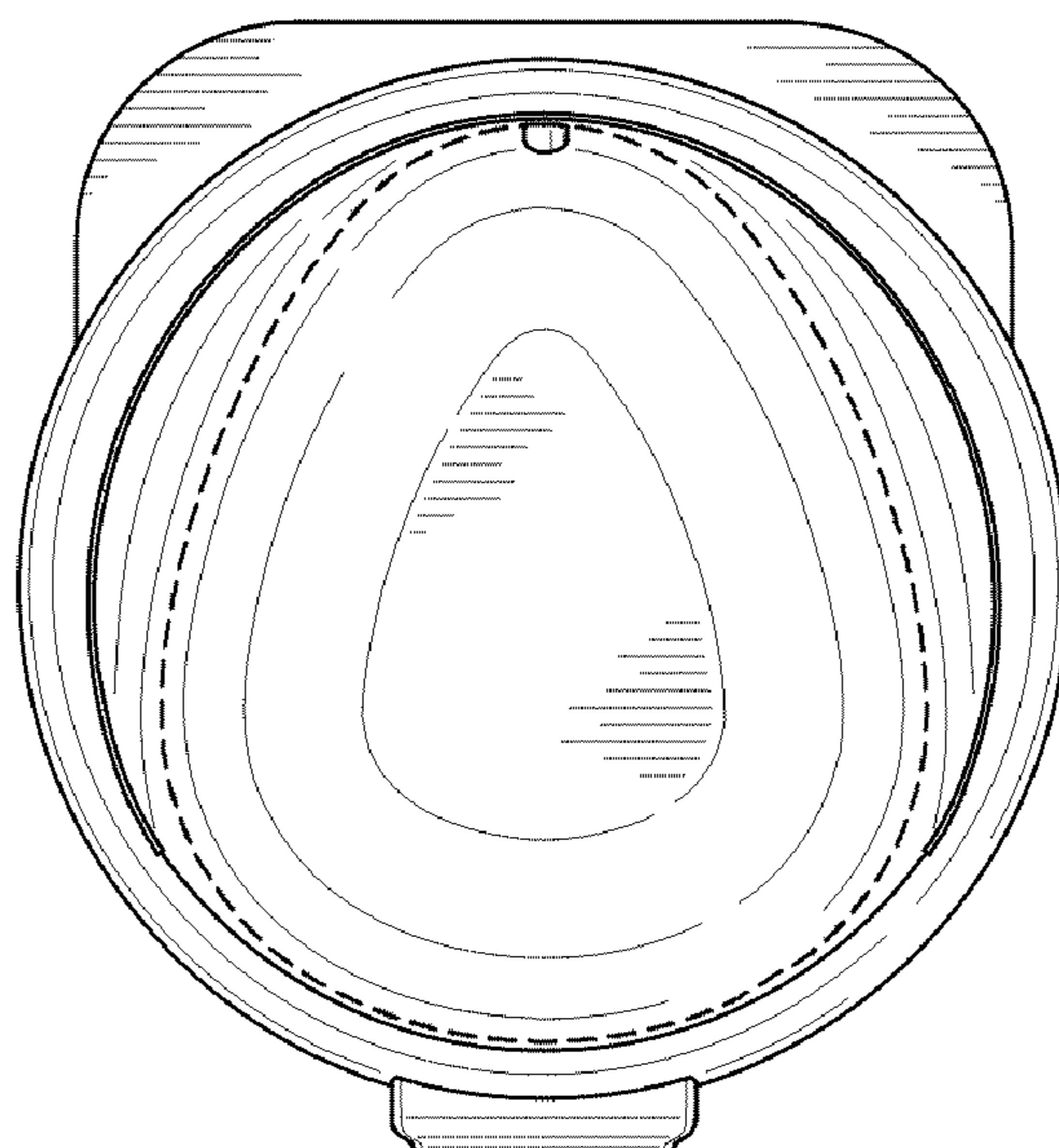

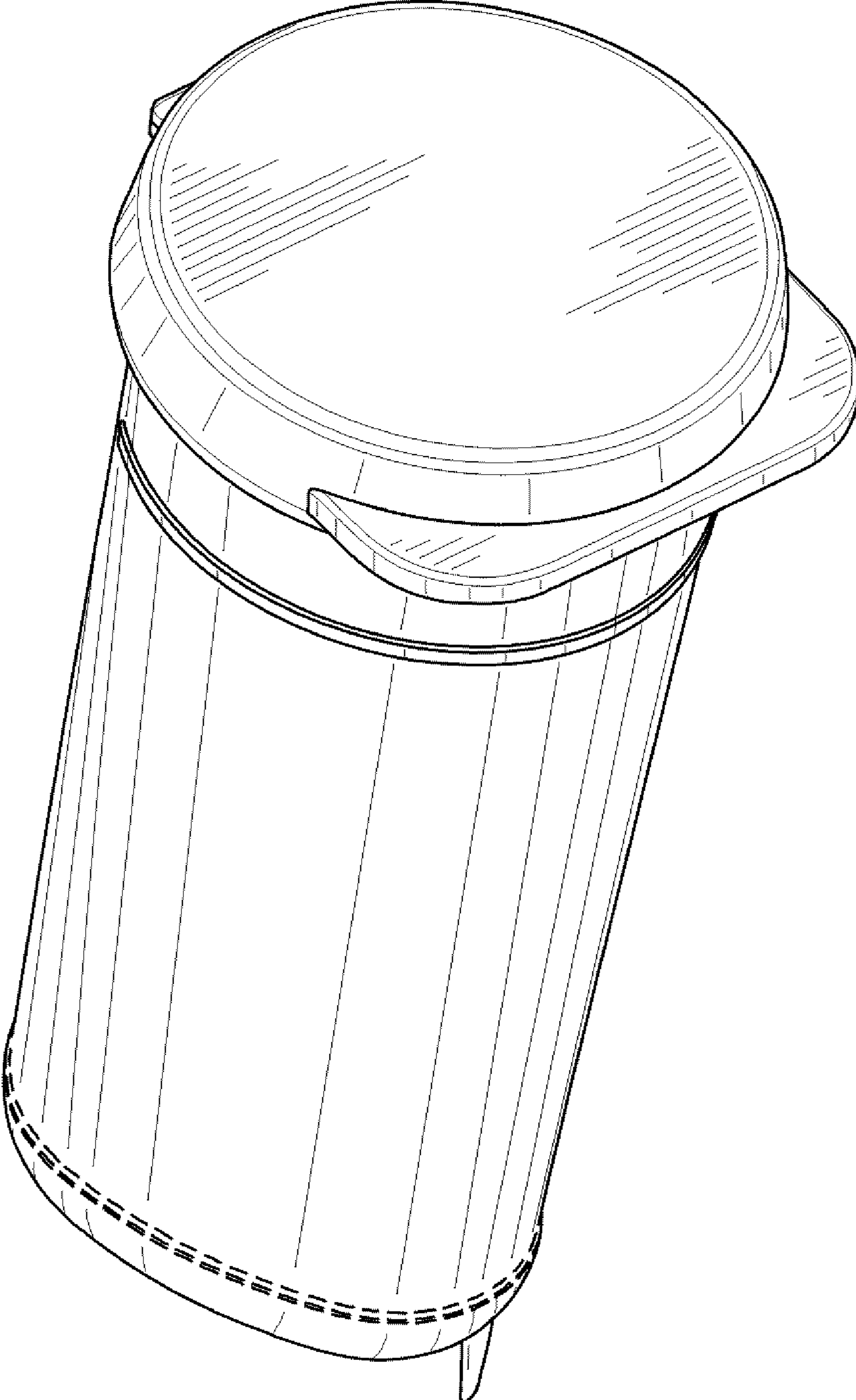

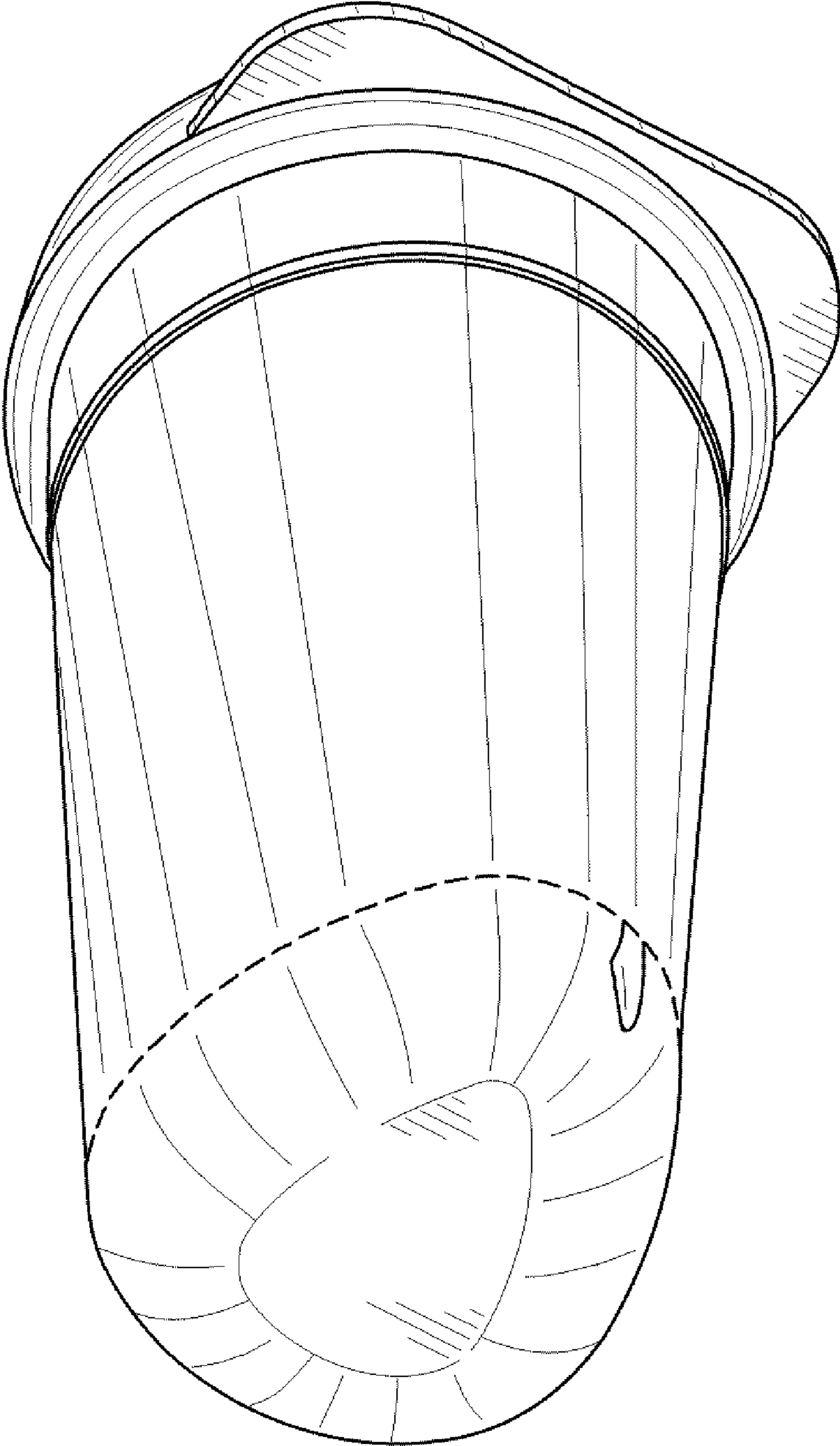
