(57) **CLAIM**

The ornamental design for a lighting fixture, as shown and described.

DESCRIPTION

- FIG. 1 is a plan view, from the top, of a lighting fixture showing my new design;
- FIG. 2 is a plan view showing the lighting fixture from the bottom;
- FIG. 3 is a front view of the lighting fixture;
- FIG. 4 is a side view showing one side of the lighting fixture;
- FIG. 5 is an isometric view, from the bottom and one side, showing the lighting fixture;
- FIG. 6 is a plan view, from the top, showing the housing of the lighting fixture in FIG. 1, shown separately for clarity of disclosure;
- FIG. 7 is a plan view showing the housing from the bottom;
- FIG. 8 is a front view of the housing;
- FIG. 9 is a side view showing one side of the housing;
- FIG. 10 is an isometric view, from the bottom and one side, of the housing;
- FIG. 11 is a plan view, from the top, showing the trim of the lighting fixture shown in FIG. 1, shown separately for clarity of disclosure;
- FIG. 12 is a plan view showing the trim from the bottom;
- FIG. 13 is a front view of the trim;
- FIG. 14 is a side view showing one side of the trim; and,
- FIG. 15 is an isometric view, from the bottom and one side, of the trim.

The broken lines represent portions of the lighting fixture that form no part of the claimed design.

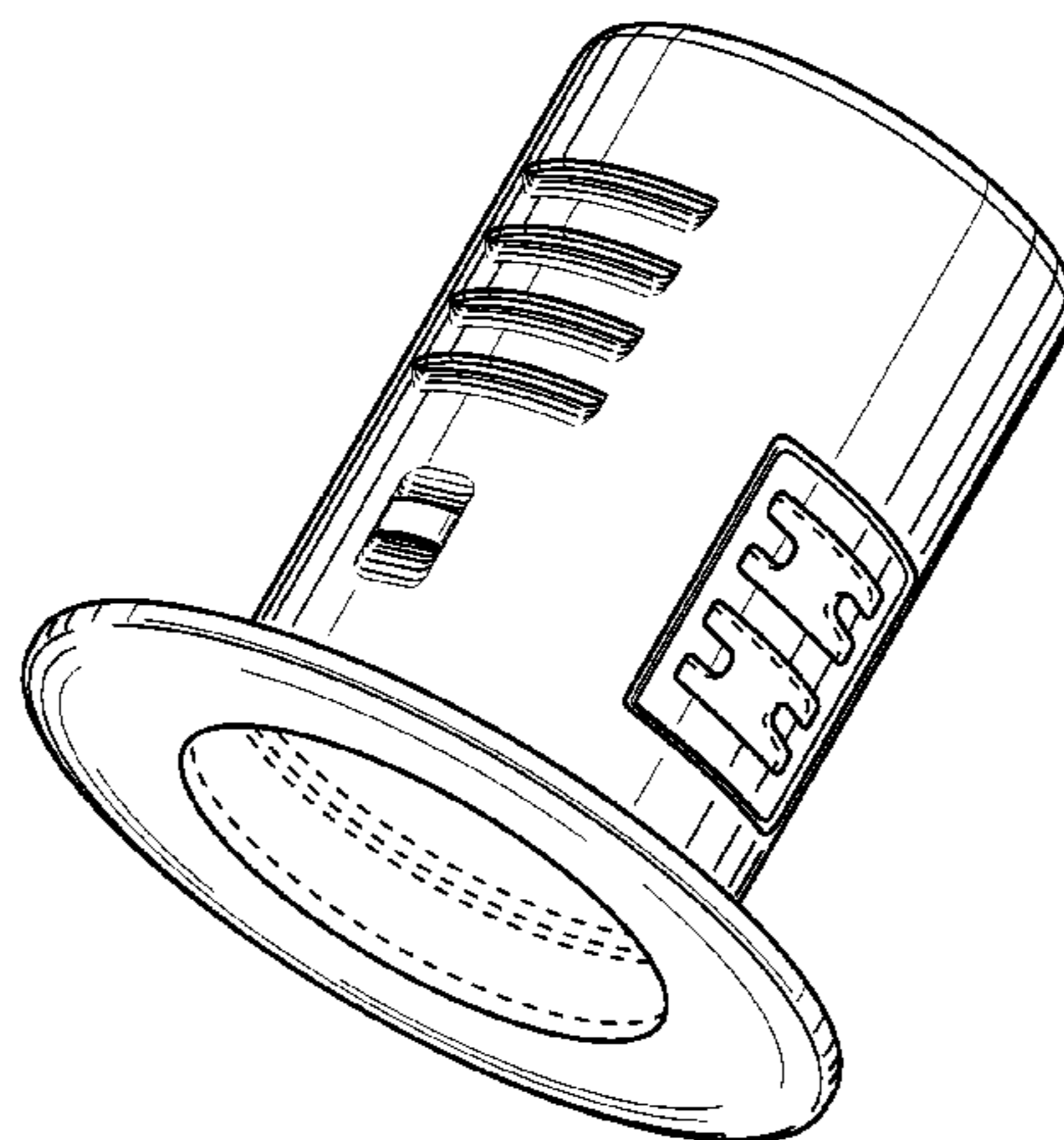

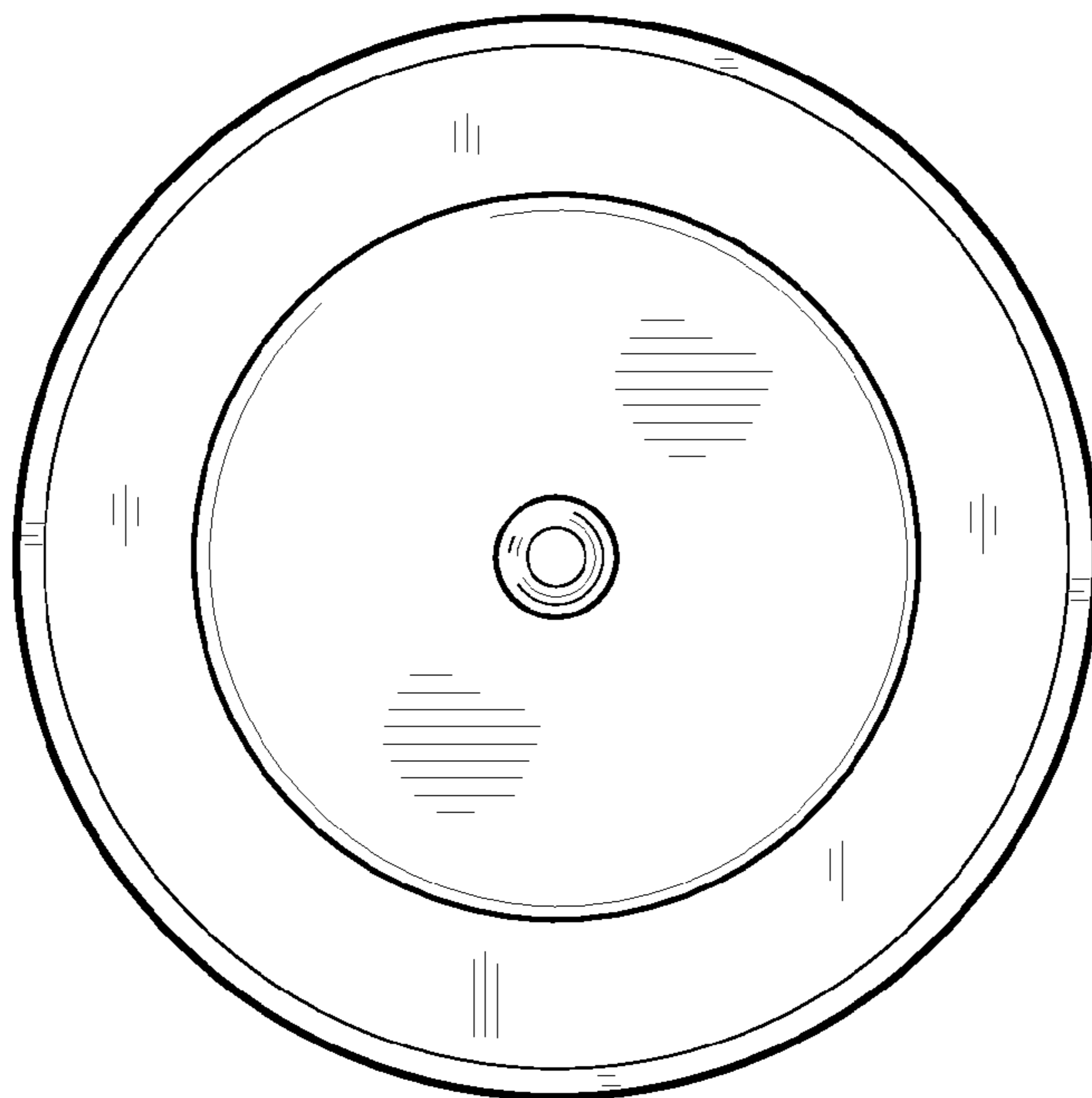

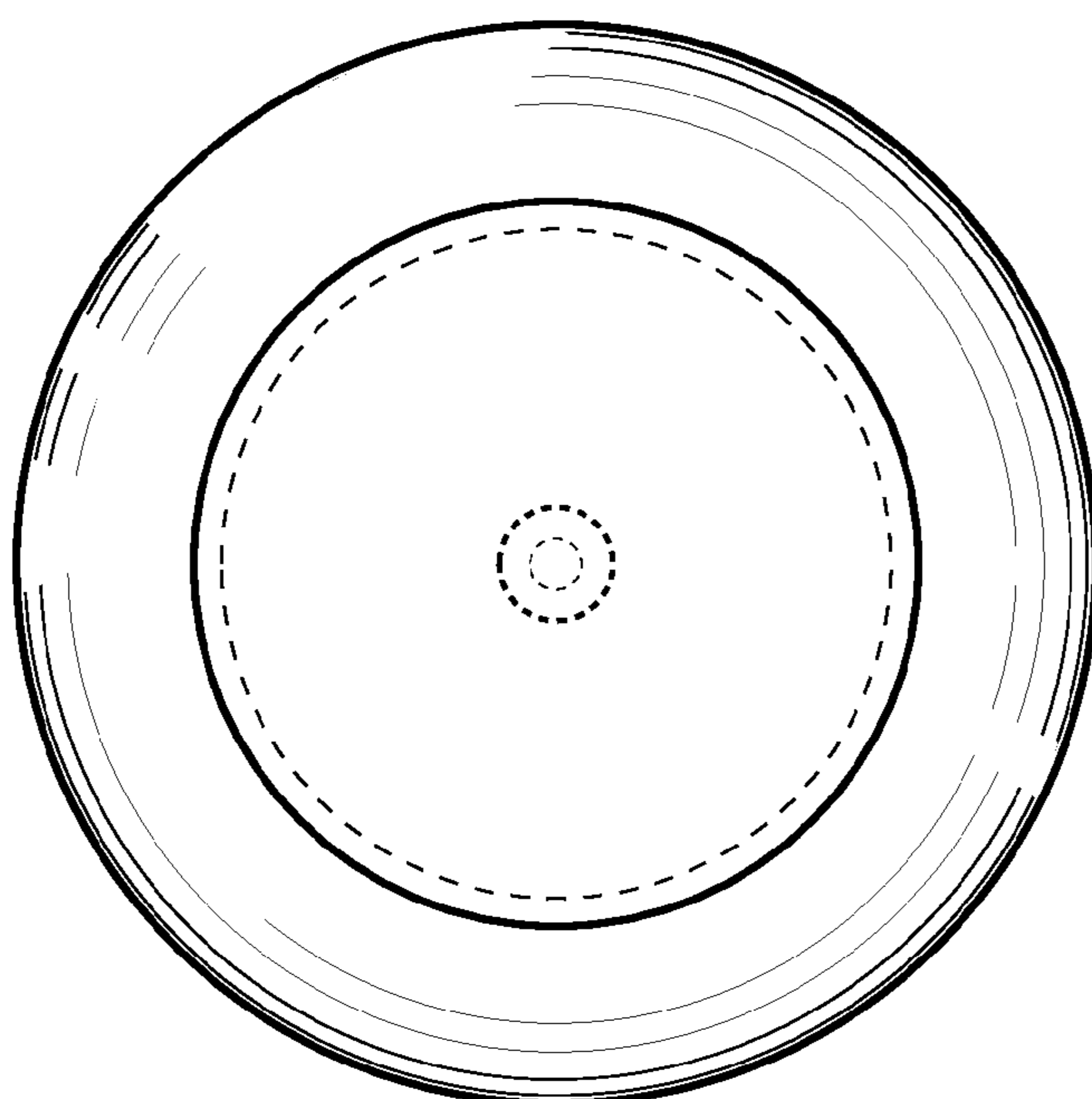

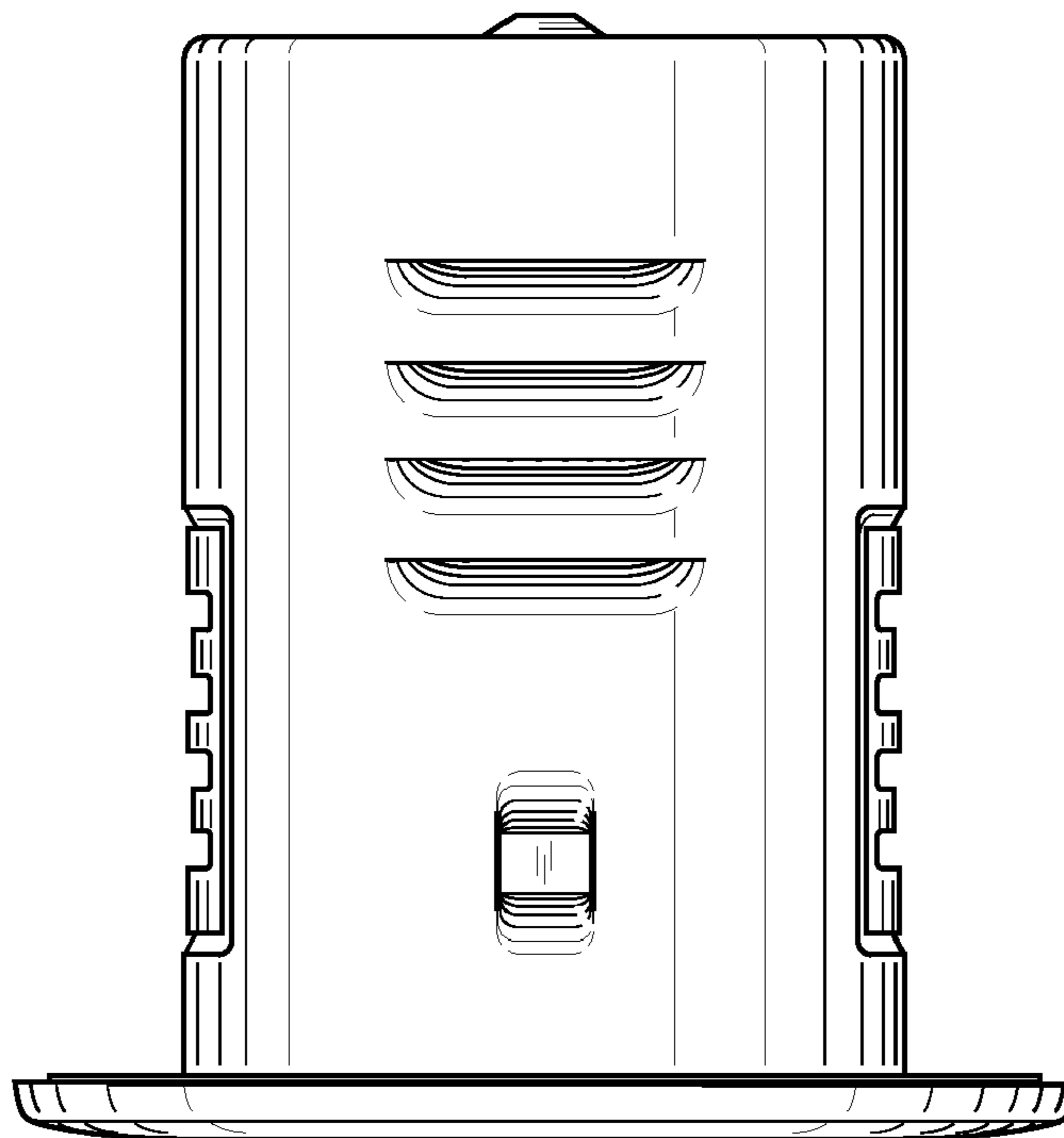

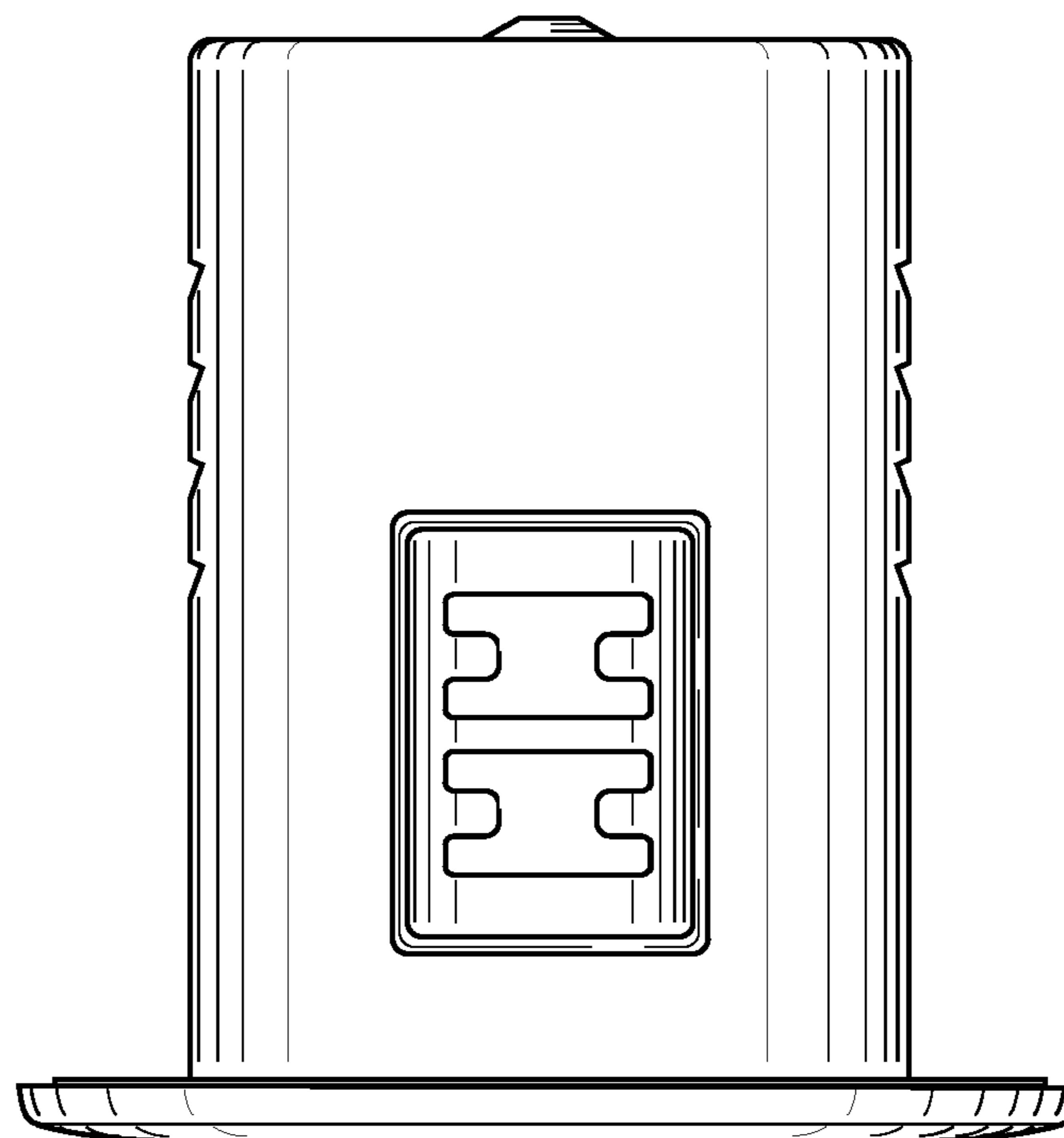

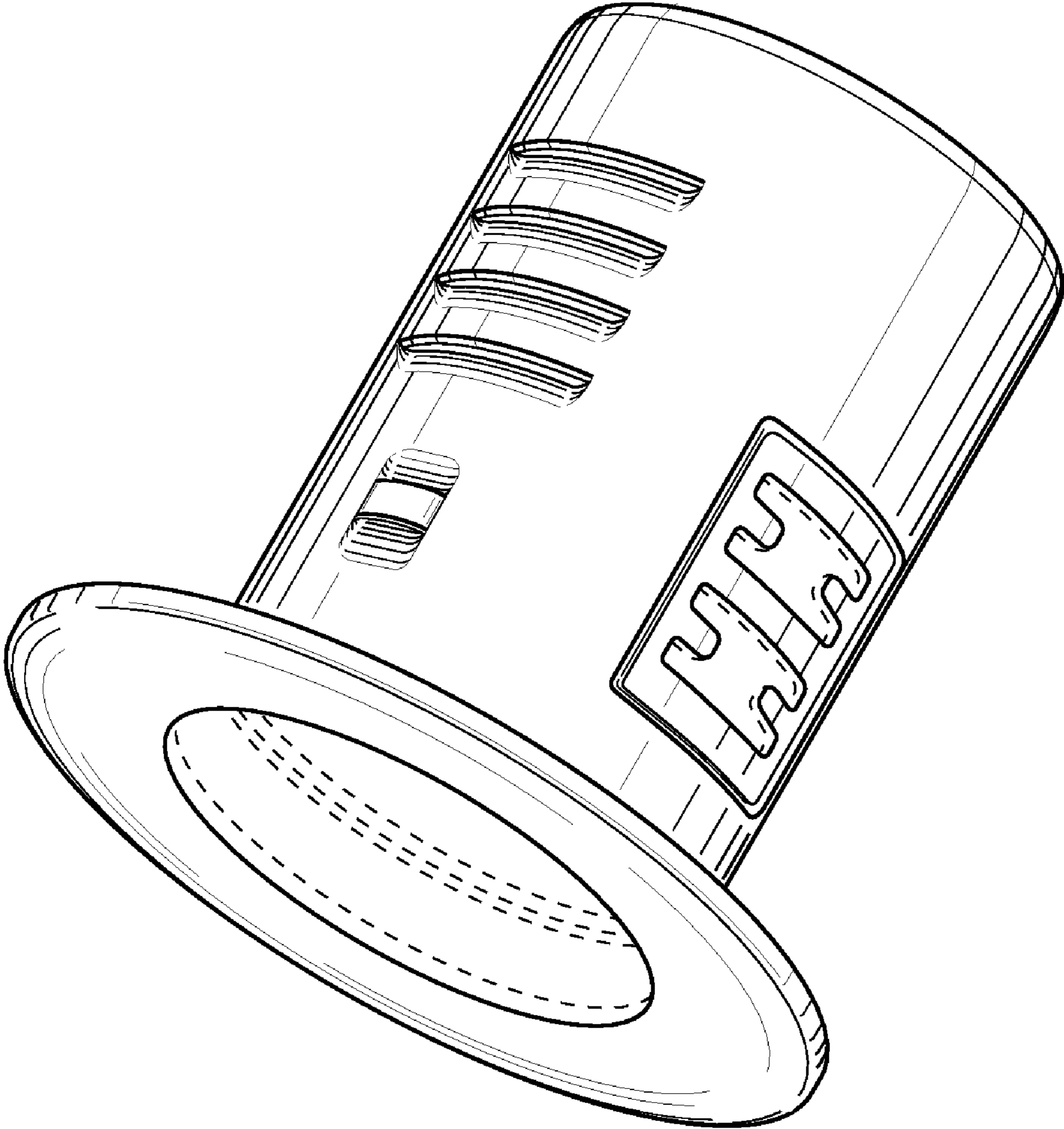

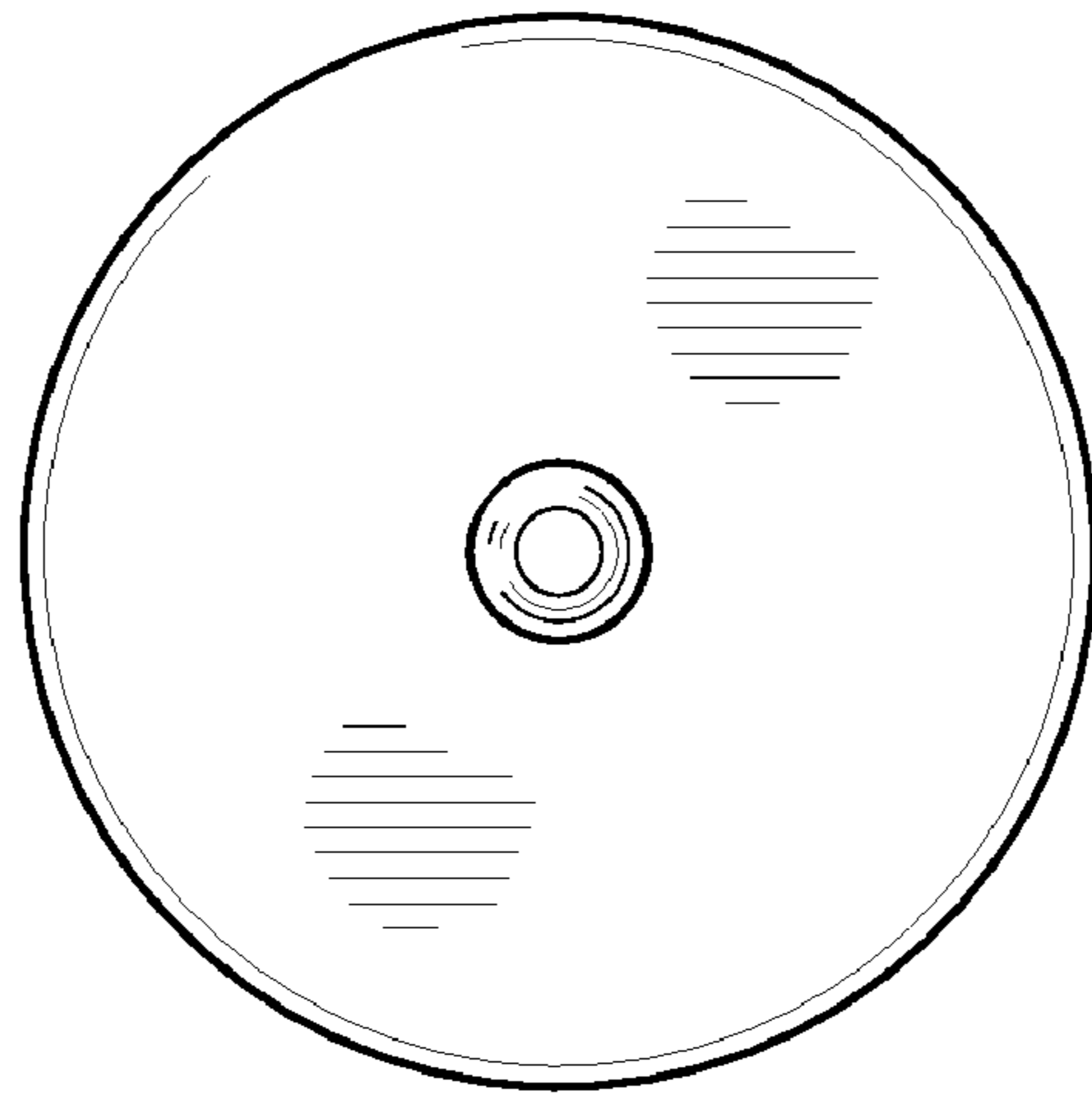

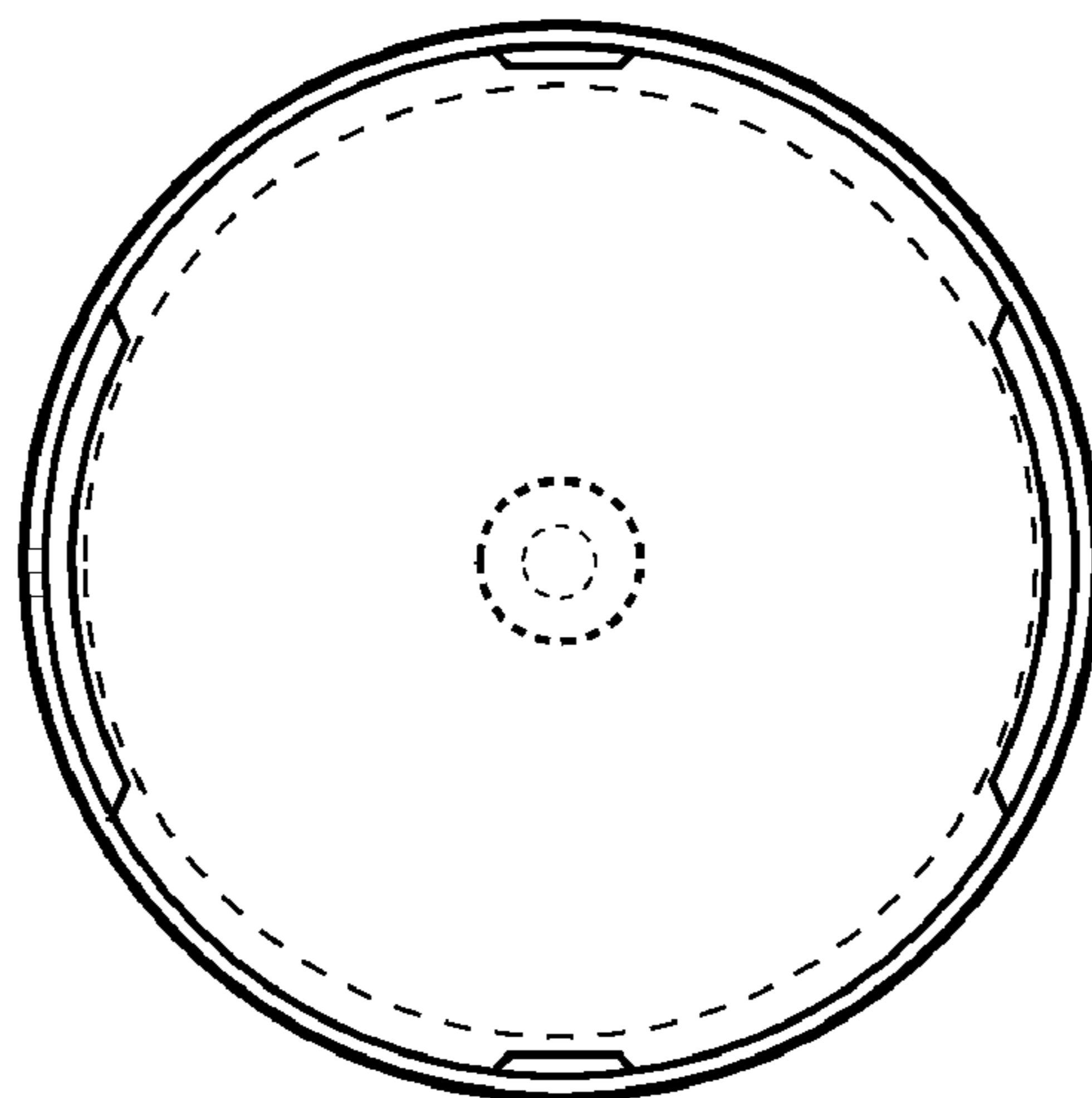

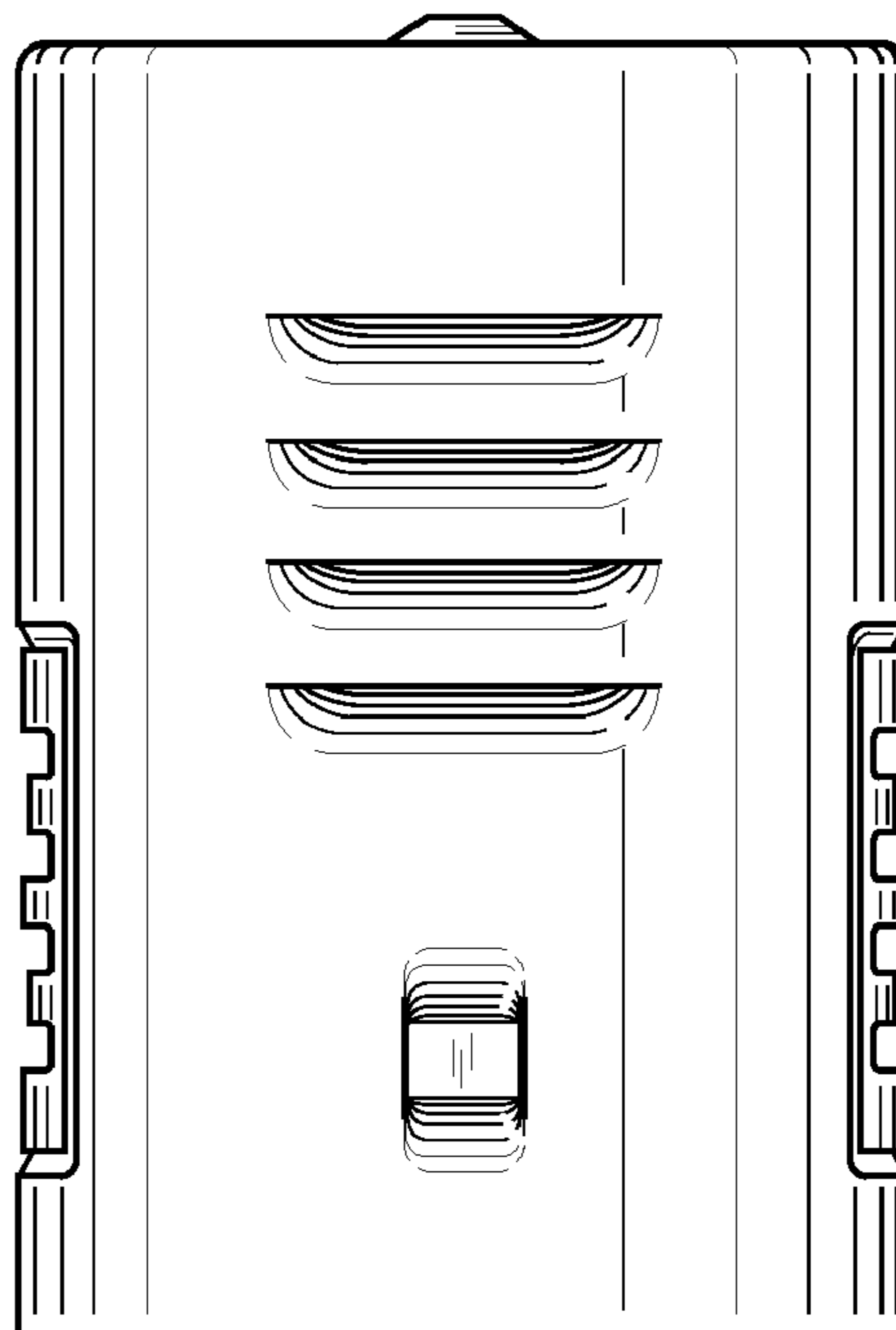

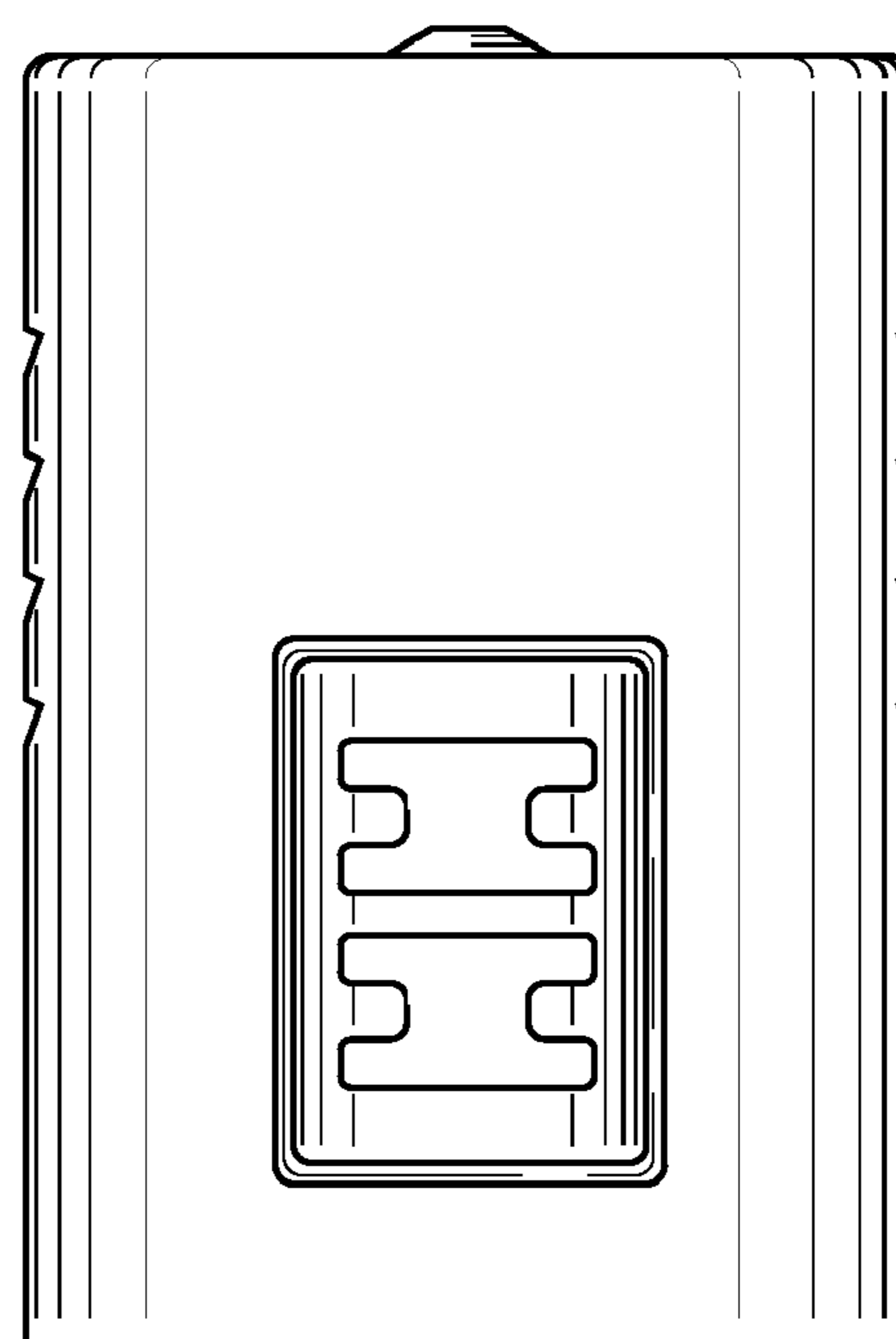

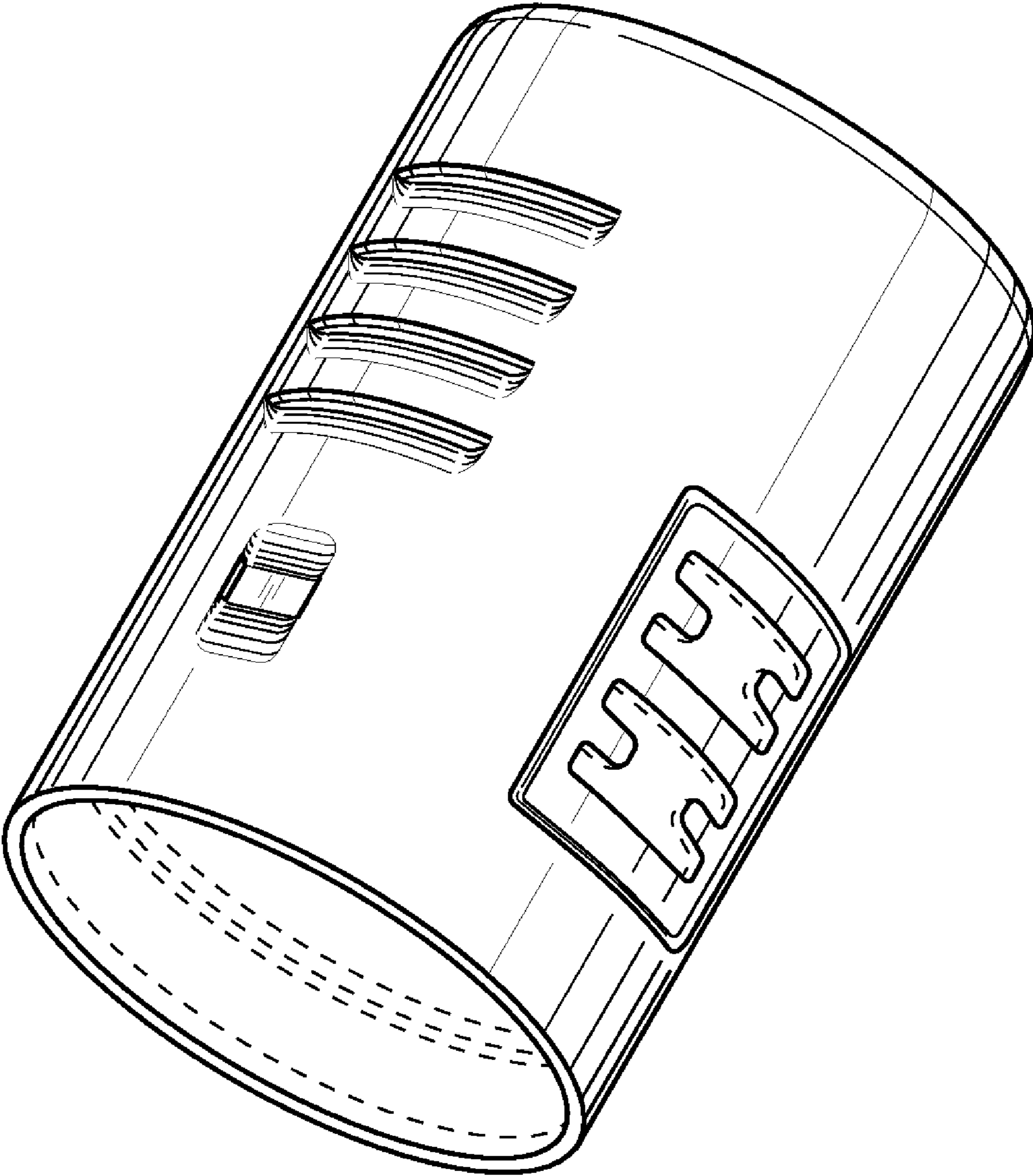

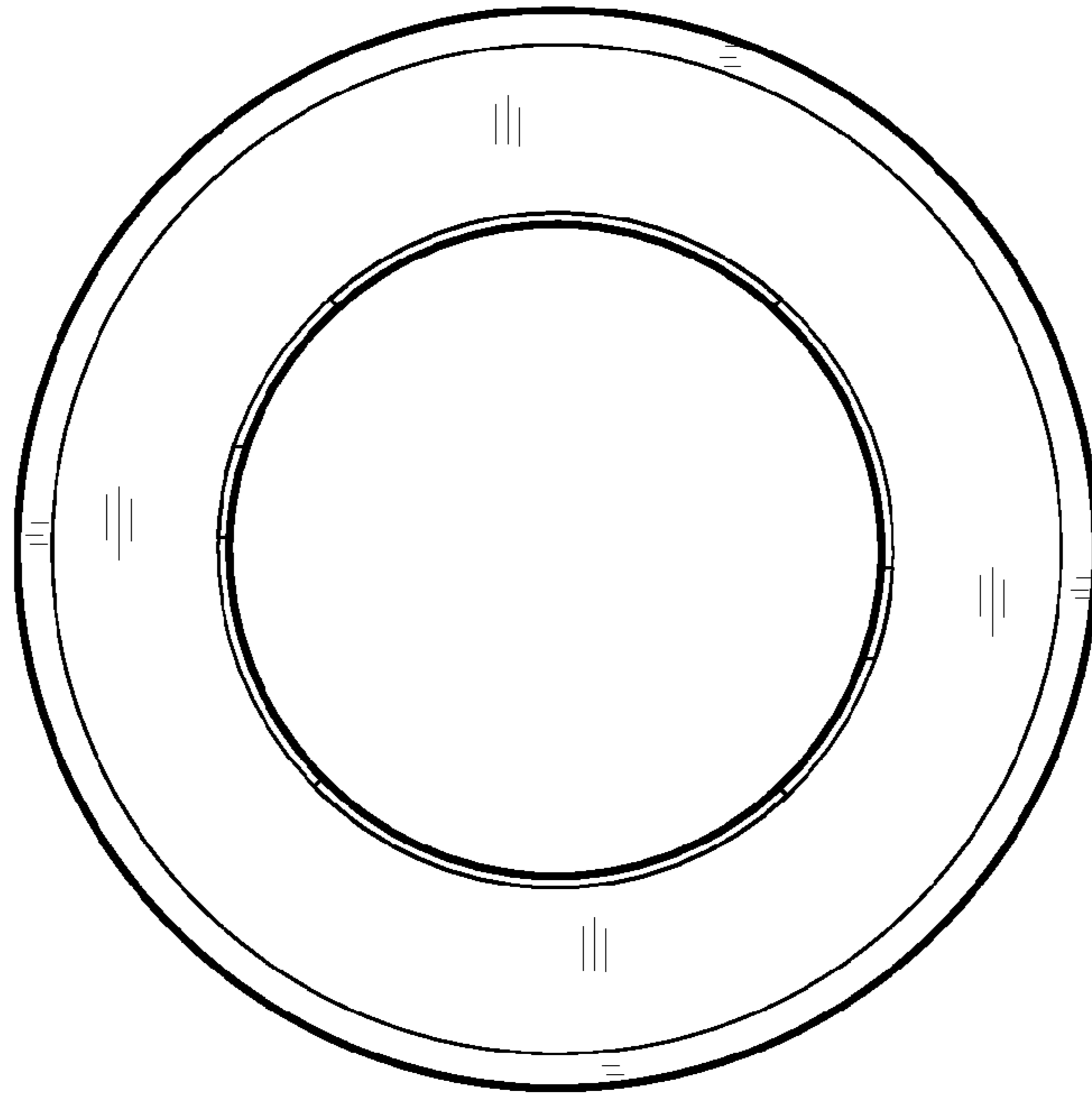

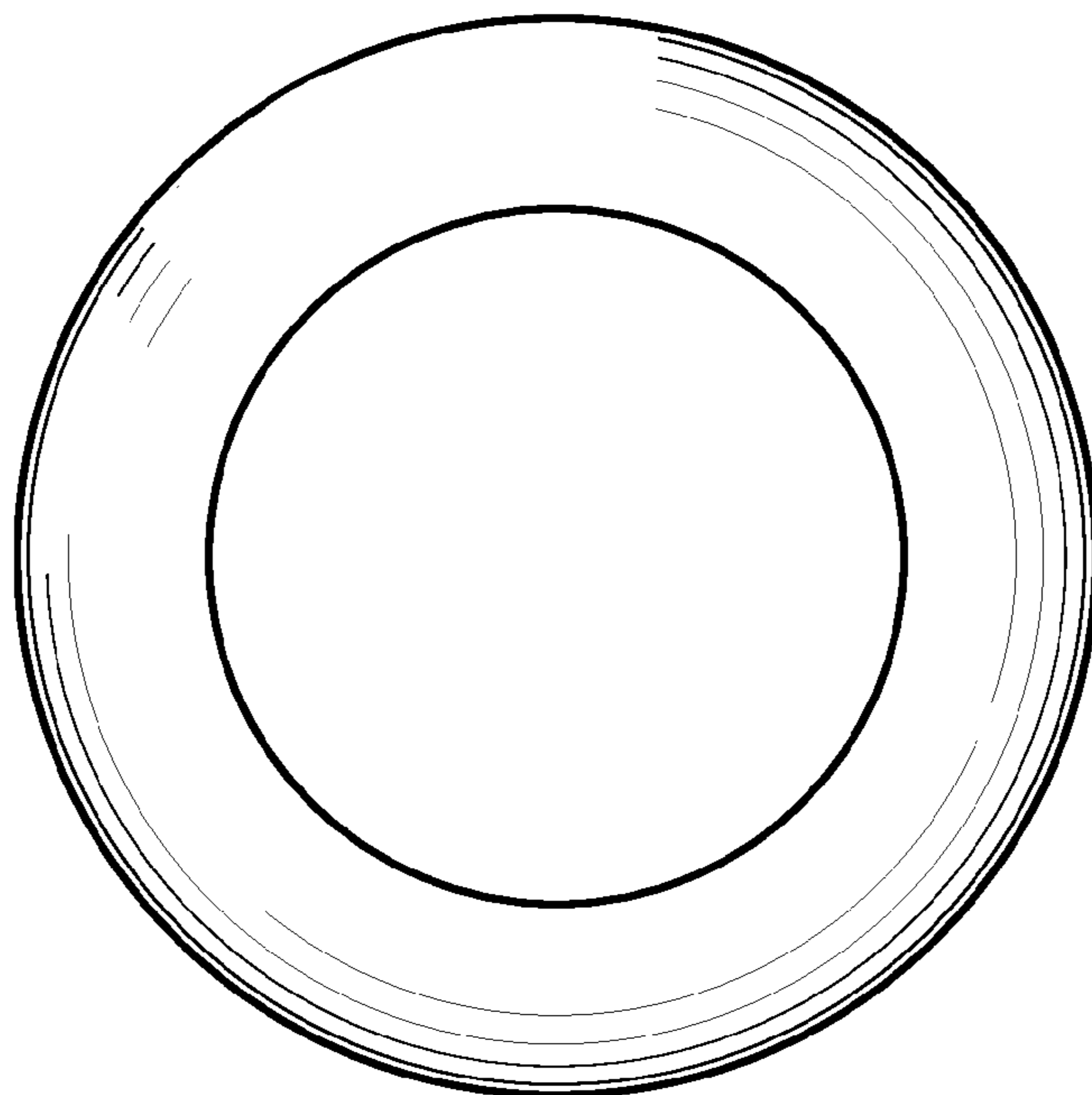

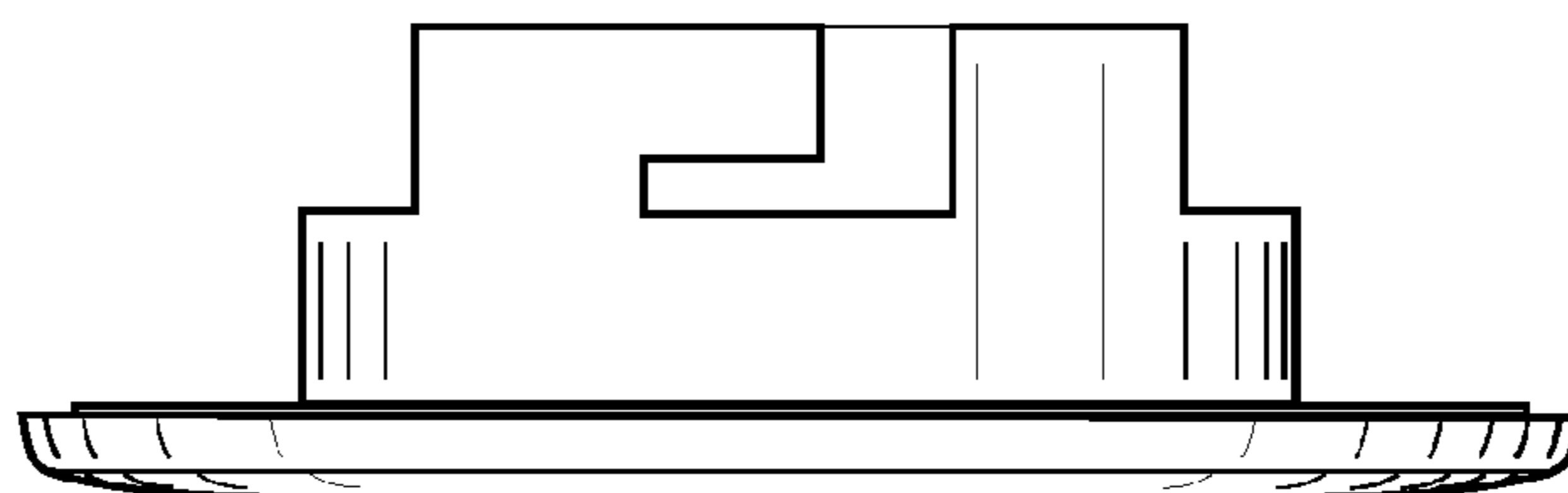

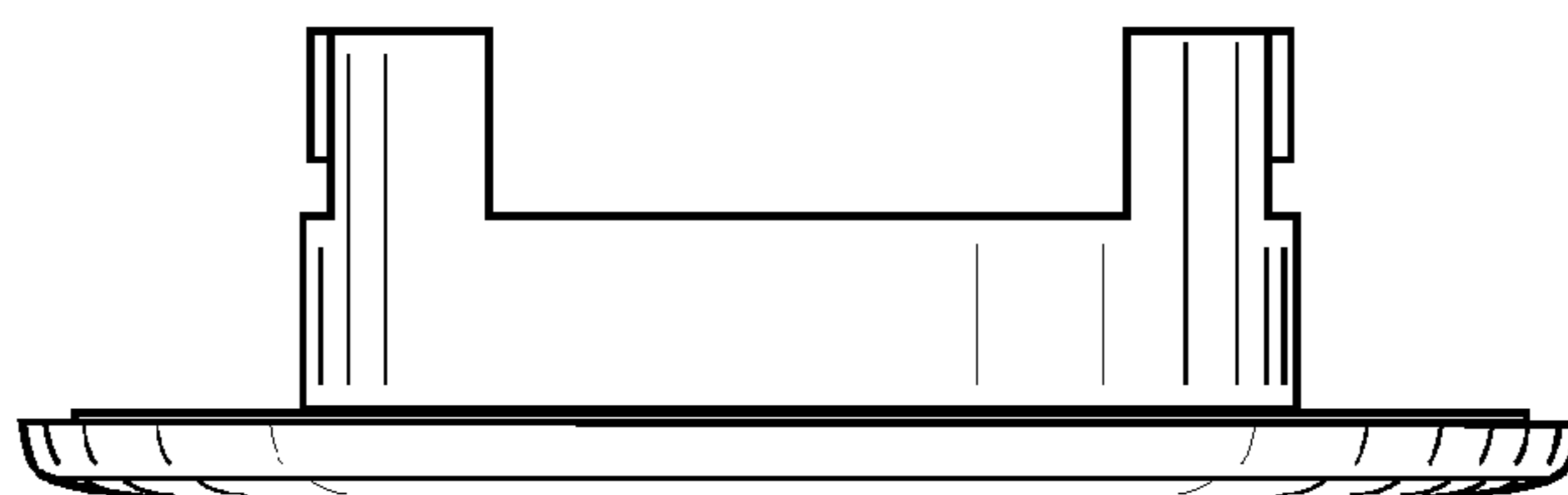
