The ornamental design for a basket for storing and transporting goods in shops and other selling premises, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of the basket for storing and transporting goods in shops and other selling premises showing my design.

FIG. 7 is a back perspective view, showing the handle in an upright position;

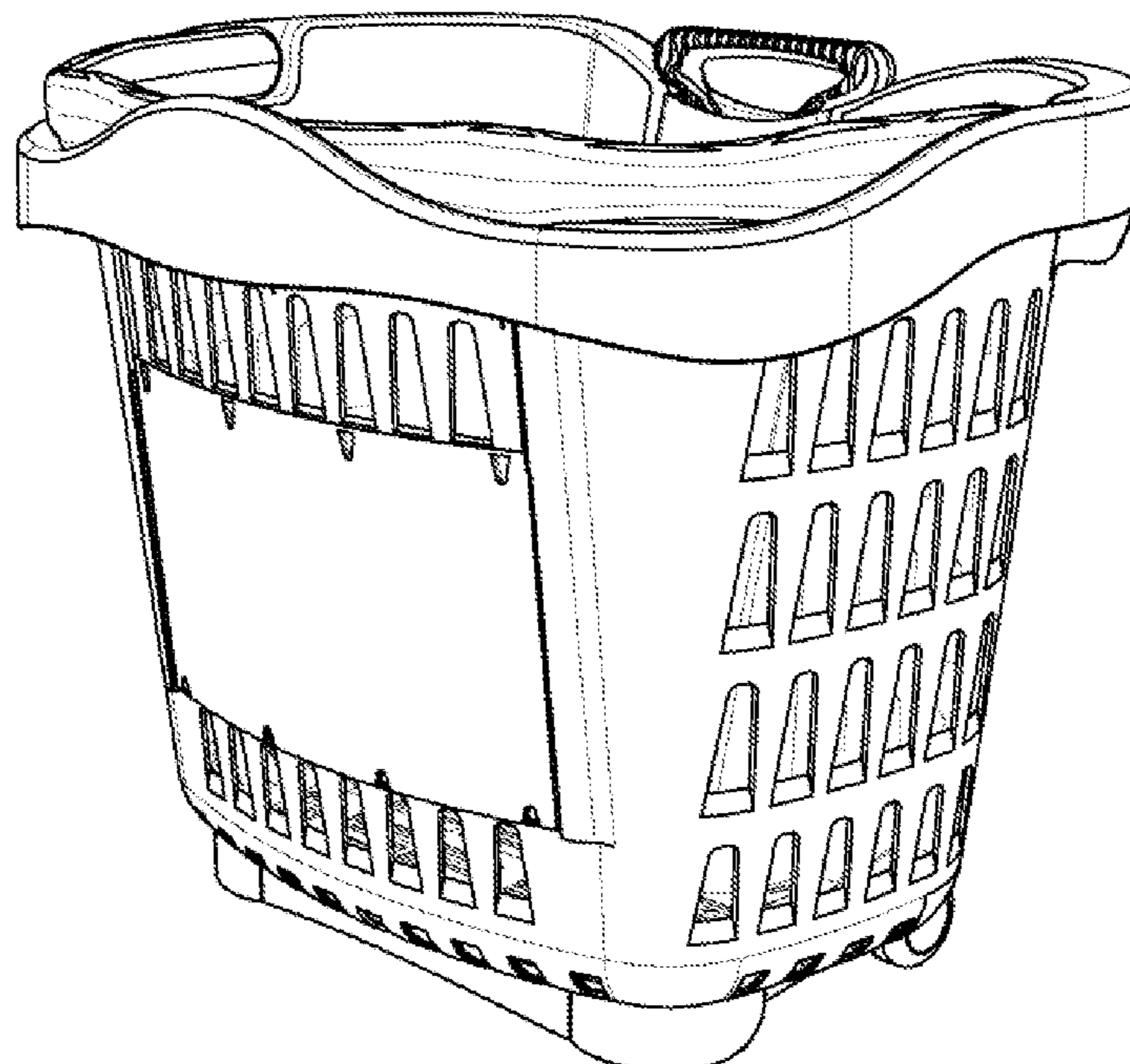
FIG. 8 is an upper perspective view, showing the arm in an extended position;

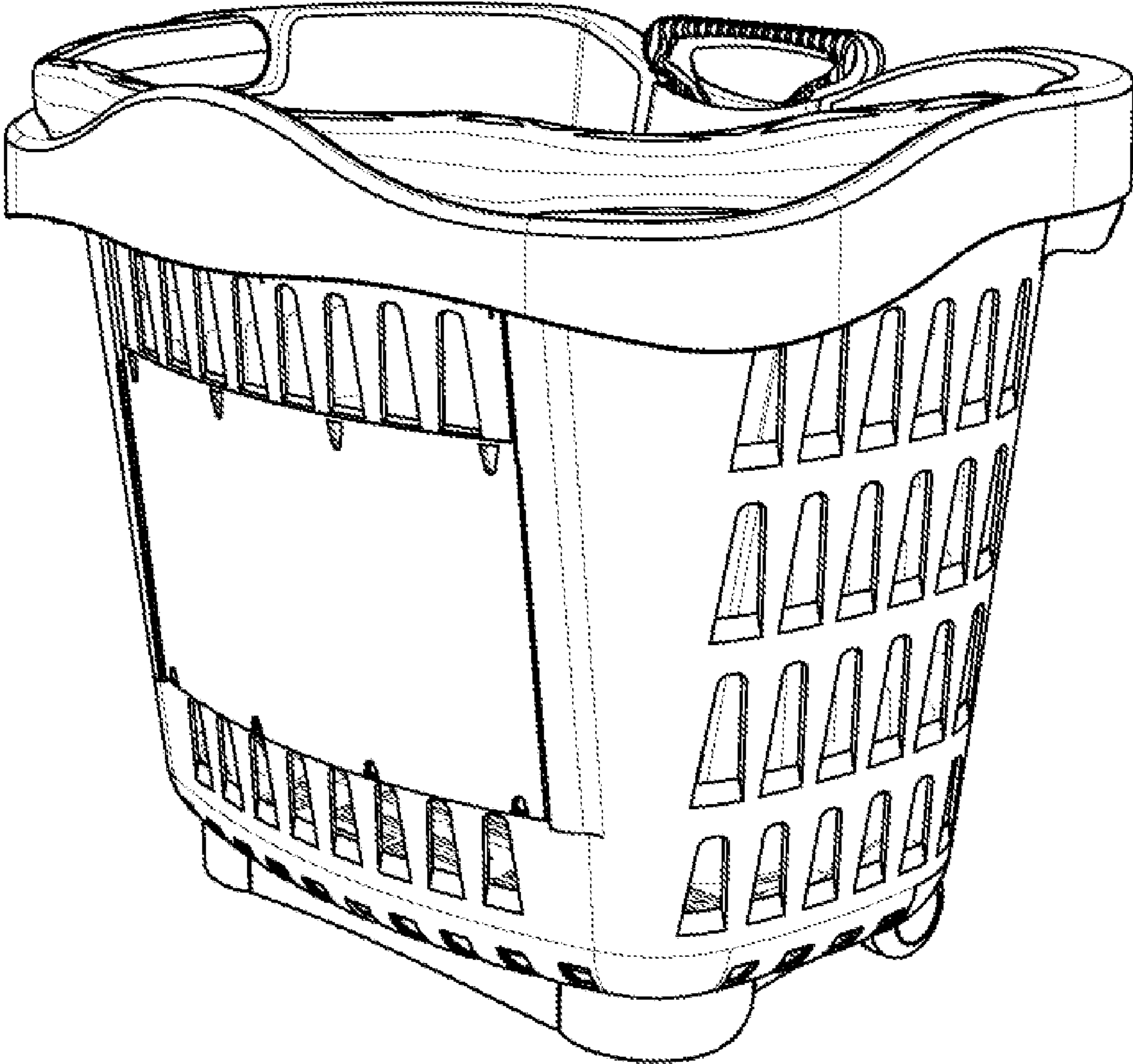

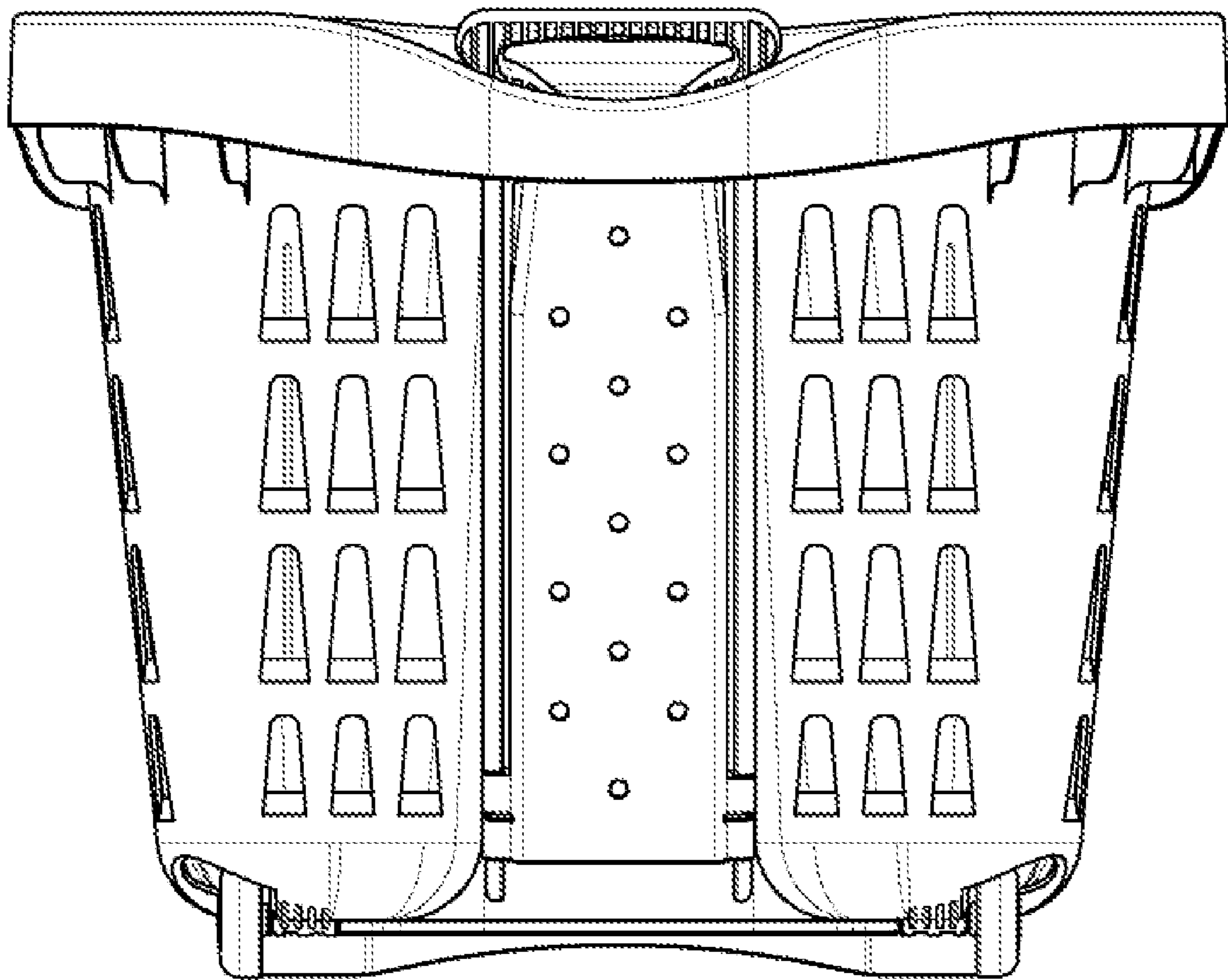

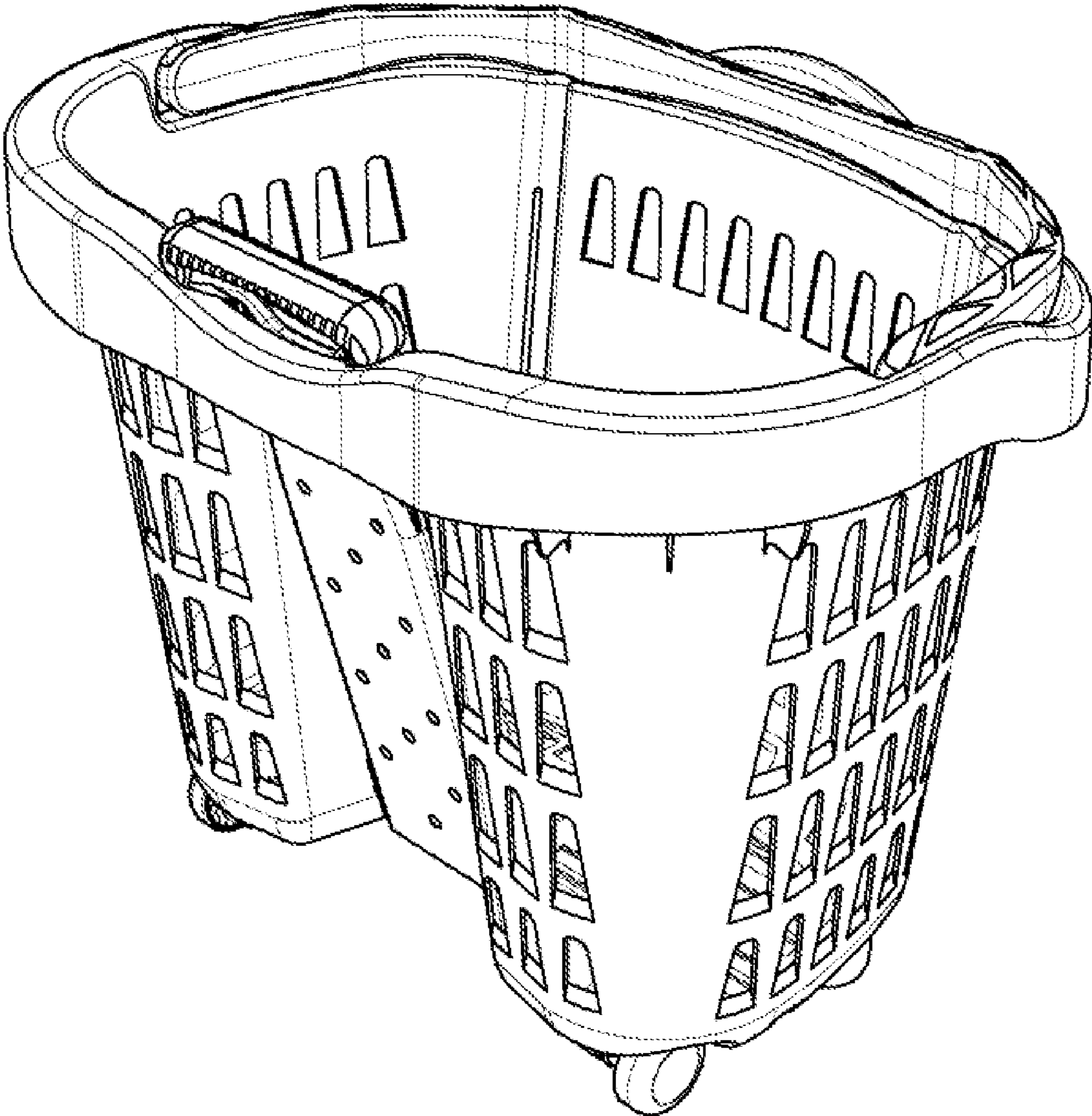

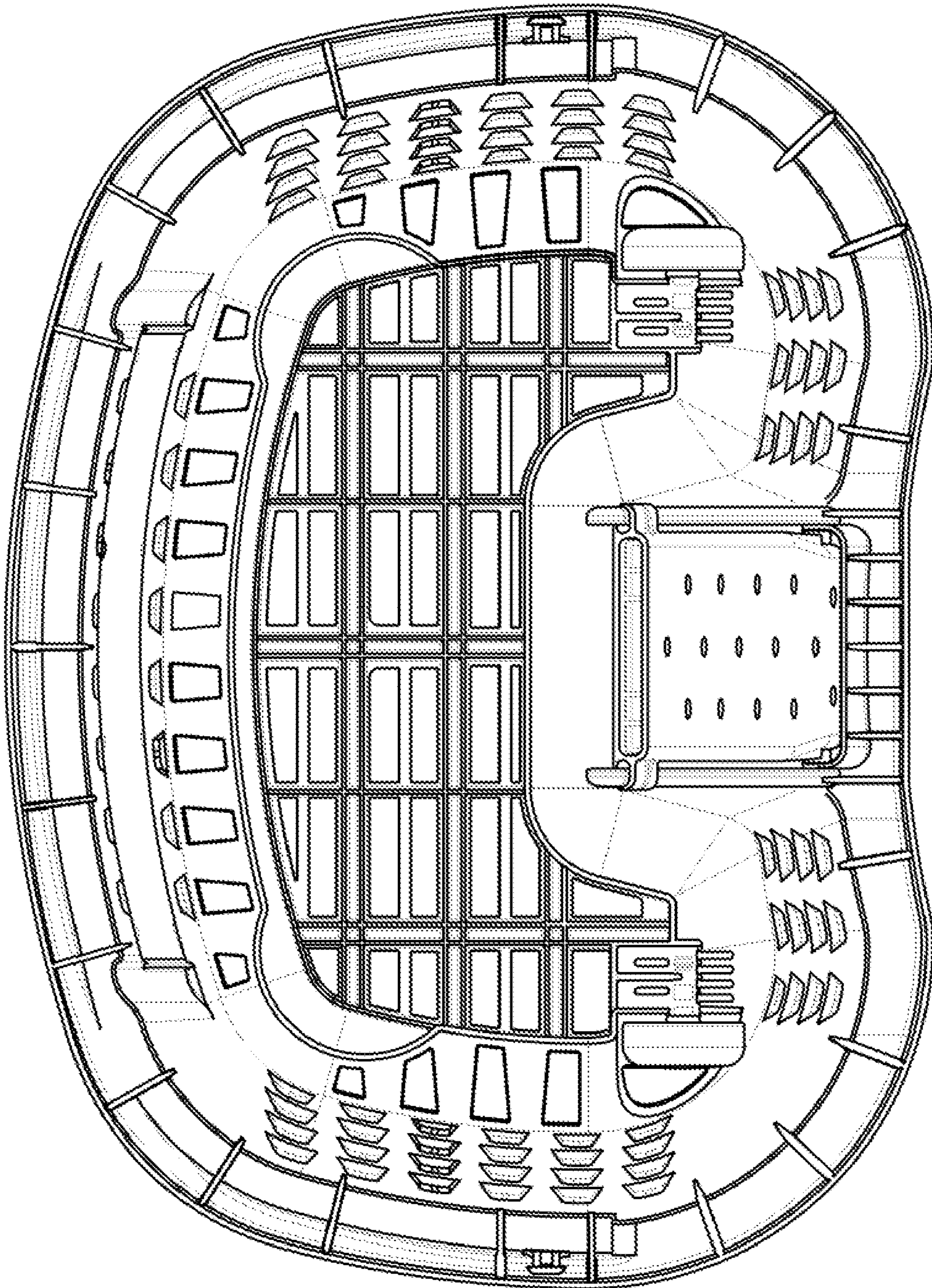

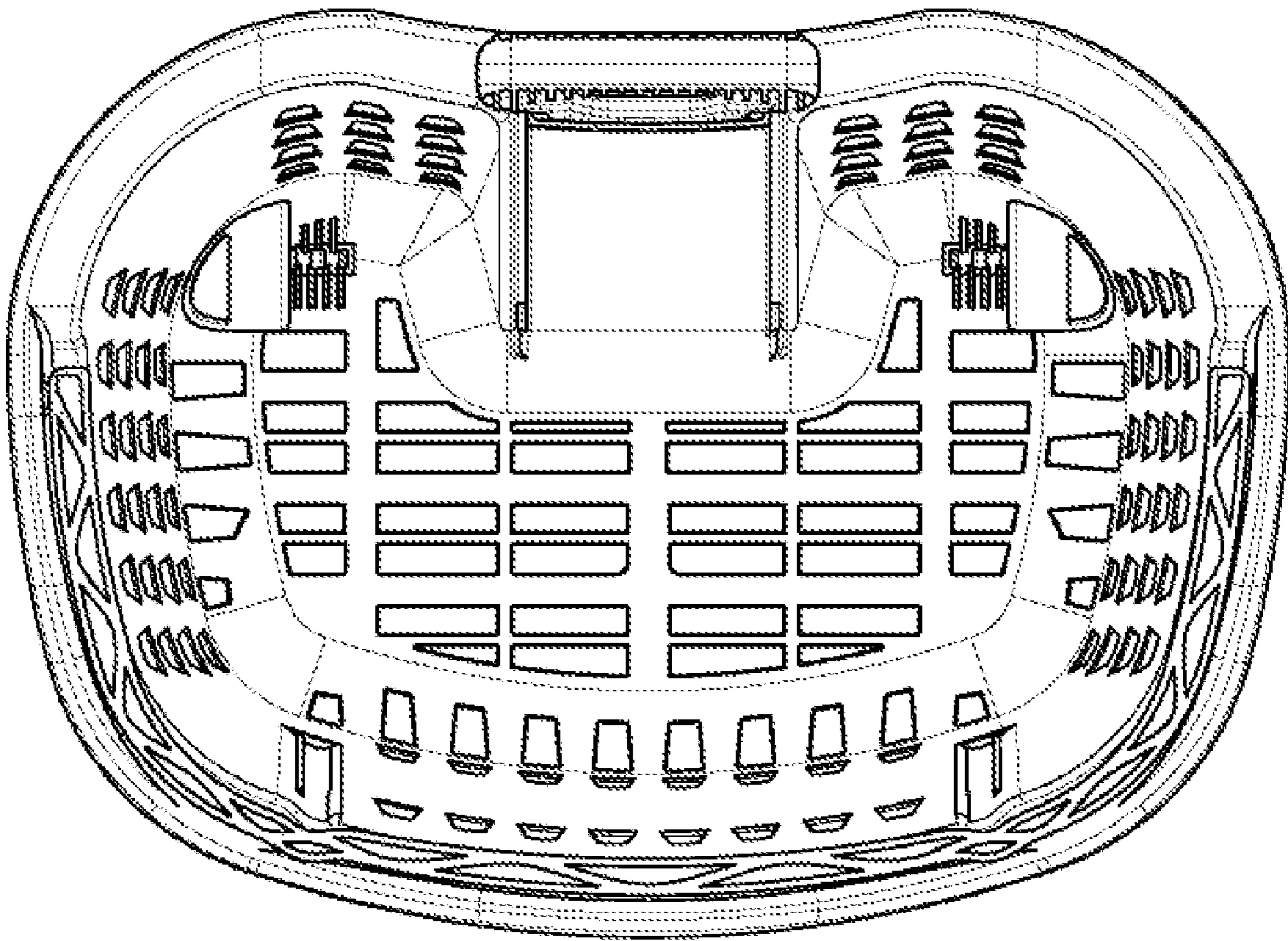

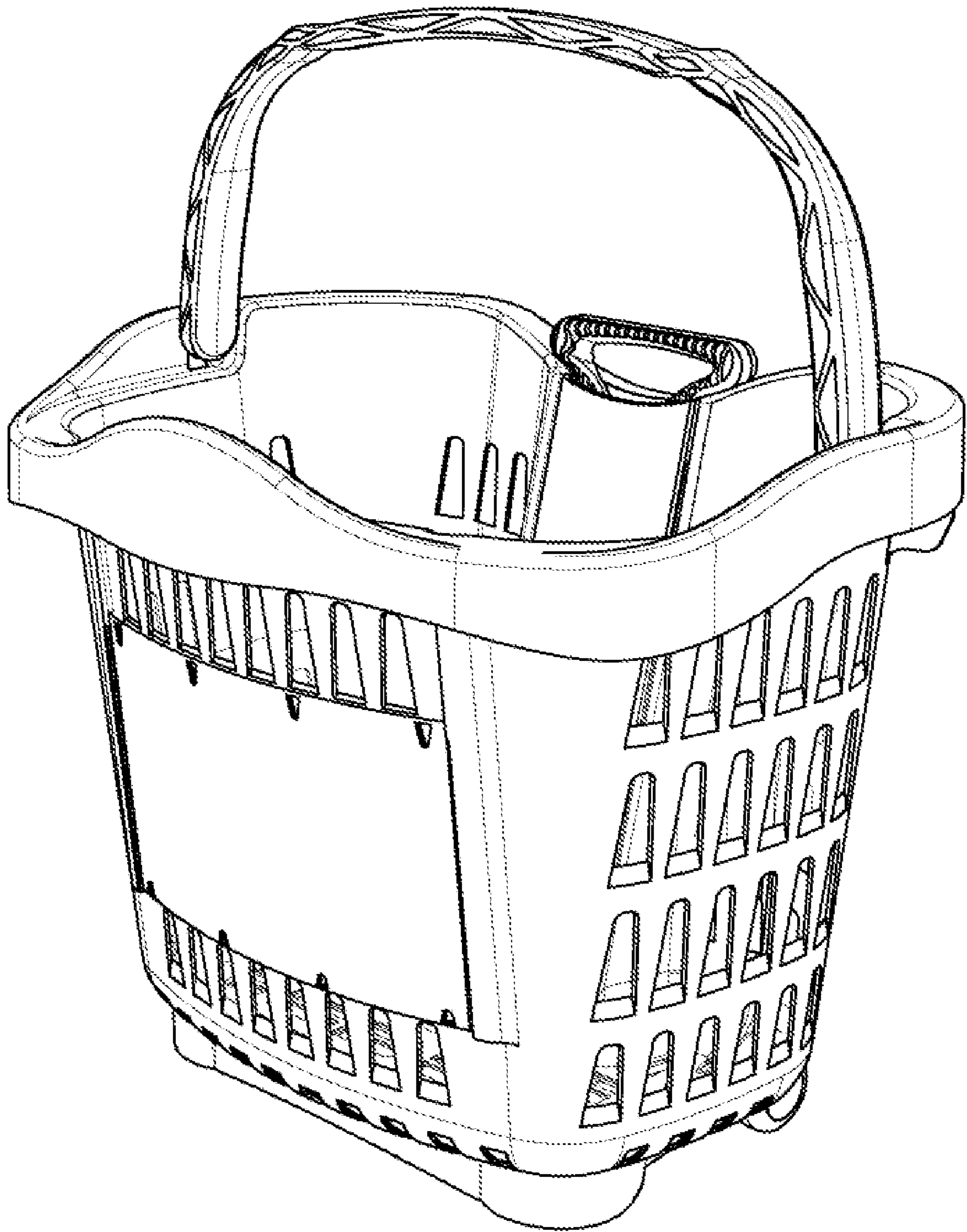

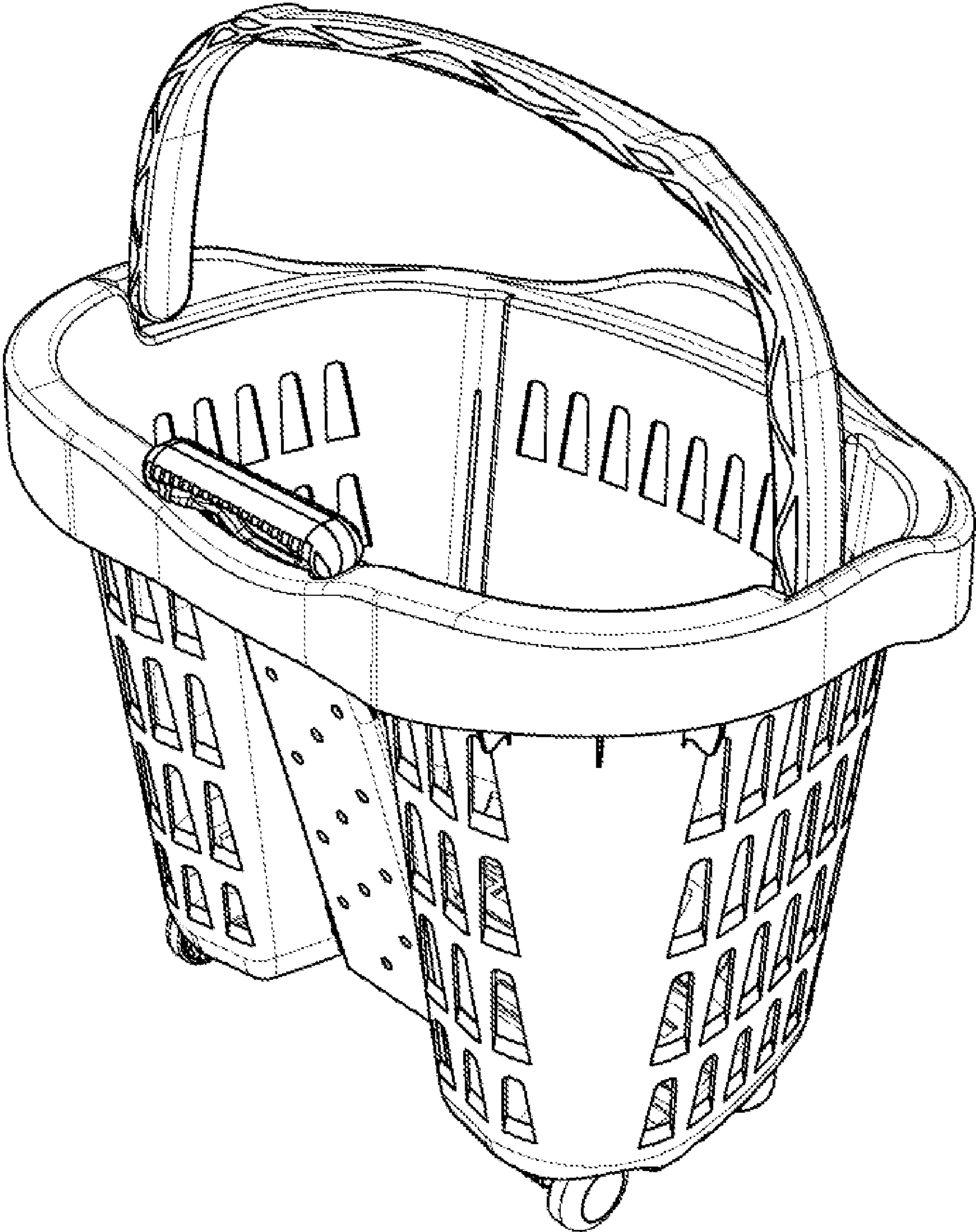

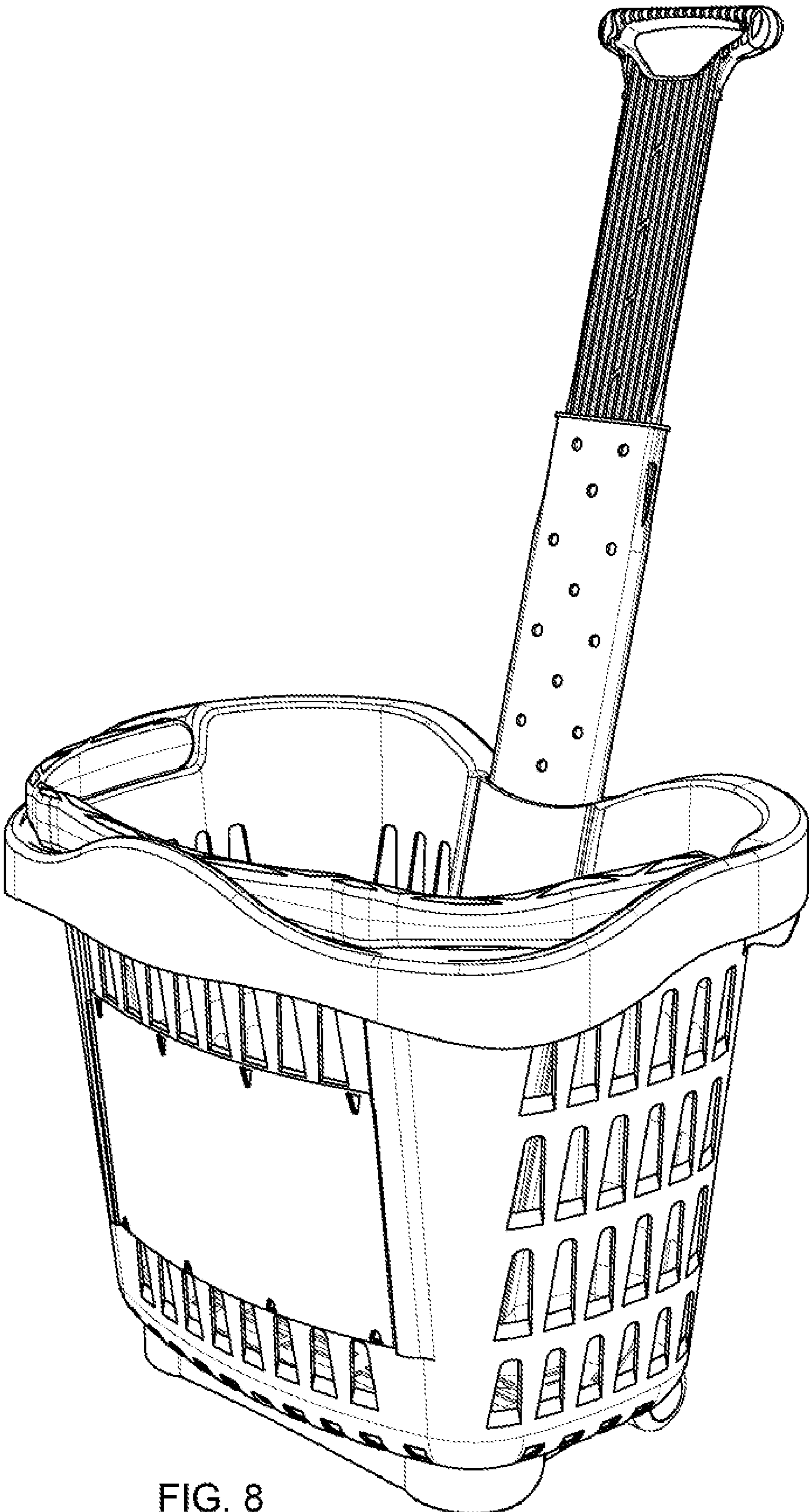

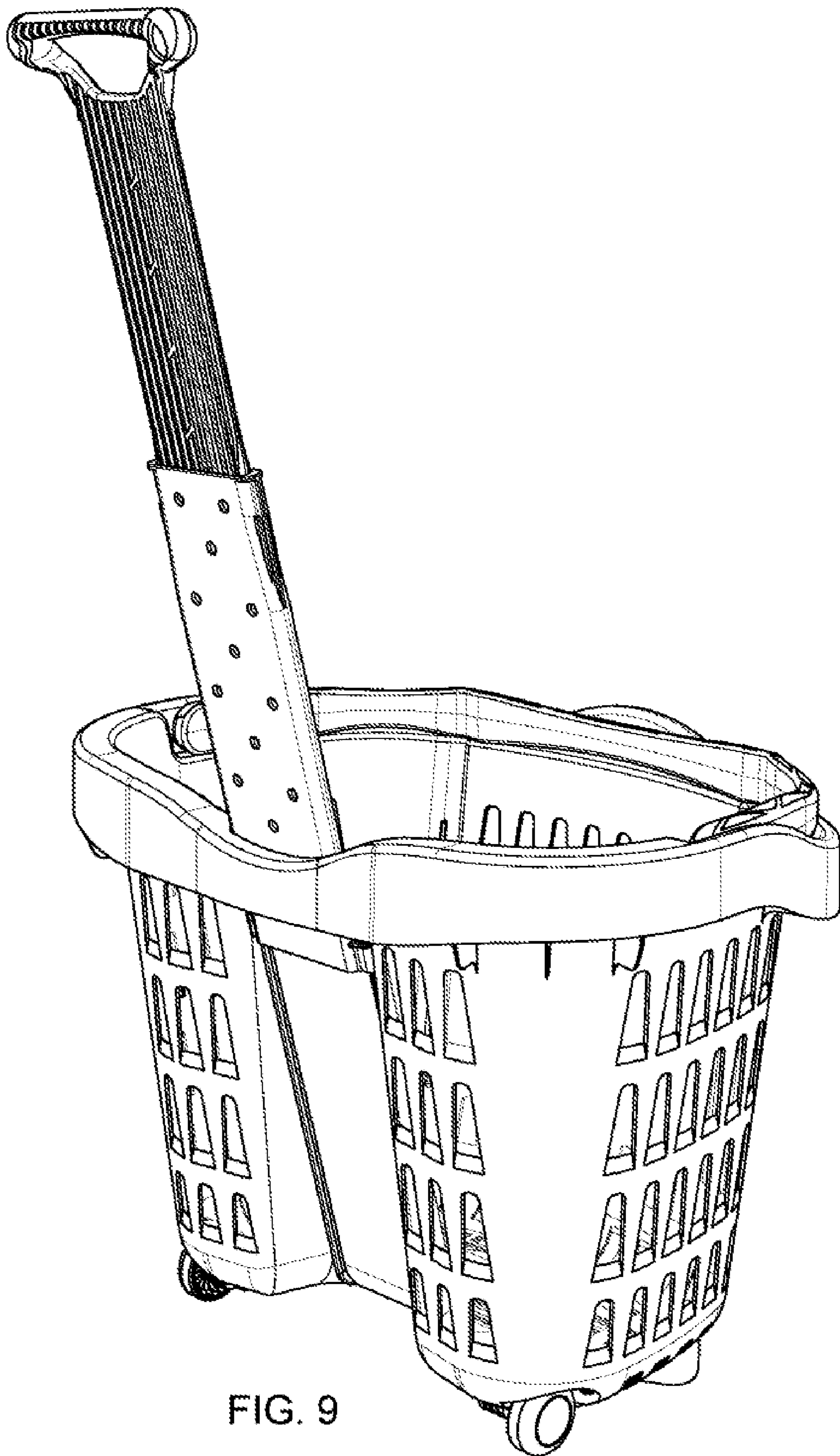

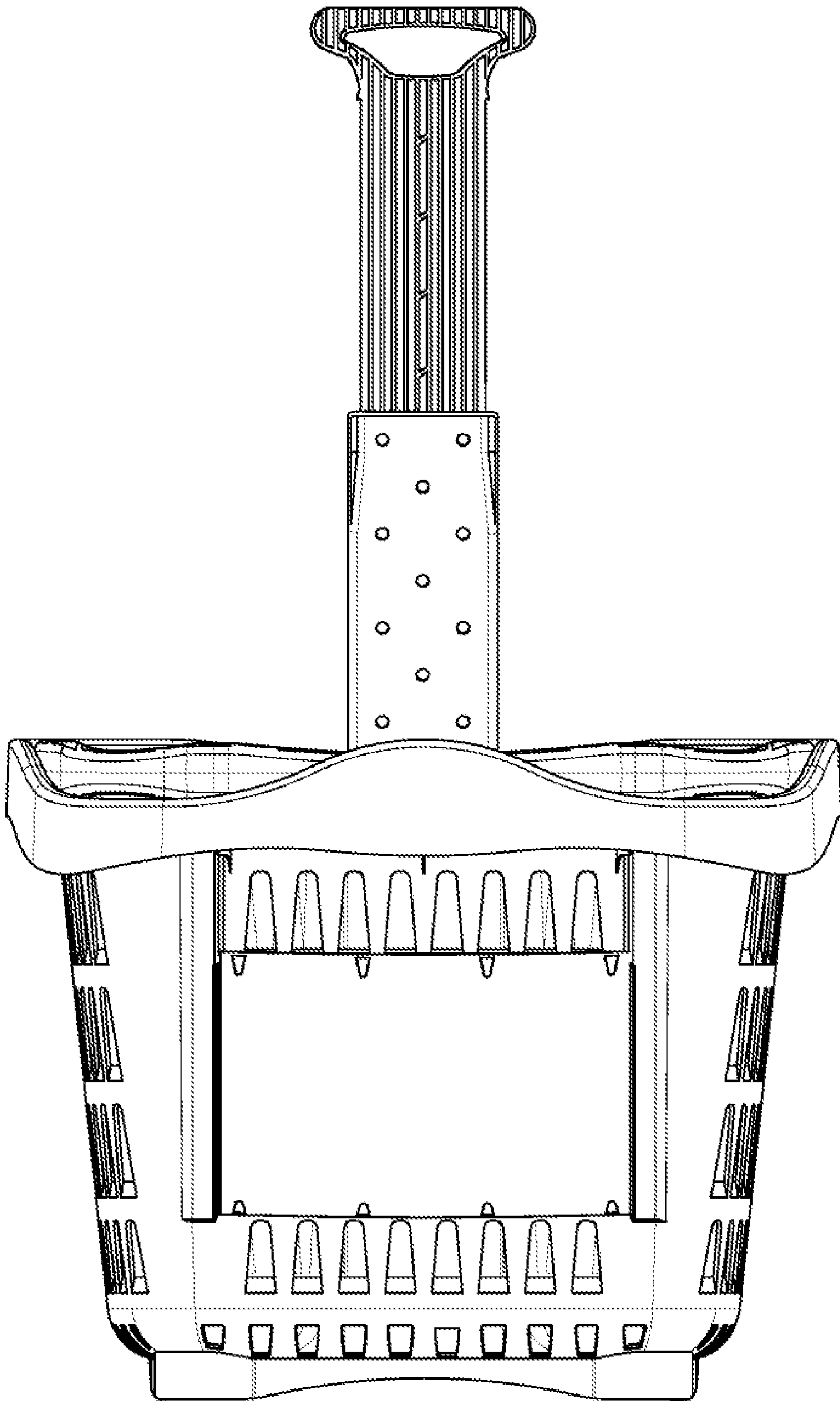

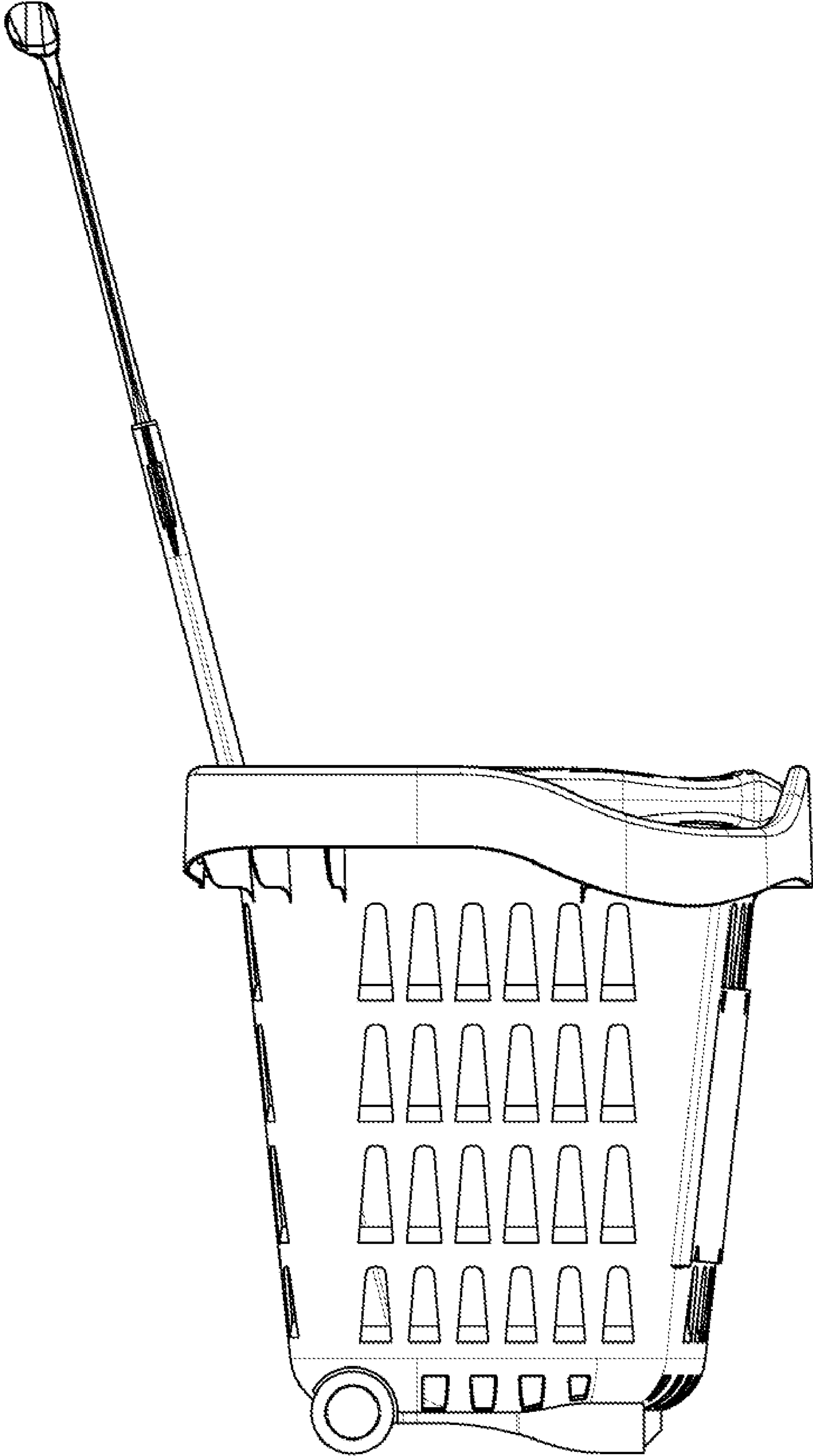
