(57) **CLAIM**

I claim an ornamental design for apparel, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of apparel showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a front elevational view of a second embodiment of apparel;

FIG. 4 is a rear elevational thereof;

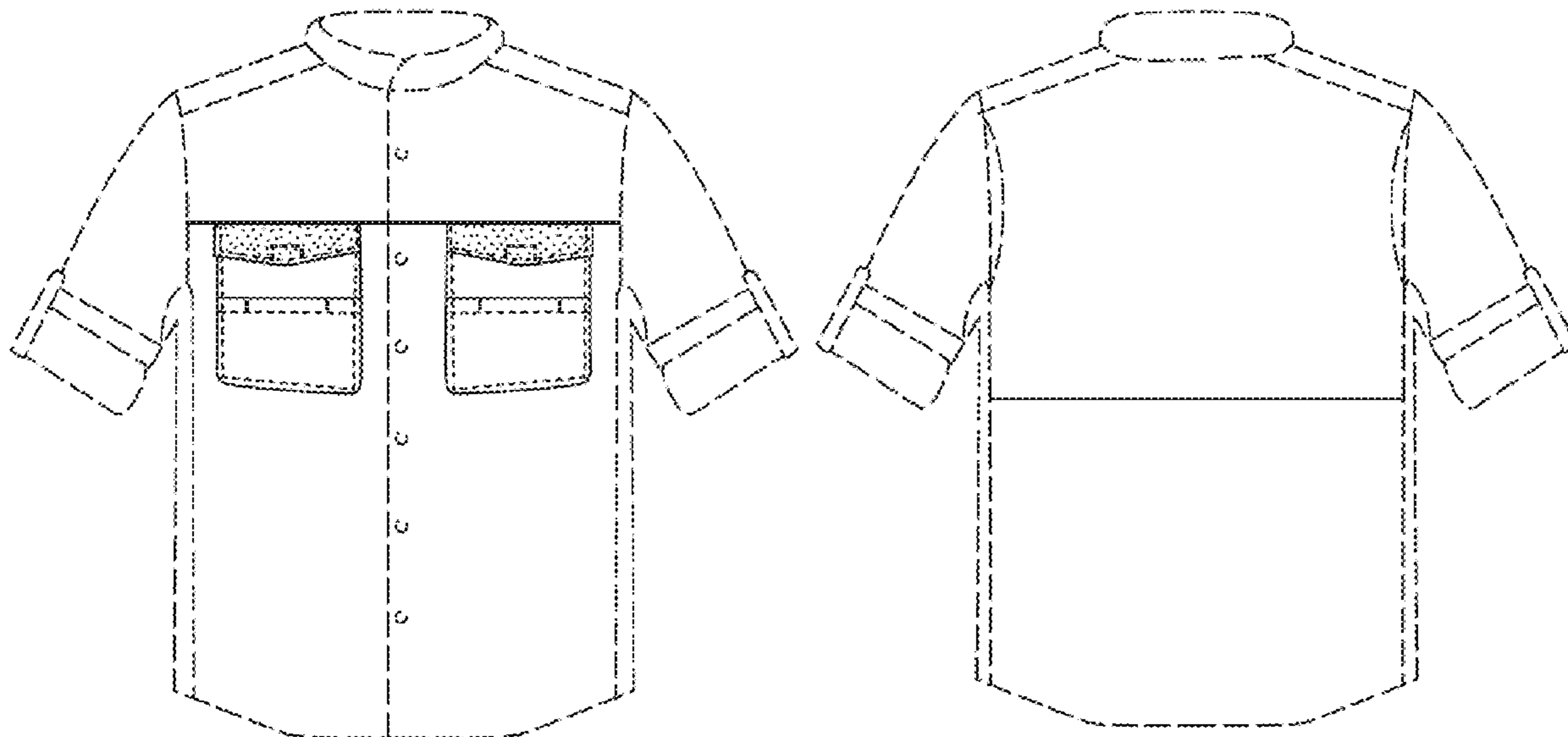
FIG. 5 is a front elevational view of a third embodiment of apparel; and,

FIG. 6 is a rear elevational view thereof.

The broken lines on the surface of the pockets in FIGS. 1, 3 and 5 represent stitching.

The remaining broken lines in FIGS. 1-6 showing a shirt represent the portion of the design, which forms no part of the claim.

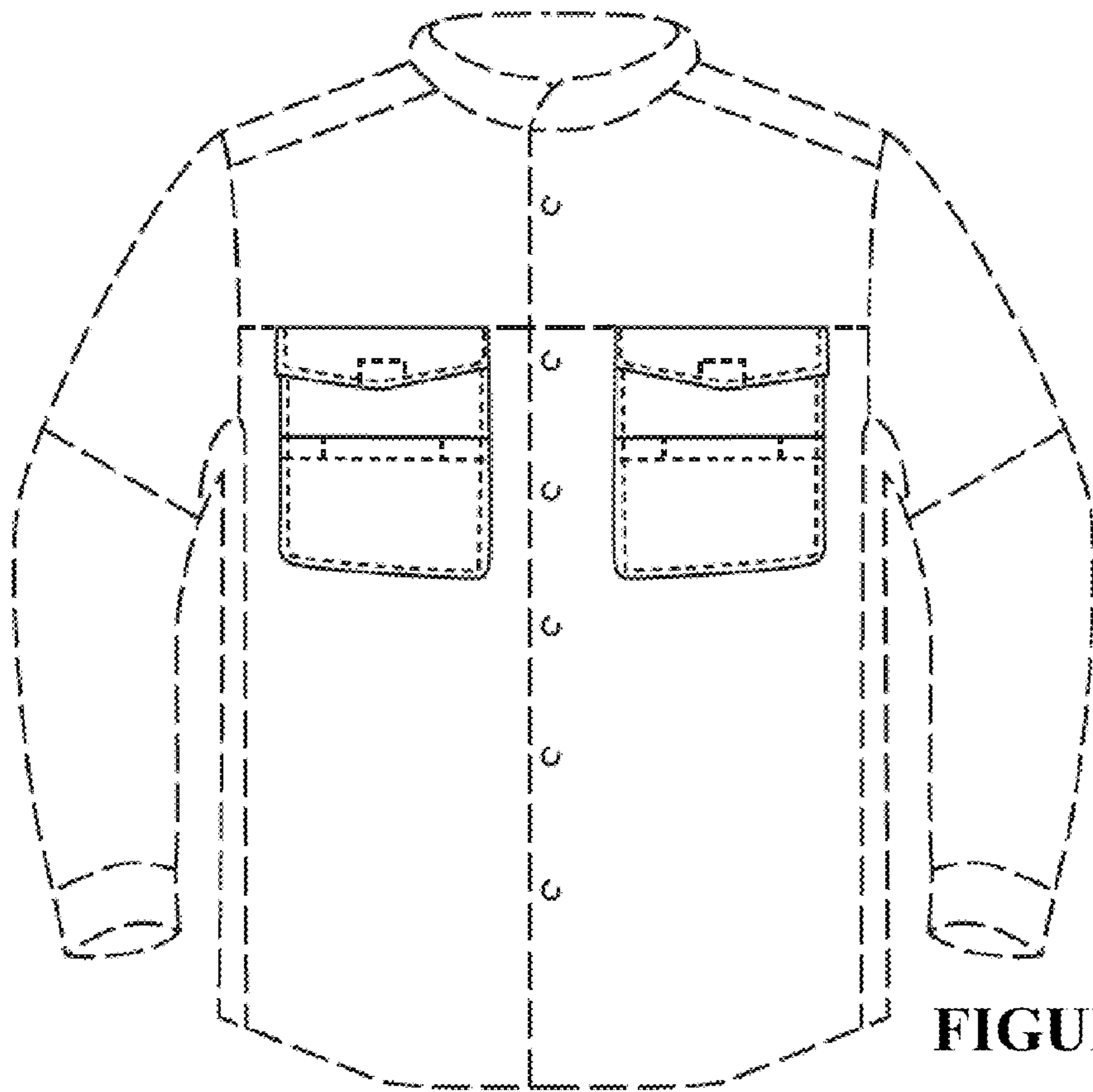

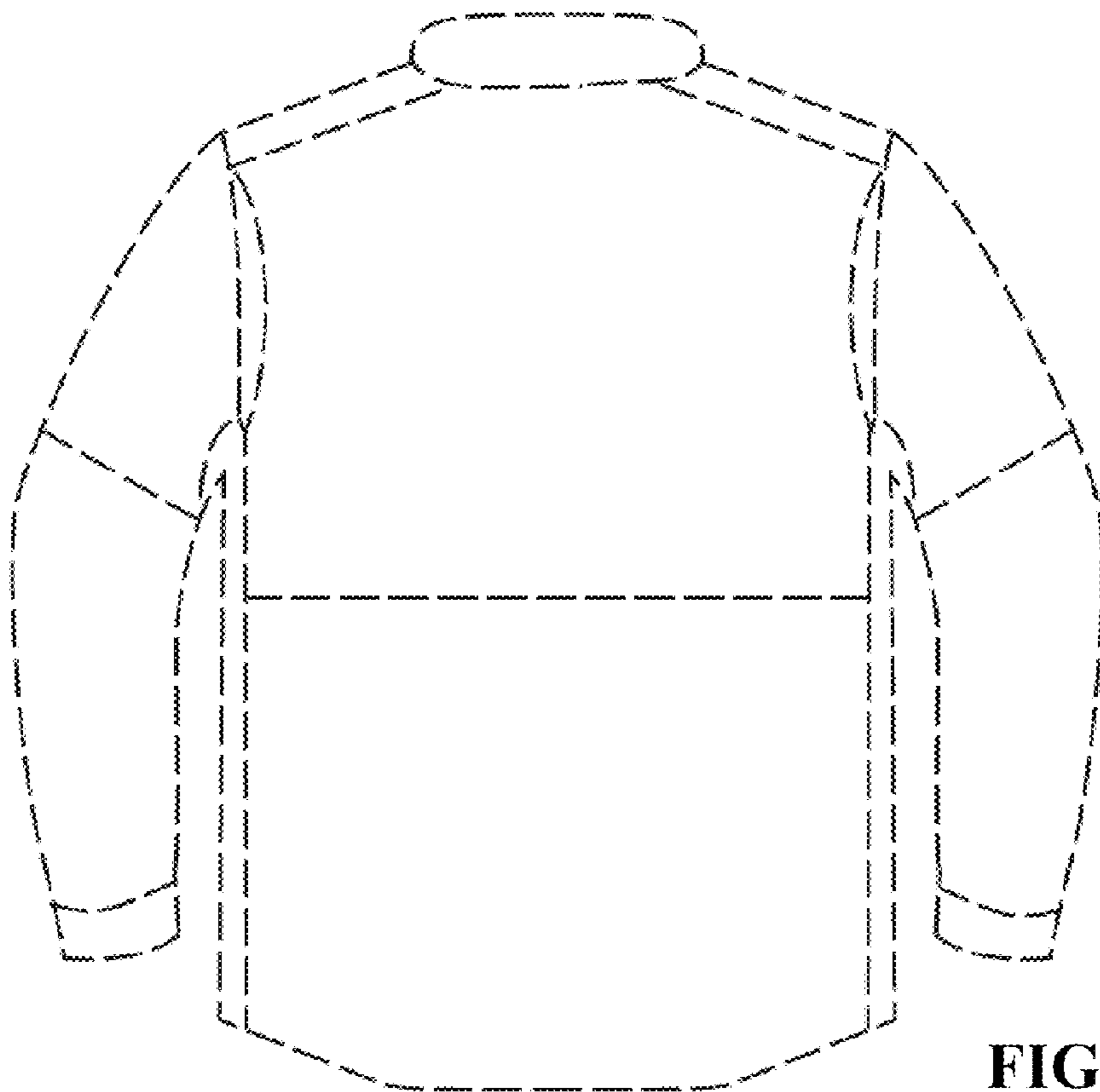

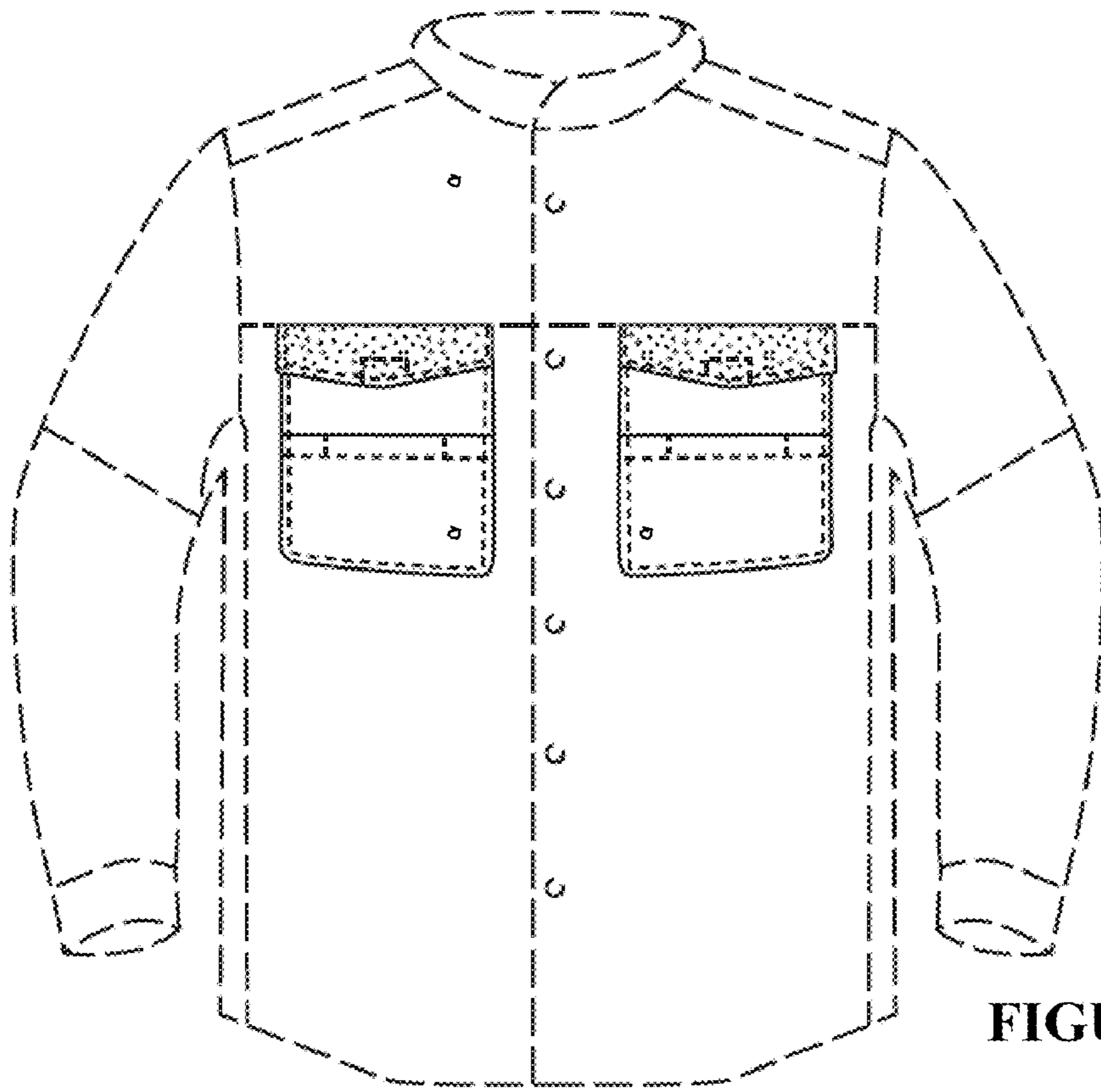

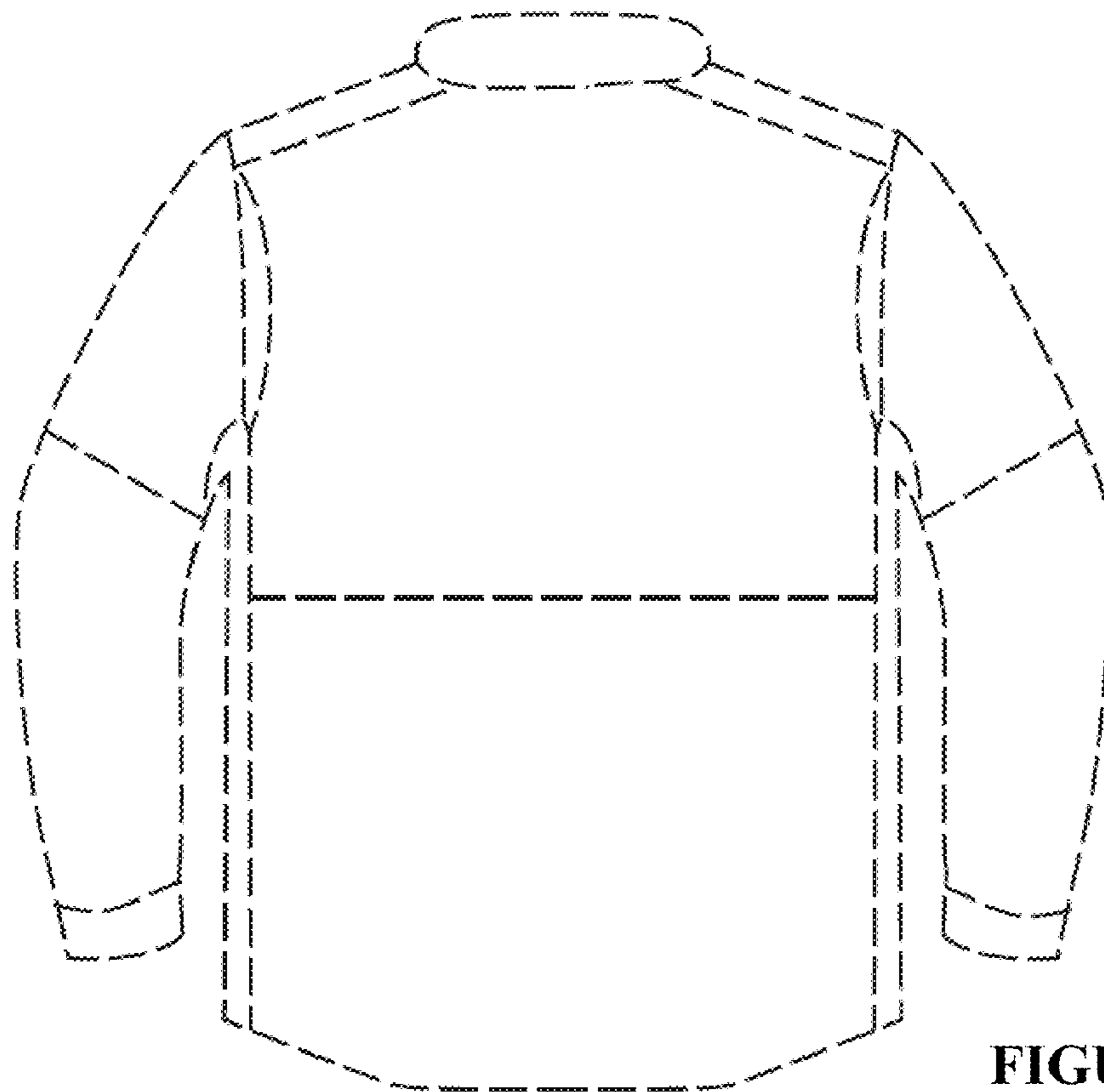

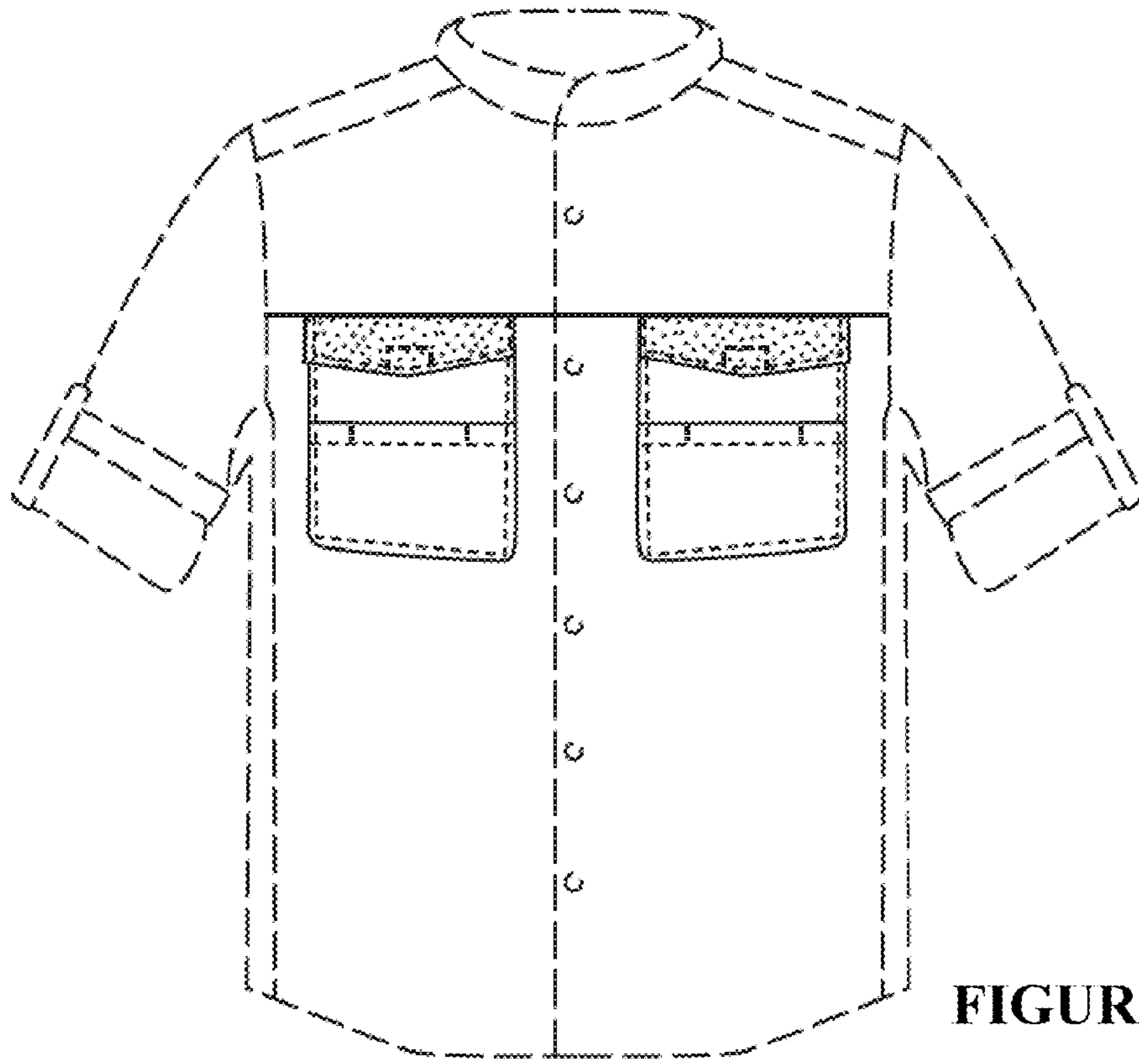

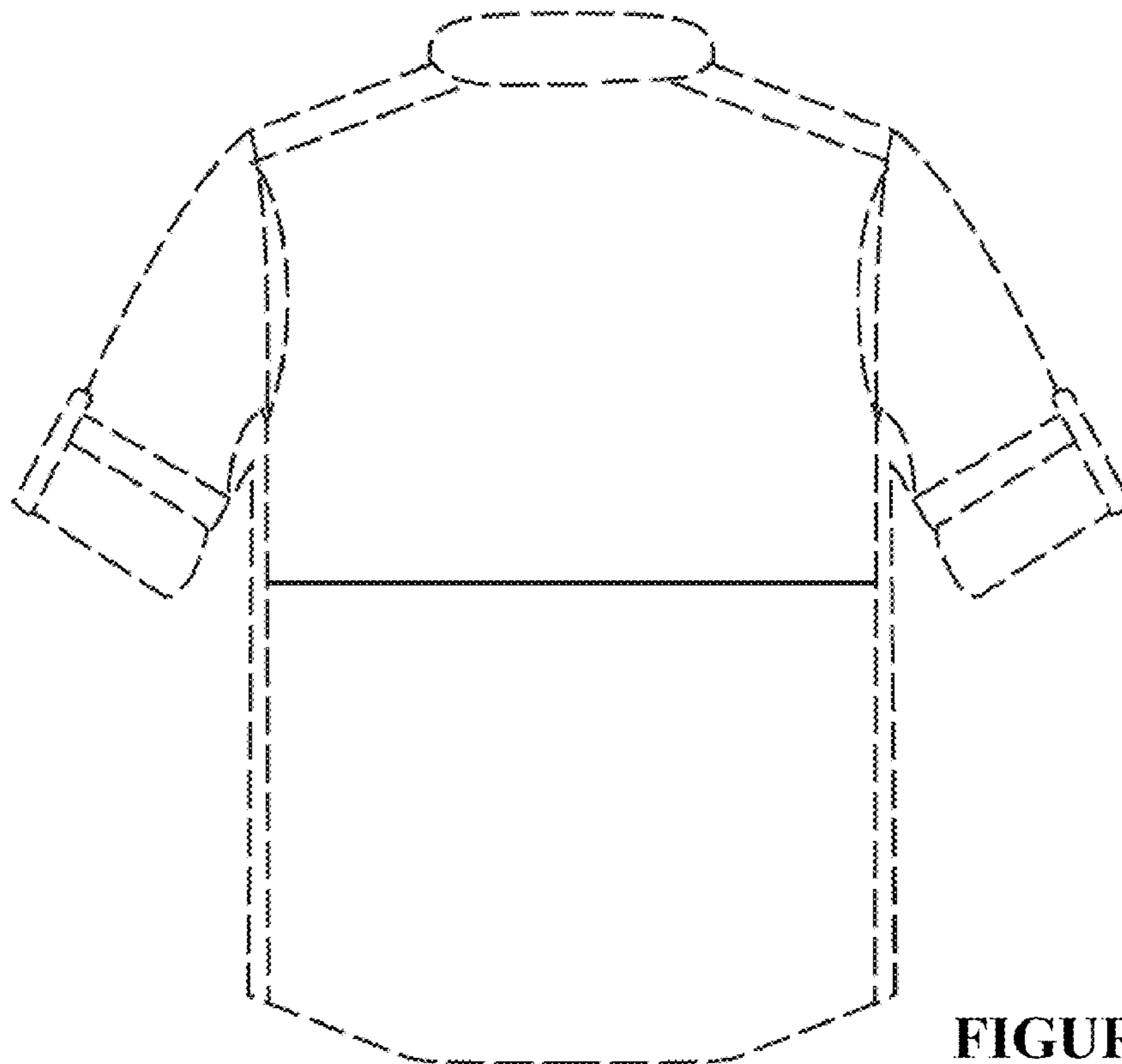
