FIG. 11 is a left side view of the handbag shown in FIG. 1, in an open position;

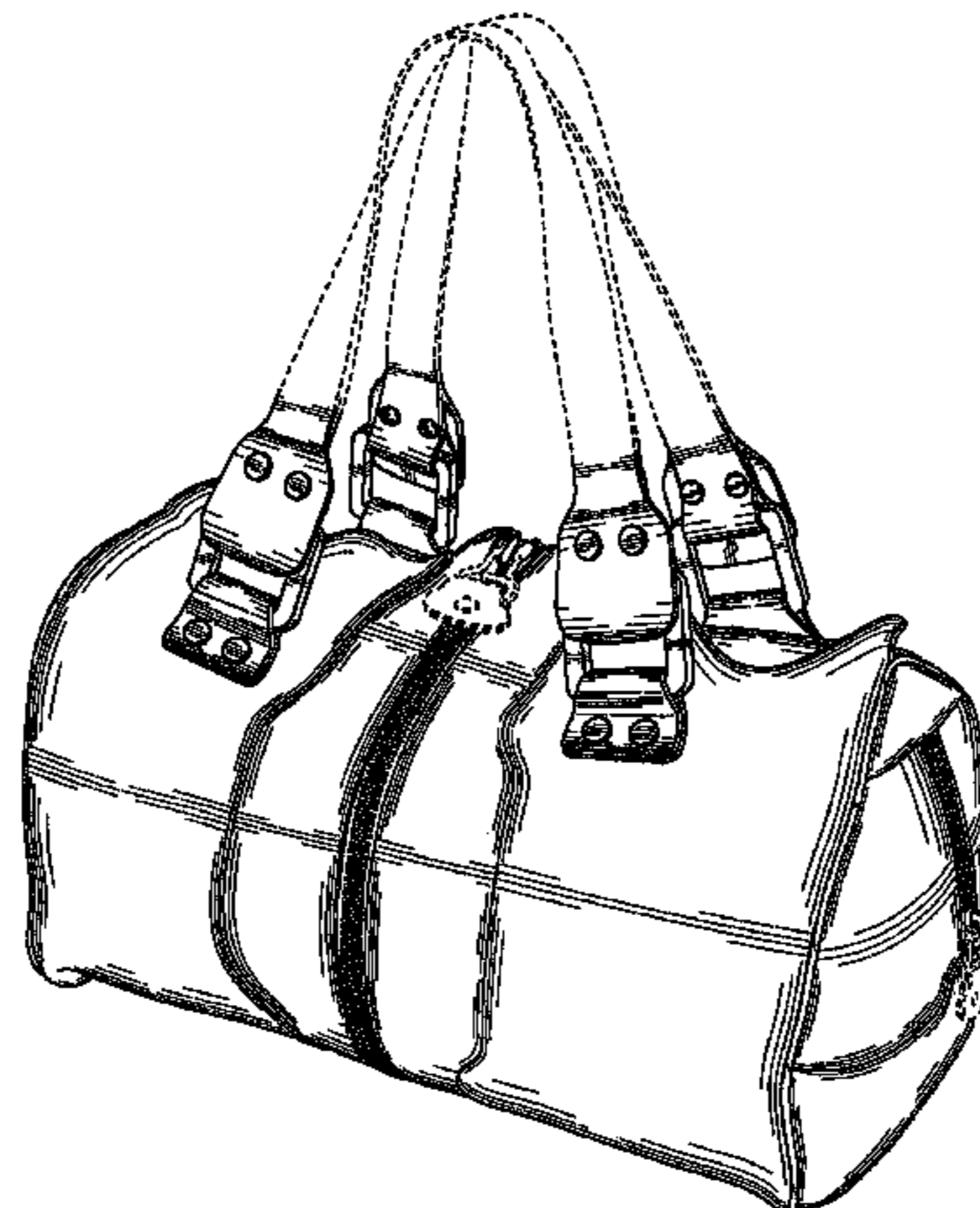
FIG. 12 is a right side view of the handbag shown in FIG. 1, in an open position;

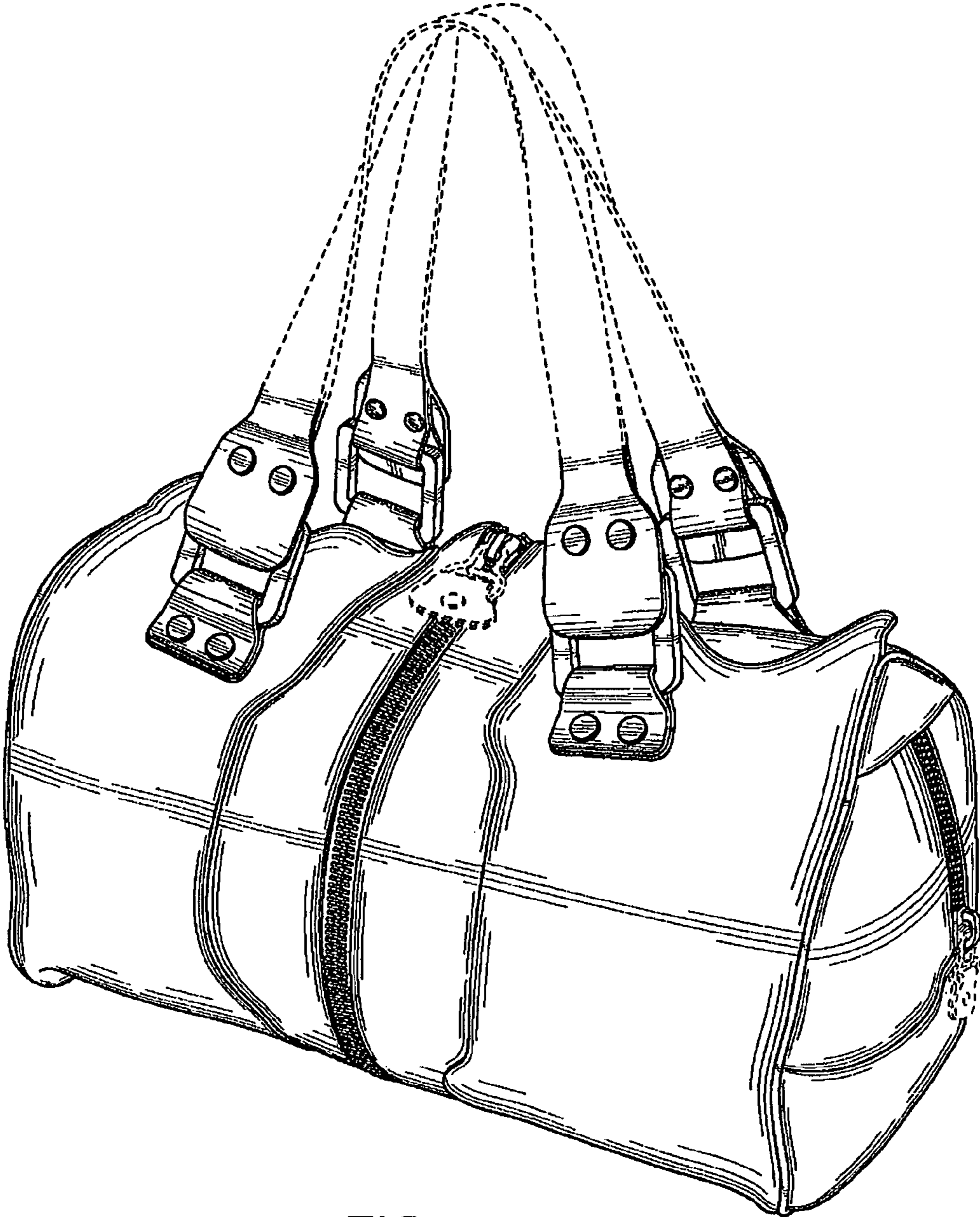

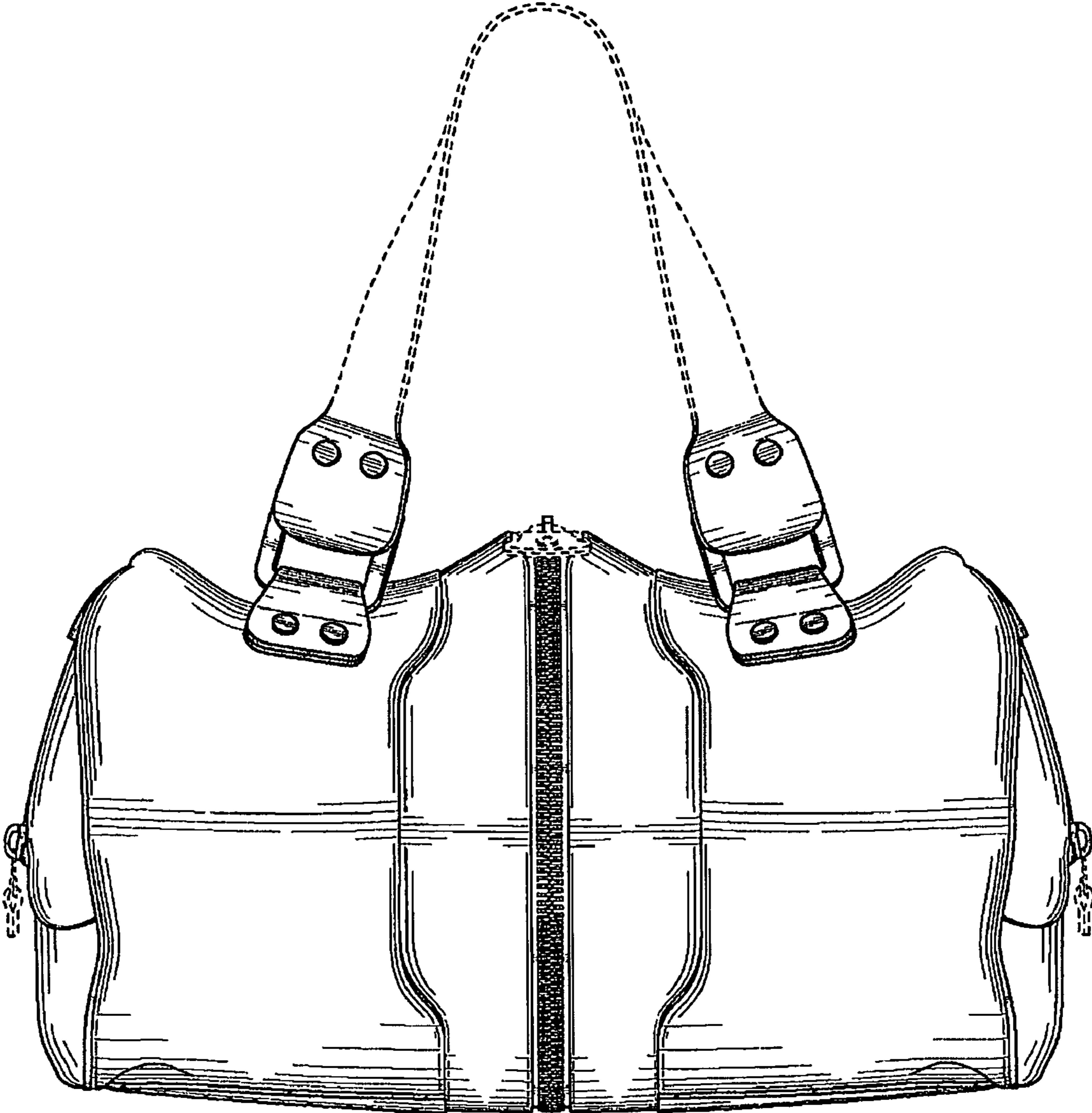

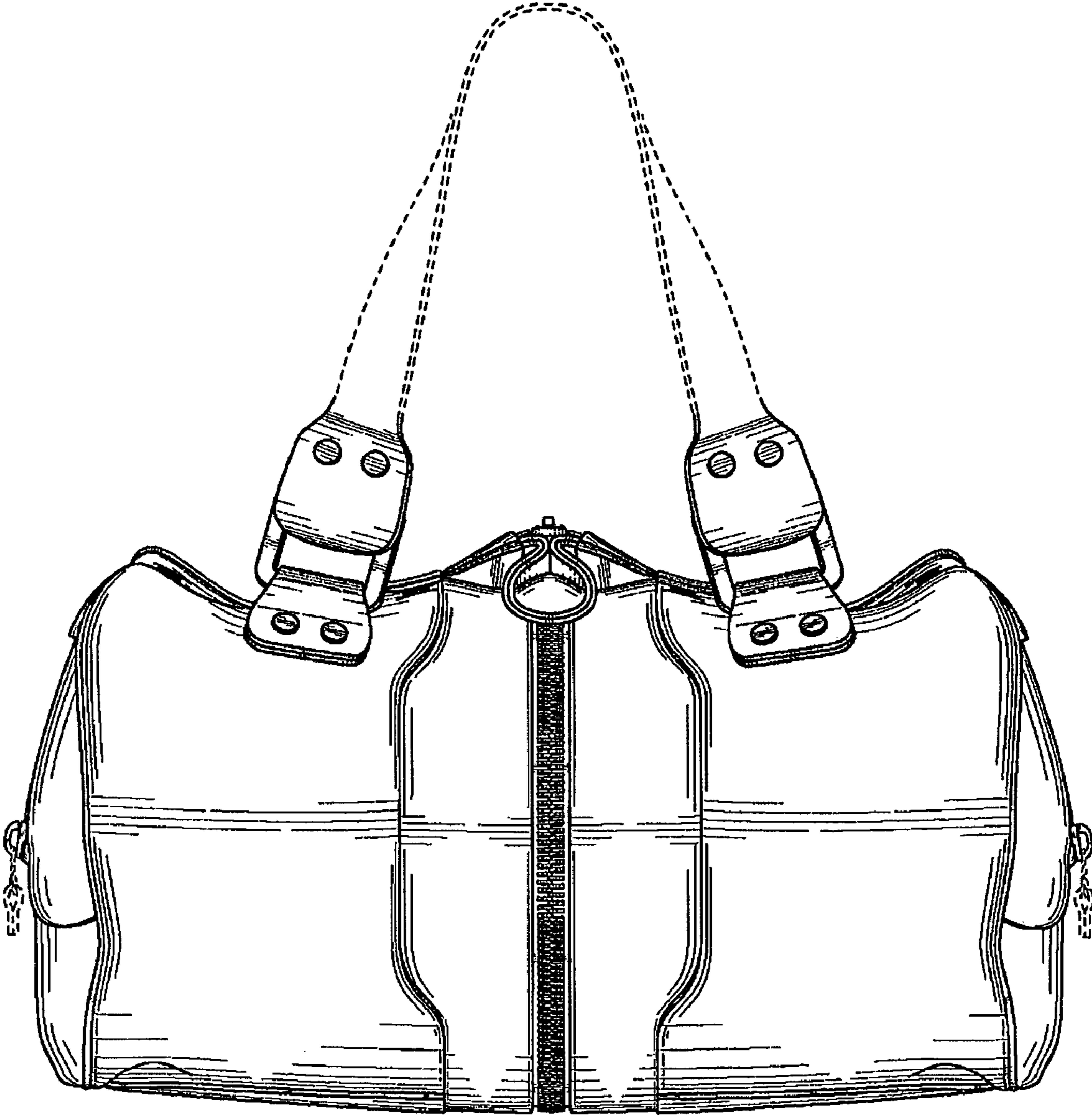

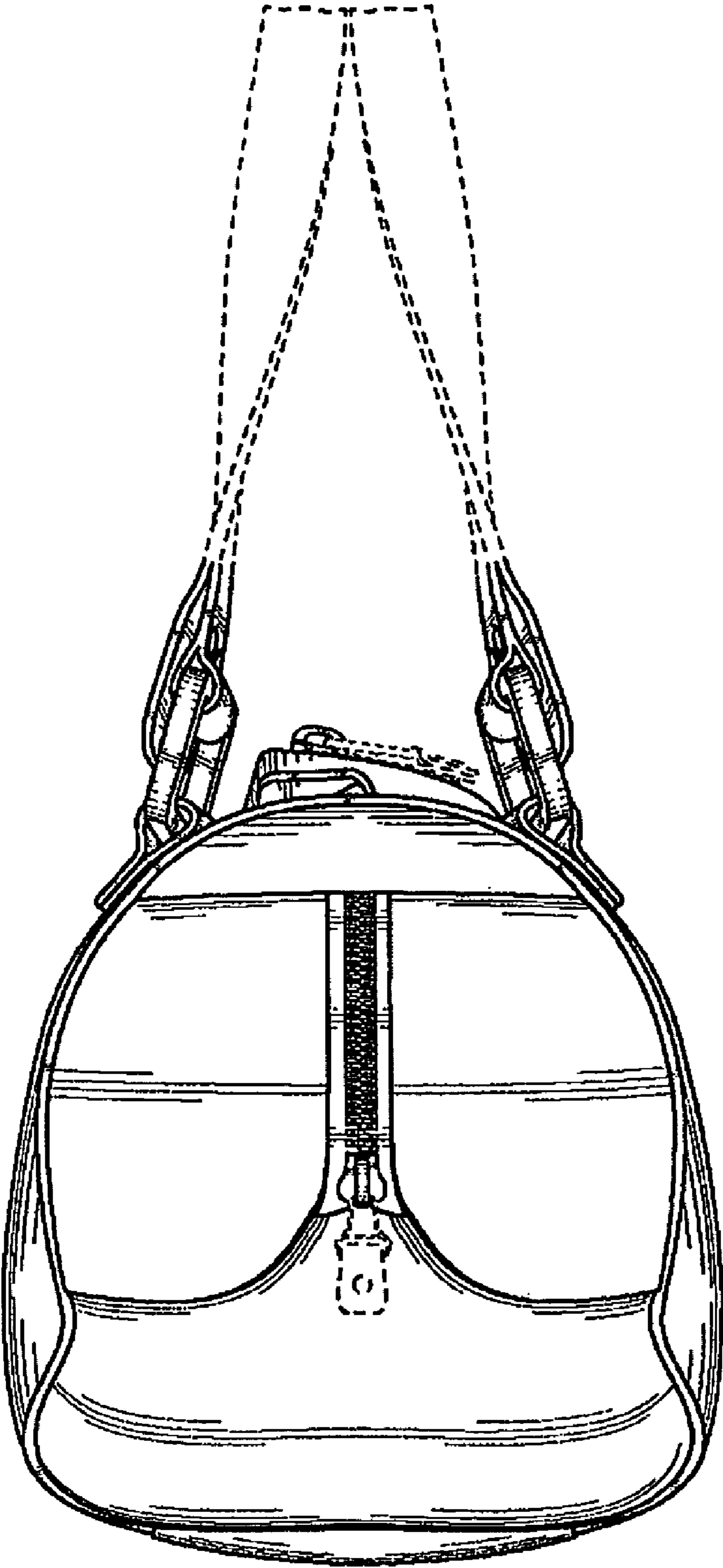

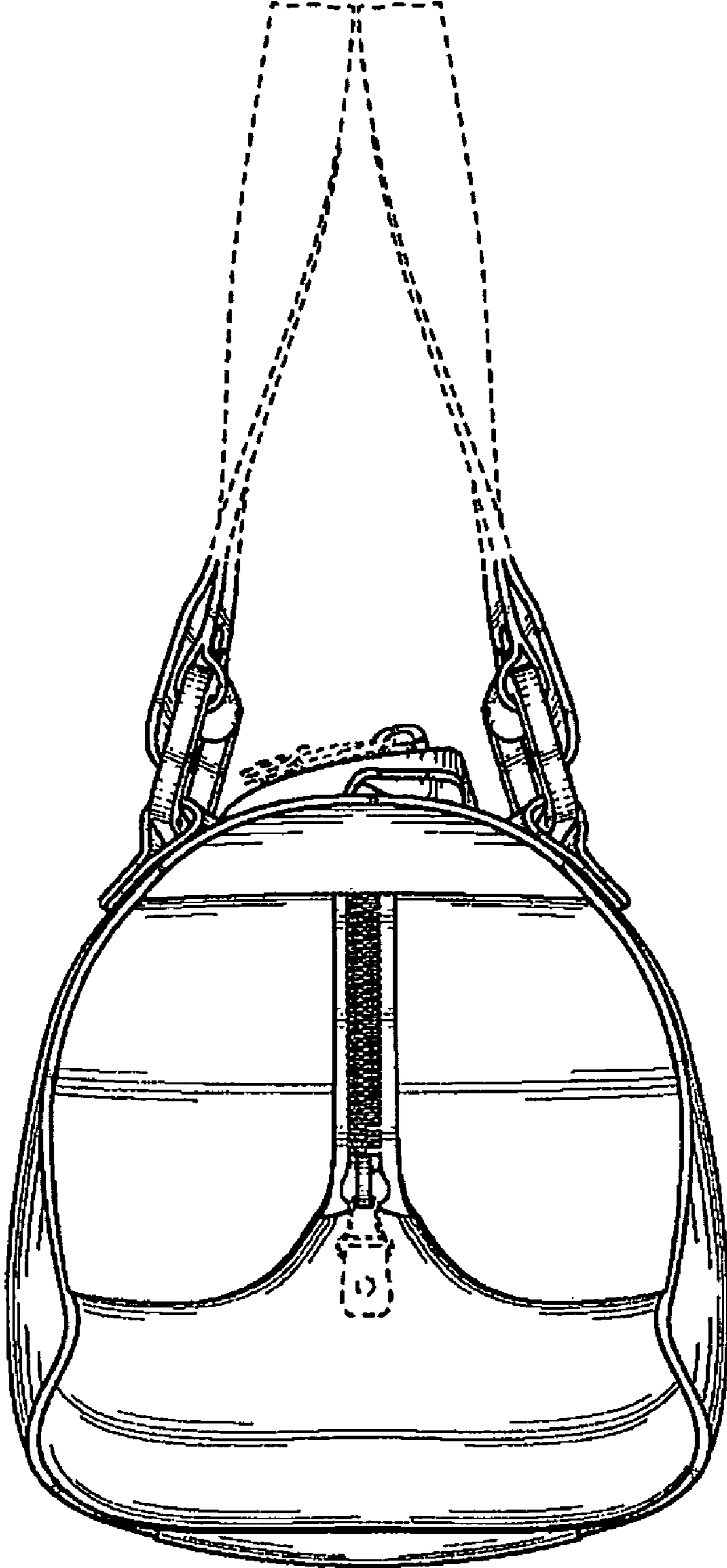

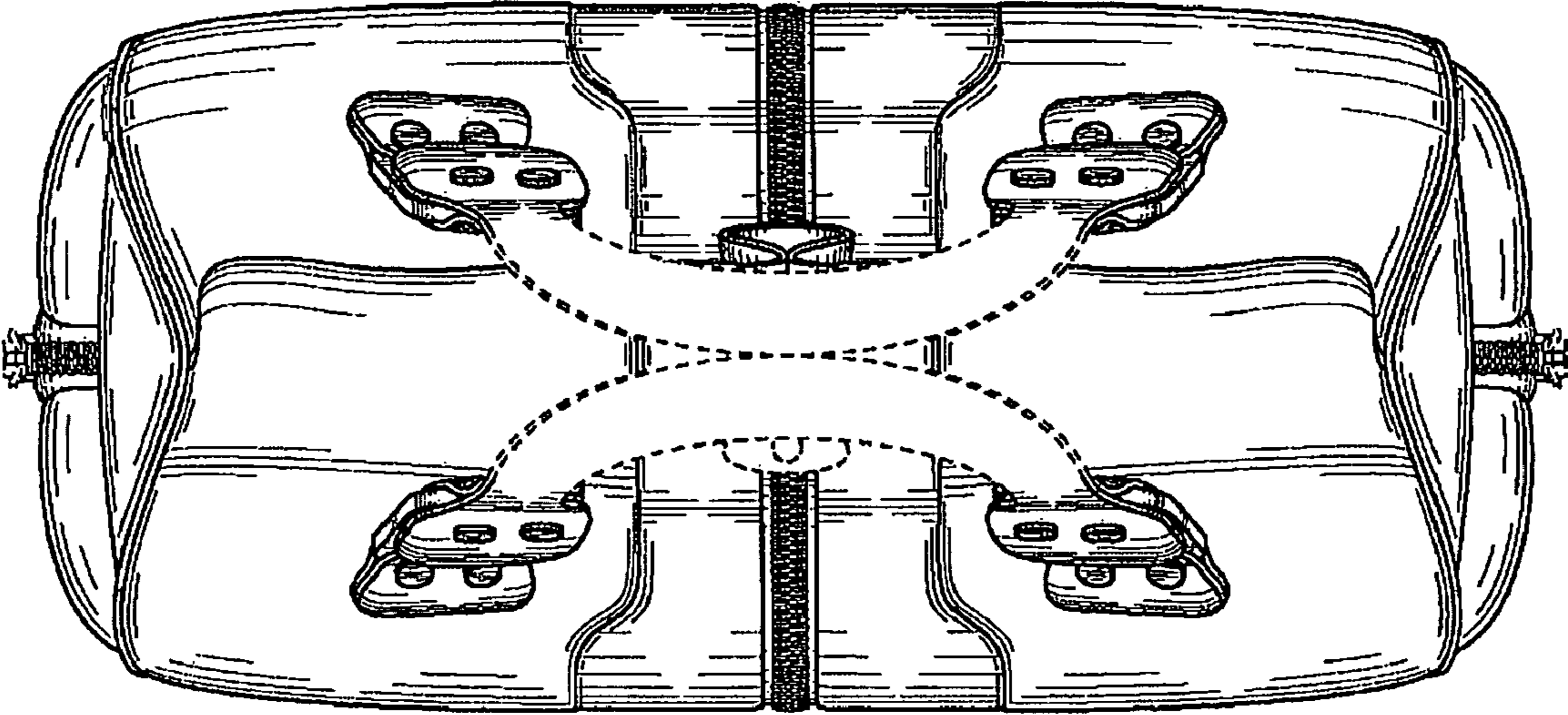

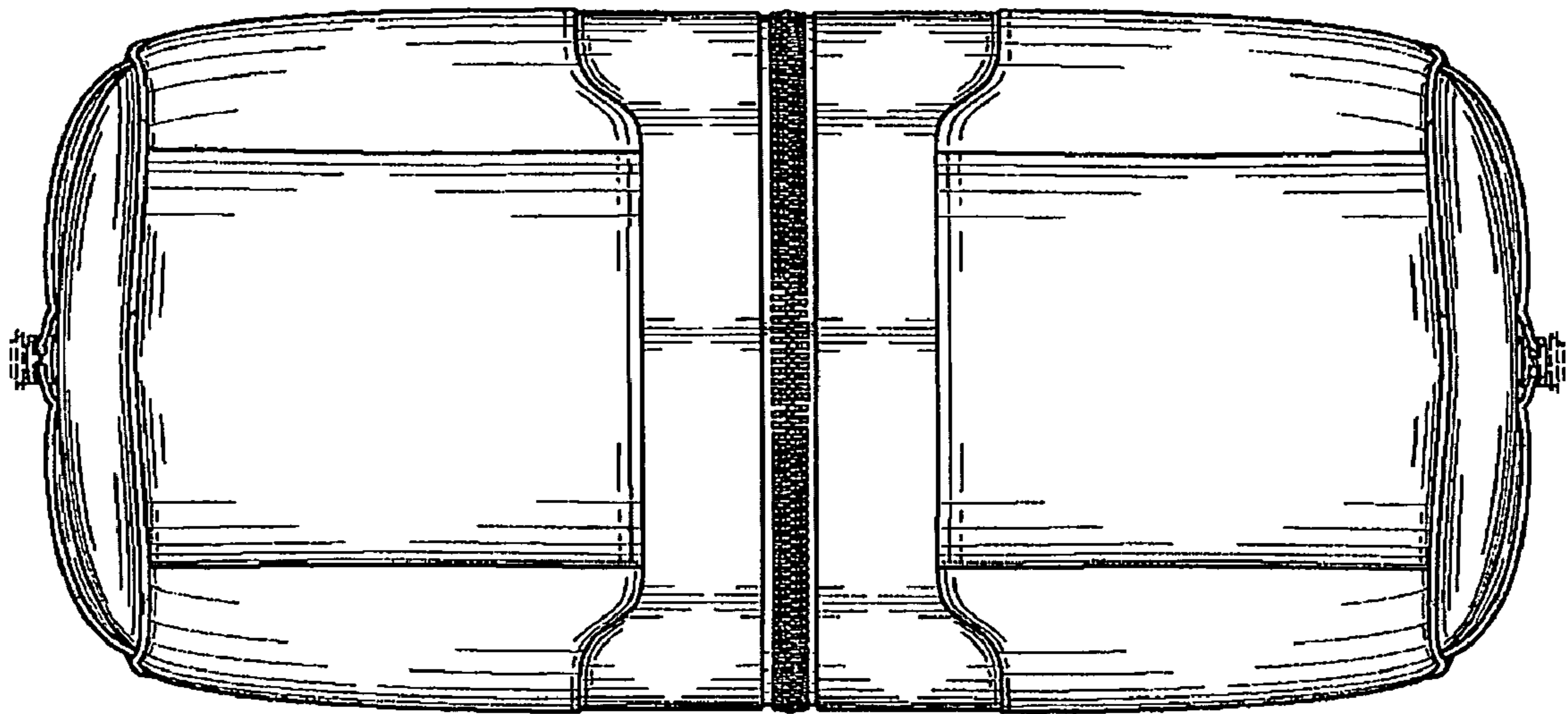

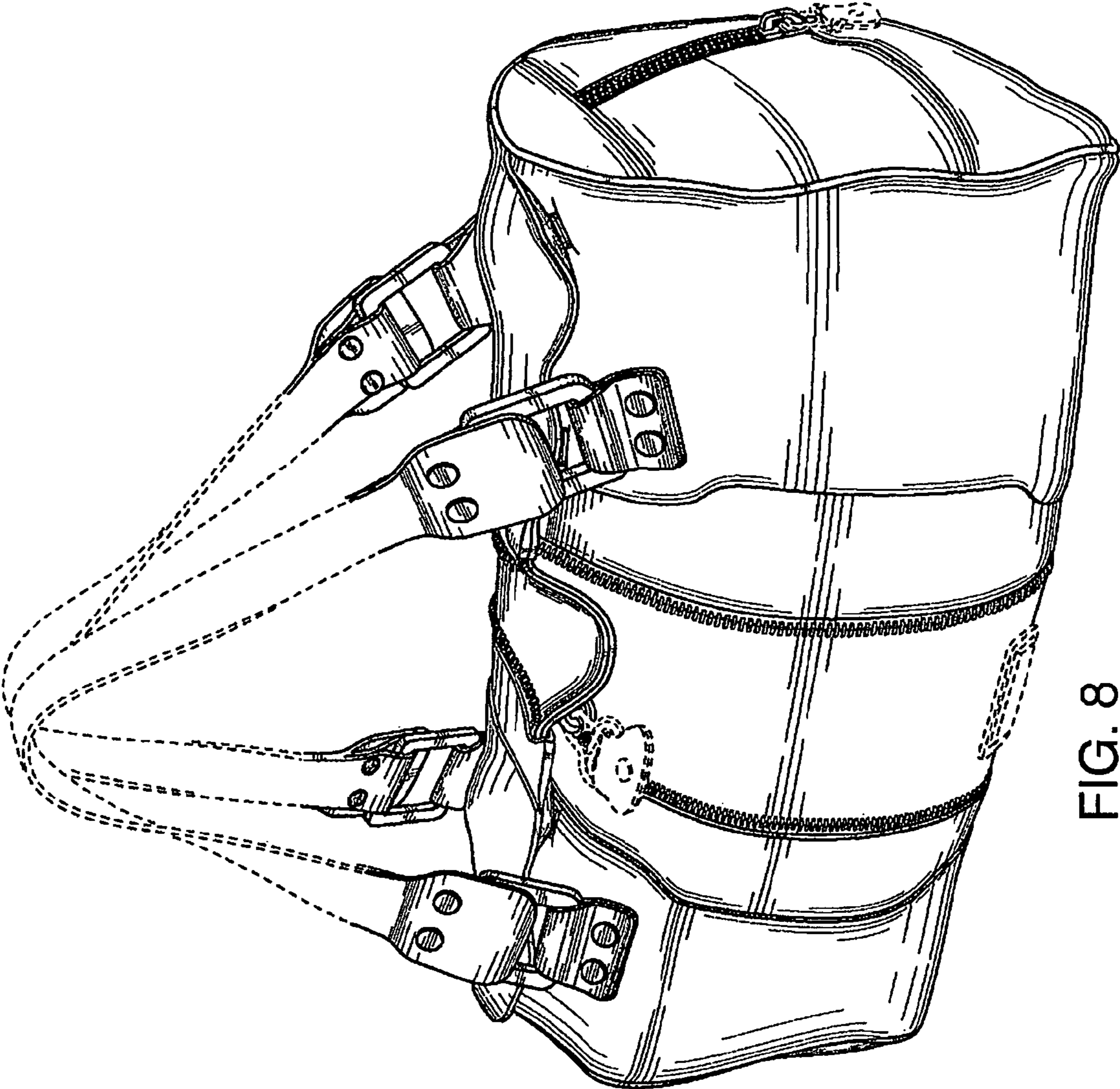

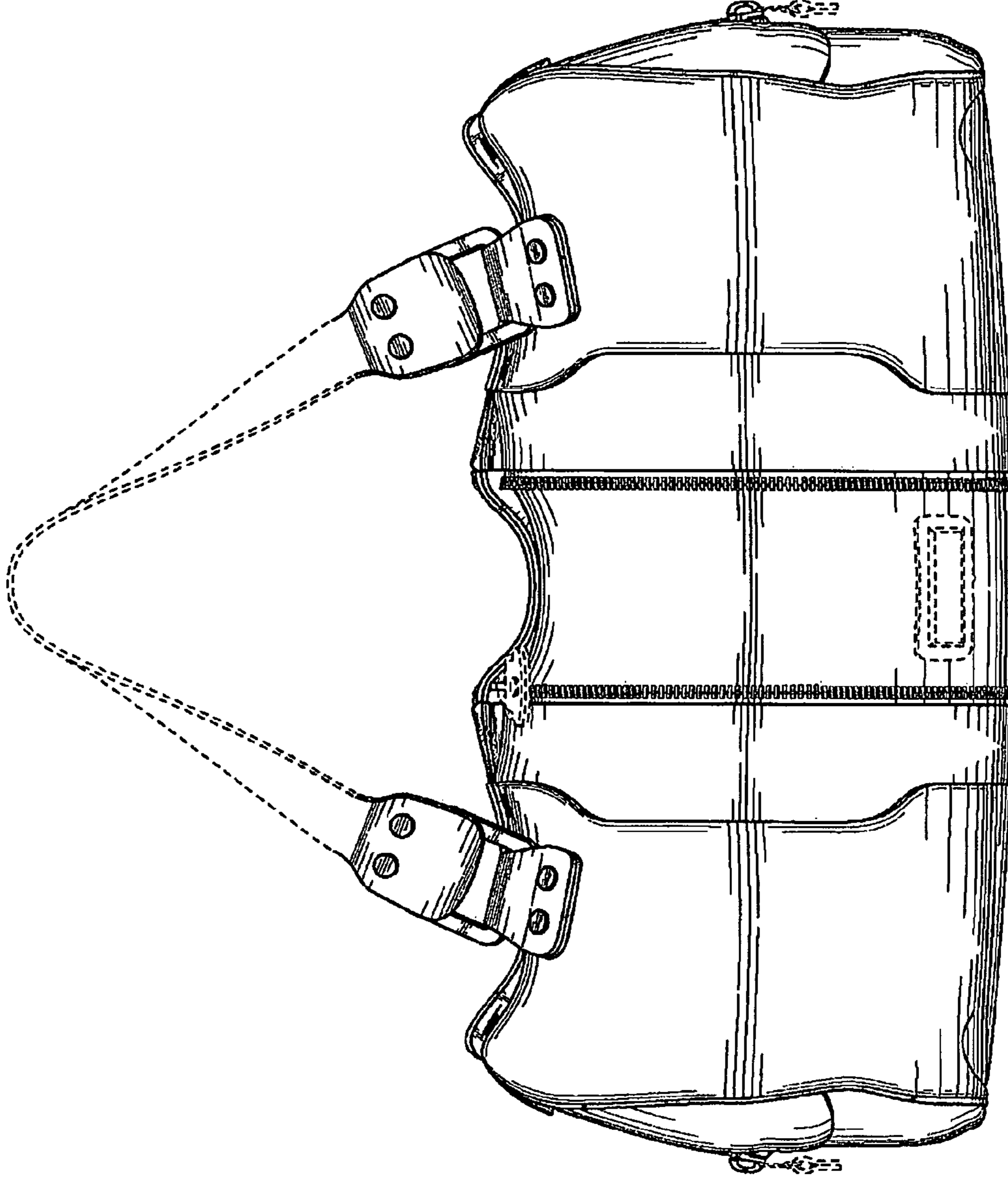

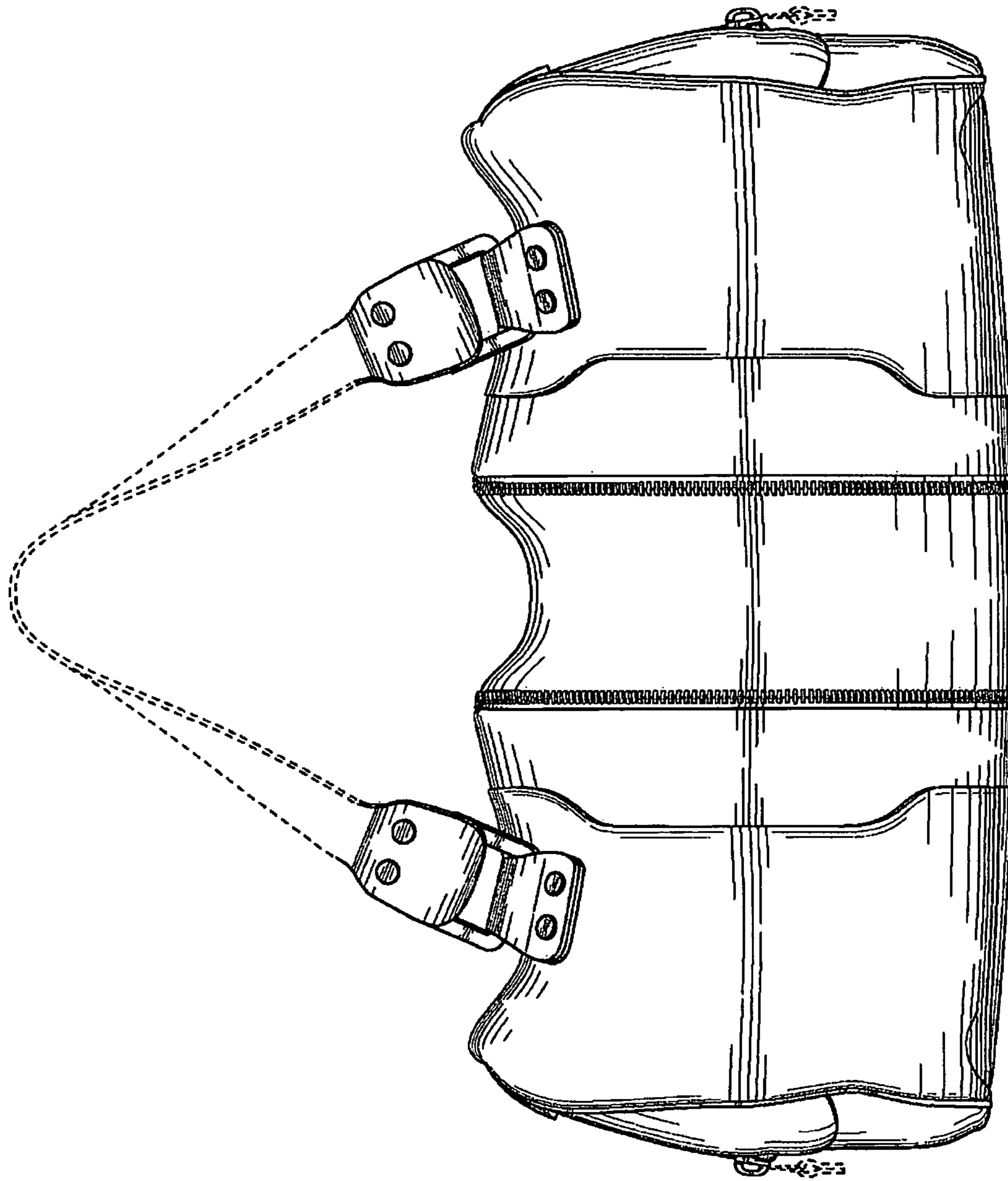

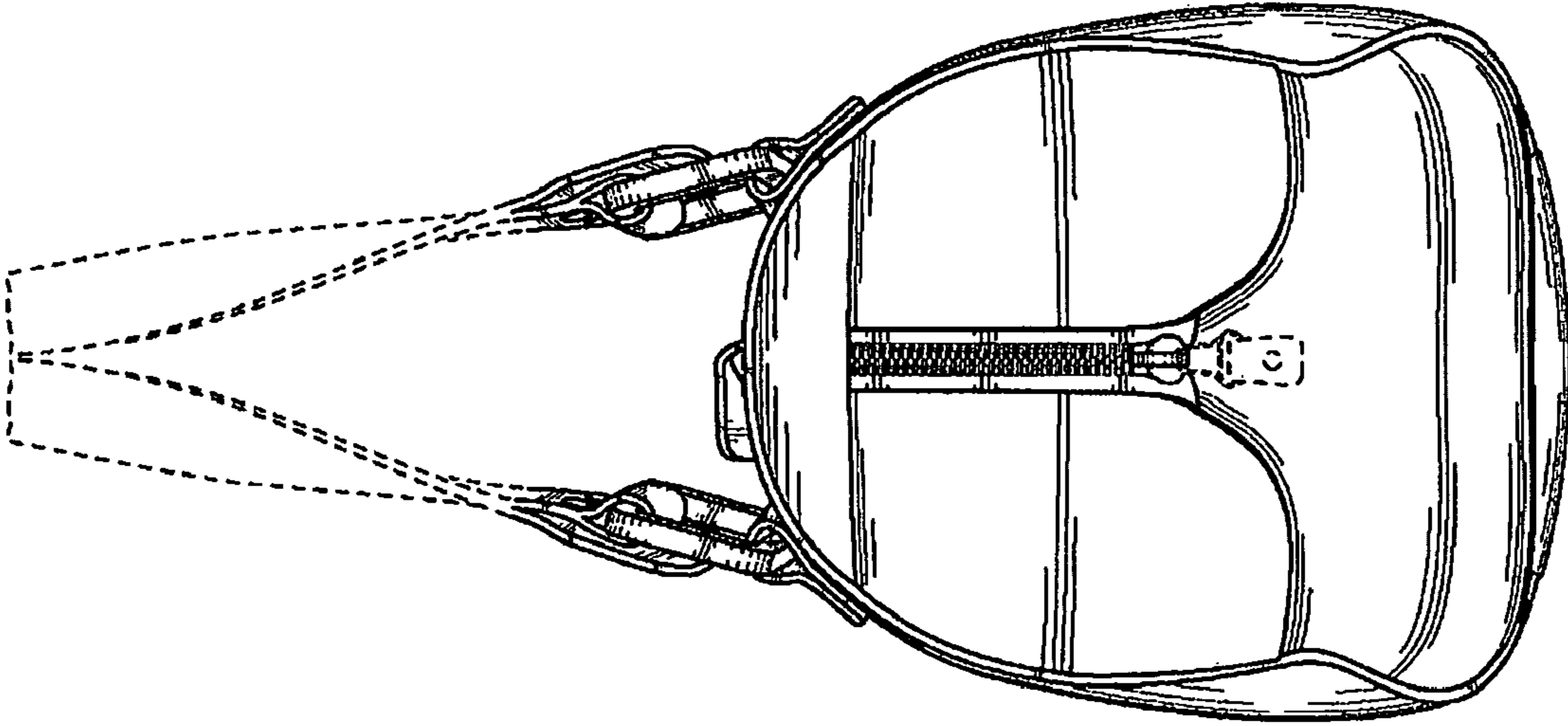

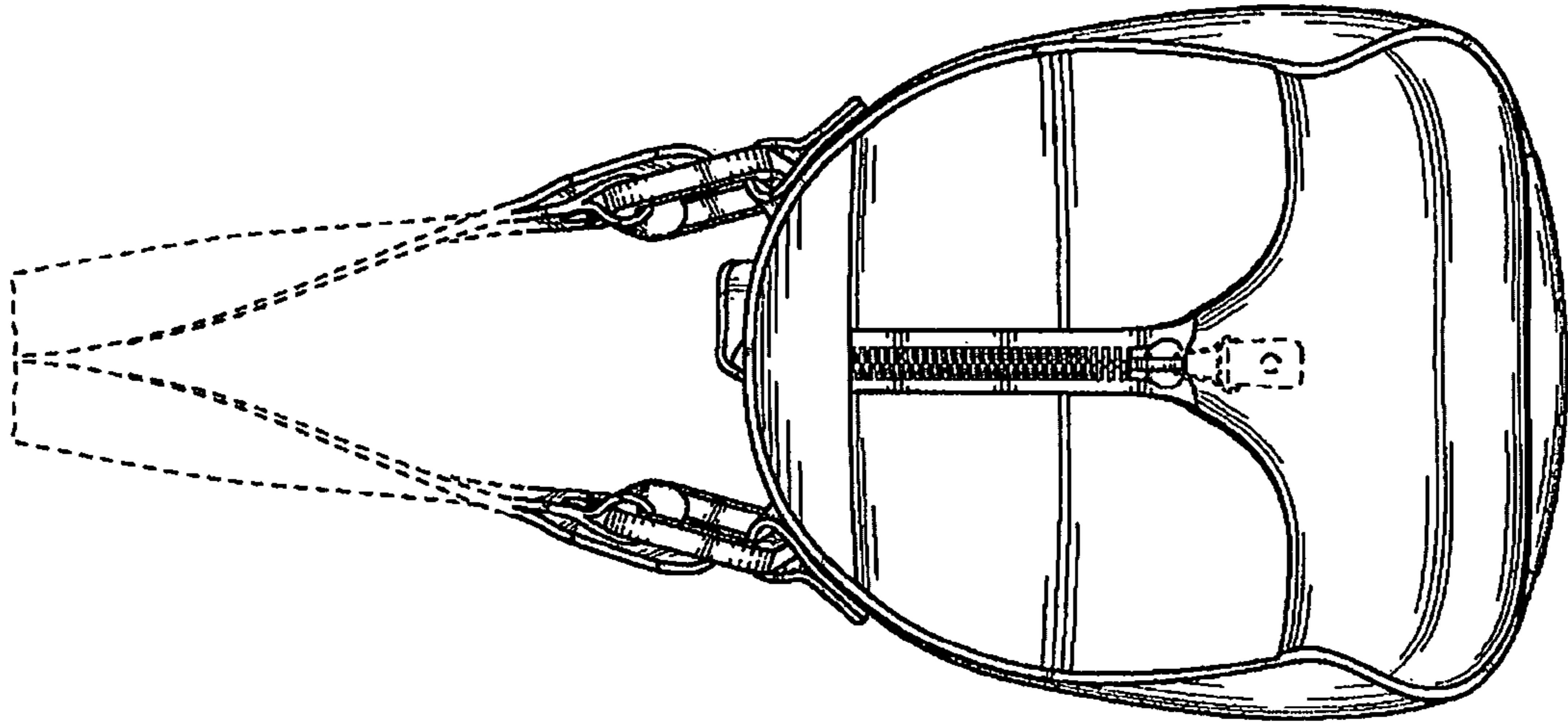

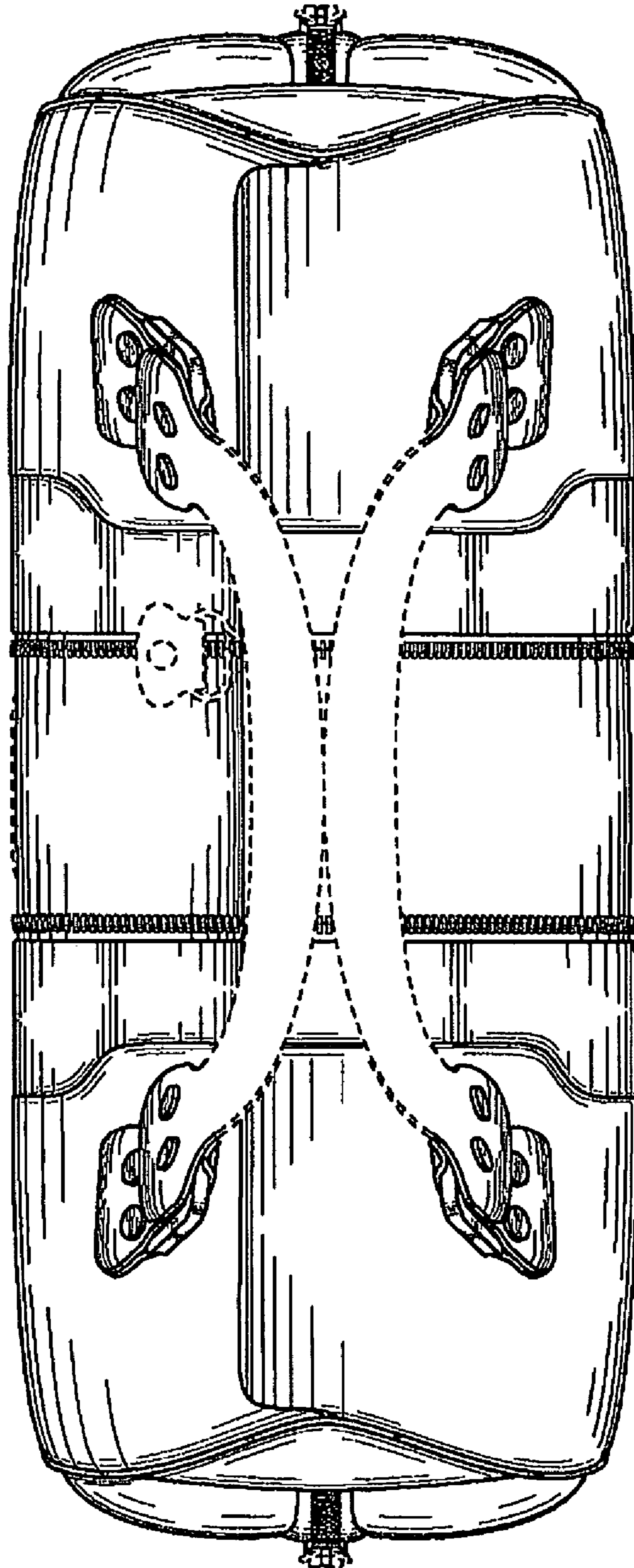

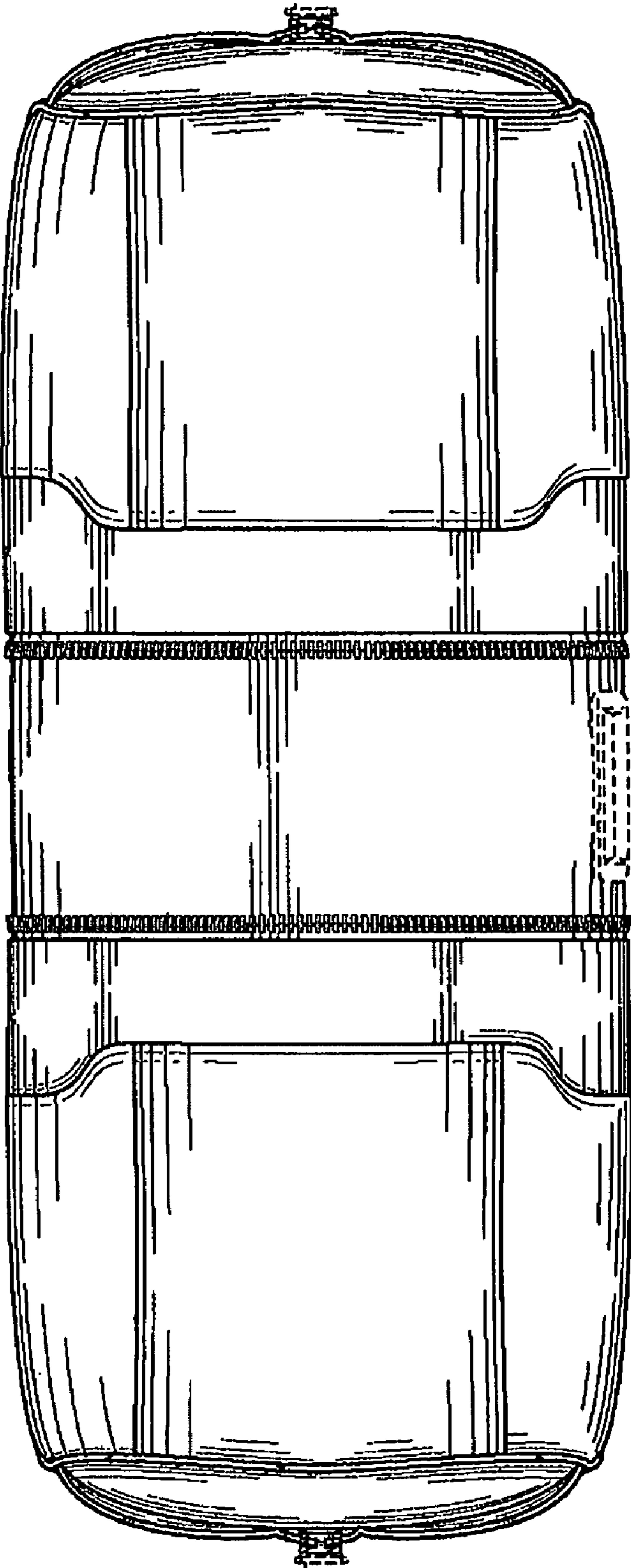
